The ornamental design for a diamond 3D arch trellis, as shown and described.

DESCRIPTION

FIG. 10 is a right side view of the second embodiment thereof;

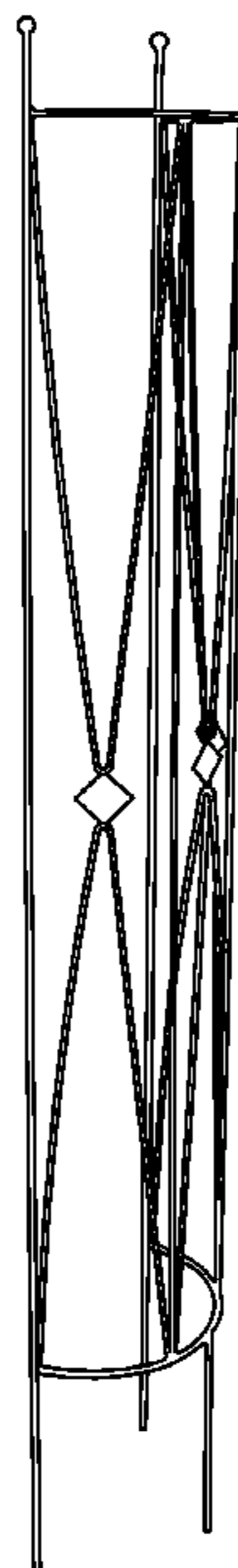
FIG. 11 is a left side view of the second embodiment thereof;

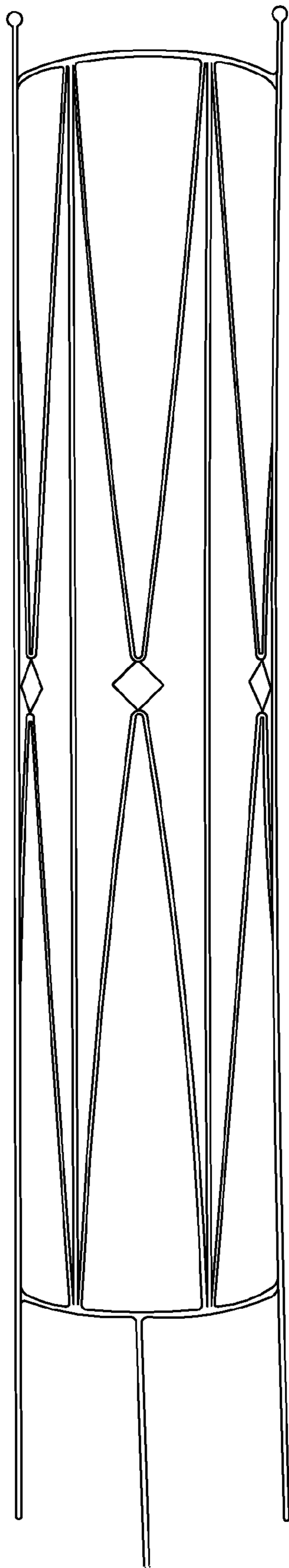

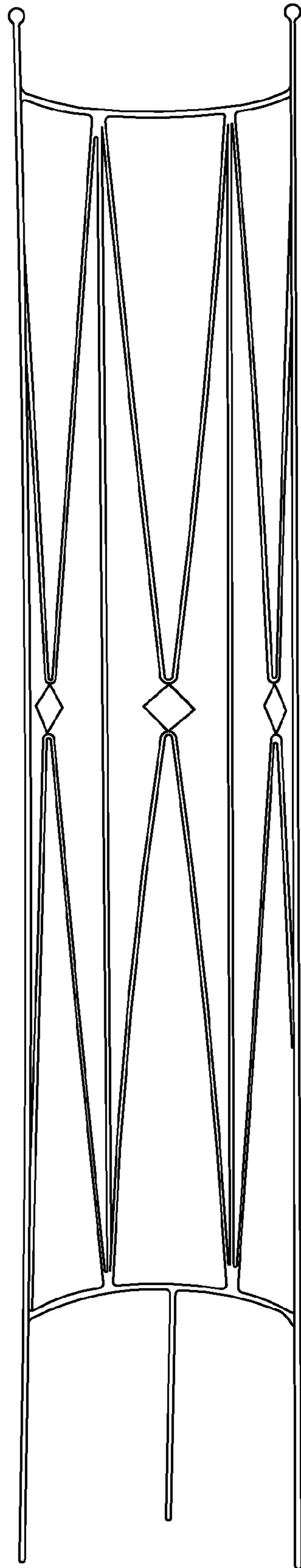

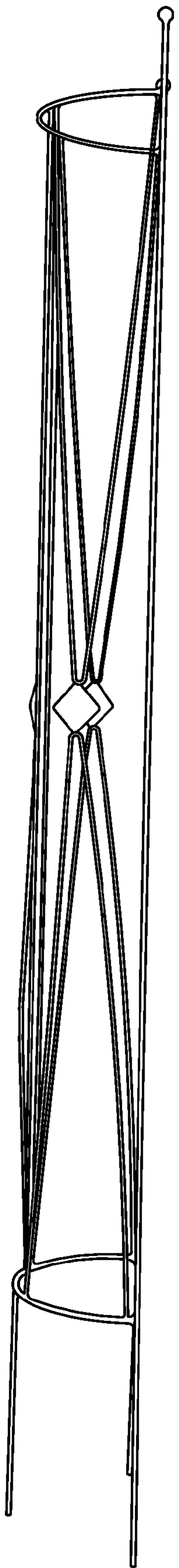

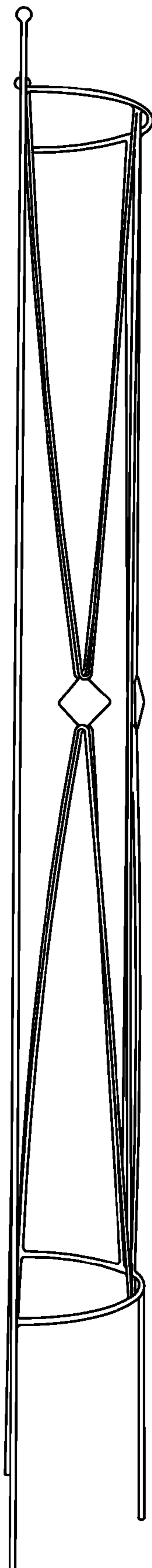

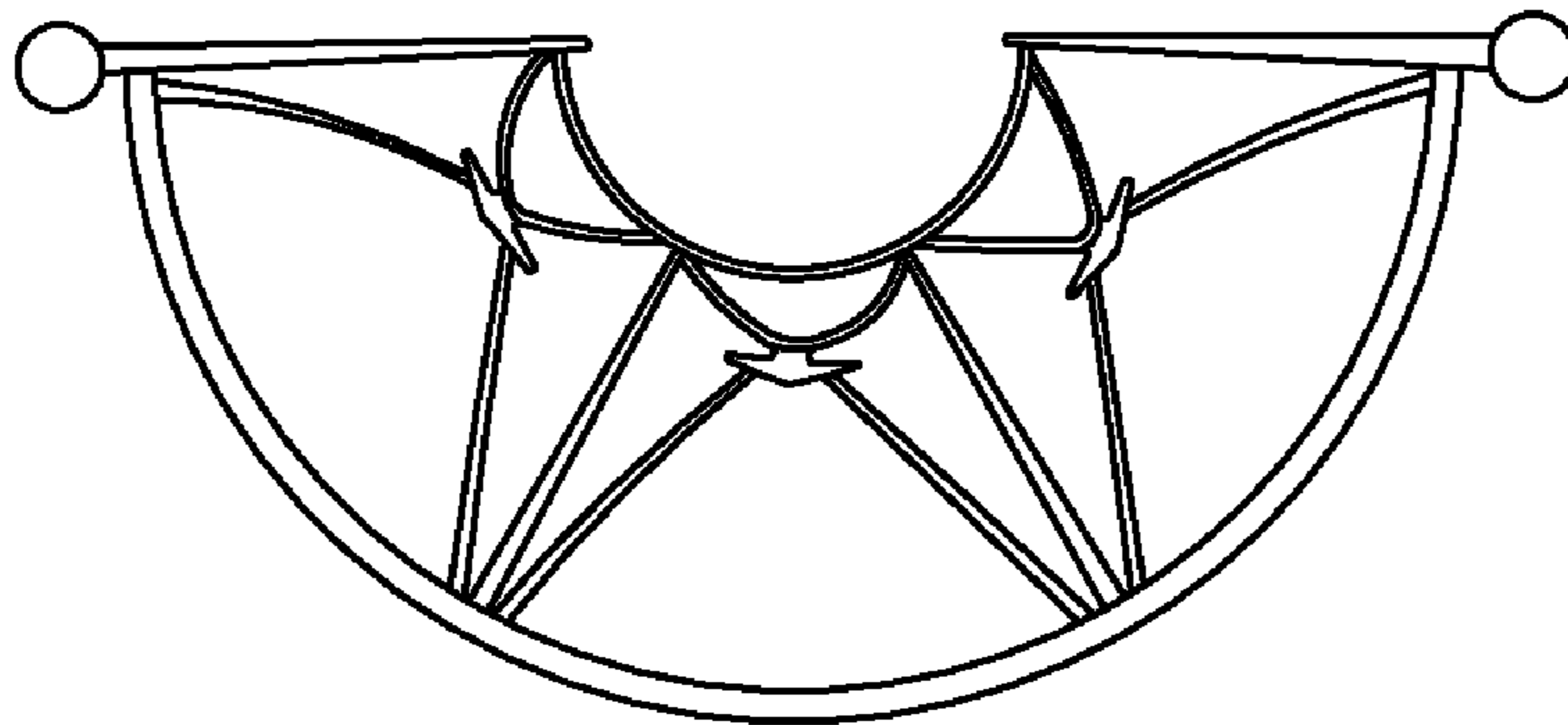

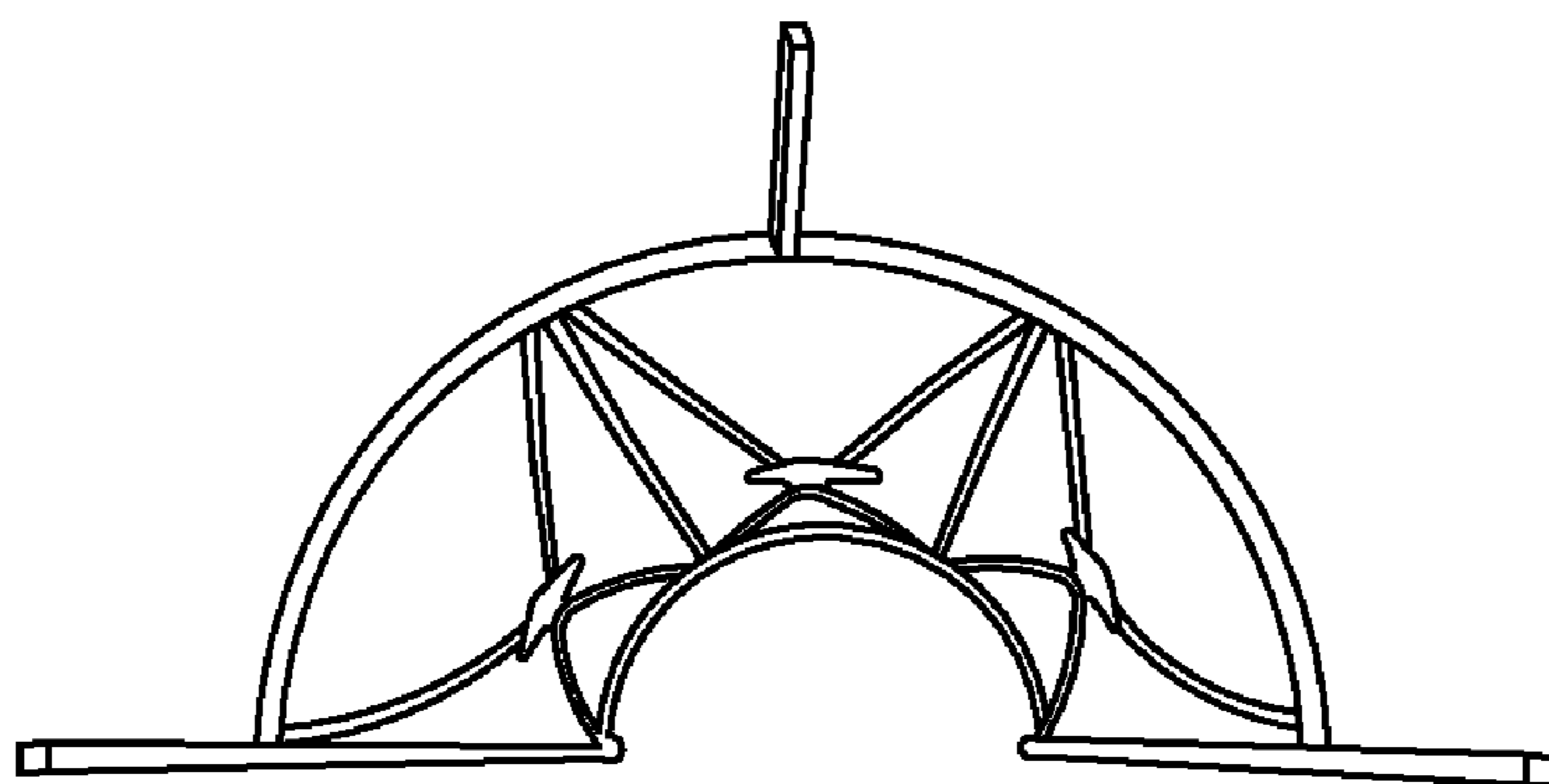

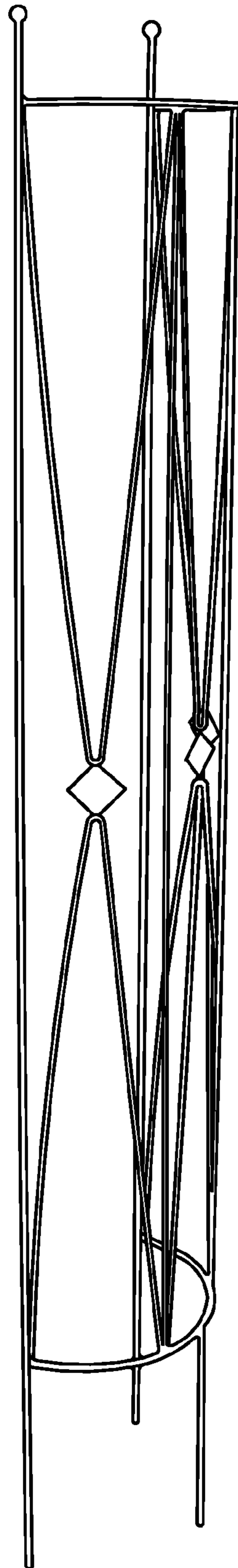

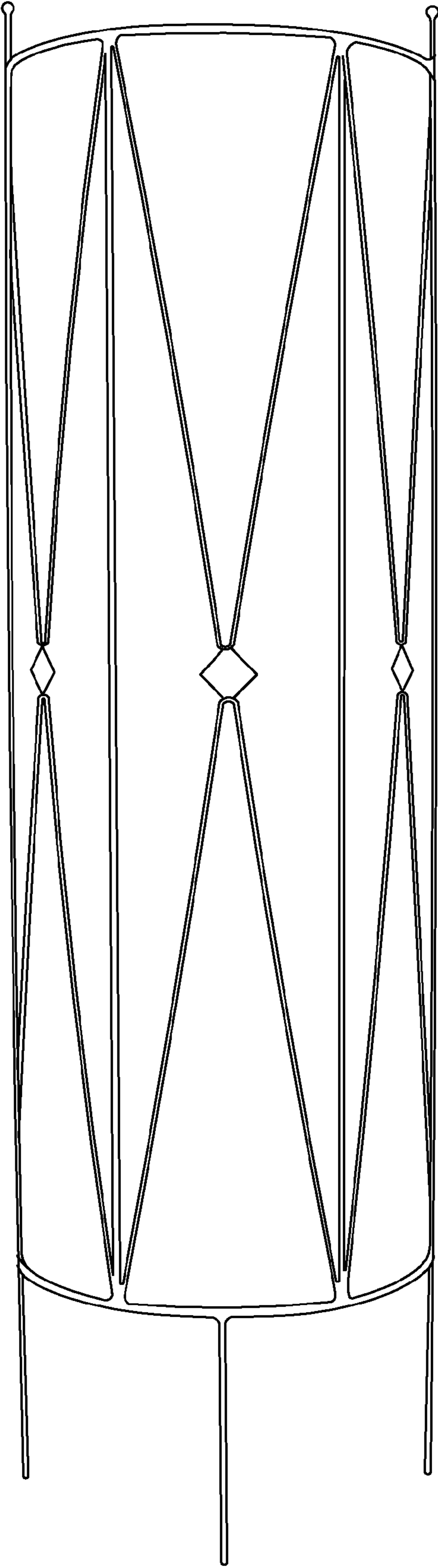

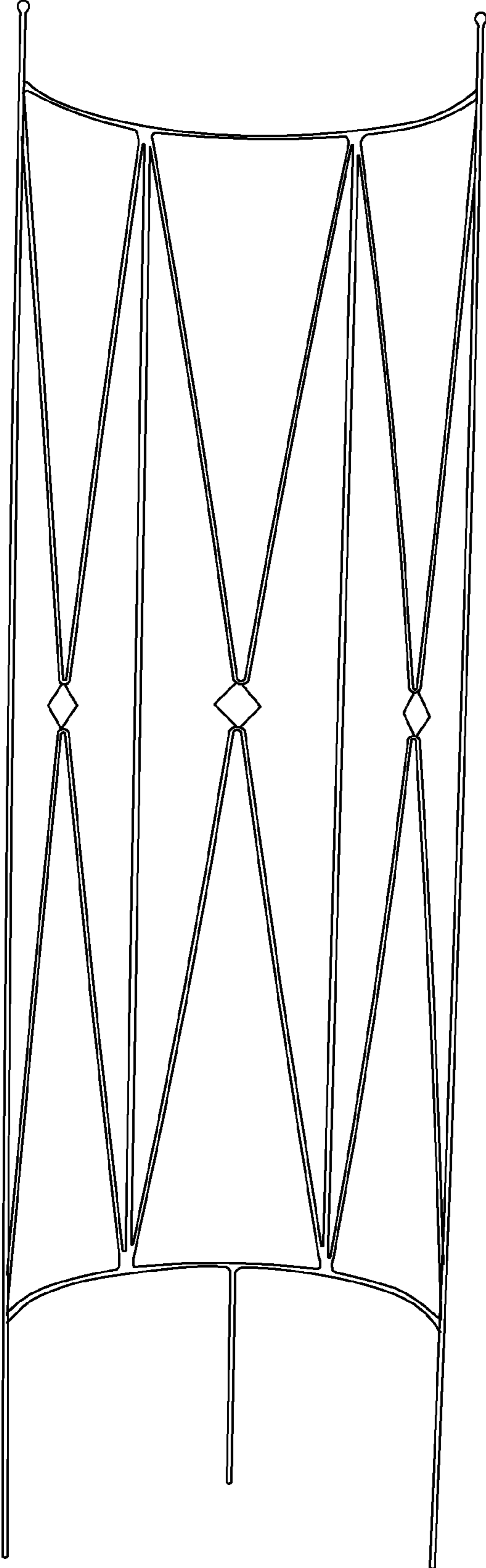

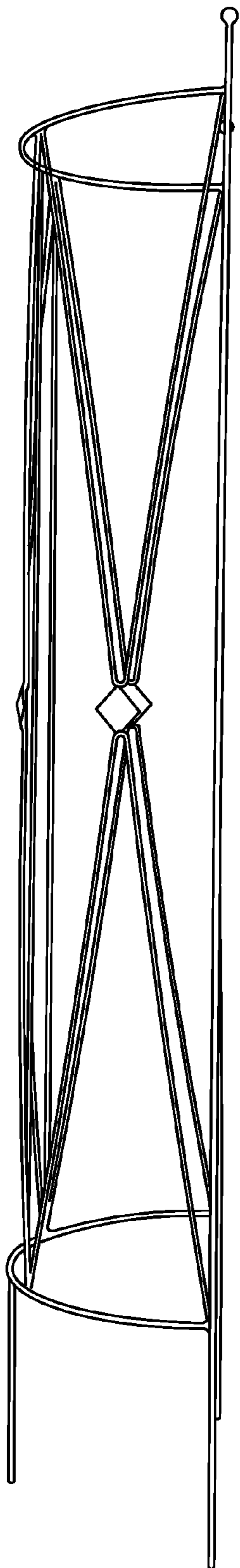

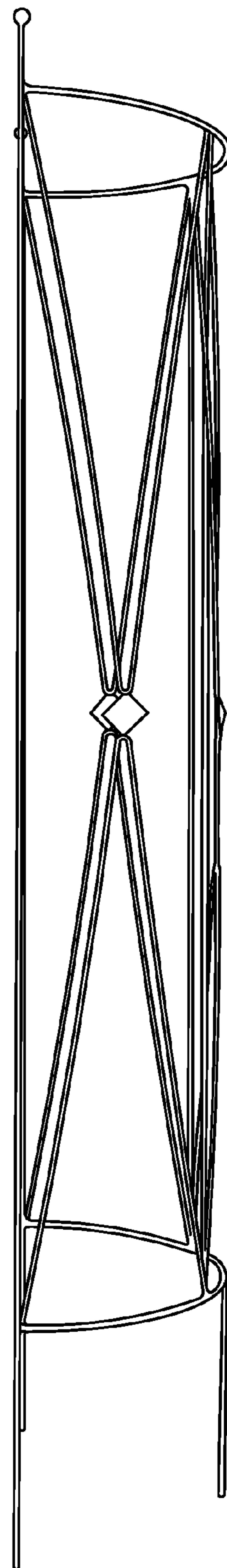

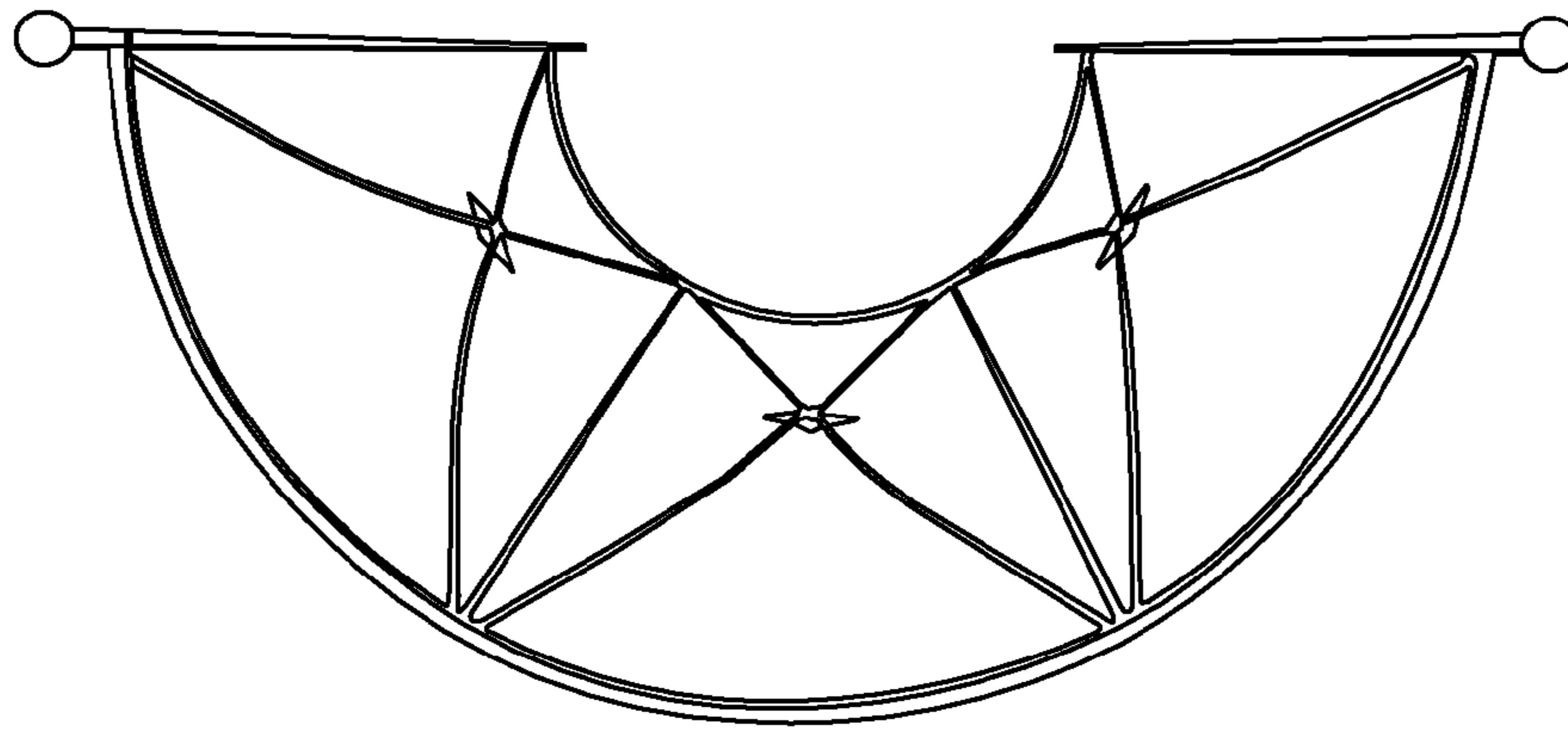

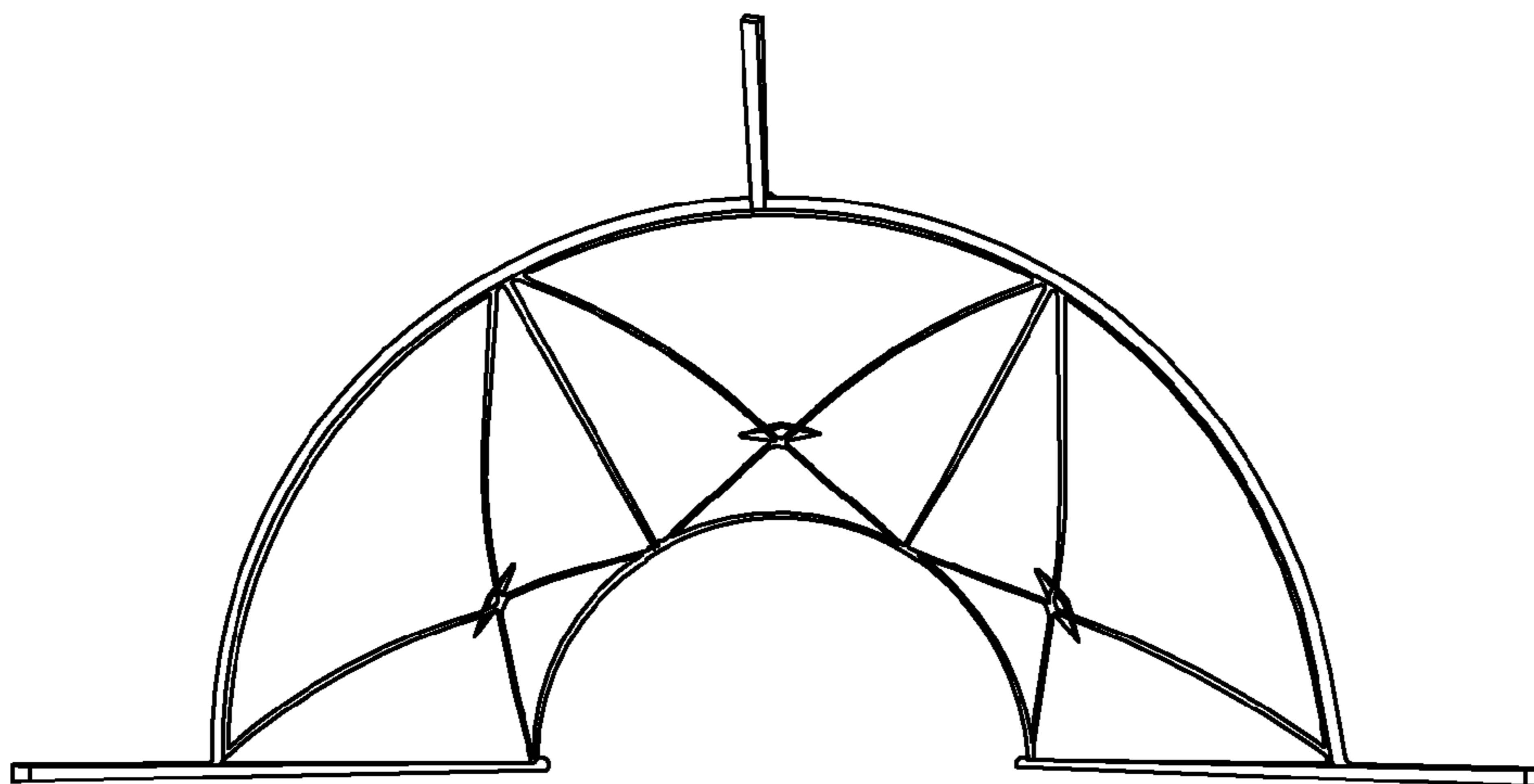

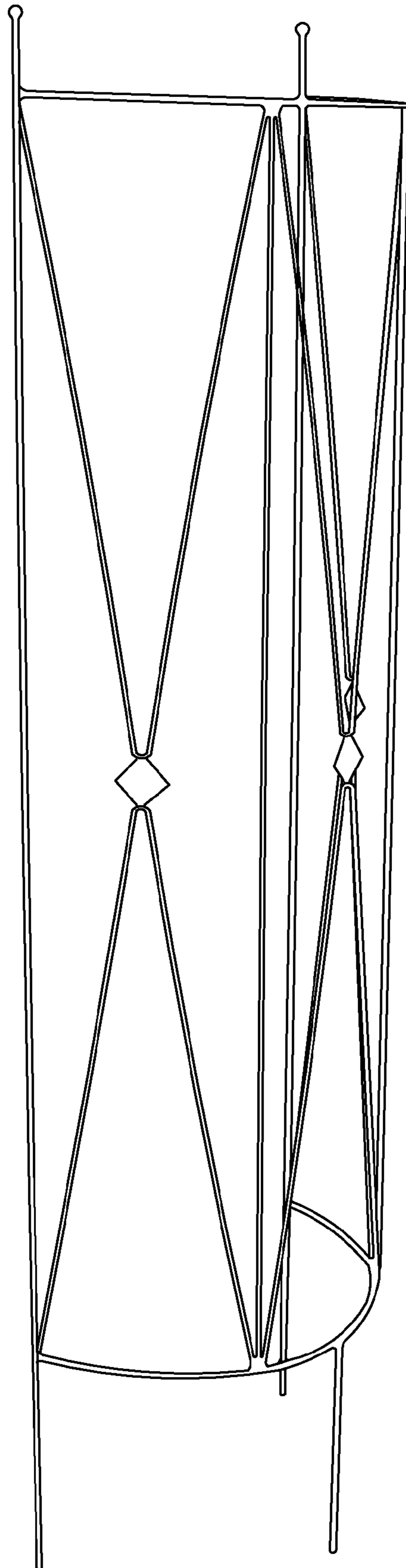
