The ornamental design for a lamp housing, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of the lamp housing showing
my new design;

FIG. 2 is a right side elevational view thereof, the left side
elevational view being a mirror image thereof;

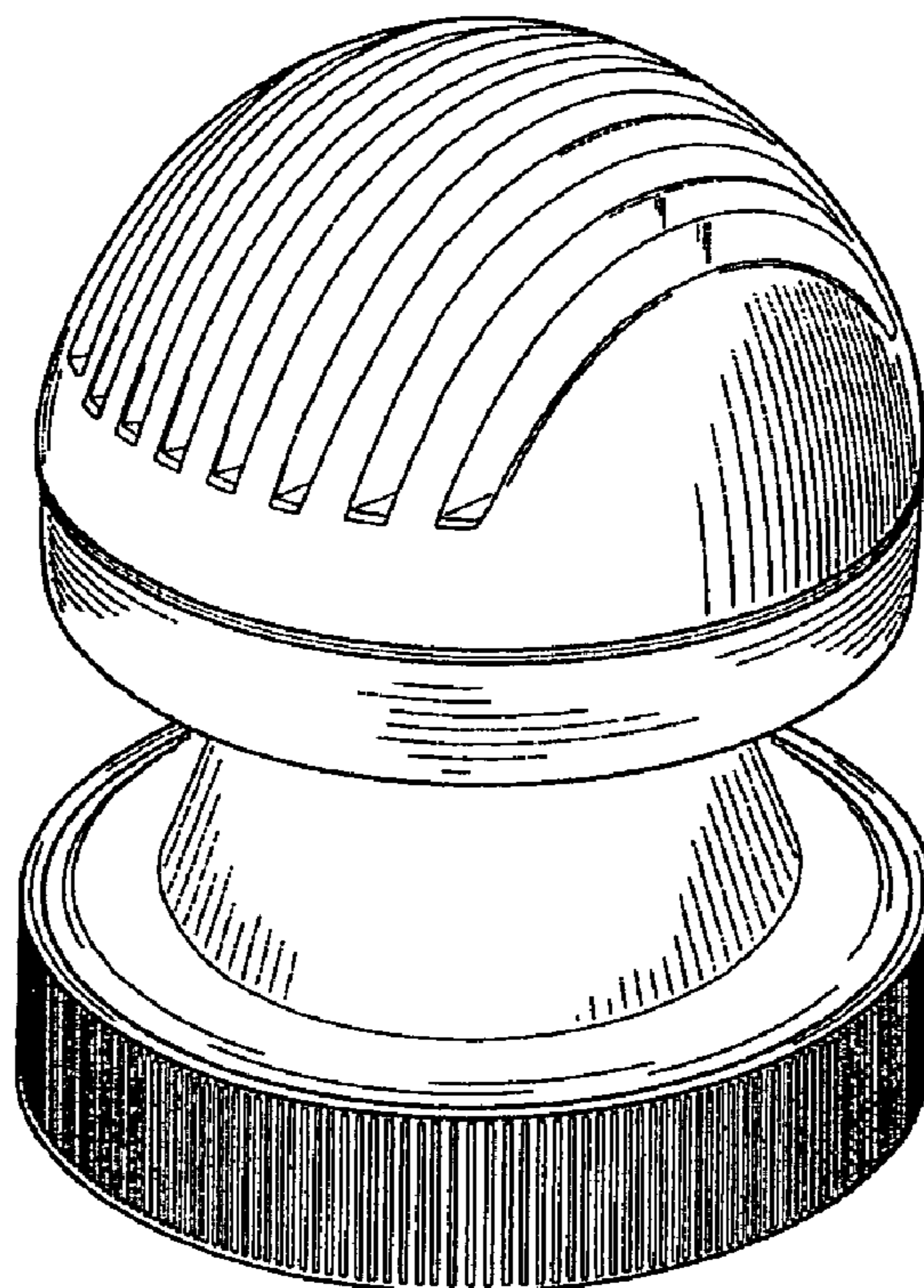
FIG. 3 is a front elevational view thereof, the rear elevational

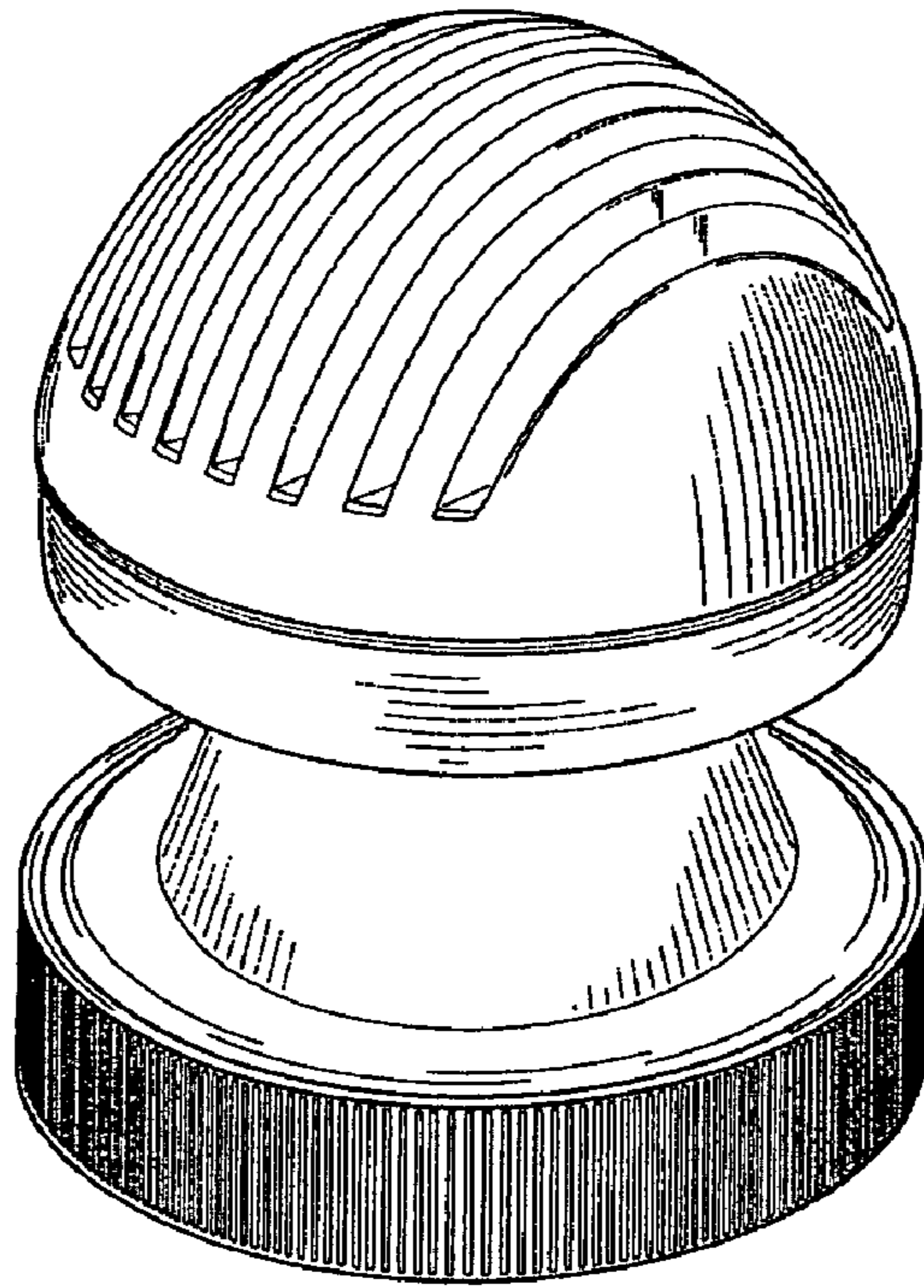

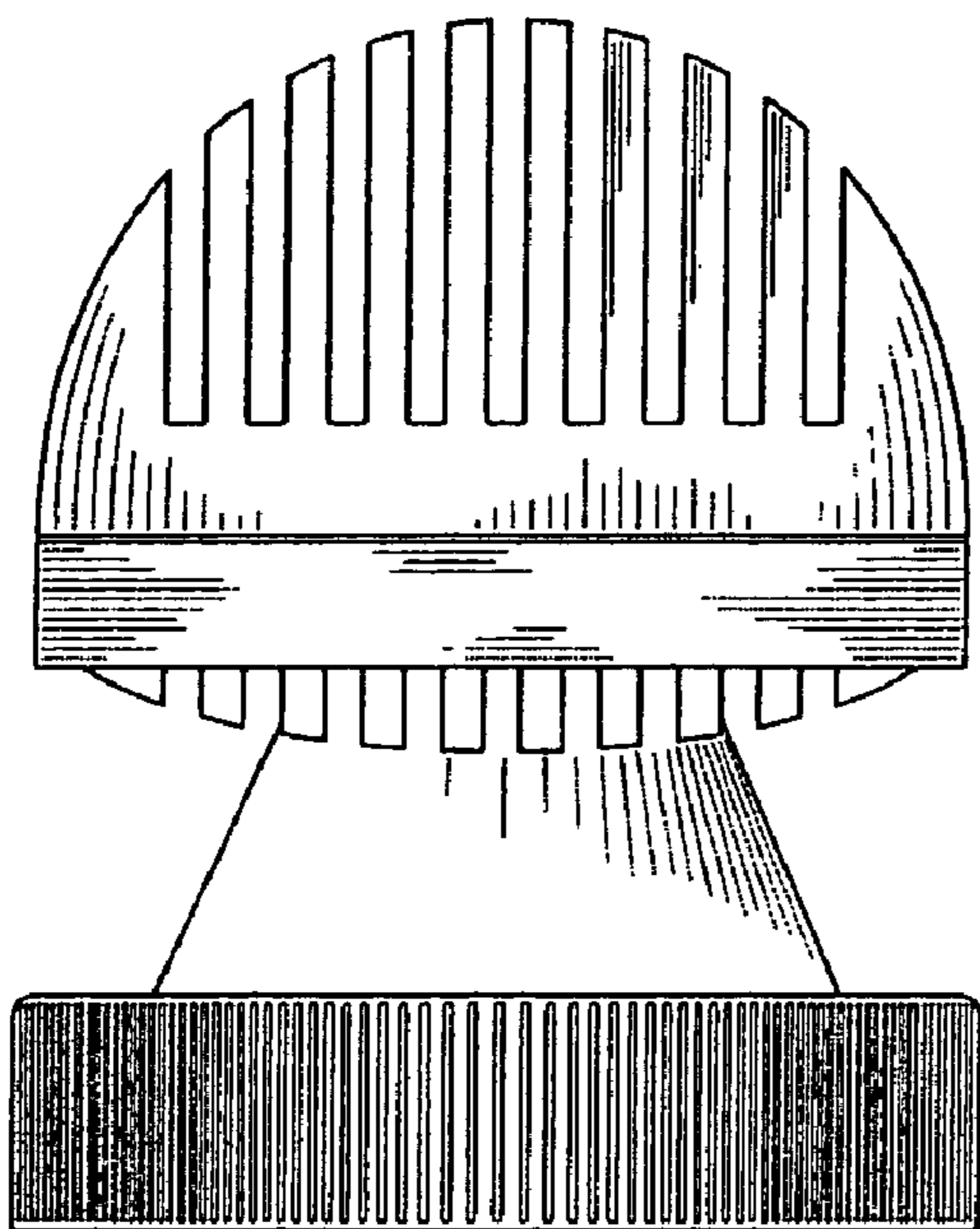

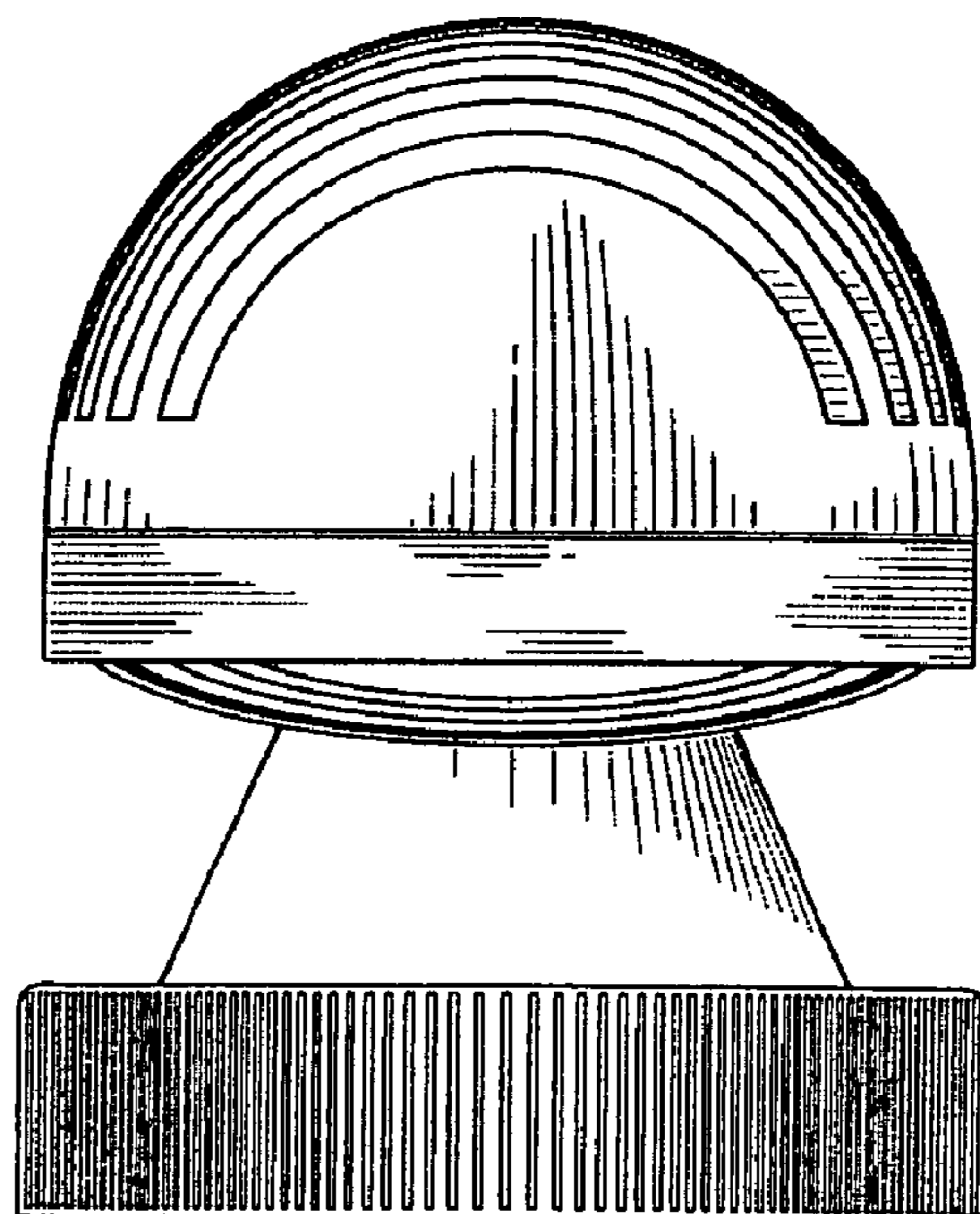

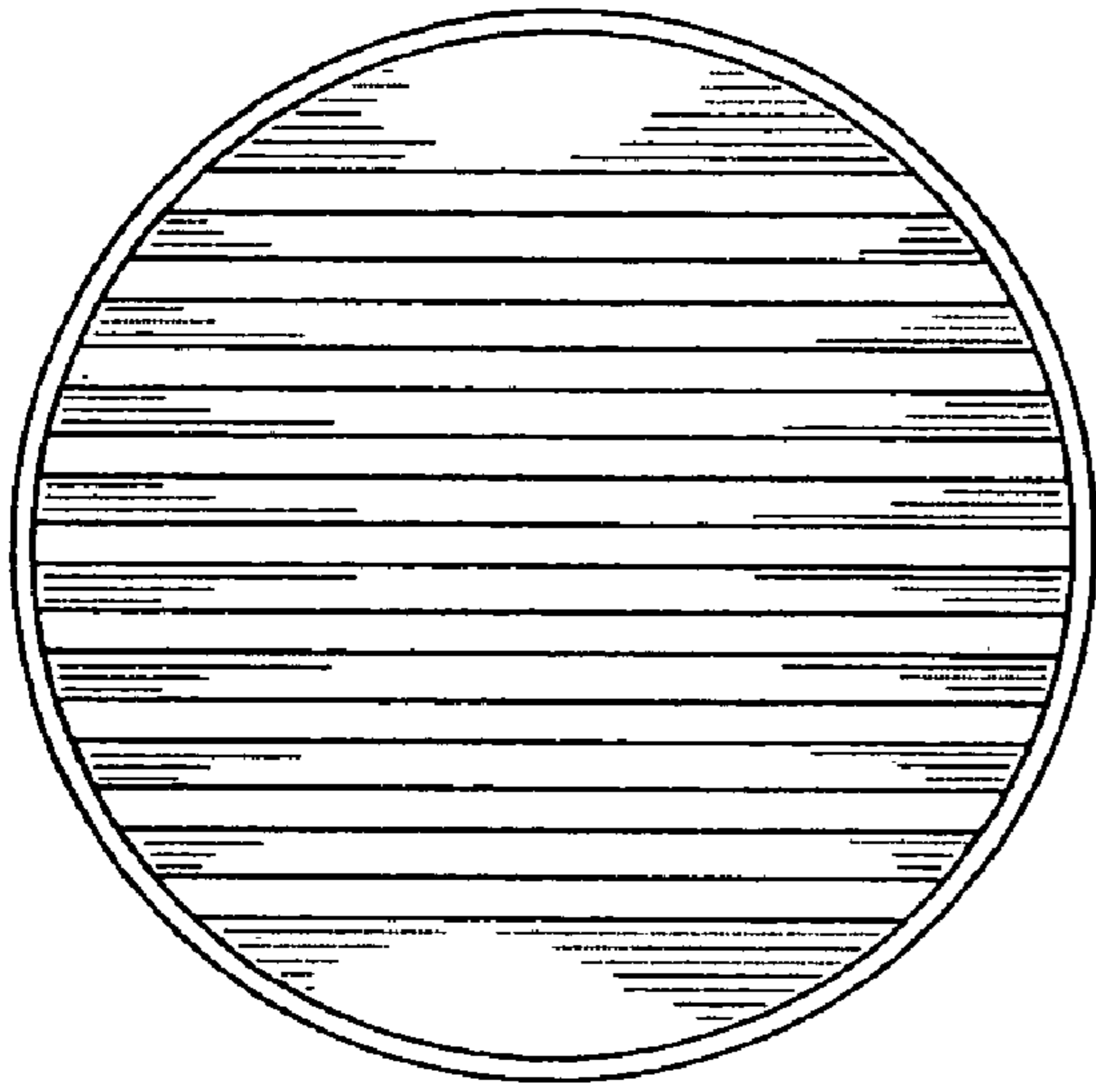

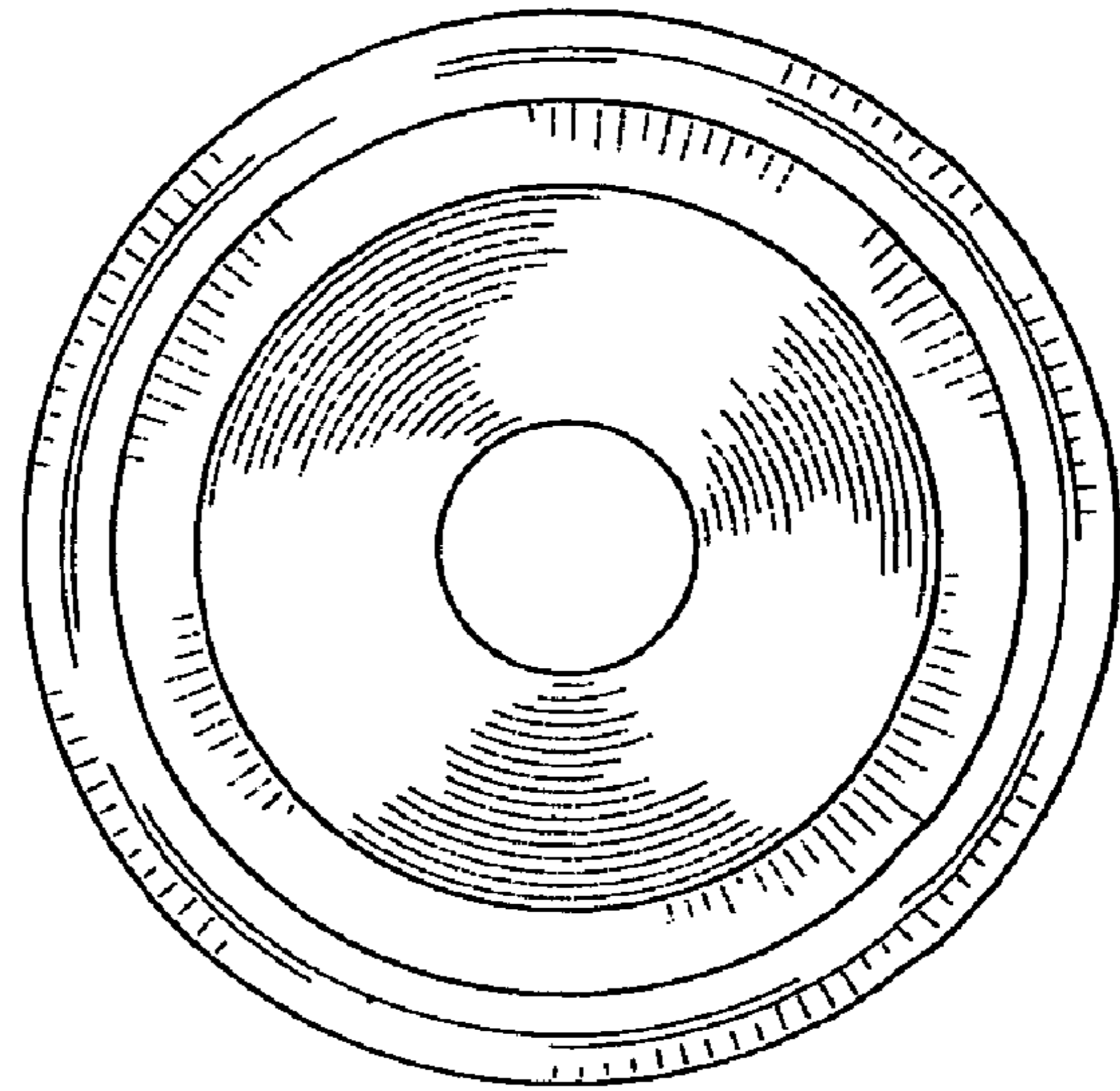

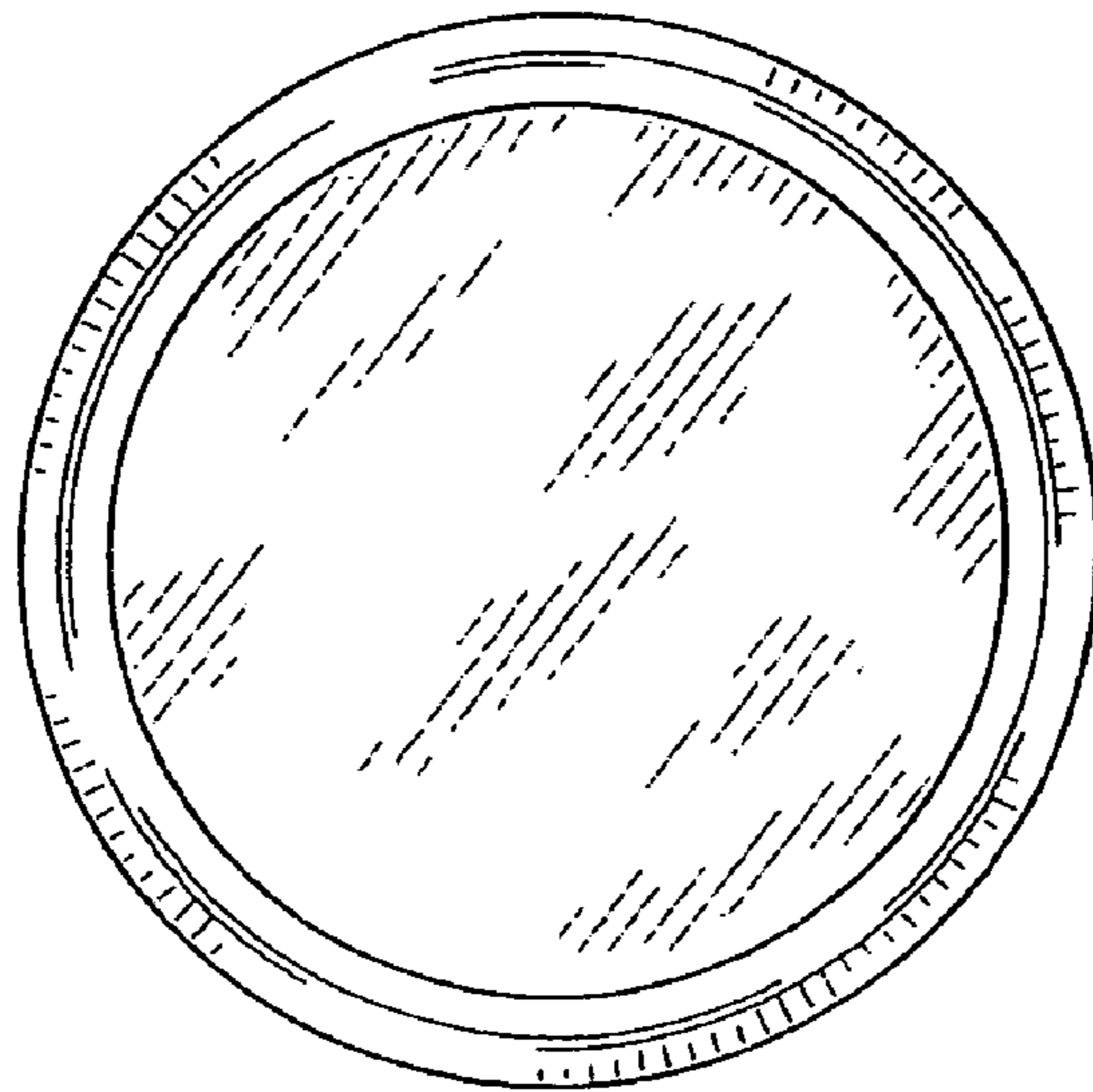
