FIG. 3 is a front view of the perfume sampler vaporizer of FIG. 1;

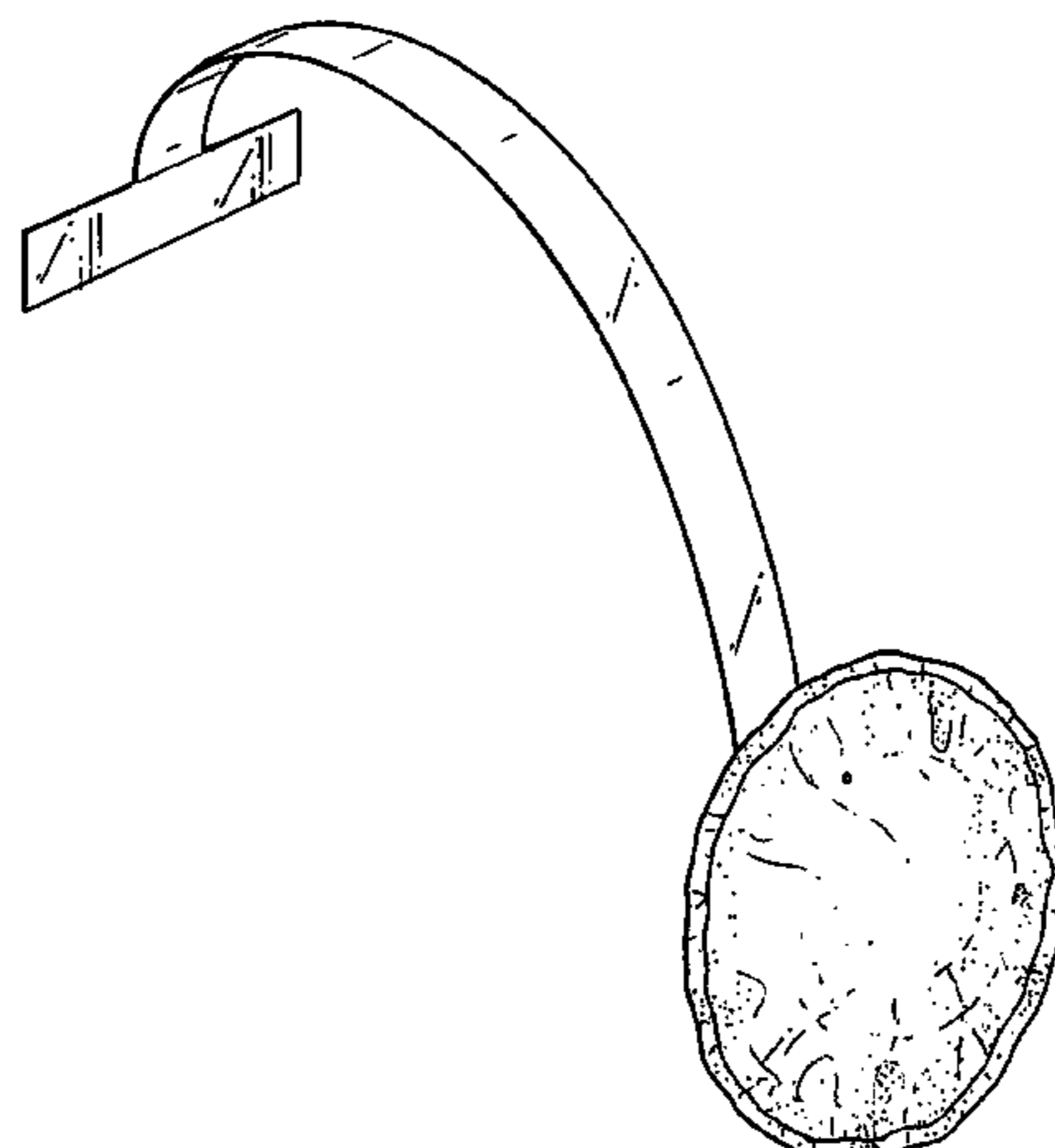
FIG. 4 is a left view of the perfume sampler vaporizer of FIG. 1;

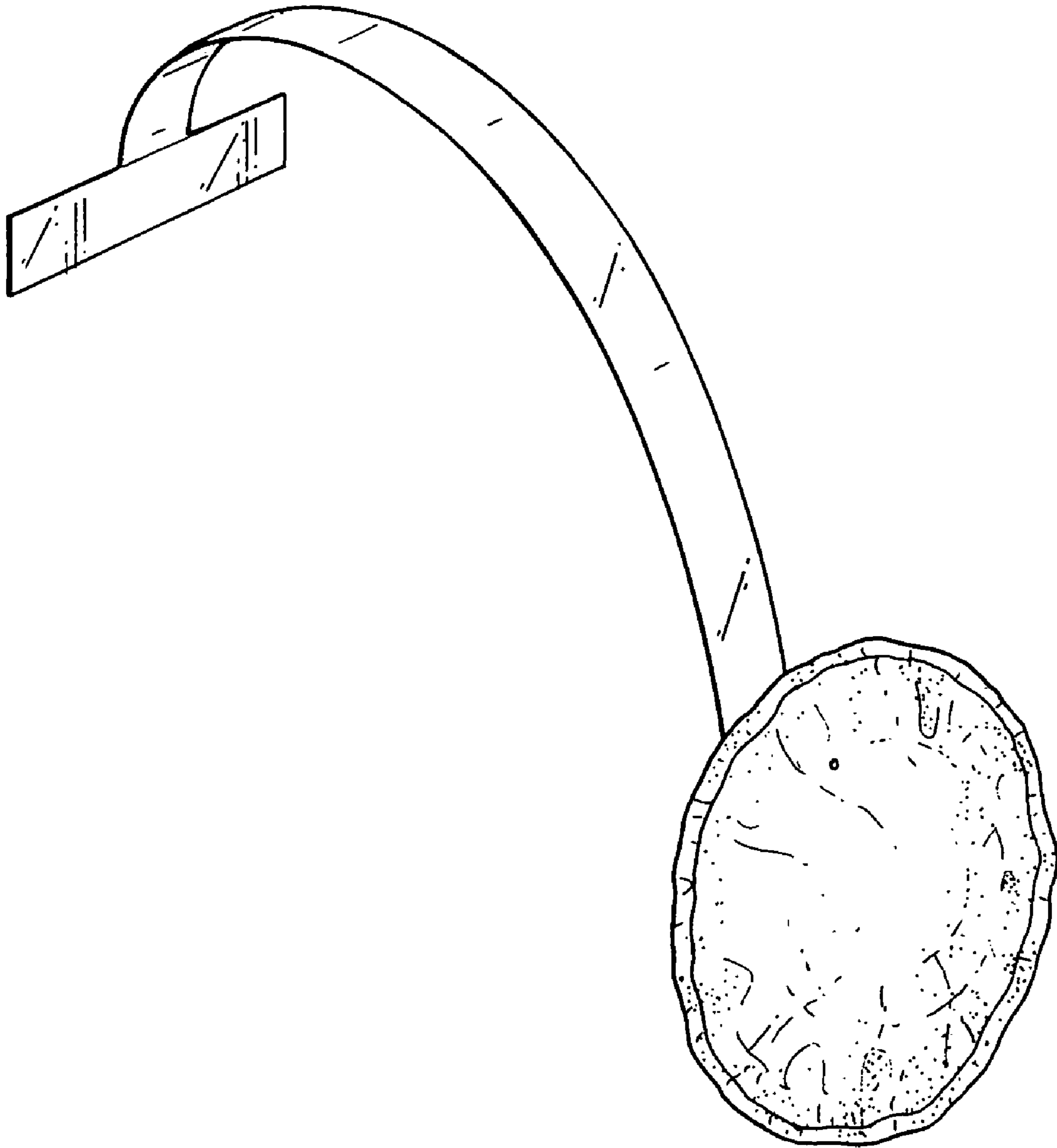

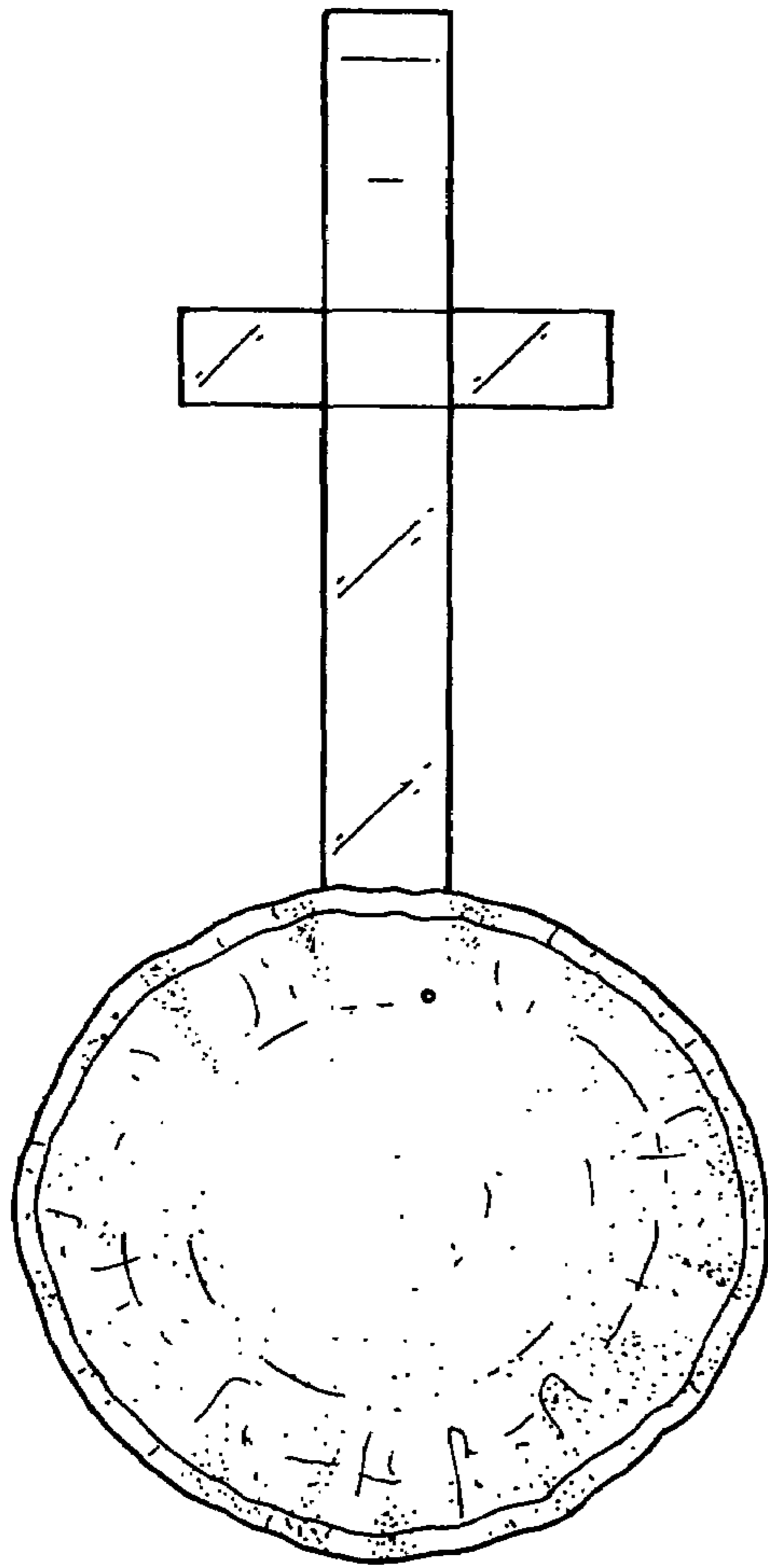

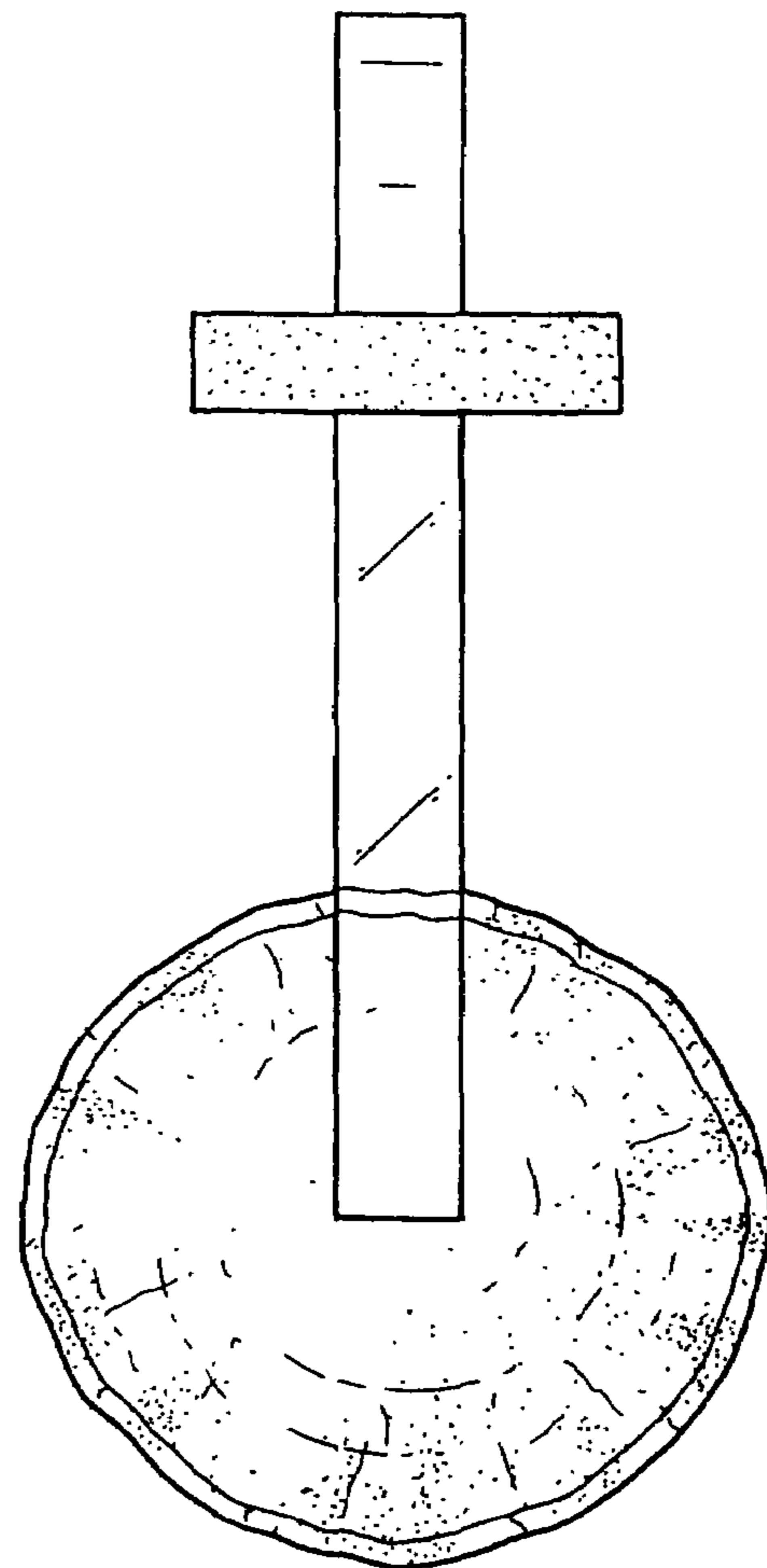

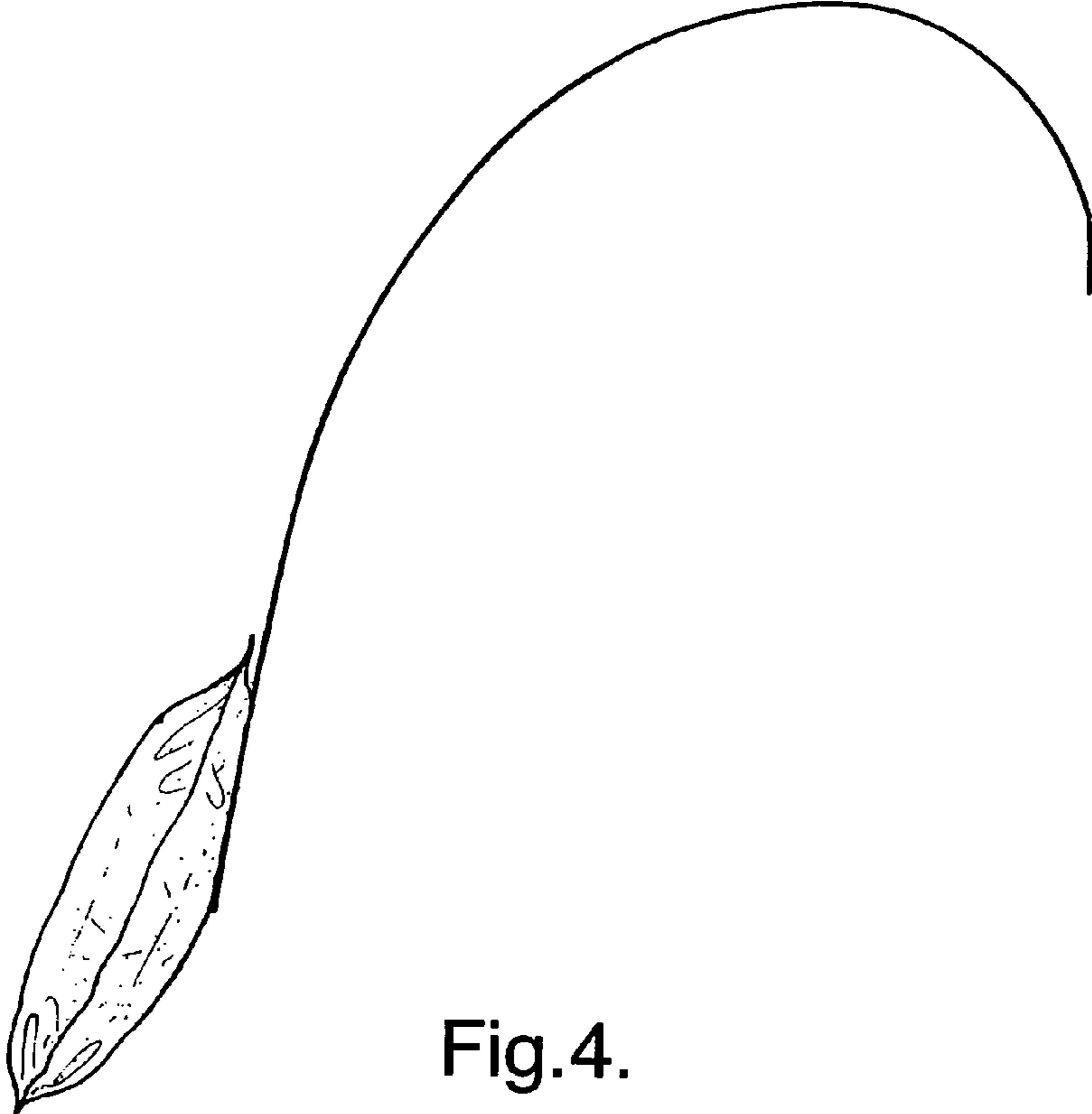

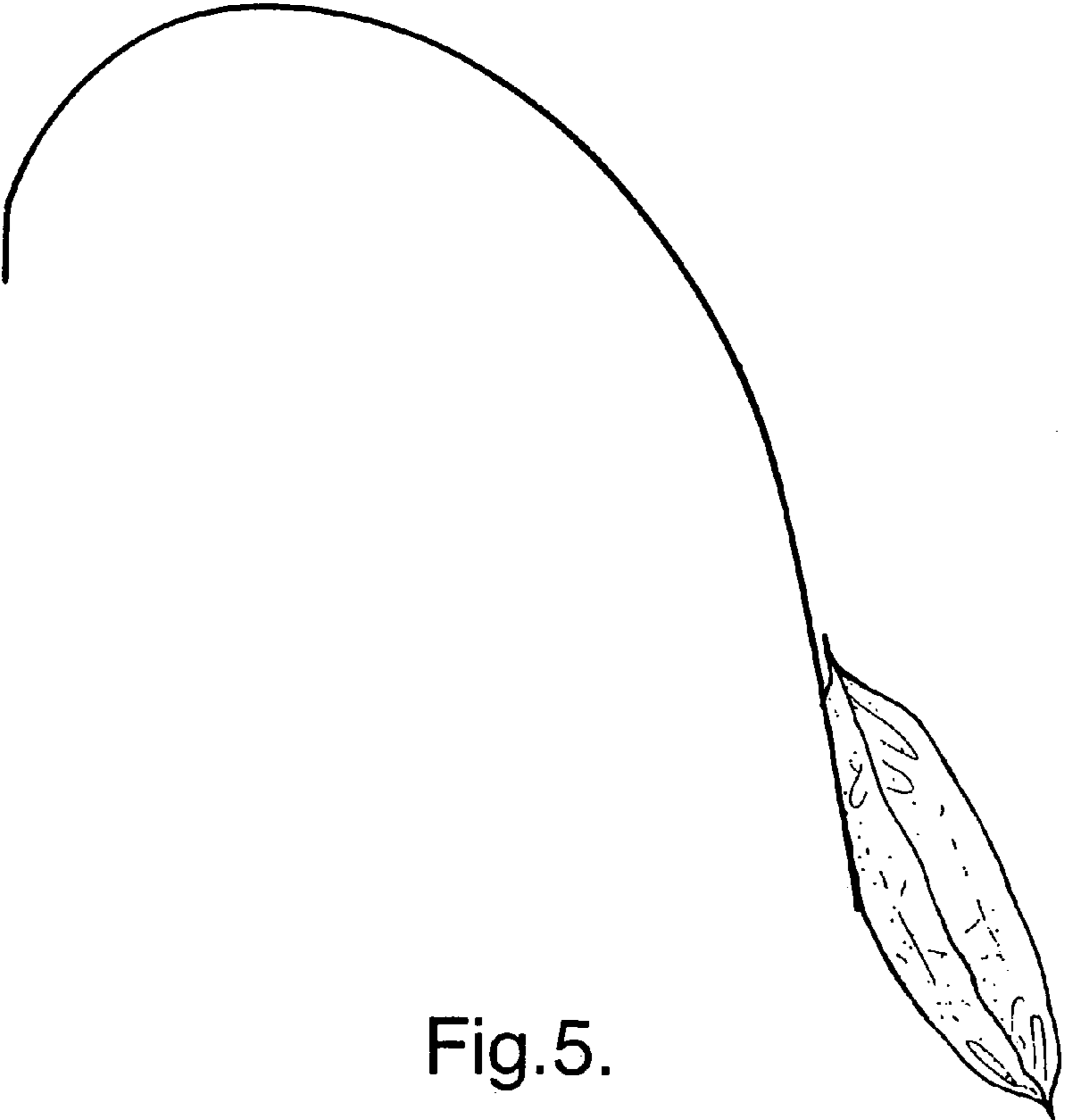

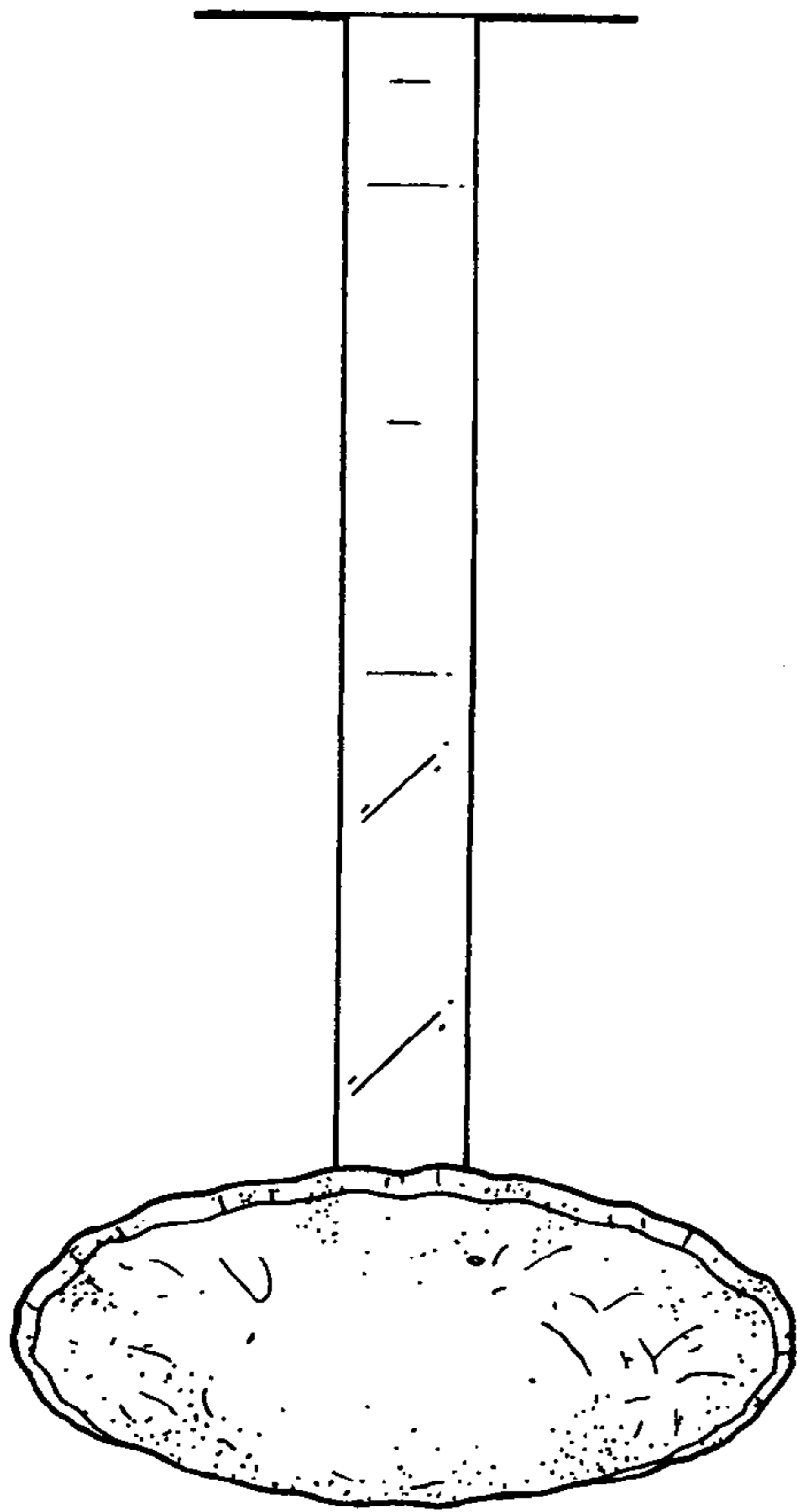

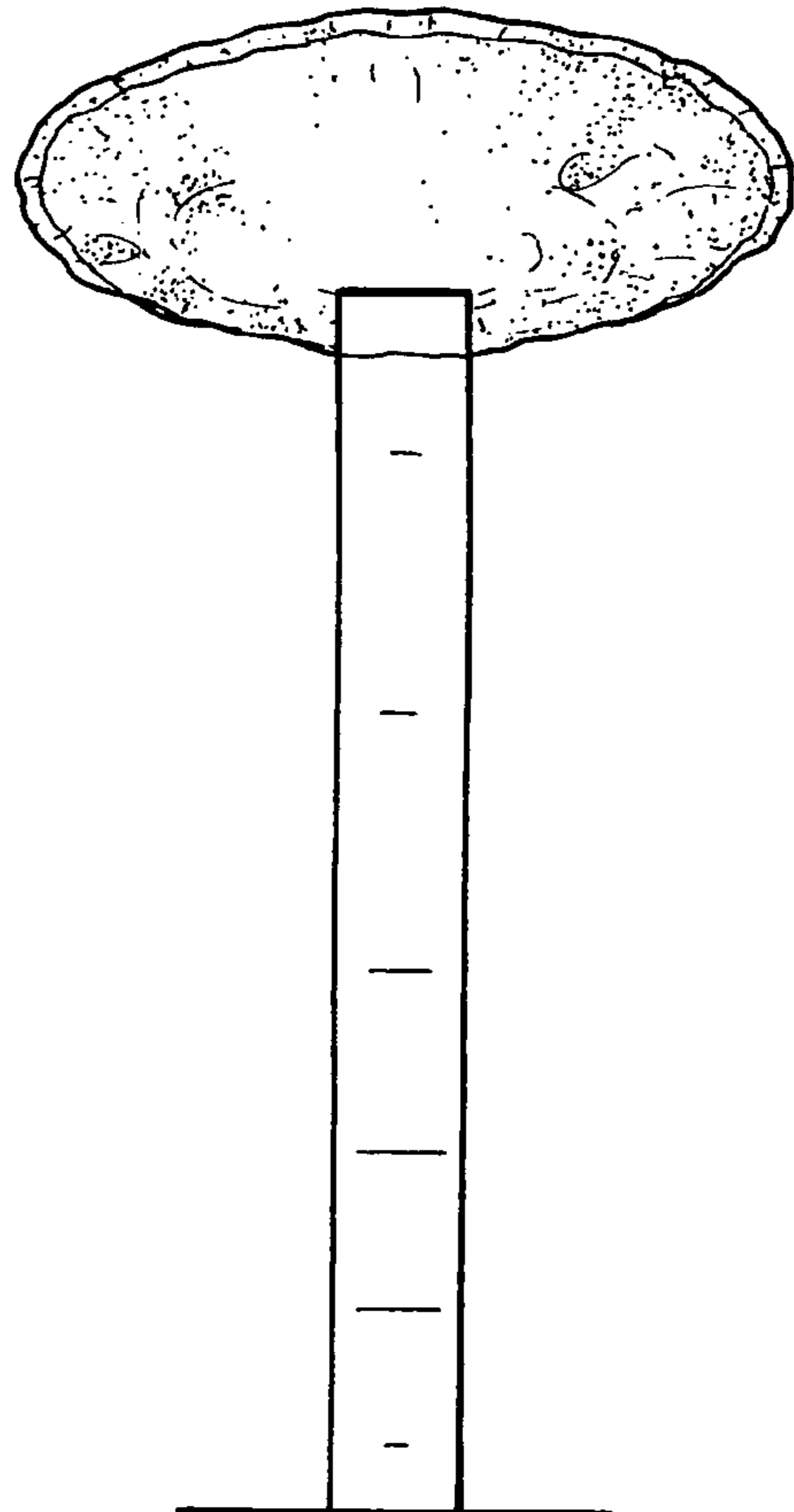
