DESCRIPTION

FIG. 1 is a front perspective view of the messaging device as shown in use.

FIG. 2 is a rear perspective view of the messaging device of FIG. 1 as shown in use.

FIG. 3 is a front side elevational view of the messaging device of FIG. 1.

FIG. 4 is a rear side elevational view of the messaging device of FIG. 1.

FIG. 5 is a top plan view of the messaging device of FIG. 1.

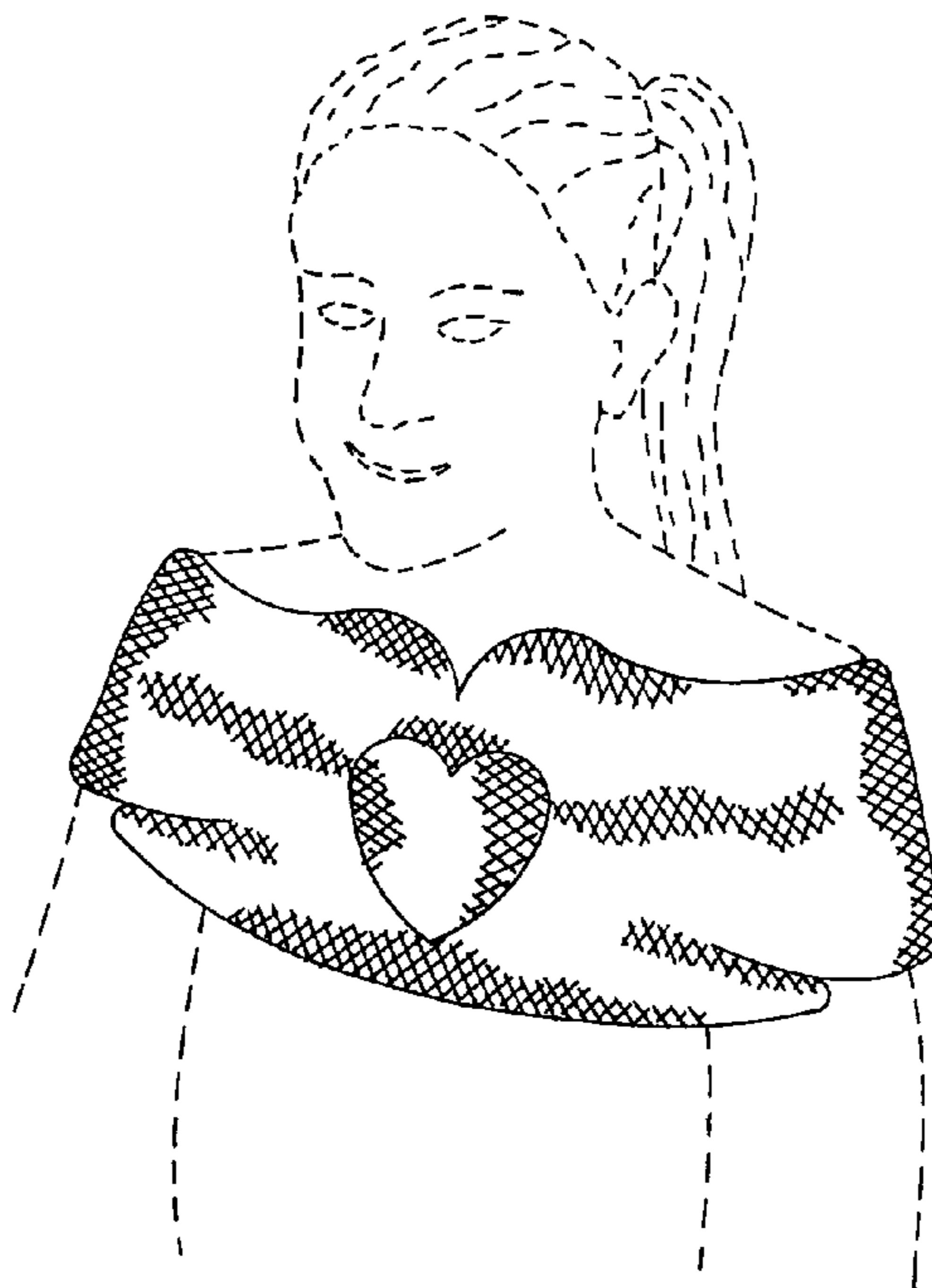
FIG. 6 is a bottom plan view of the messaging device of FIG. 1.

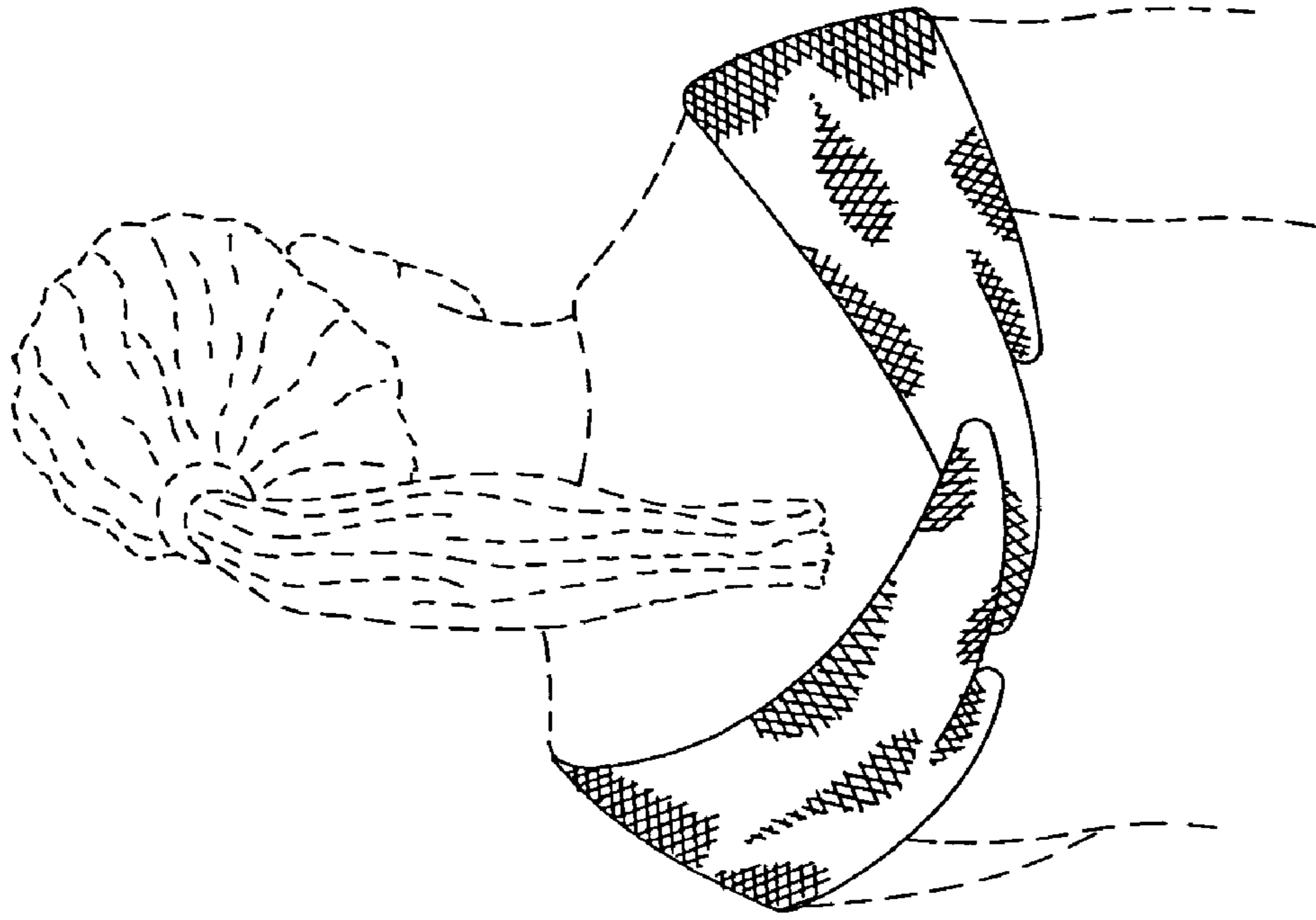

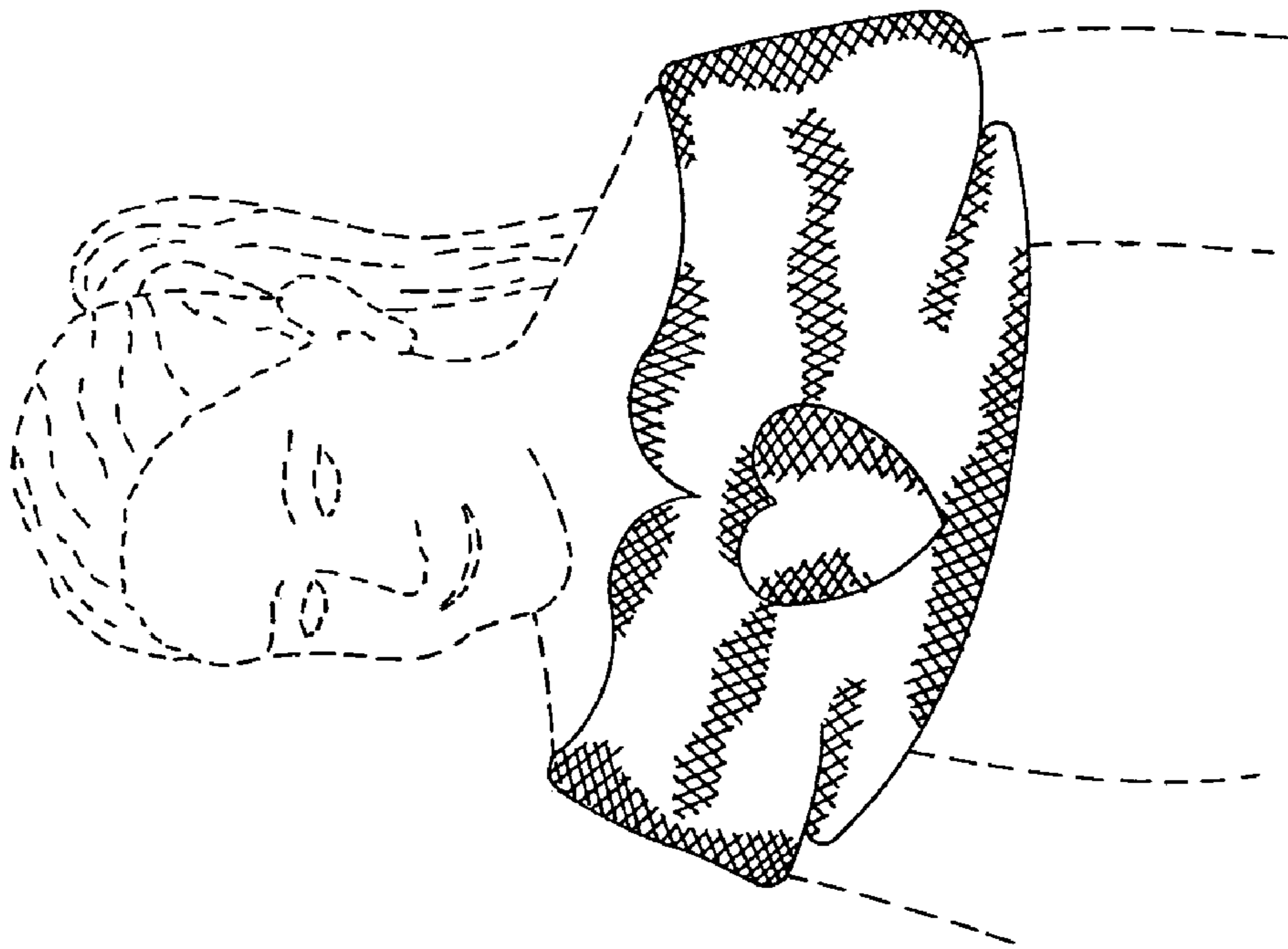

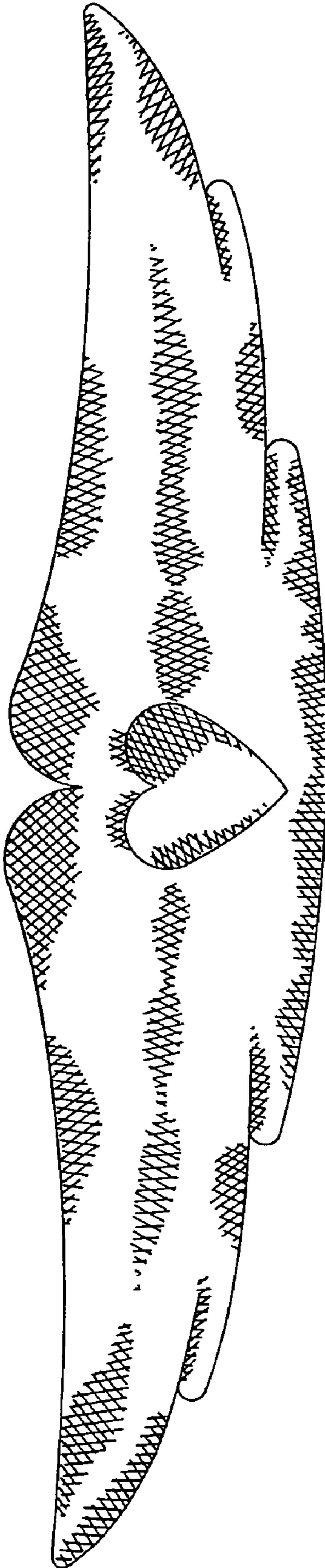

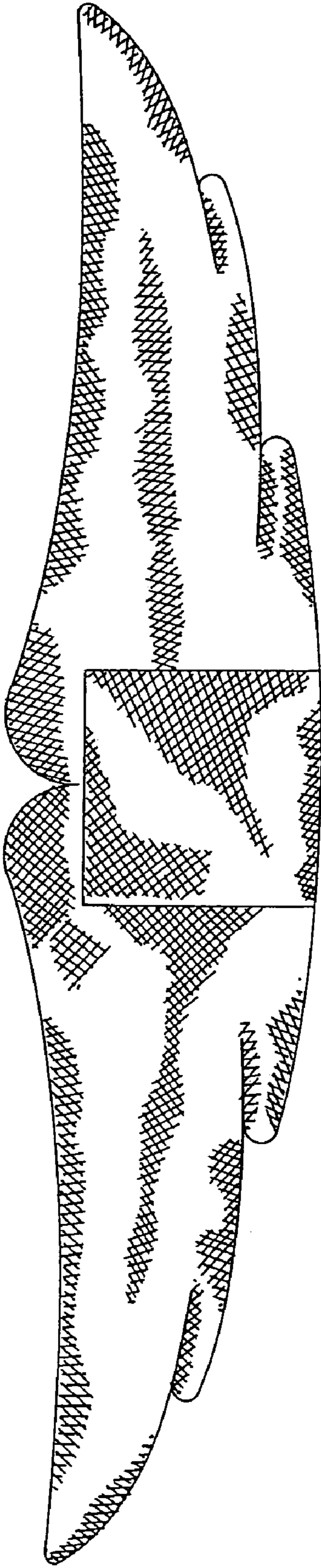
