(57) **CLAIM**

The ornamental design for a “sole for shoe,” as shown and described in the drawings.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a sole for shoe in accordance with the new design;

FIG. 2 is a left side perspective view thereof;

FIG. 3 is a right side perspective view thereof;

FIG. 4 is a front and top perspective view thereof;

FIG. 5 is a rear and bottom perspective view thereof;

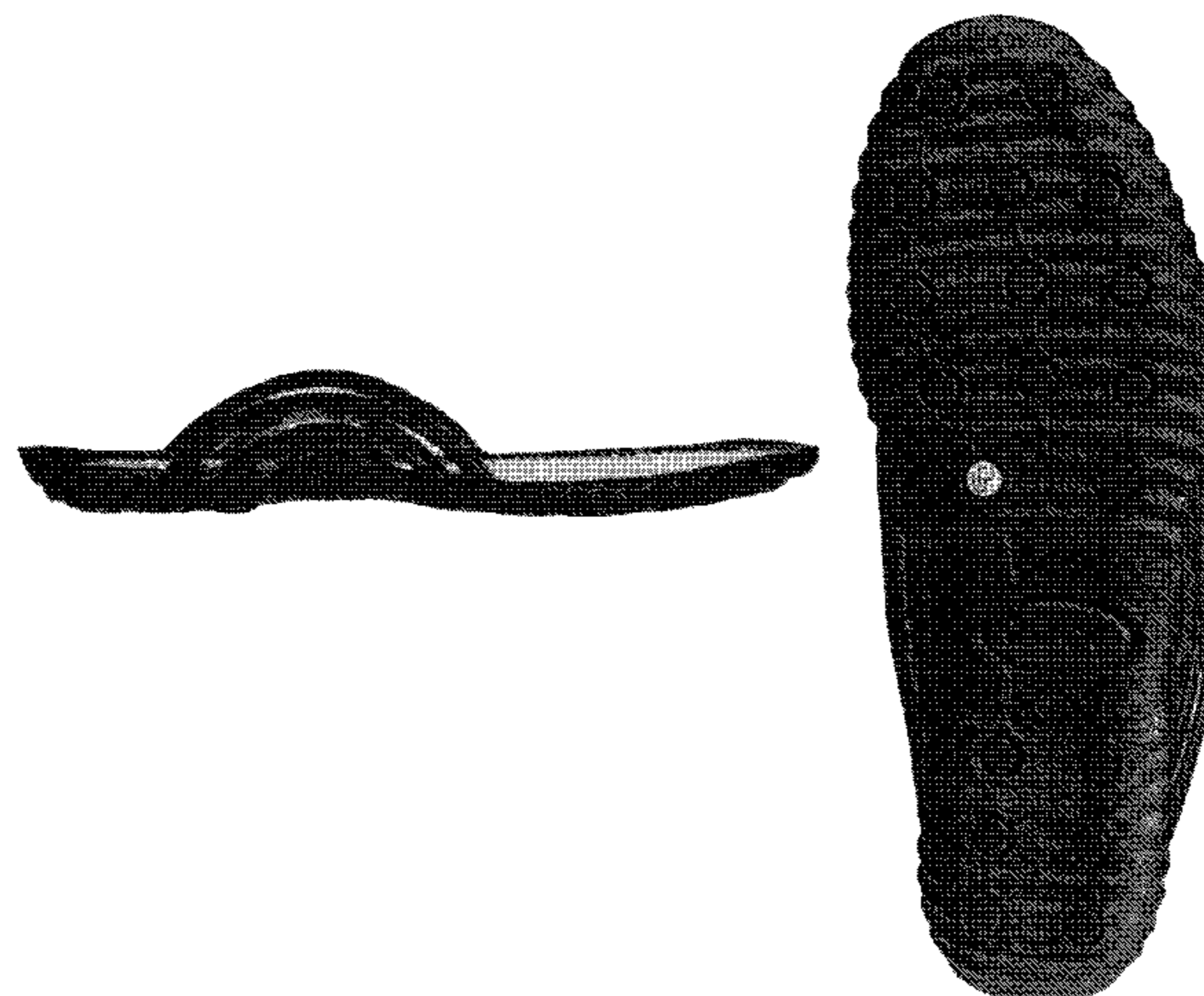
FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

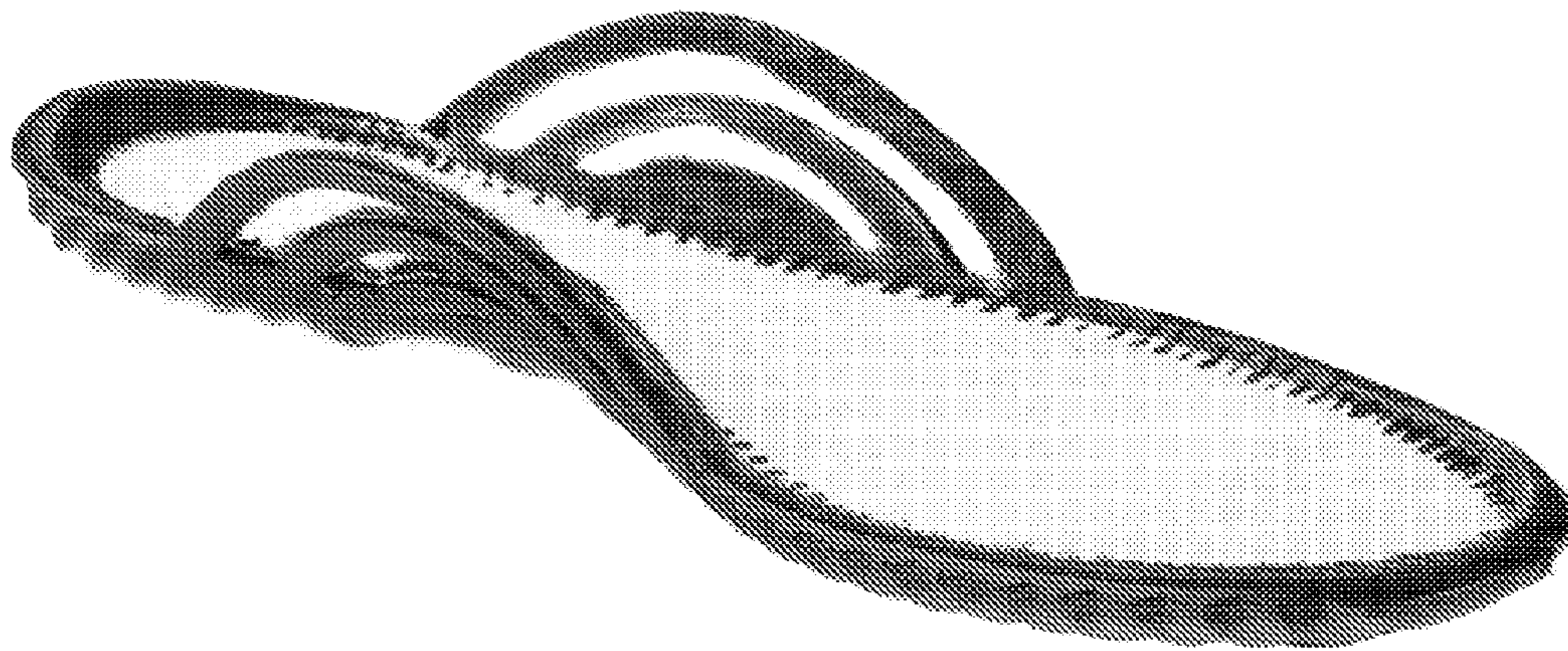

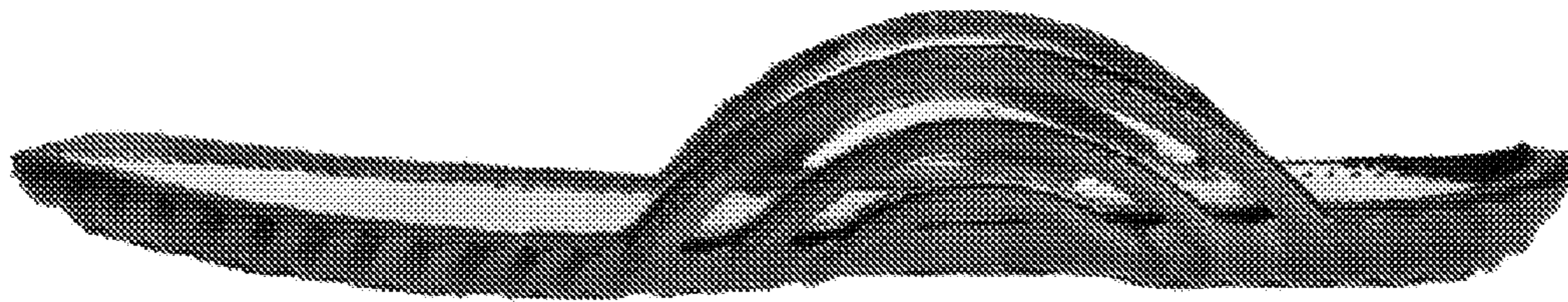

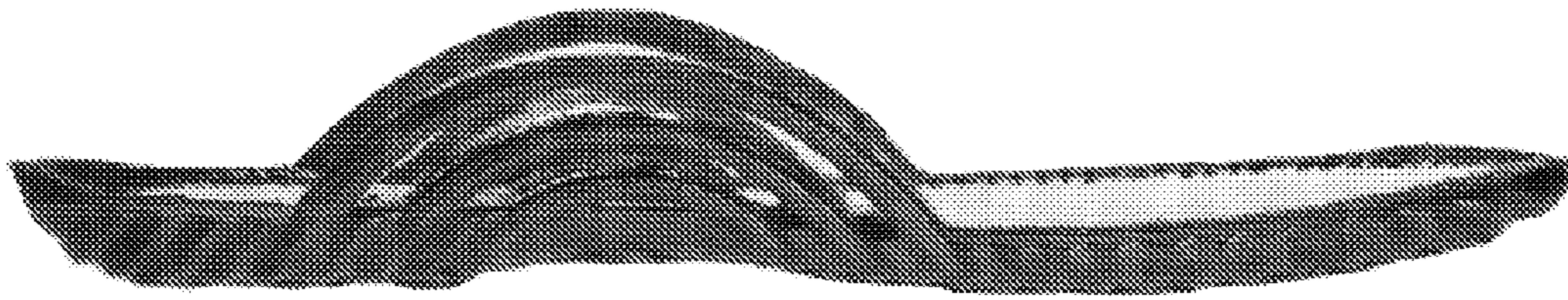

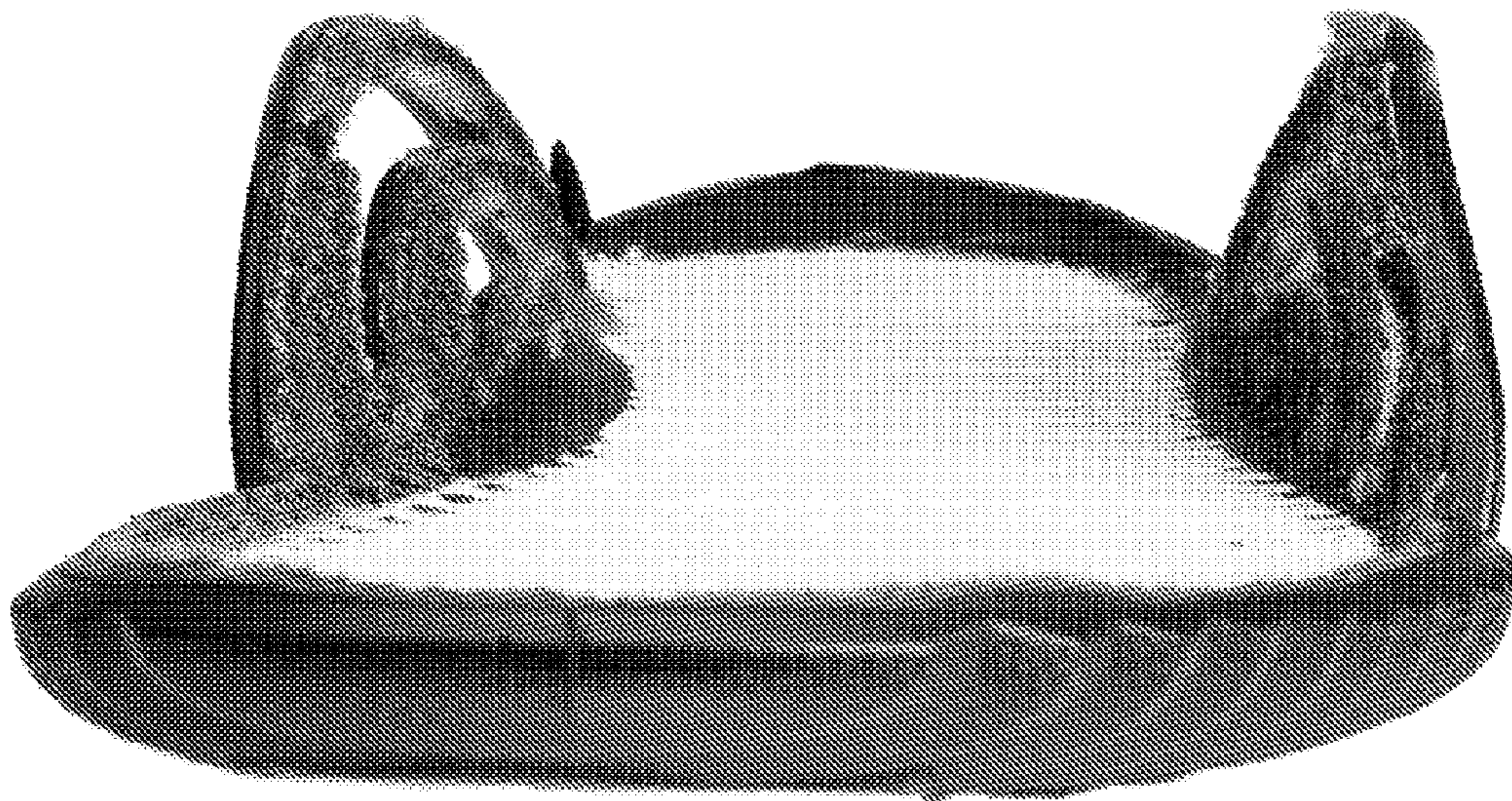

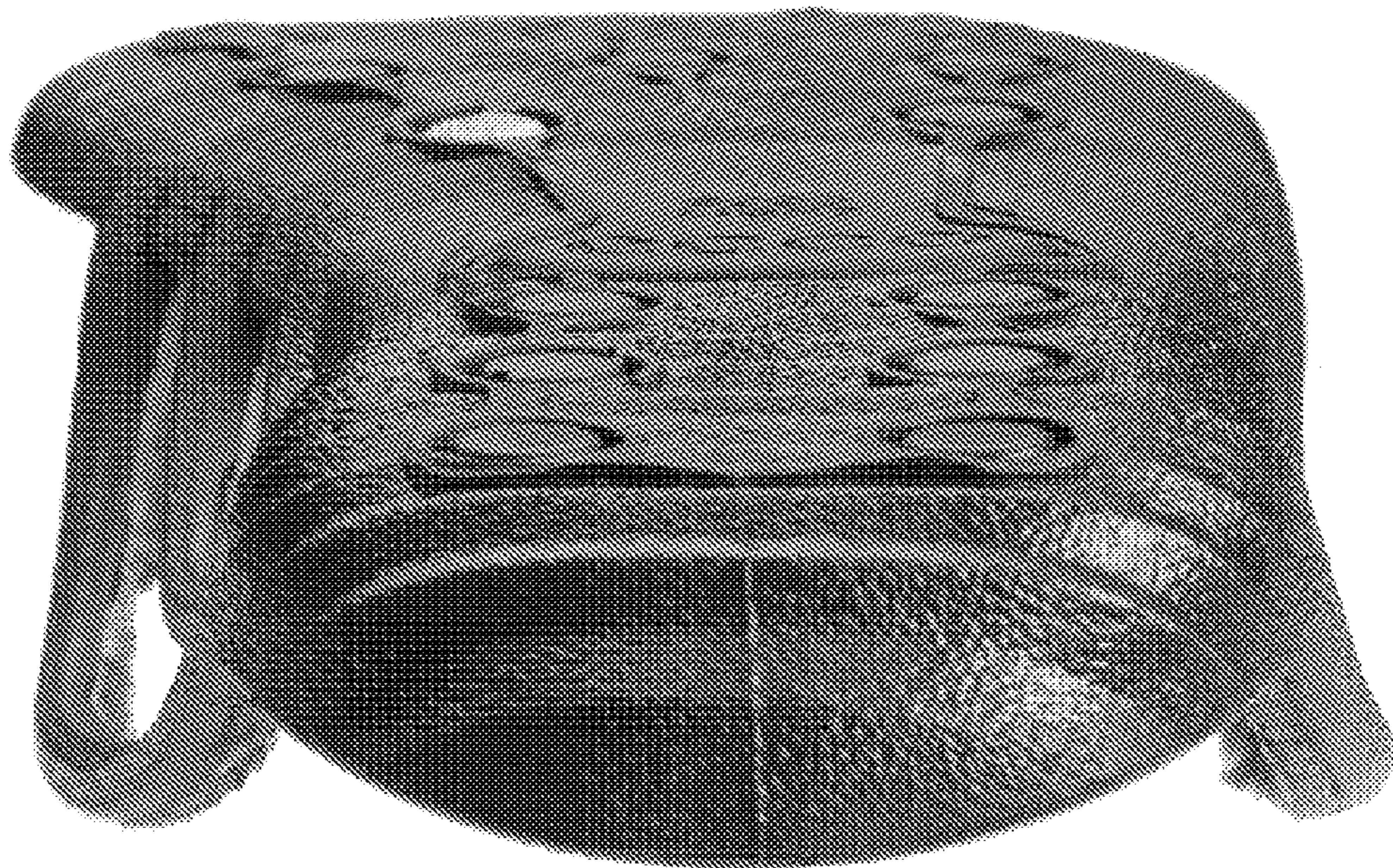

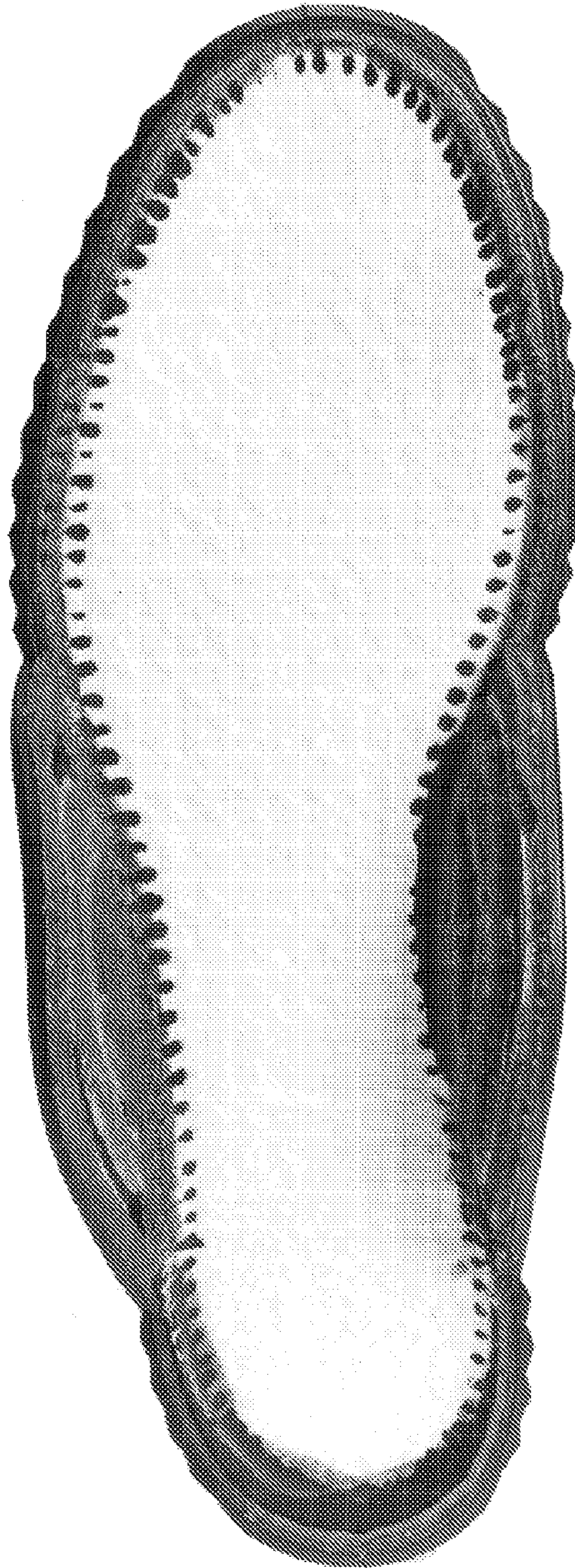
