The ornamental design for a mascara brush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mascara brush showing our new design;

FIG. 4 is a right side elevation view thereof;

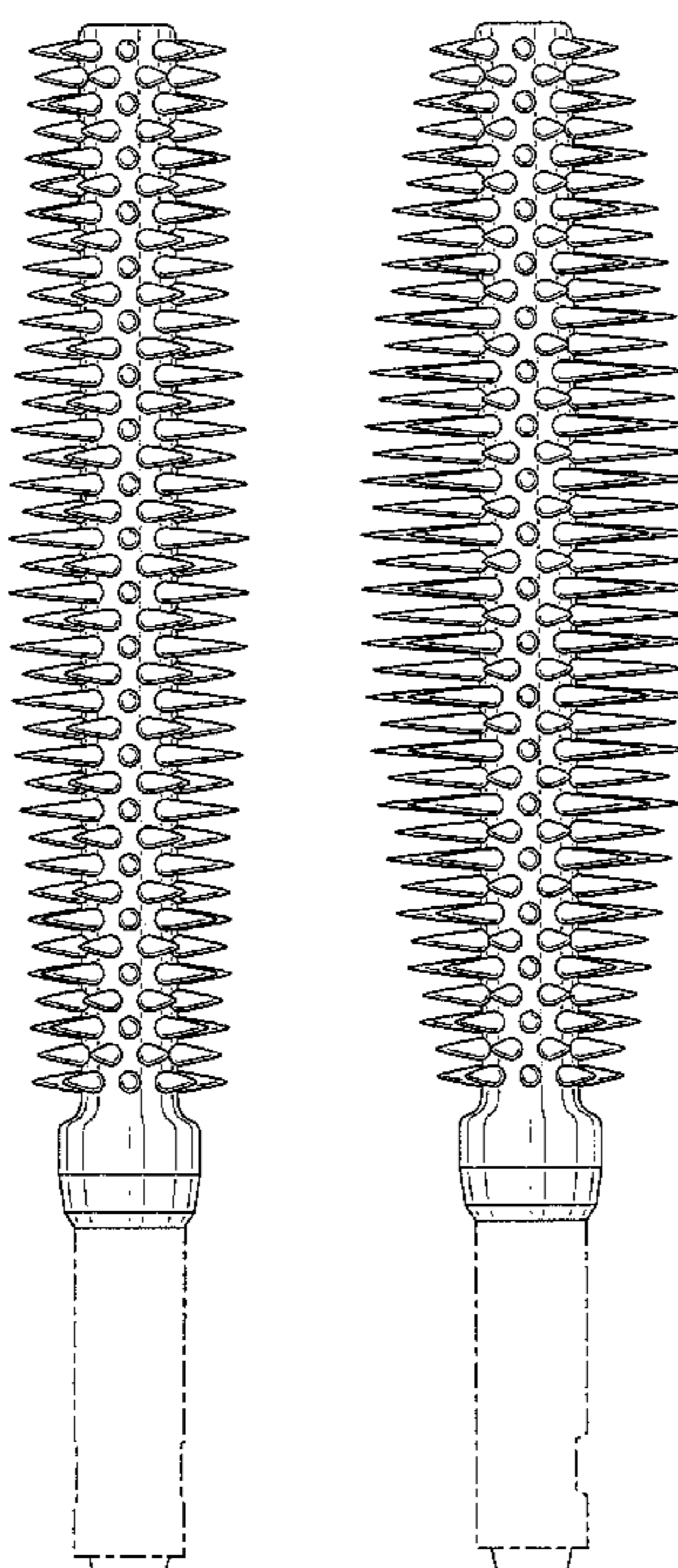
FIG. 5 is a left side elevation view thereof;

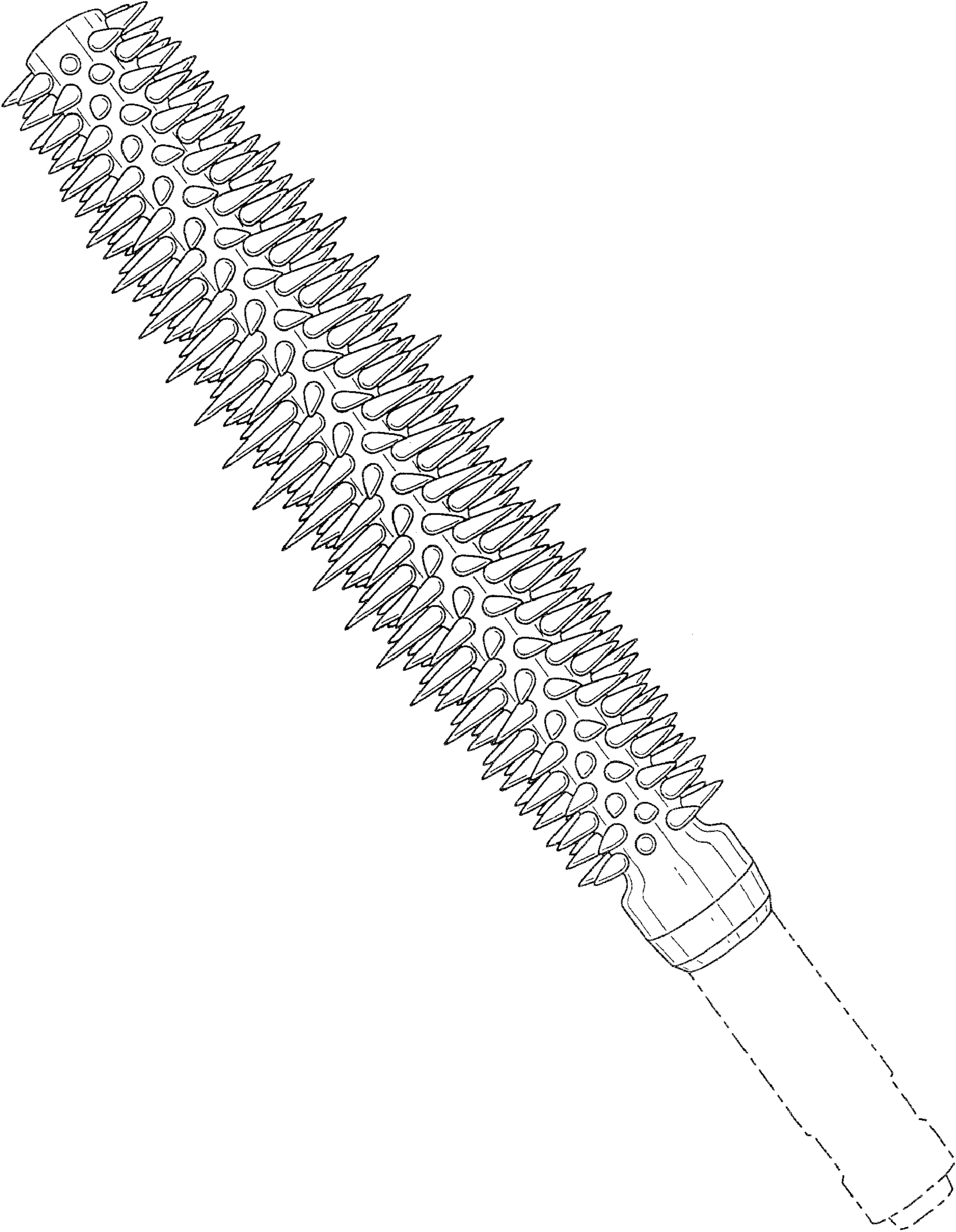

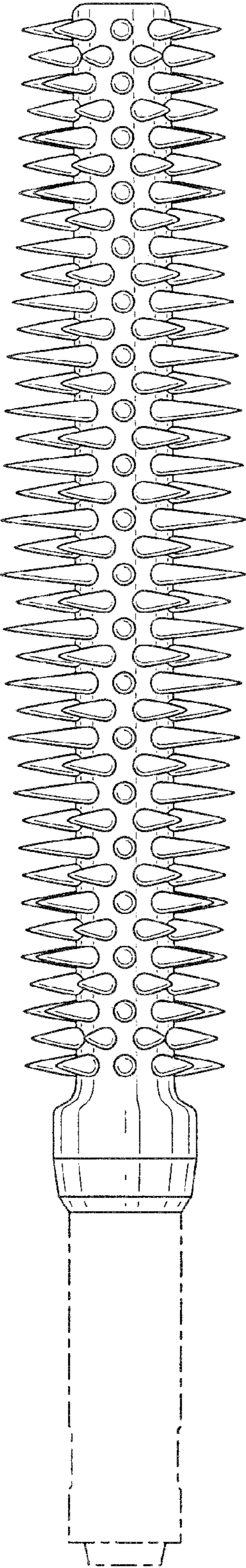

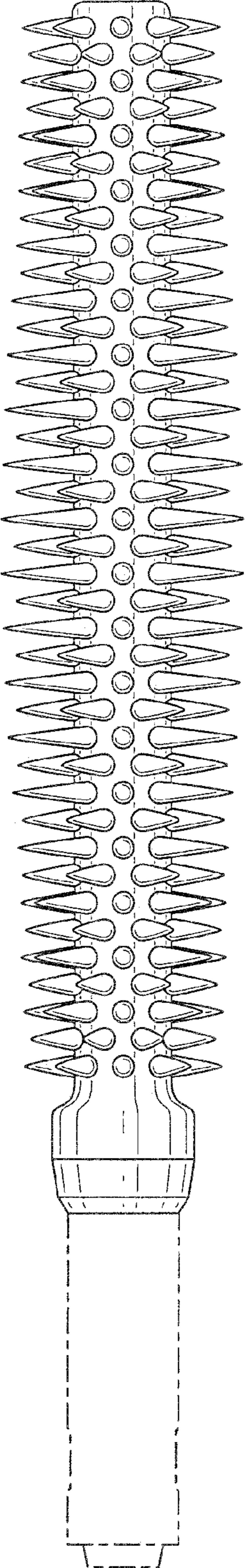

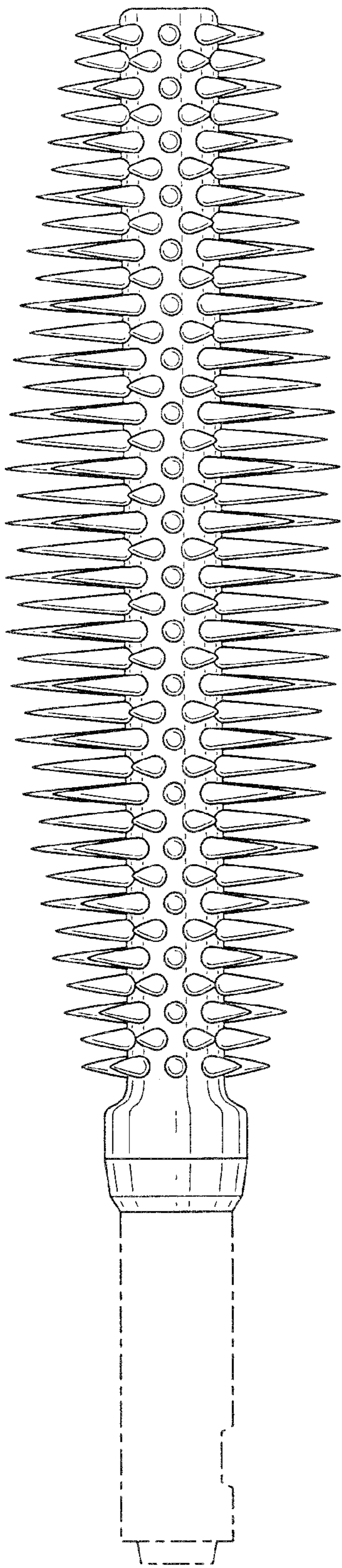

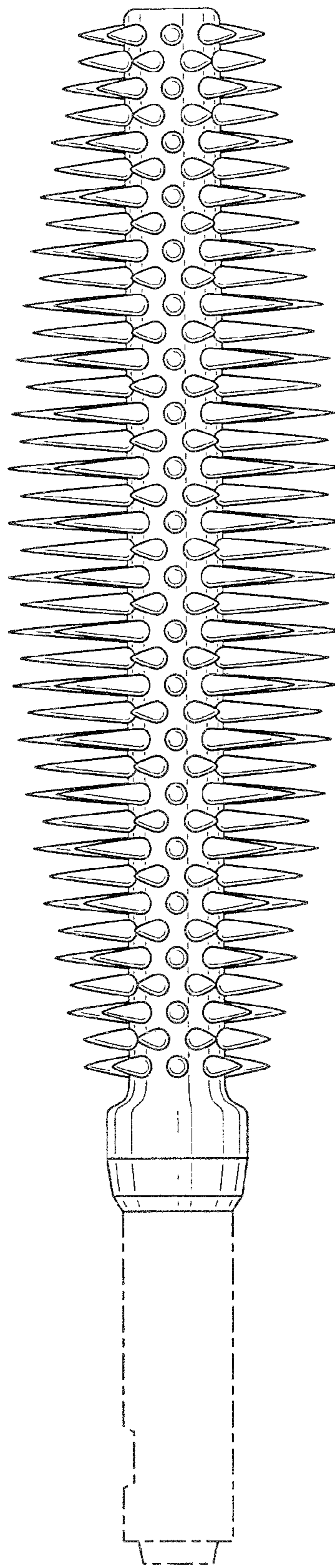

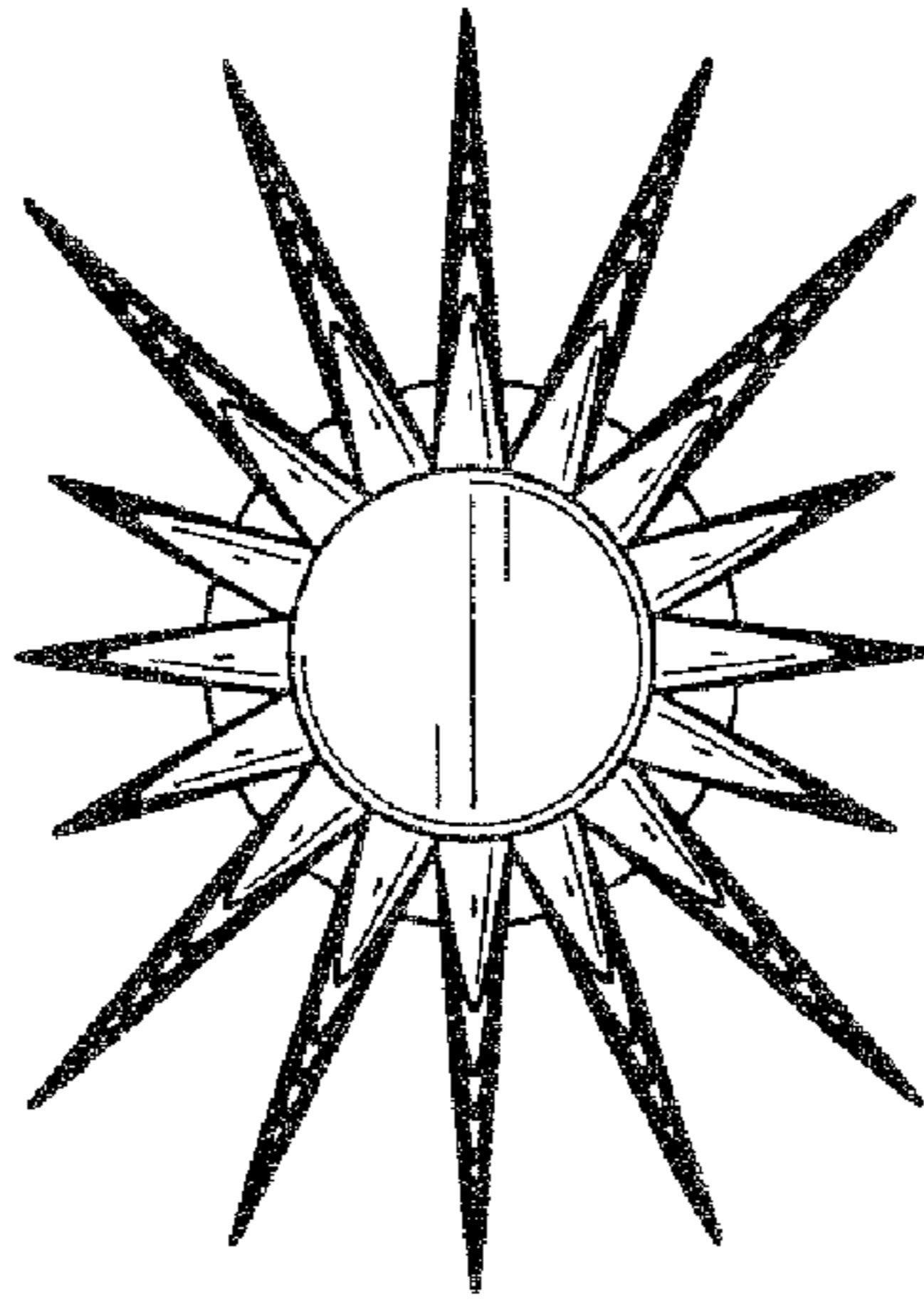

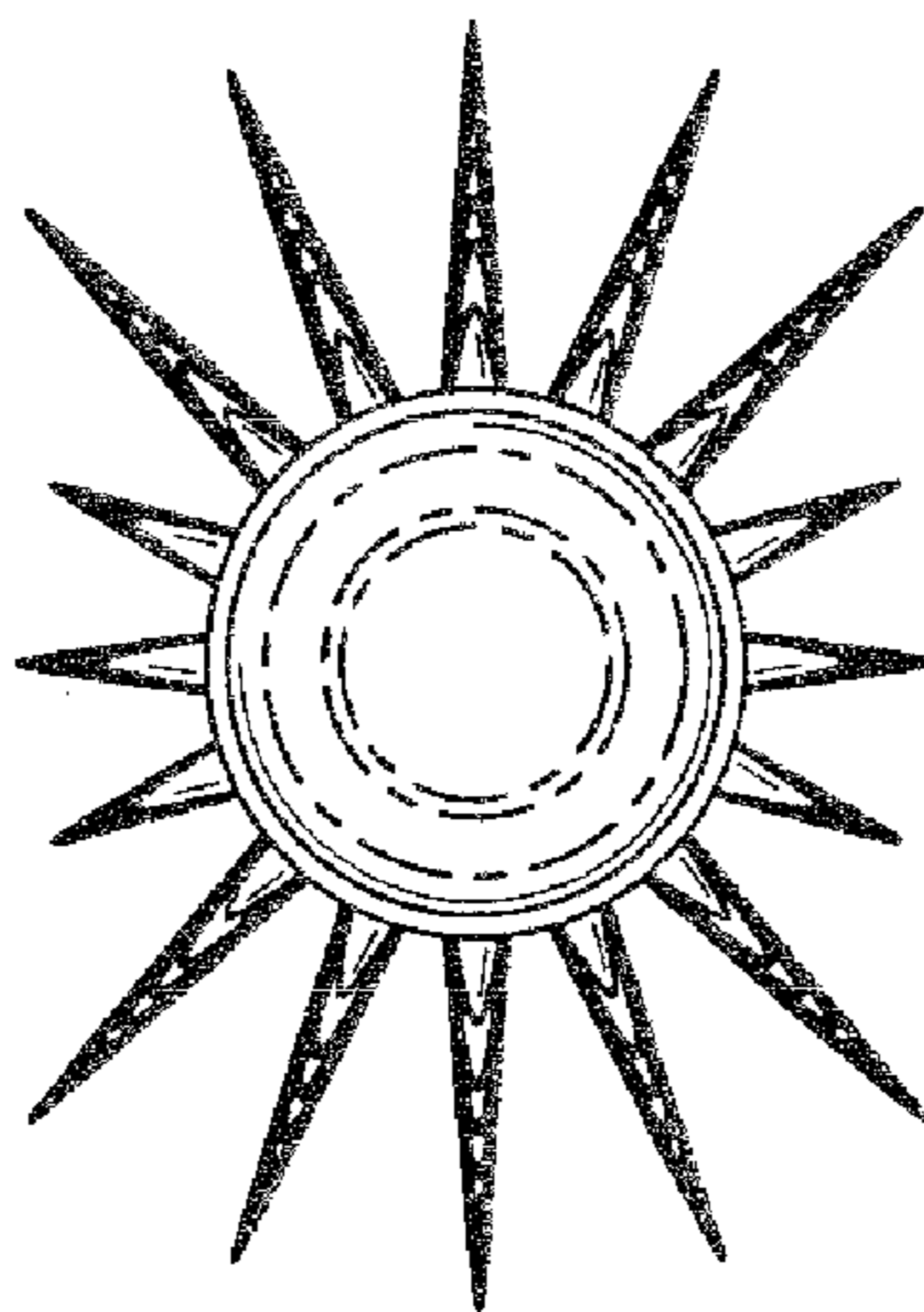
