DESCRIPTION

FIG. 1 is a right, rear, bottom perspective view showing a conduit guide clip in accordance with the present invention; FIG. 2 is a left, top, front perspective view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a rear view thereof; FIG. 8 is a front view thereof; FIG. 9 is a right rear bottom perspective view of an alternate embodiment of our conduit guide clip configured as a mirror image of the conduit guide clip shown in FIG. 1 and adapted for mounting on an opposite side of a tubular support; FIG. 10 is a left, top, front perspective view thereof; FIG. 11 is a bottom view thereof; FIG. 12 is a top plan view thereof; FIG. 13 is a left side elevational view thereof; FIG. 14 is a right side elevational view thereof; FIG. 15 is a rear view thereof, and, FIG. 16 is a front view thereof.

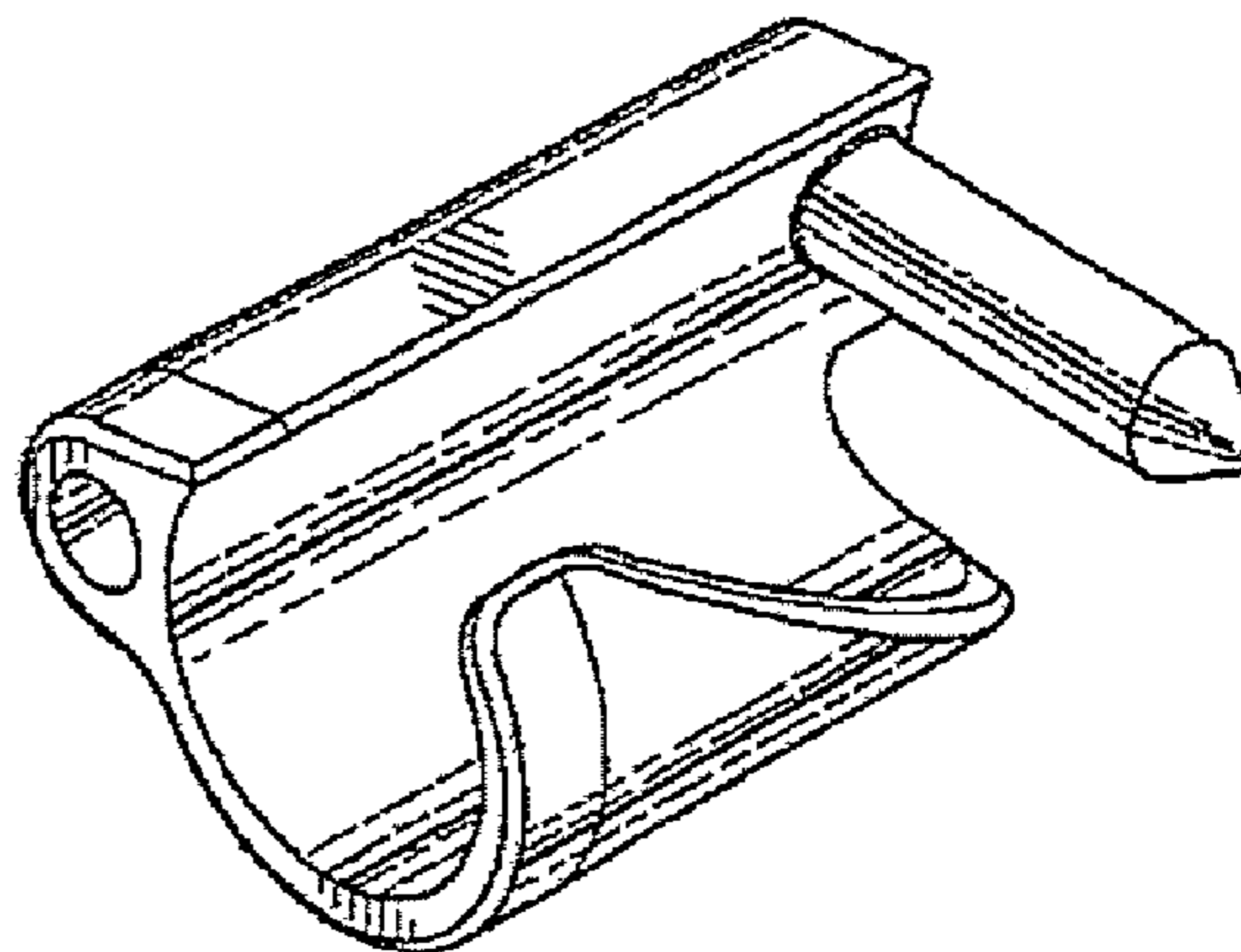
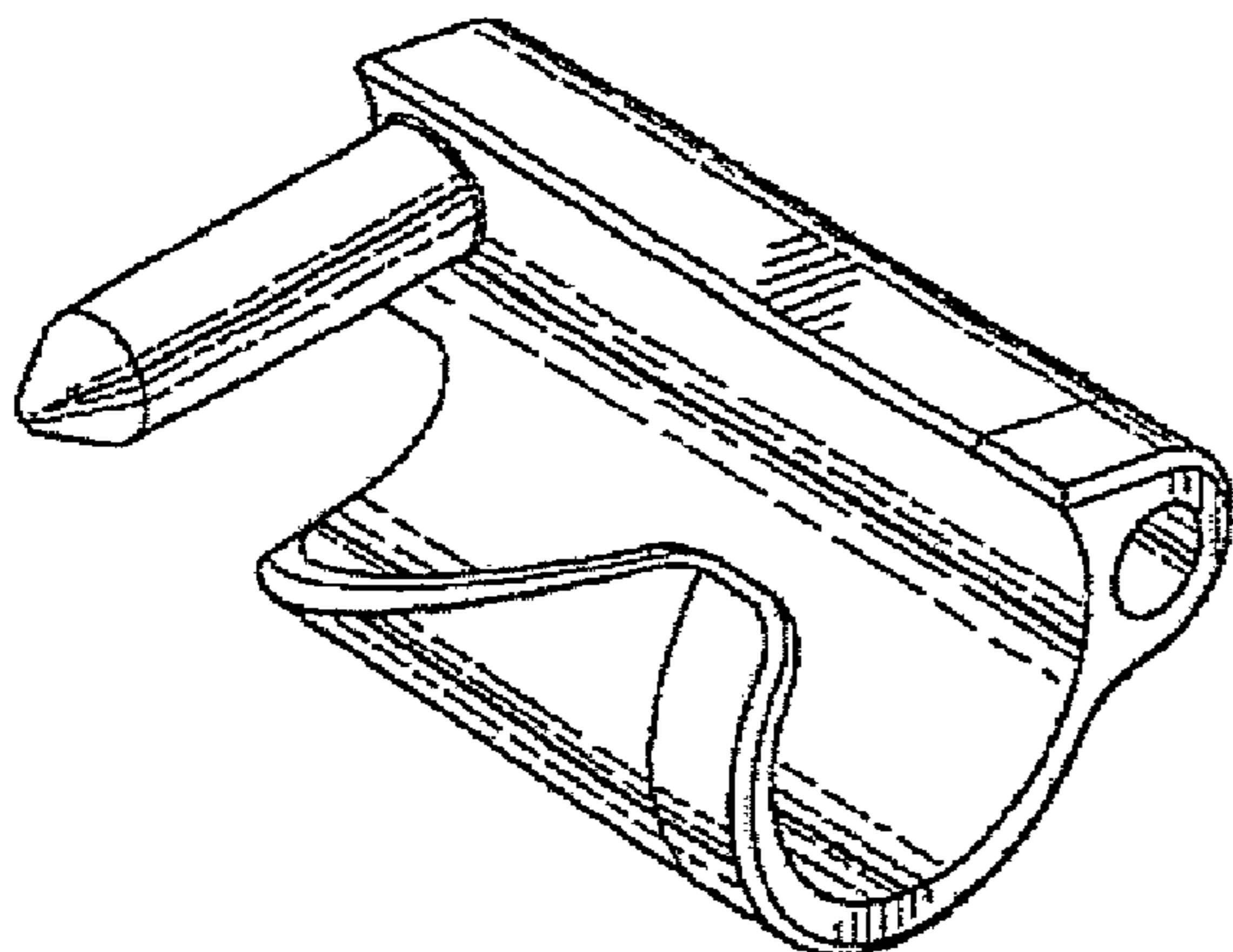

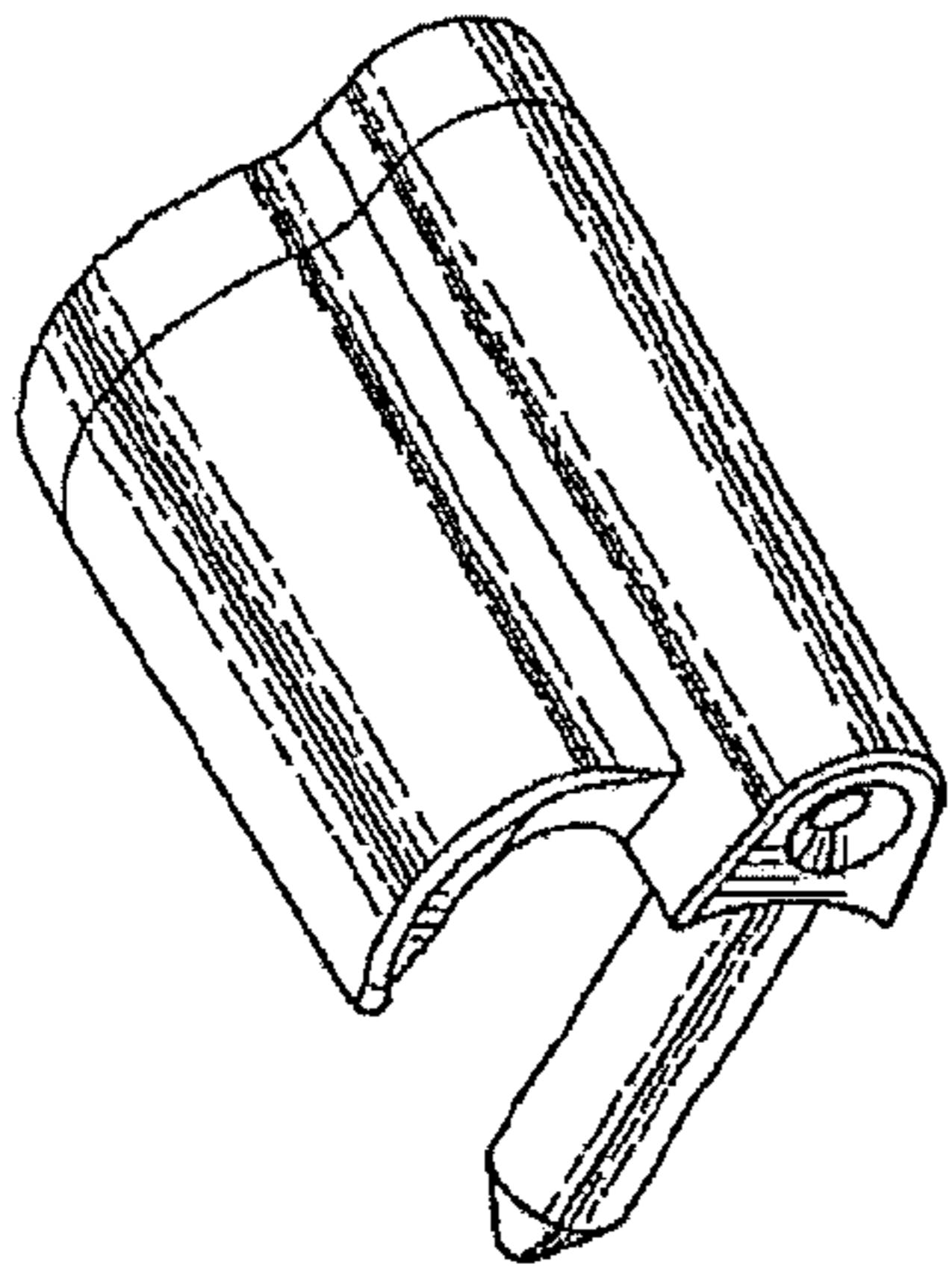

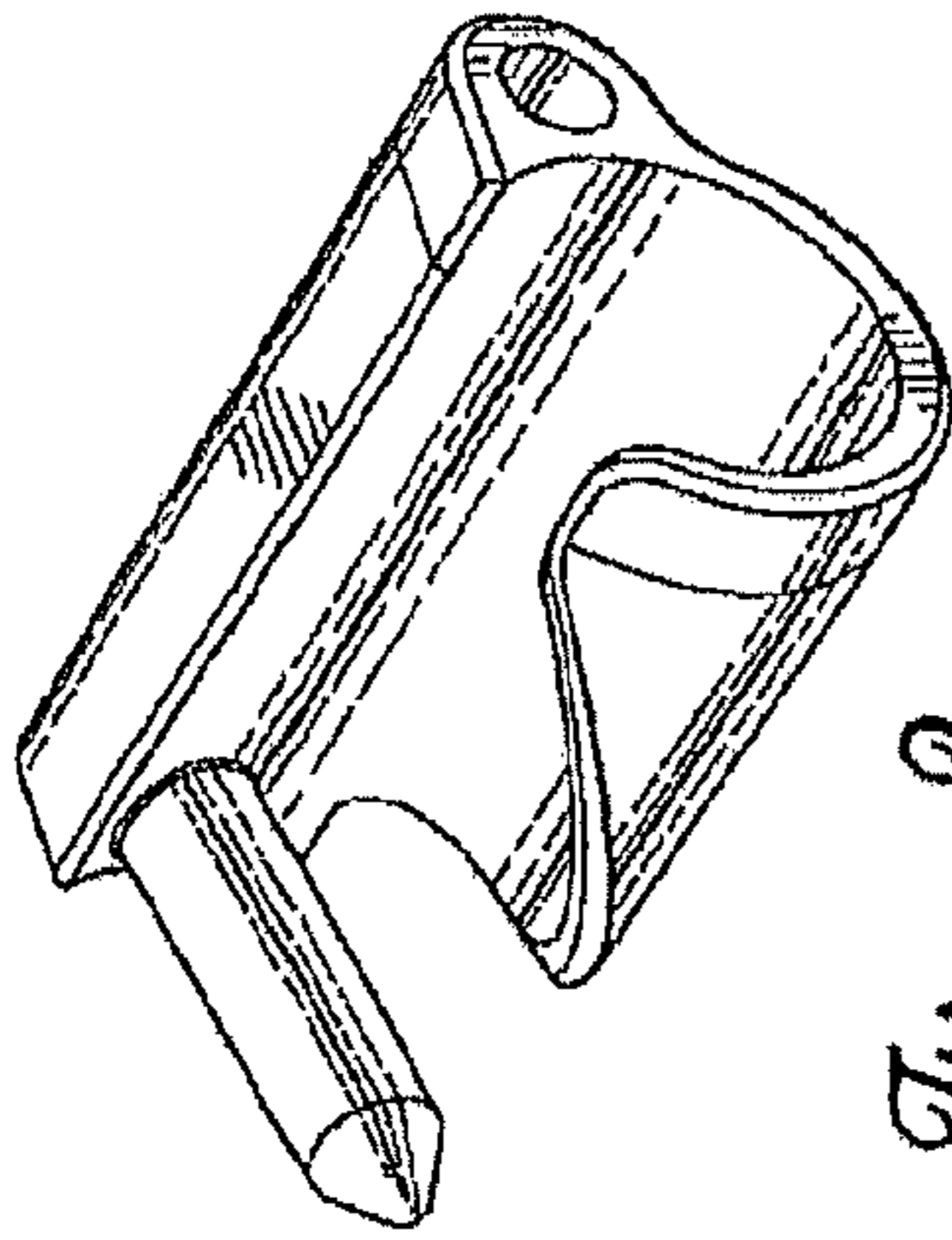

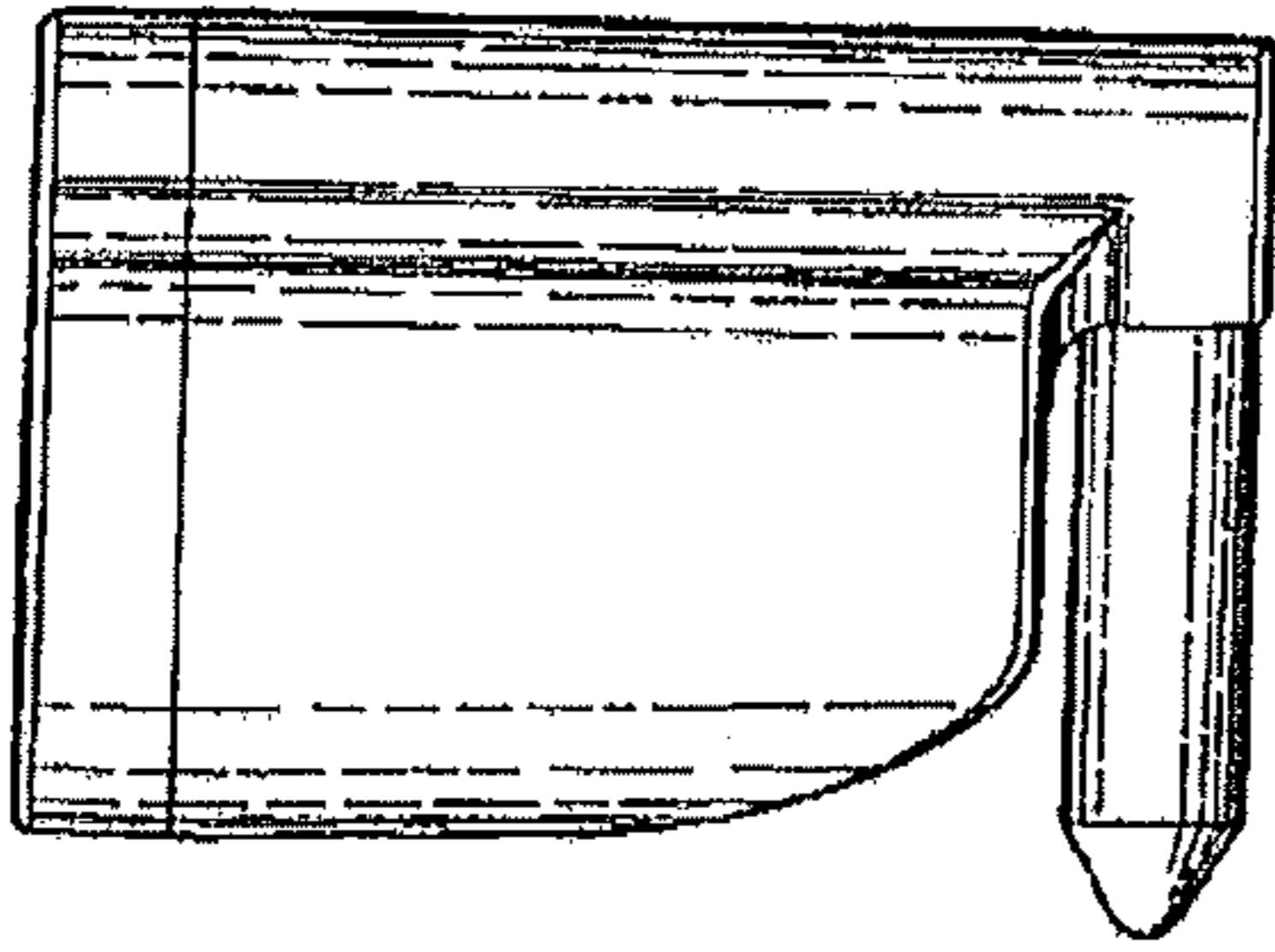

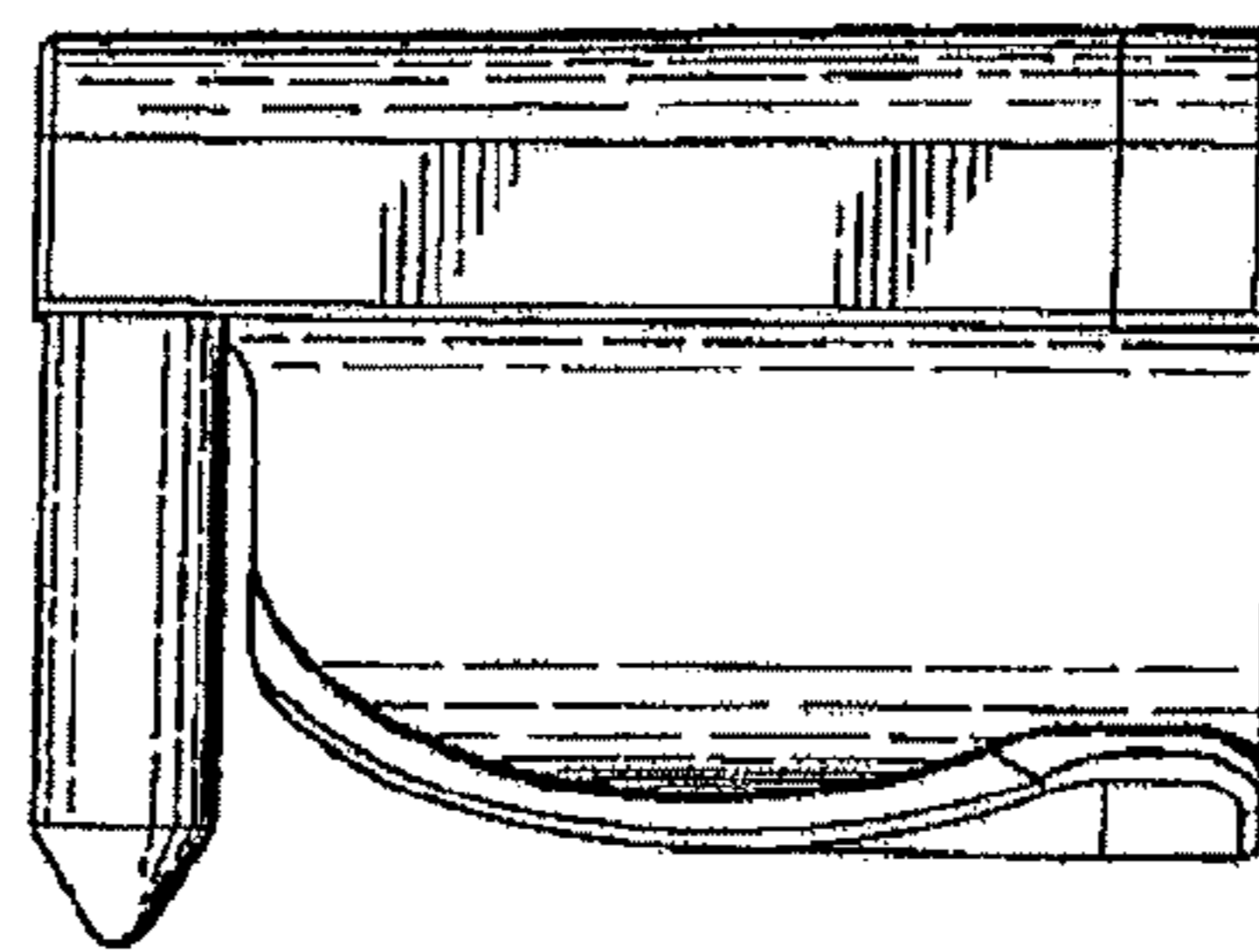

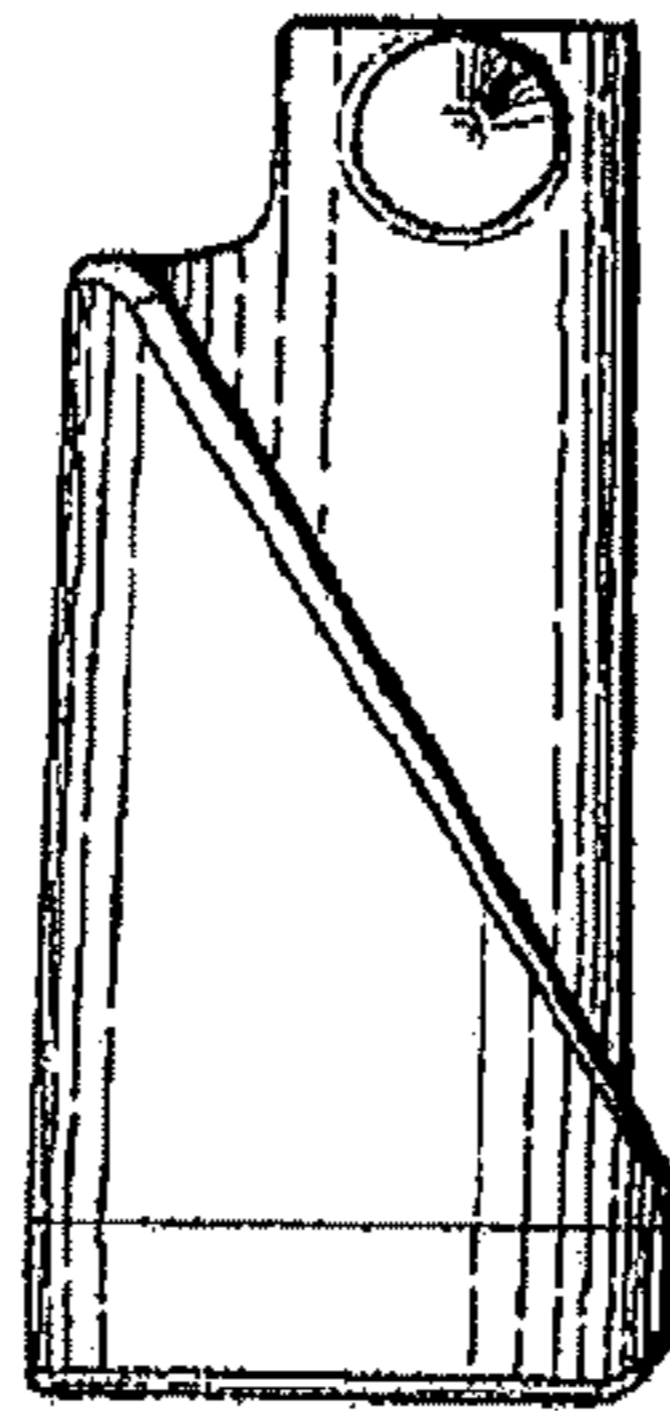

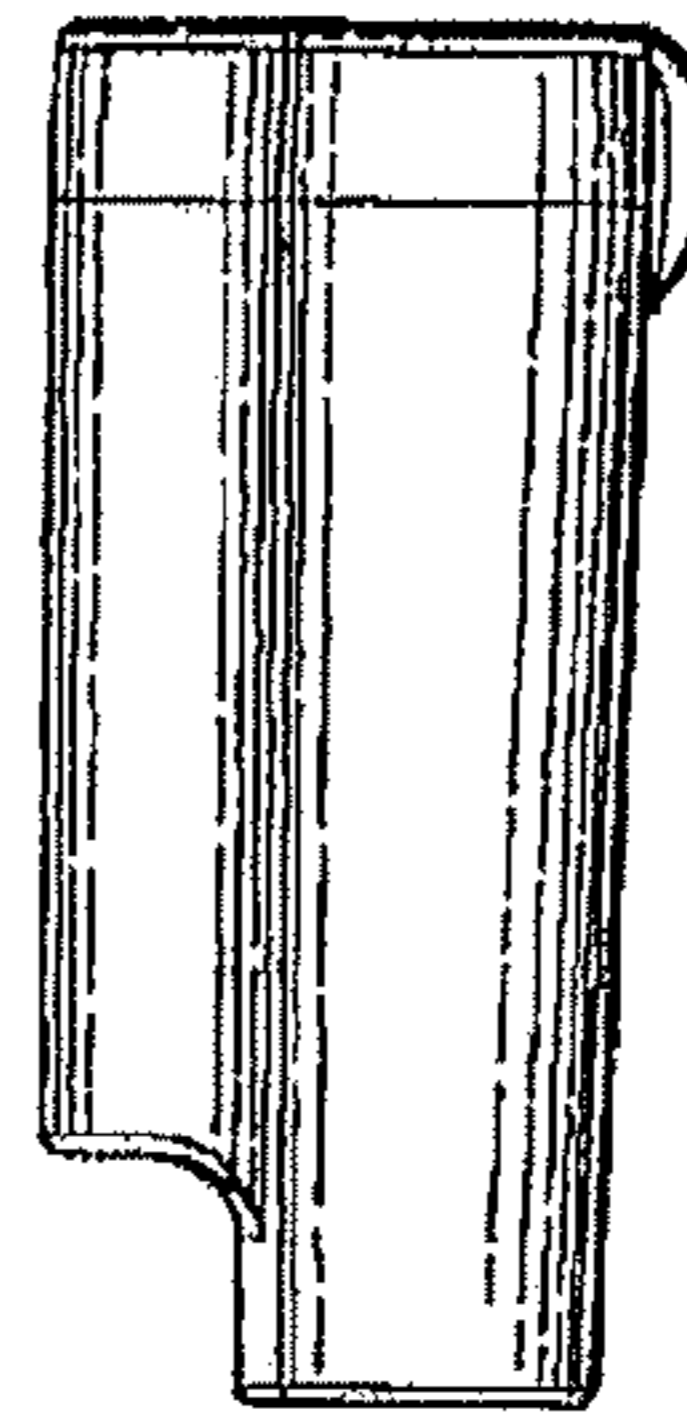

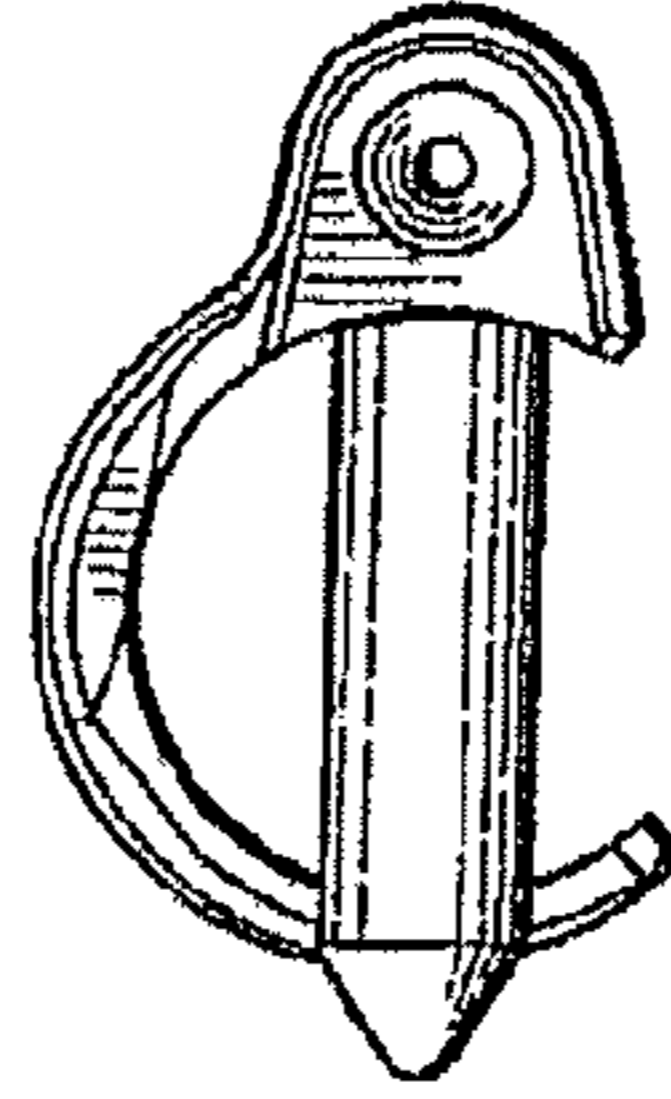

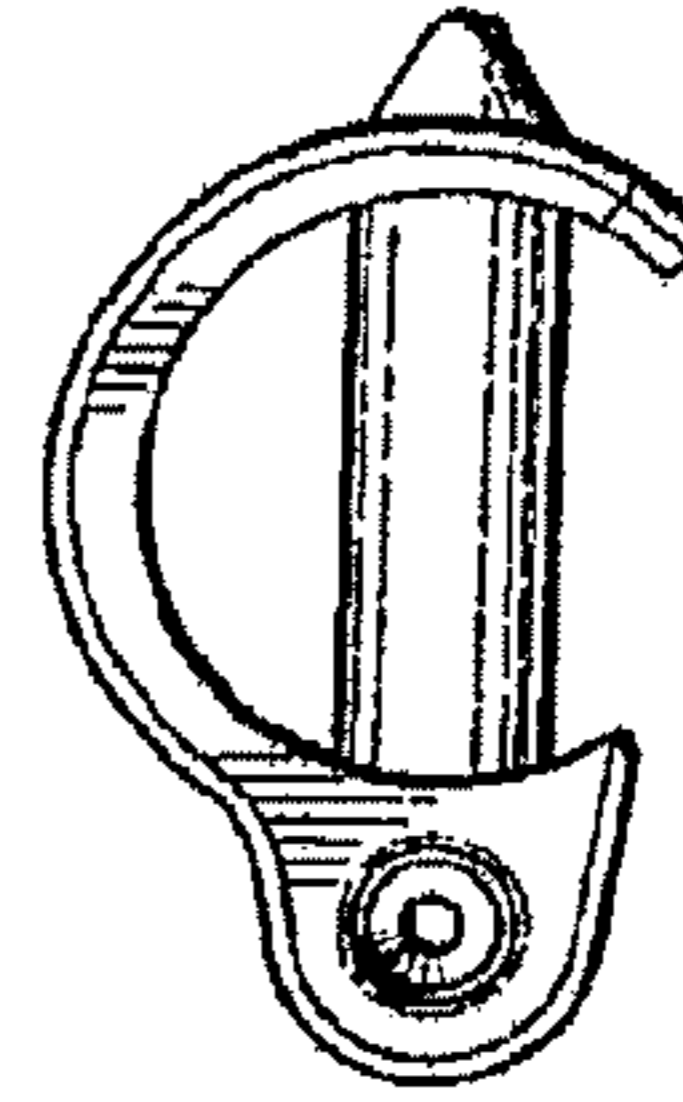

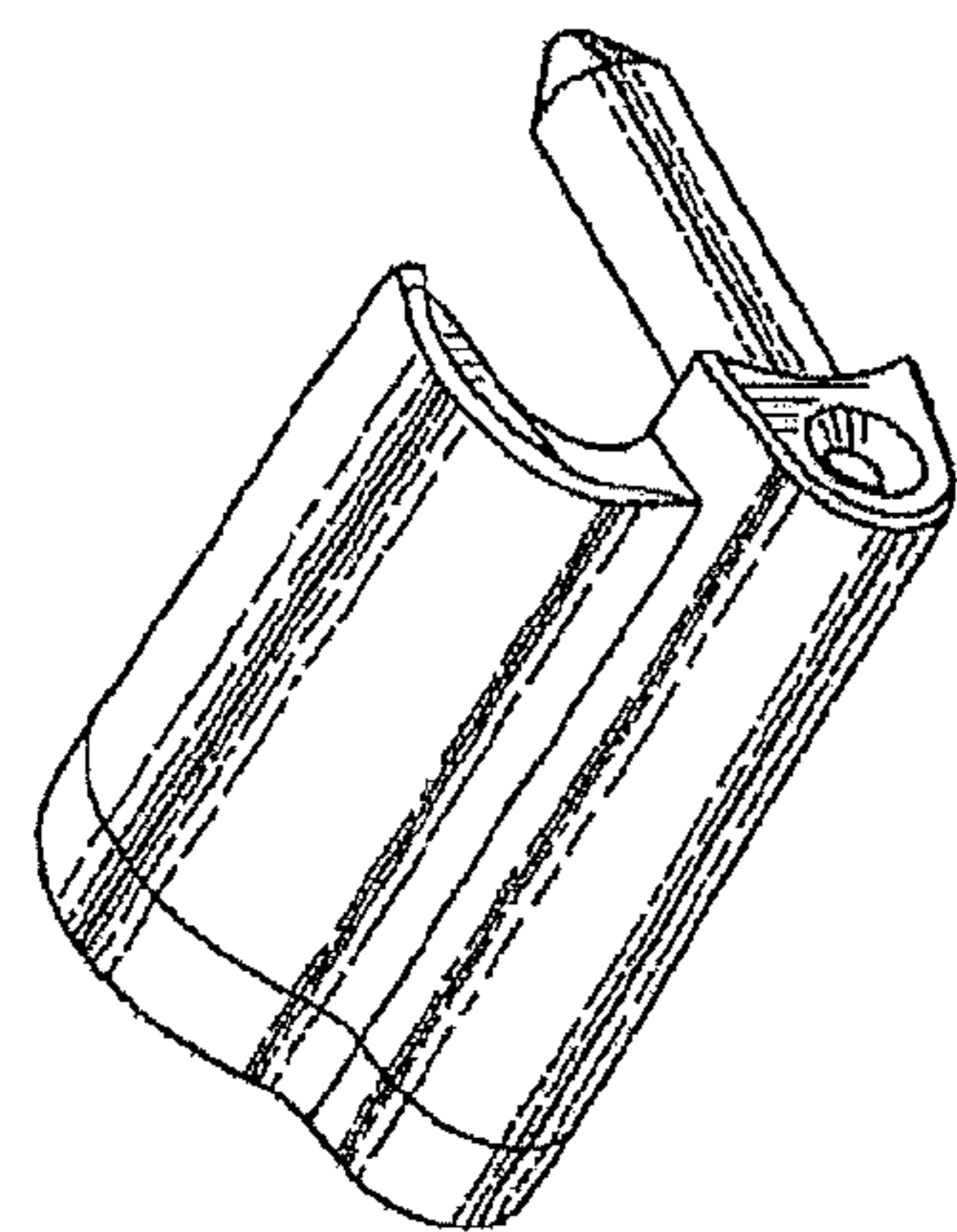

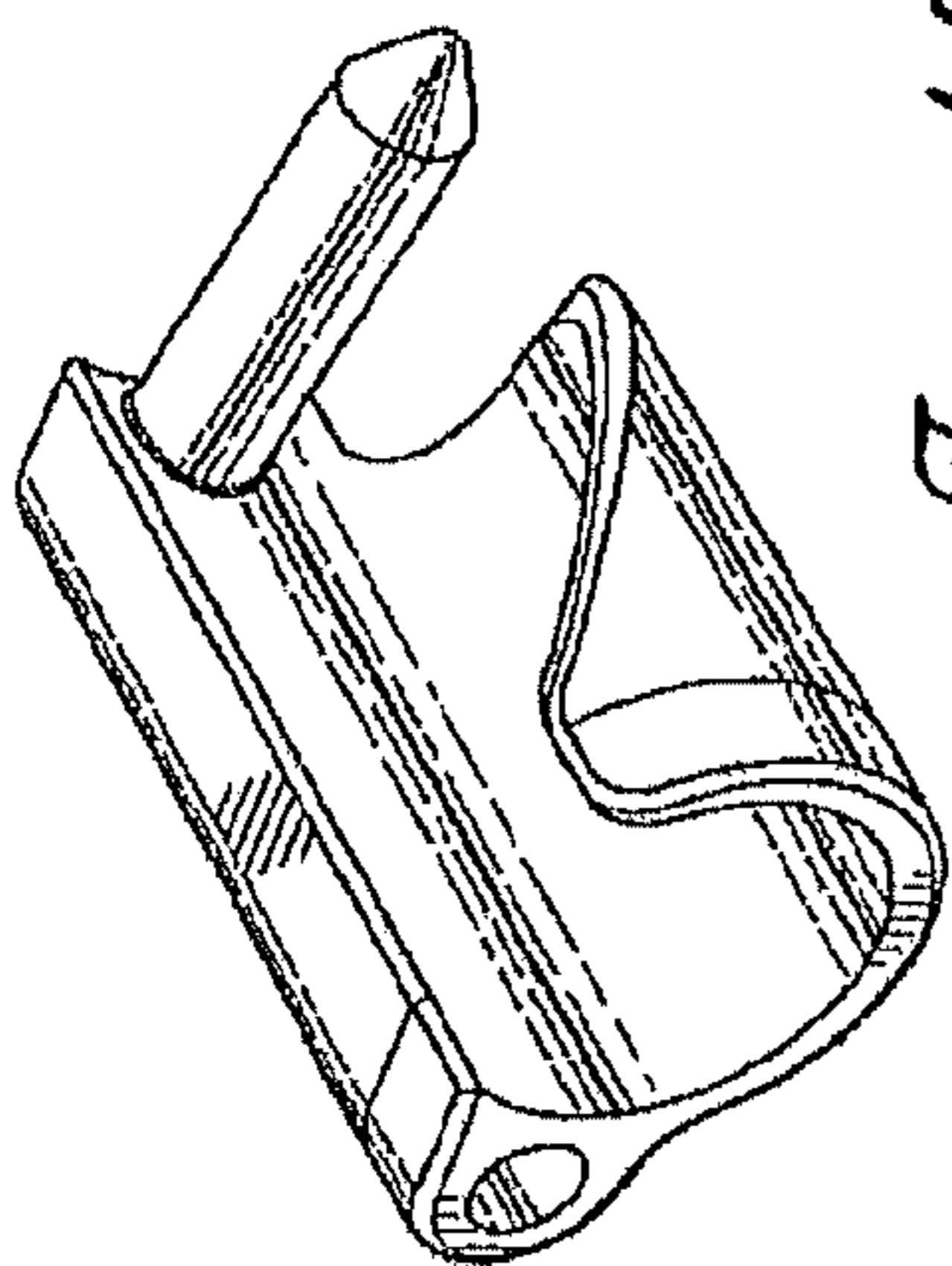

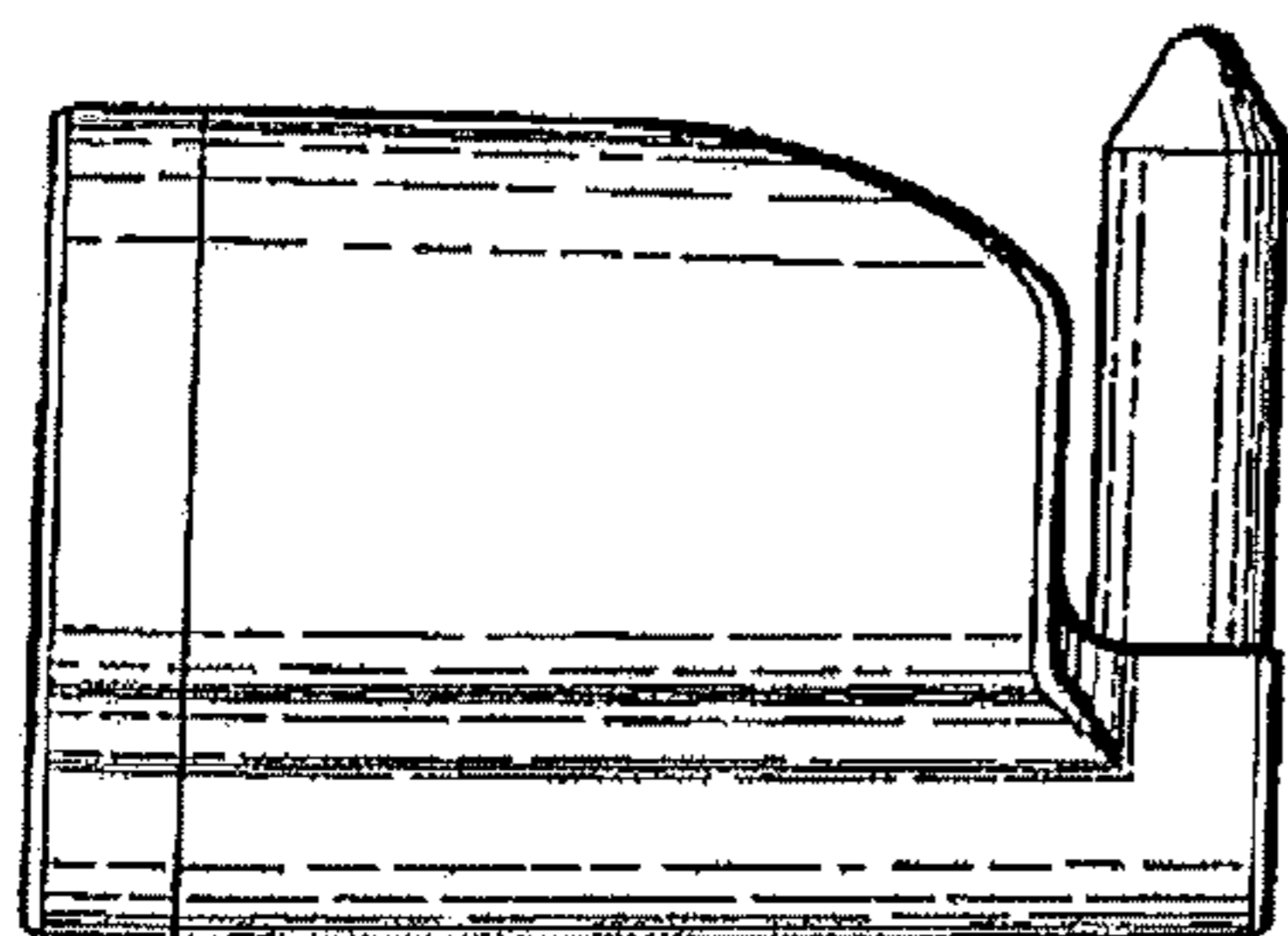

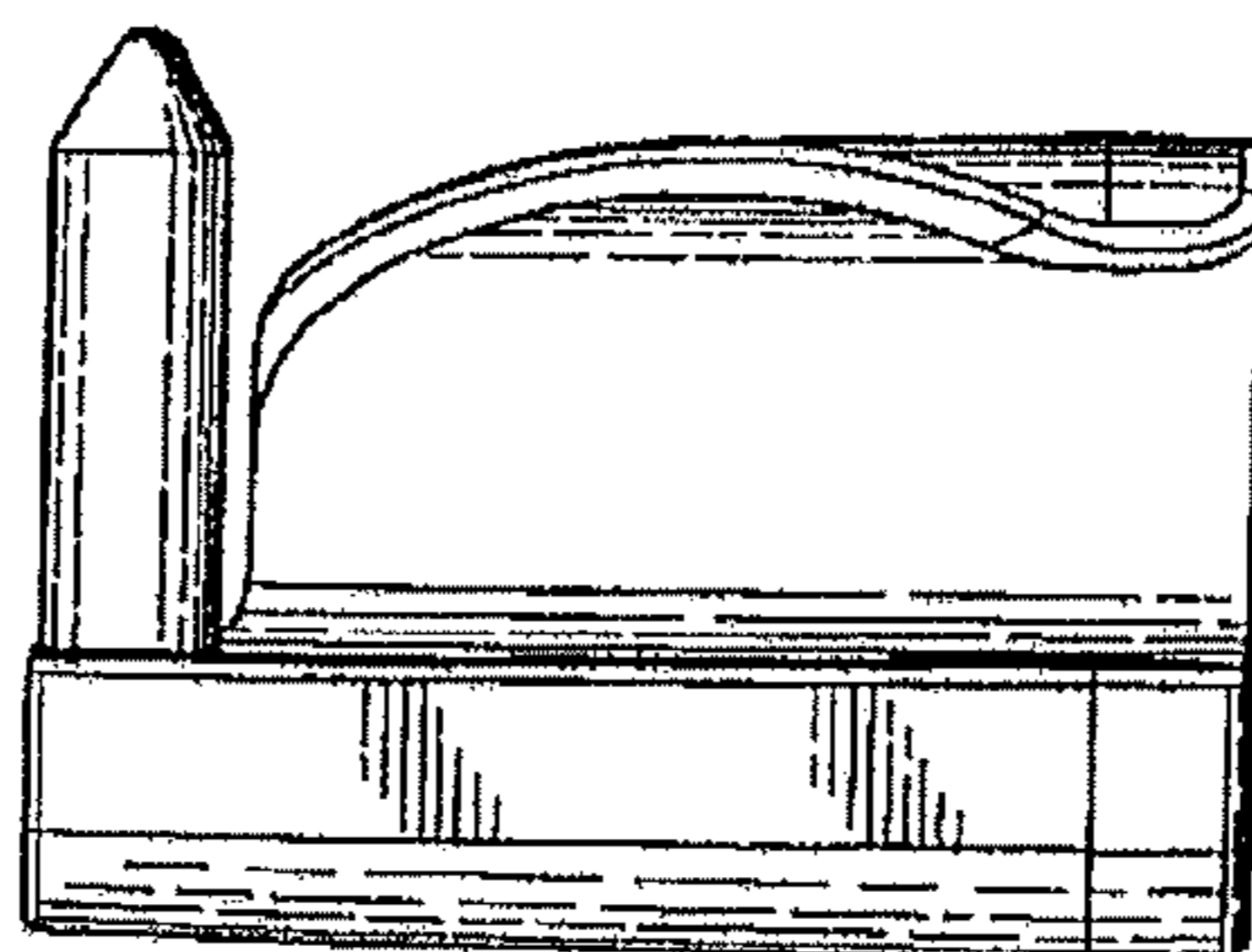

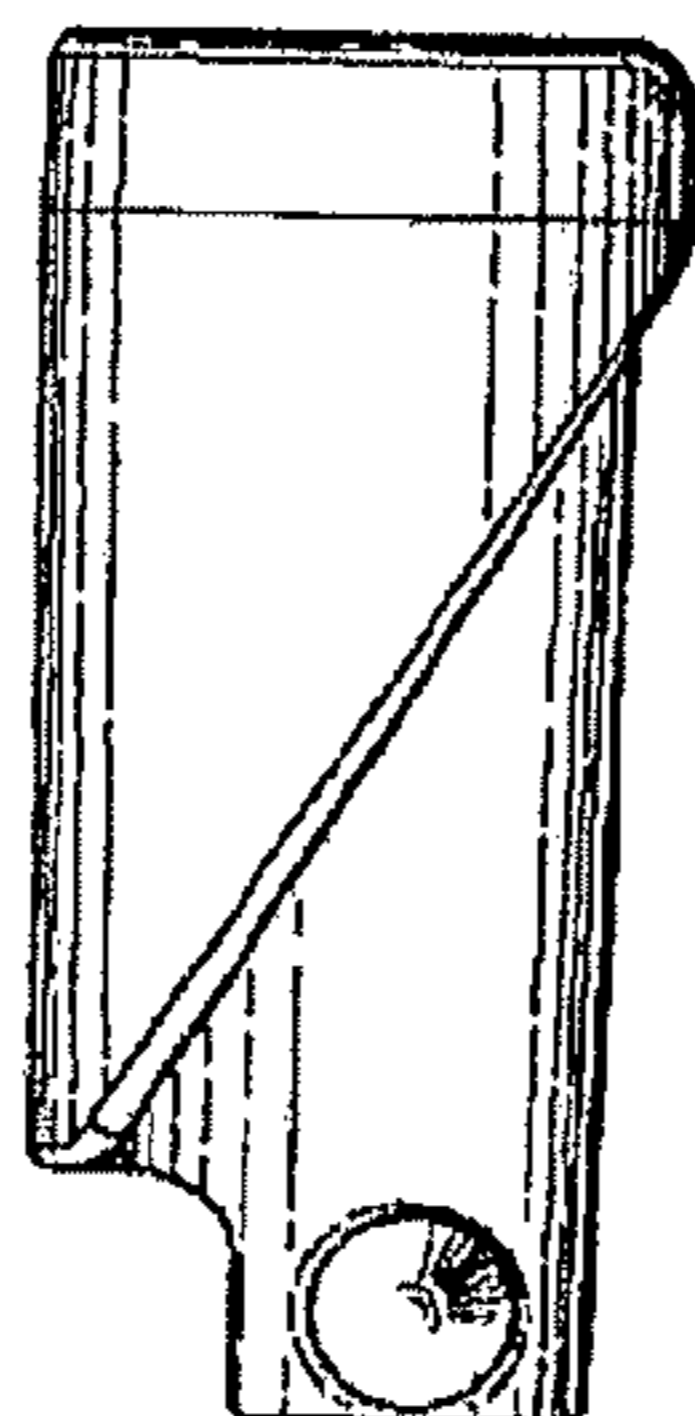

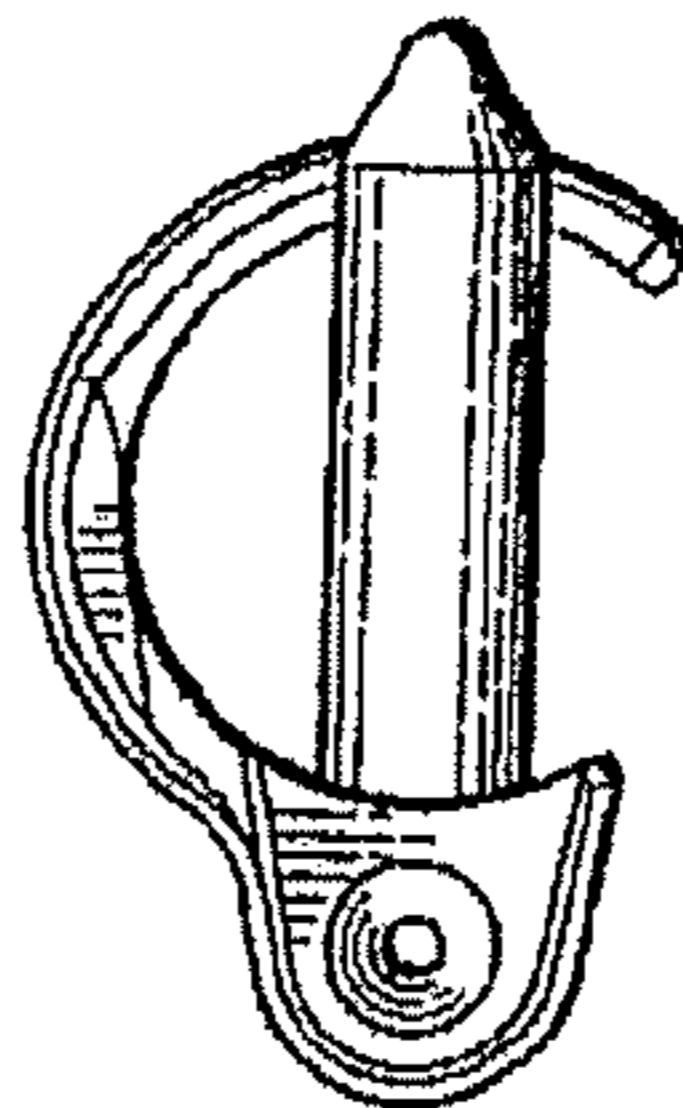

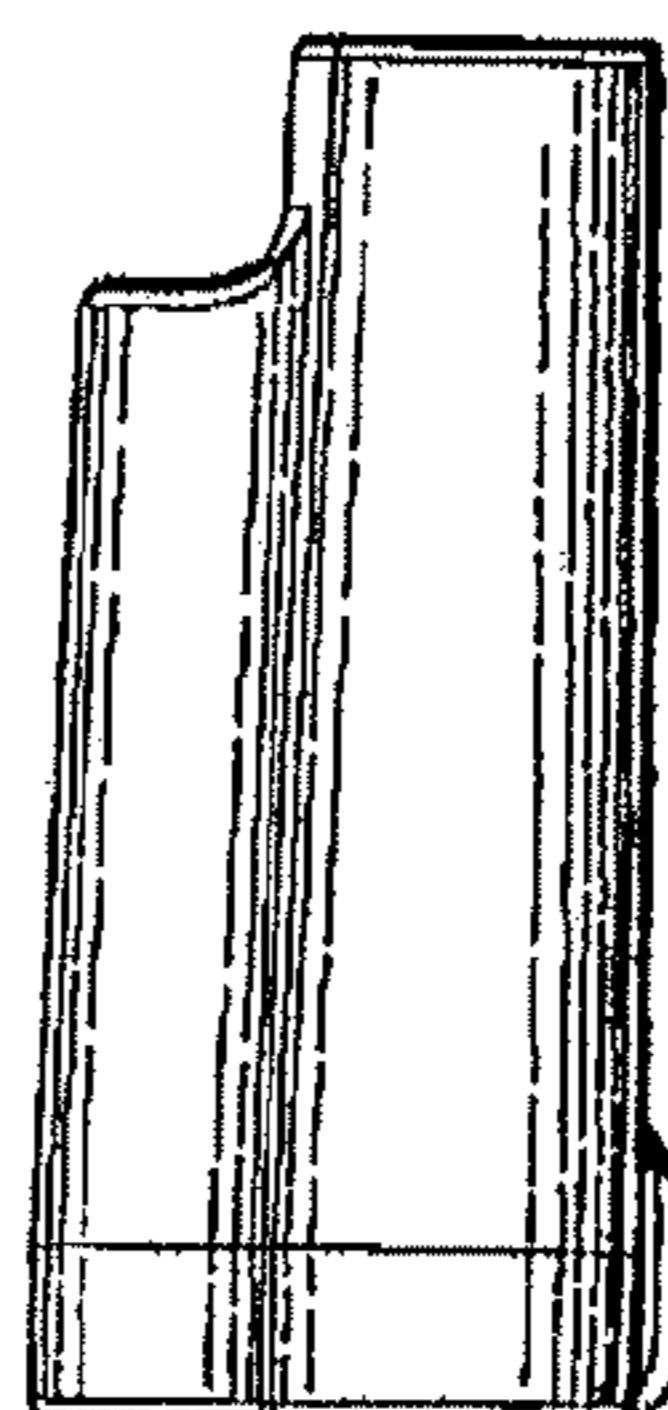

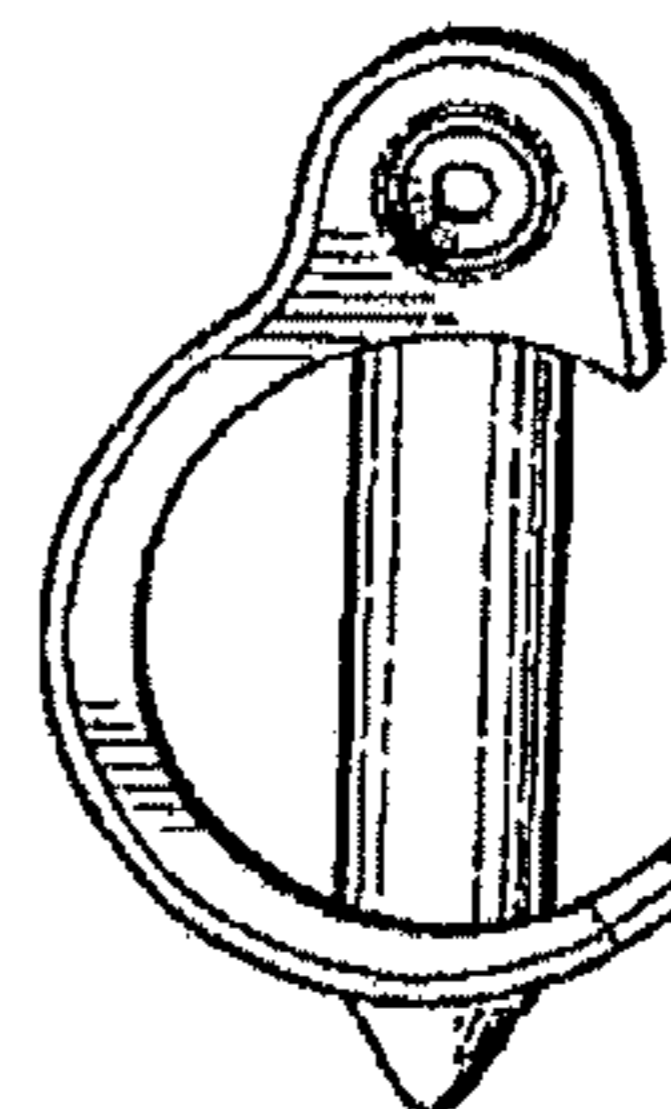
