The ornamental design for a display box, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a display box showing my new design;

FIG. 2 is a front plan view thereof;

FIG. 6 is a right side view thereof;

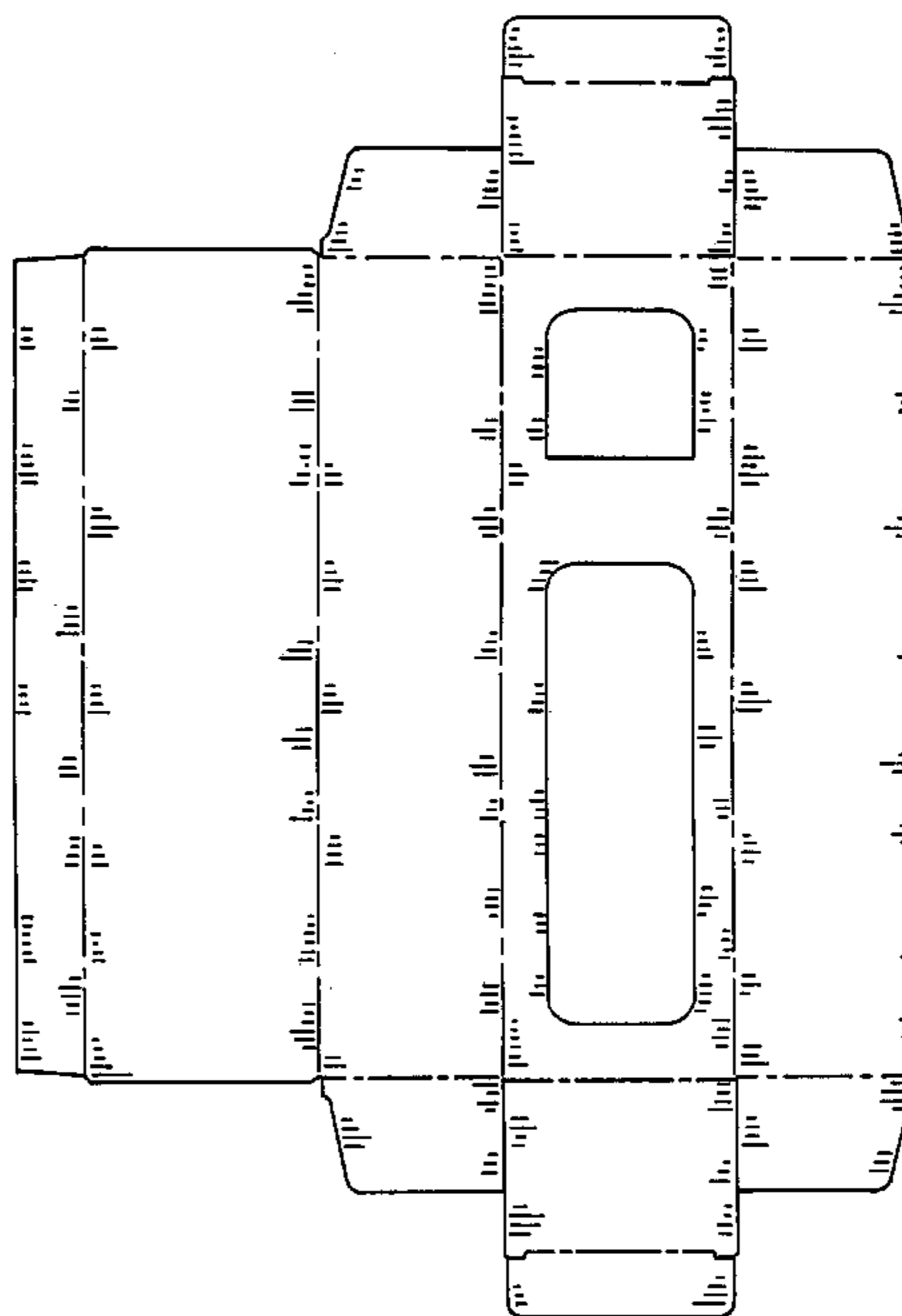
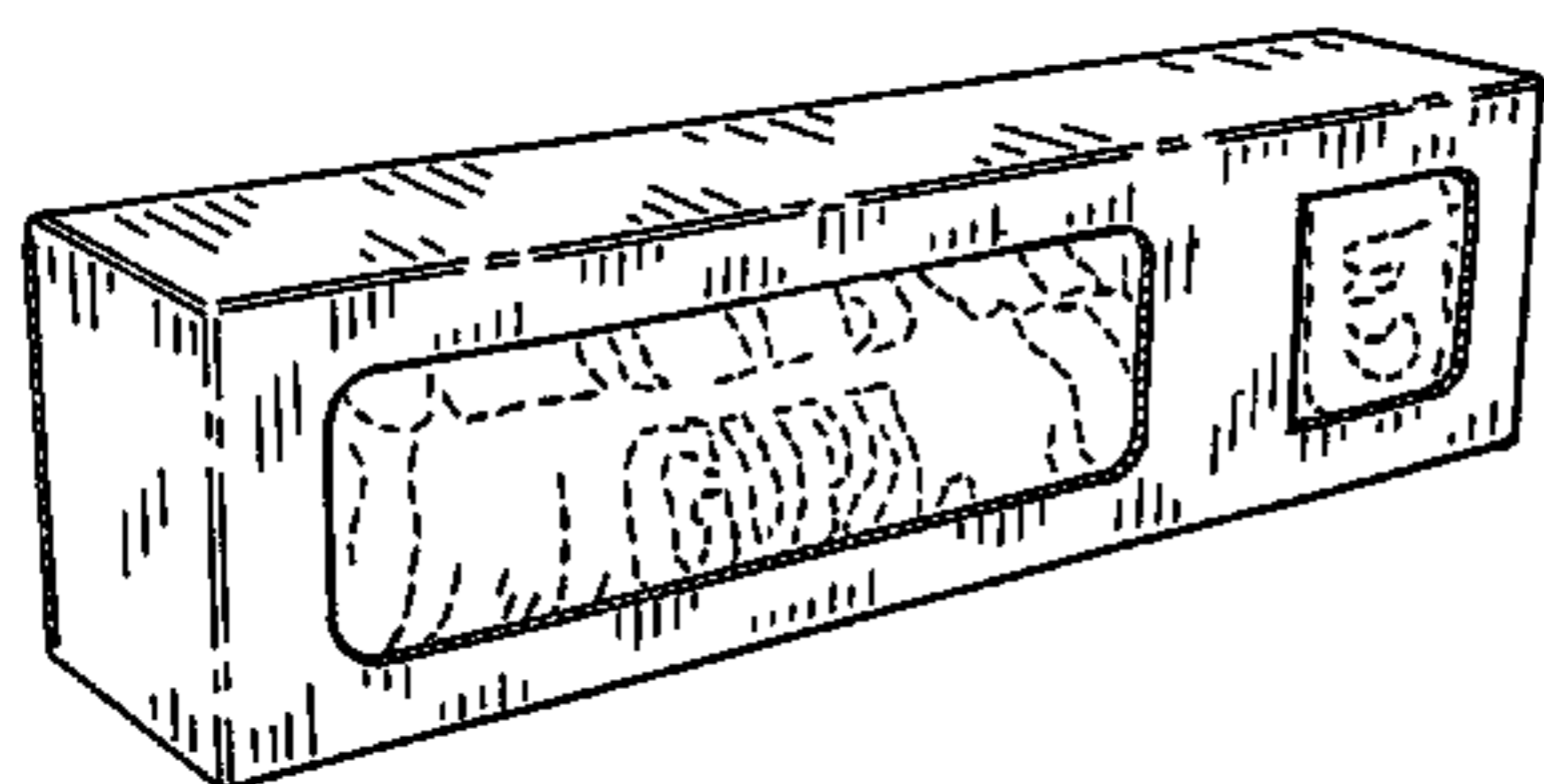
FIG. 7 is a left side view thereof; and,

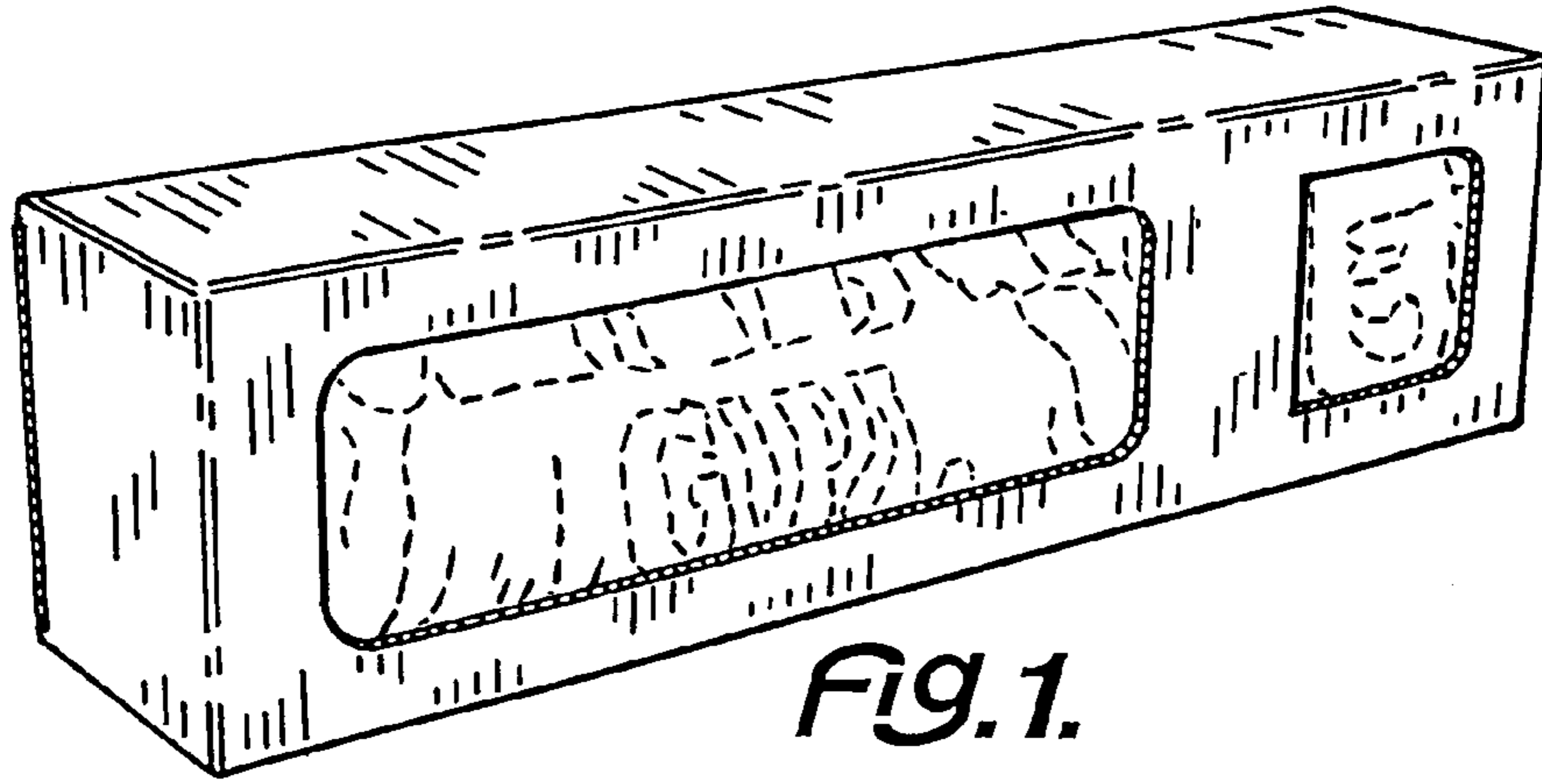

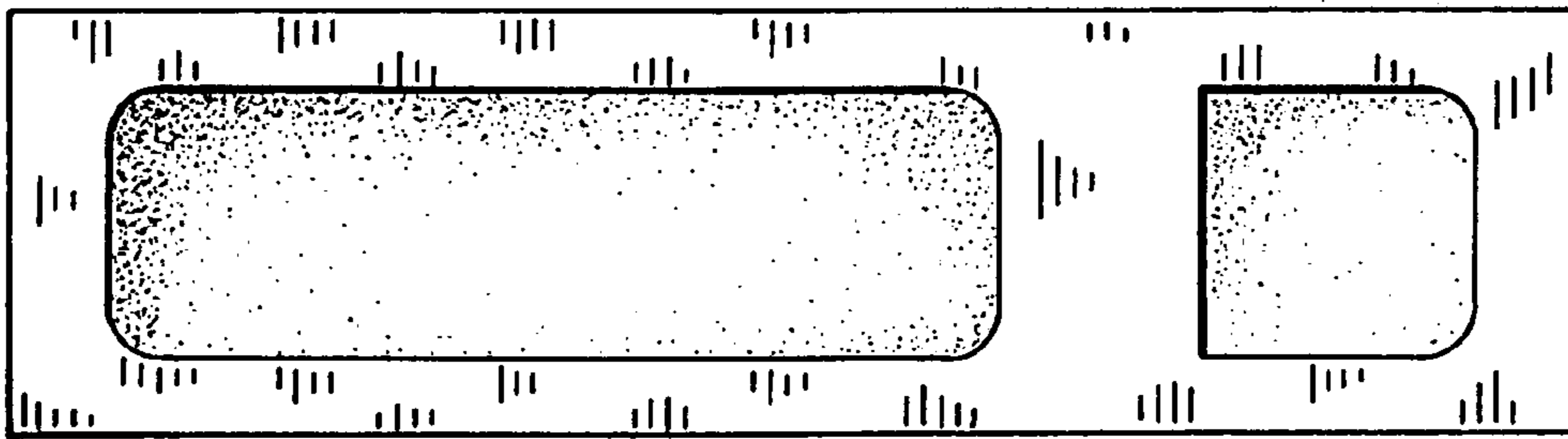

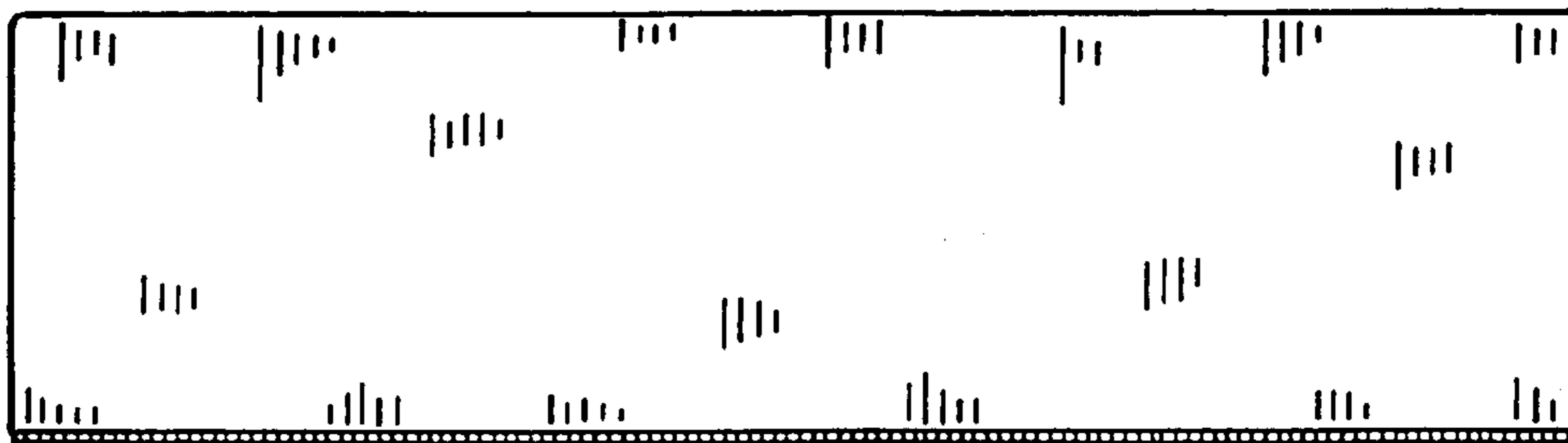

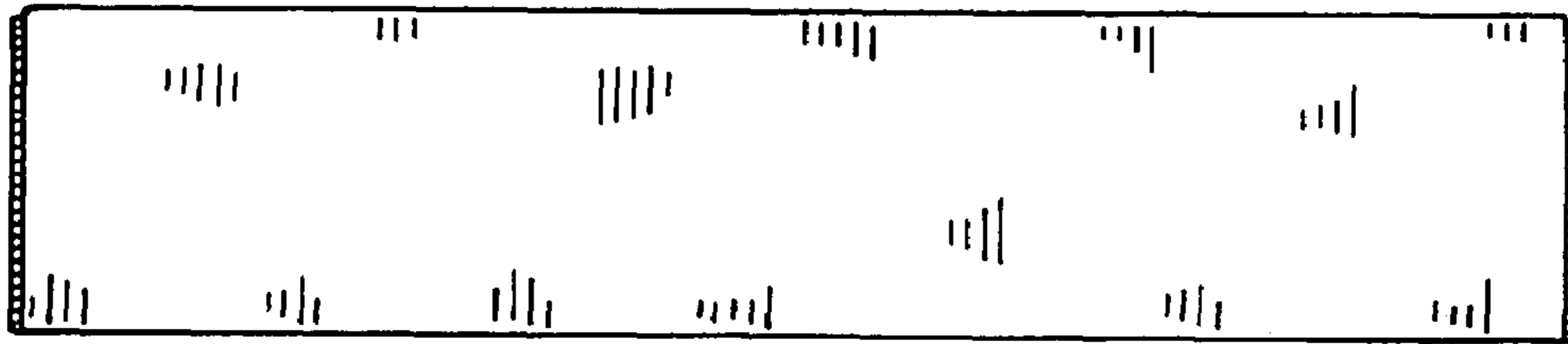

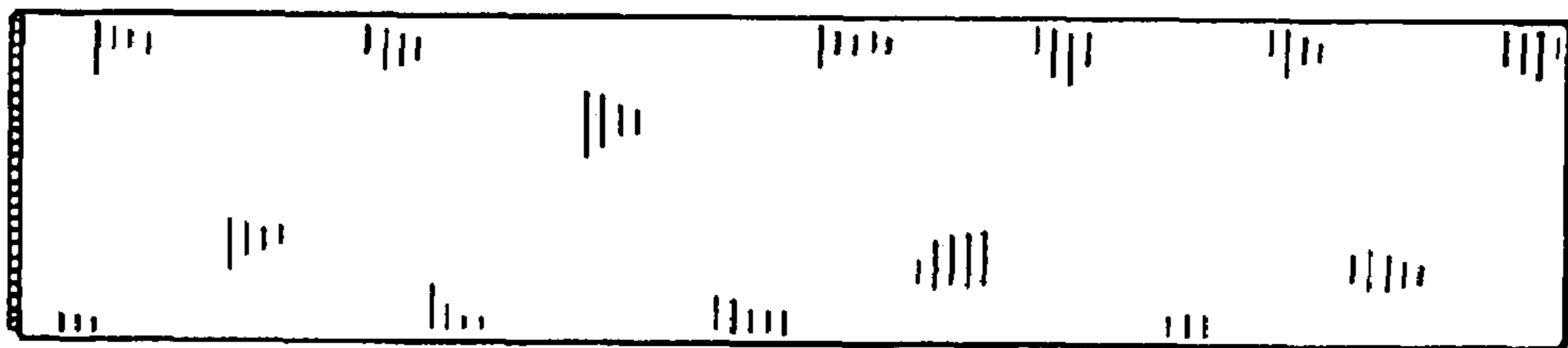

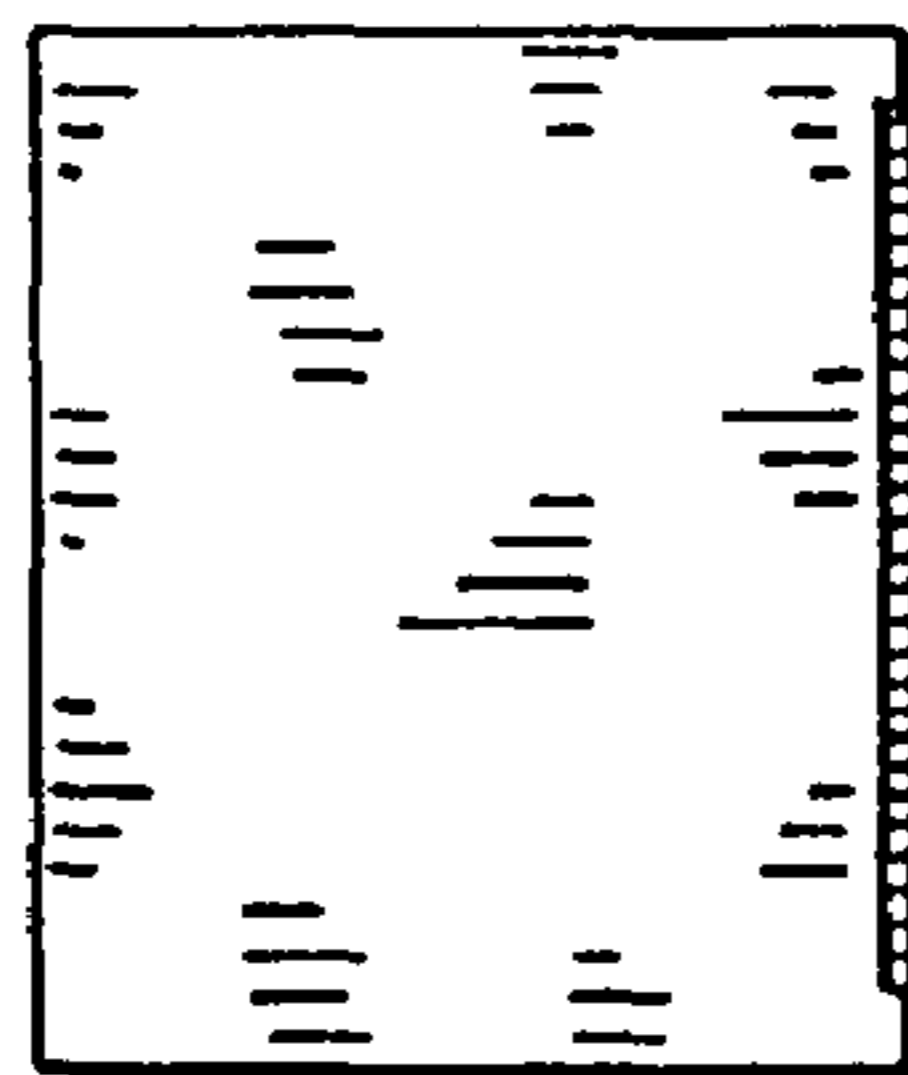

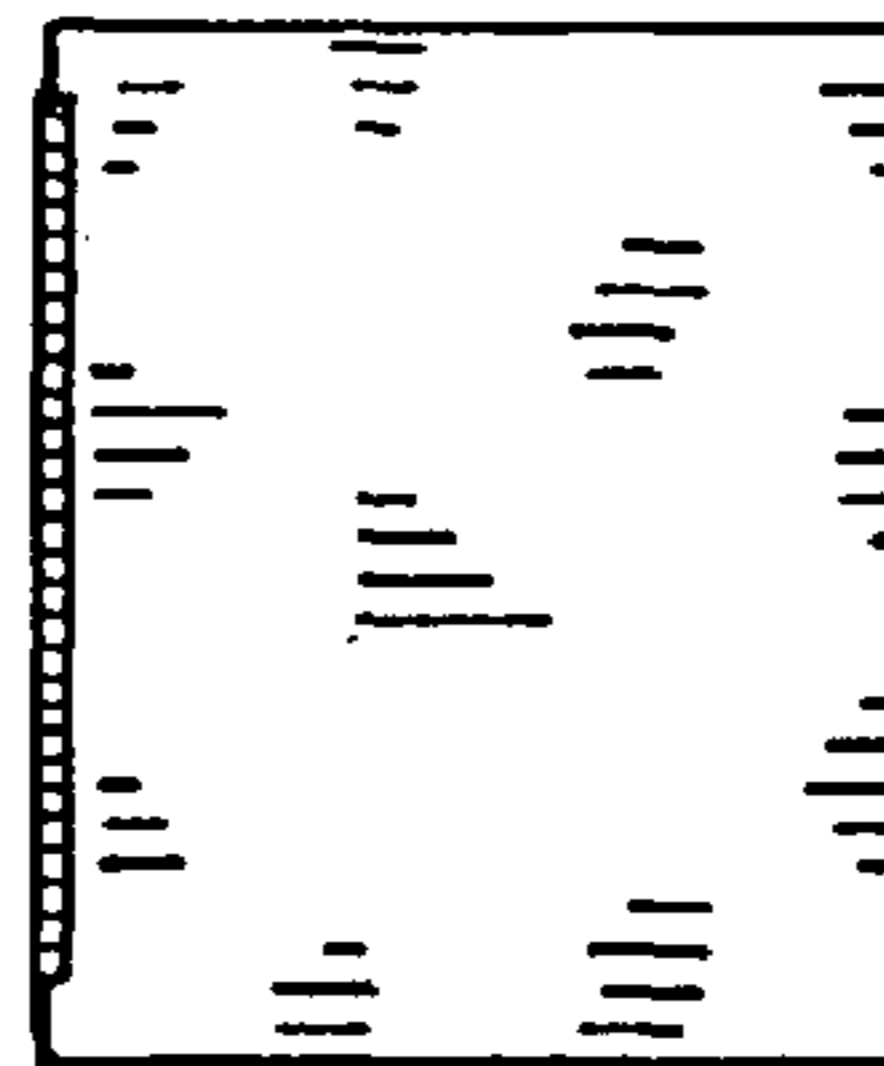

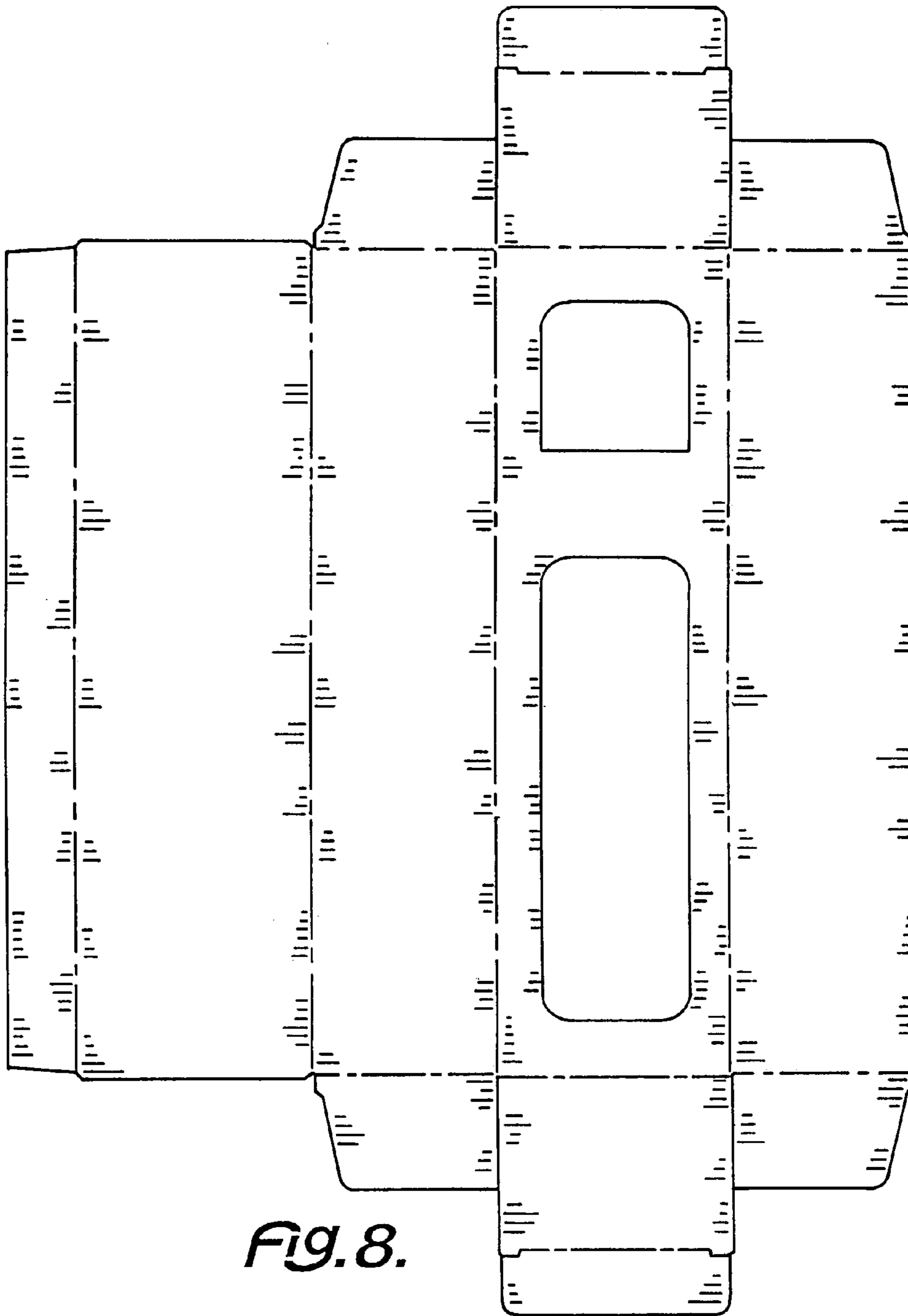
