(57) **CLAIM**

The ornamental design for a chip-type solid state electrolytic capacitor, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, bottom and right side perspective view of a chip-type solid state electrolytic capacitor showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side elevational view thereof;

FIG. 5 is a right side elevational view thereof;

FIG. 6 is a top plan view thereof; and,

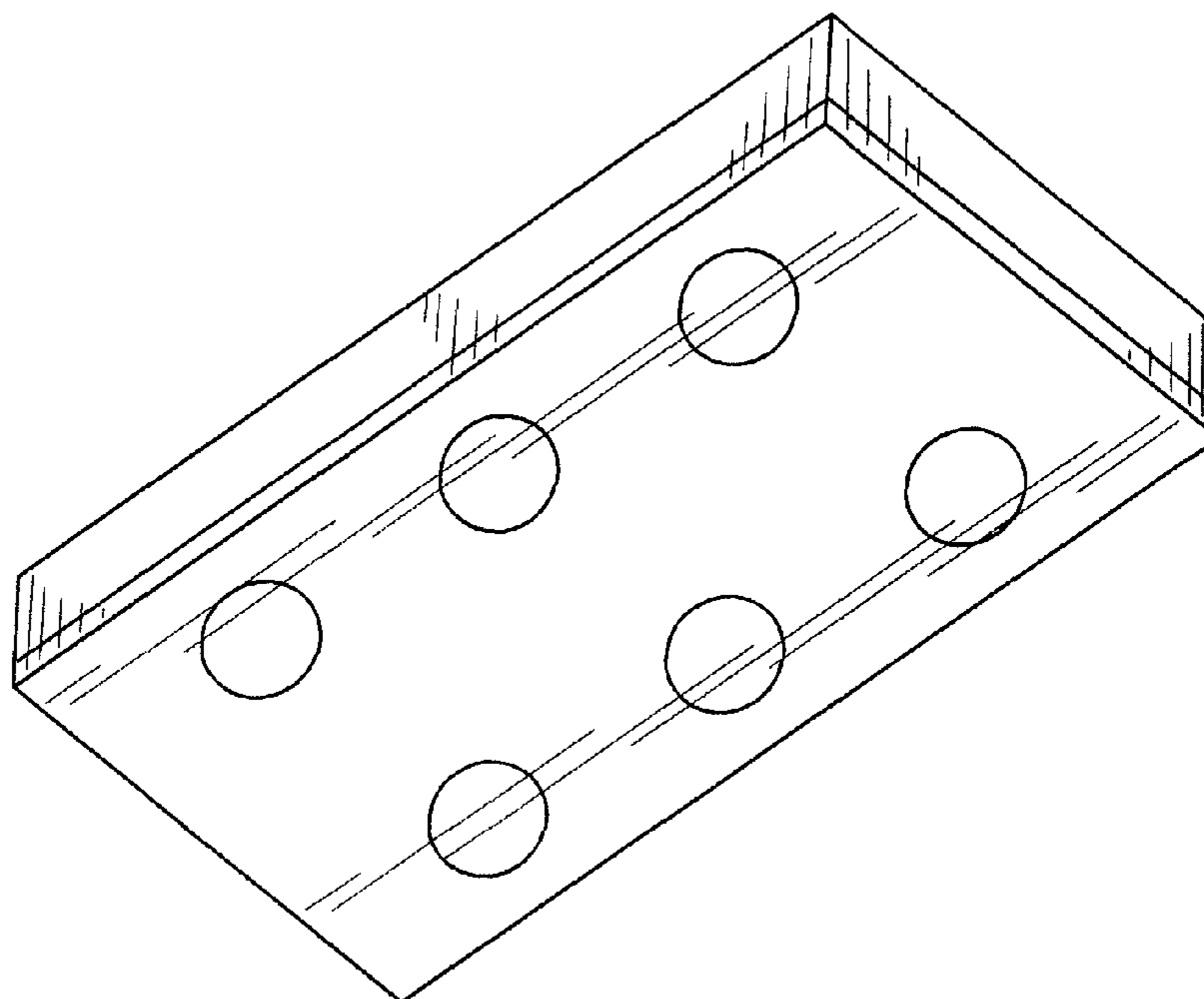

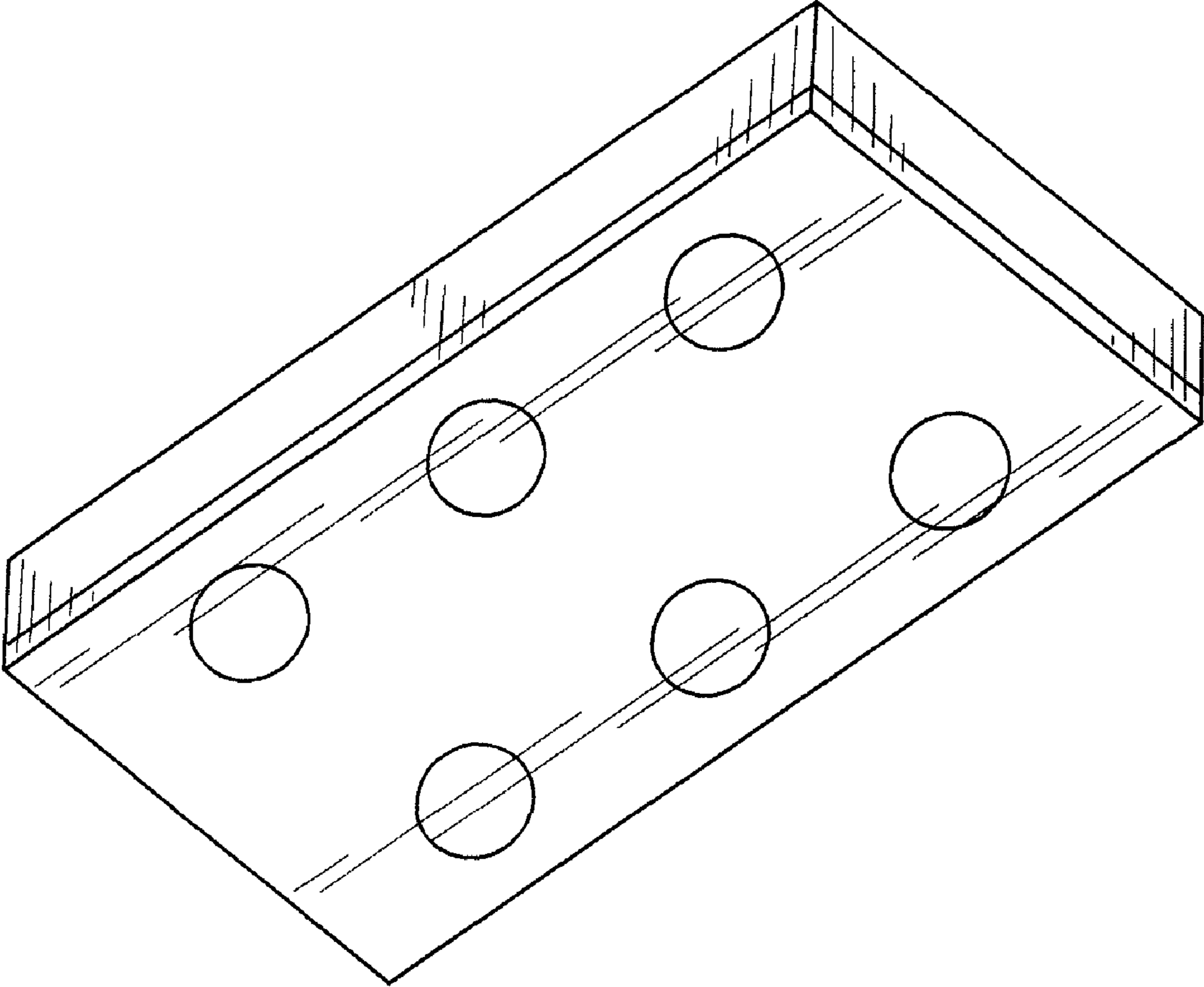

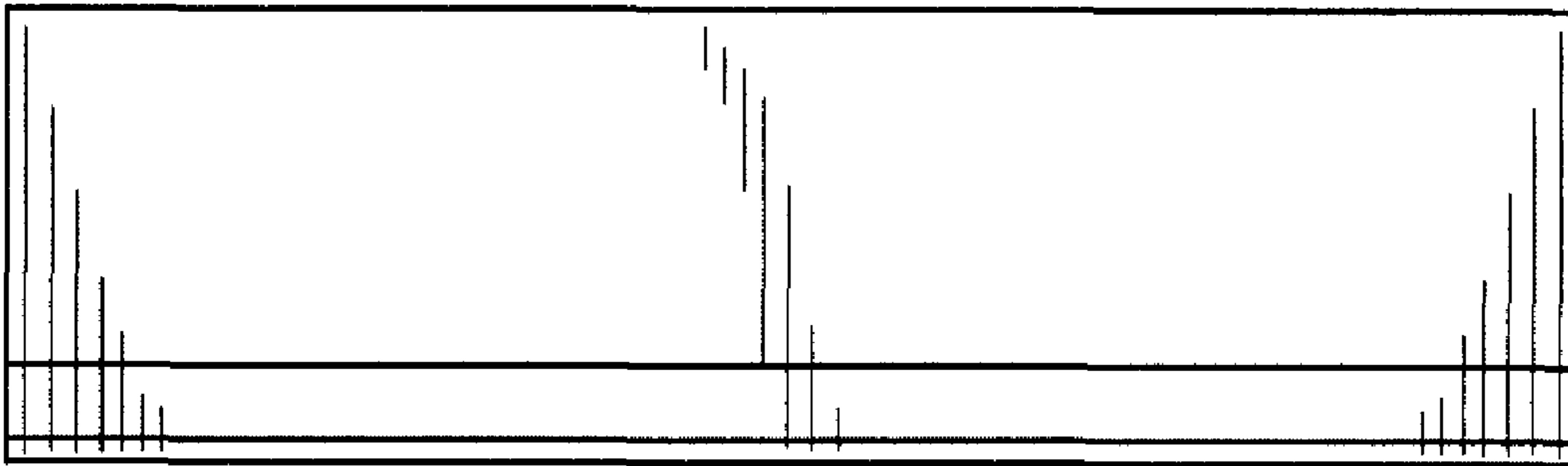

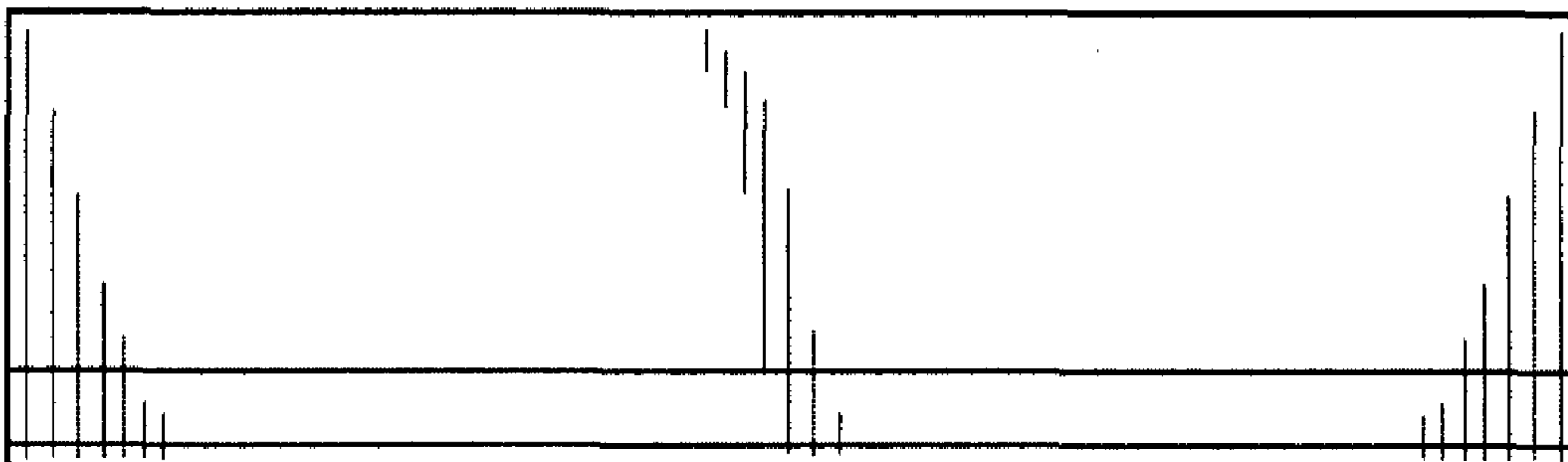

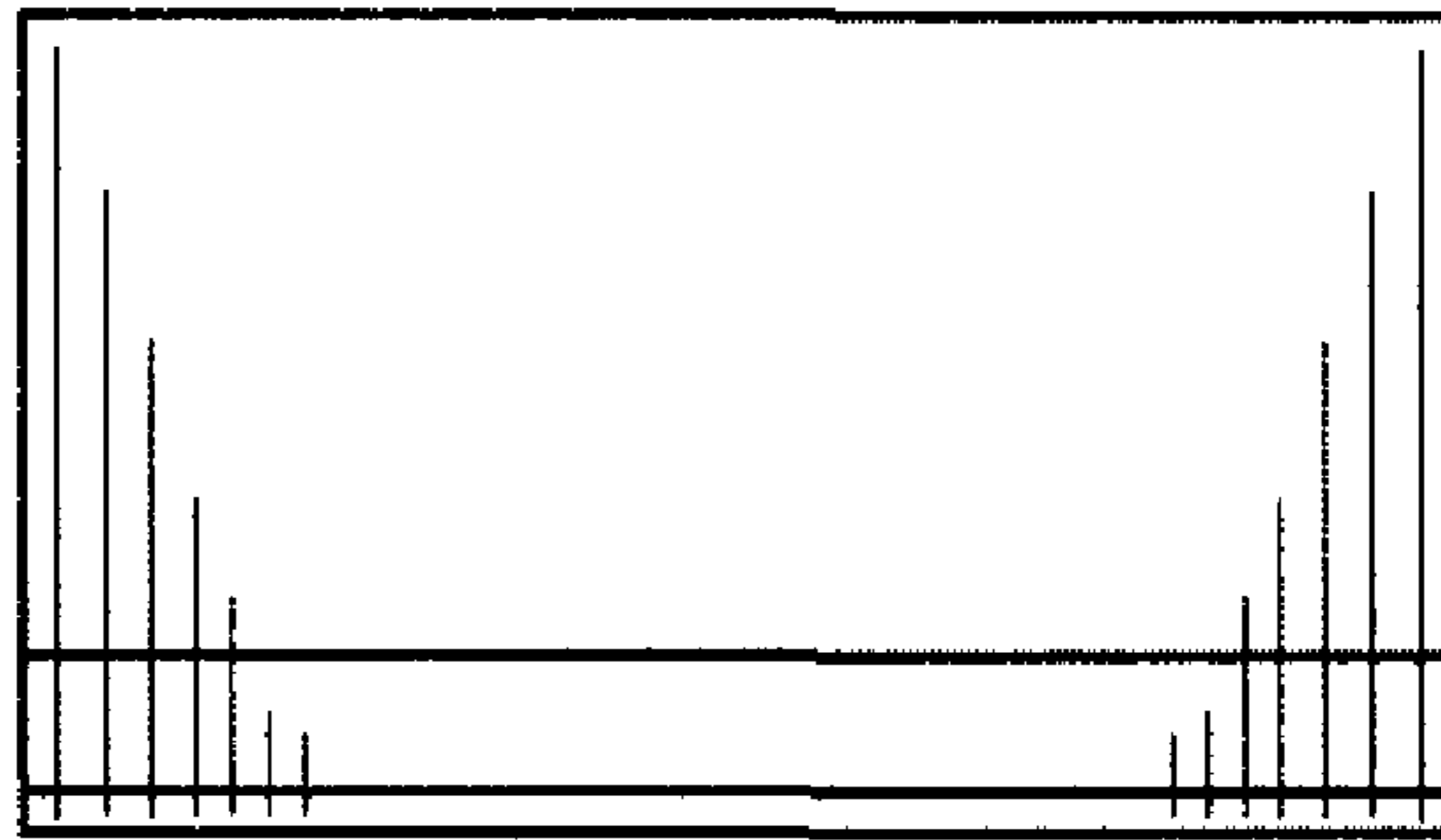

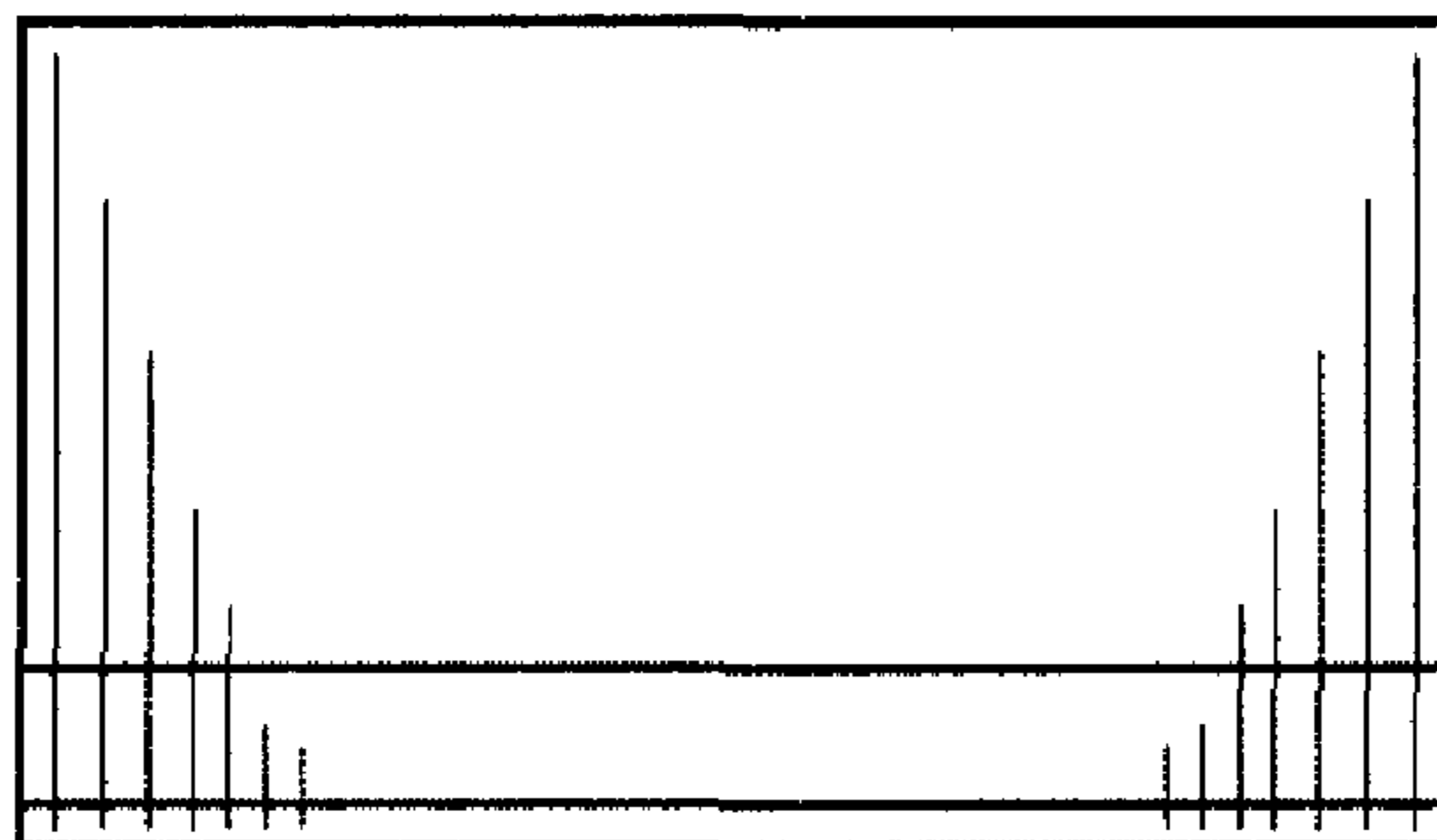

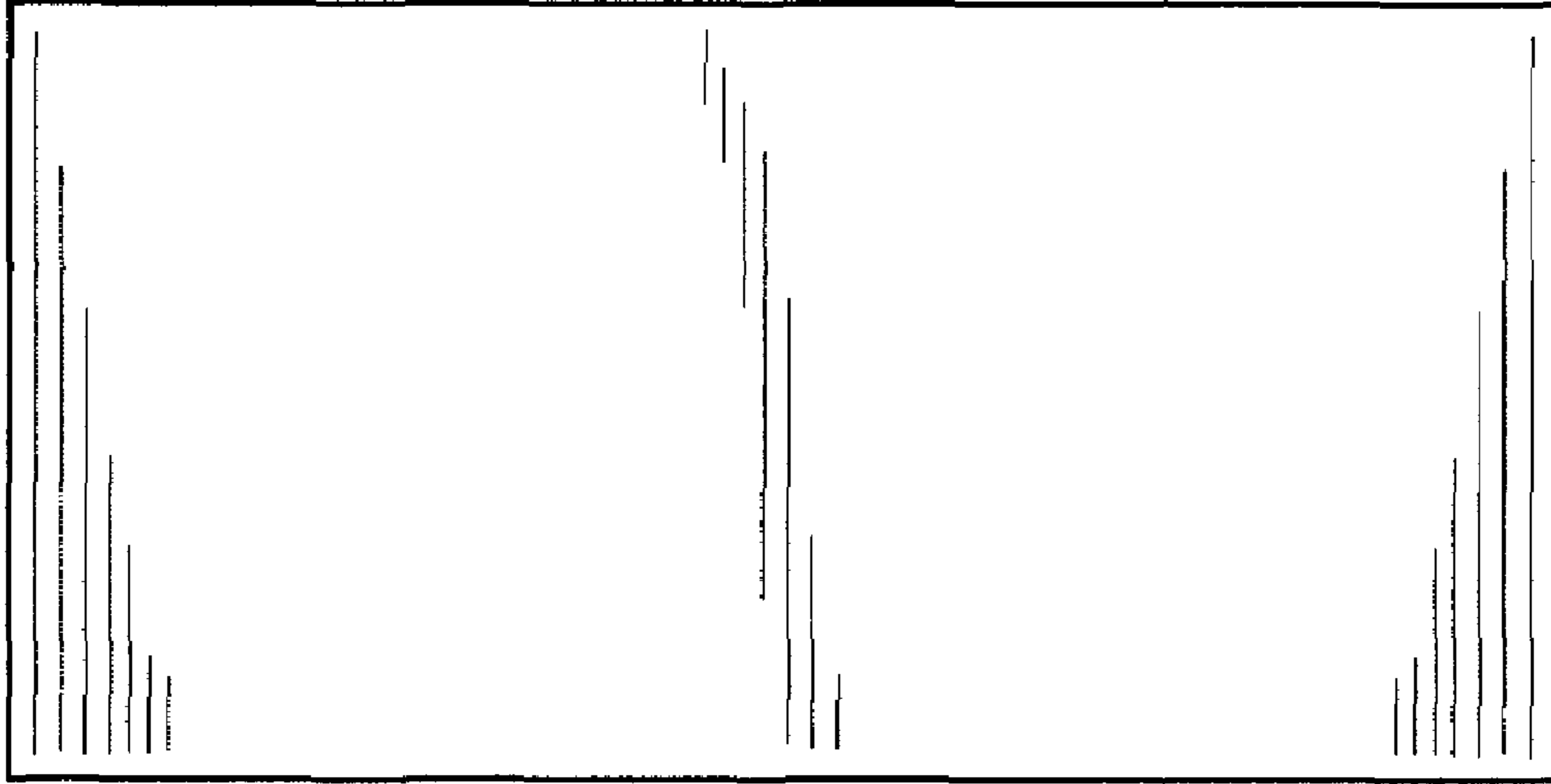
