The ornamental design for an appliance outlet box, as shown  
and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an appliance outlet box  
showing a first embodiment of our new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a right side elevational view thereof;

FIG. 7 is a bottom plan view thereof; and,

FIG. 8 is a front elevational view of a front elevational view  
of a second embodiment thereof, the only difference residing  
in the addition of plugs in drain holes.

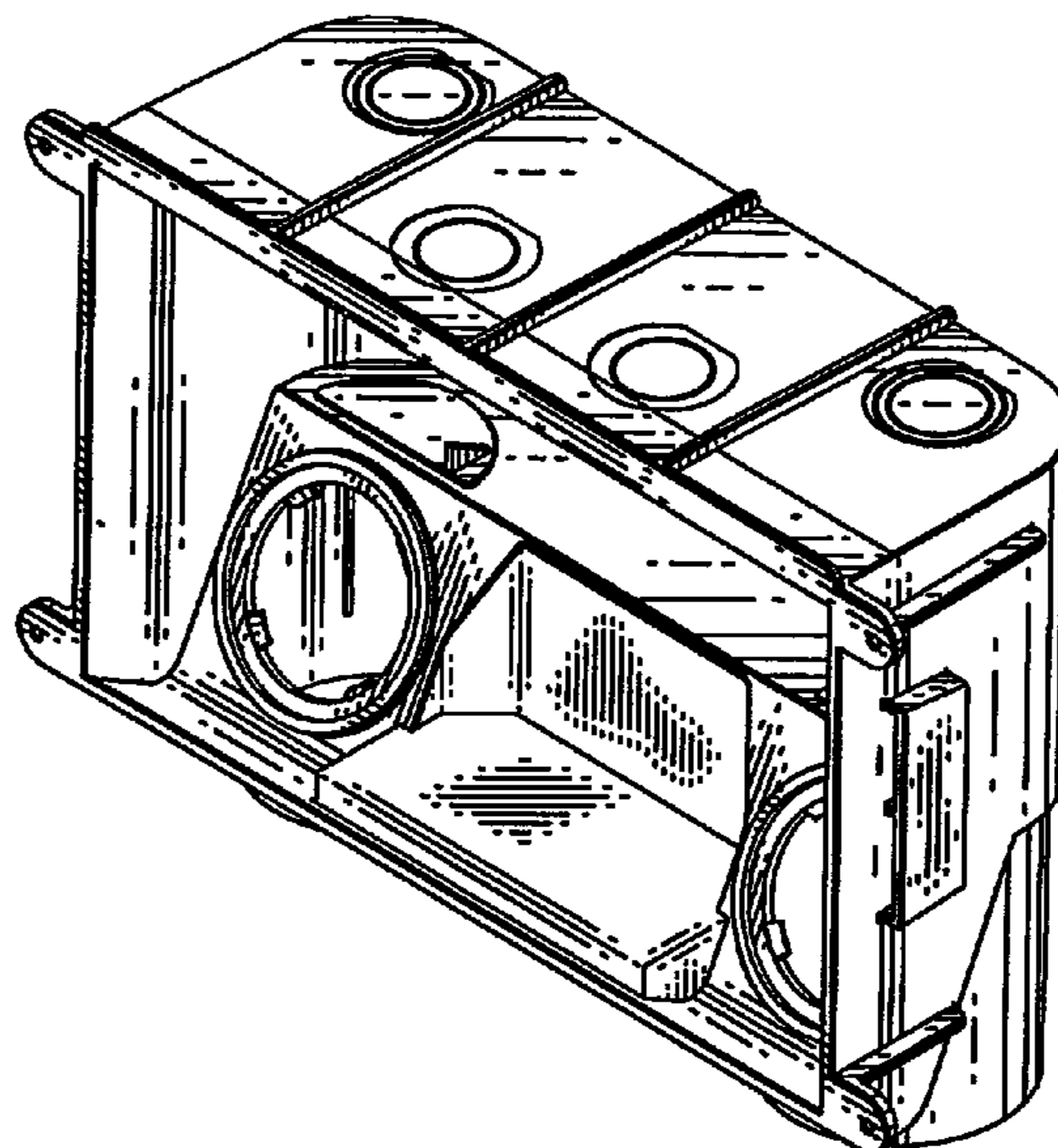

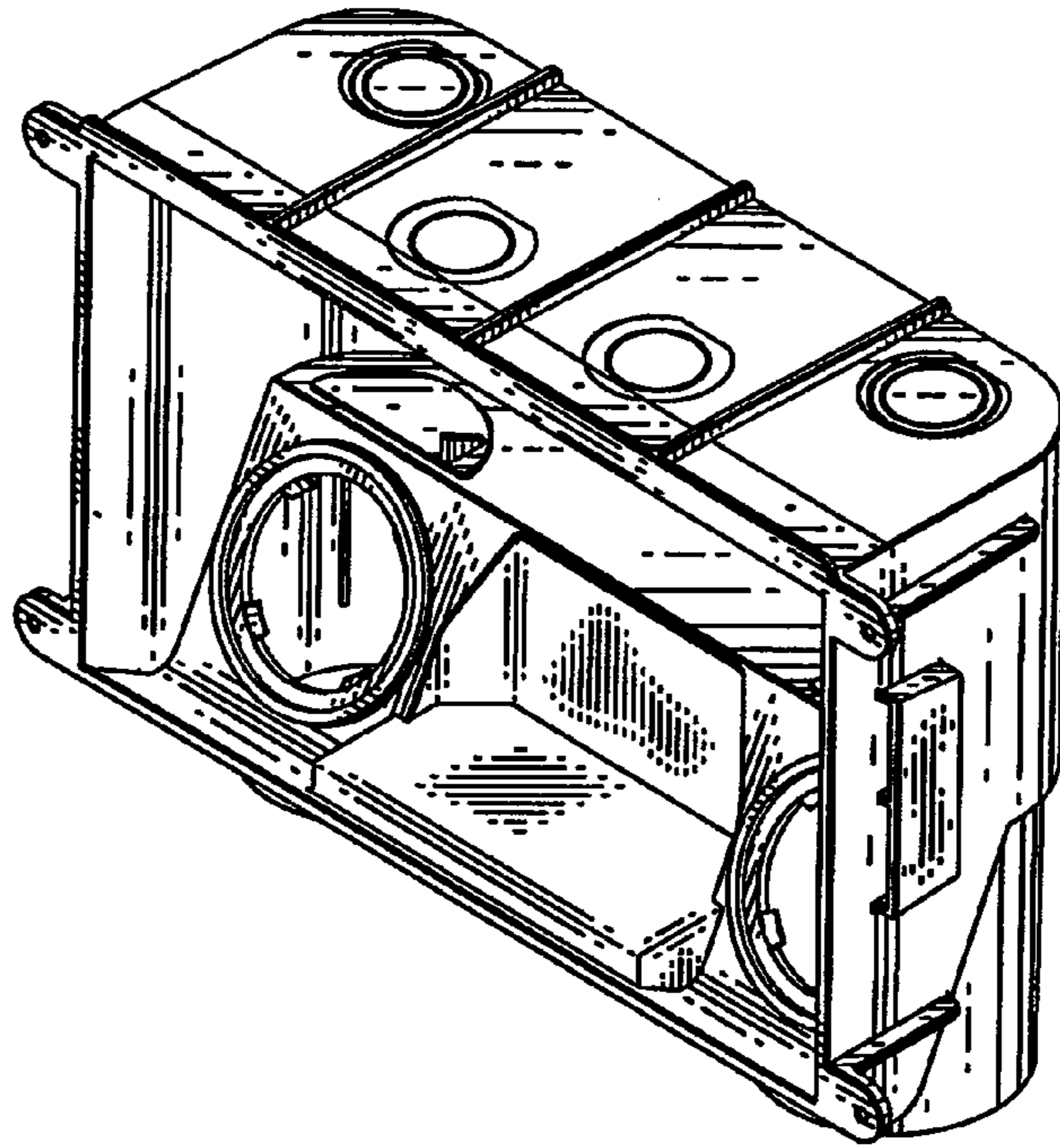

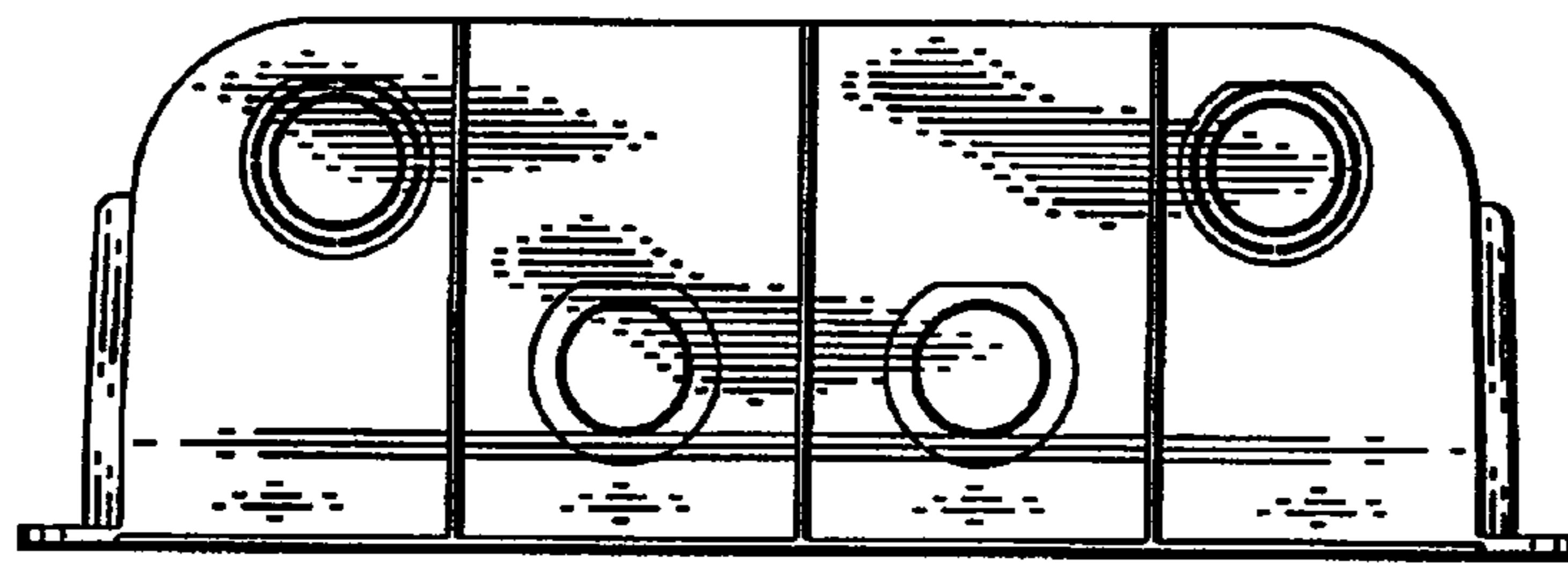

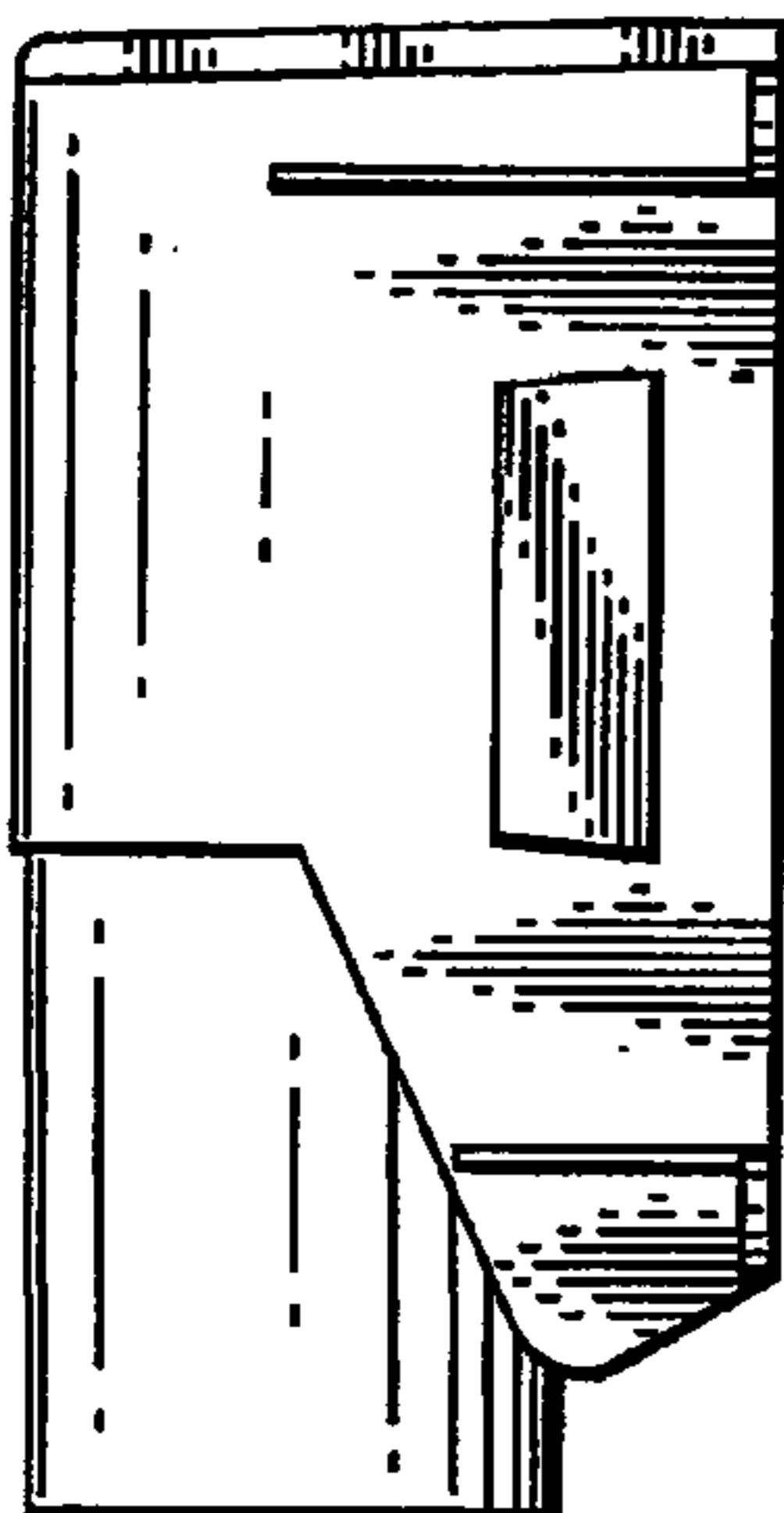
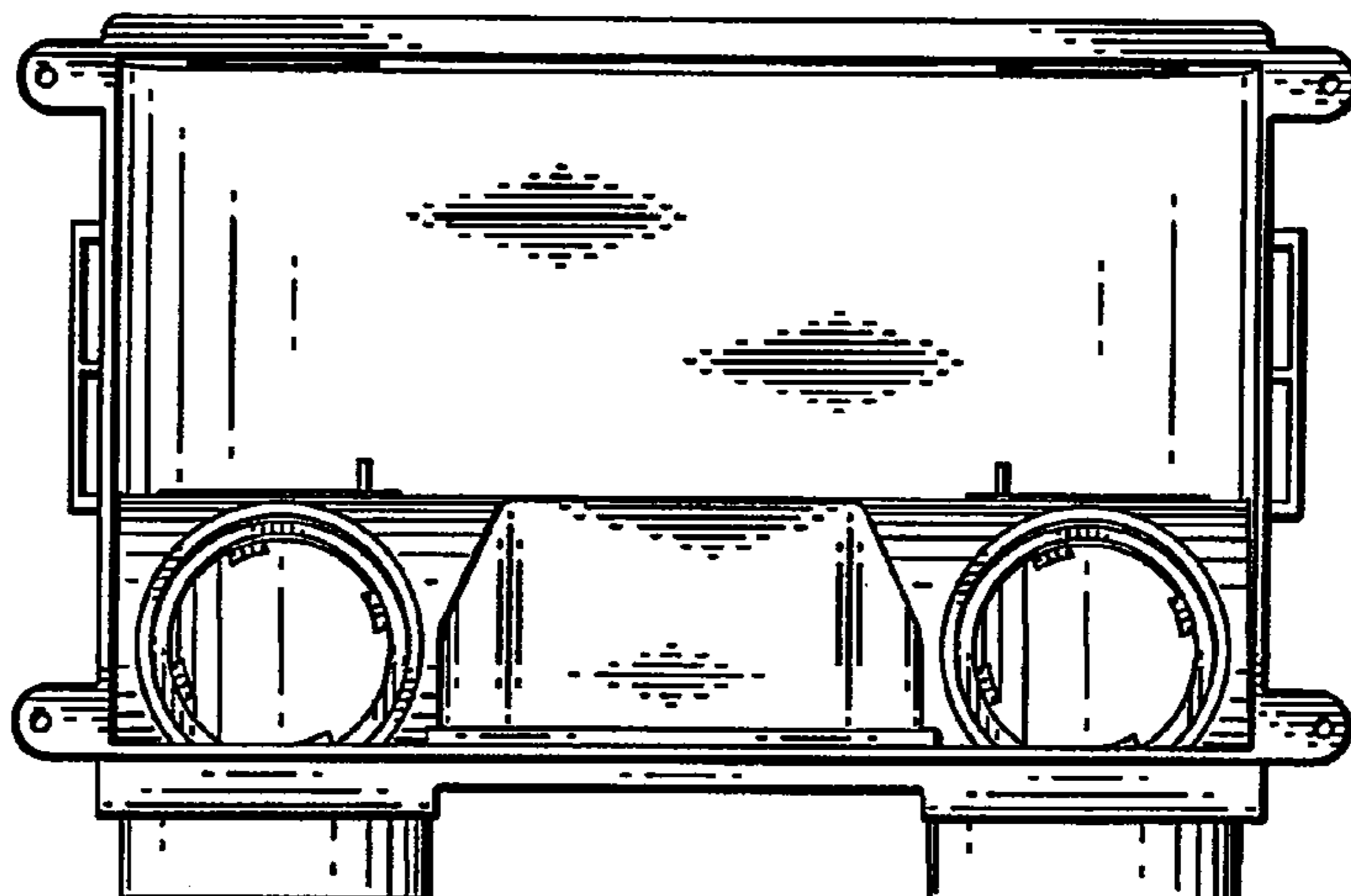
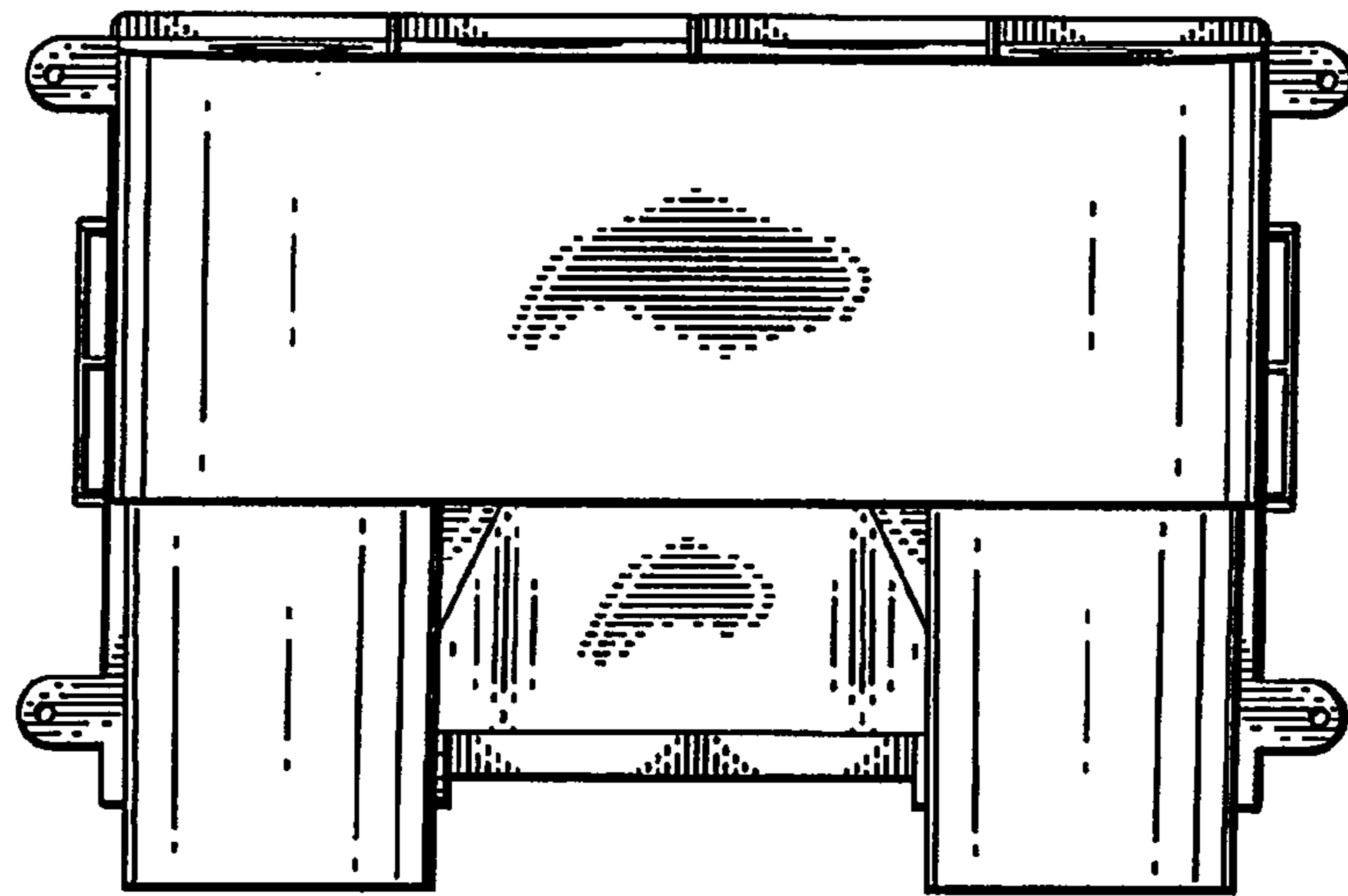


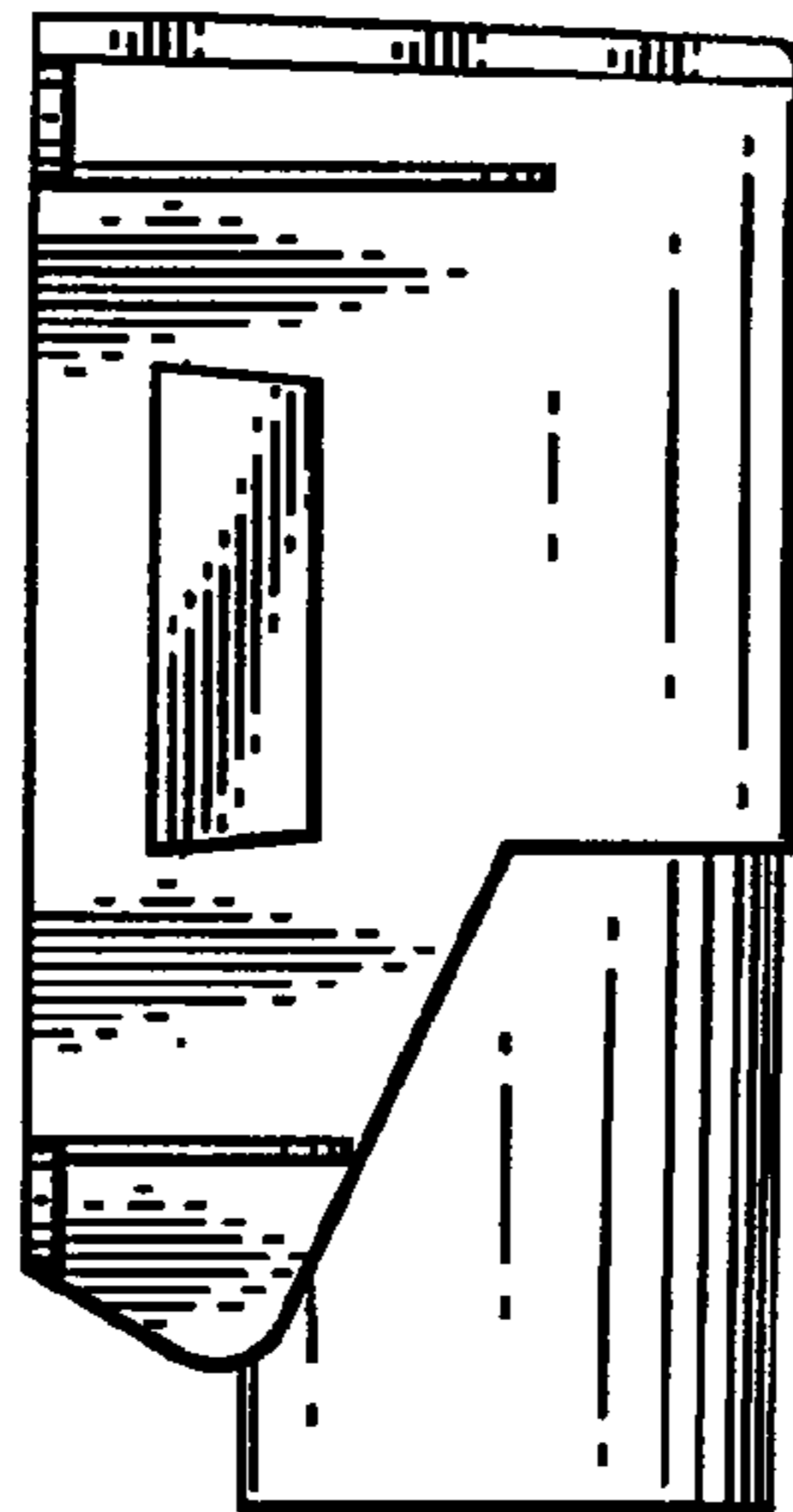

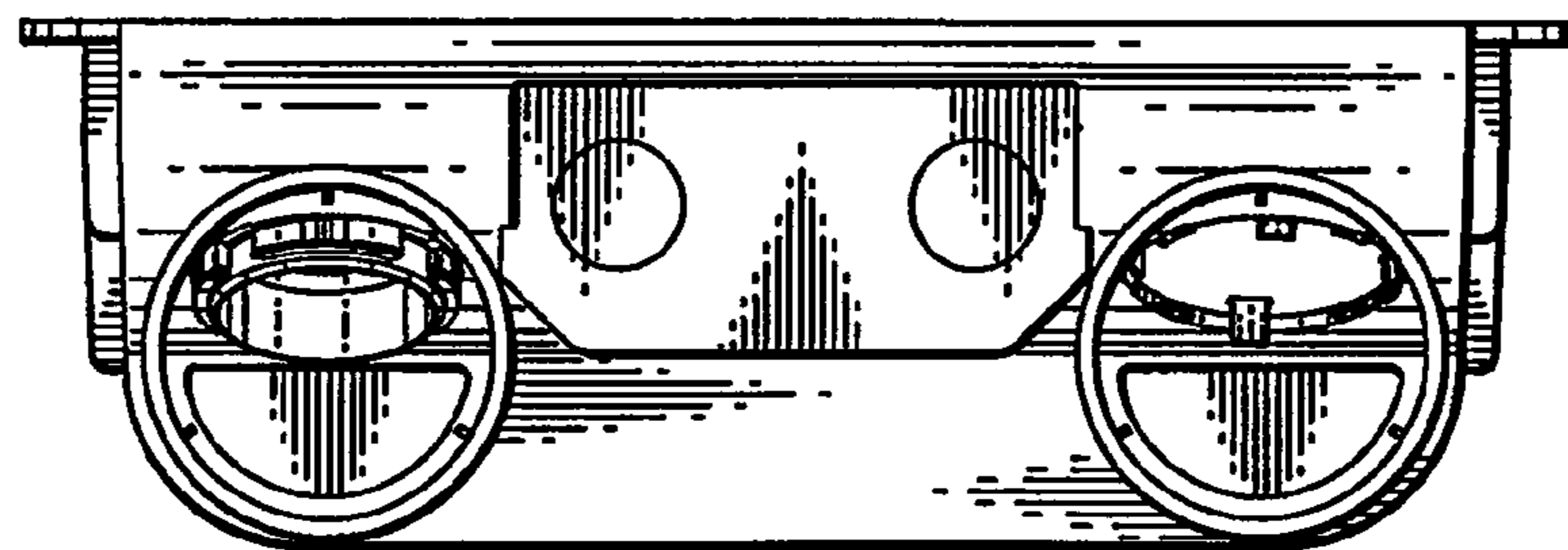
