The ornamental design for the portion of a computer screen with an icon image, as shown and described.

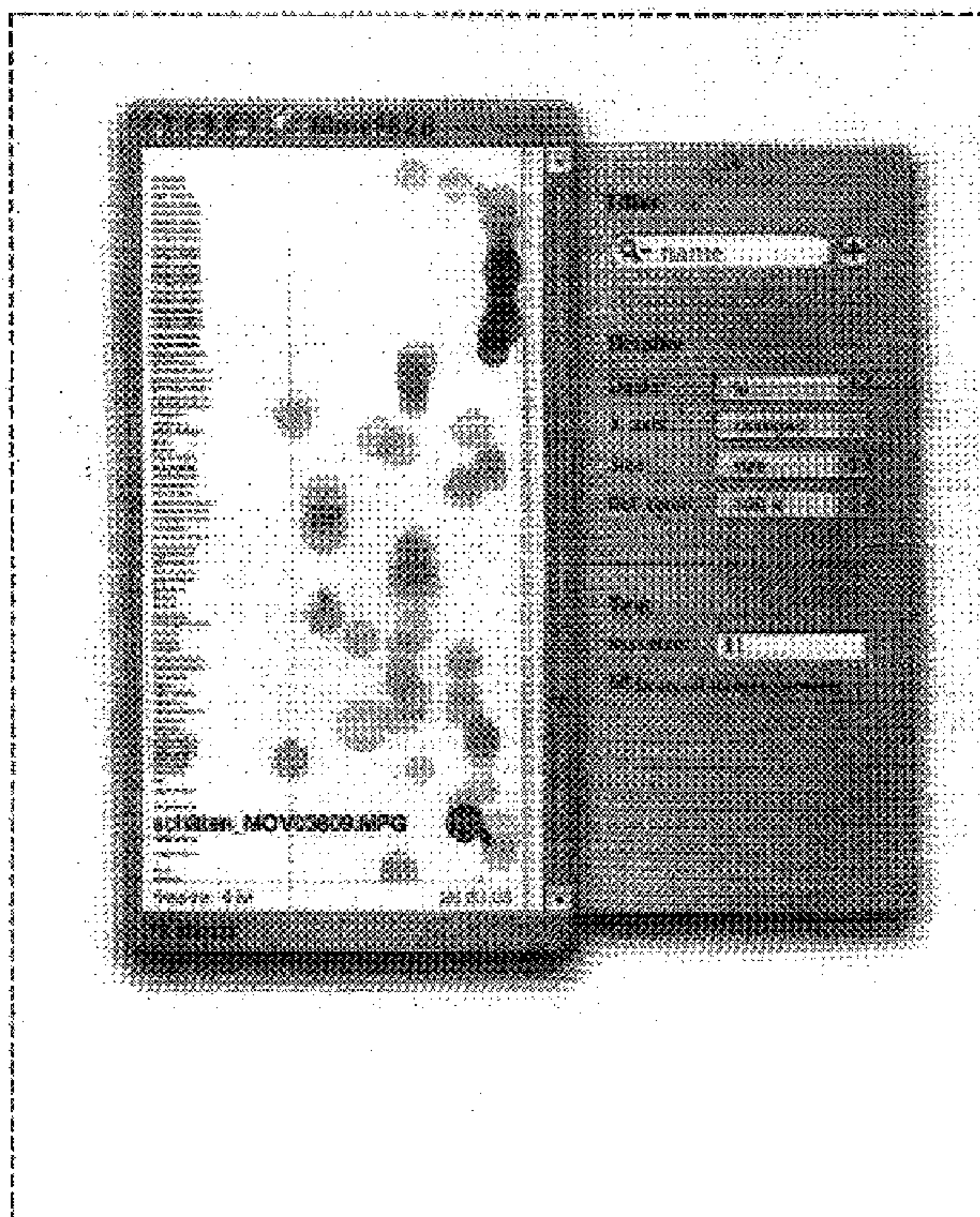

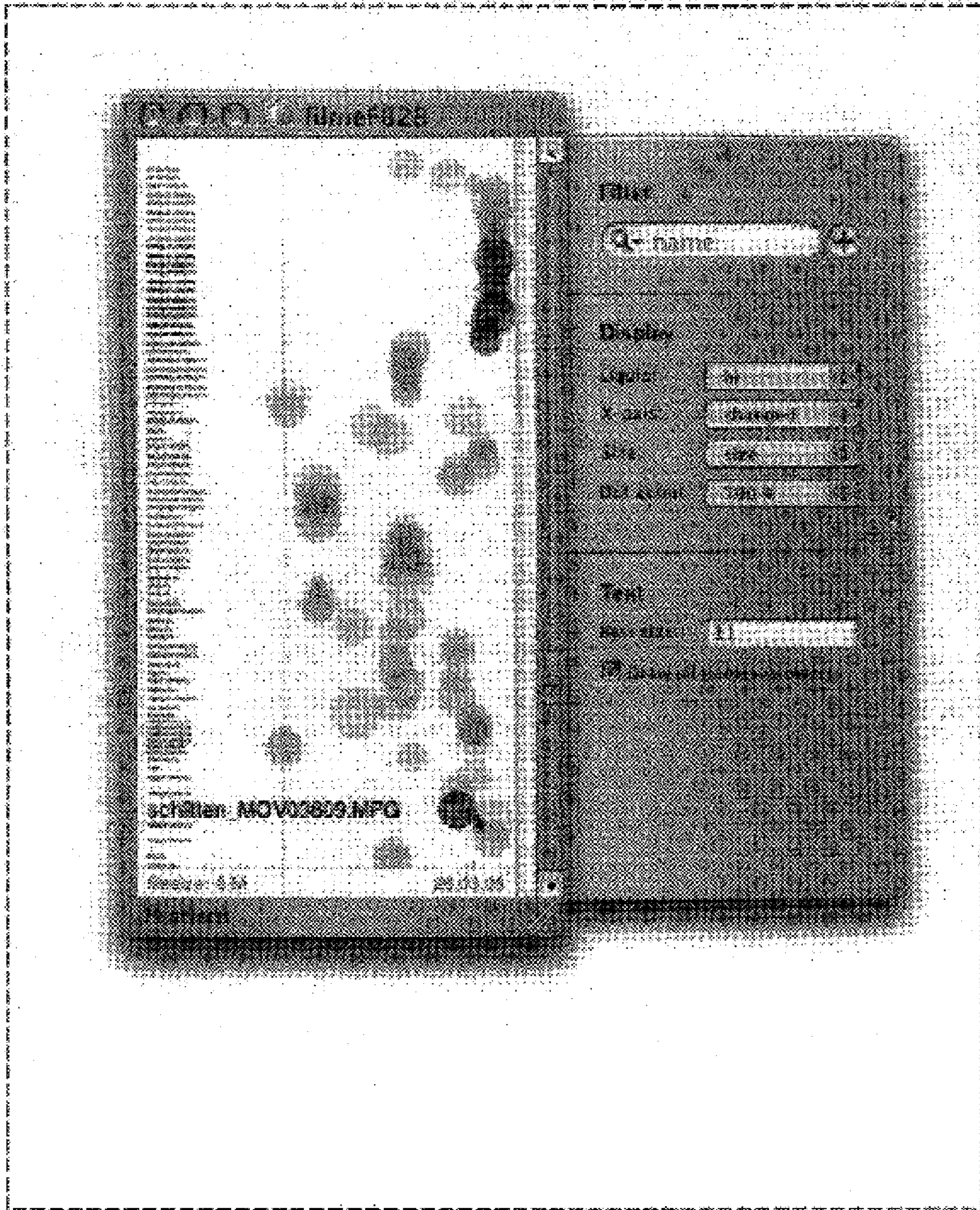
The FIGURE is a front view of a portion of a computer screen with an icon image.
