The ornamental design for a background image for a portion of a display screen, as shown and described.

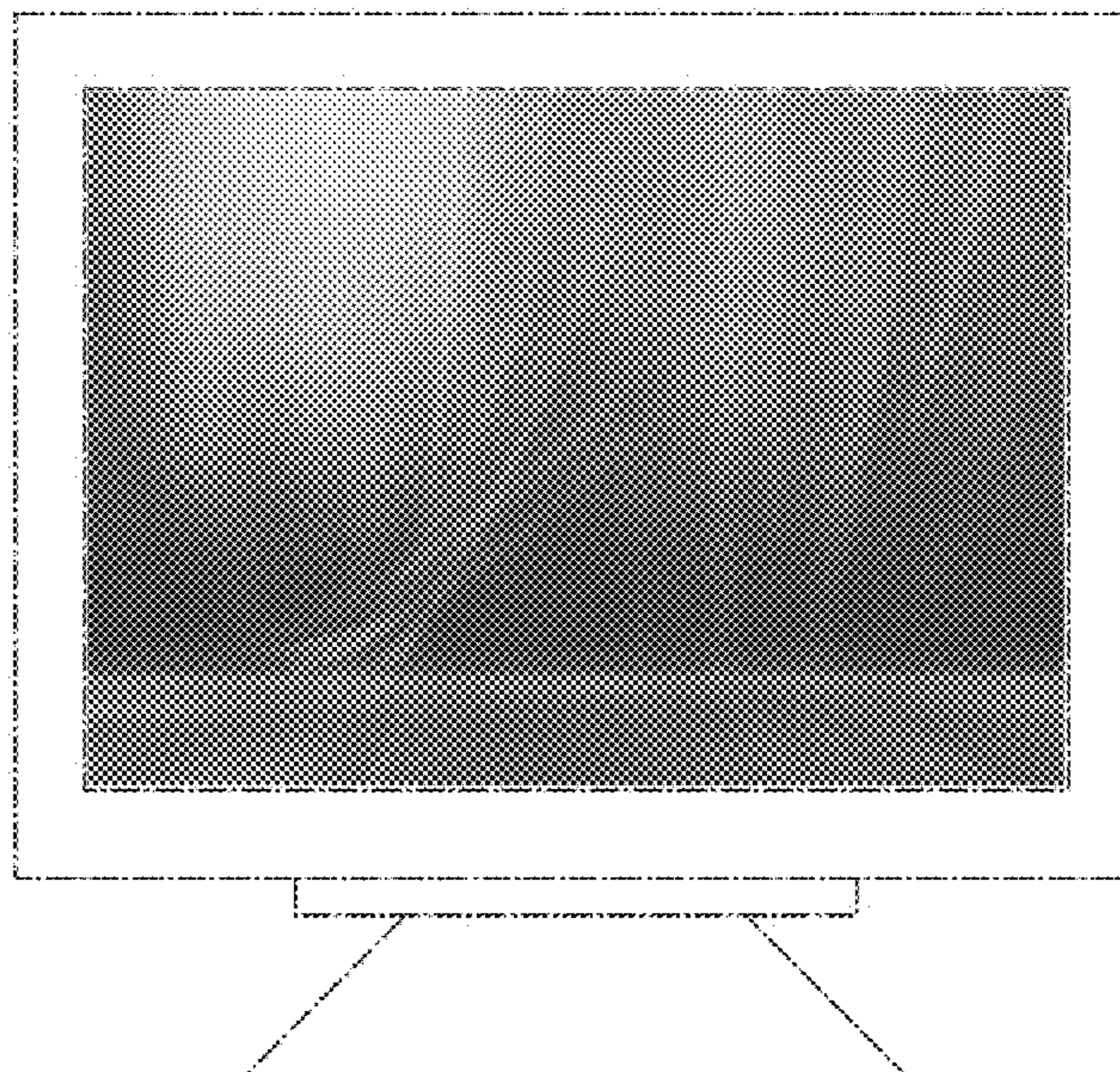
DESCRIPTION

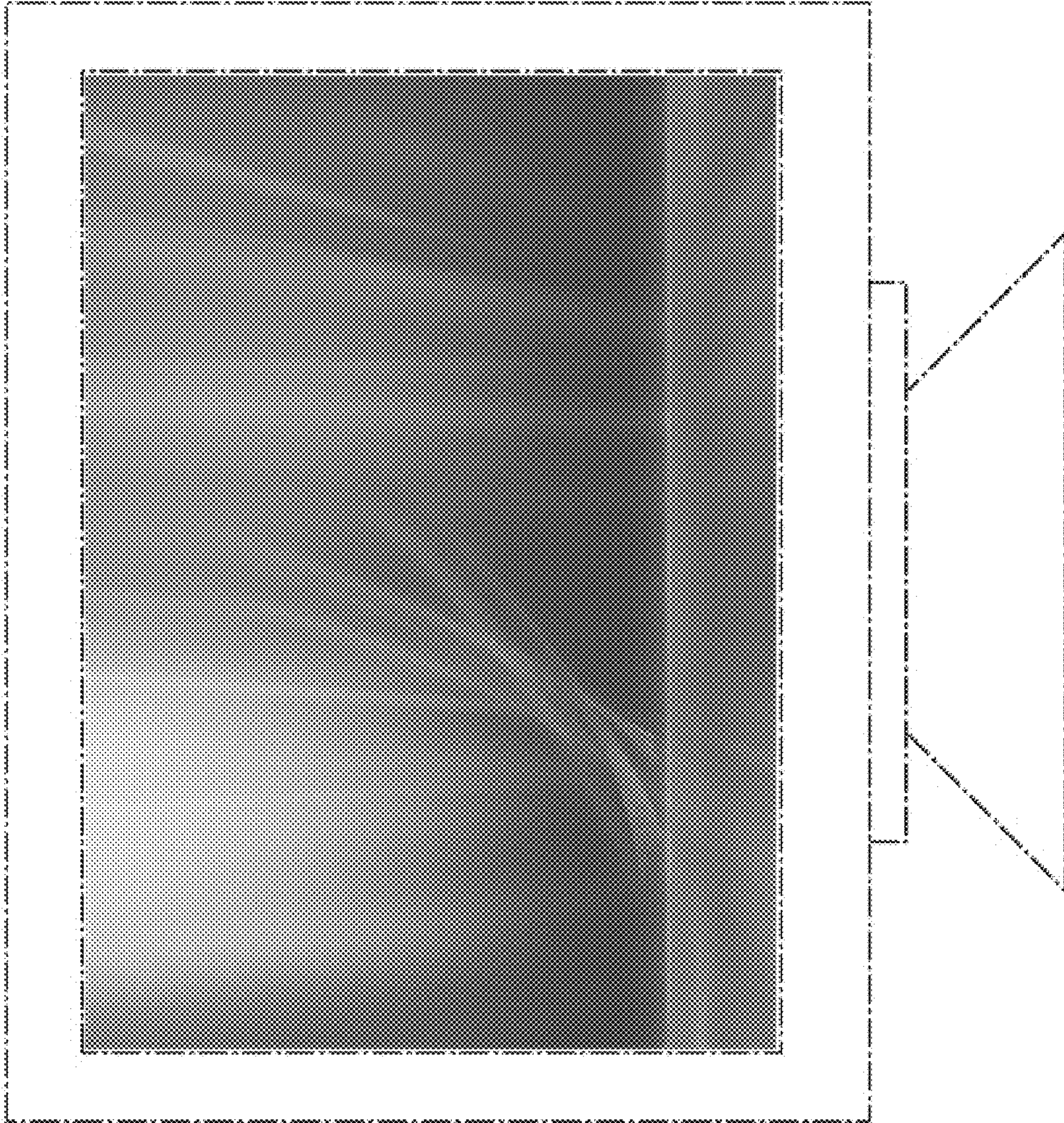
