DESCRIPTION

FIG. 1 is a perspective view of a point of sale terminal showing a first embodiment of the new design;

FIG. 2 is a front view of the point of sale terminal of FIG. 1;

FIG. 3 is a back view of the point of sale terminal of FIG. 1;

FIG. 4 is a right side view of the point of sale terminal of FIG. 1;

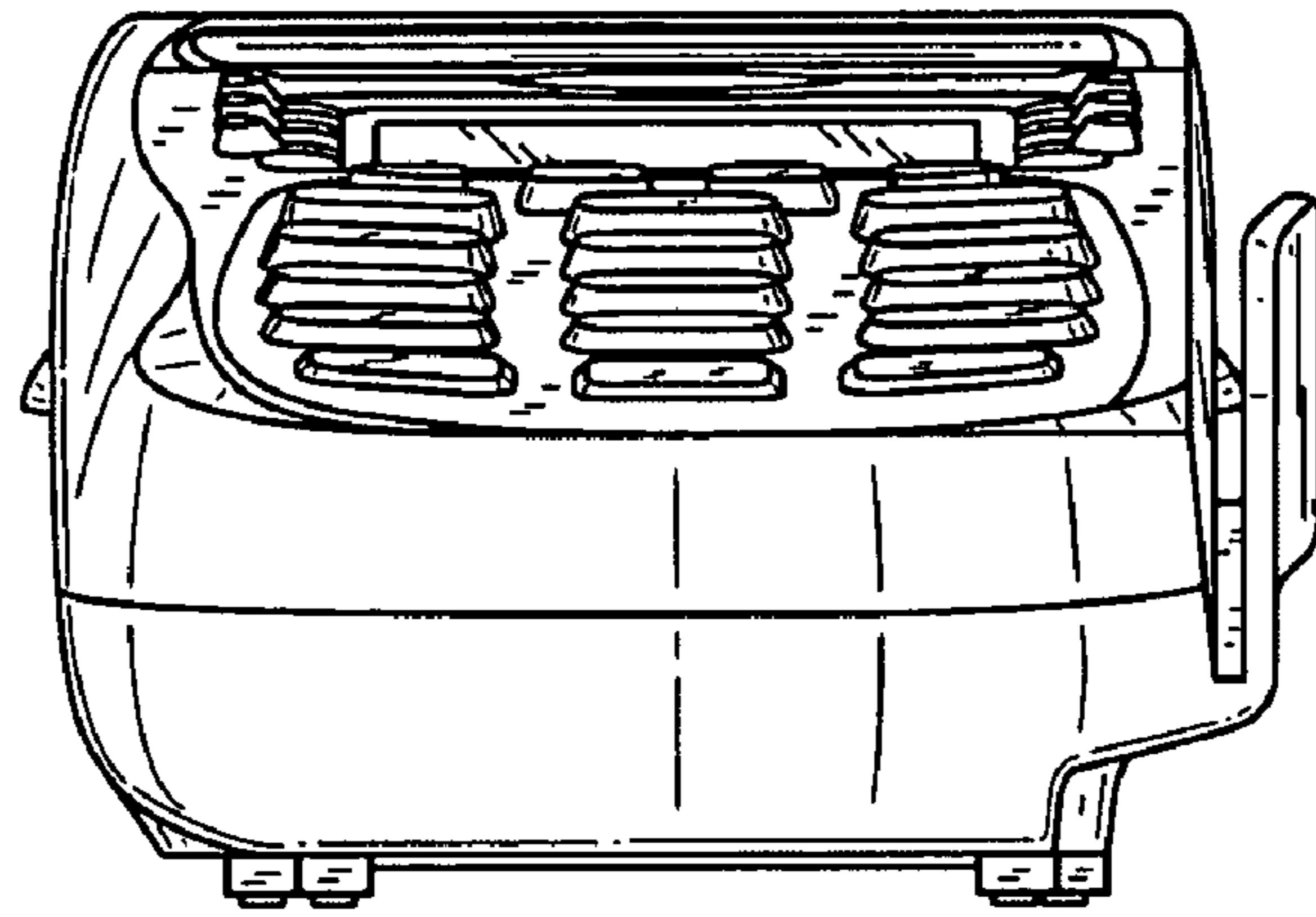

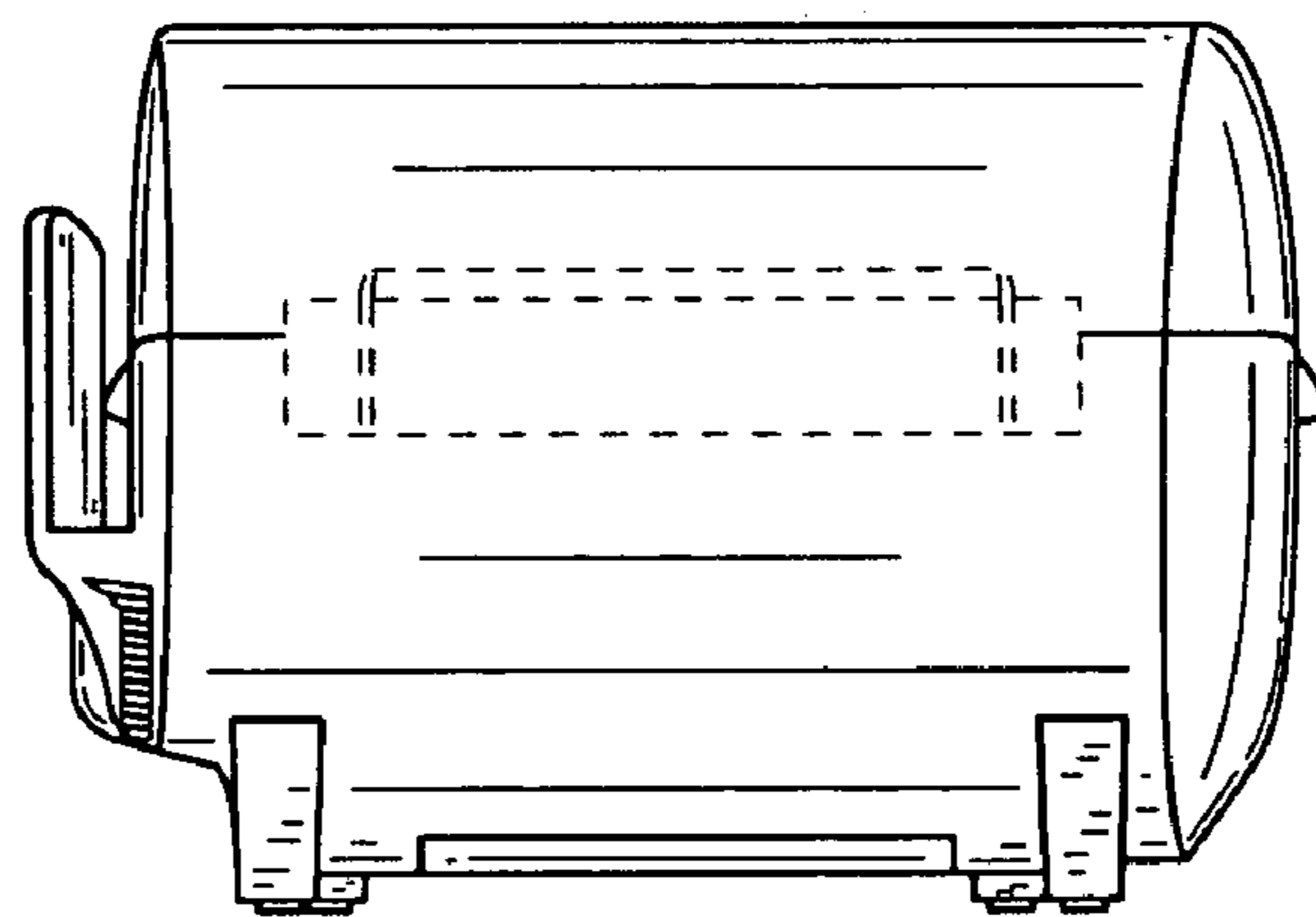

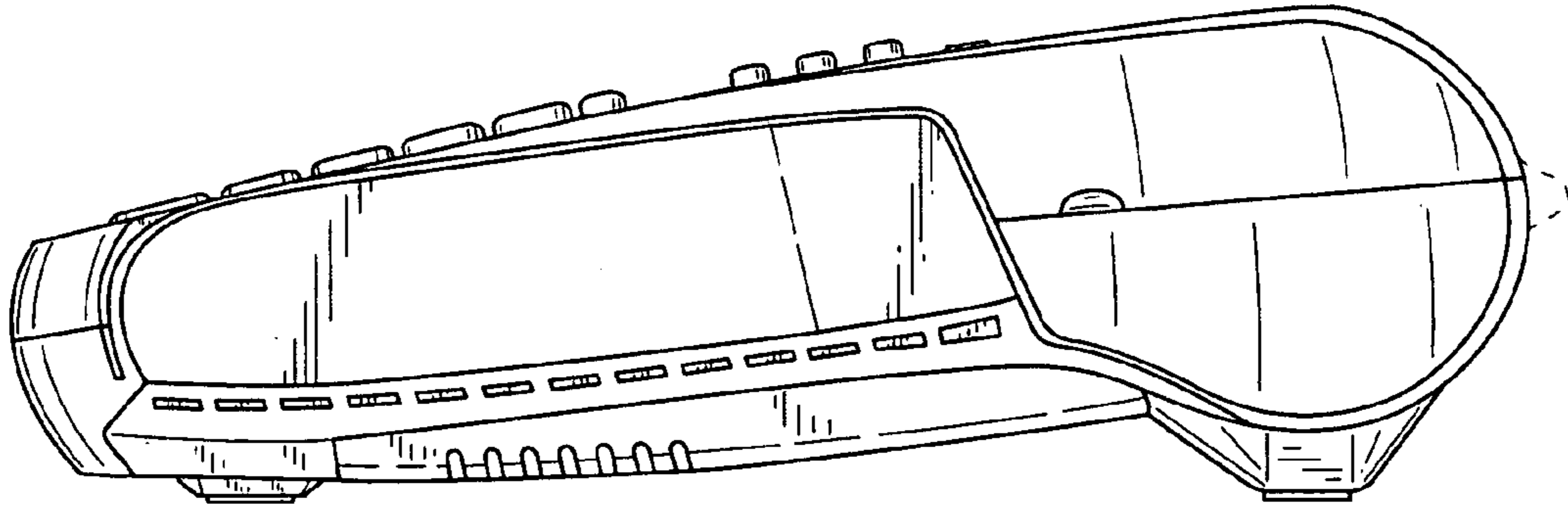

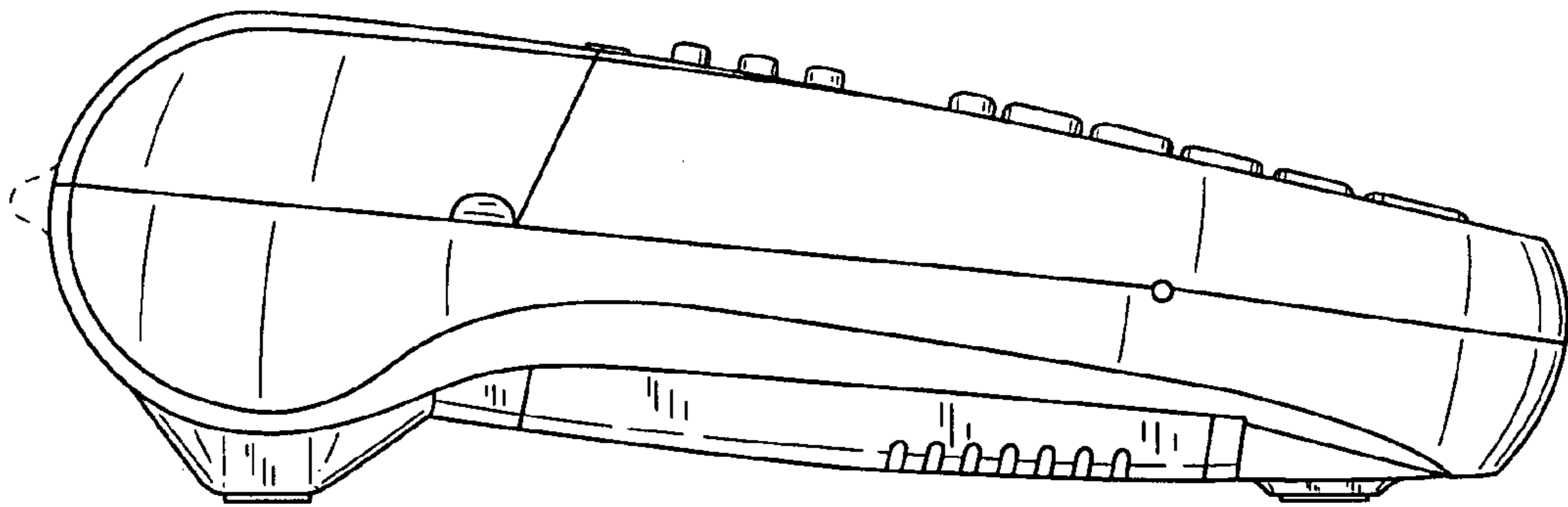

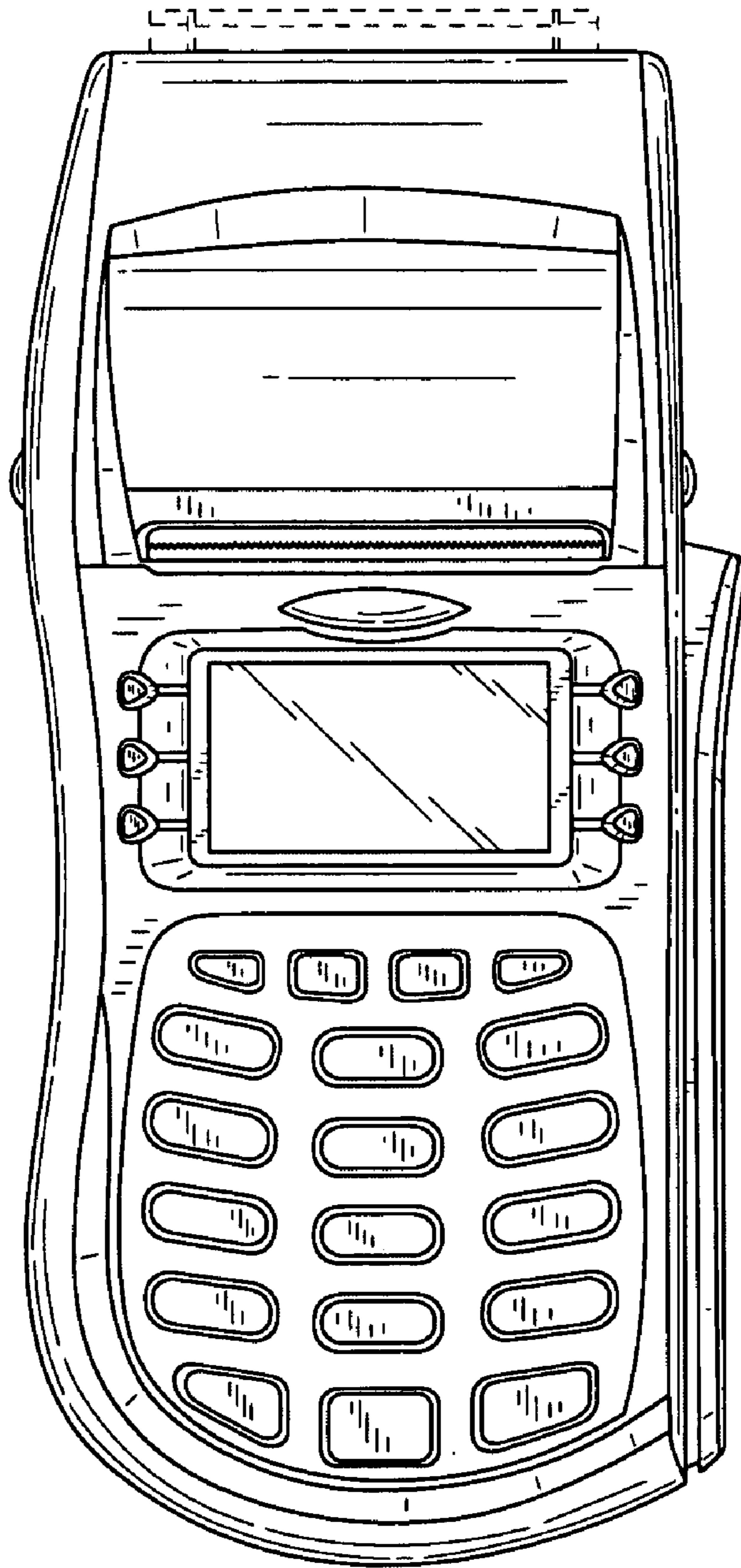

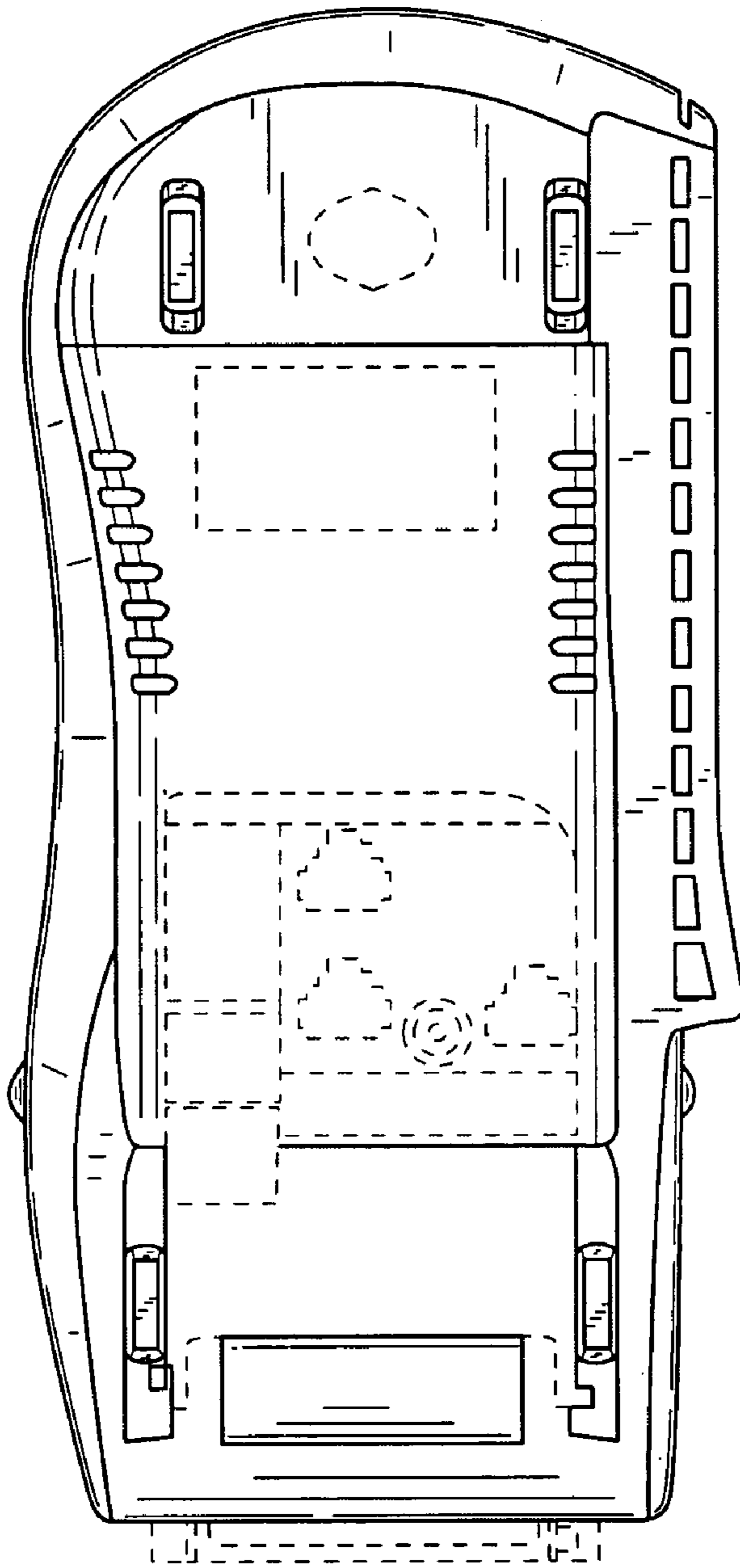

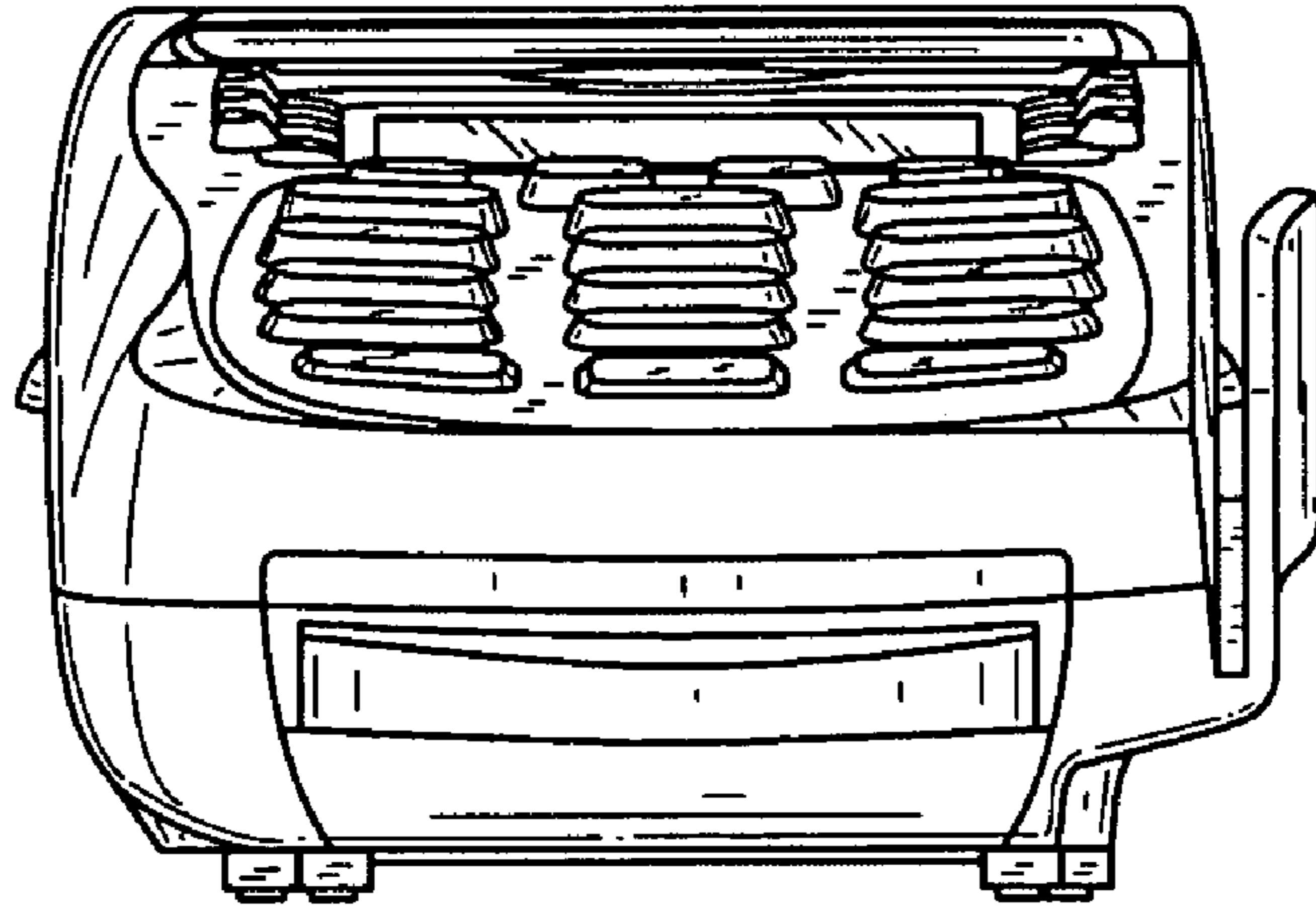

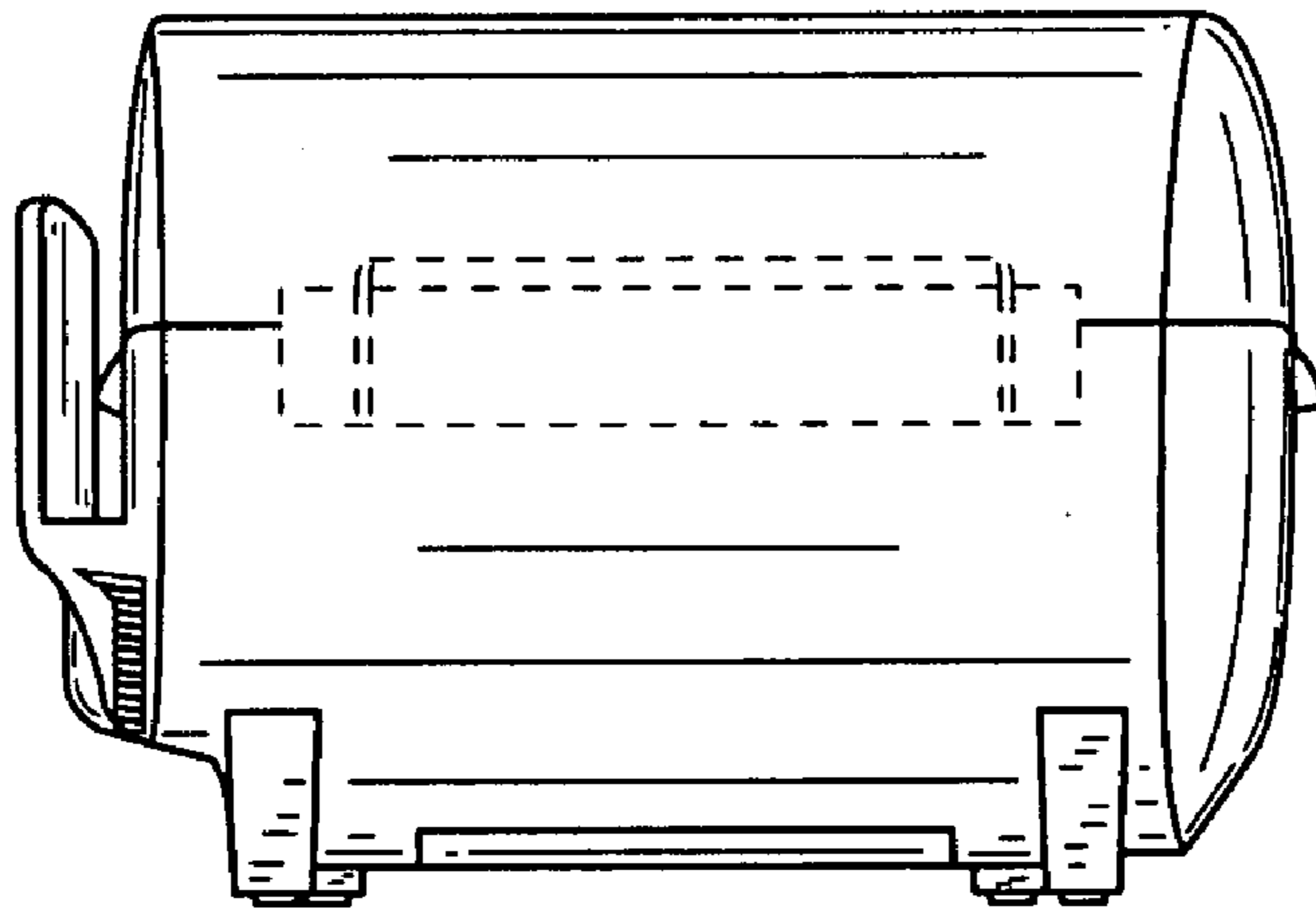

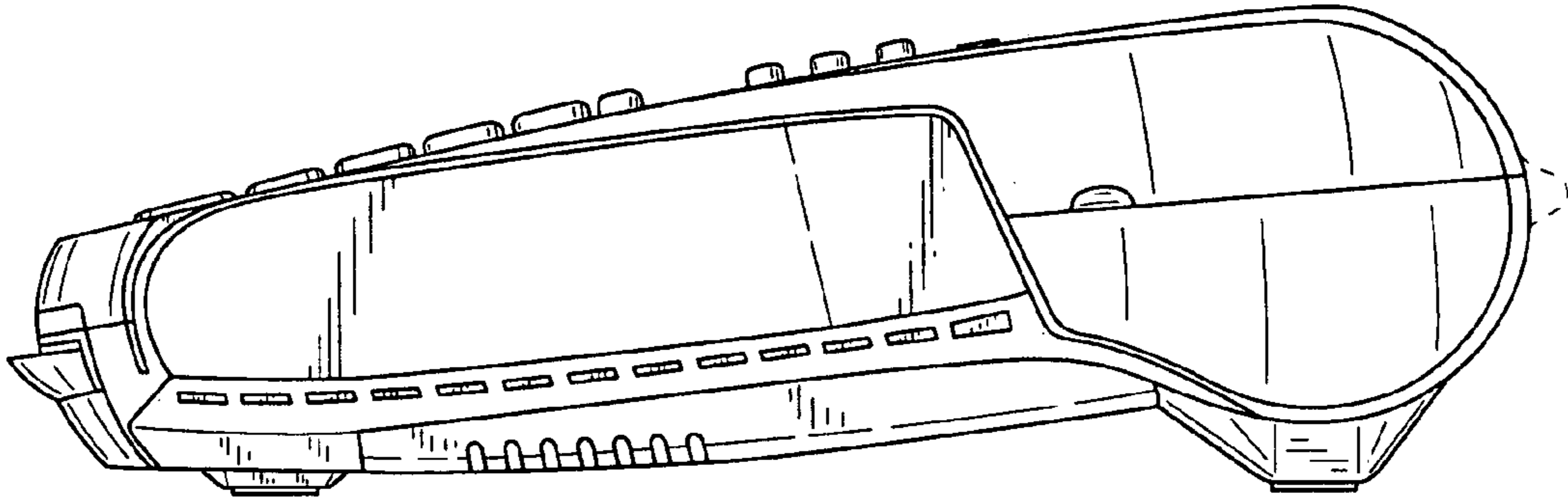

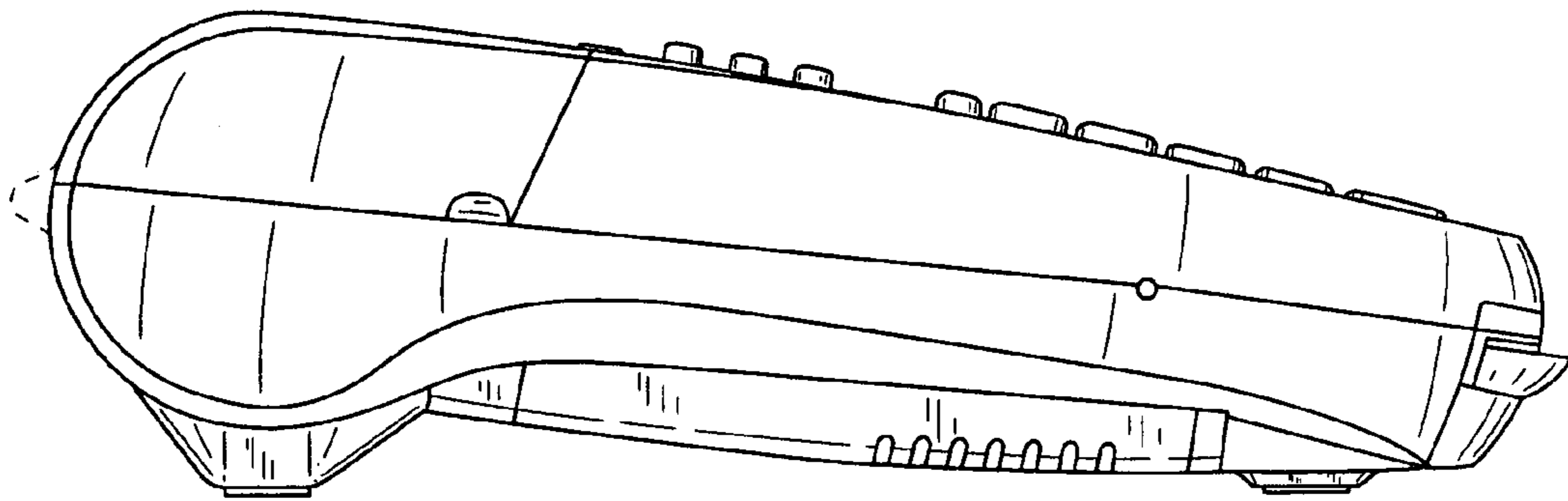

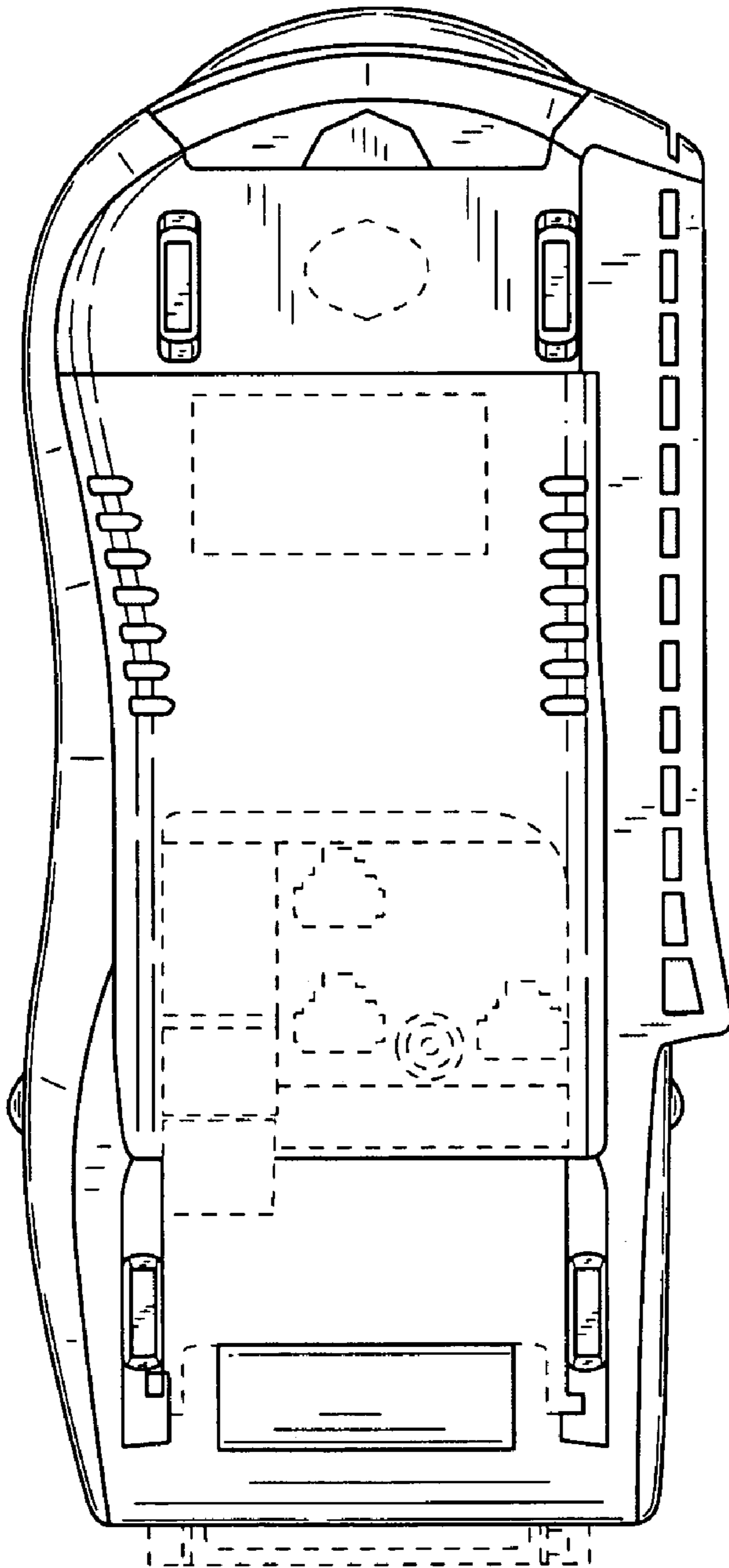
