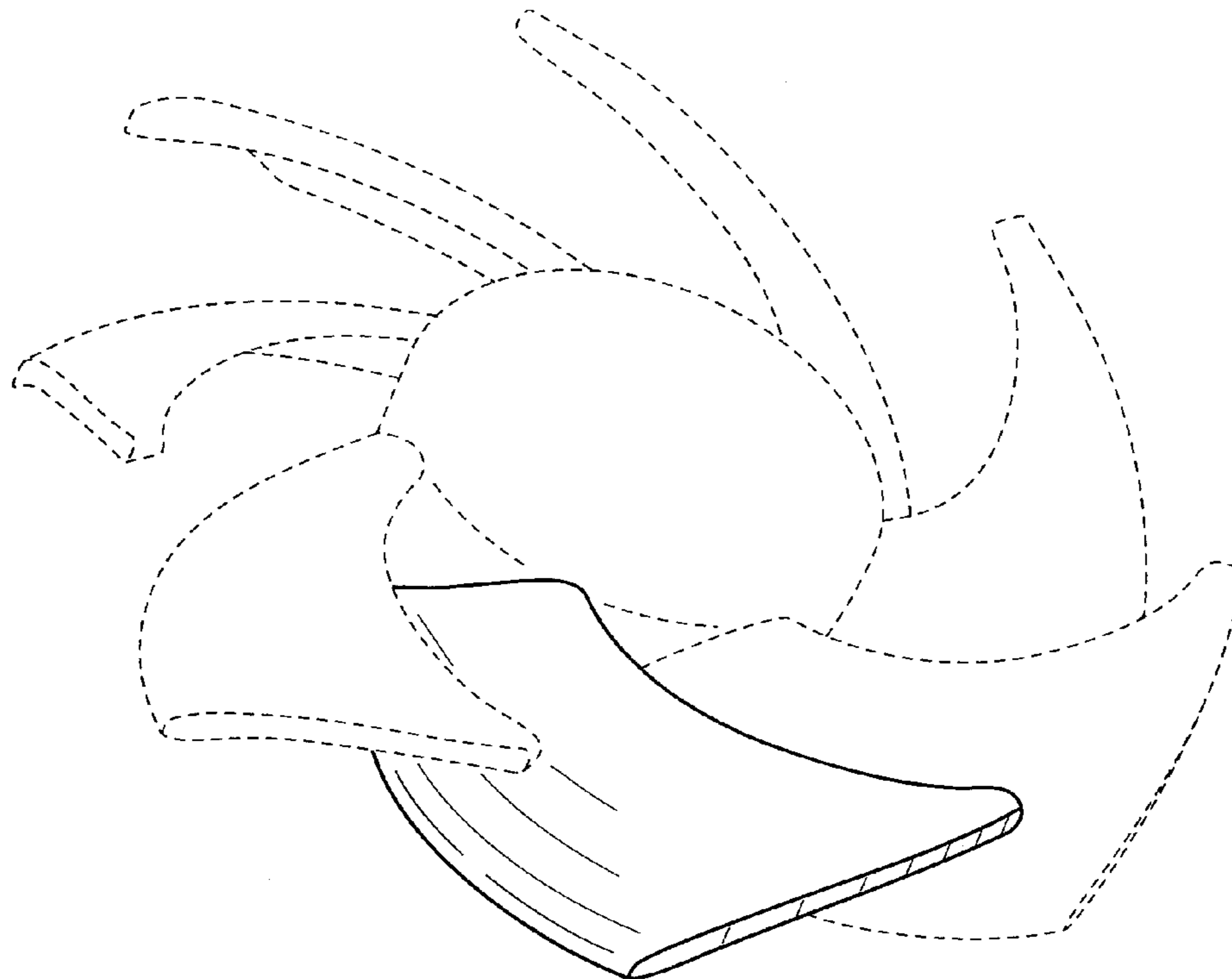
The broken line showing of fan blades and a hub is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

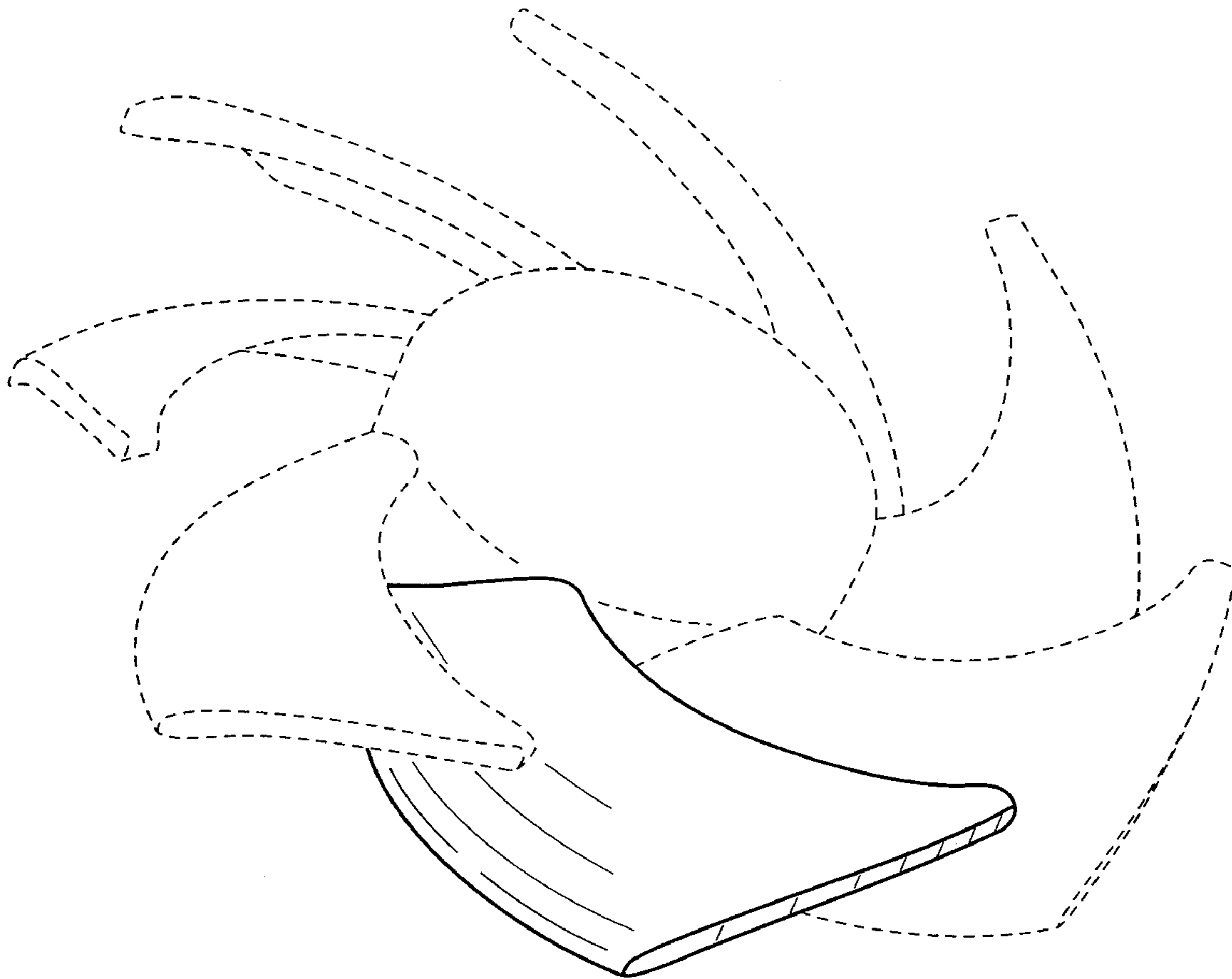

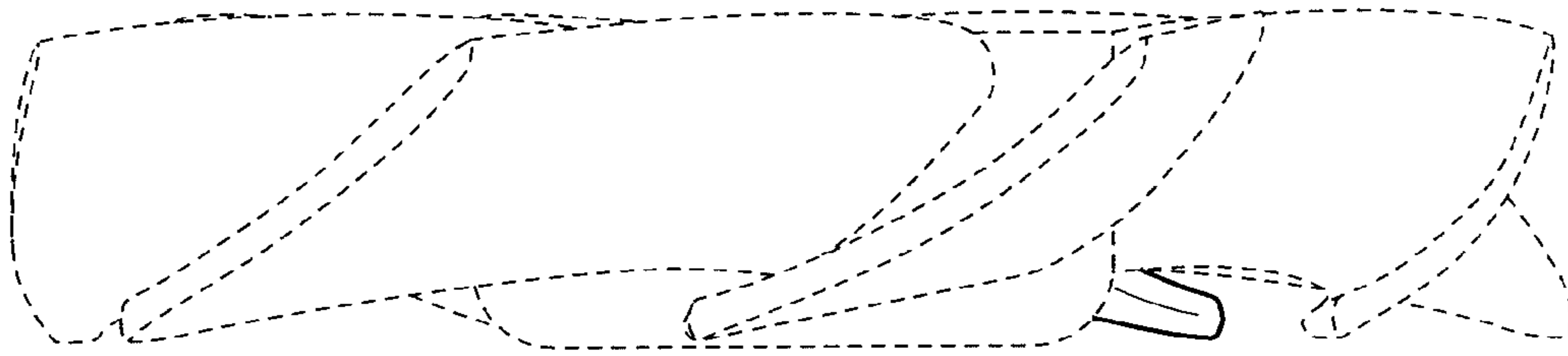

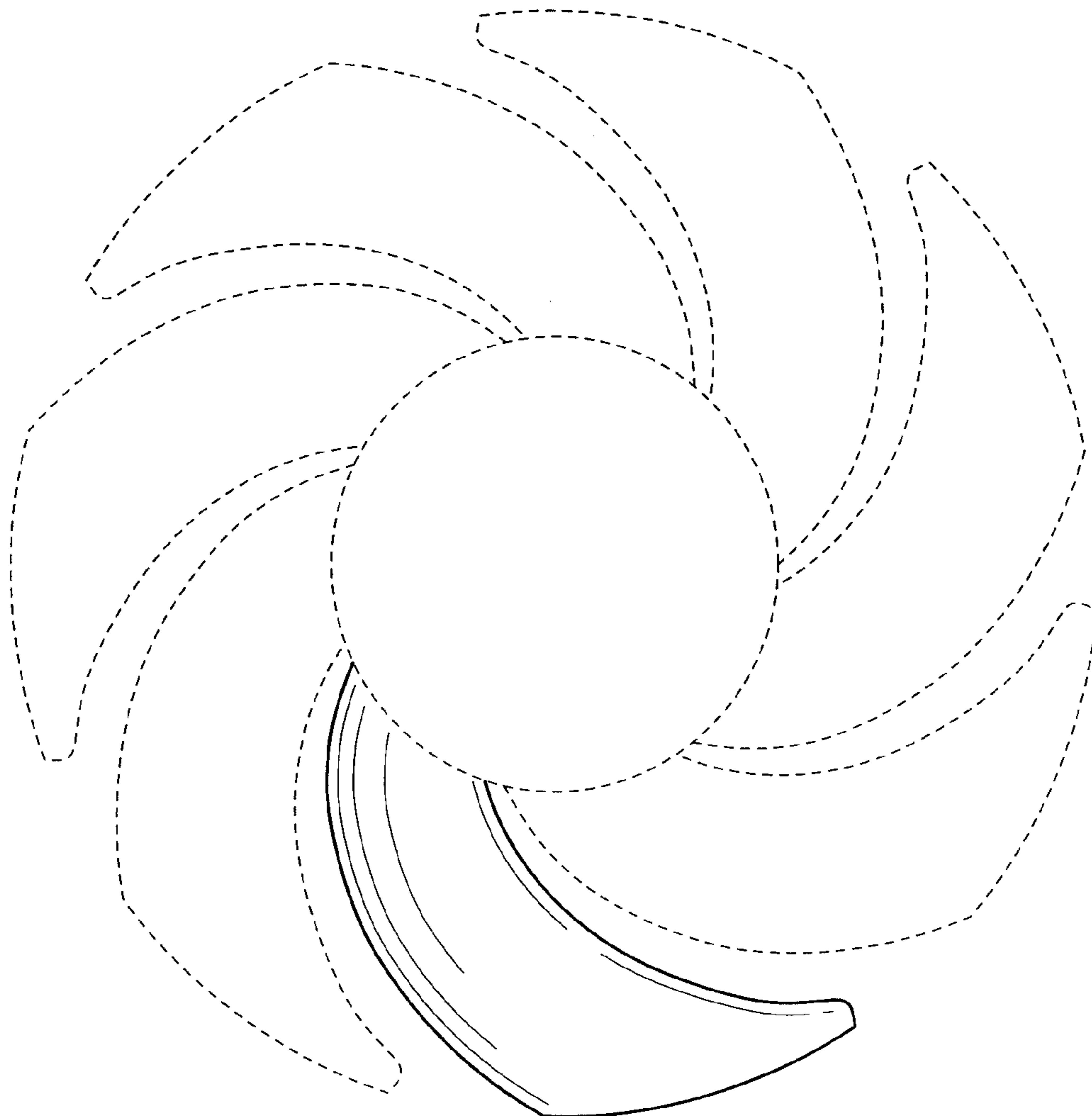

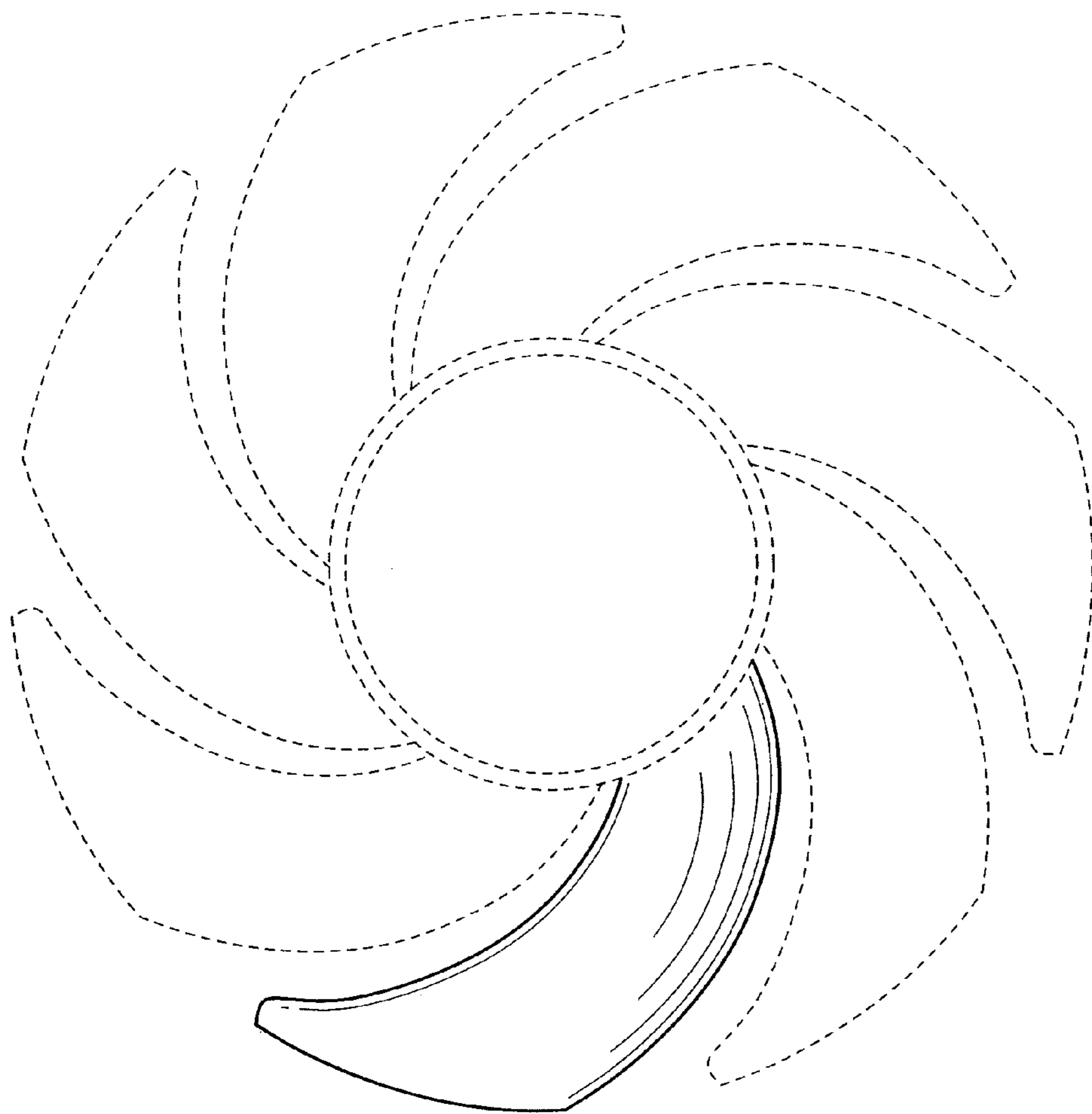

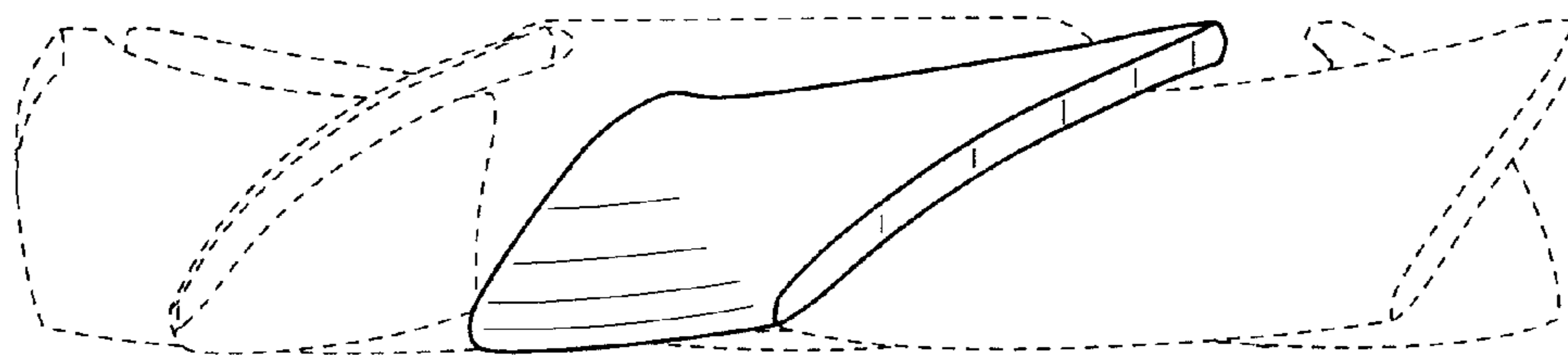
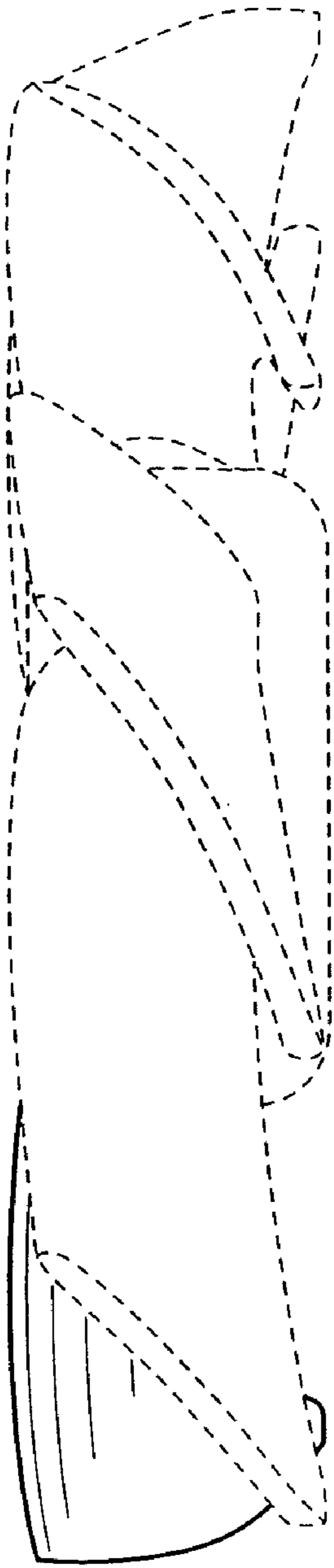
