FIG. 2 is a side view of a body fluid assay device.

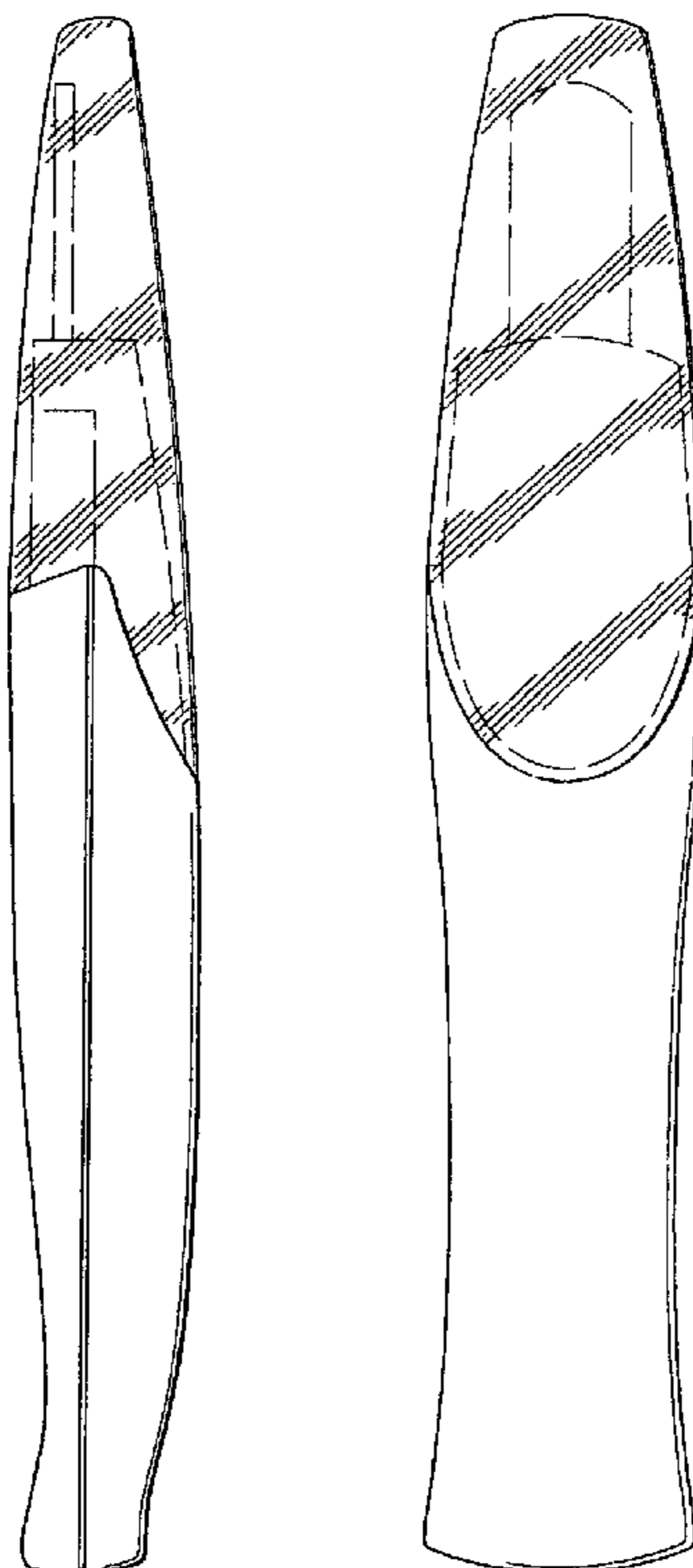
FIG. 3 is a top plan view of a body fluid assay device.

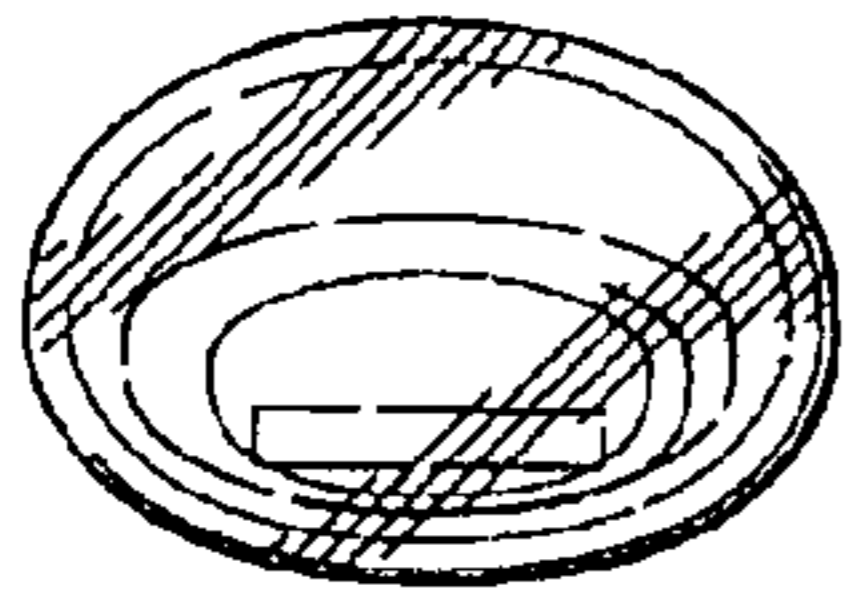

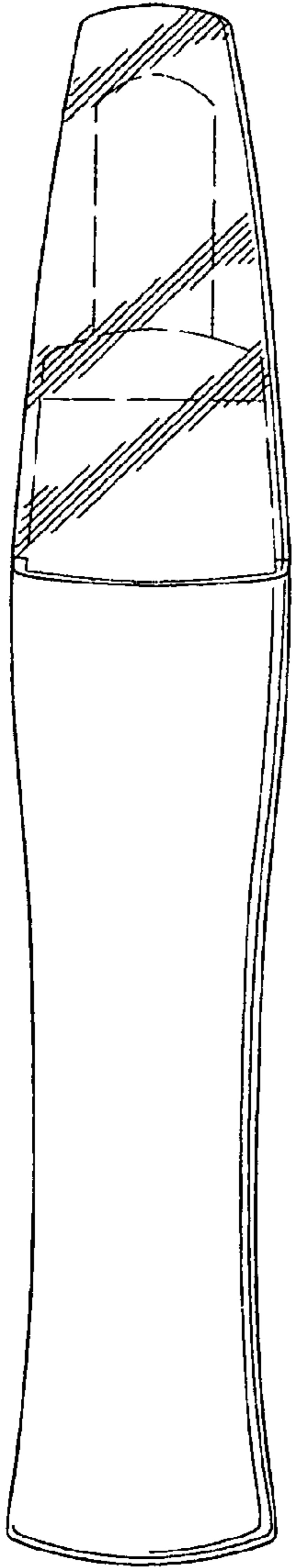

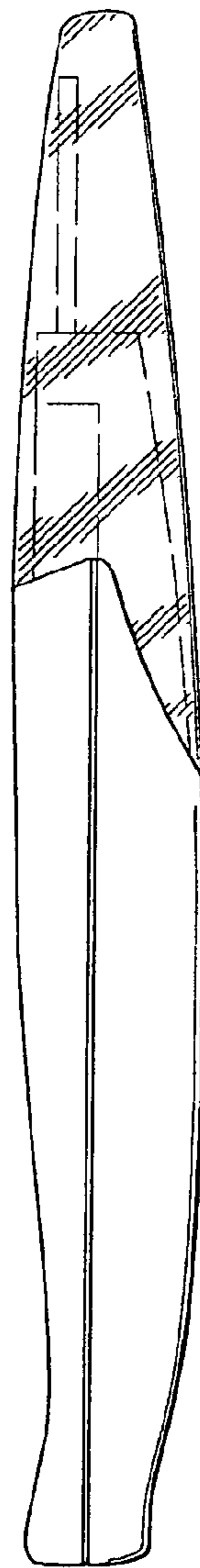

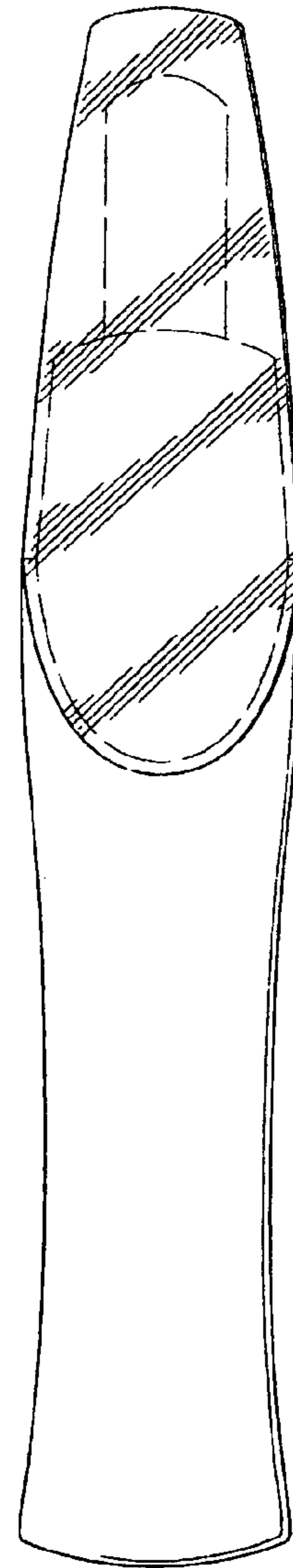

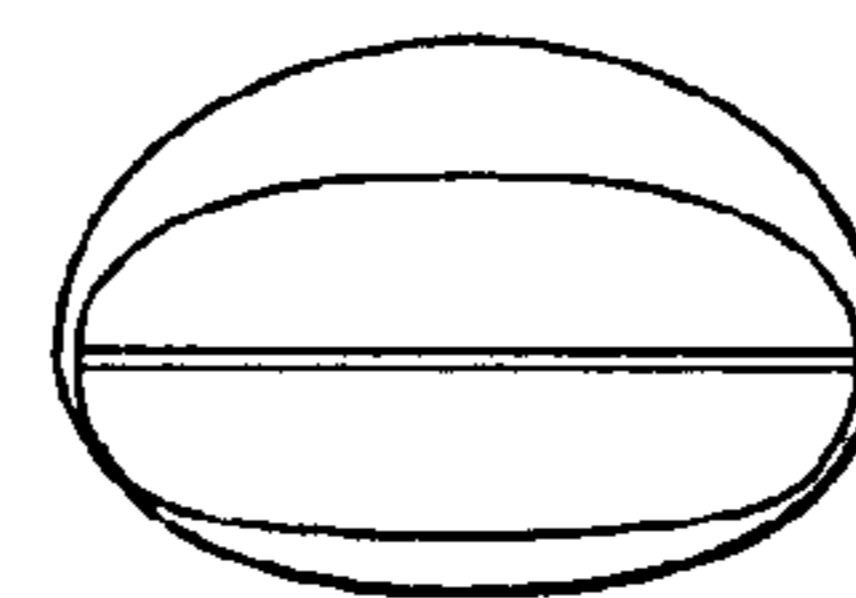
