The ornamental design for a store façade, as shown and described.

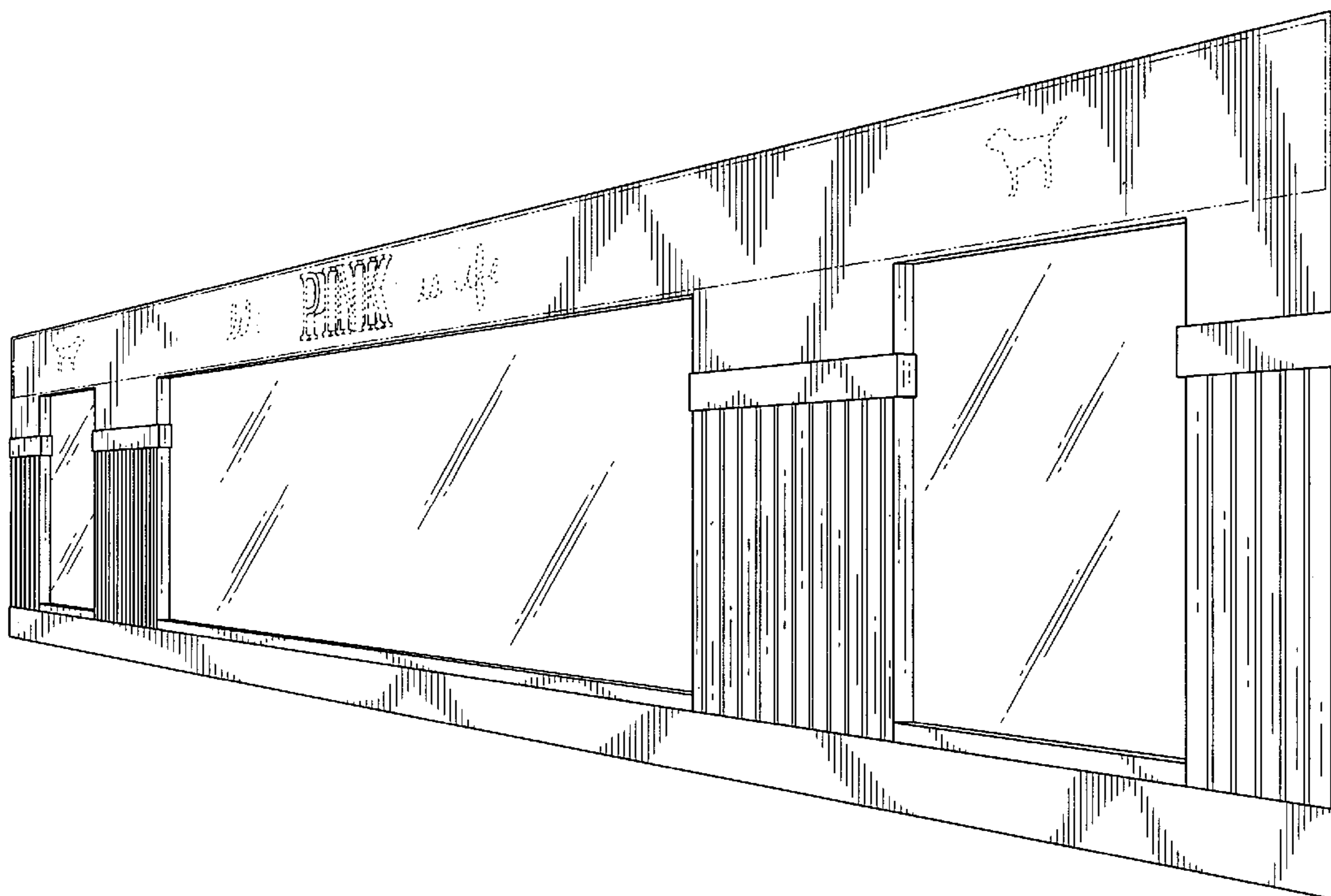
DESCRIPTION

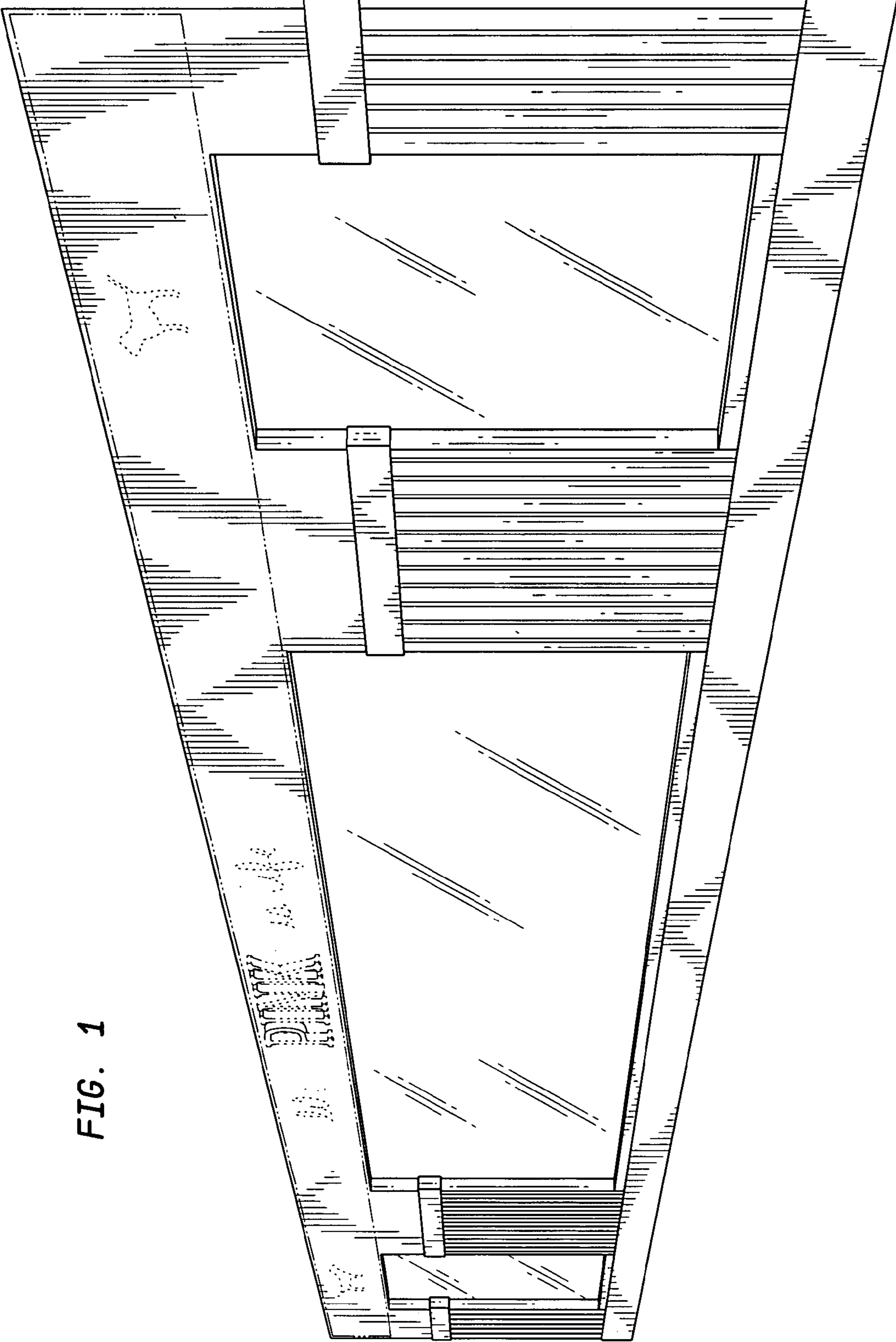
