The ornamental design for a lighting fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the invention;

FIG. 2 is a left side view of the first embodiment. The right side view is identical;

FIG. 3 is a top view of the first embodiment;

FIG. 4 is a bottom view of the first embodiment;

FIG. 5 is a front view of the first embodiment;

FIG. 6 is a back view of the first embodiment;

FIG. 7 is a perspective view of a second embodiment of the invention mounted on a pole which is not part of the design;

FIG. 8 is a left side view of the second embodiment. The right side view is identical;

FIG. 9 is a top view of the second embodiment;

FIG. 10 is a bottom view of the second embodiment;

FIG. 11 is a front view of the second embodiment; and,

FIG. 12 is a back view of the second embodiment.

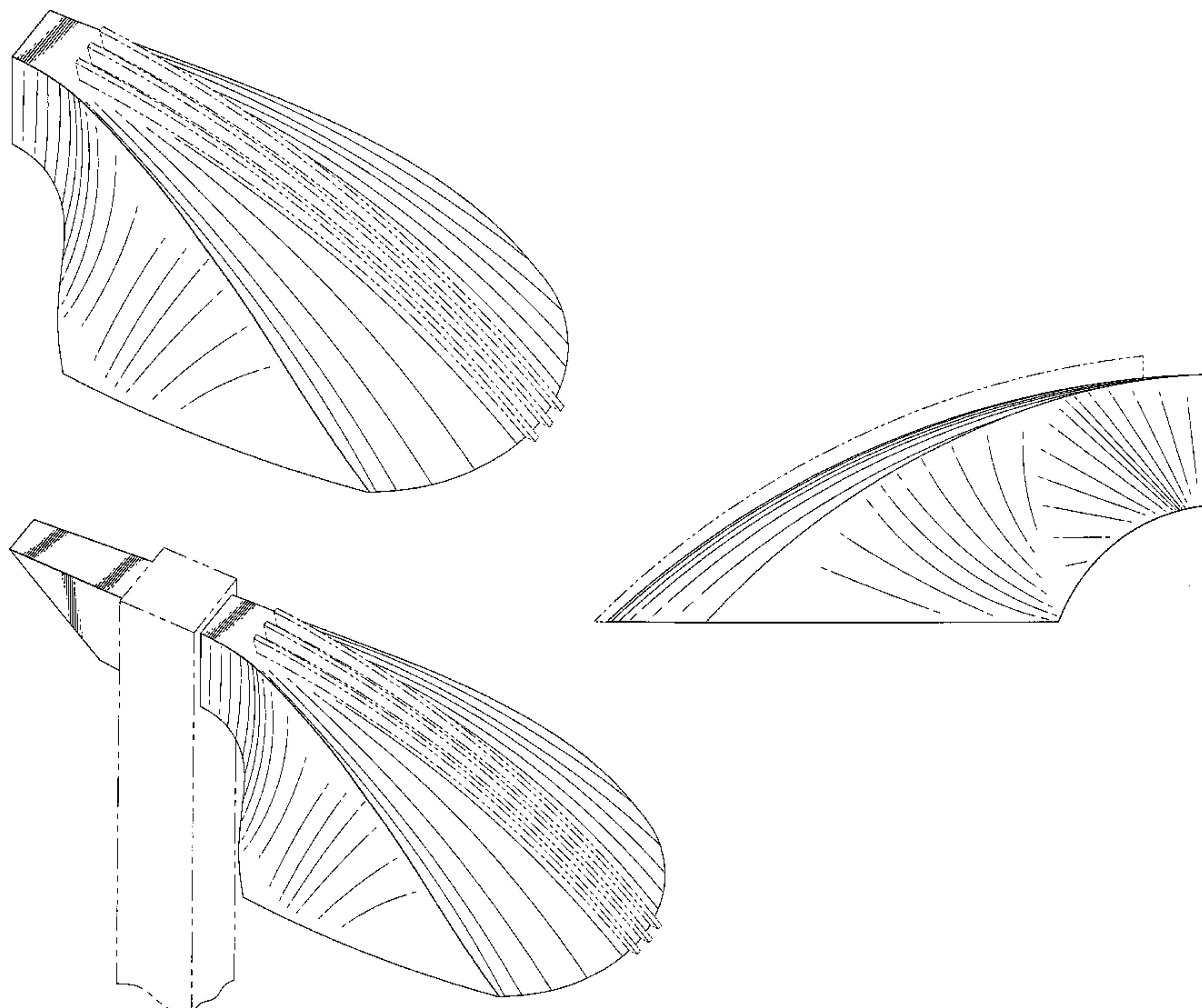
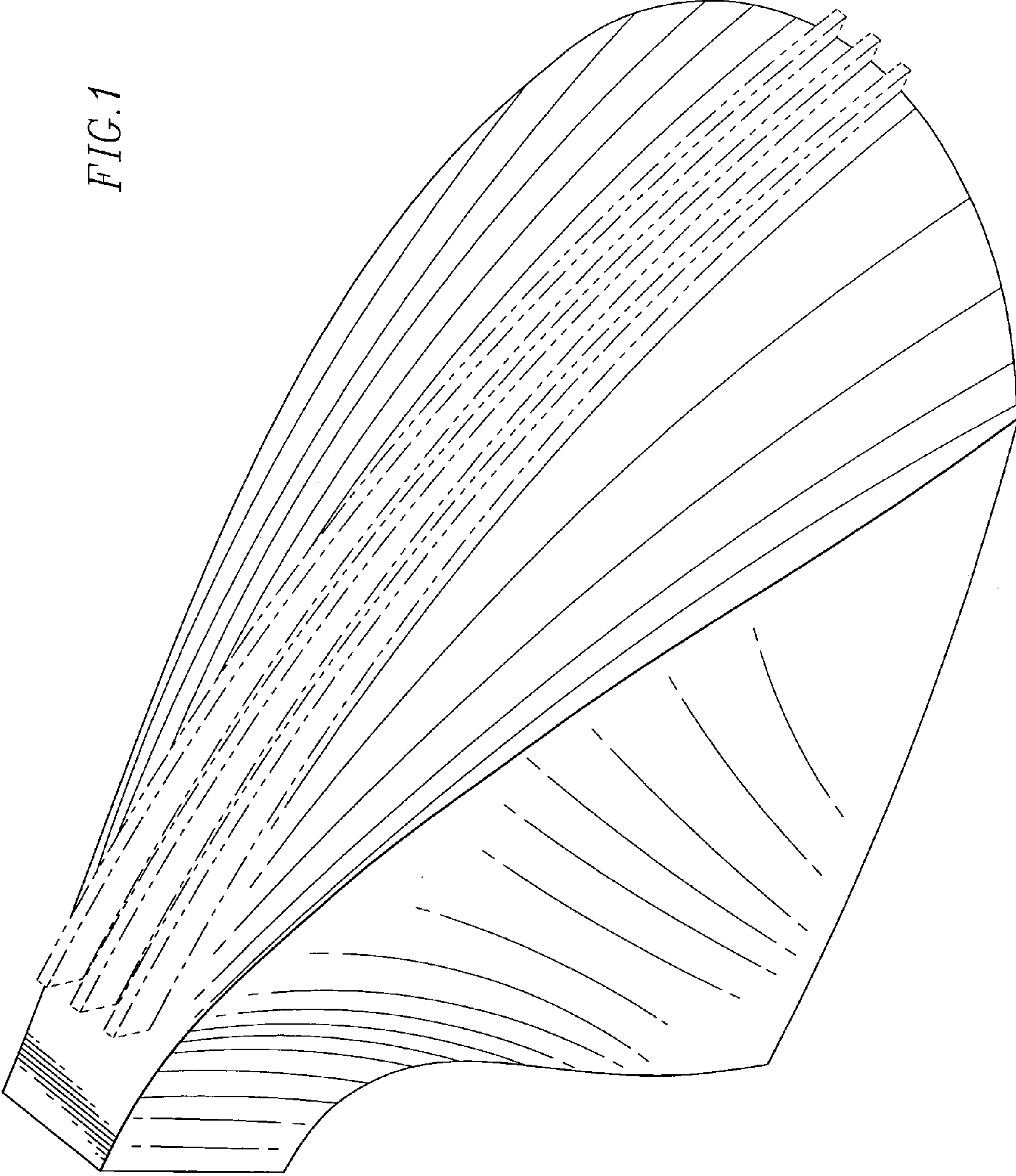

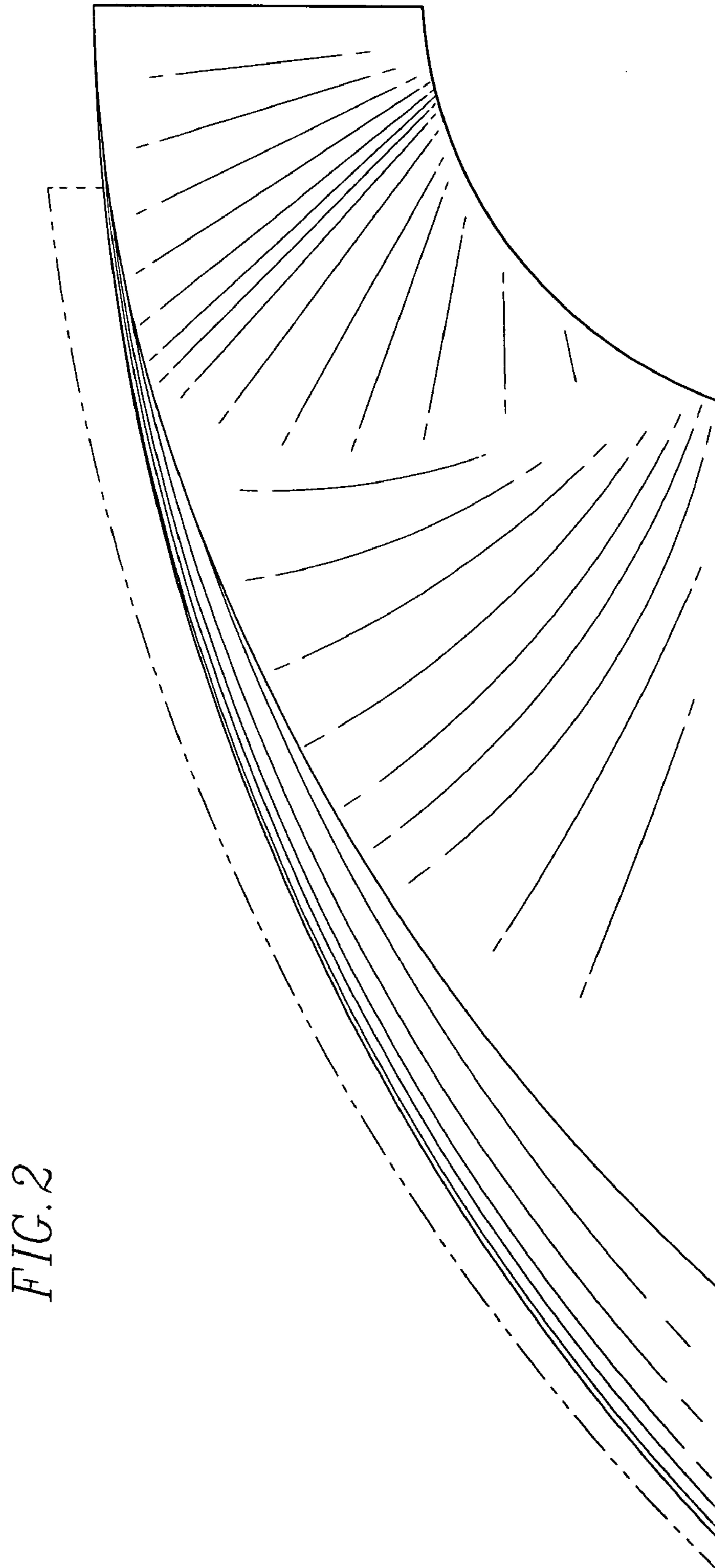

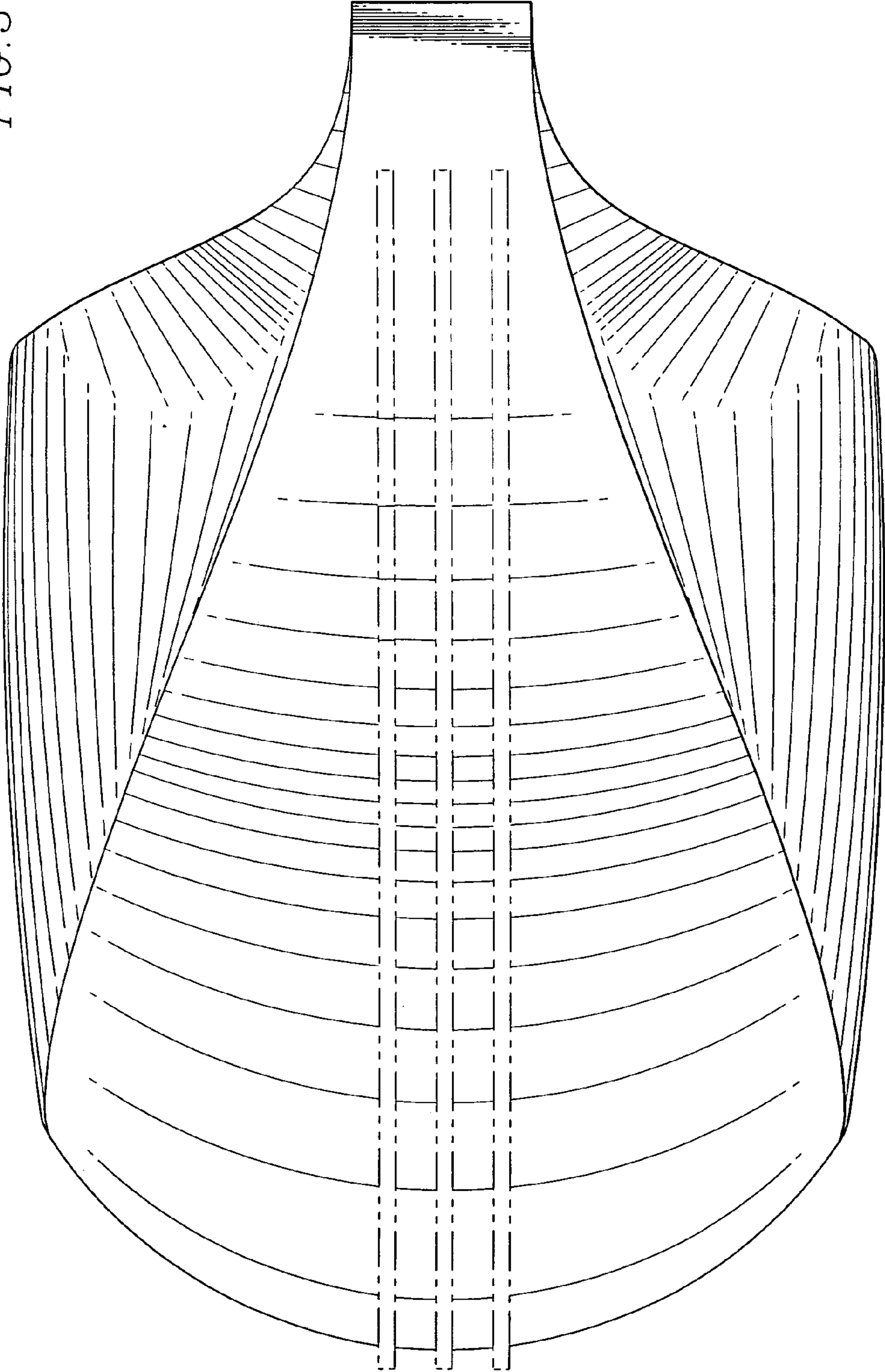

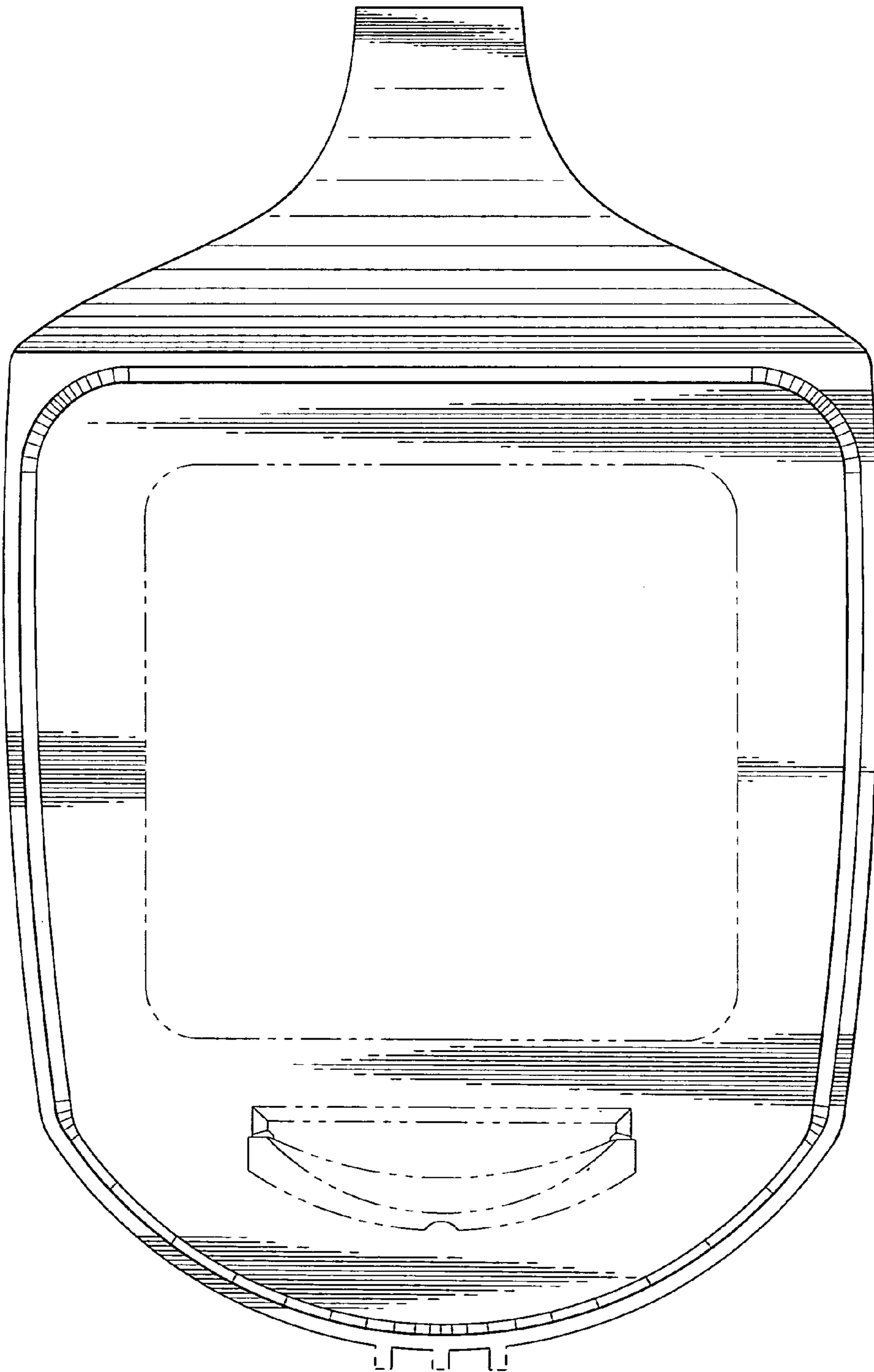

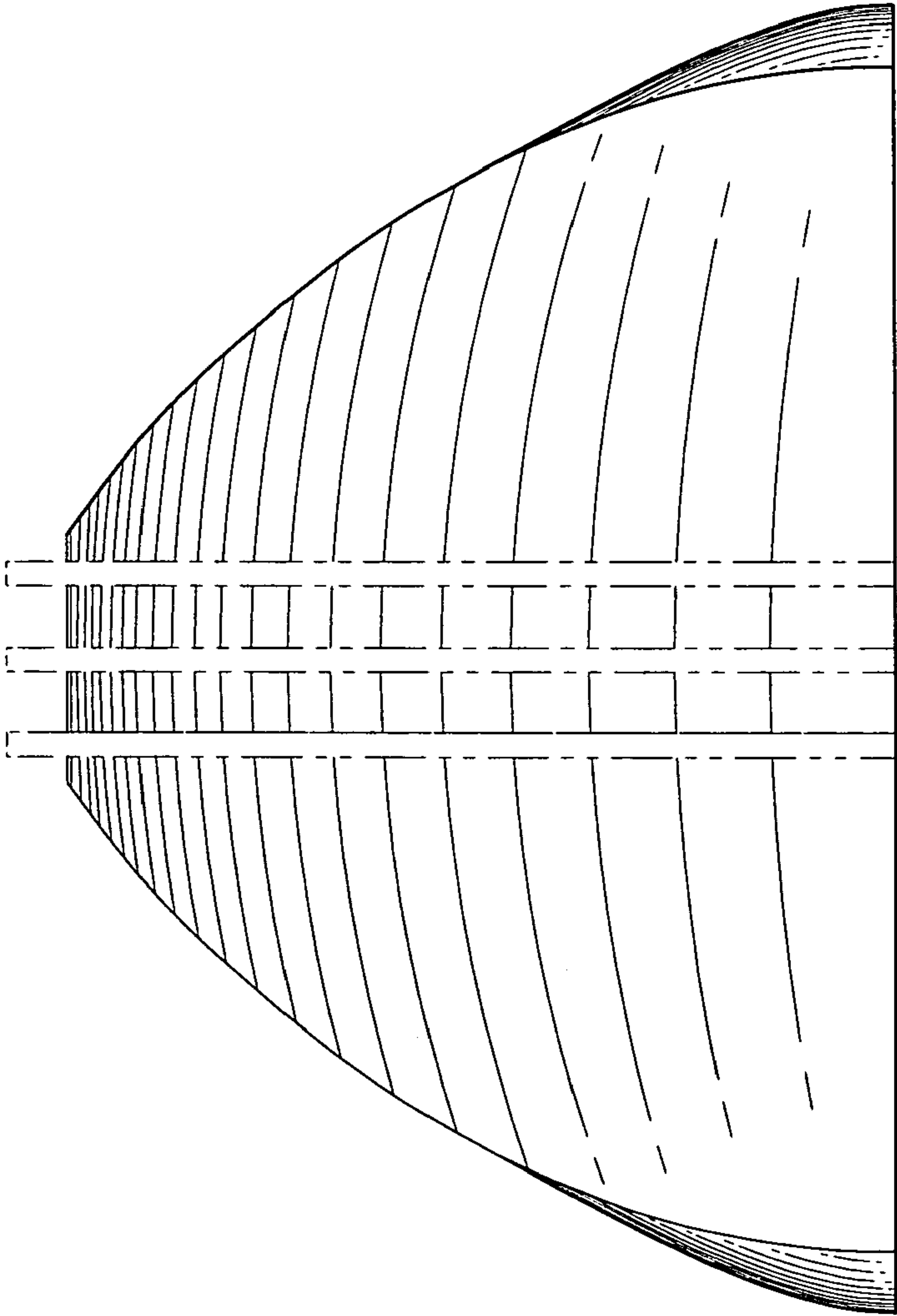

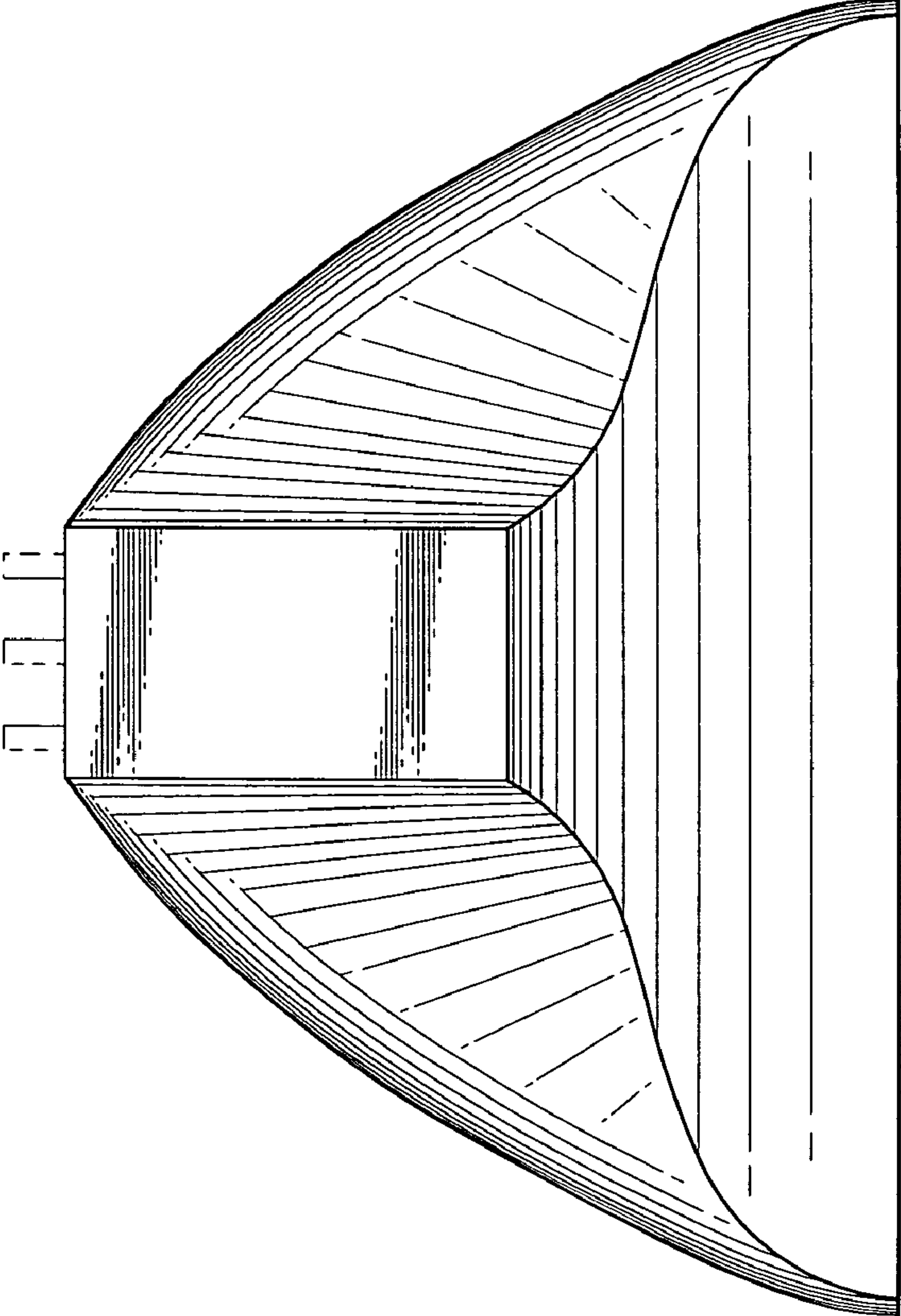
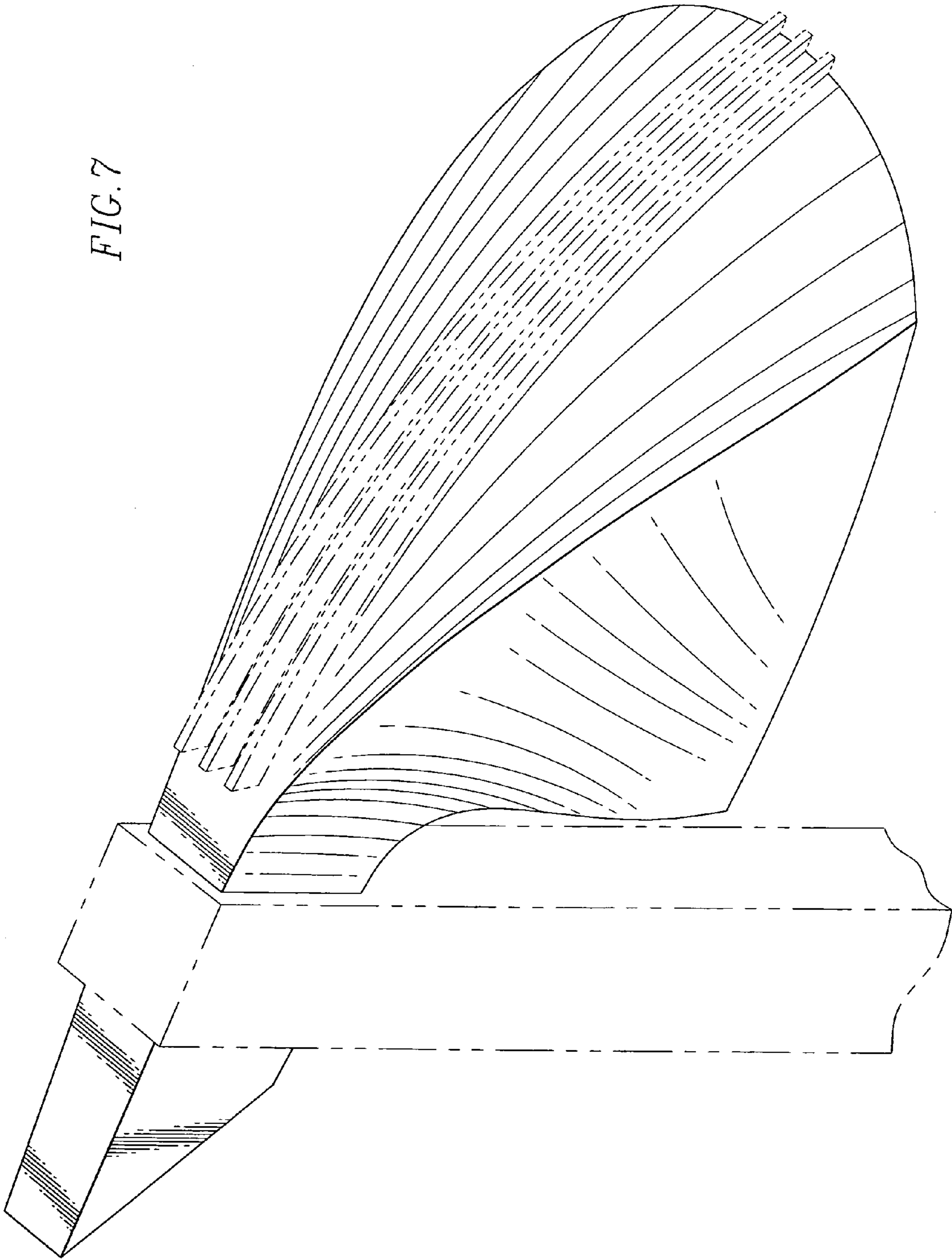

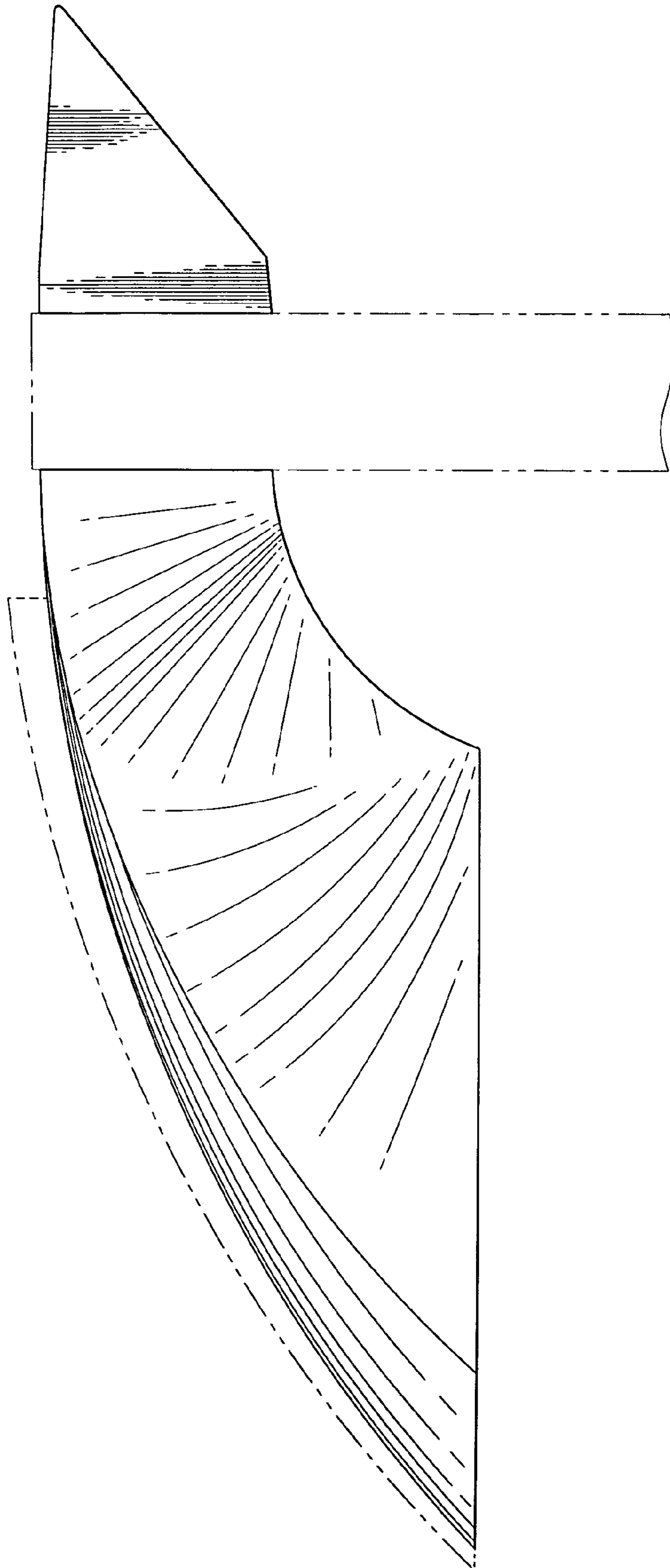

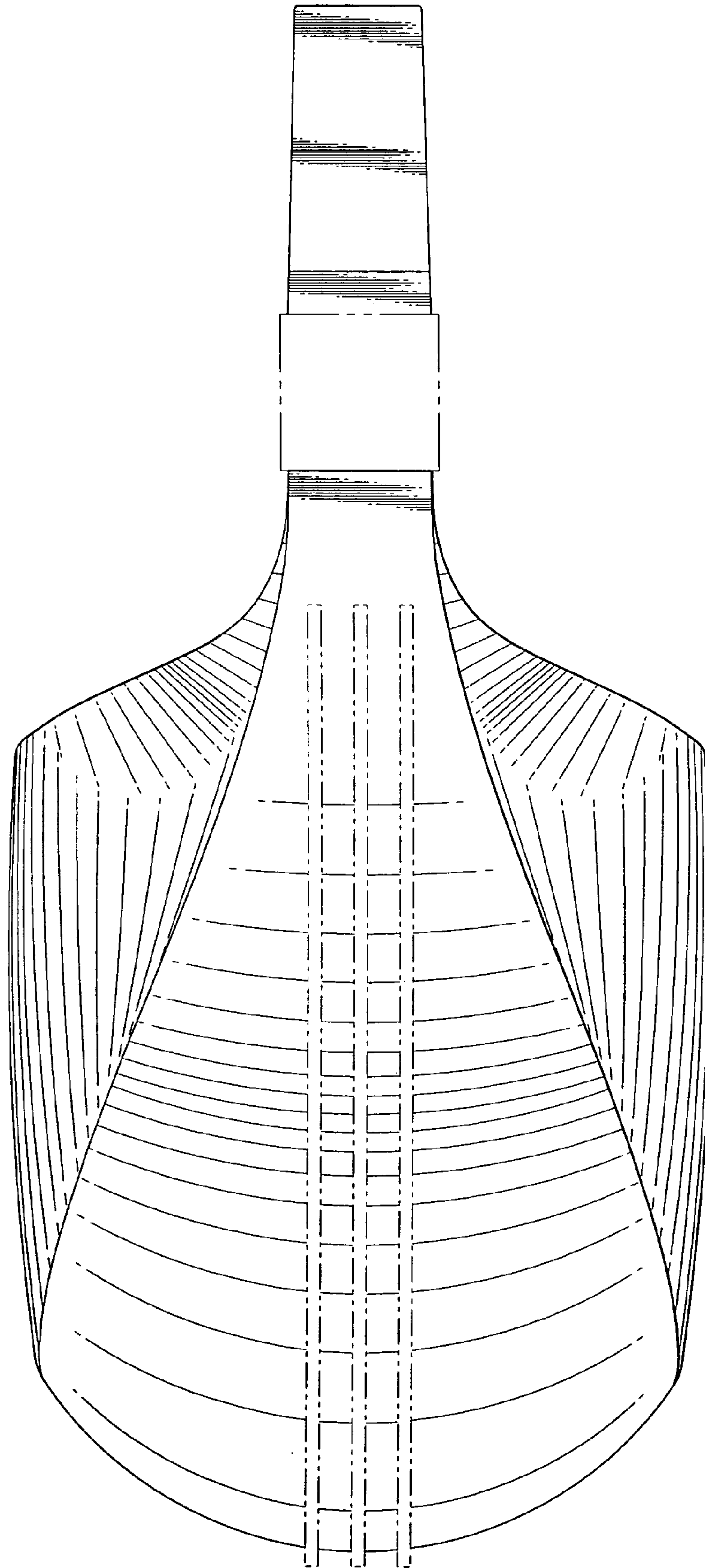

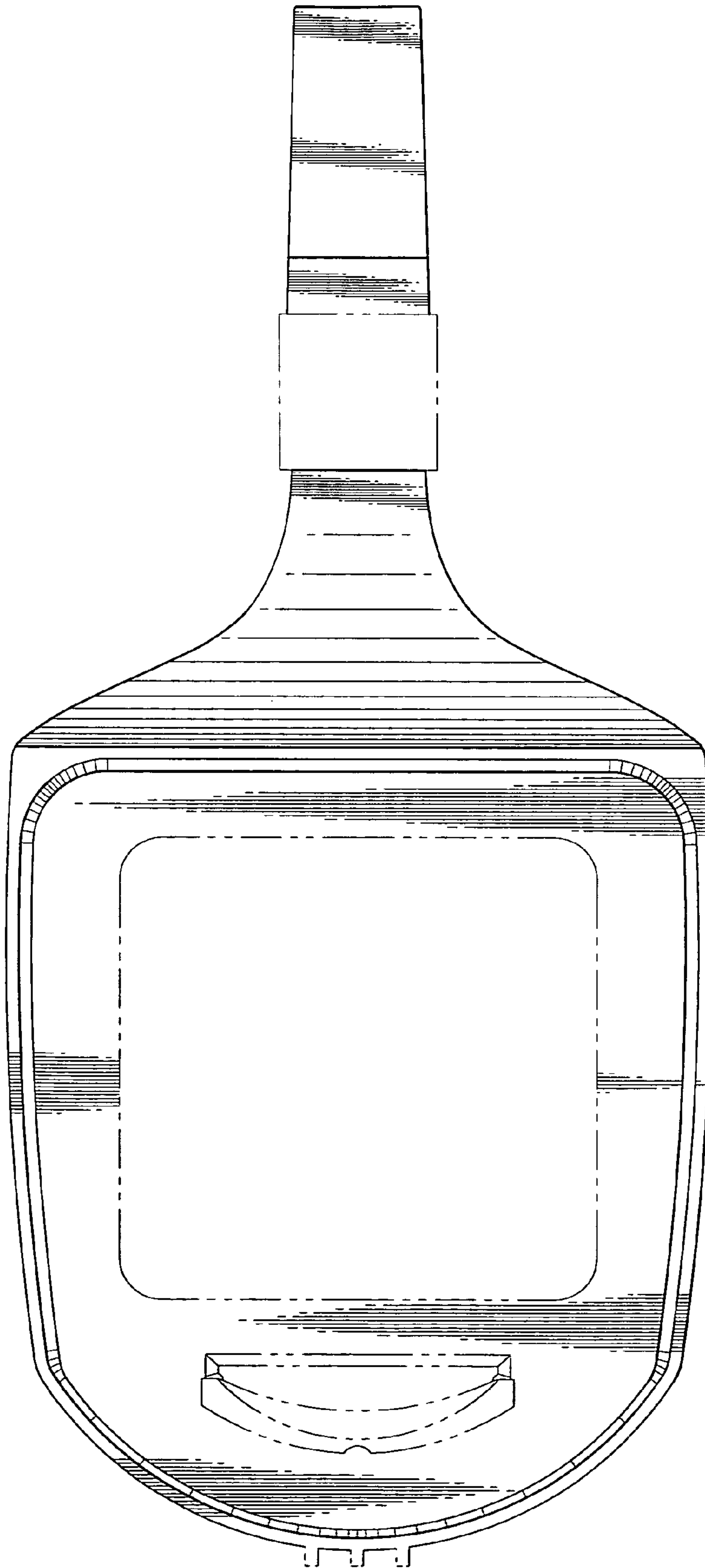

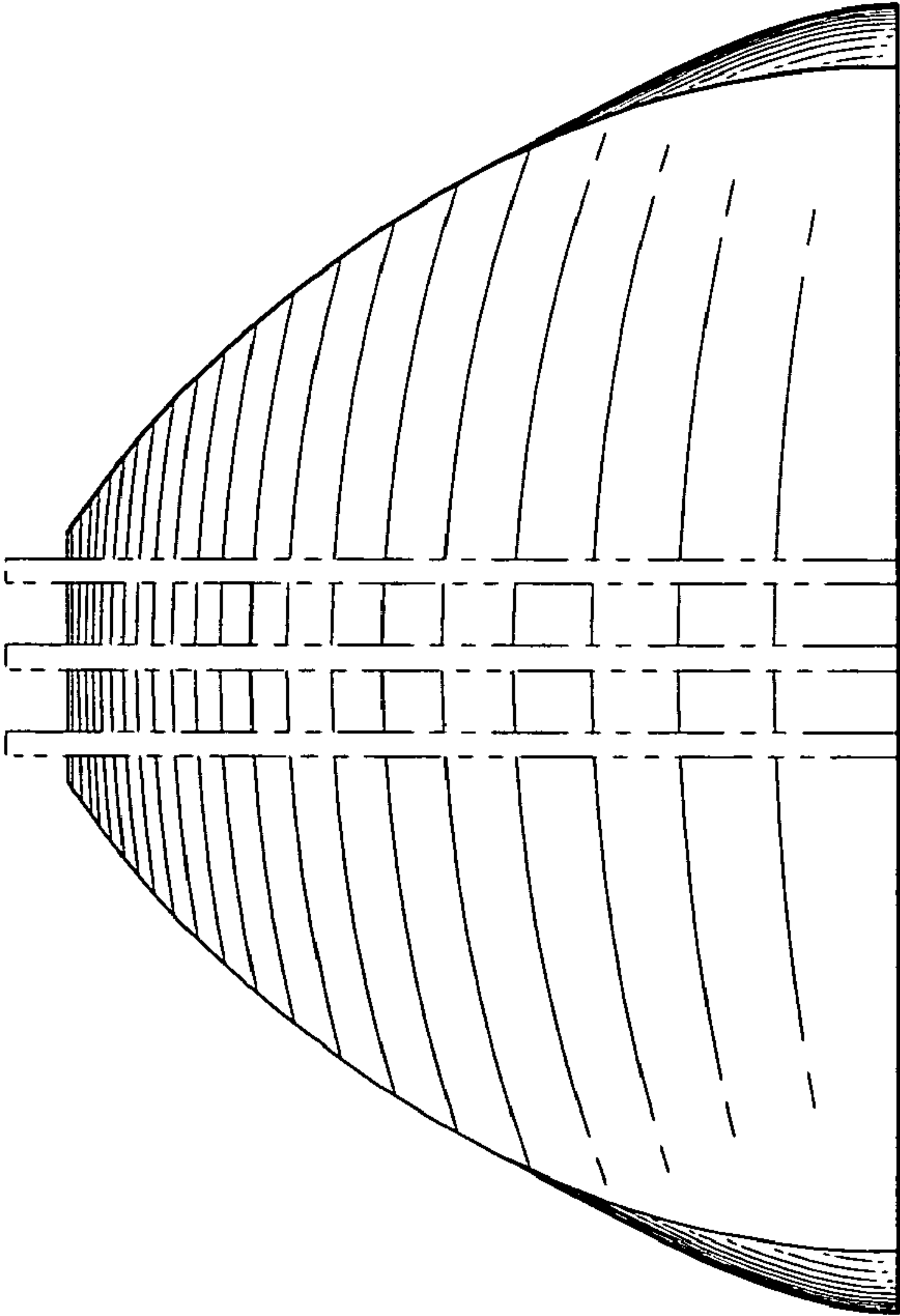
