FIG. 4 is a left open view of the cosmetic carrying case.

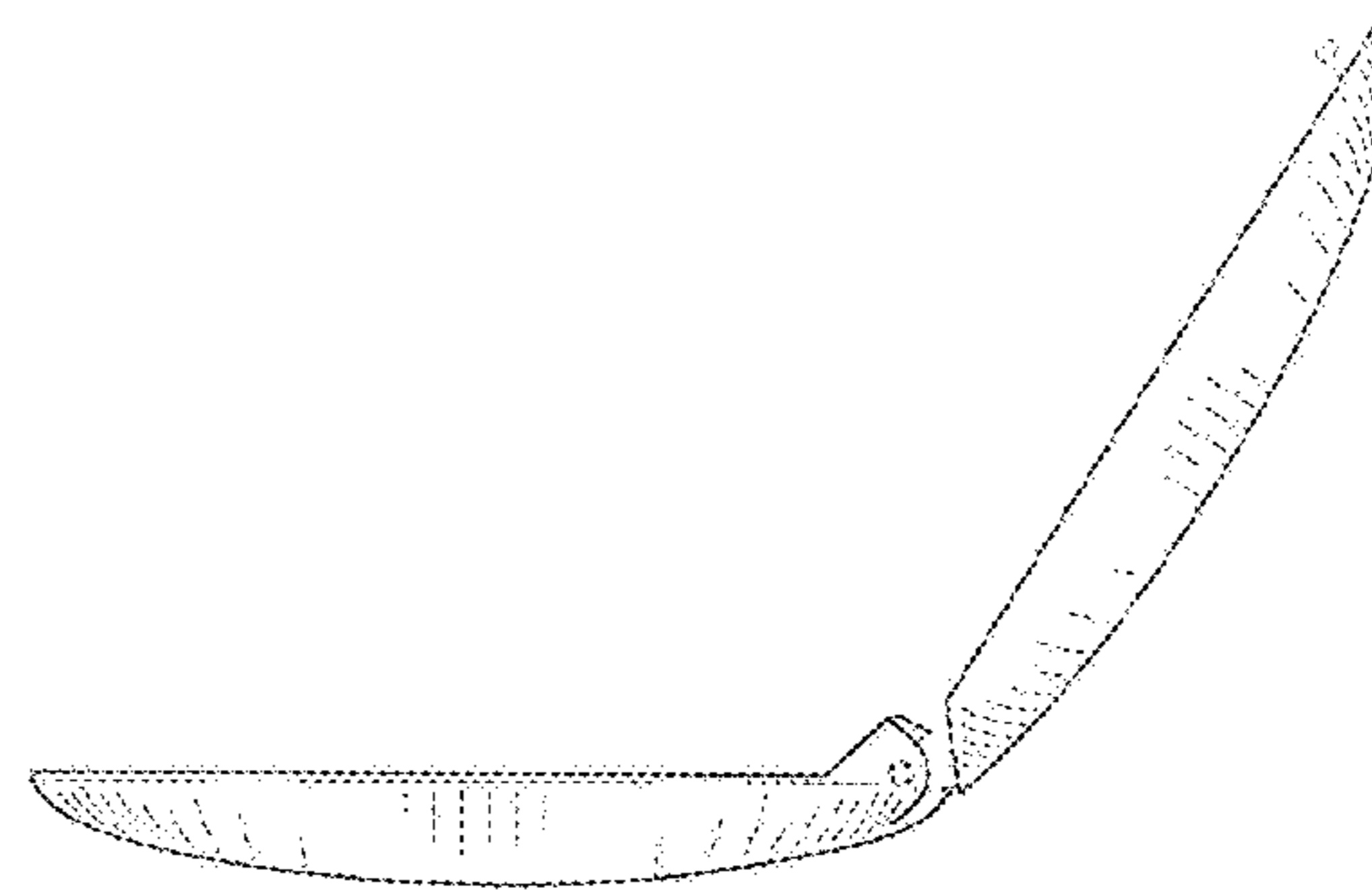
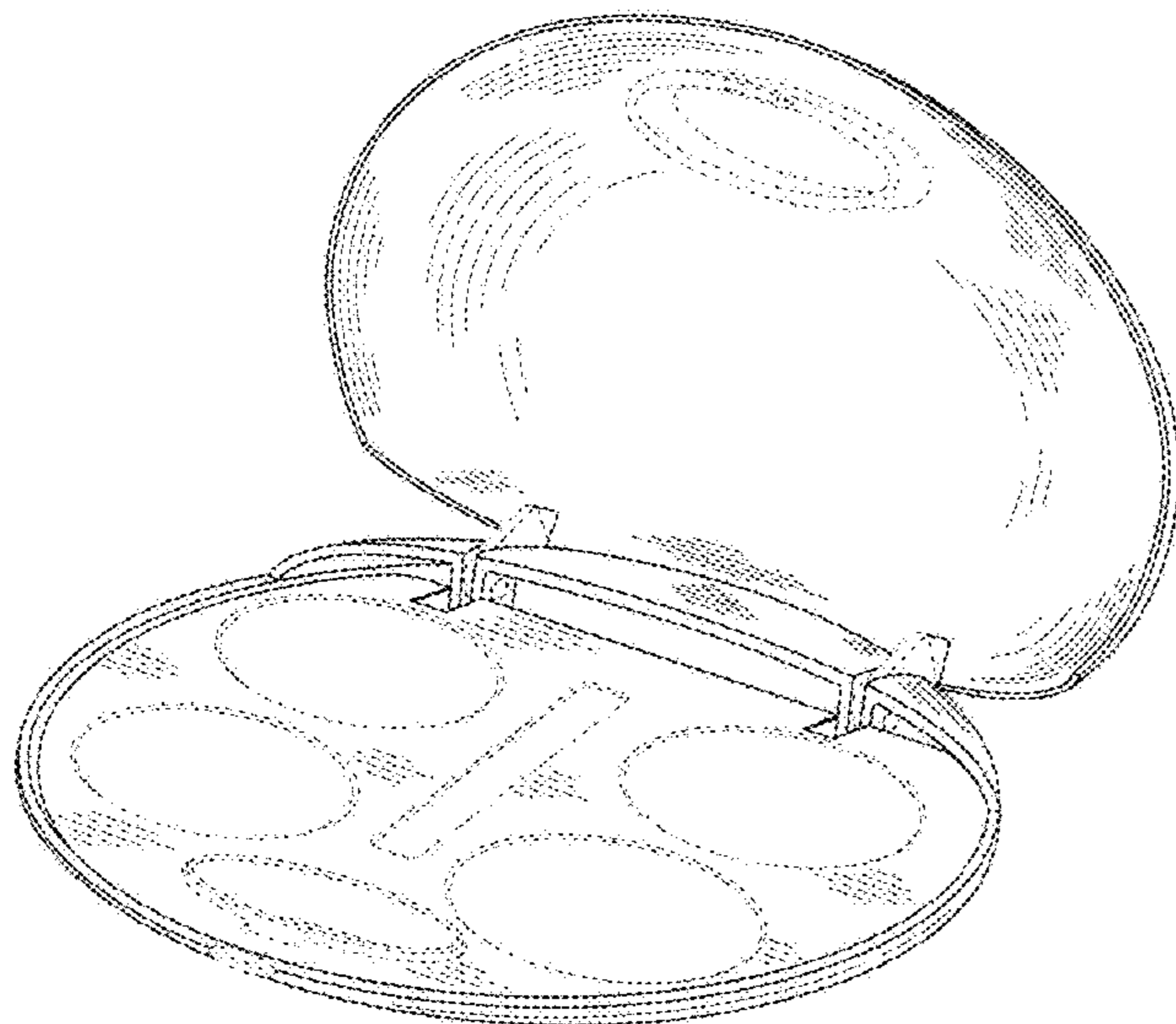
FIG. 5 is a right open view of the cosmetic carrying case.

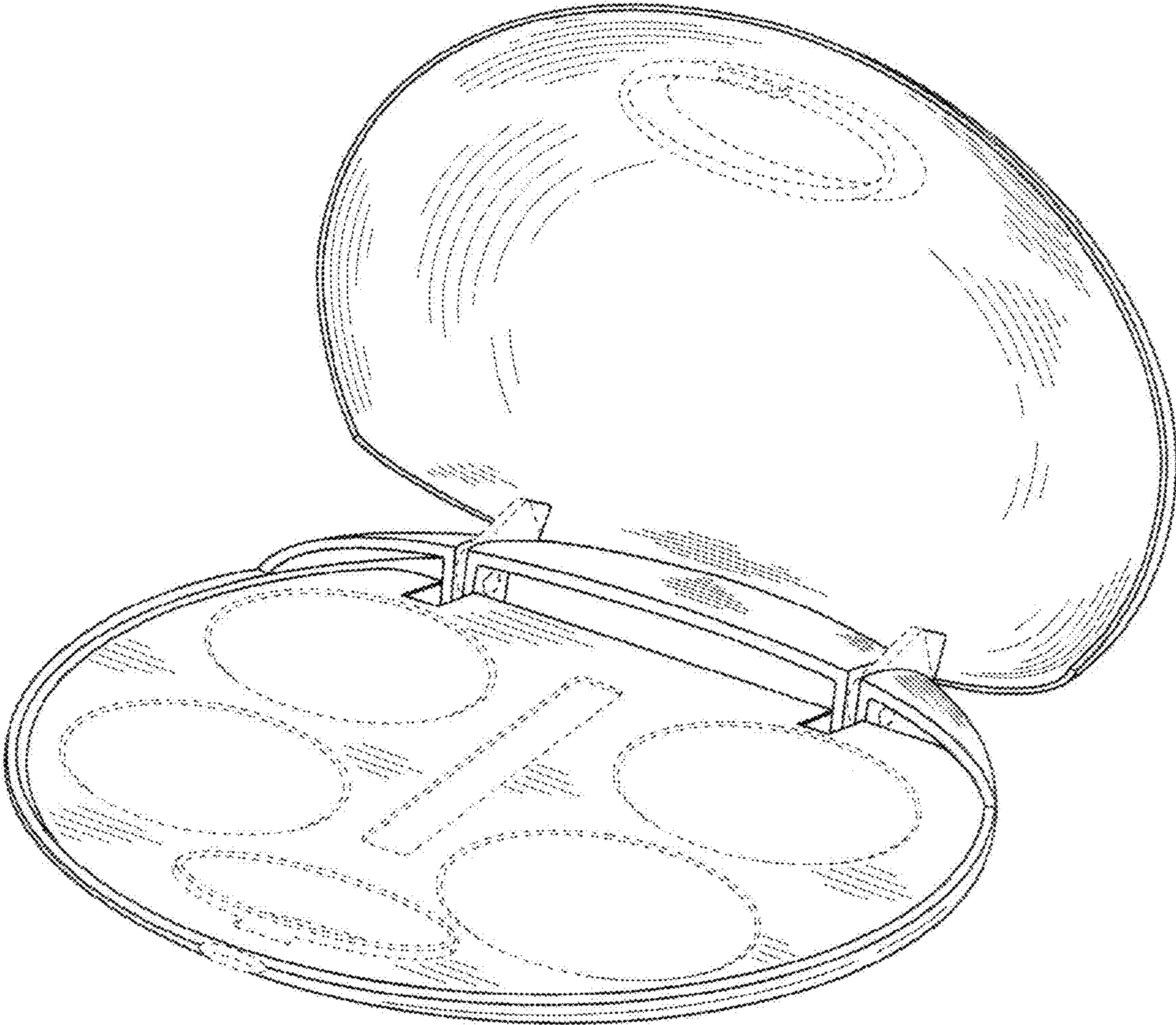

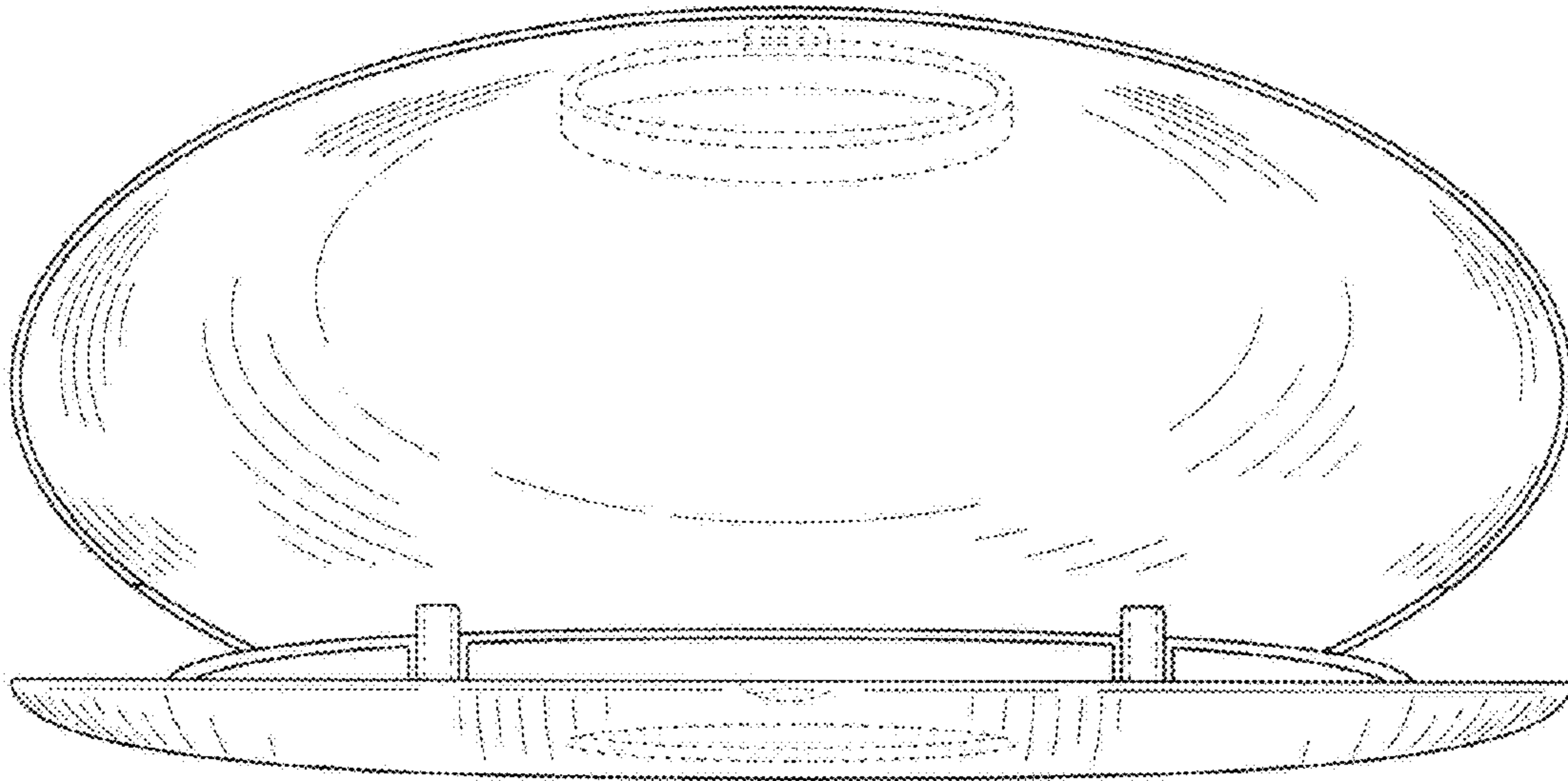

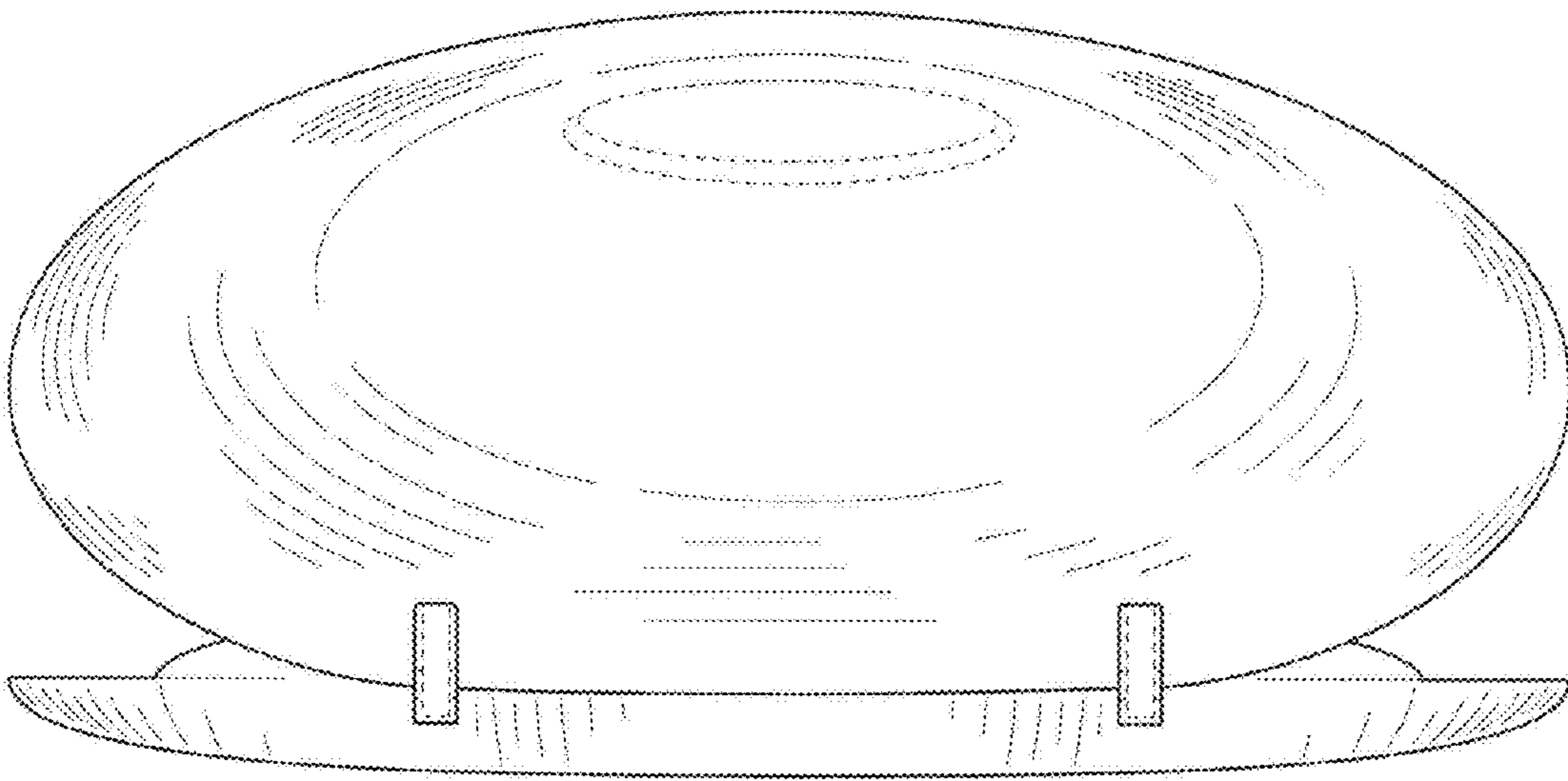

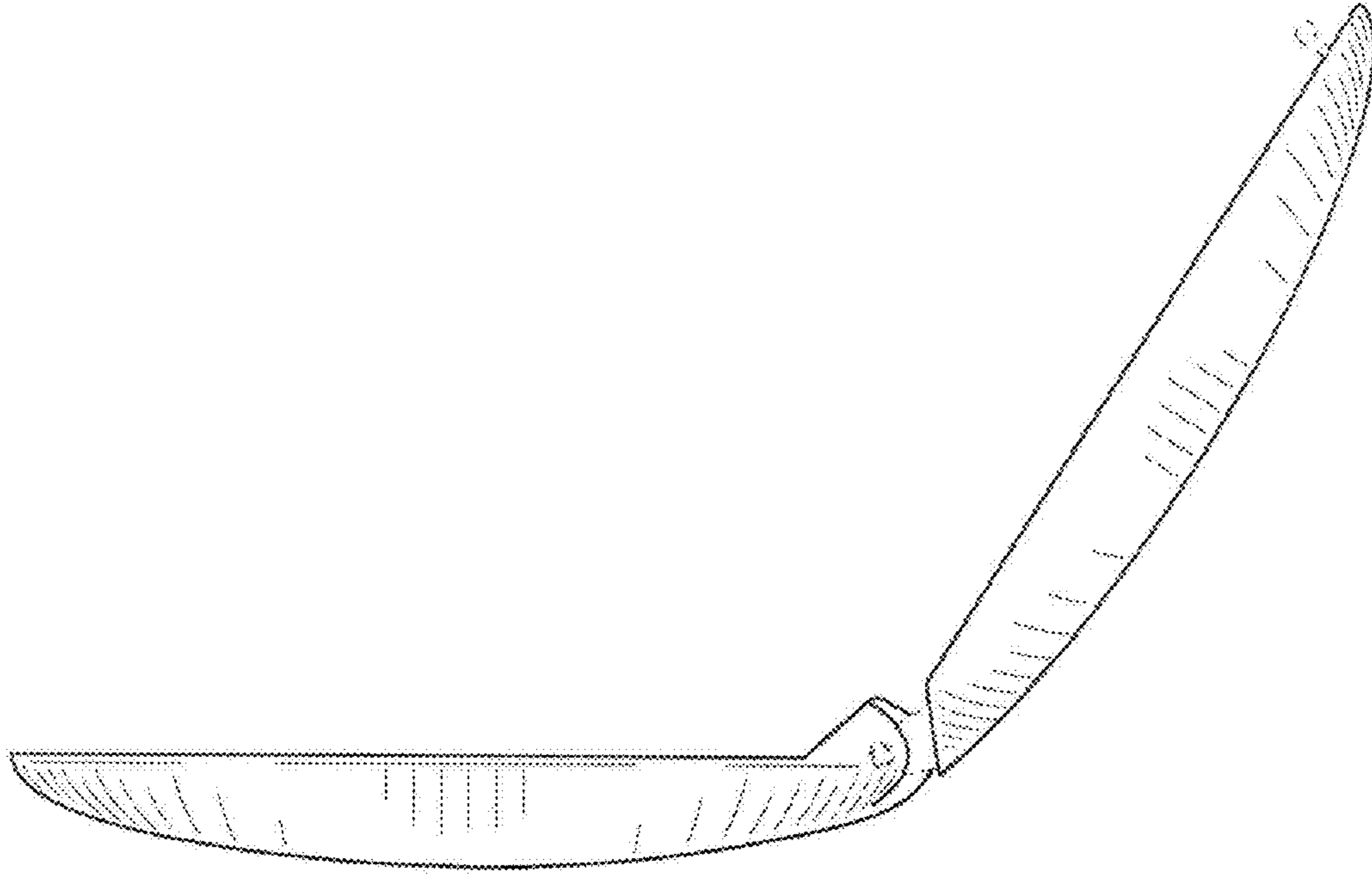

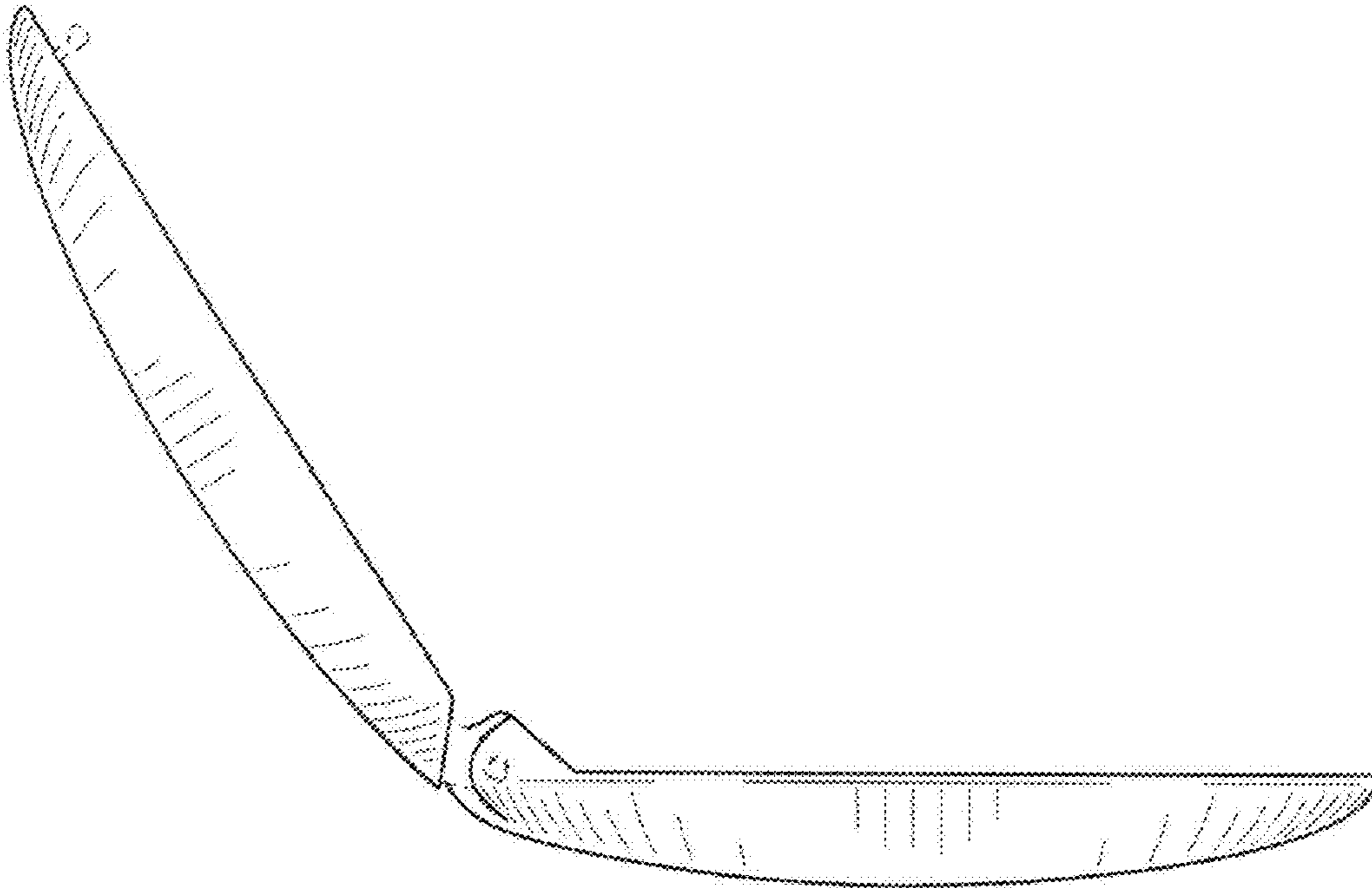

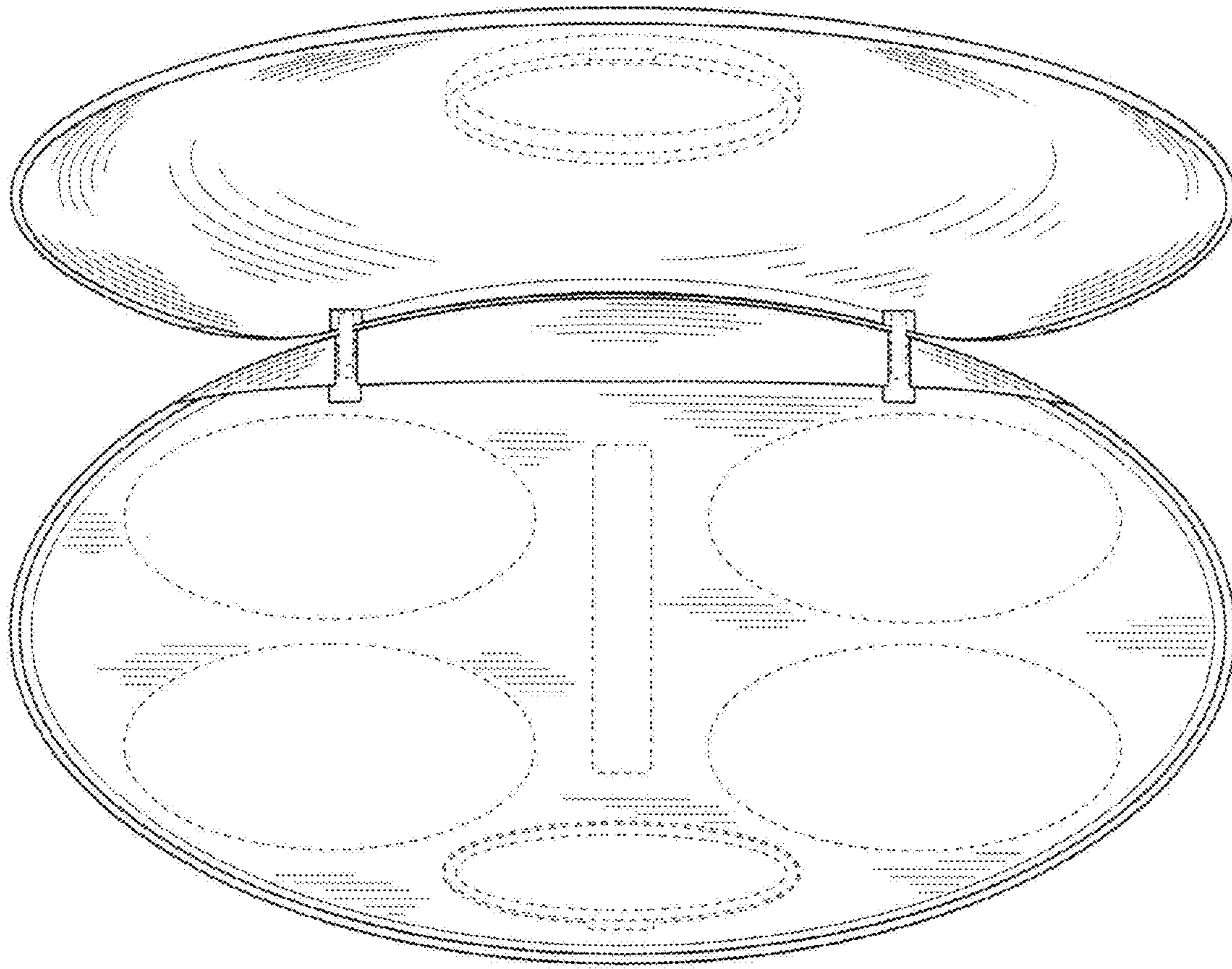

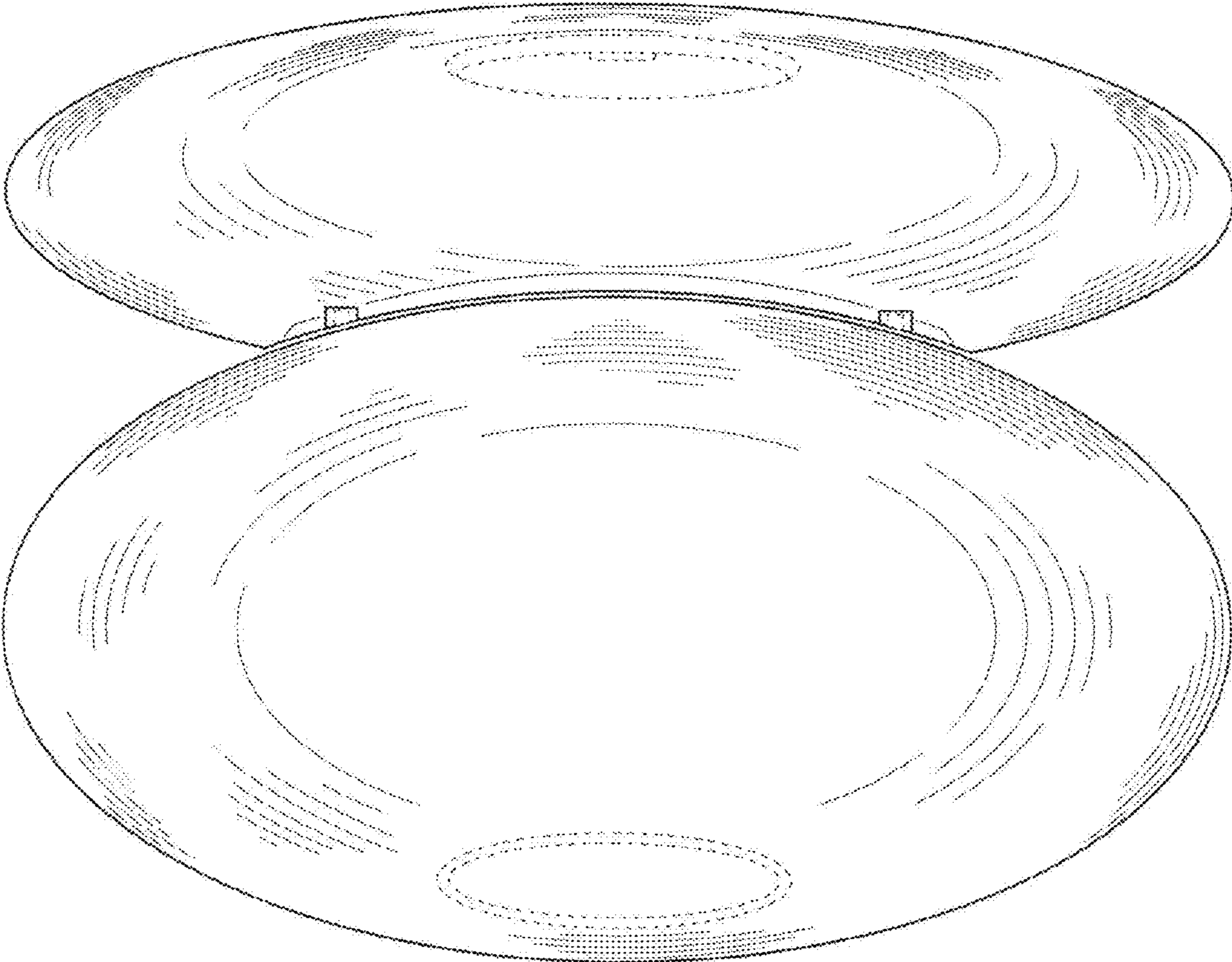
