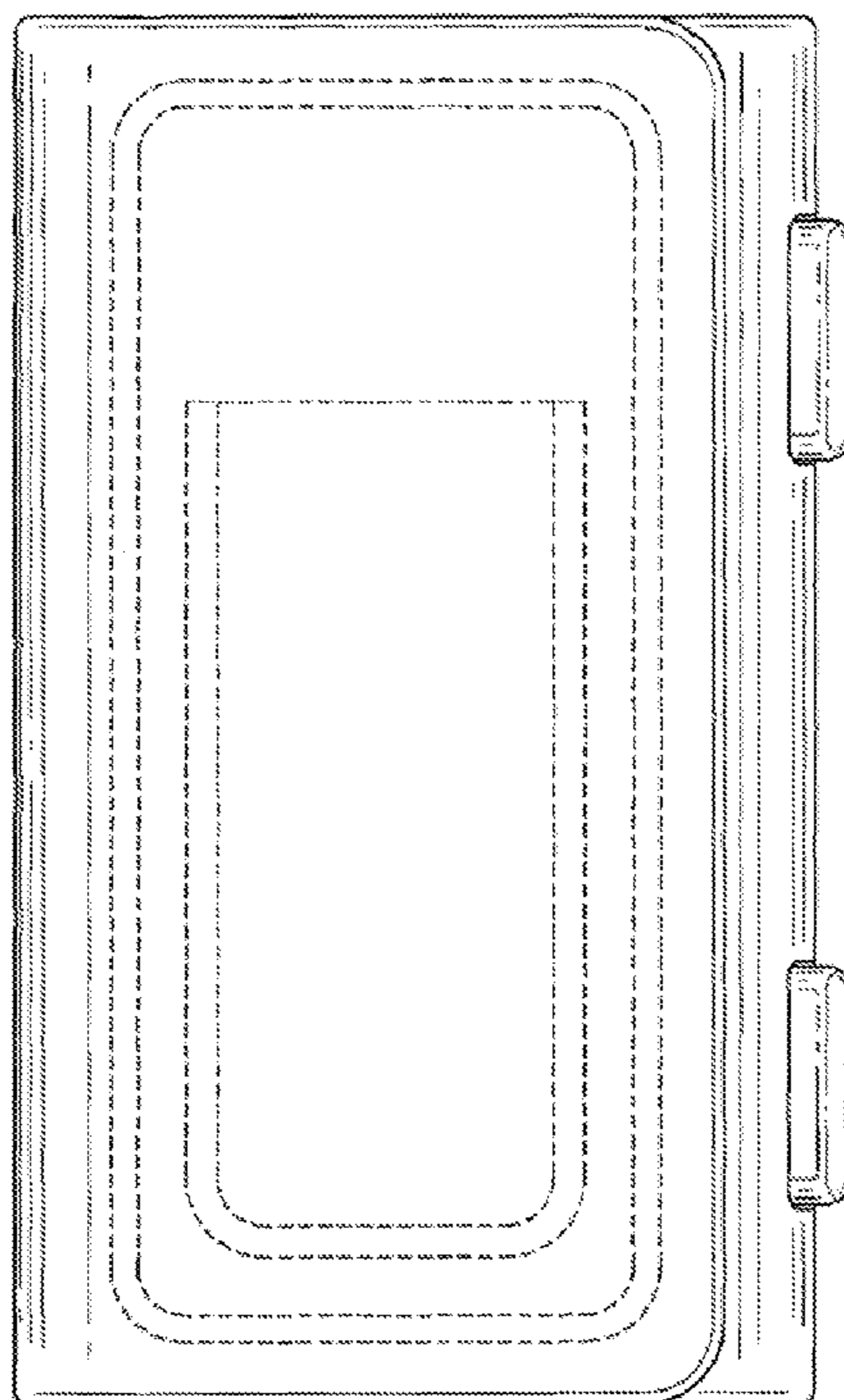
(57) **CLAIM**

I claim the ornamental design for a case for electrical device, as shown.

DESCRIPTION

FIG. 1 is a front view of the case in a closed configuration; FIG. 2 is a top view of the case in a closed configuration; FIG. 3 is a back view of the case in the closed configuration; FIG. 4 is a right view of the case in the closed configuration; FIG. 5 is a back, left isometric view of the case in the closed configuration; FIG. 6 is a left view of the case in the closed configuration; FIG. 7 is a bottom view of the case in the closed configuration; FIG. 8 is a front view of the case in an open configuration; FIG. 9 is a bottom view of the case in the open configuration; FIG. 10 is a top, back isometric view of the case in the open configuration; FIG. 11 is a right, top isometric view of the case in the open configuration; FIG. 12 is a top, left isometric view of the case in the open configuration; FIG. 13 is a left, top isometric view of the case in the open configuration; and, FIG. 14 is a top view of the case in the open configuration. 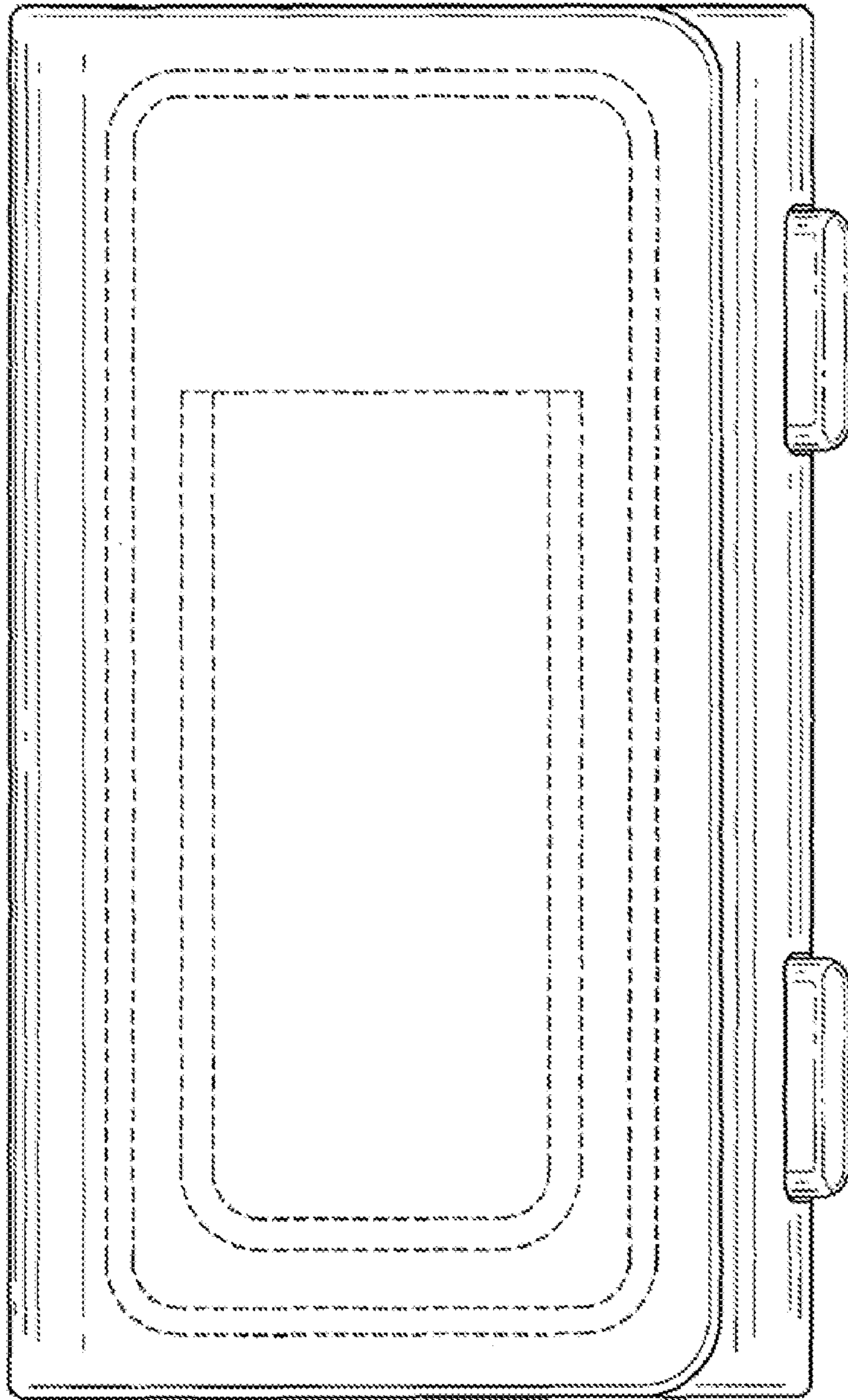

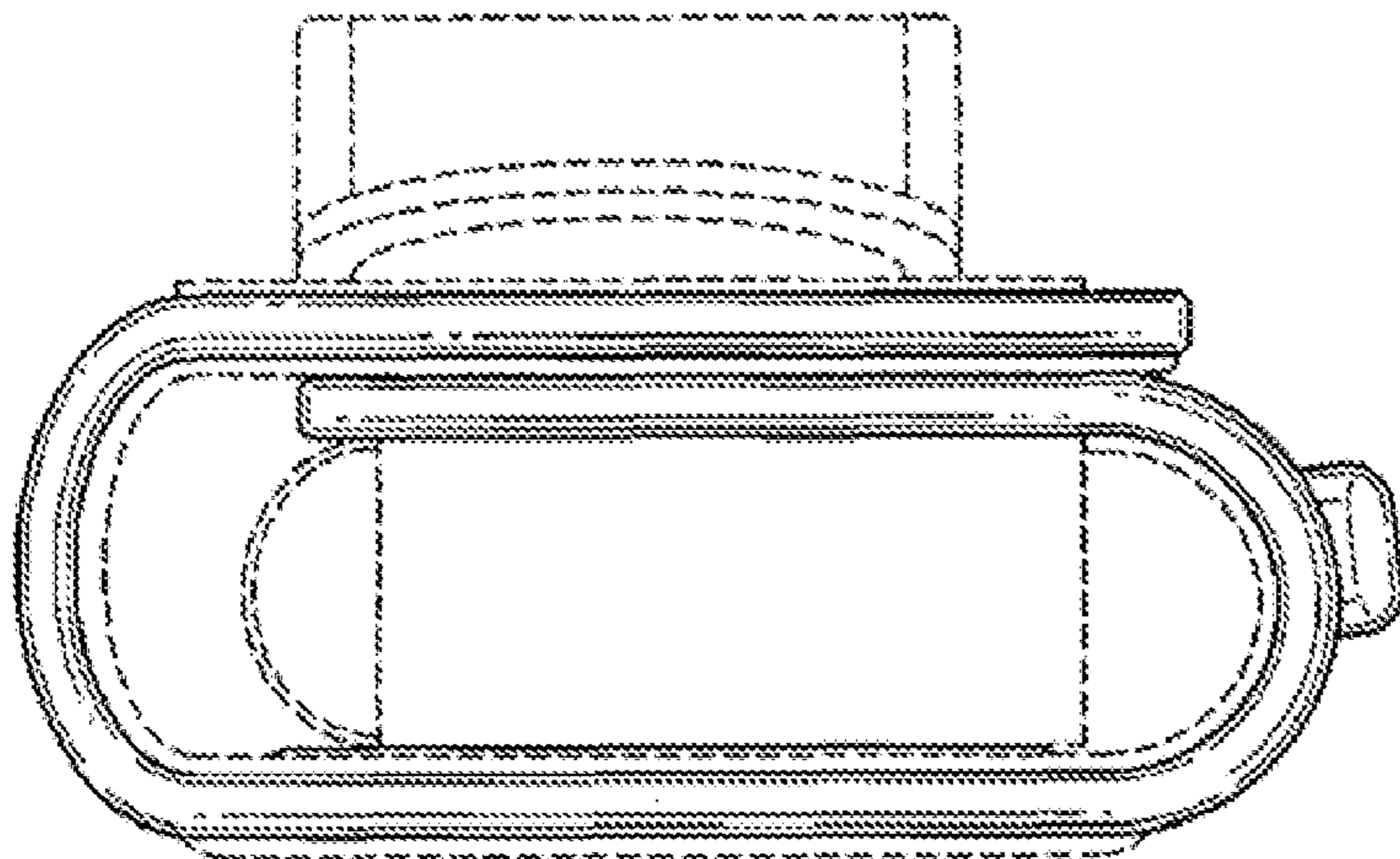

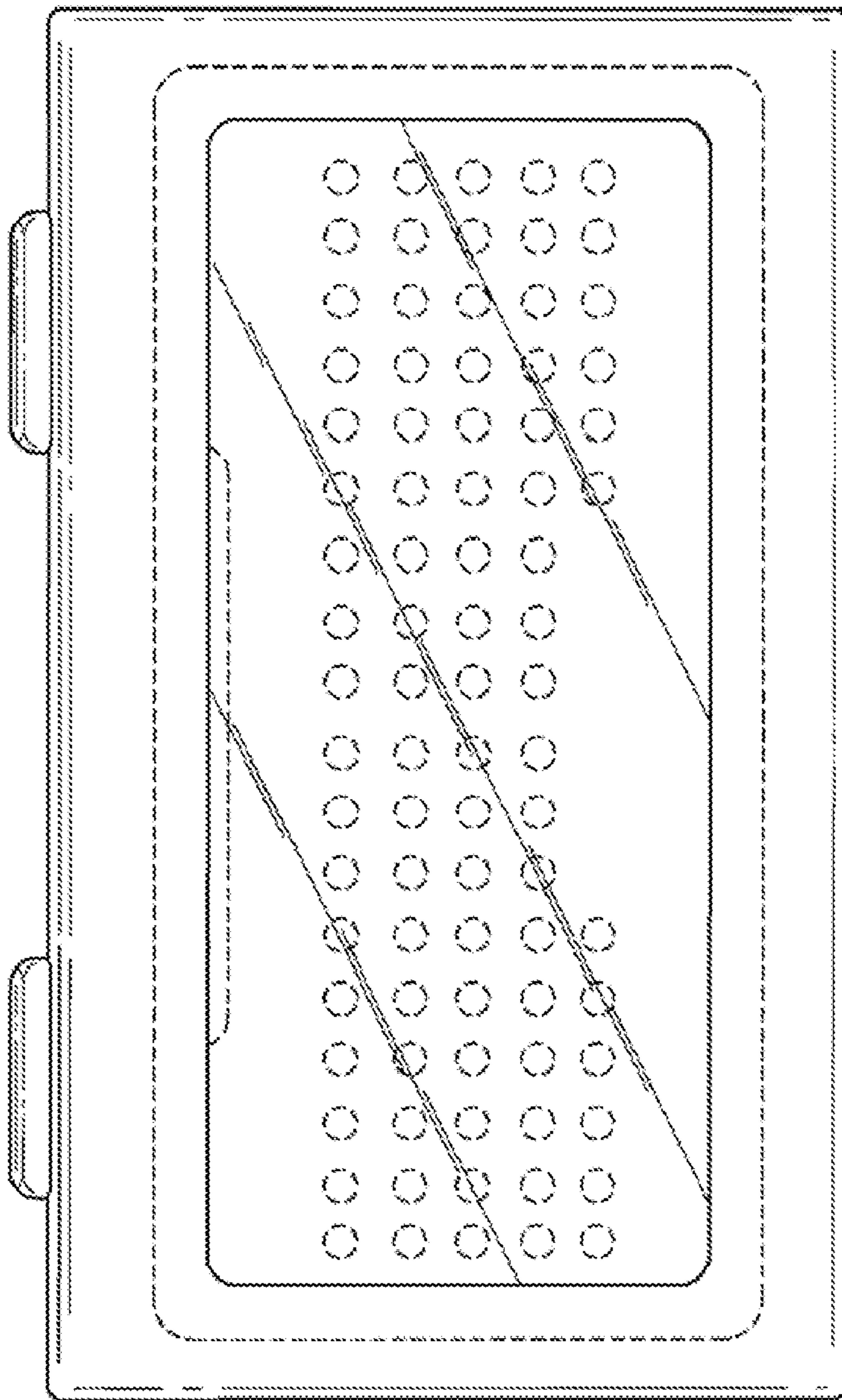

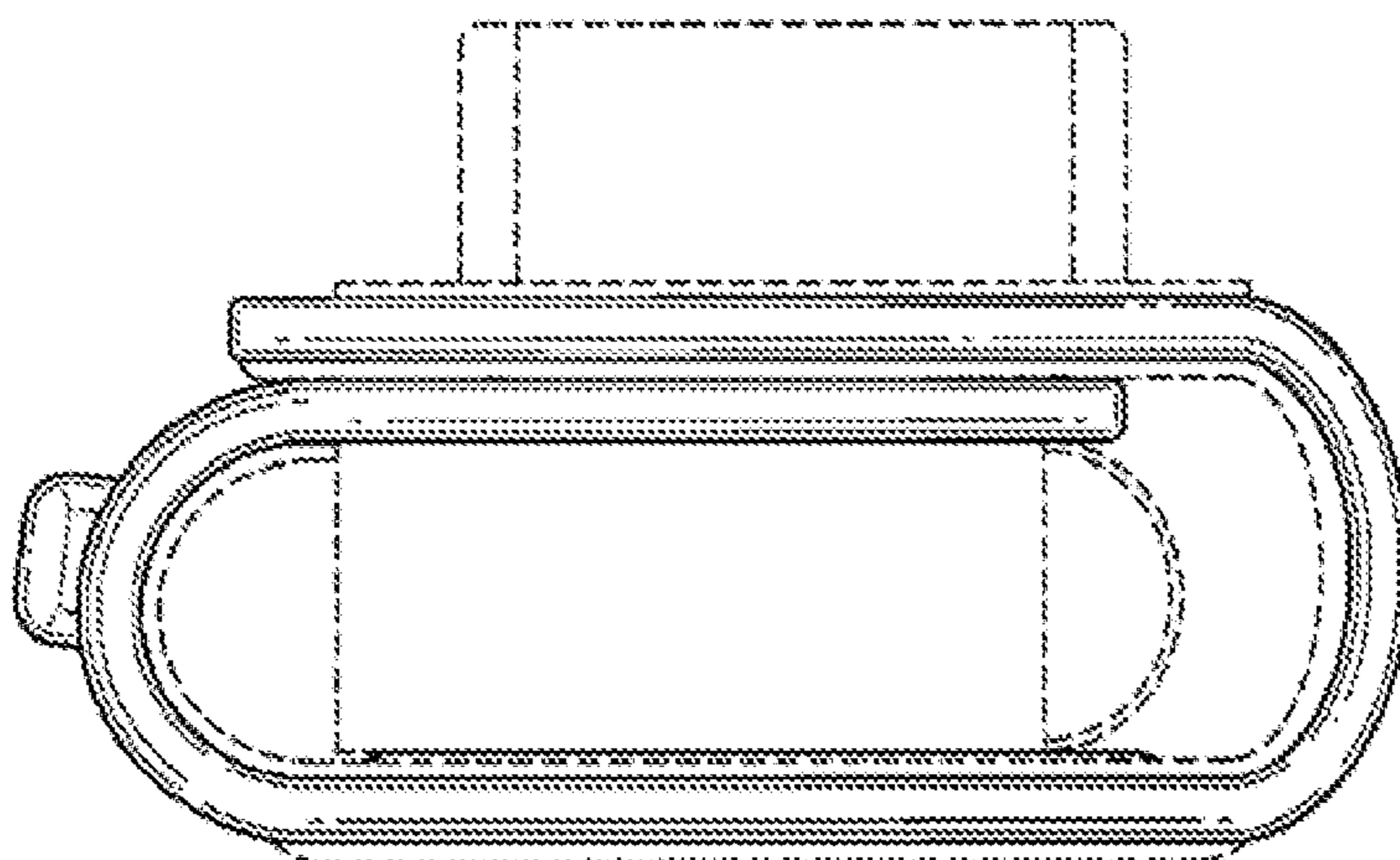

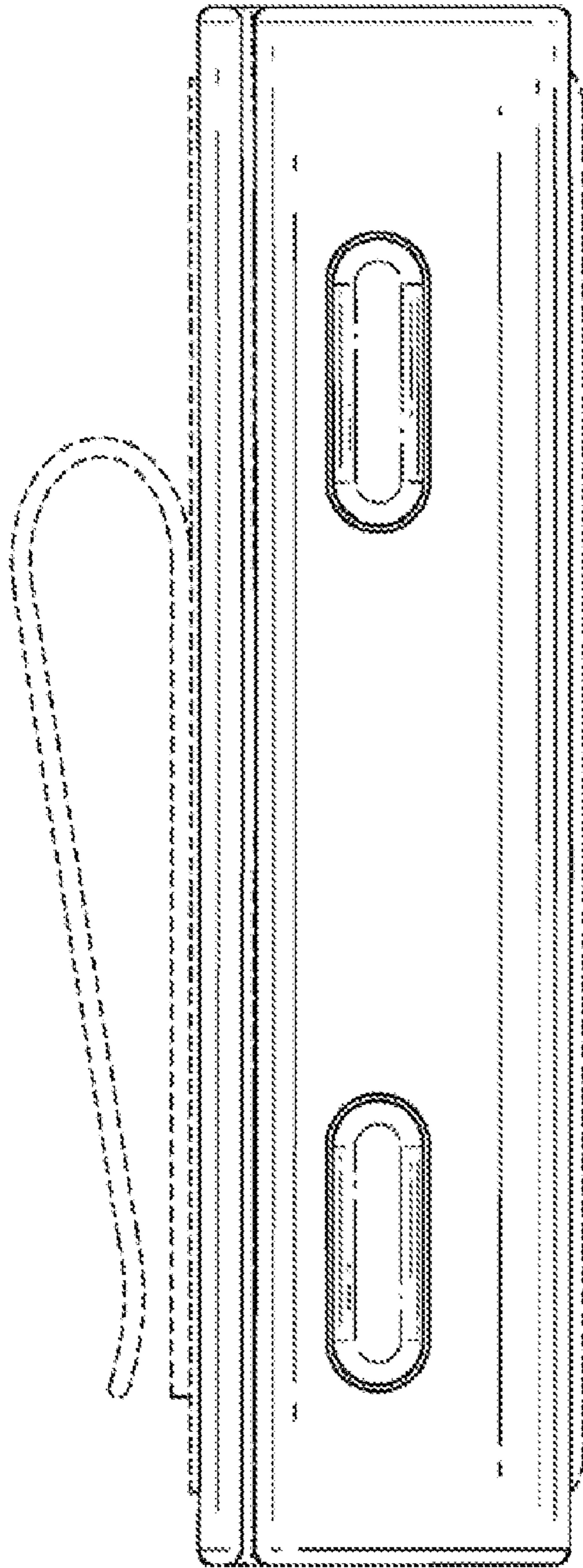

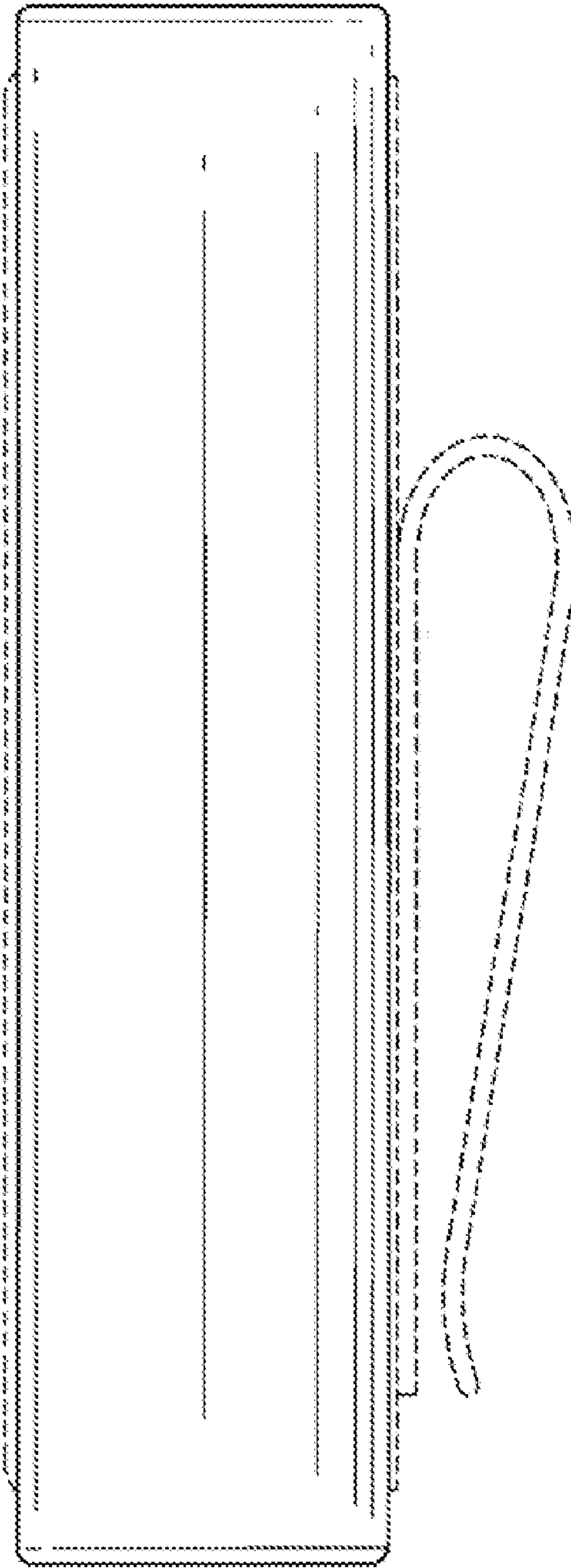

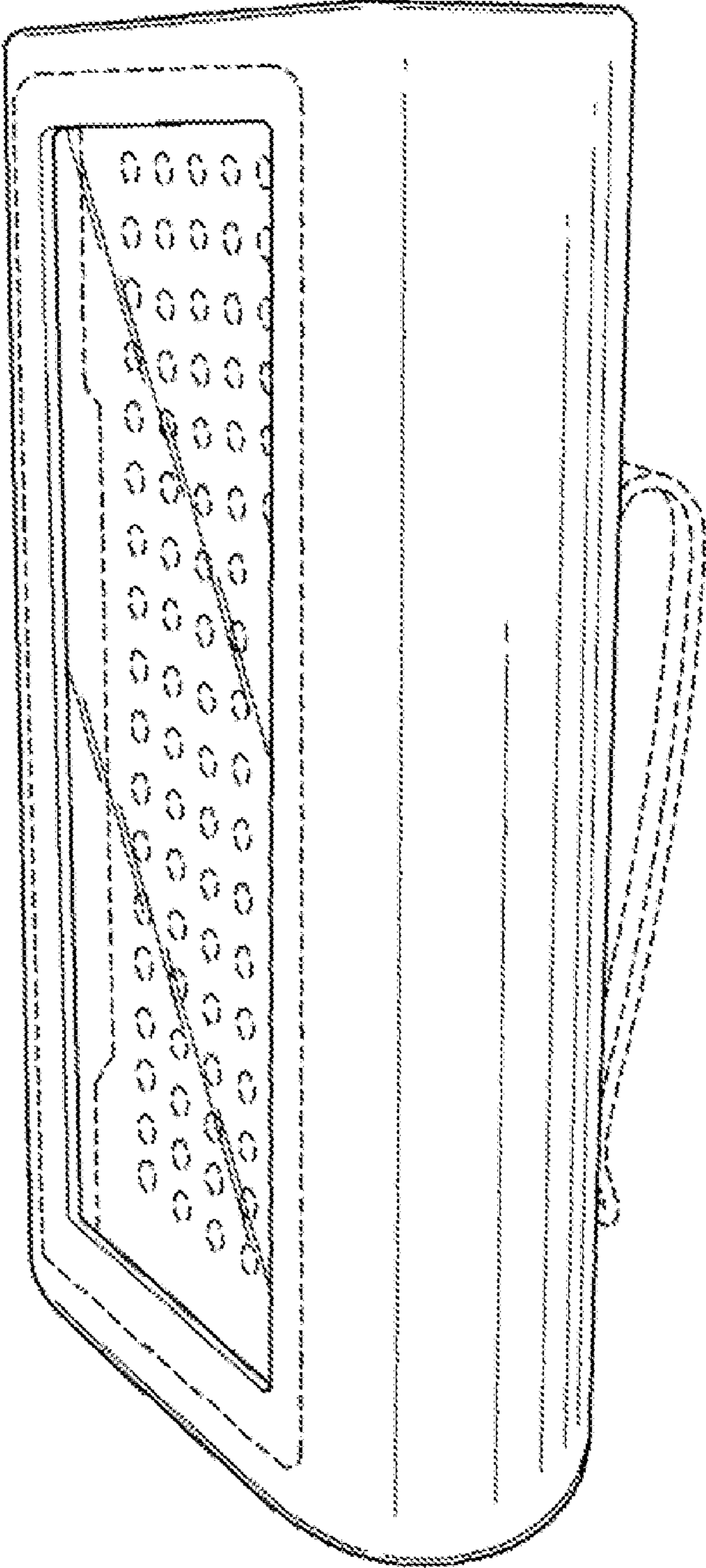

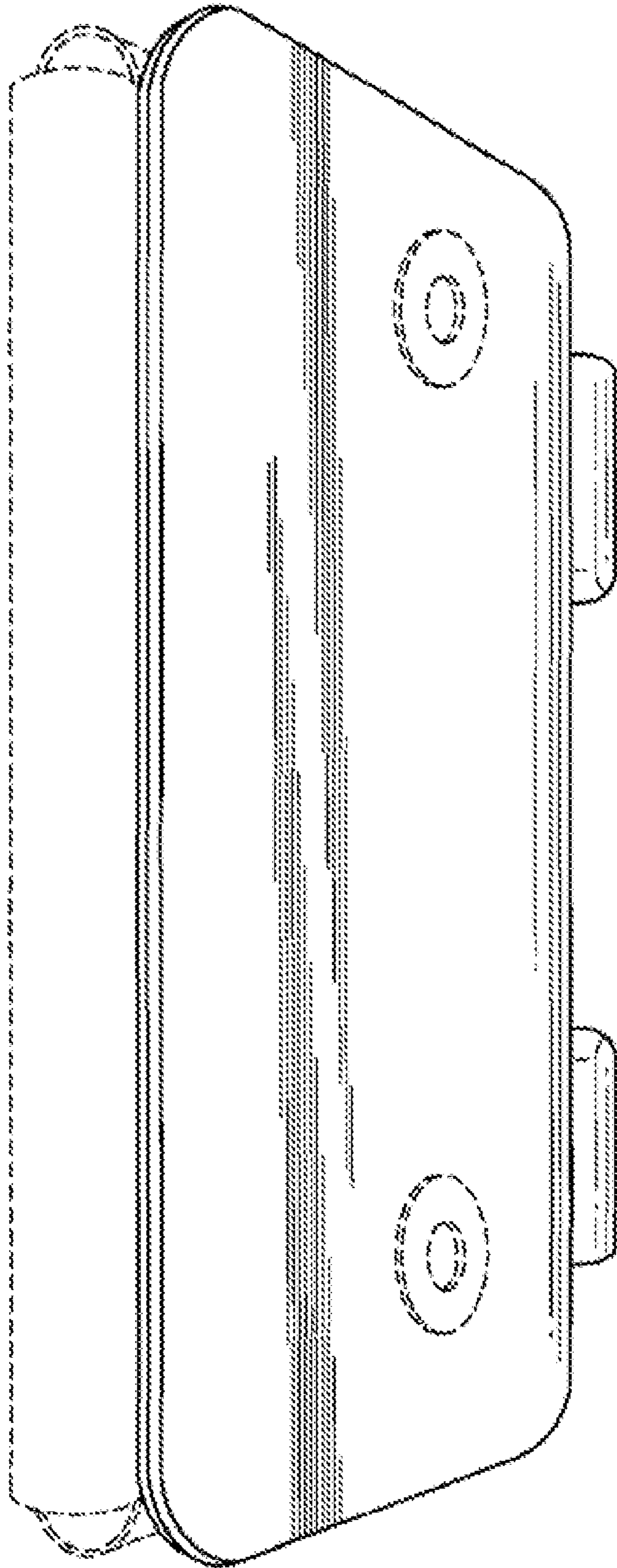

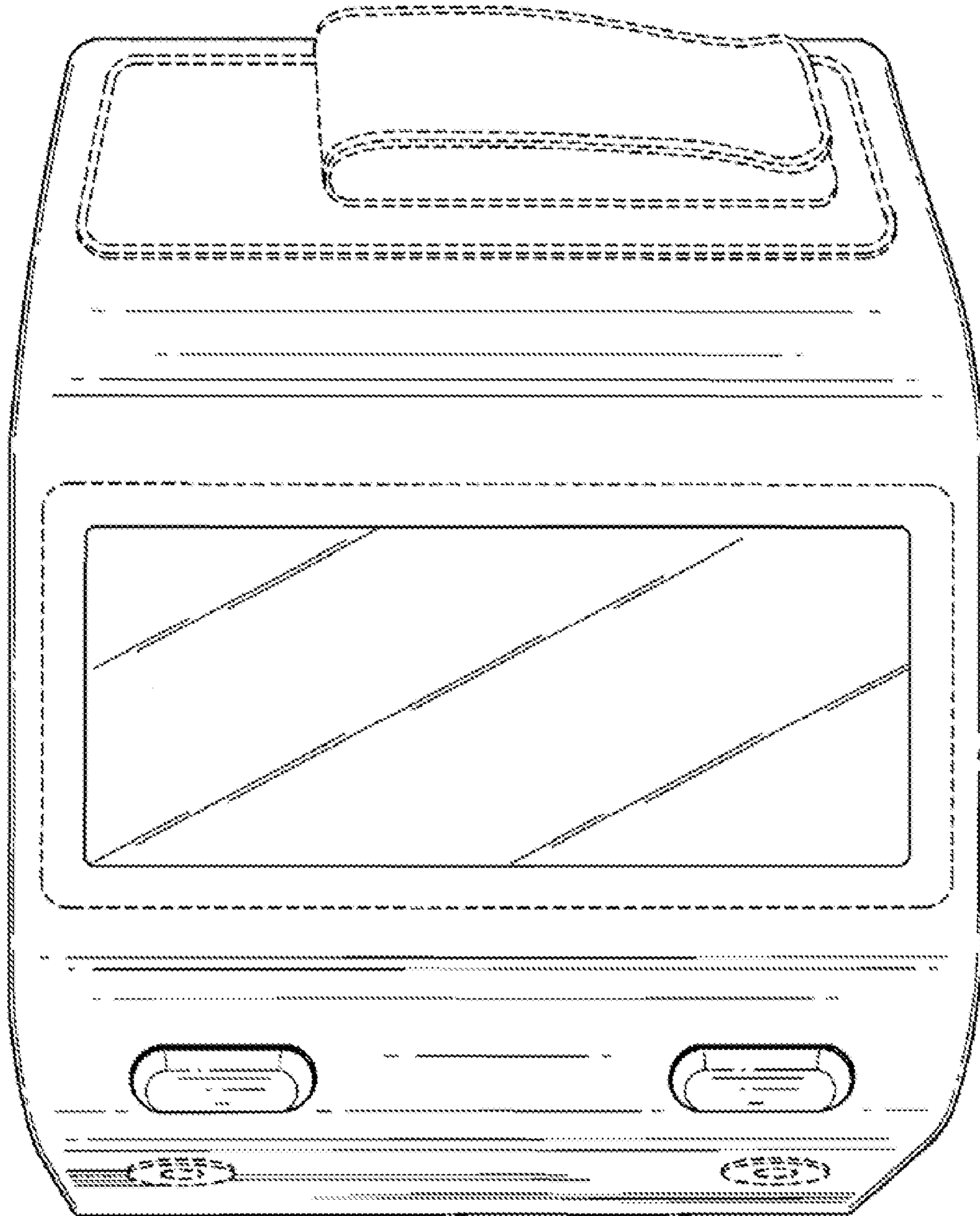

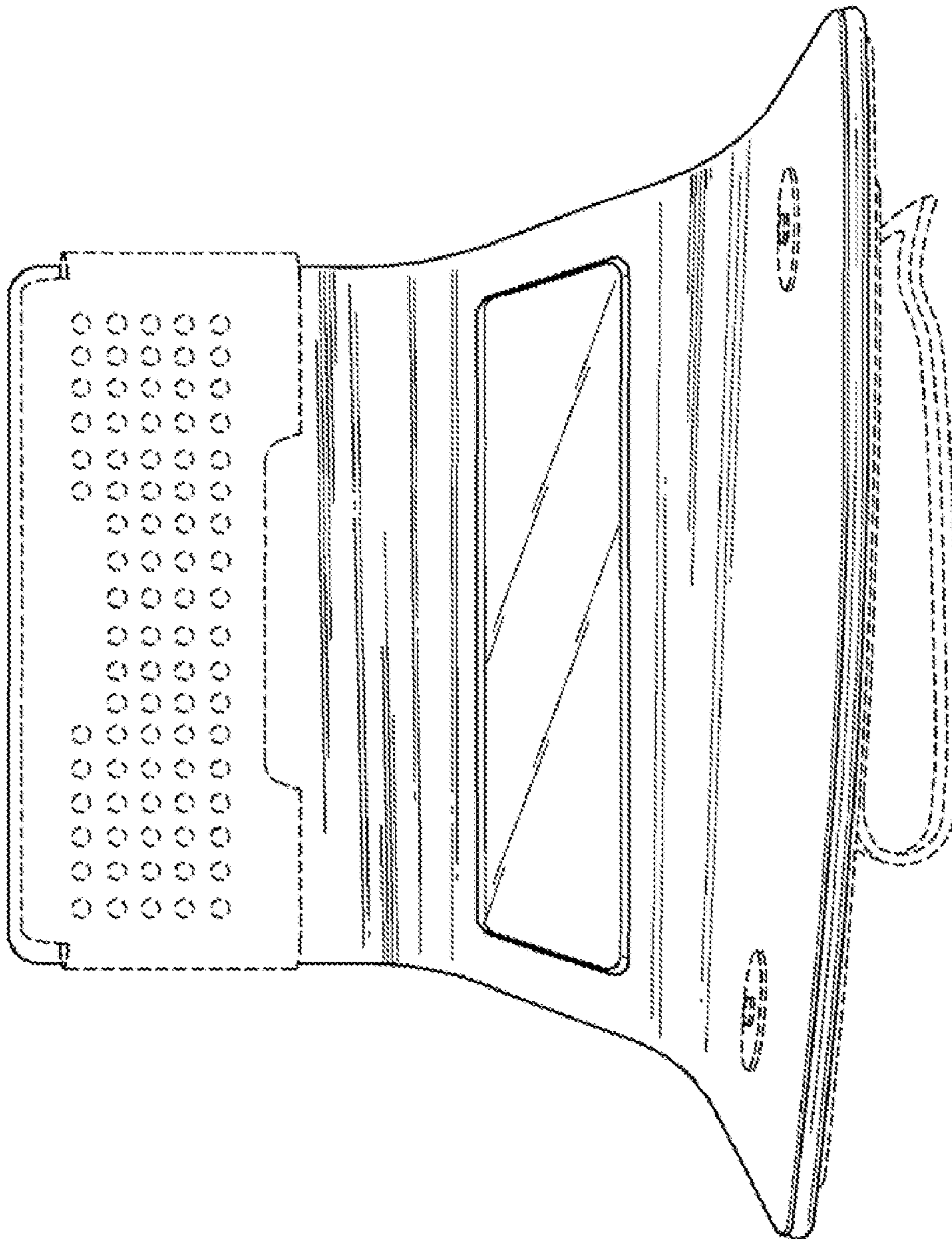

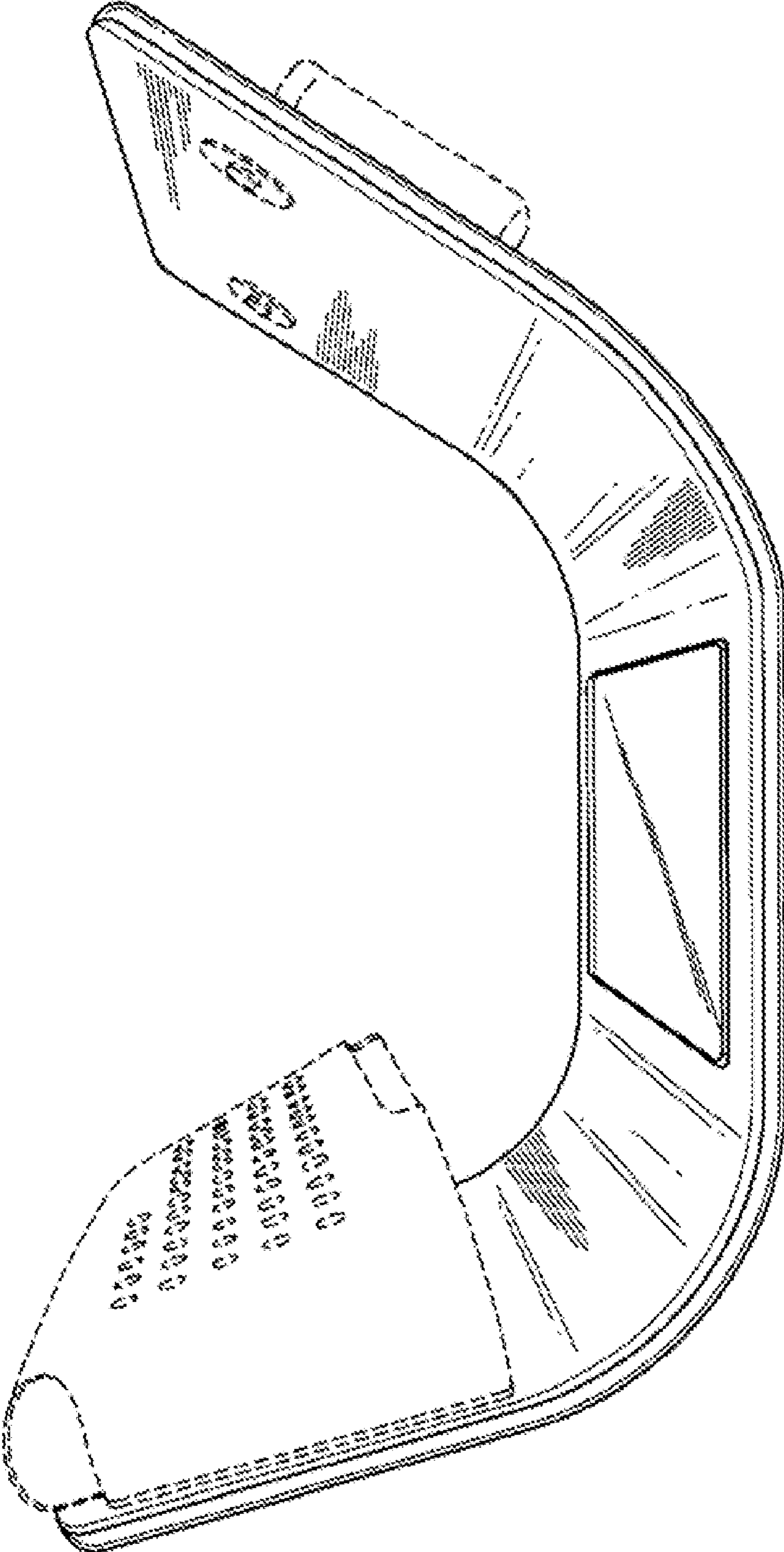

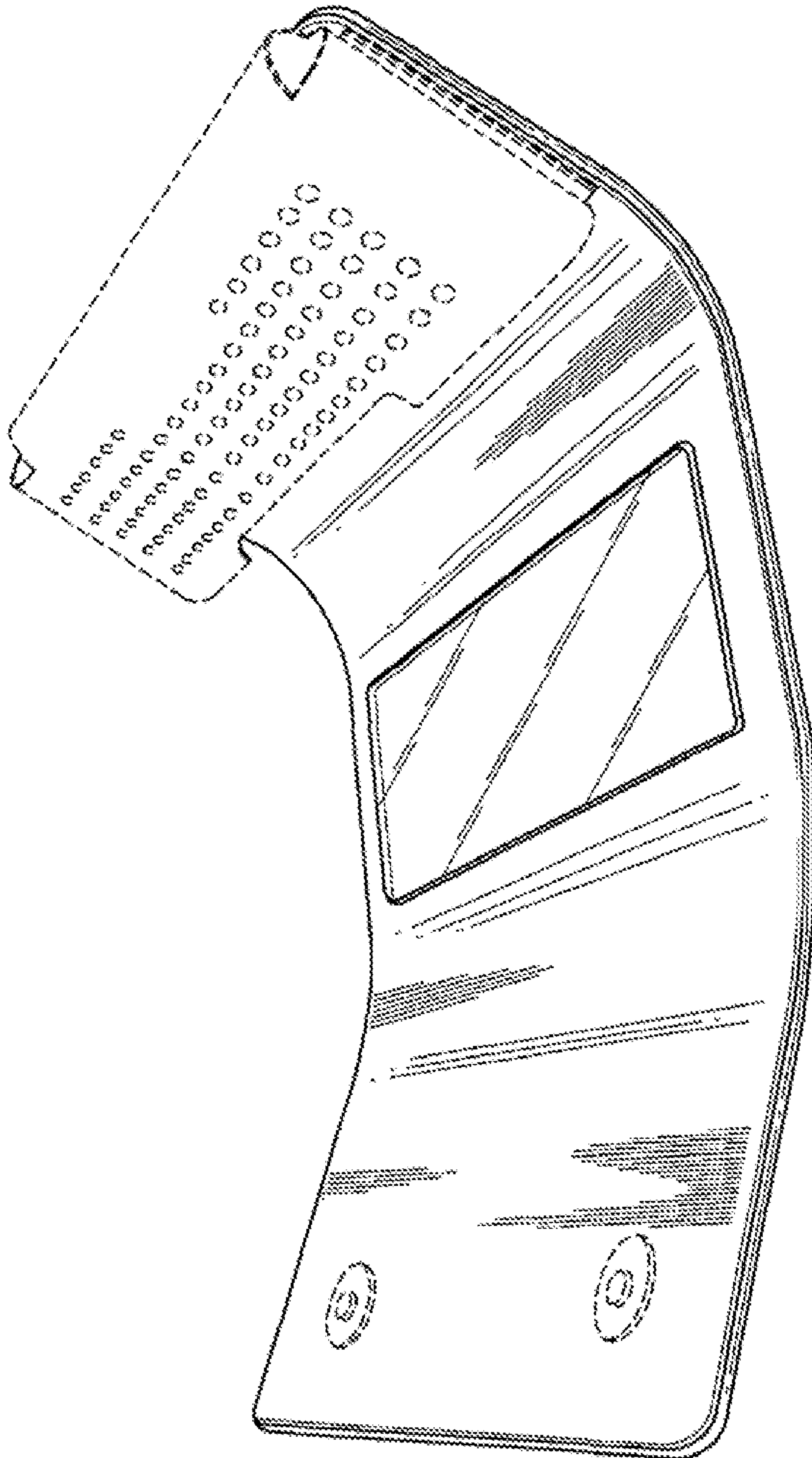

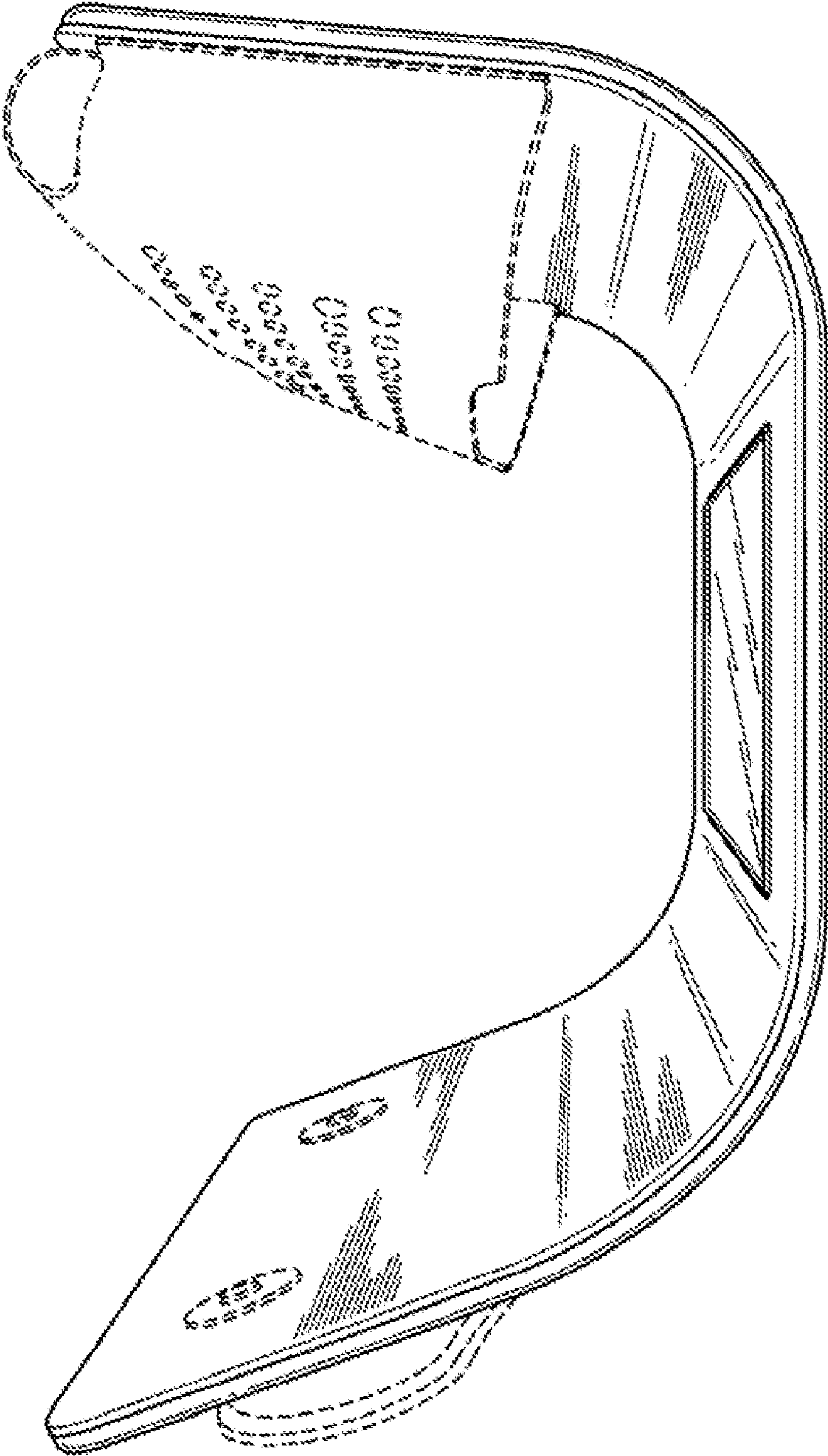

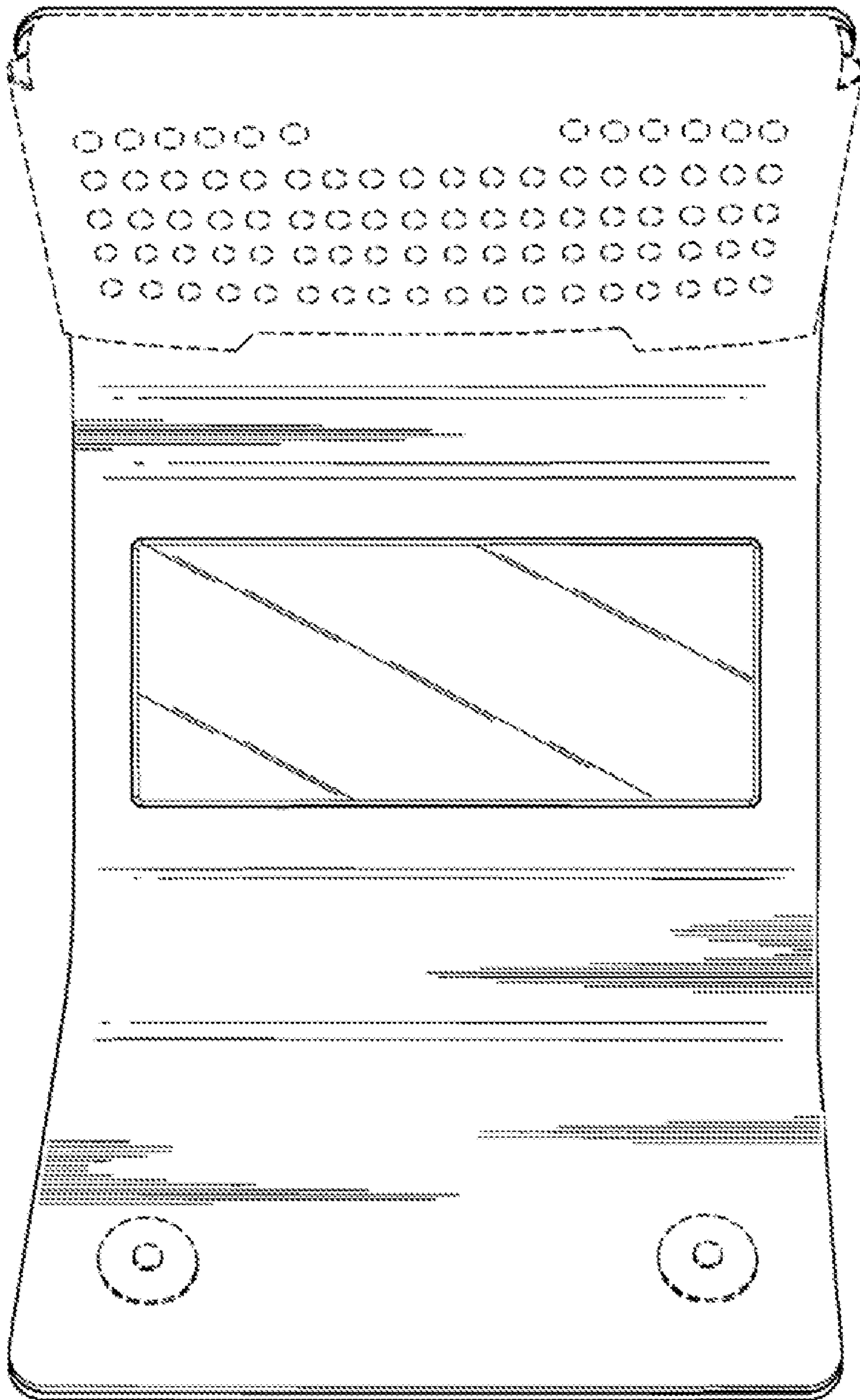
