DESCRIPTION

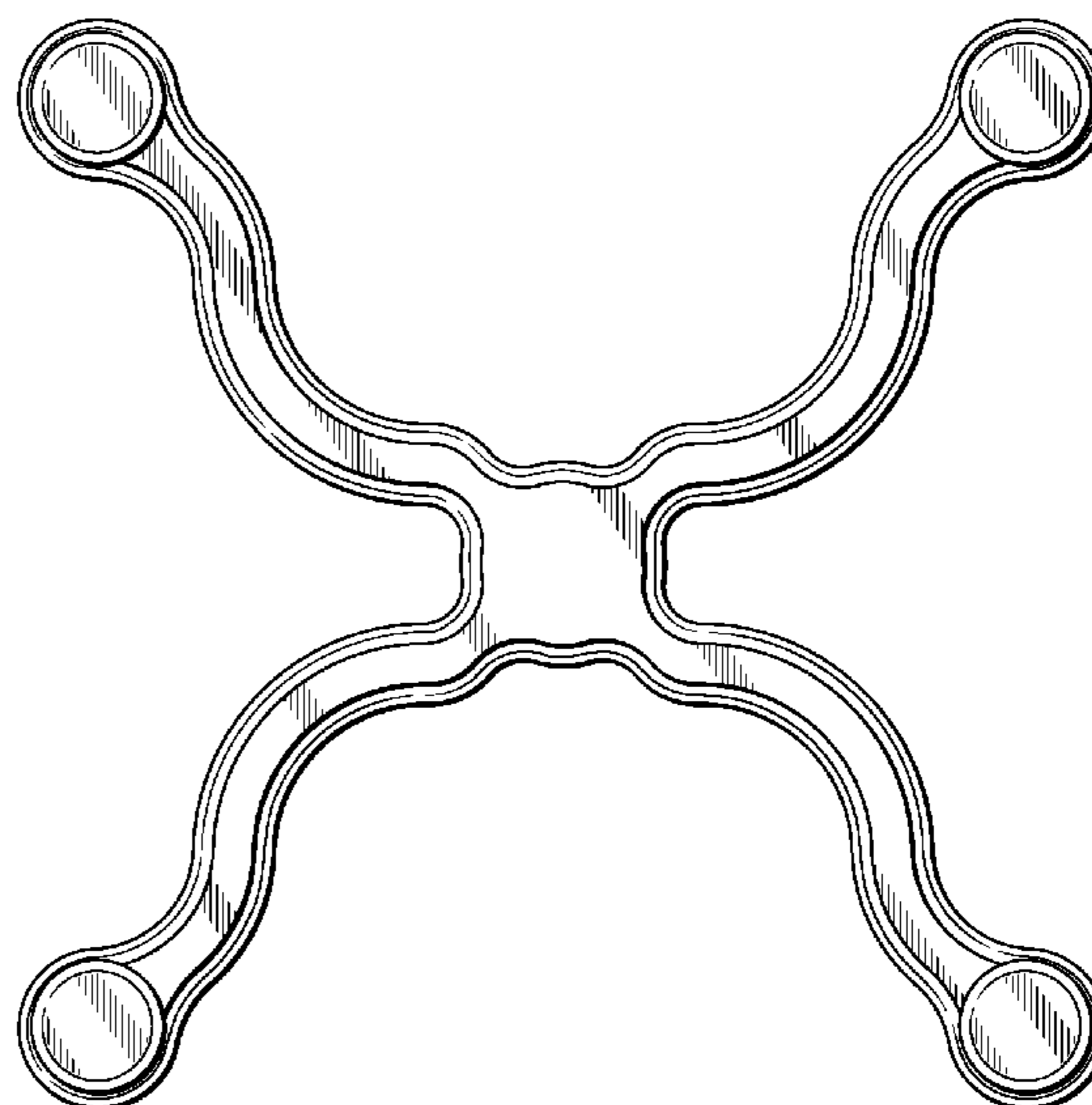
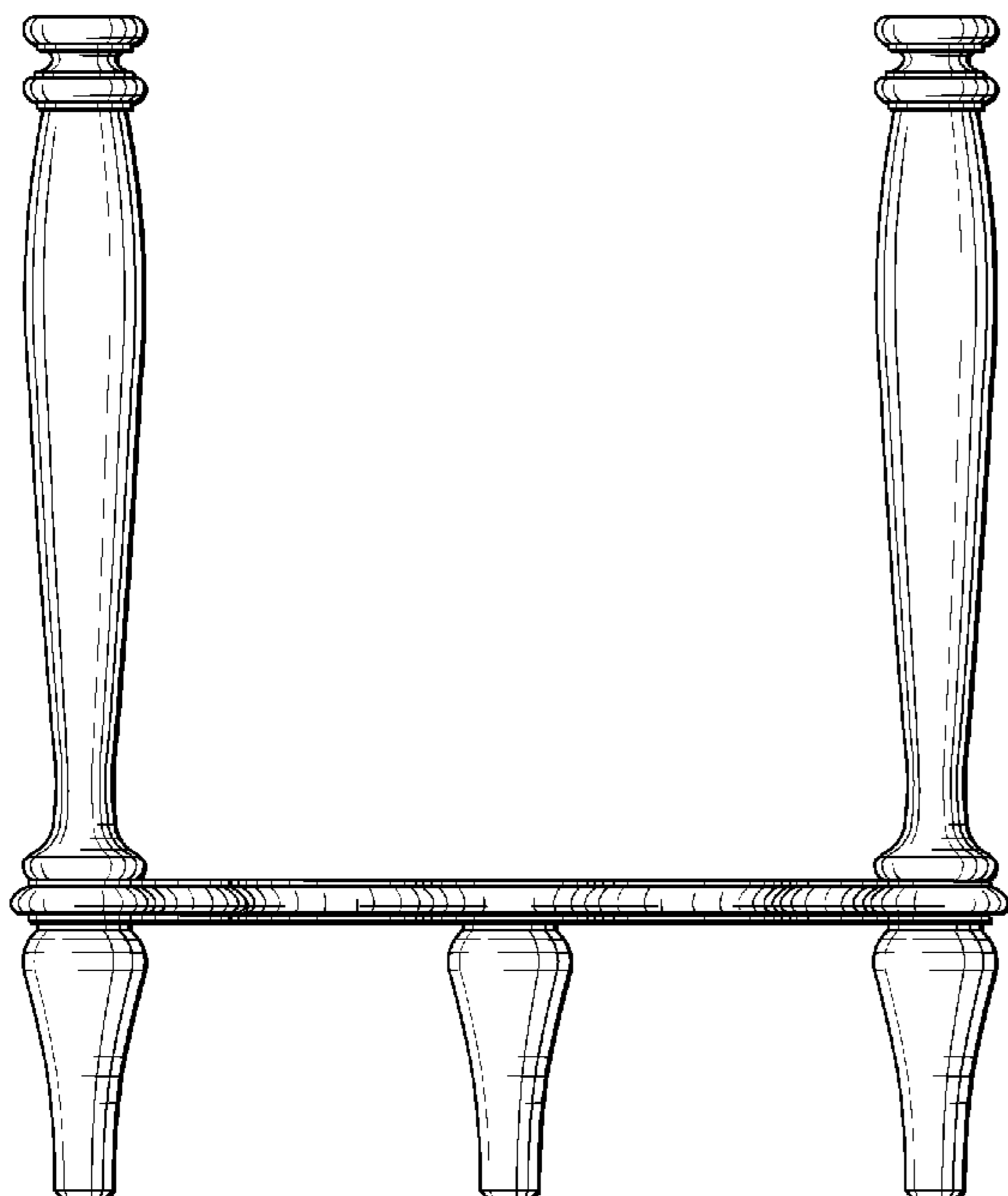
FIG. 1 is a front elevational view of a table base showing my new design, with the rear elevational view thereof being identical.

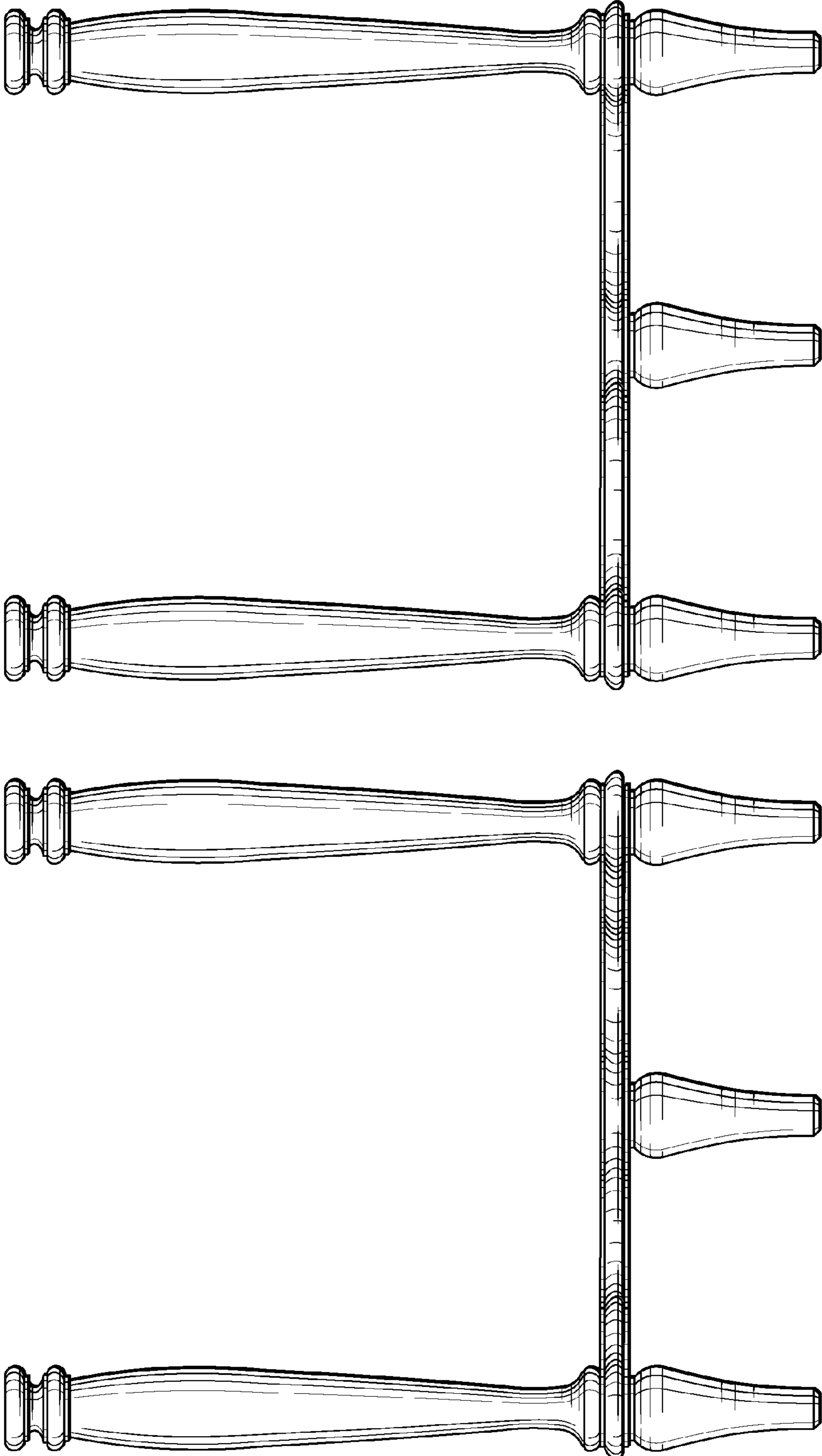

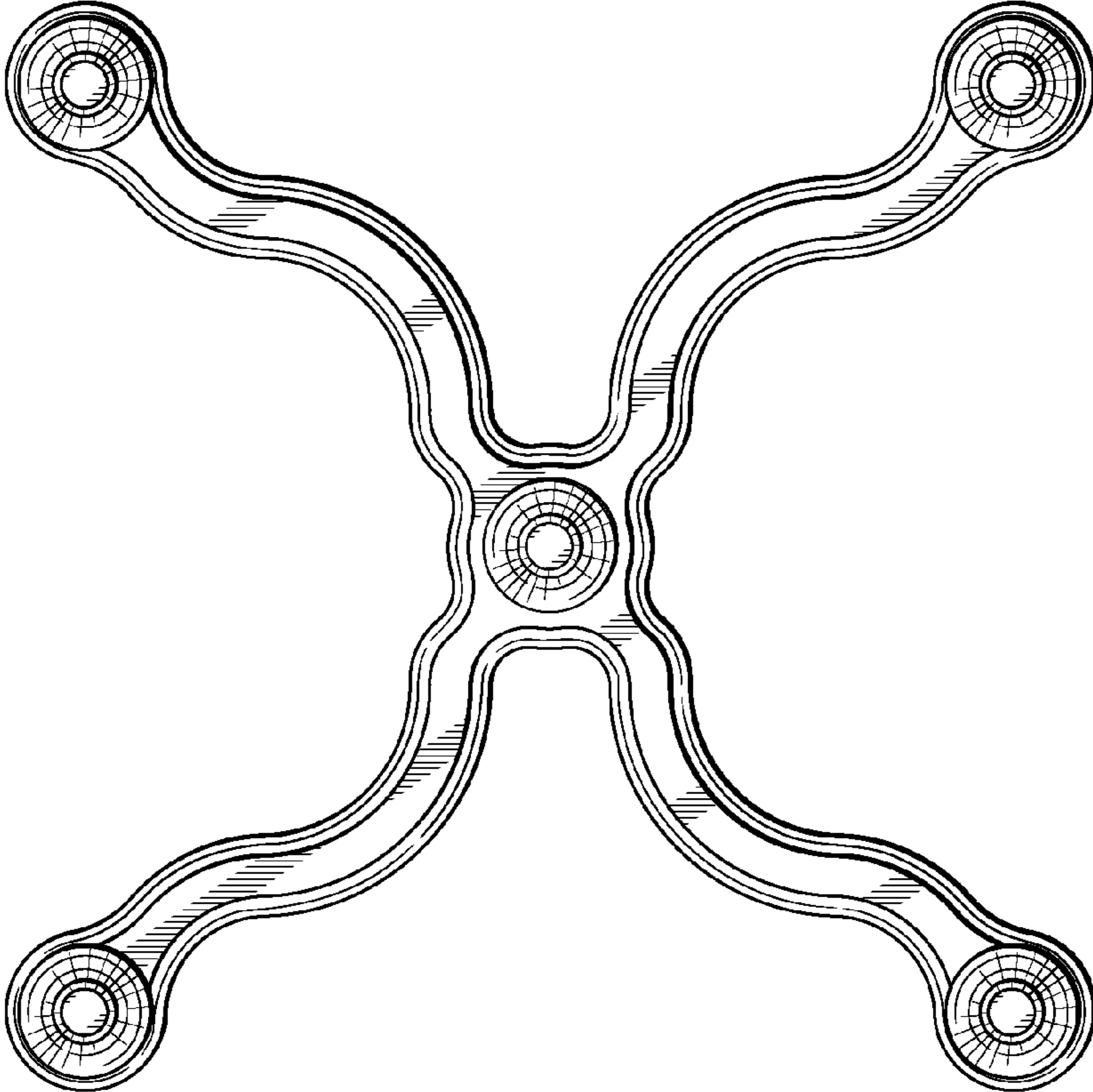

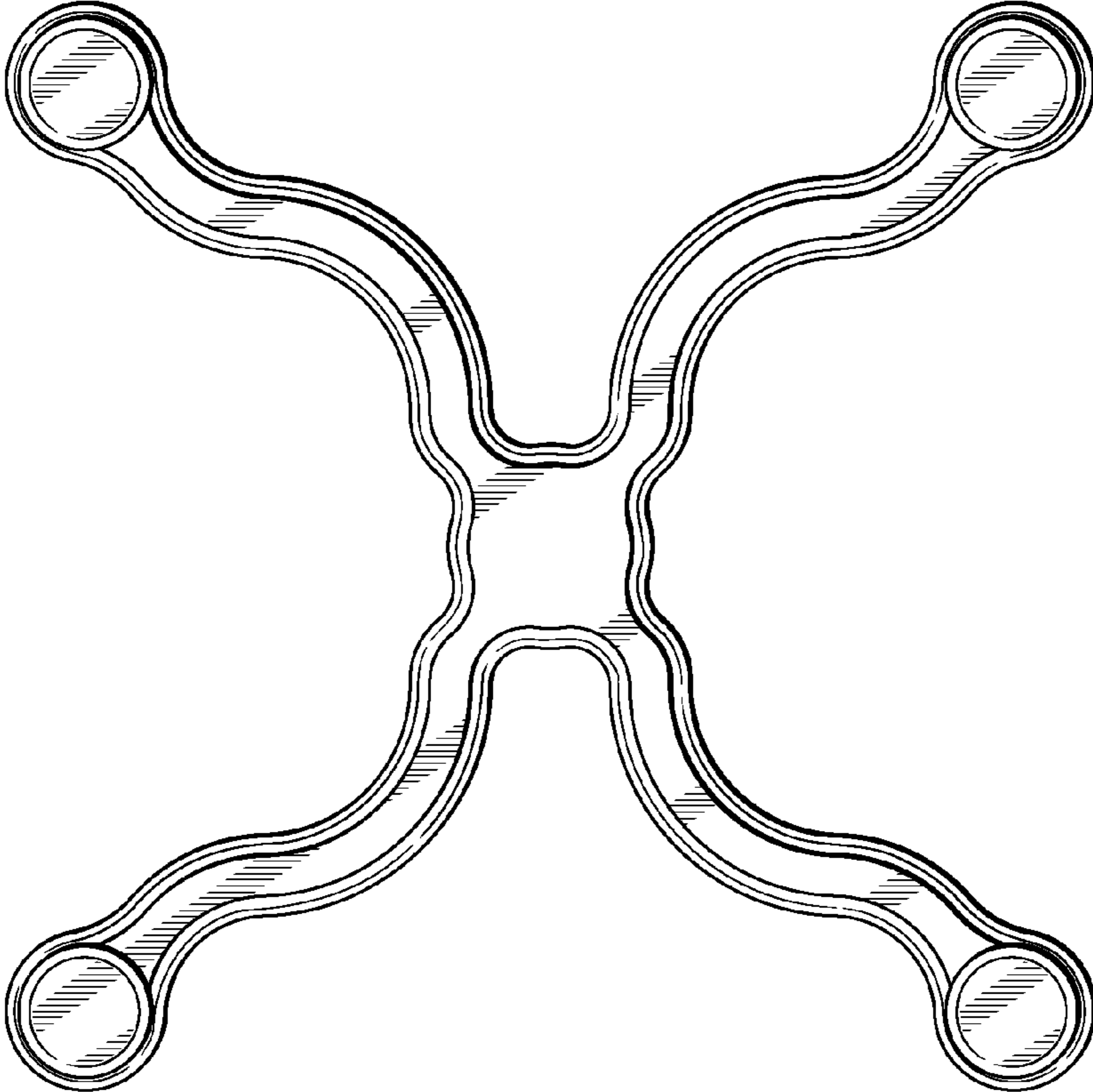
