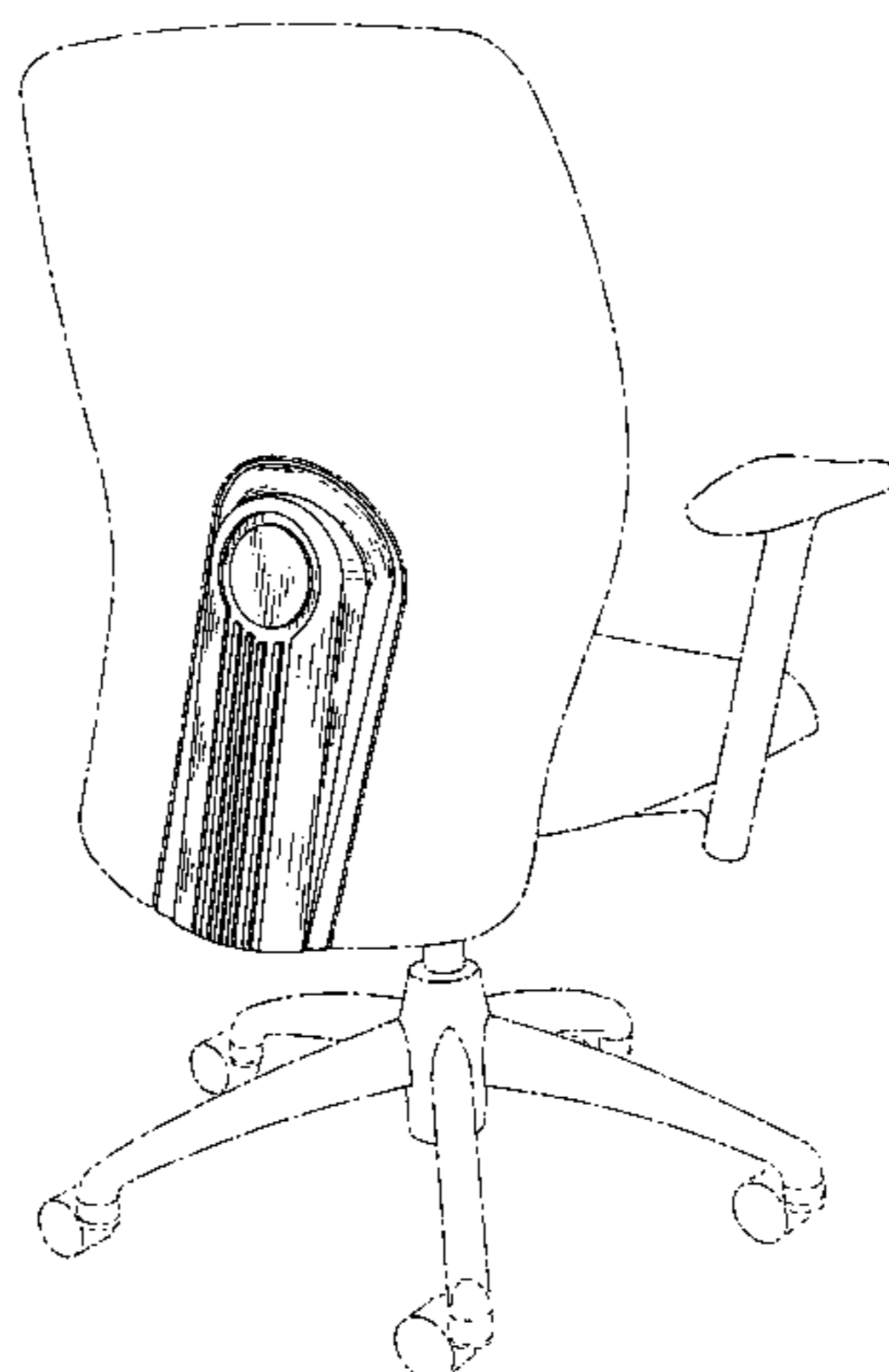
(57) **CLAIM**

The ornamental design for a chair backrest detail, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a chair backrest detail according to our new design;

 FIG. 4 is a right side view thereof.

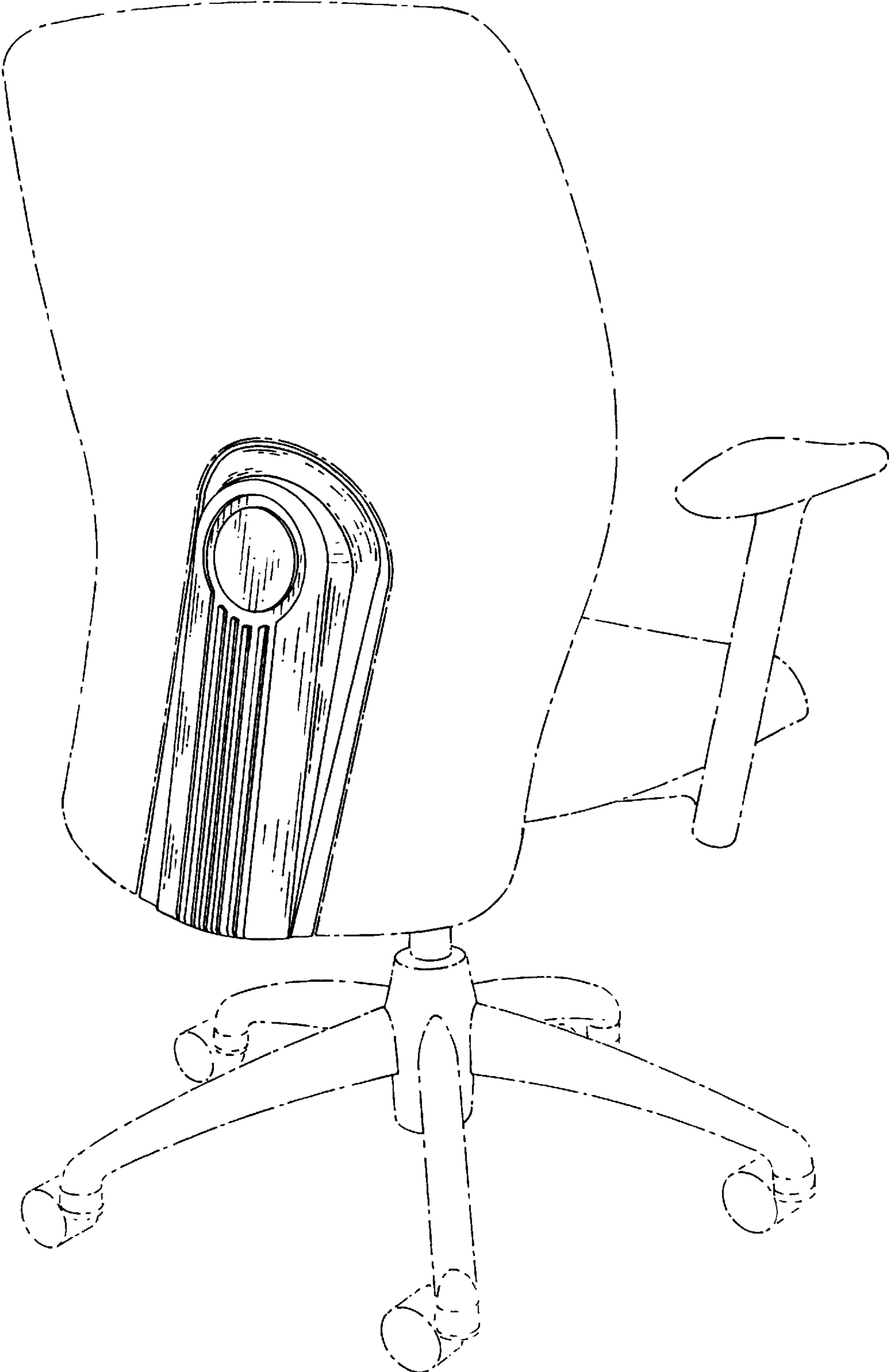
