The ornamental design for drinking vessel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a drinking vessel or jug according to a first embodiment showing my new design;

FIG. 2 is a front side view thereof;

FIG. 3 is a back side view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is an exploded front side view thereof with its bottom shown in a removed position;

FIG. 8 is a perspective view of second embodiment of the drinking vessel or jug;

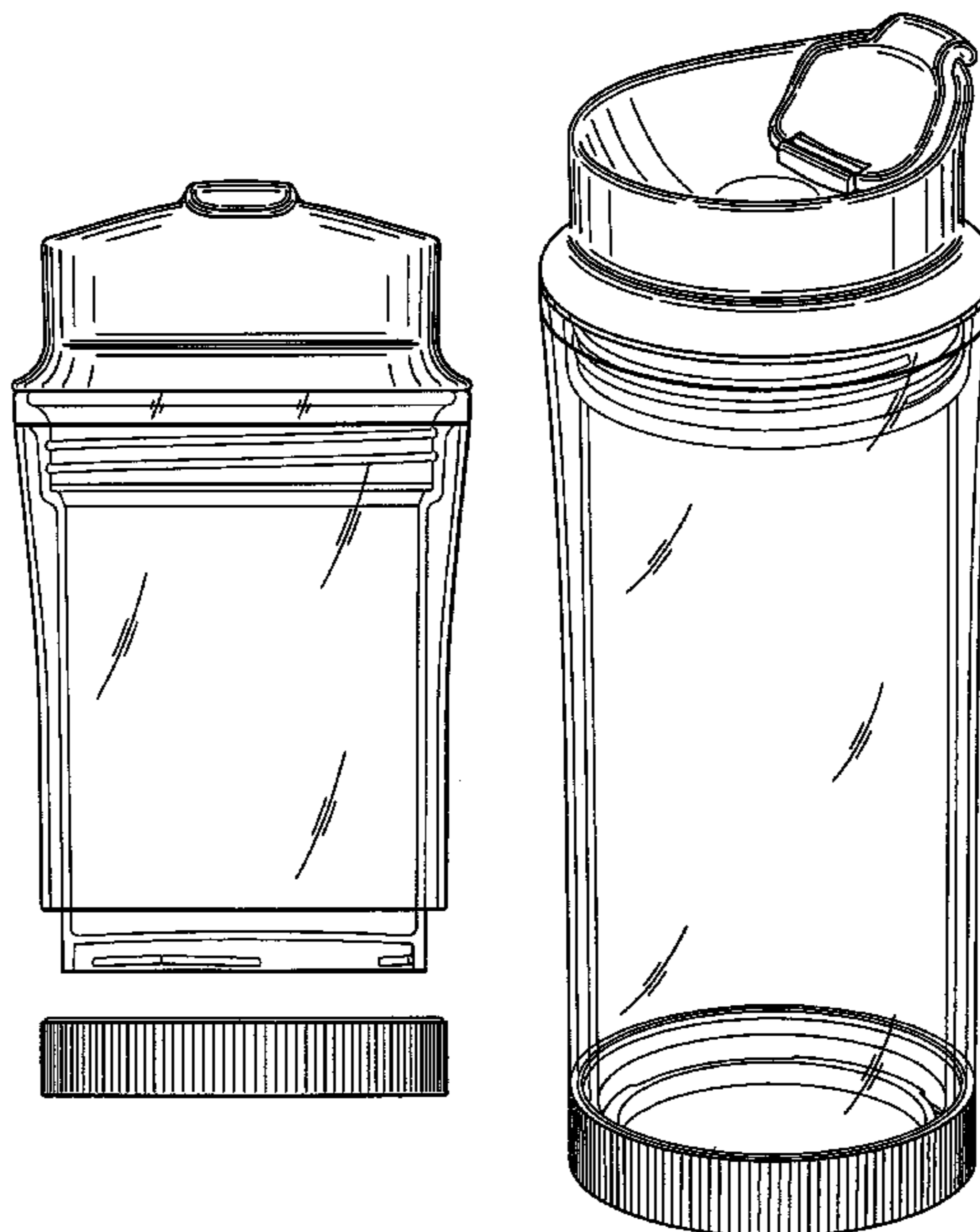

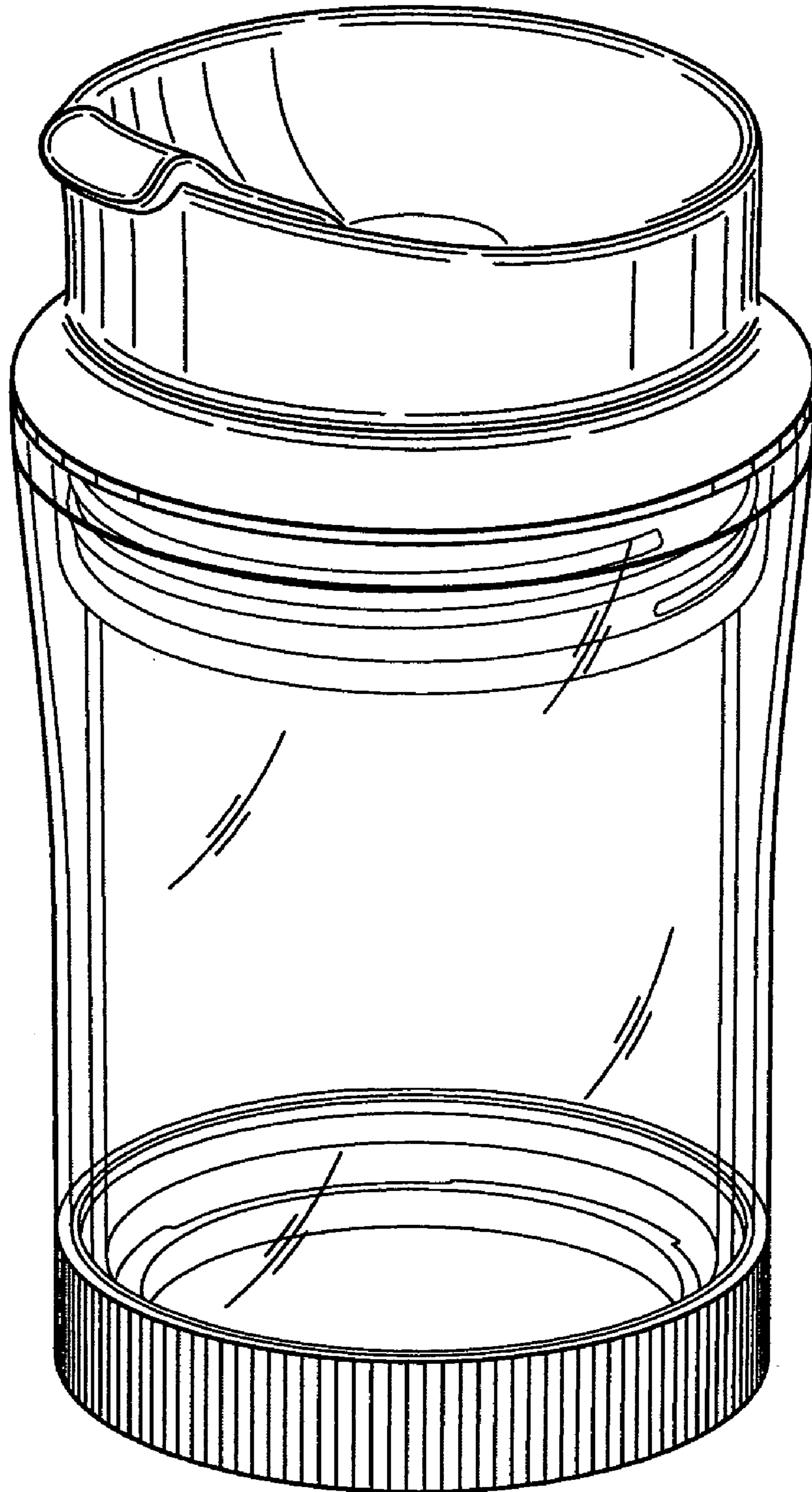

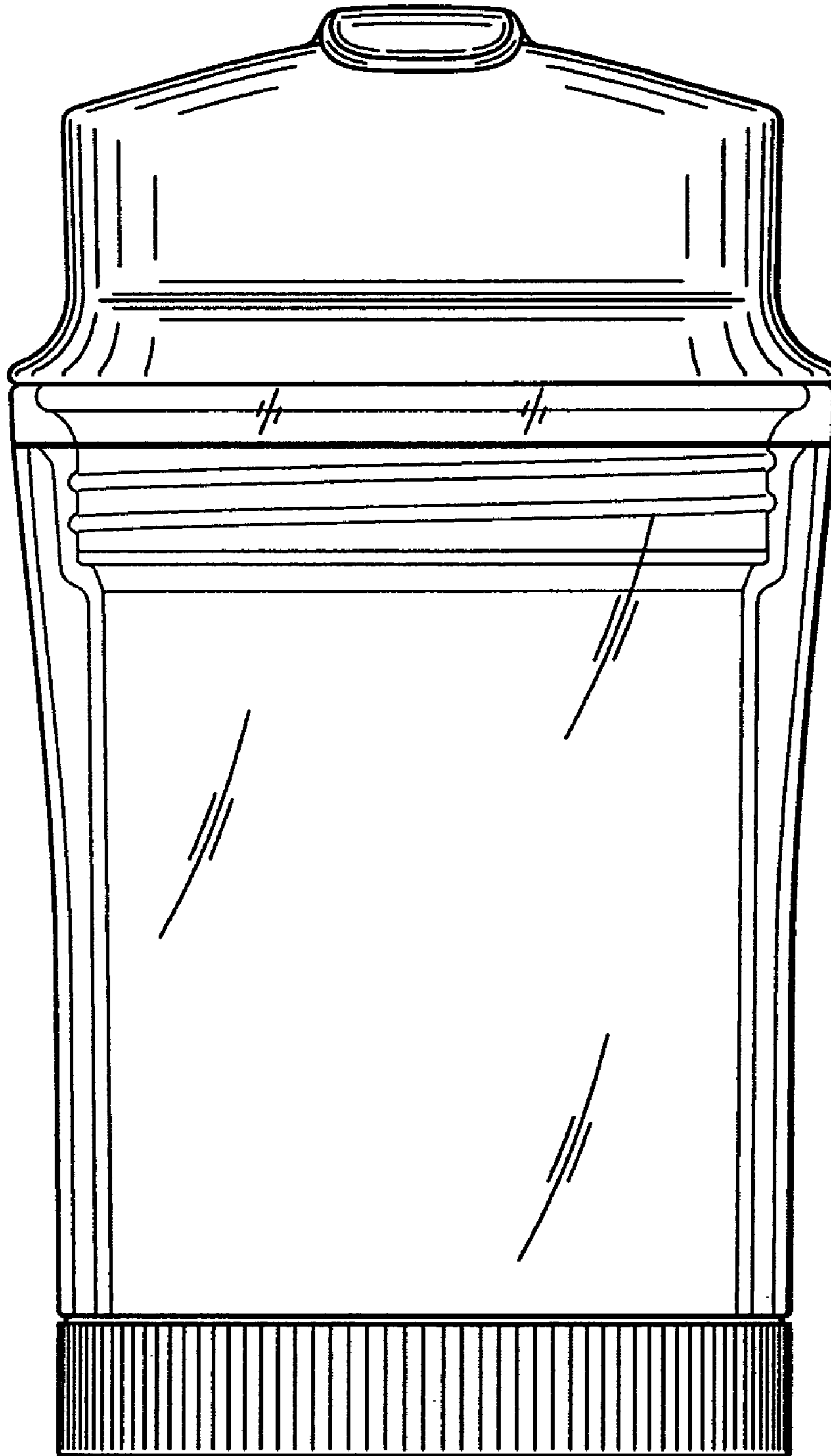

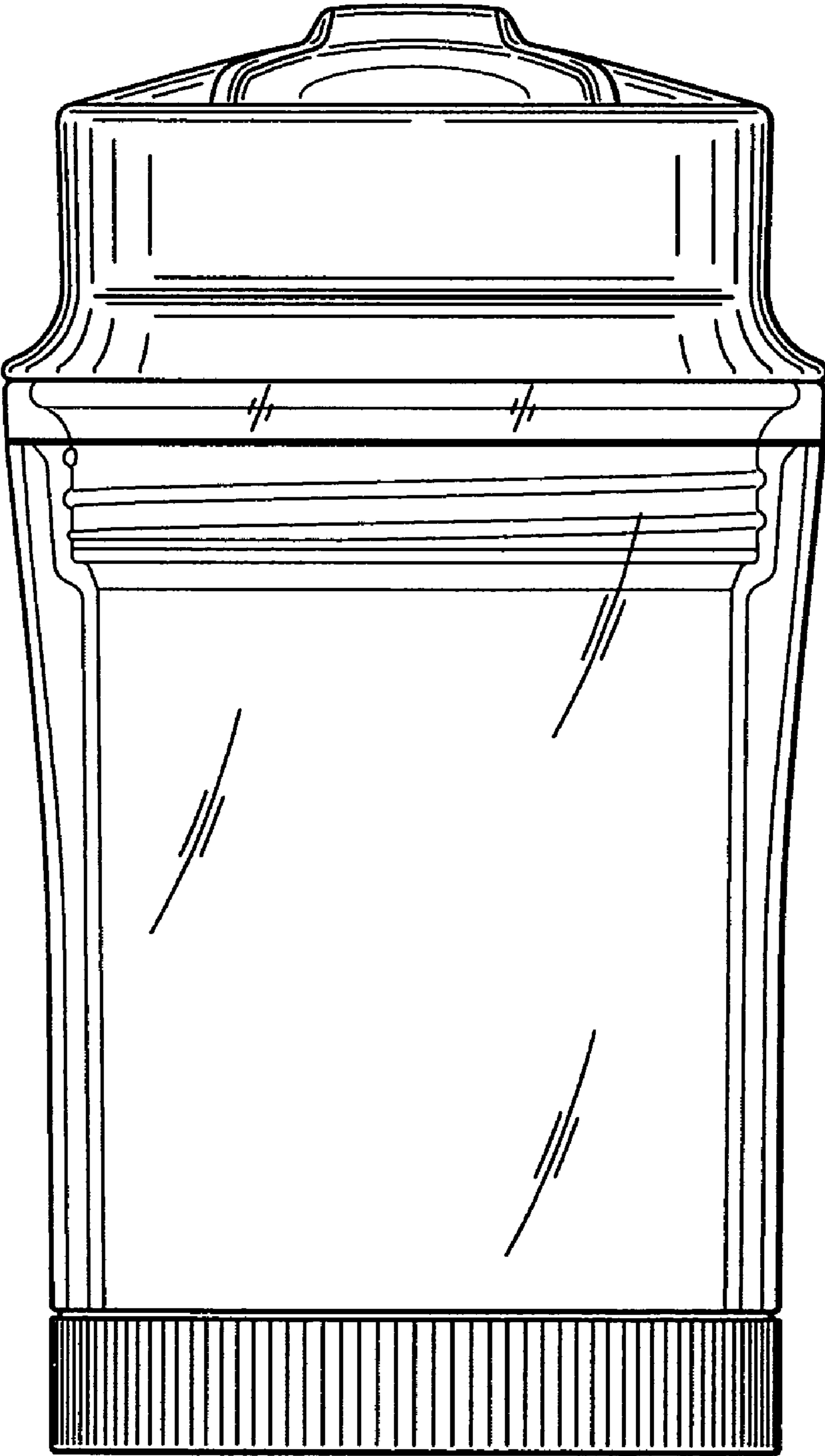

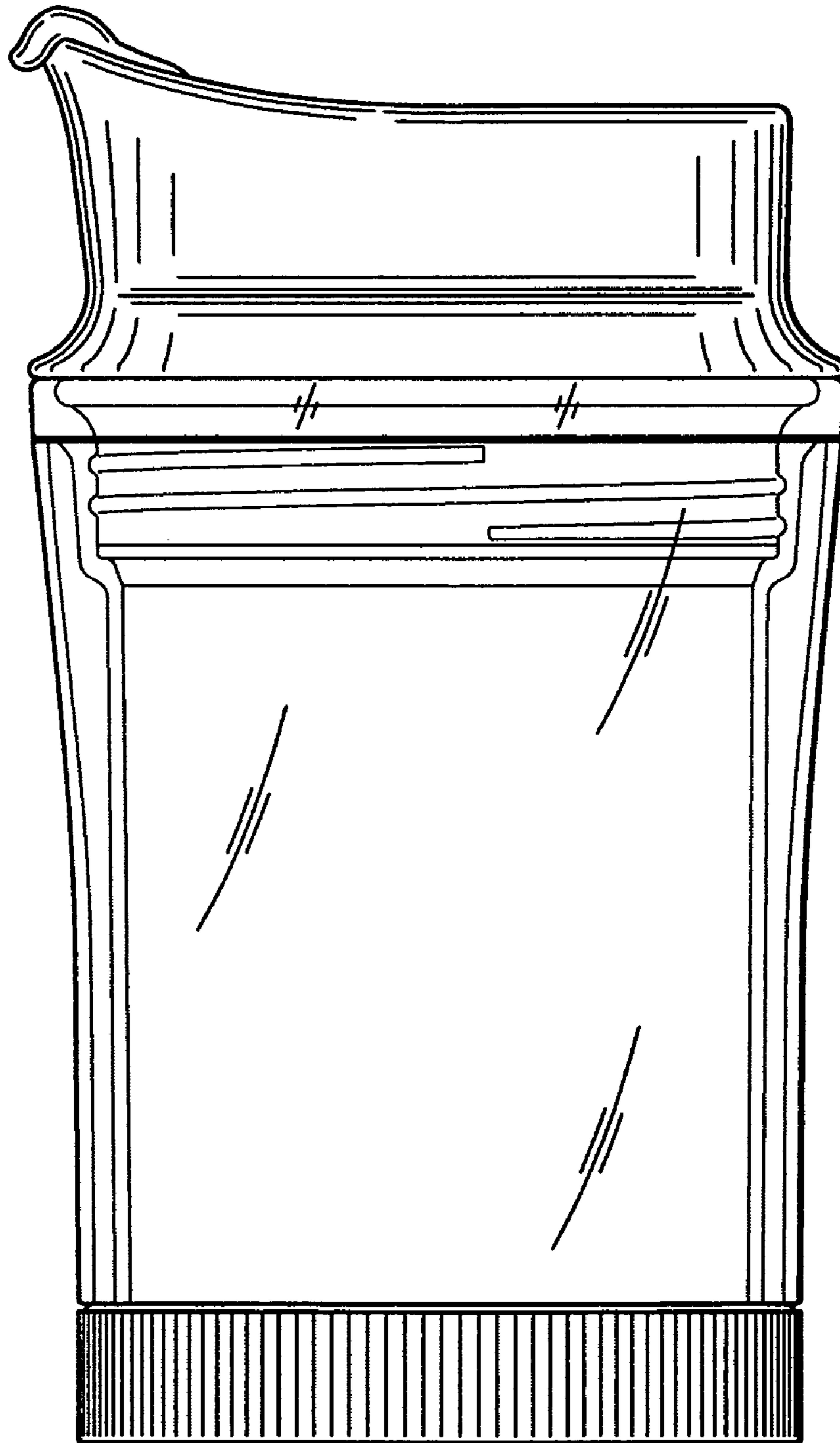

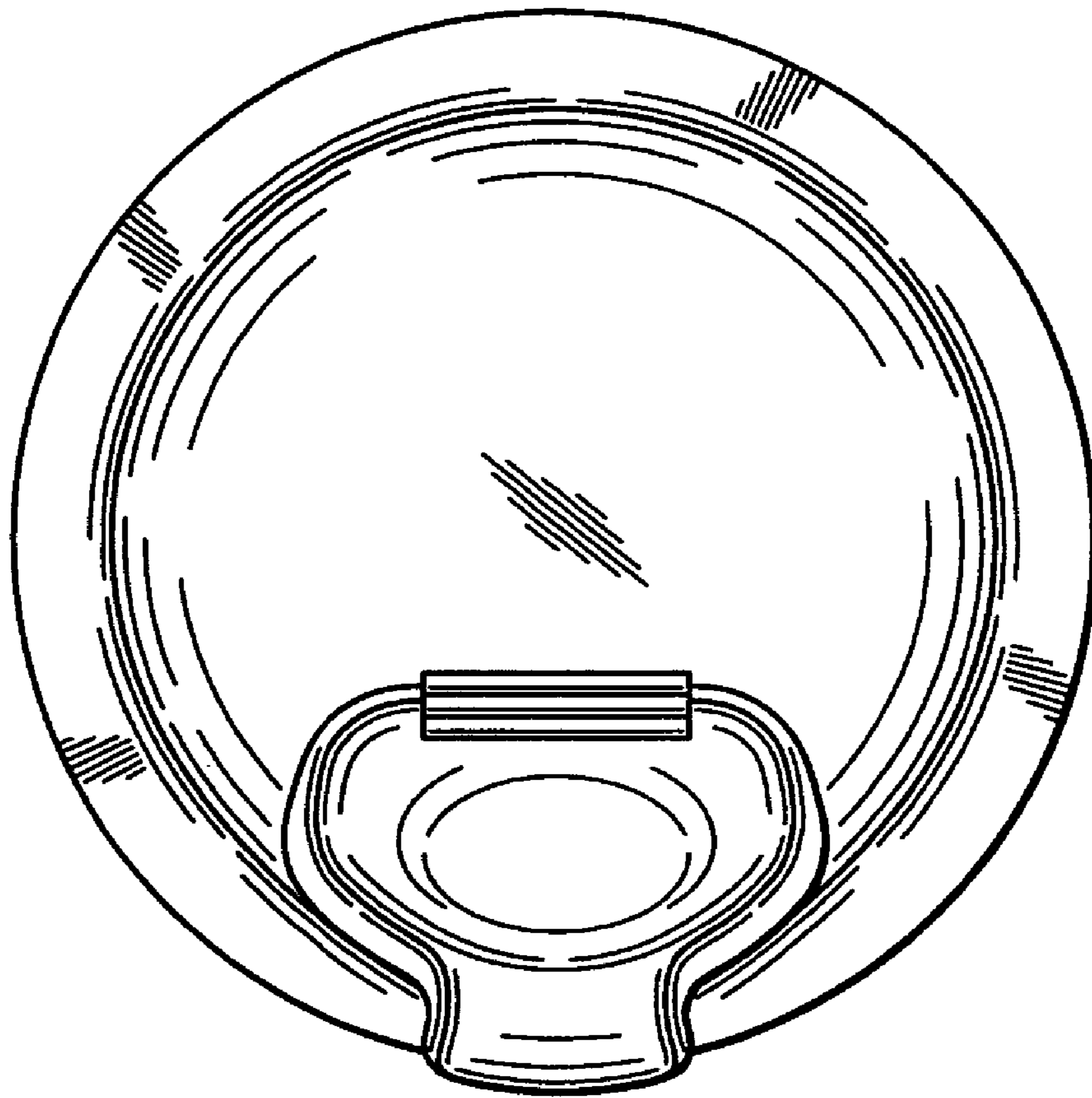

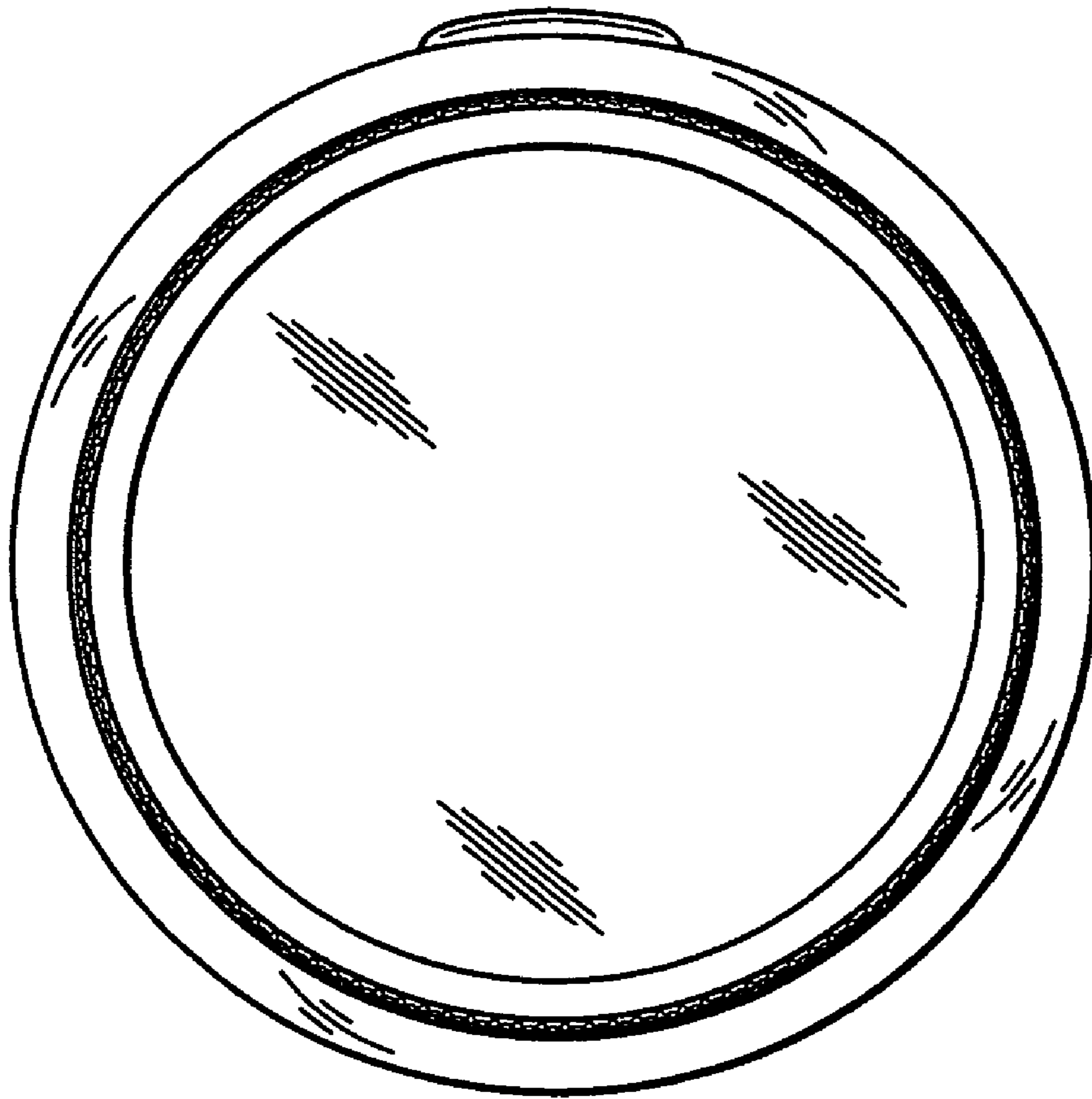

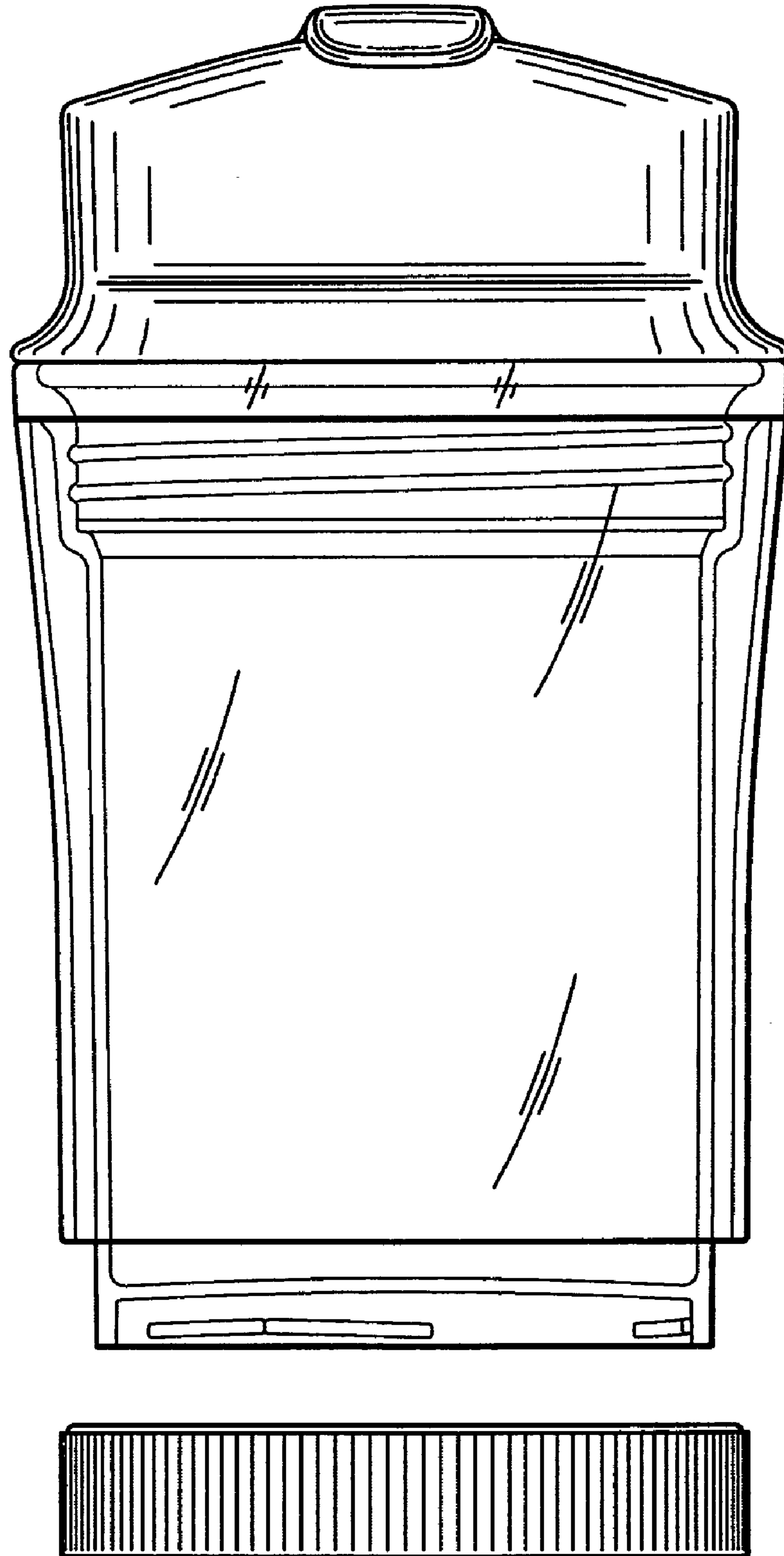

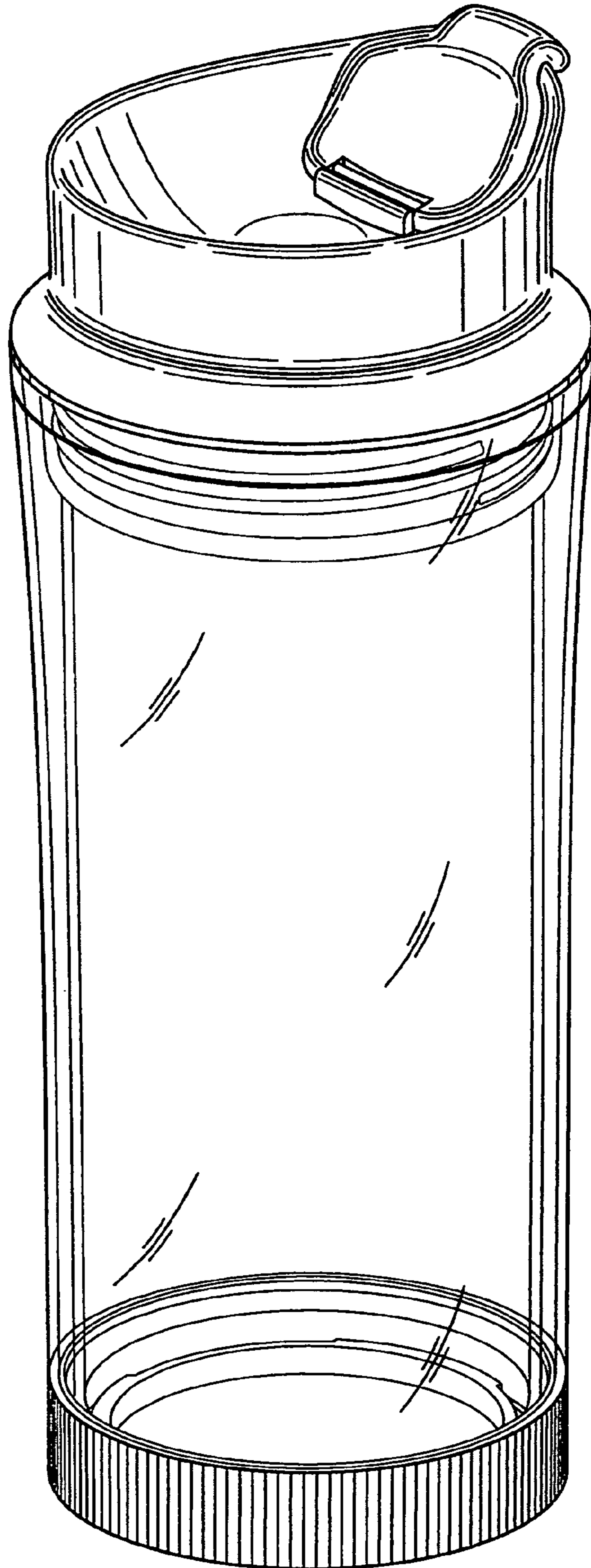

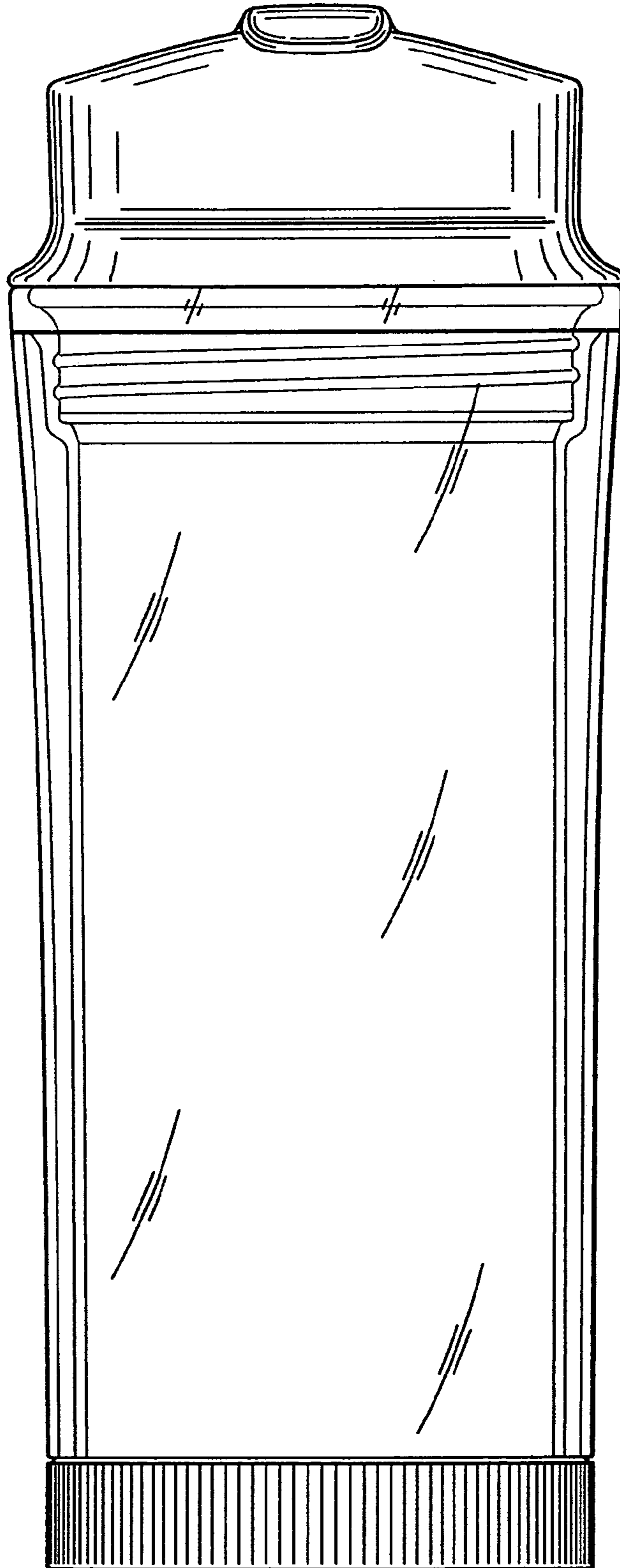

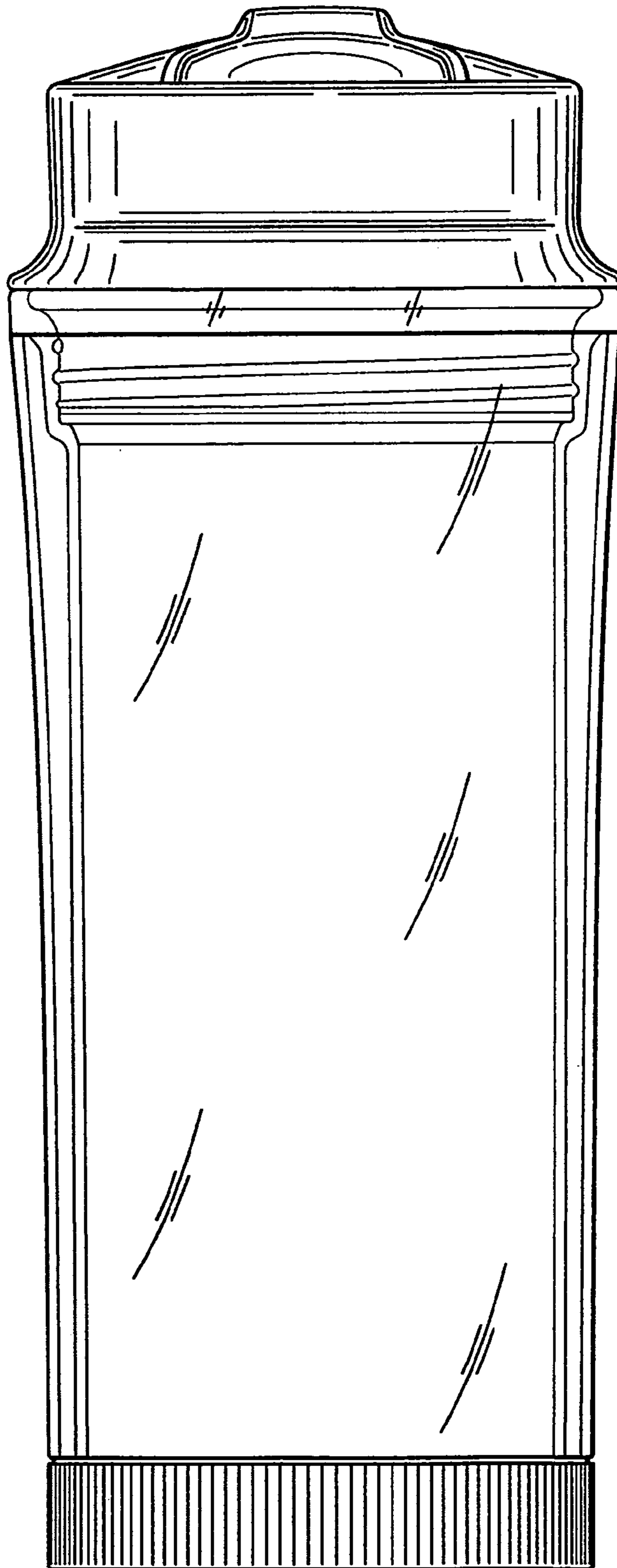

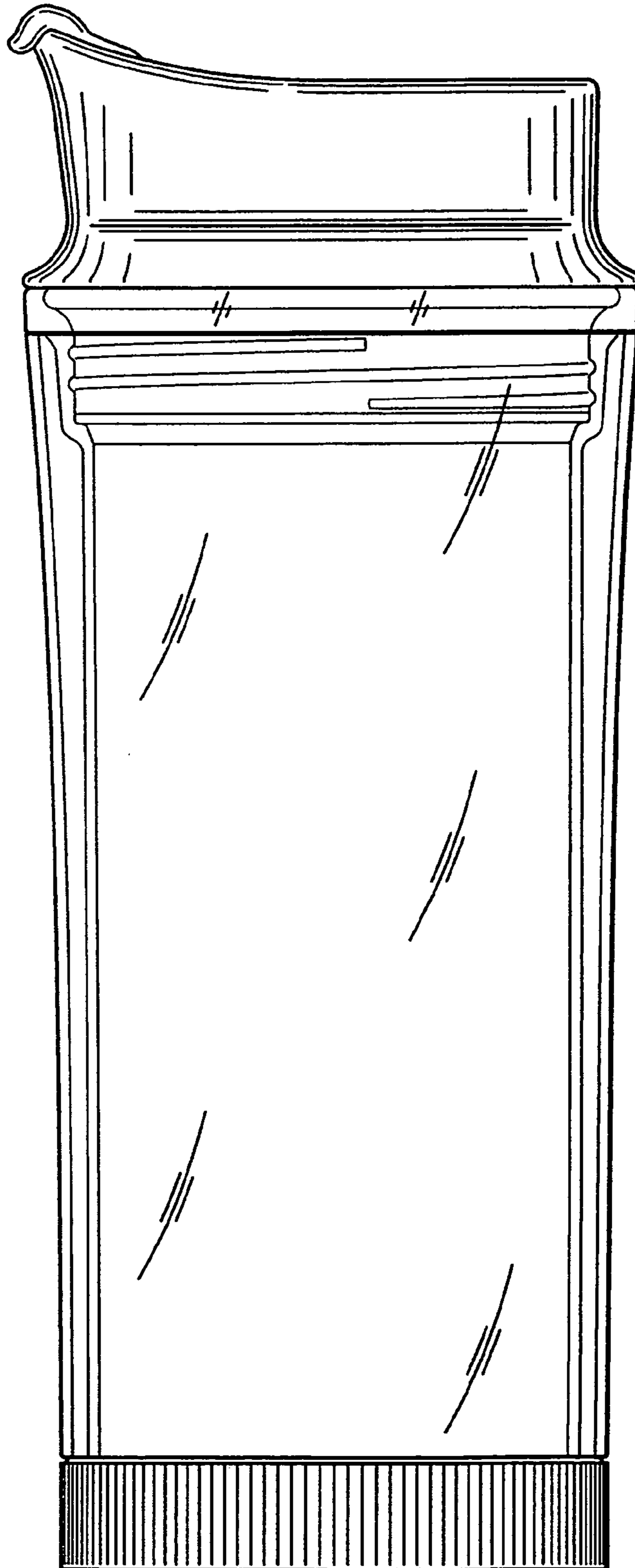

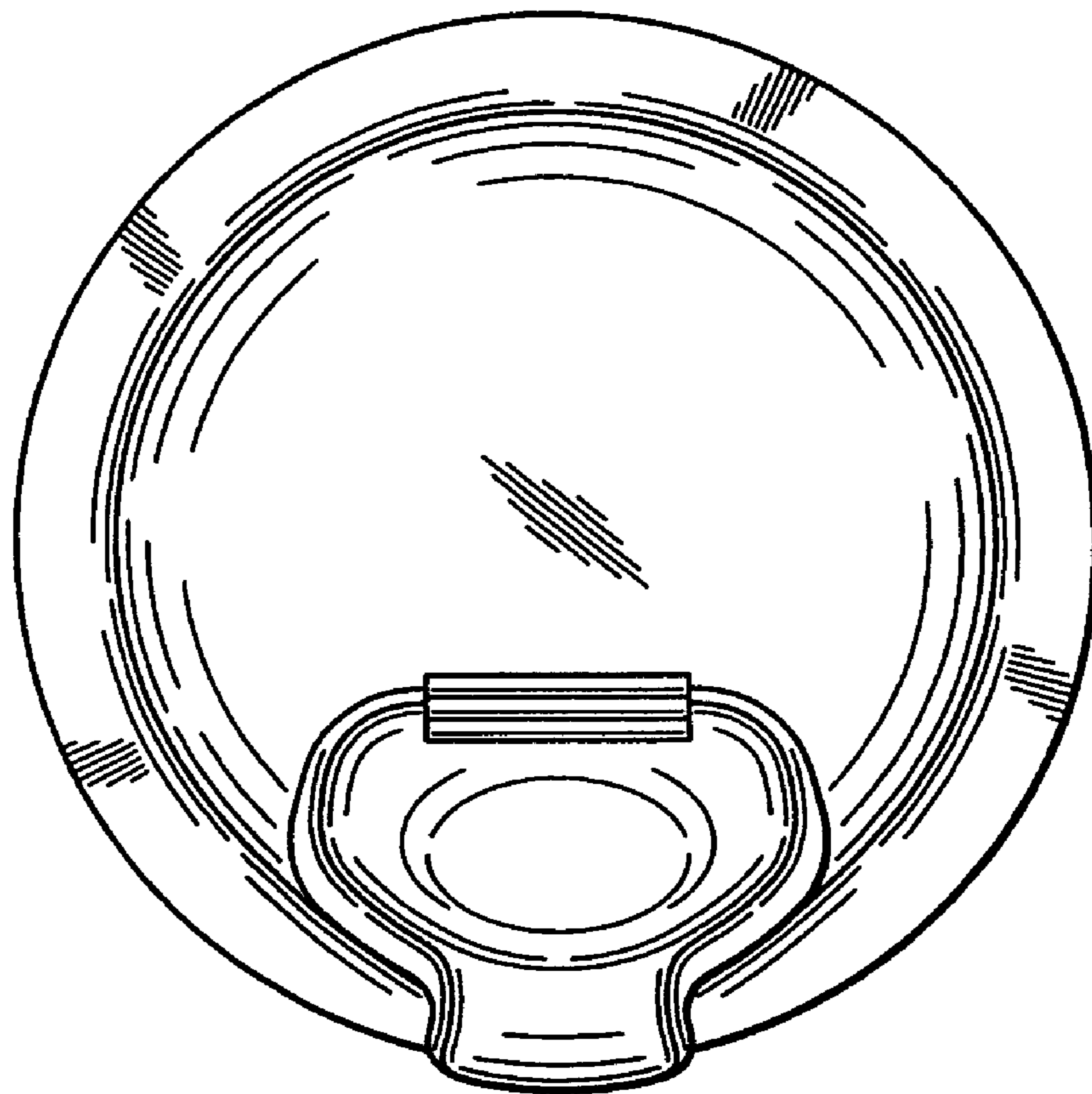

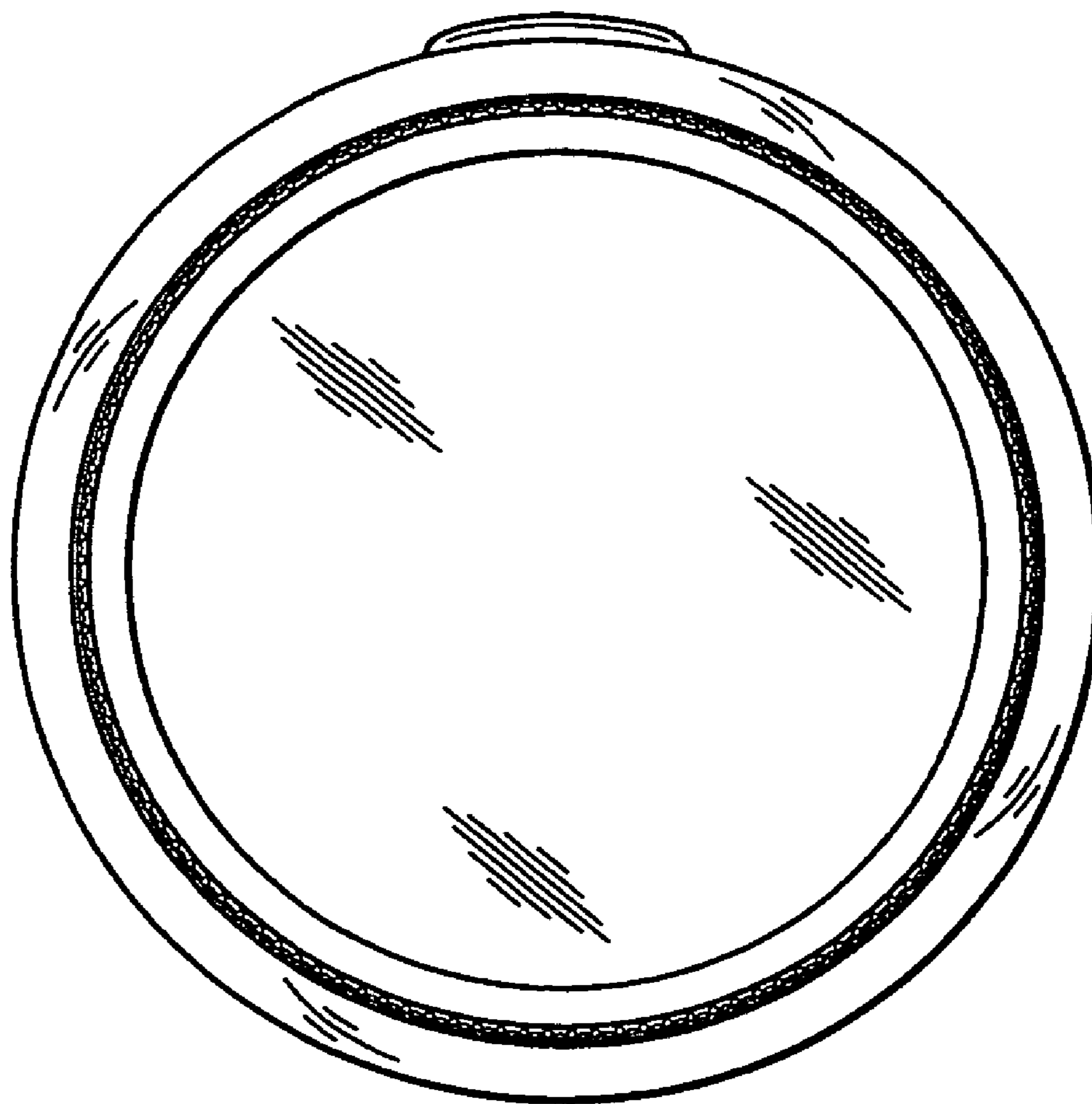
