The ornamental design for a cast resin coil with attaching bases, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of our new cast resin coil with attaching bases according to the invention;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is right-side elevational view thereof;

FIG. 6 is left-side elevational view thereof; and,

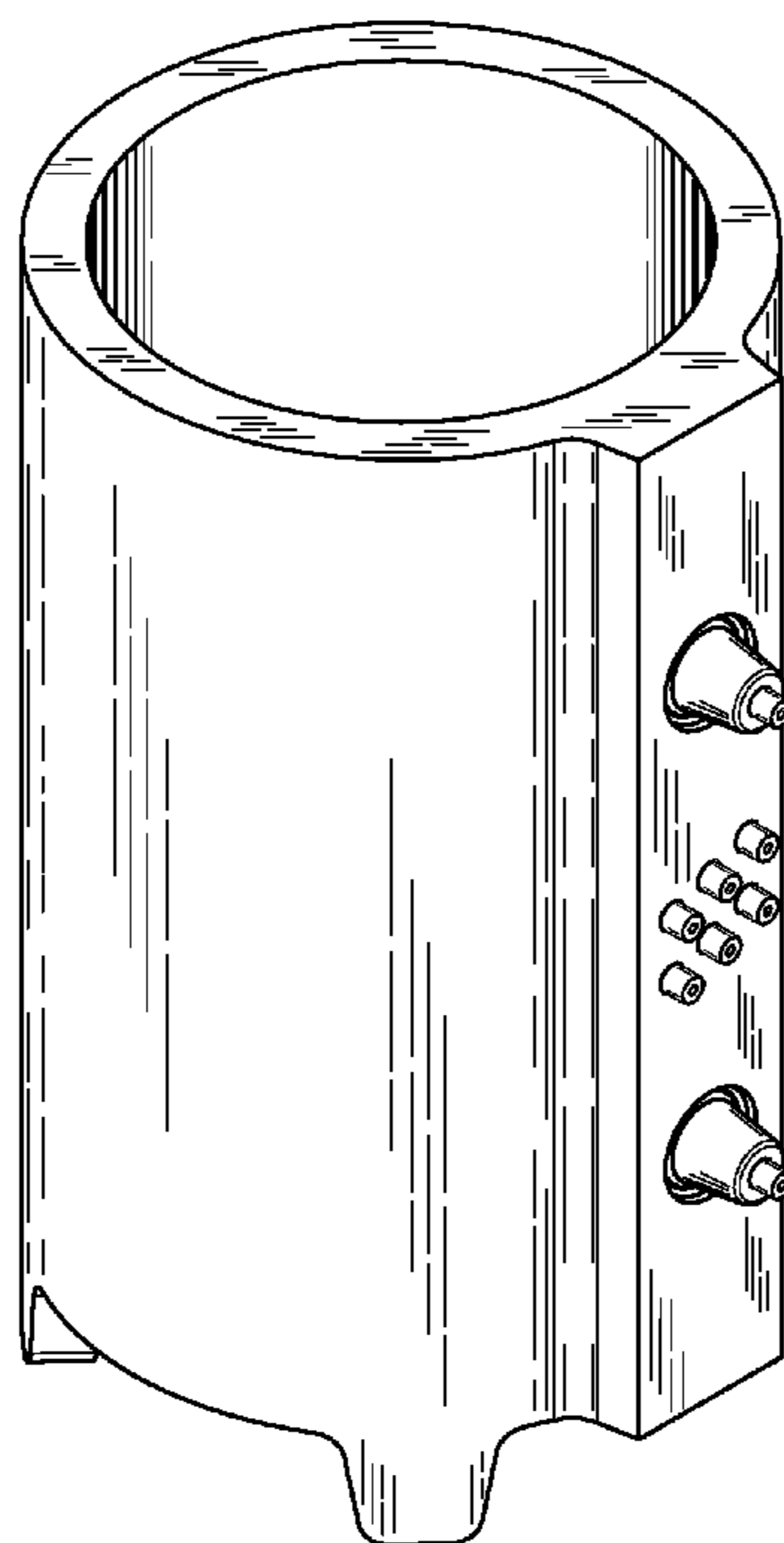

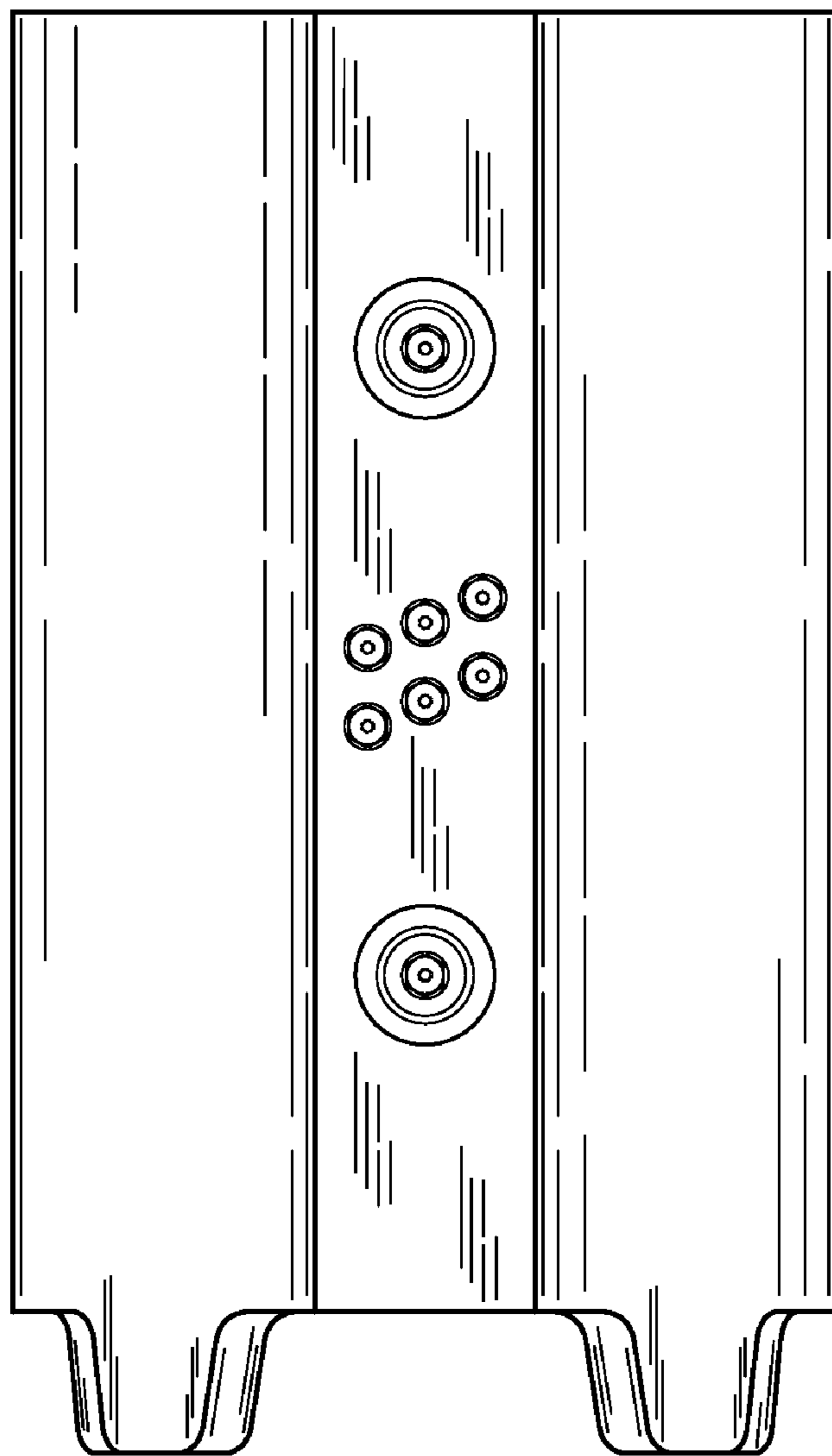

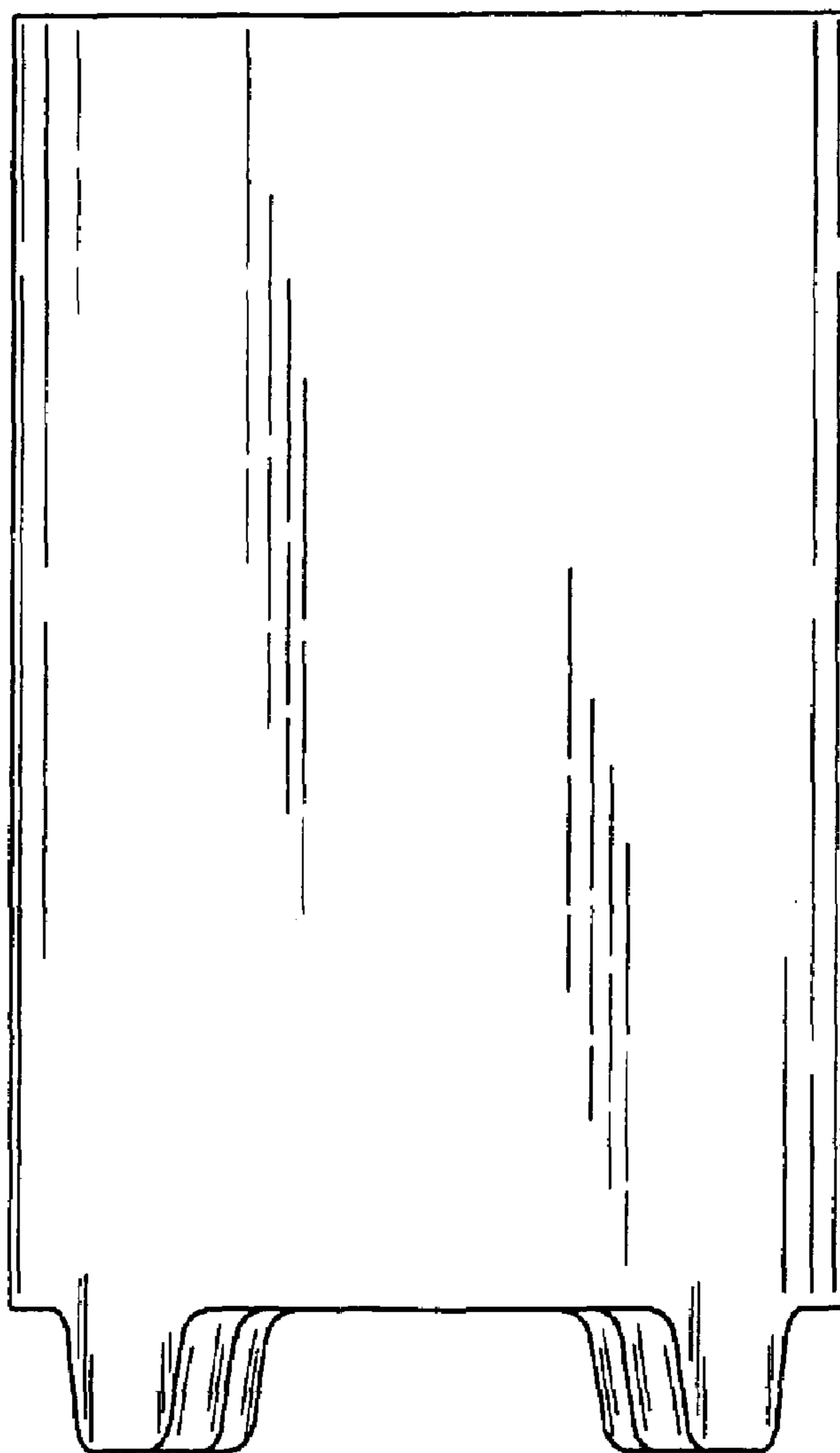

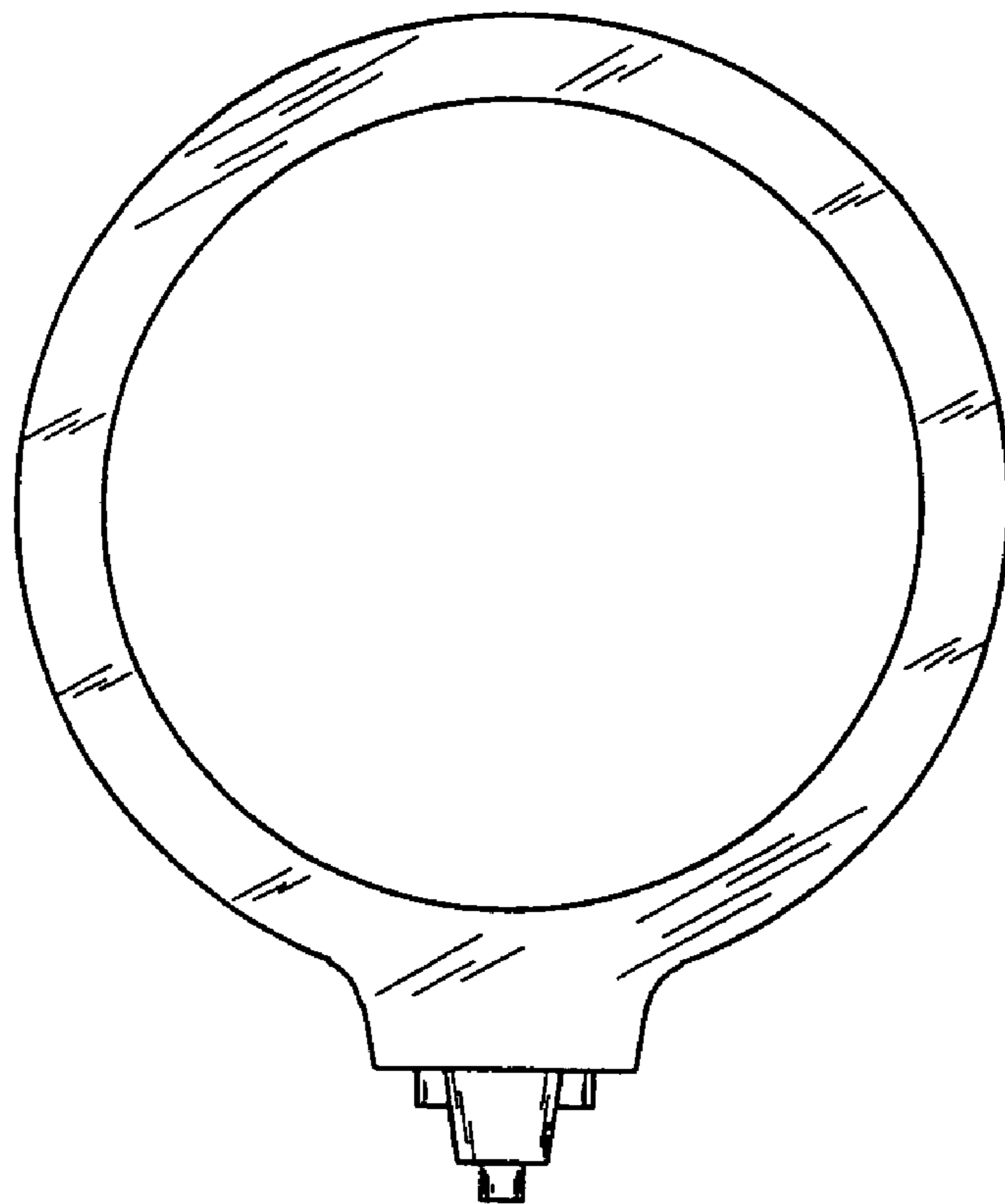

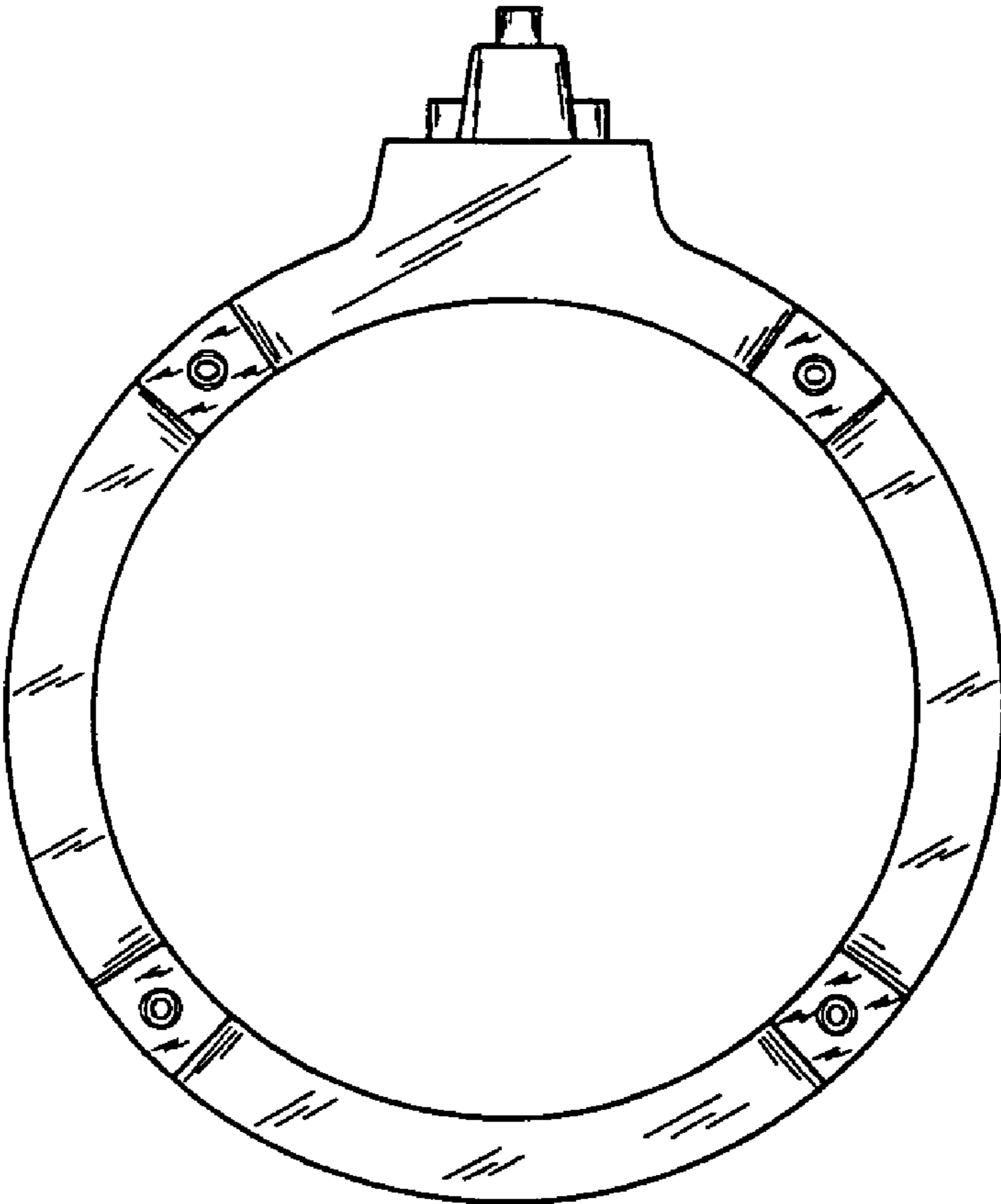

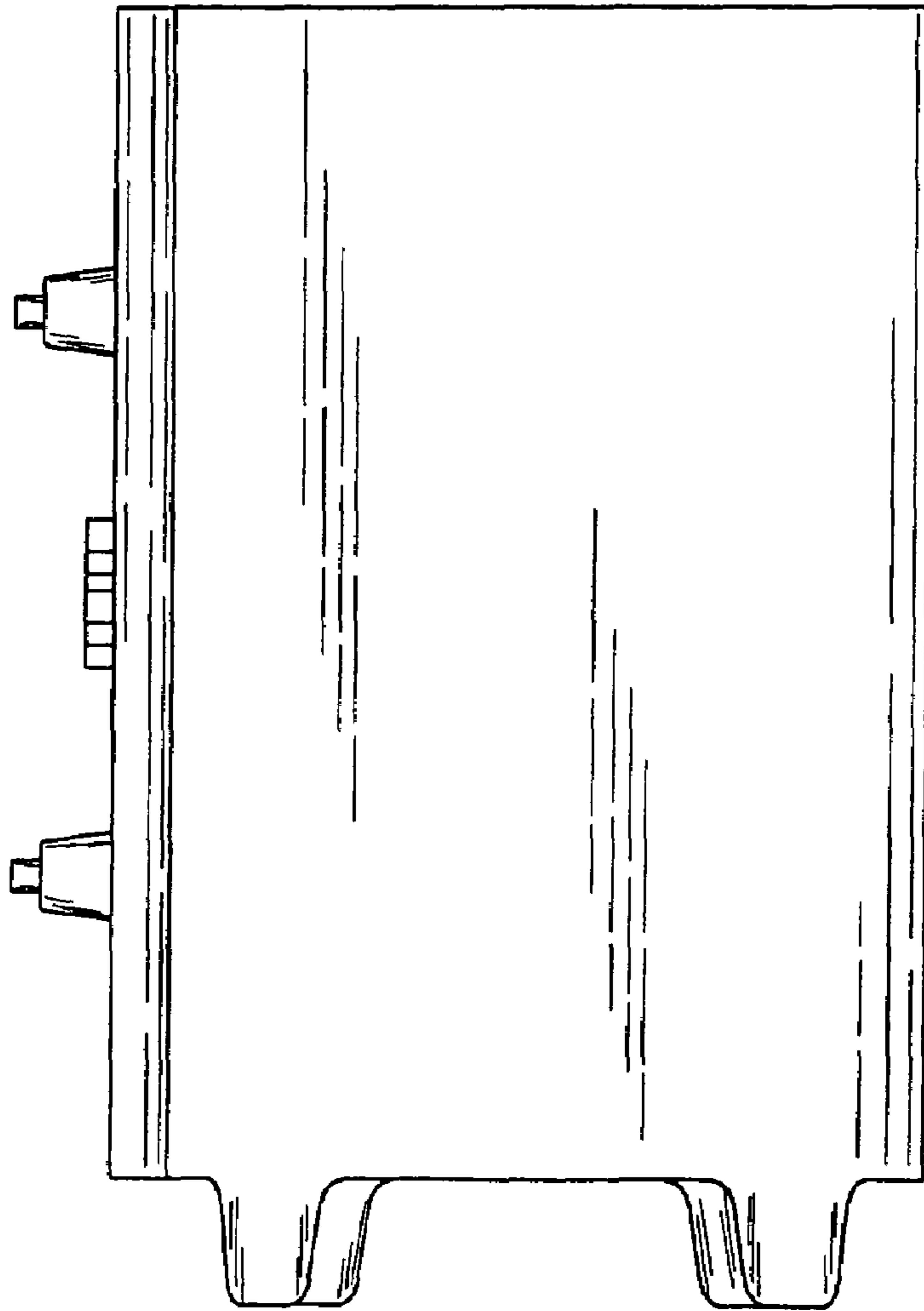

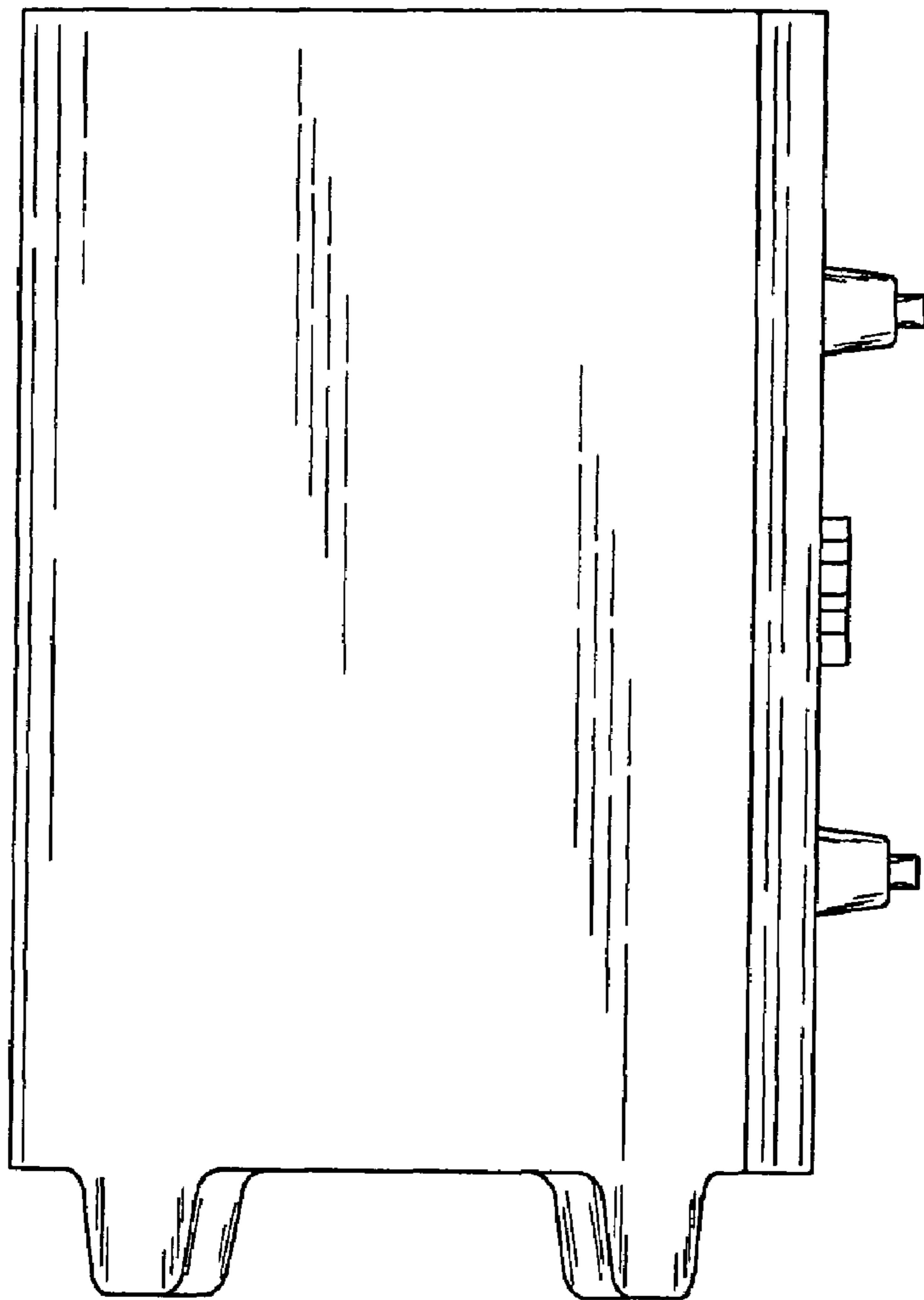
