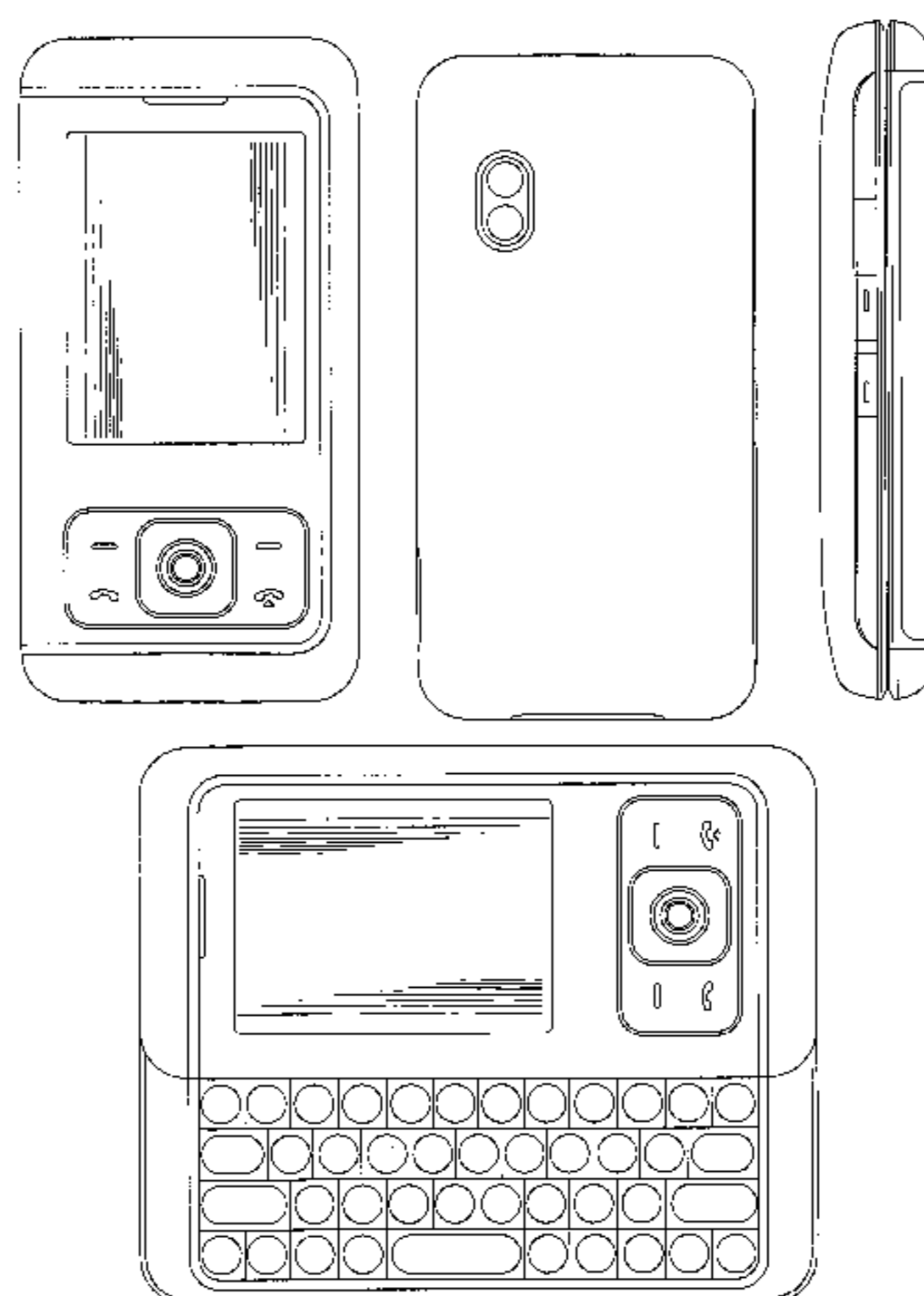
(57) **CLAIM**

The ornamental design for a portable phone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portable phone;
FIG. 2 is a front view of the portable phone of FIG. 1;
FIG. 3 is a rear view of the portable phone of FIG. 1;
FIG. 4 is a left-side view of the portable phone of FIG. 1;
FIG. 5 is a right-side view of the portable phone of FIG. 1;
FIG. 6 is a top plan view of the portable phone of FIG. 1;
FIG. 7 is a bottom plan view of the portable phone of FIG. 1; and,
FIG. 8 is an open side view of the portable phone of FIG. 1, where the display is slid vertically.

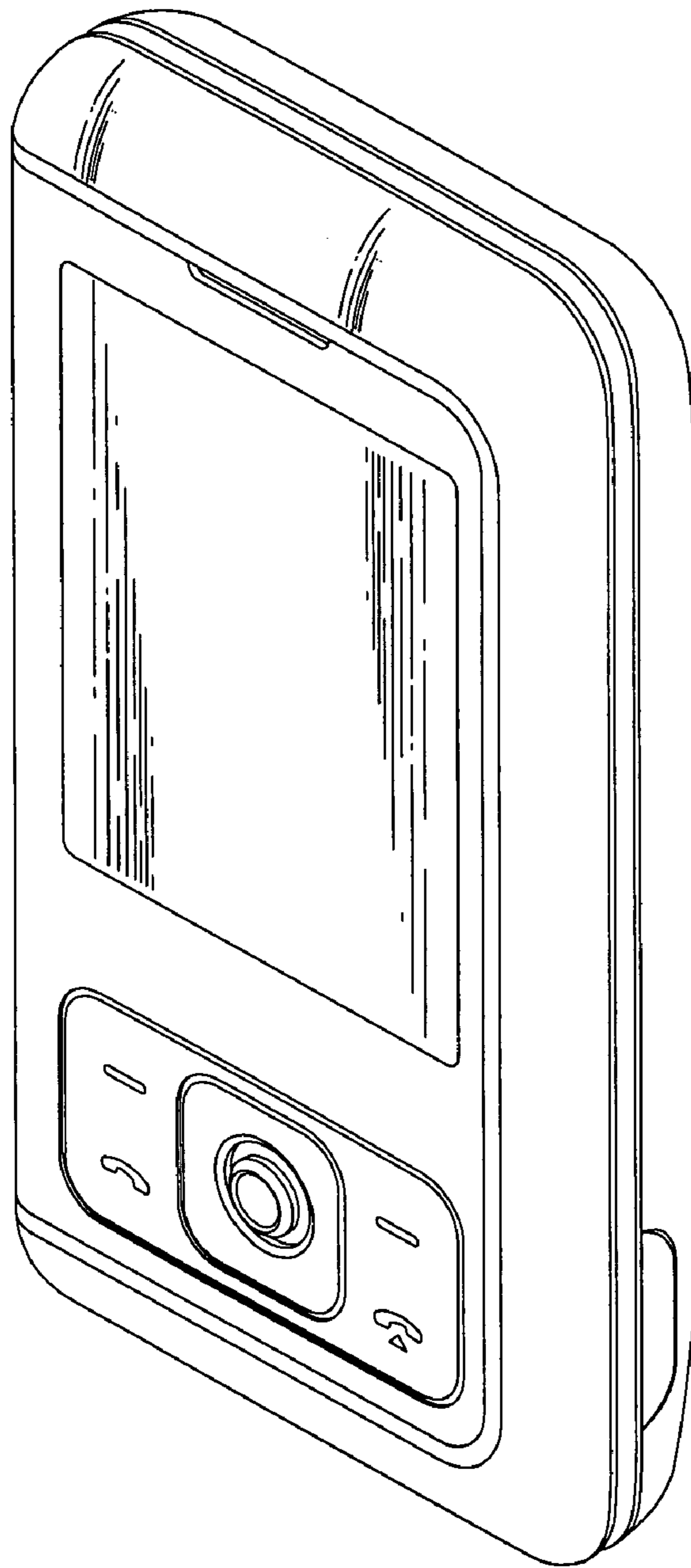

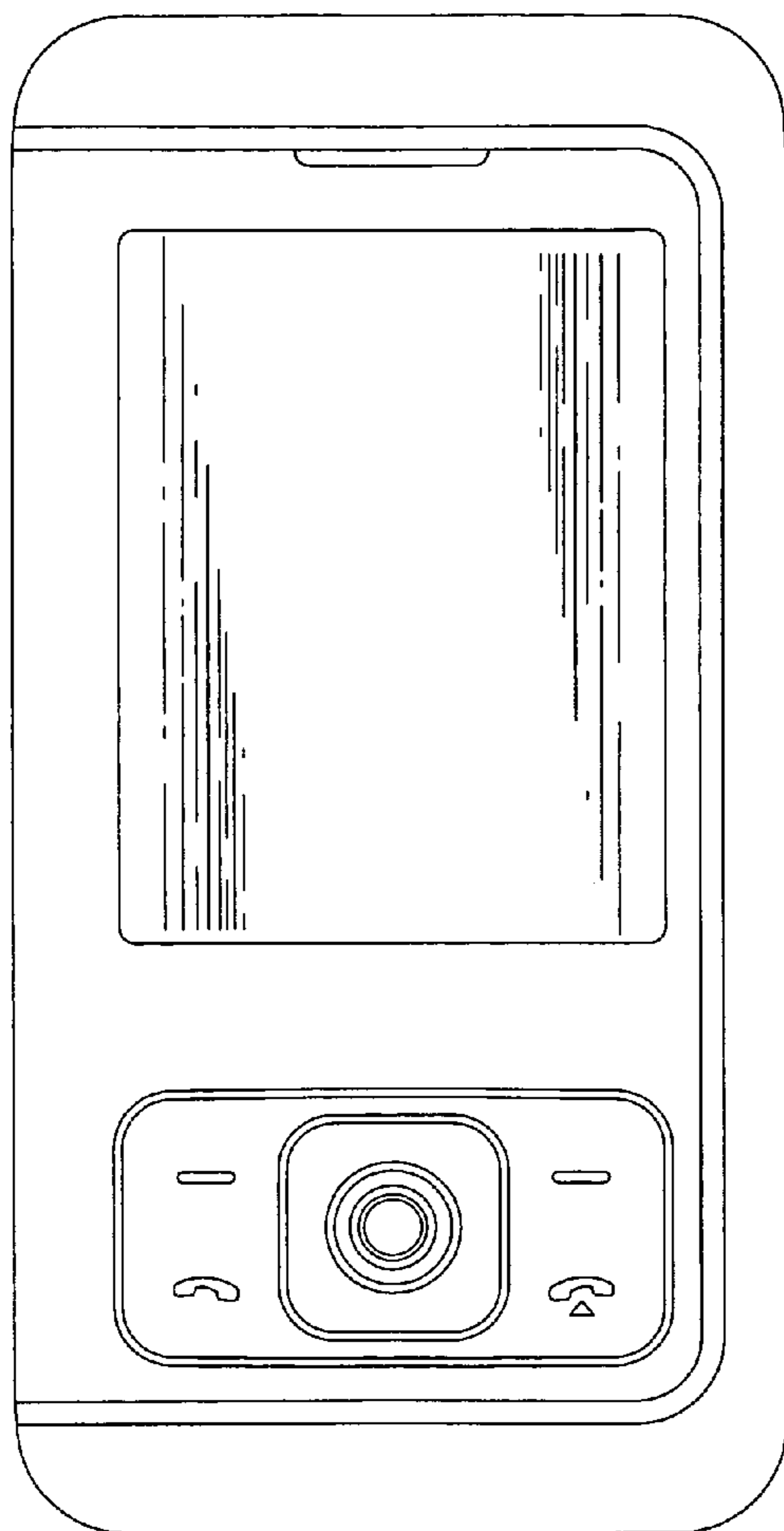

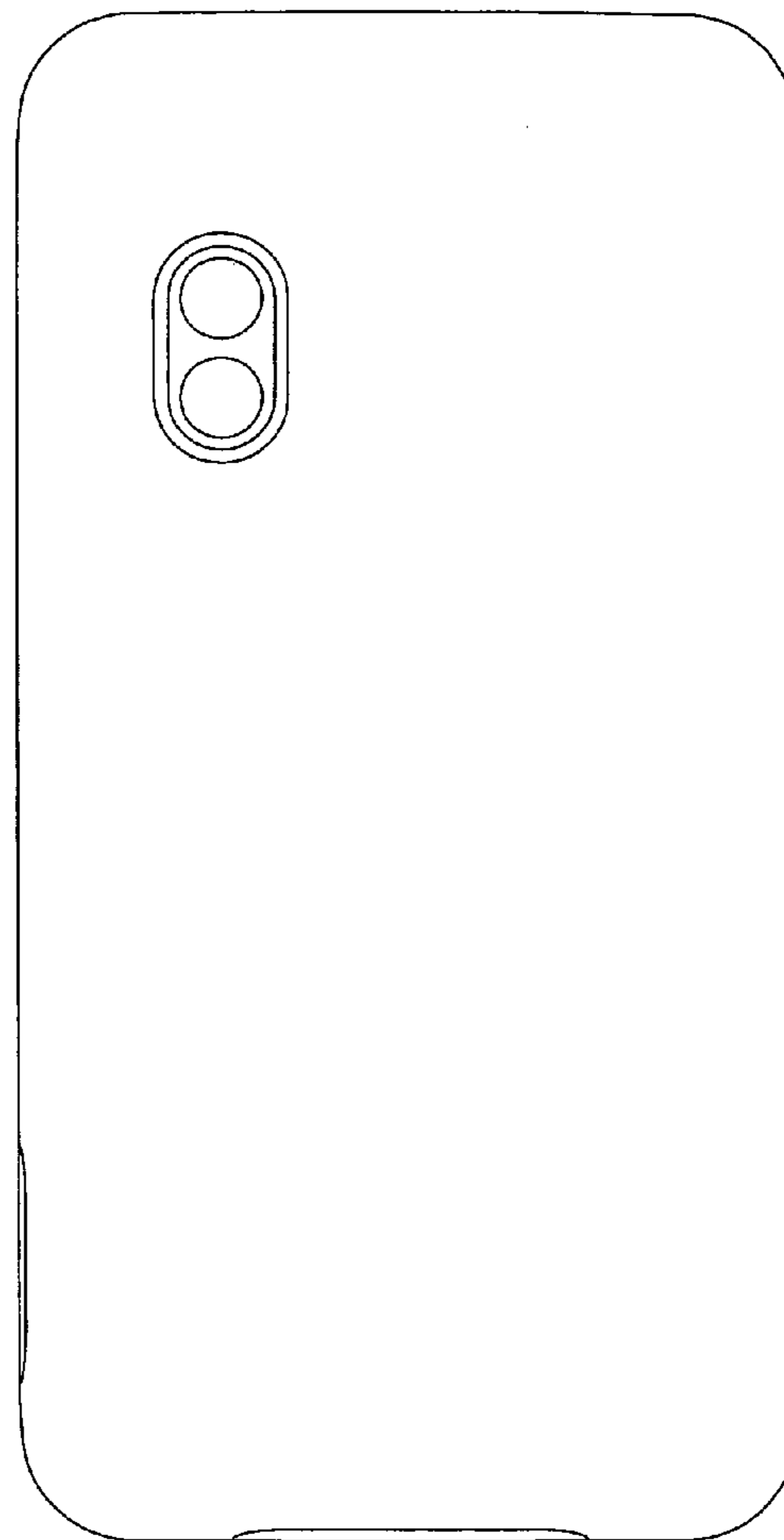

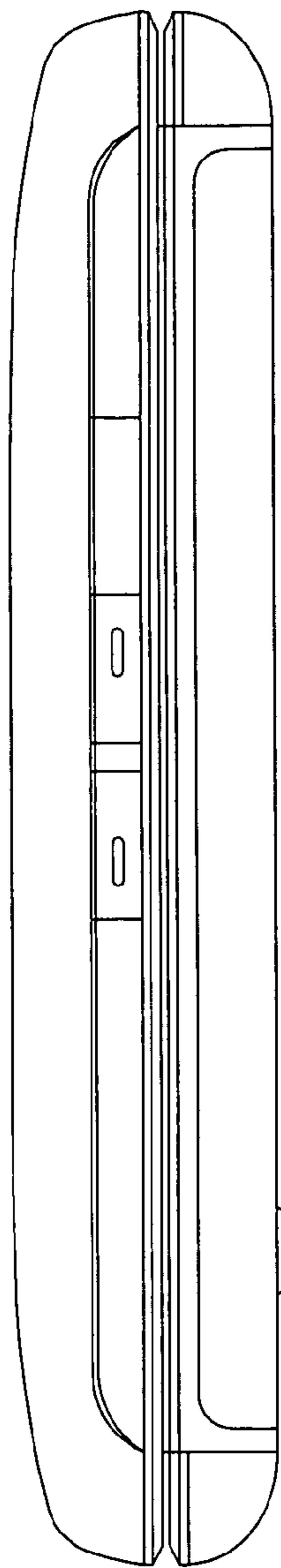

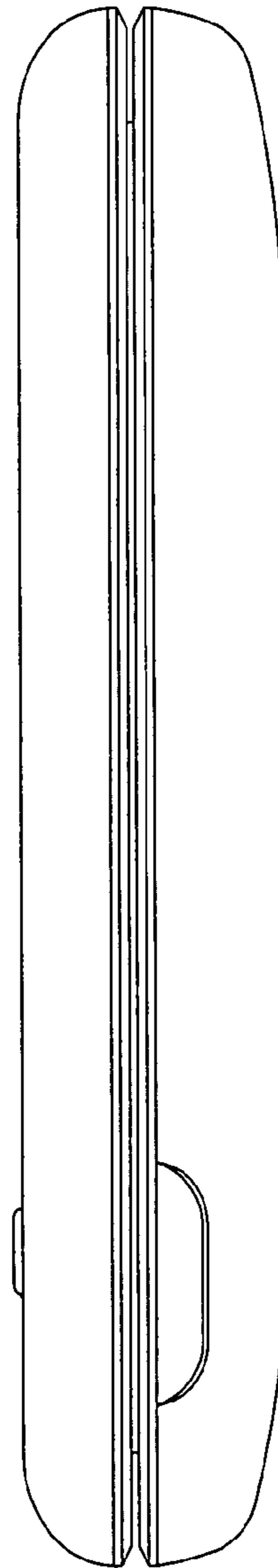

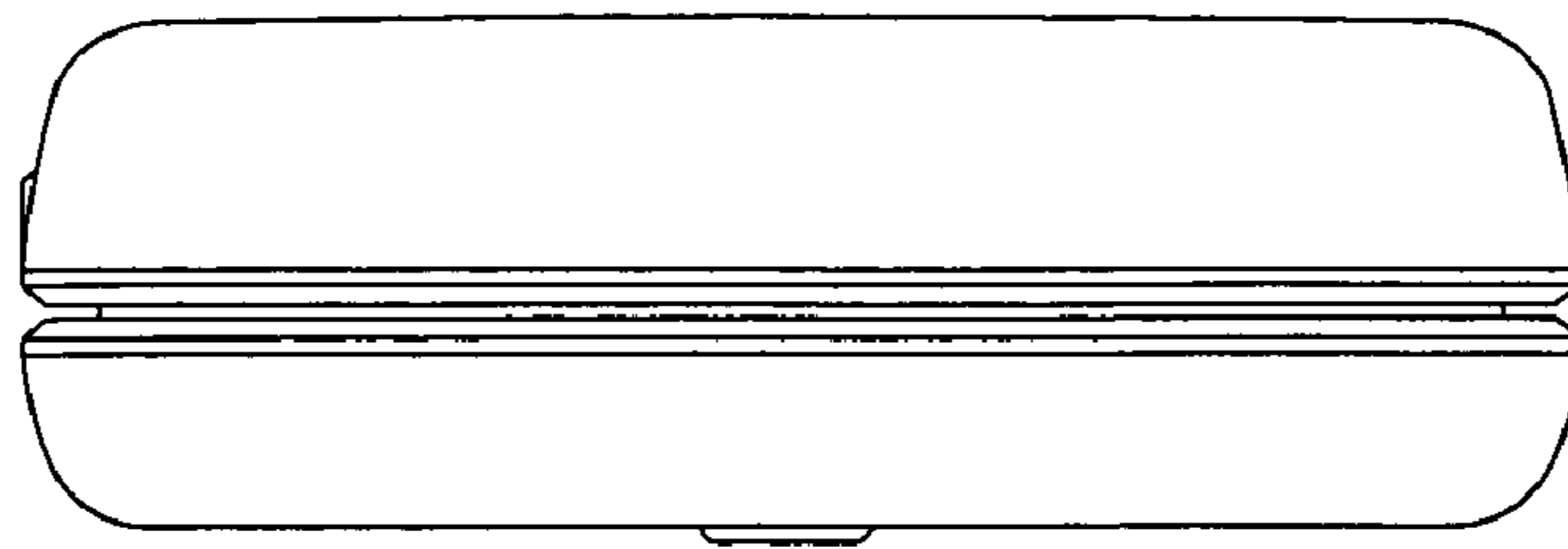

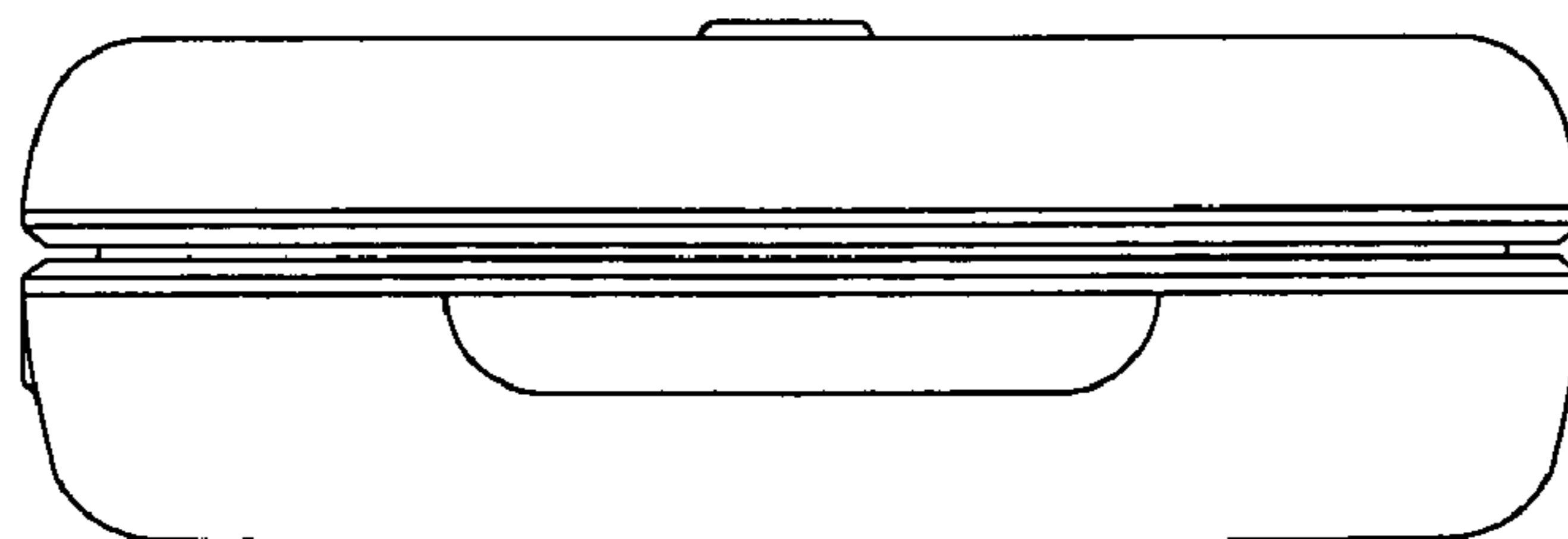
