FIG. 2 is a front elevational view thereof, the rear elevational view is a mirror image thereof;

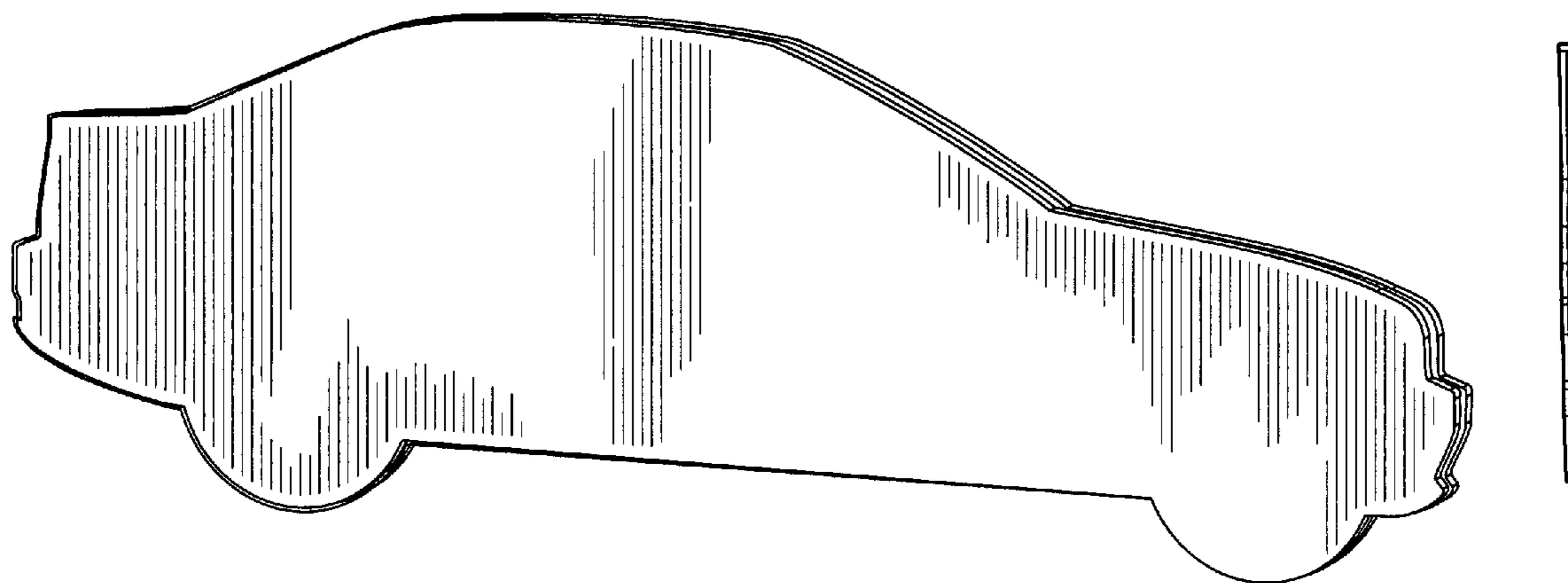
FIG. 3 is a left-side elevational view thereof;

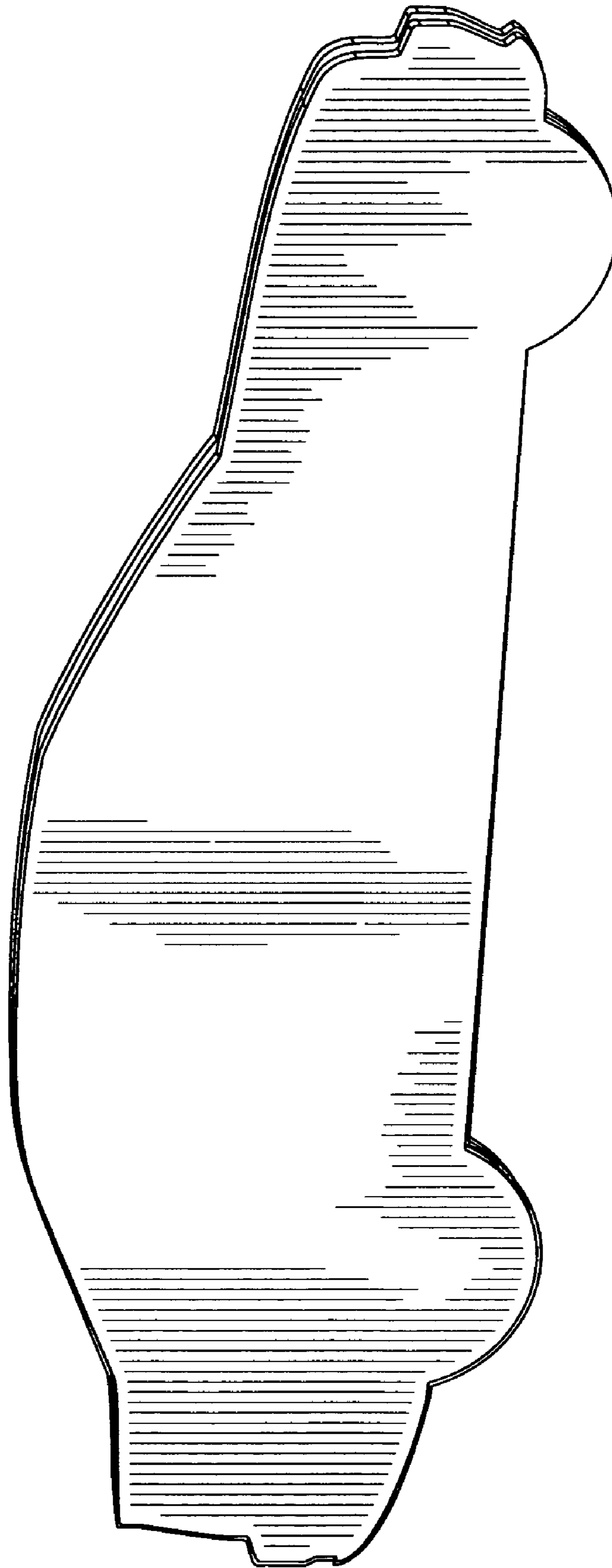

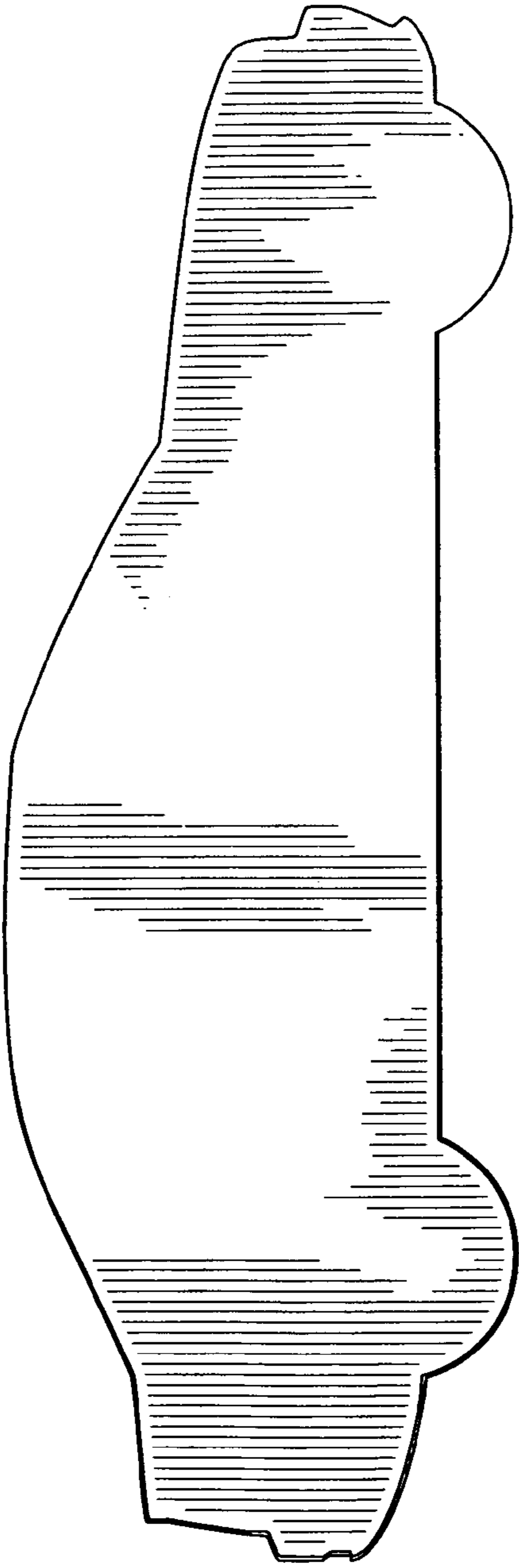
