FIG. 1 is a top perspective view of a badge for a golf club head;

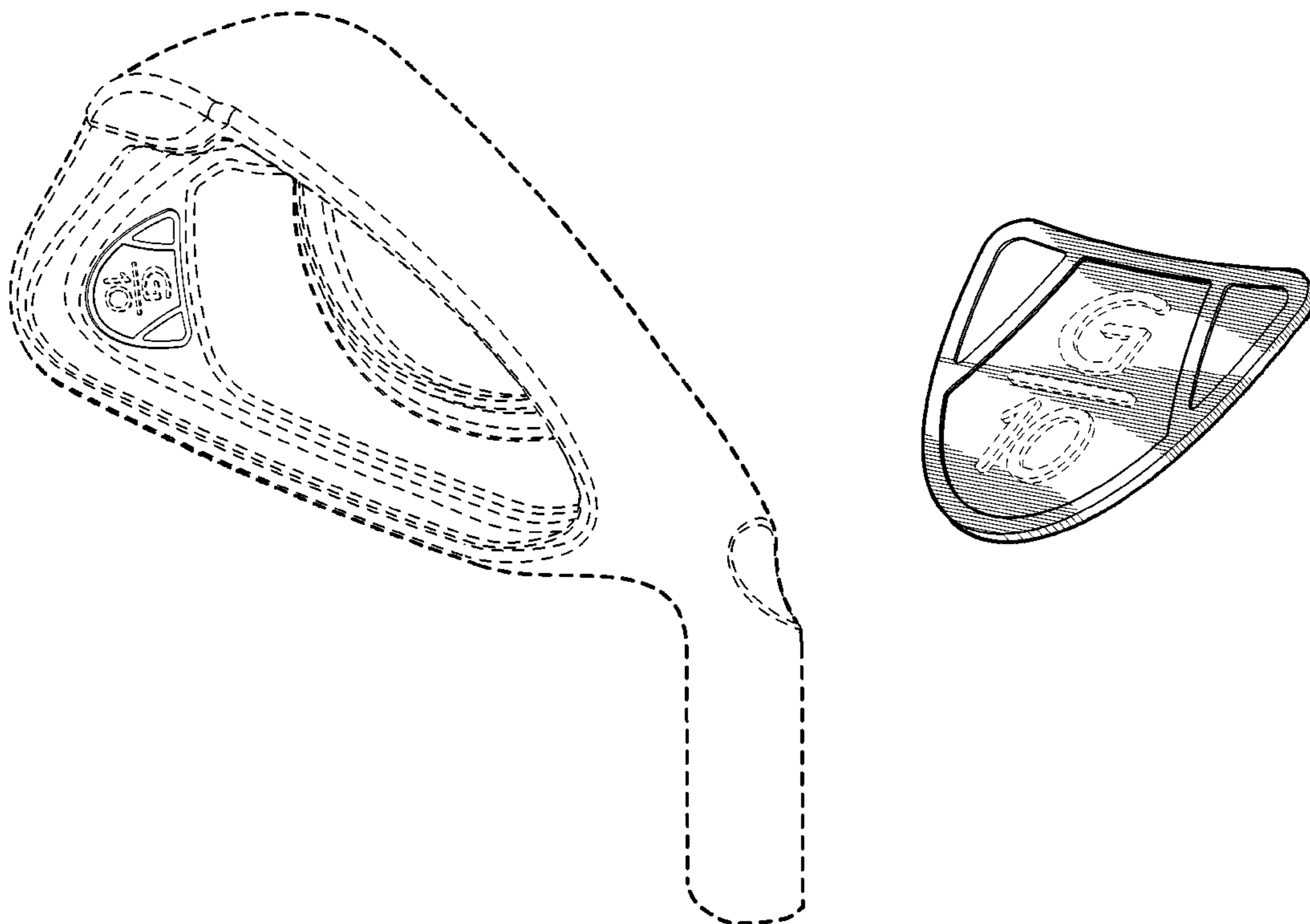
FIG. 2 is a front elevational view of the badge of FIG. 1;

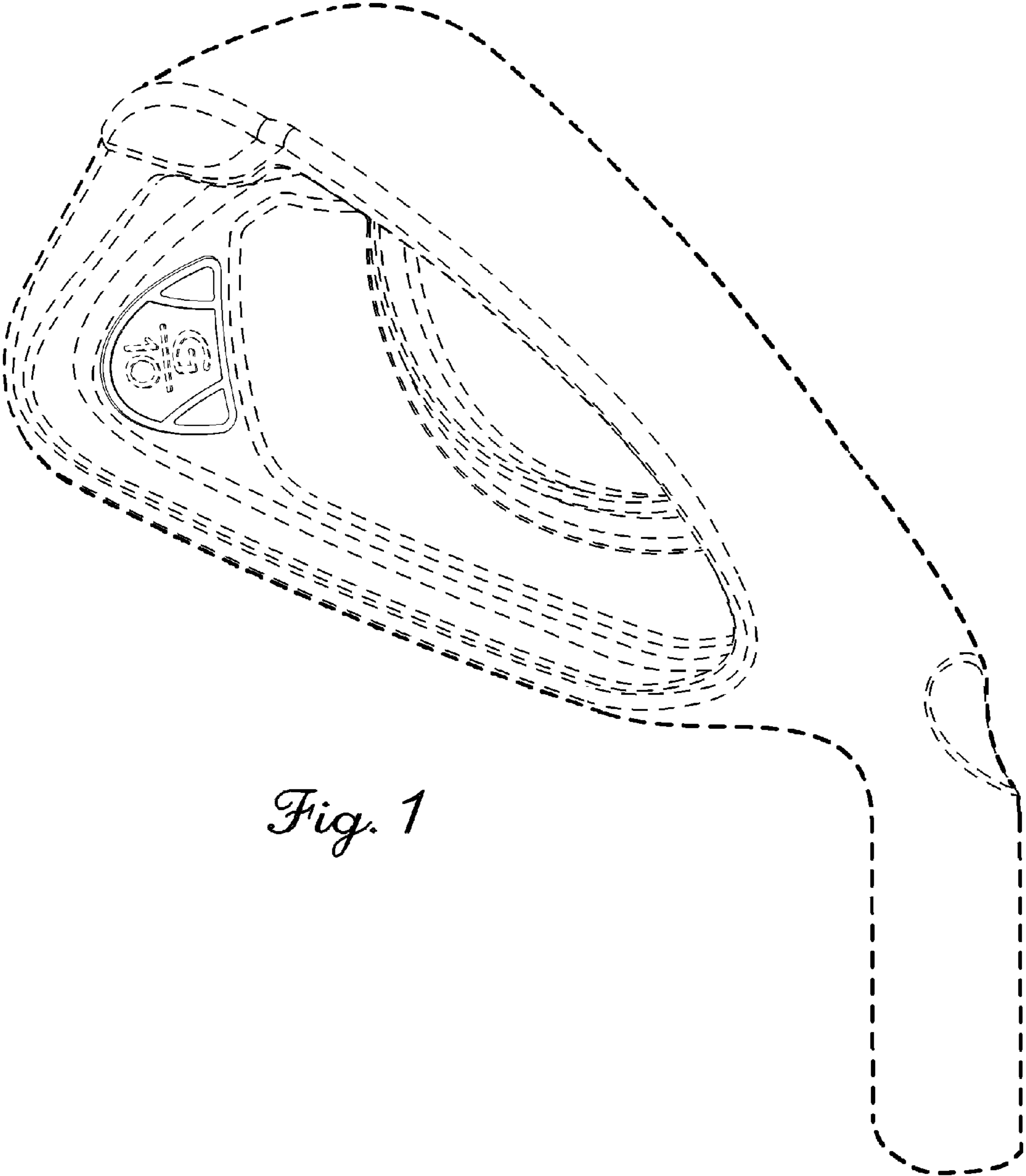
FIG. 3 is an enlarged front view of the badge of FIG. 1, shown for clarity if illustration; and,

FIG. 4 is a top perspective view of the badge of FIG. 3.

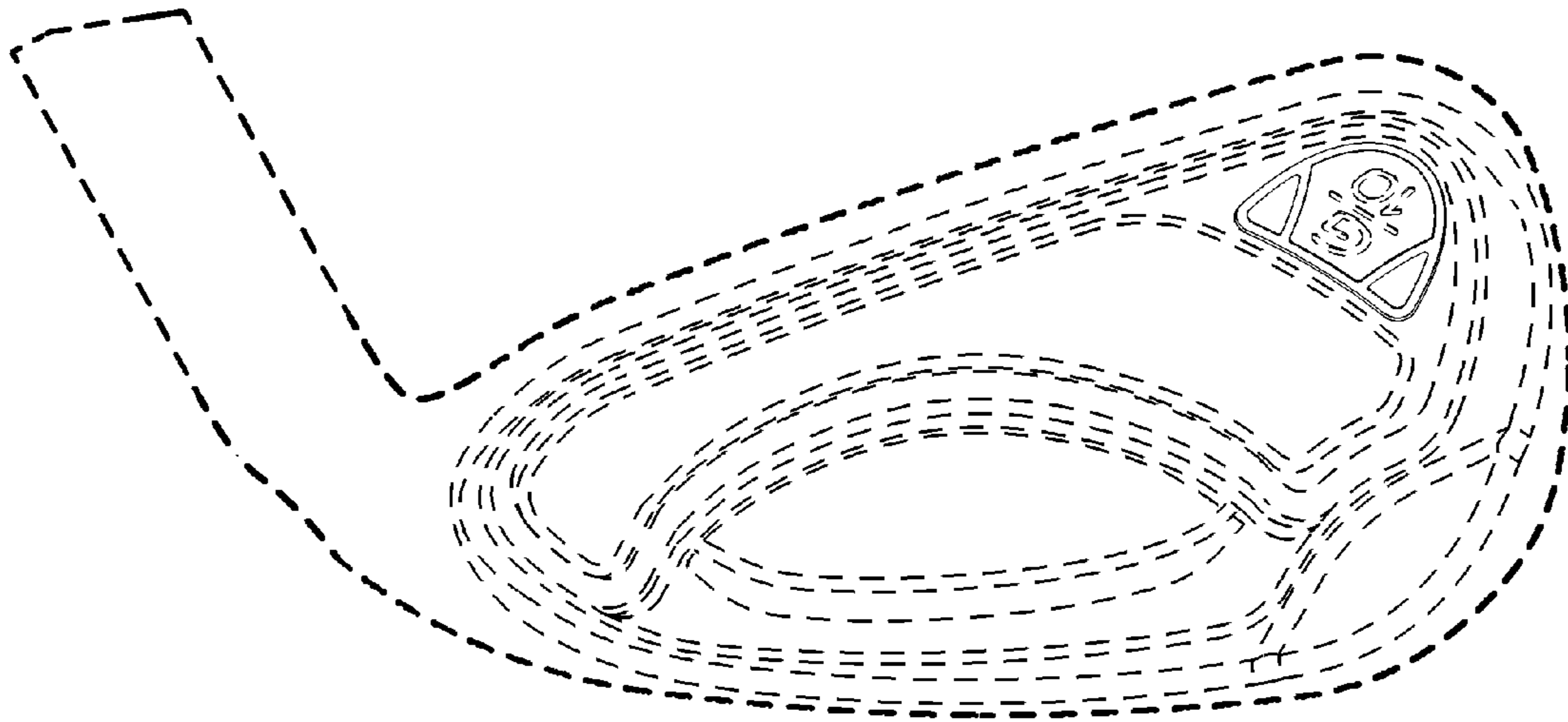
The broken lines shown in FIGS. 1, 2, 3, and 4 are for illustrative purposes only and form no part of the claimed design.

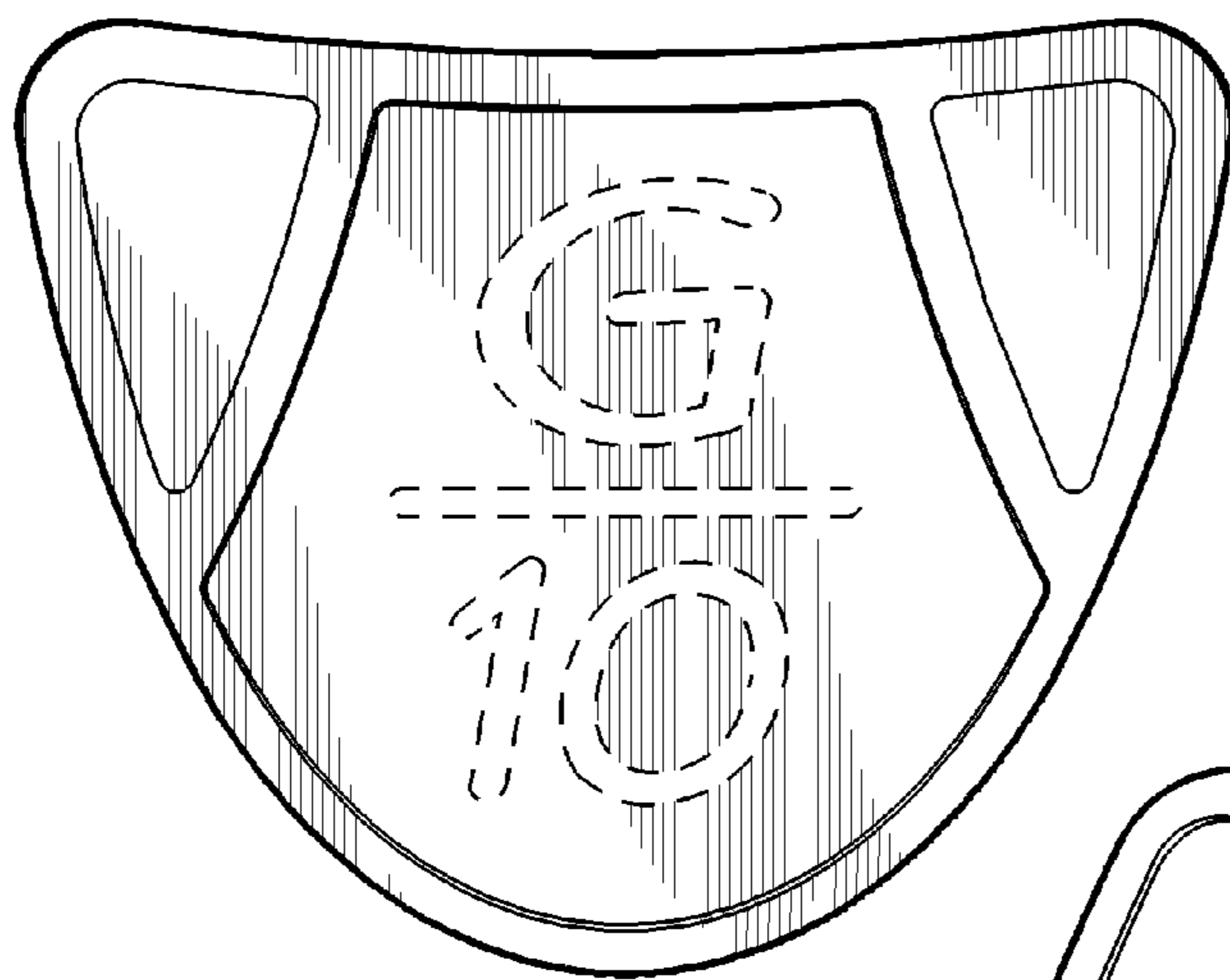




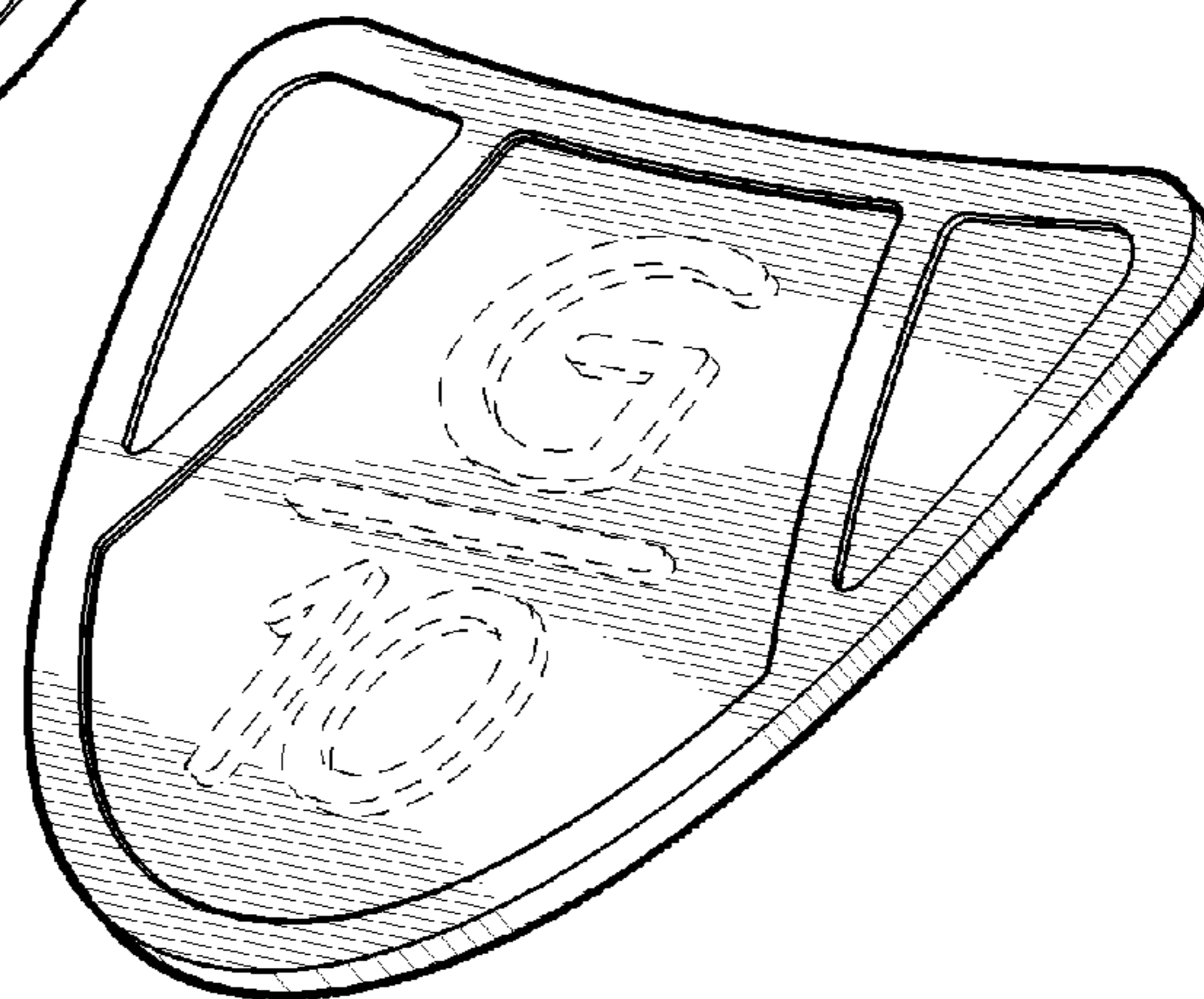
