The ornamental design for a golf club head for a putter, as shown and described.

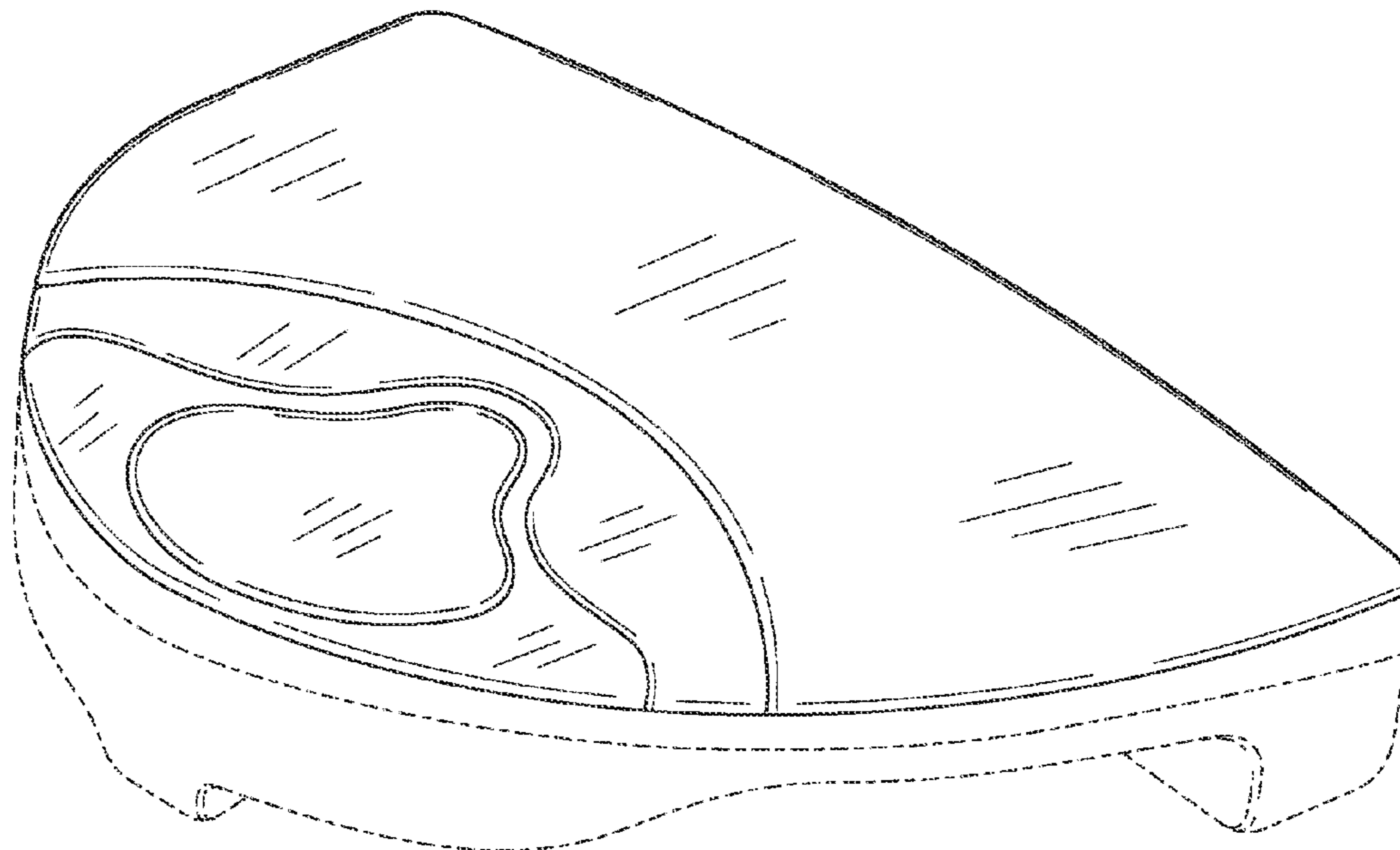
DESCRIPTION

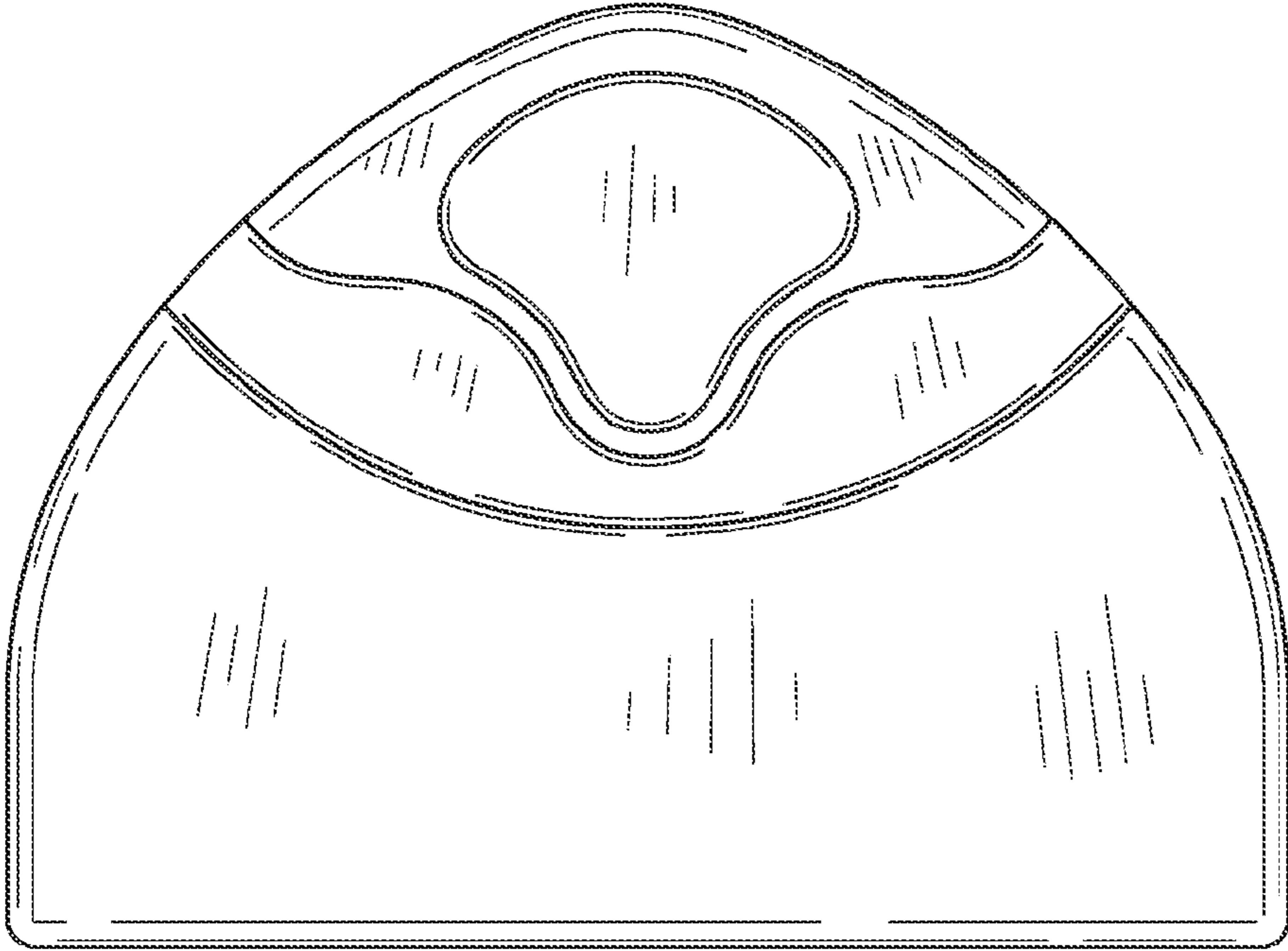

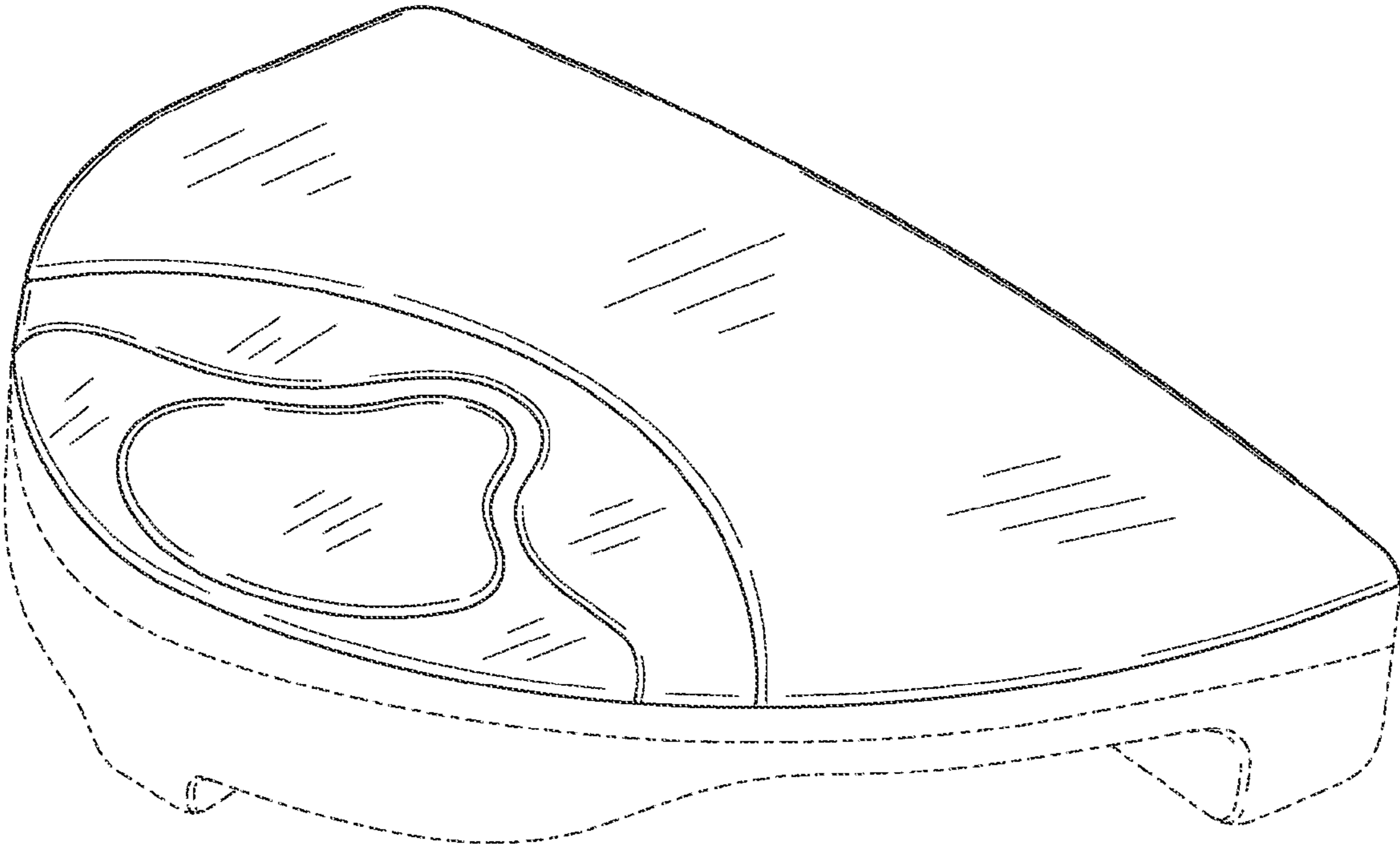
