(57) **CLAIM**

The ornamental design for a ceiling fan component, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from below of a ceiling fan component in accordance with my design;

FIG. 2 is a reduced top plan view of the ceiling fan component in accordance with my design;

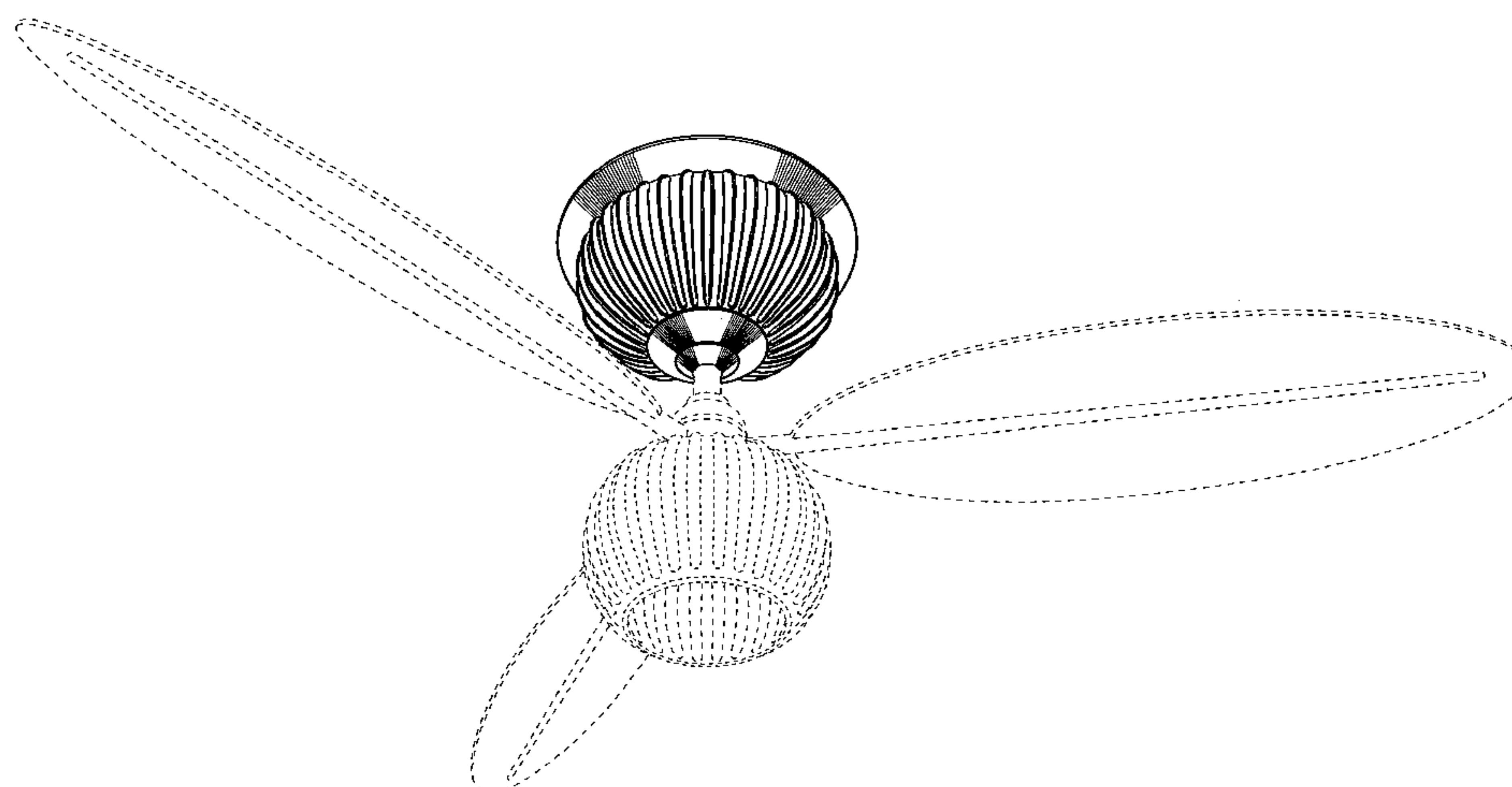
FIG. 3 is a reduced bottom plan view of the ceiling fan component in accordance with my design; and,

FIG. 4 is a side elevation view of the ceiling fan component in accordance with my design, all side views being mirror images thereof.

The broken lines showing environmental structure are for illustrative purposes and form no part of the claimed design.

The broken line showing of the support rod, blades and light fixture is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

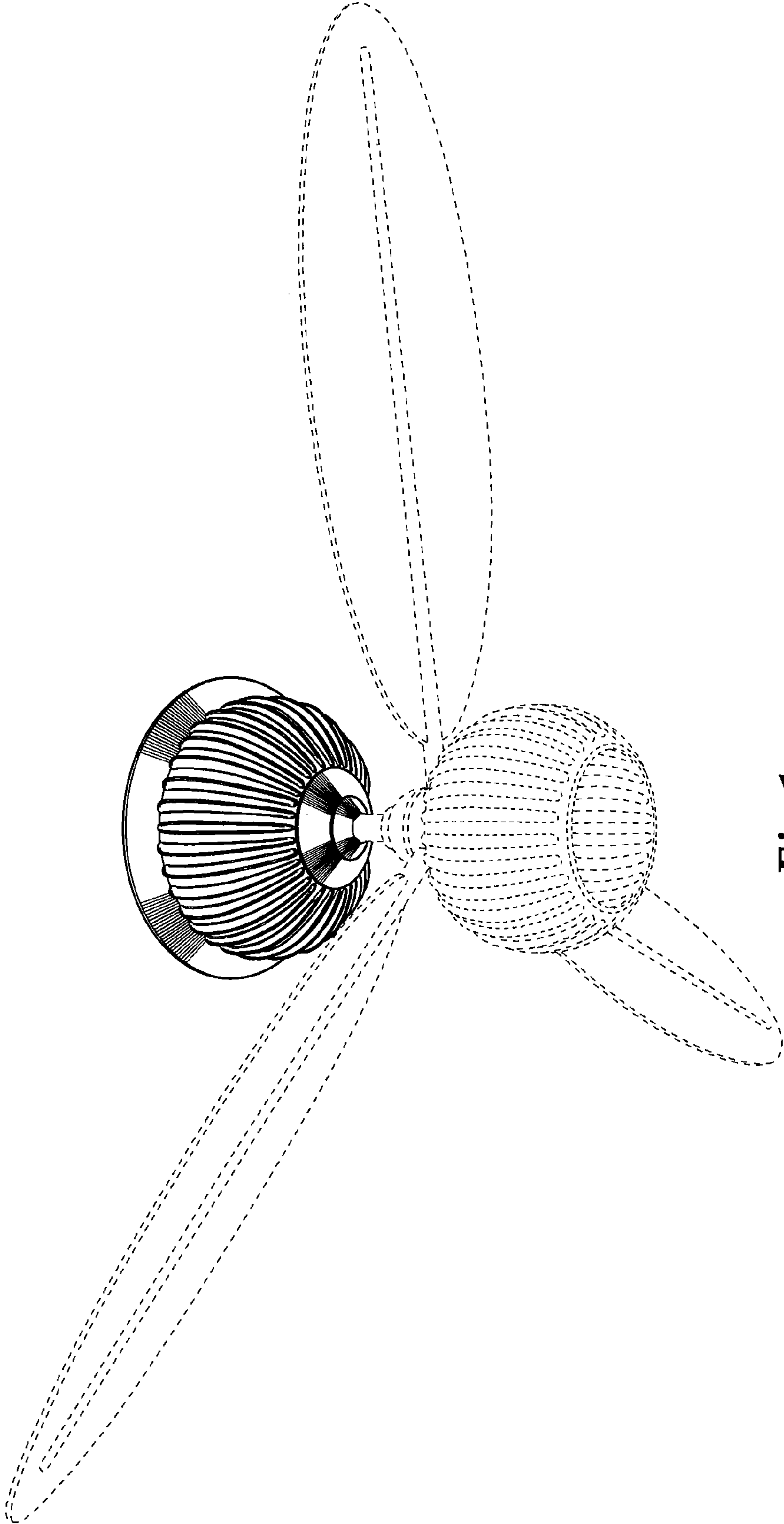

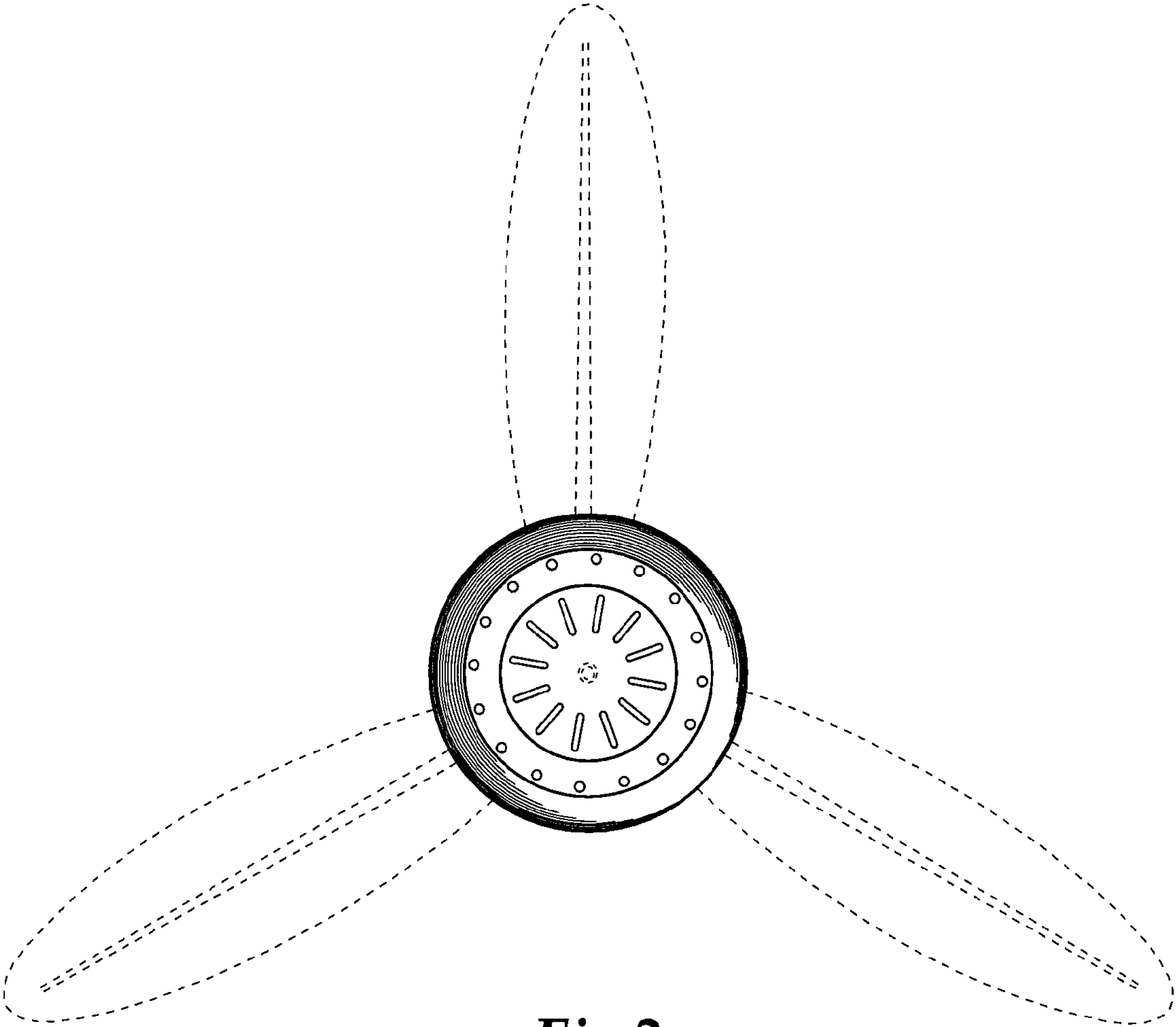

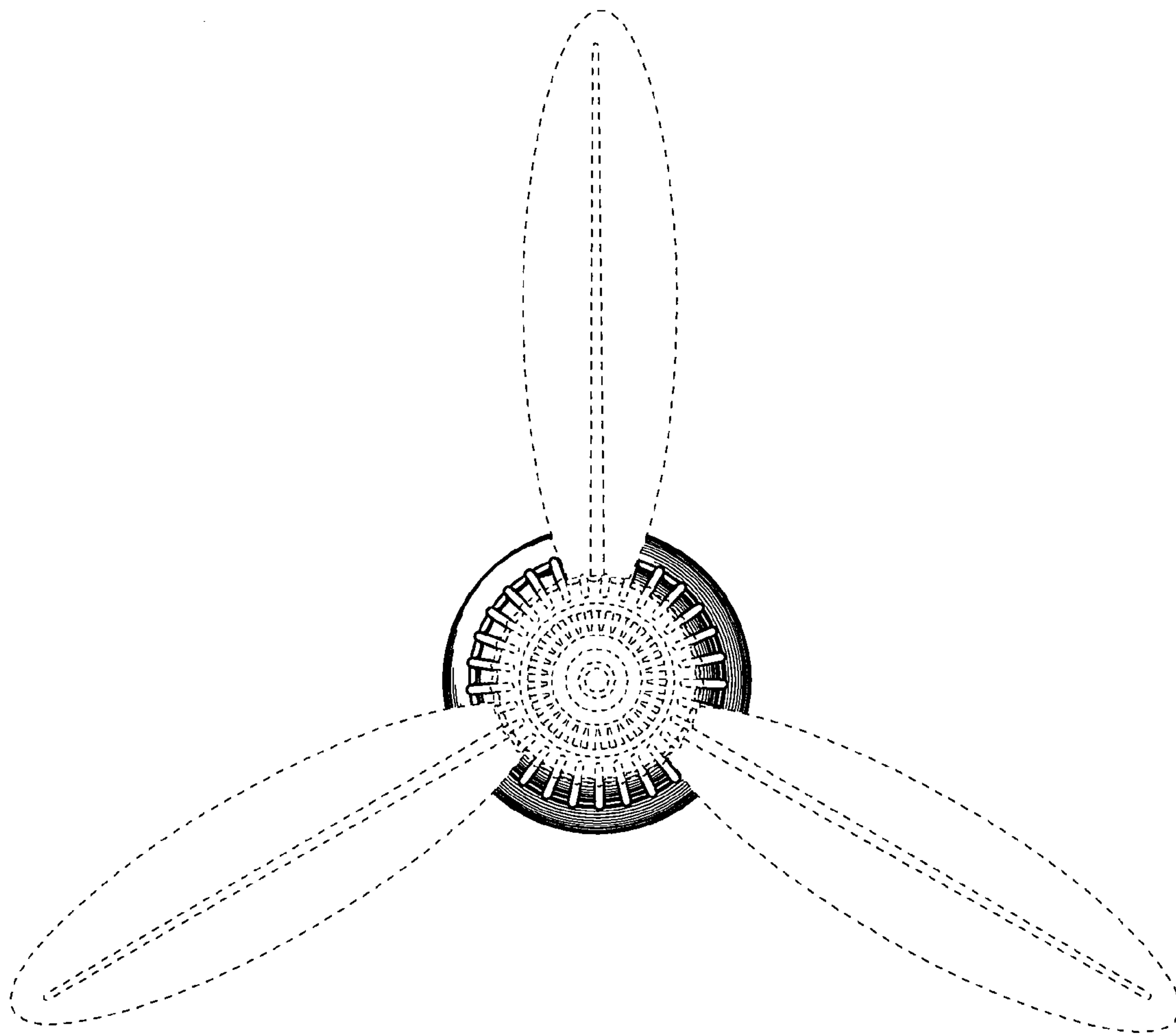

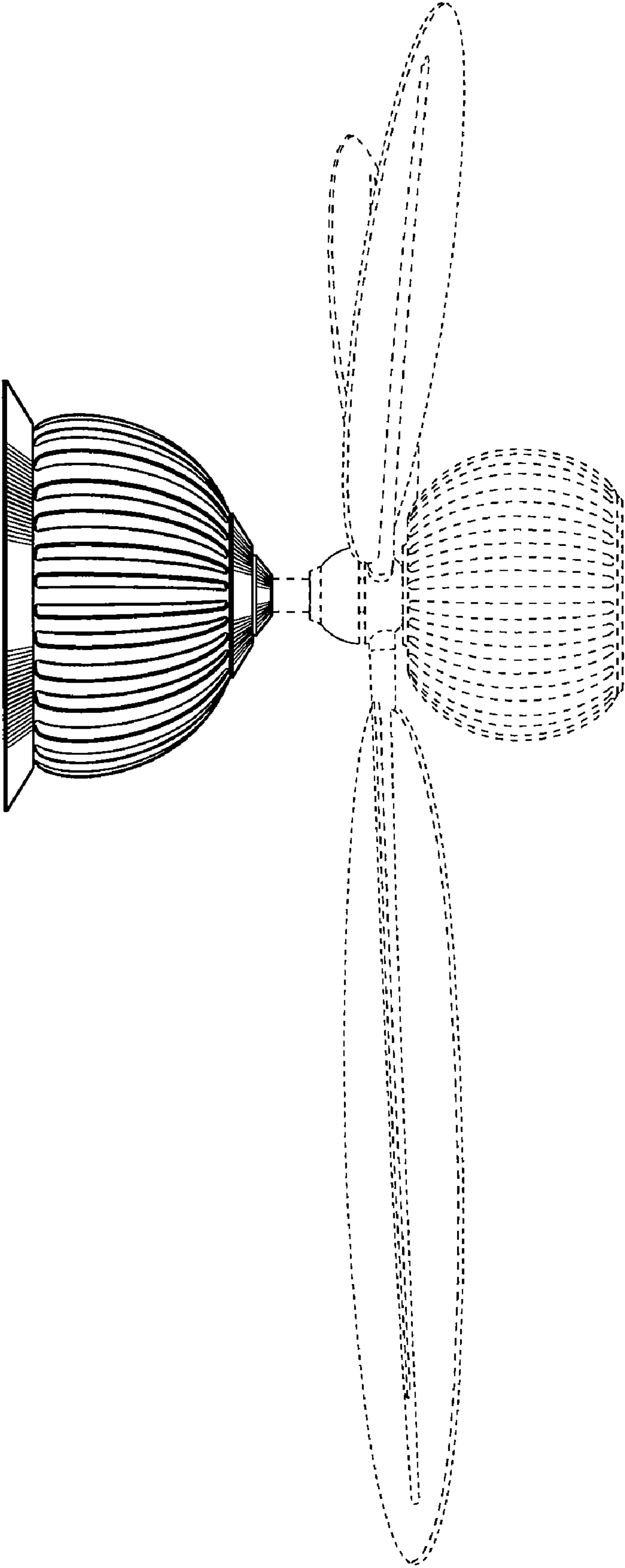
