(57) **CLAIM**

The ornamental design for a glove, as shown and described.

**DESCRIPTION**

FIG. 1 is a front/bottom perspective view of a glove according to an example embodiment of the new design.

FIG. 2 is a bottom view of the glove of FIG. 1 lying flat, showing a palm opening.

FIG. 3 is a top view of the glove of FIG. 1, showing a securing clasp in a closed position.

FIG. 4 is a top view of the glove of FIG. 1, showing the securing clasp in an open position.

FIG. 5 is a left side view of the glove of FIG. 1.

FIG. 6 is a right side view of the glove of FIG. 1.

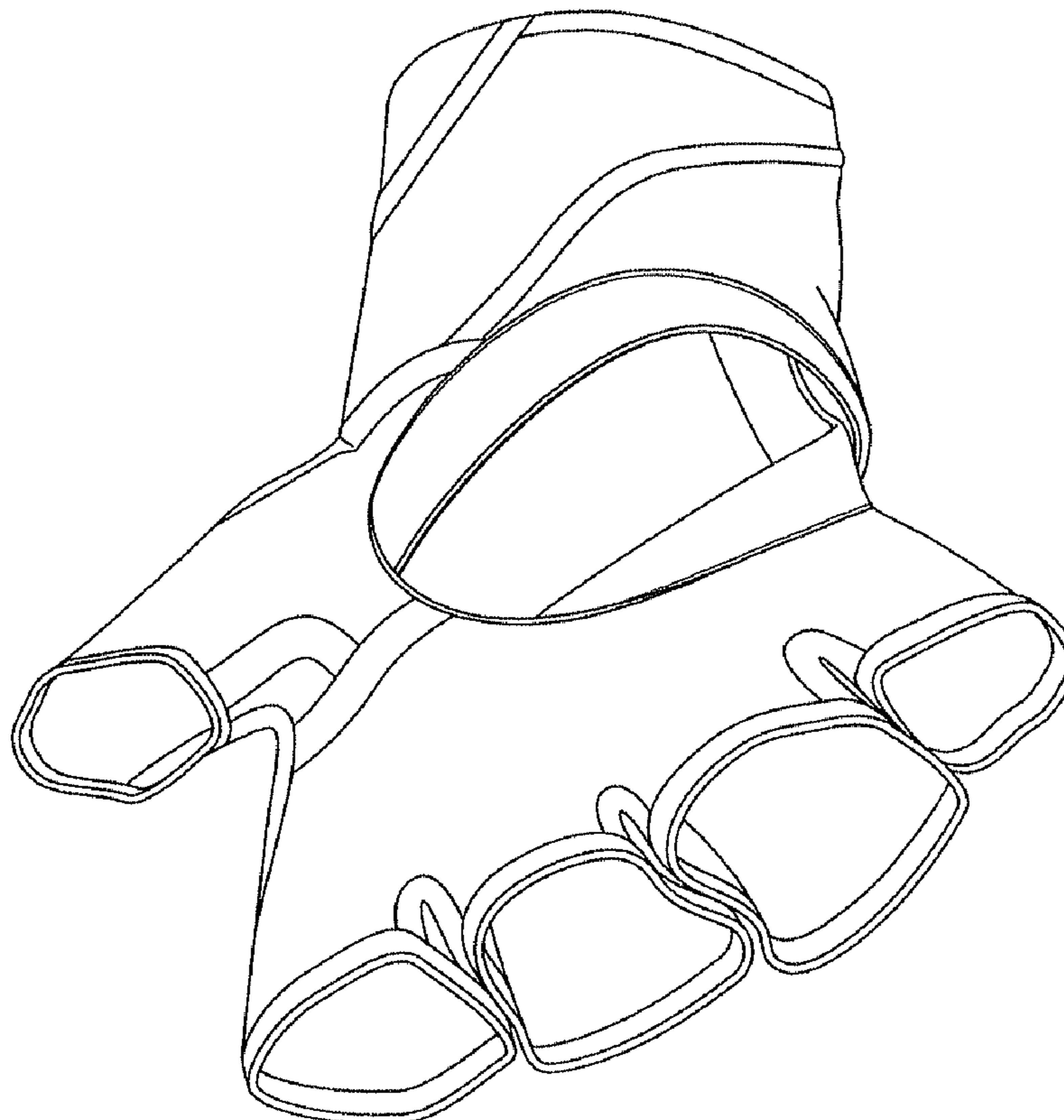
FIG. 7 is a back/wrist end view of the glove of FIG. 1; and,

FIG. 8 is a front/finger end view of the glove of FIG. 1.

The glove has finger holes, and in FIGS. 1 and 8 the material around the finger holes is in a relaxed state. Accordingly, the design is not limited to the shape of the finger holes shown in FIGS. 1 and 8.

The broken line shown in FIG. 4 of the drawing shows an unclaimed portion of the glove and therefore is for illustrative purposes only and forms no part of the claimed design.

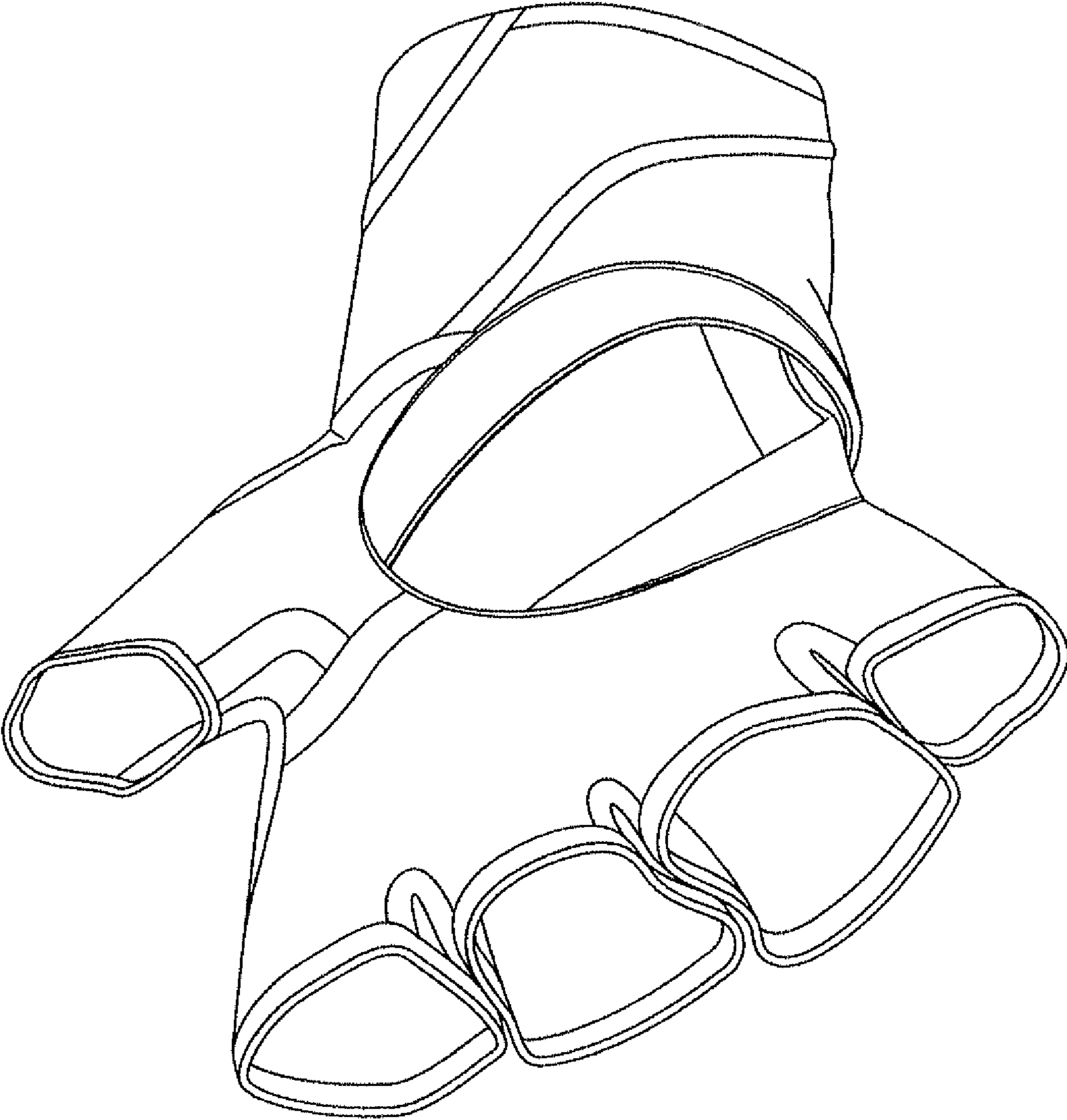

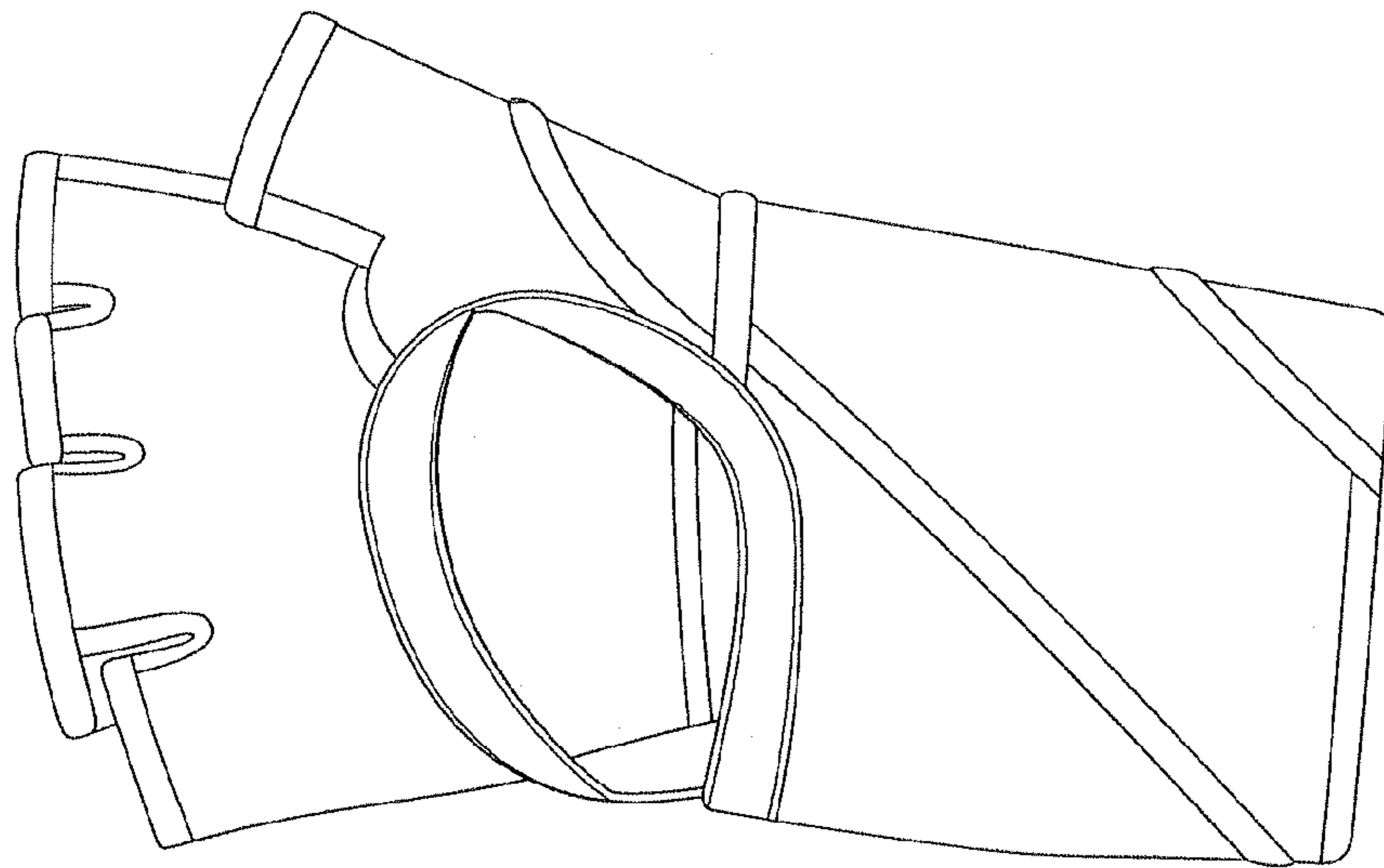

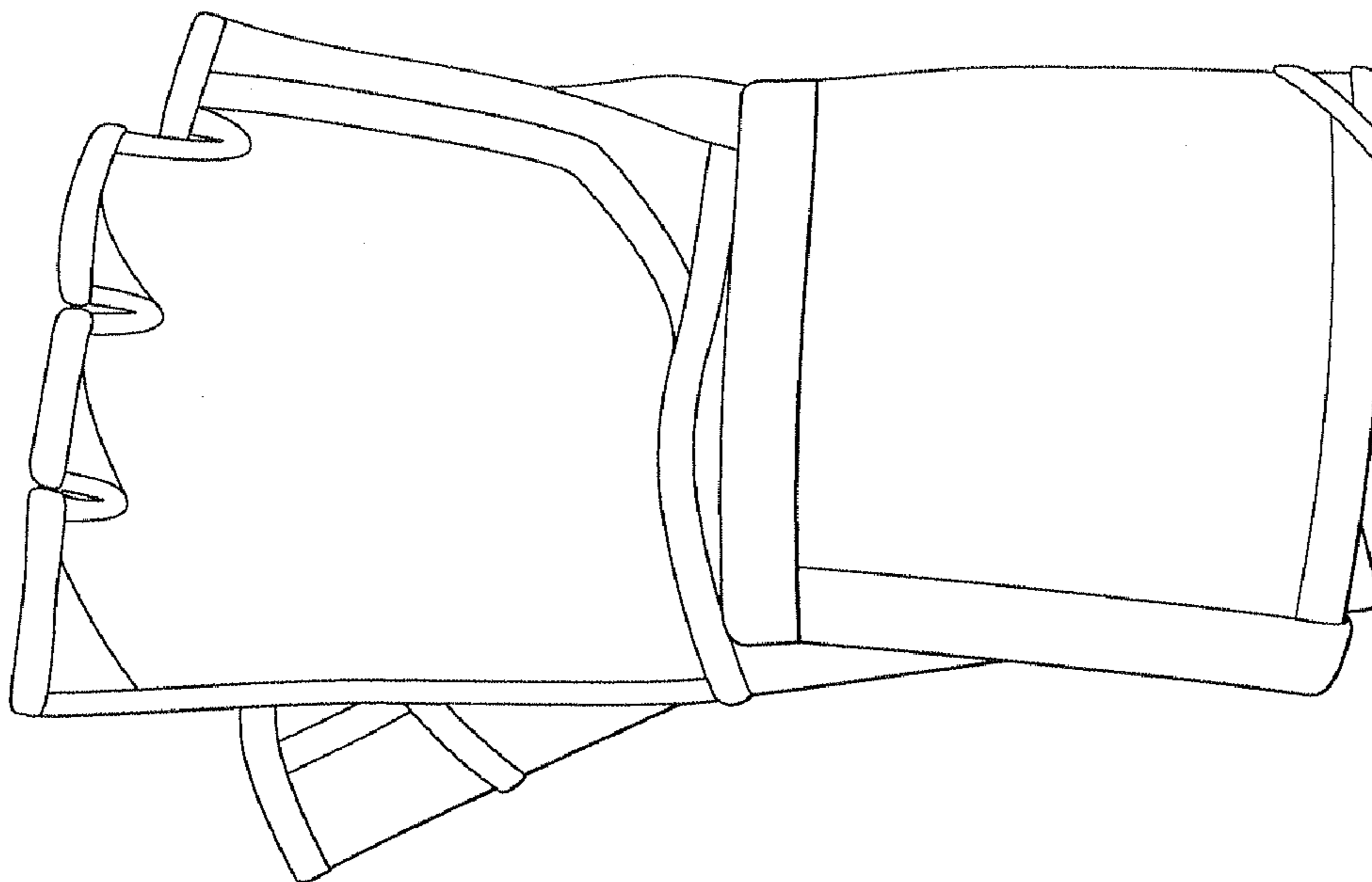

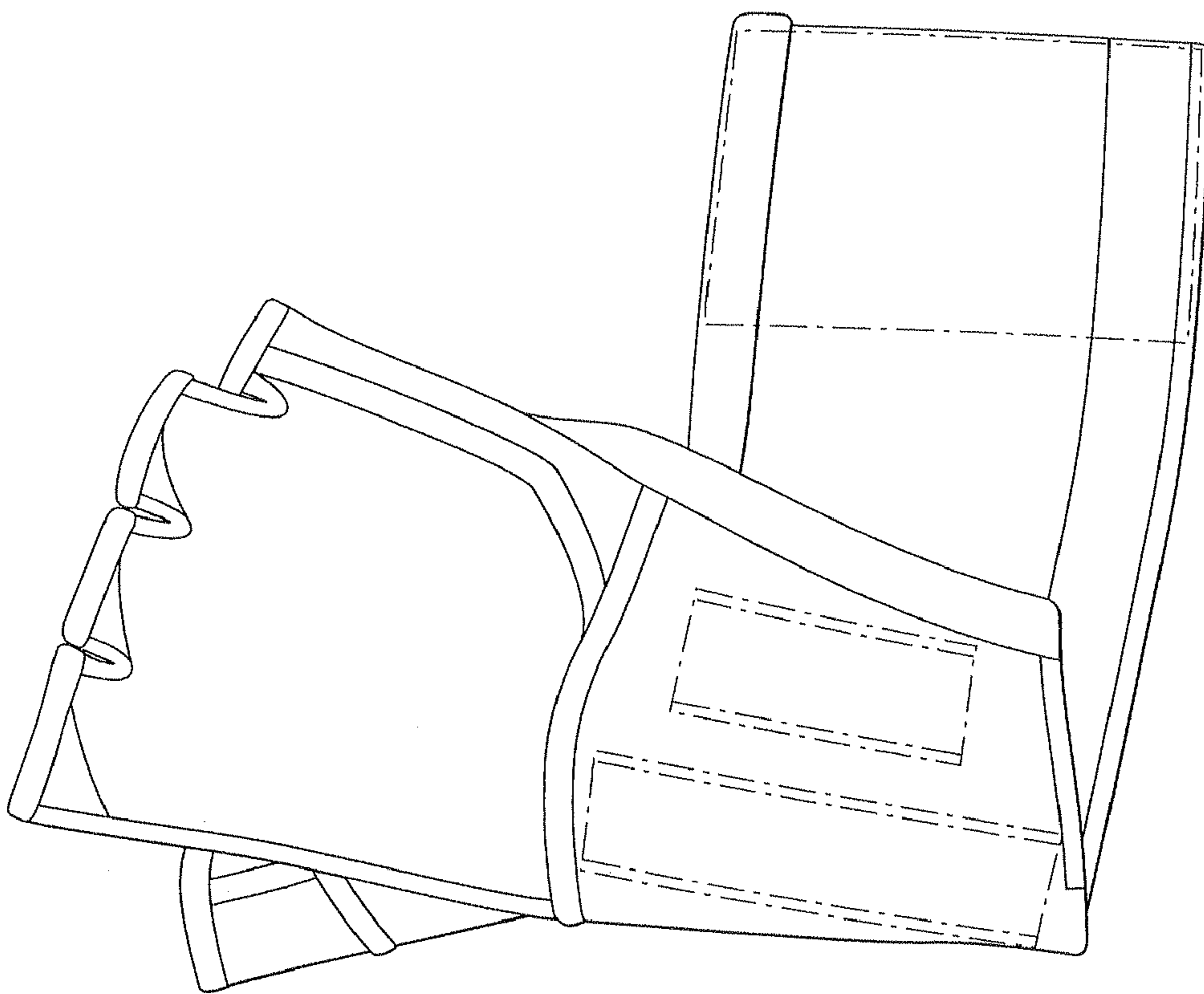

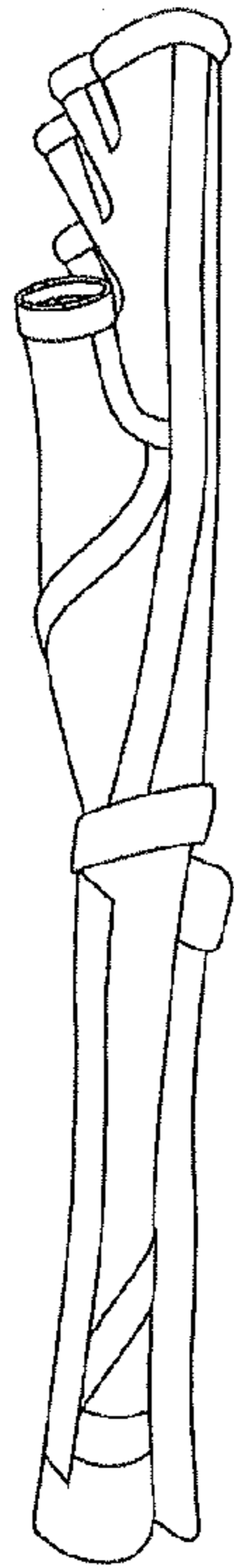

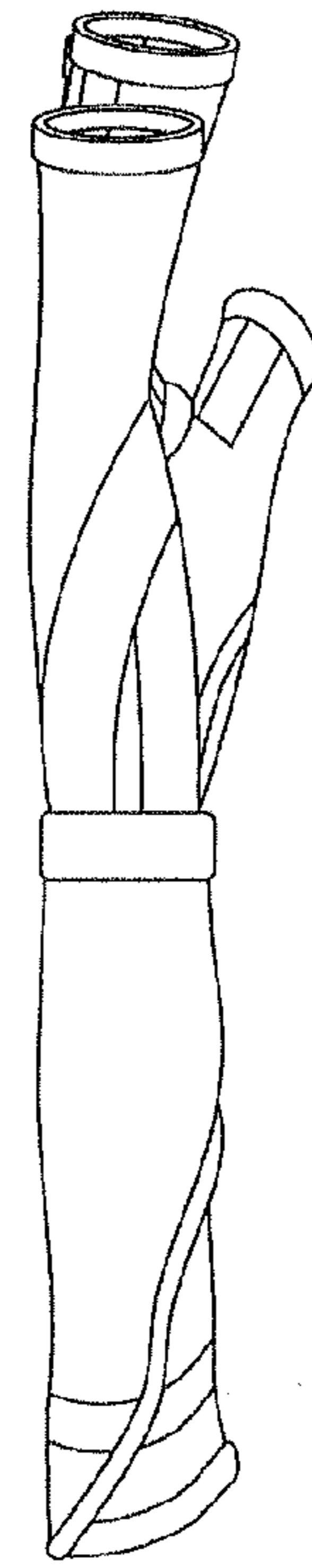

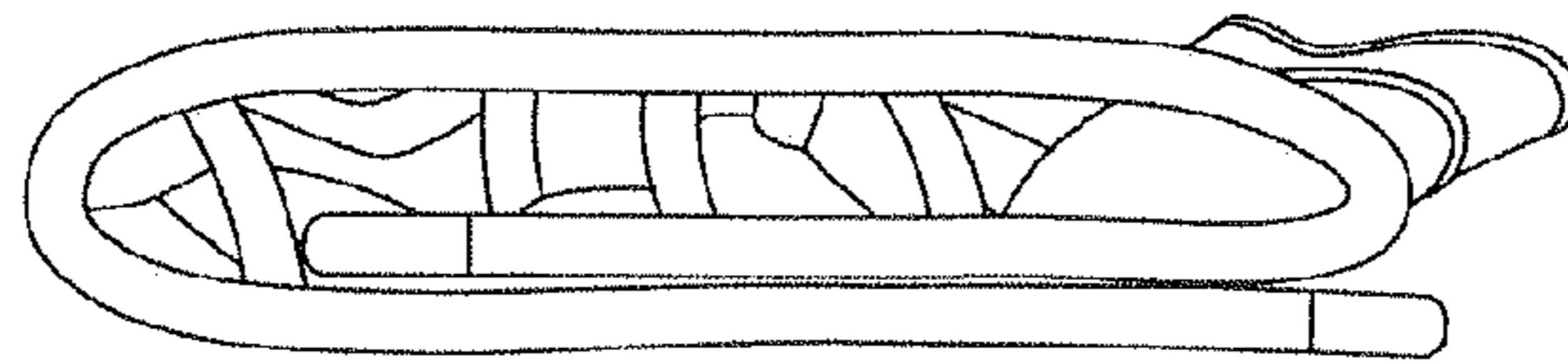

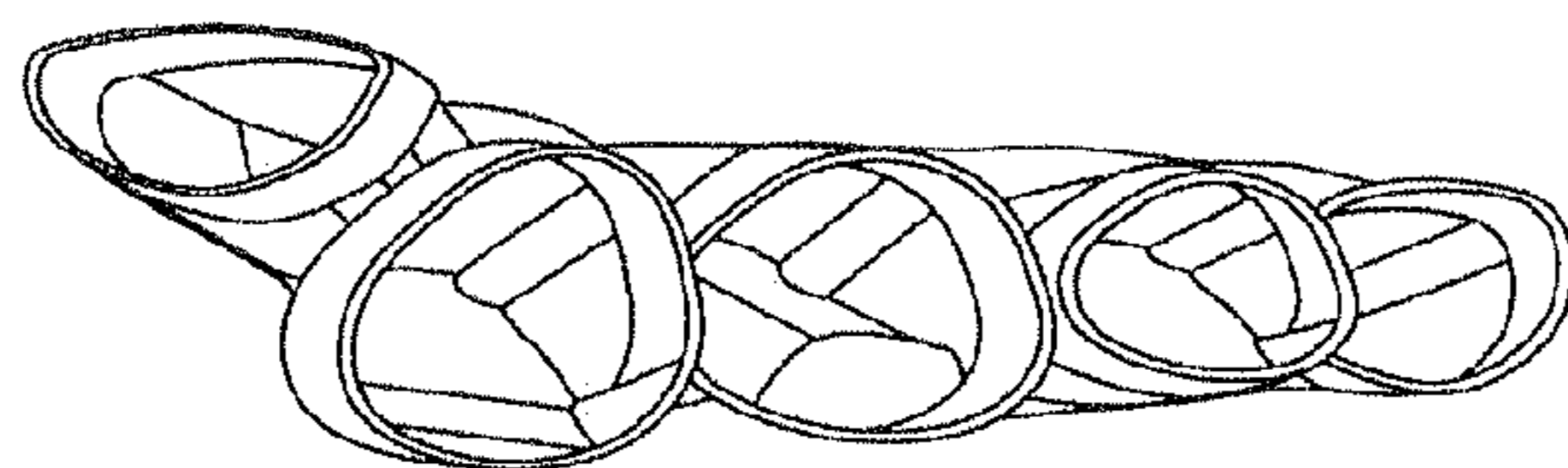
