(57) **CLAIM**

We claim the ornamental design for a pair of shoe outsoles, as shown and described.

**DESCRIPTION**

FIG. 1 is a top right perspective view of the left component of a pair of shoe outsoles showing our new design, the right component that is not shown, being a mirror image;

FIG. 2 is a bottom left perspective view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is left side elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a rear elevational view thereof; and,

FIG. 7 is a front elevational view thereof.

The broken line showing a portion of a shoe upper along with the remainder of the shoe outsole throughout the figures illustrates the portion of the design that forms no part of the claim.

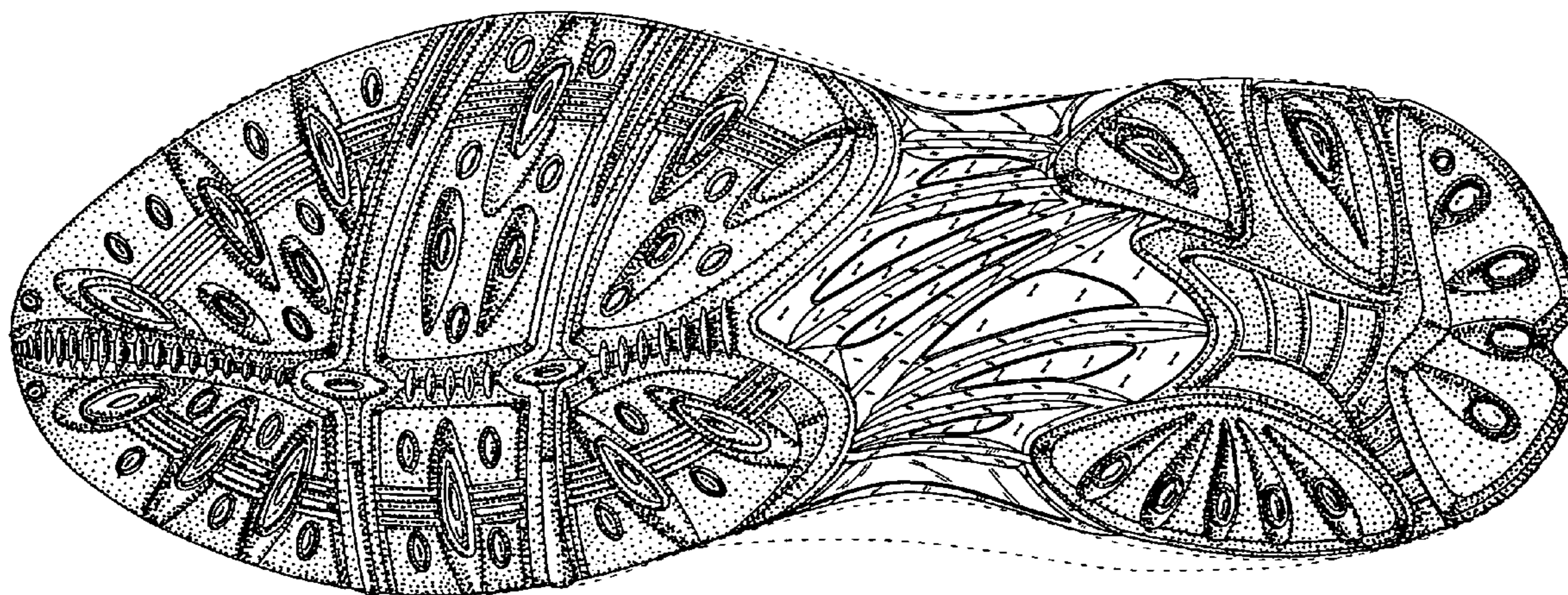
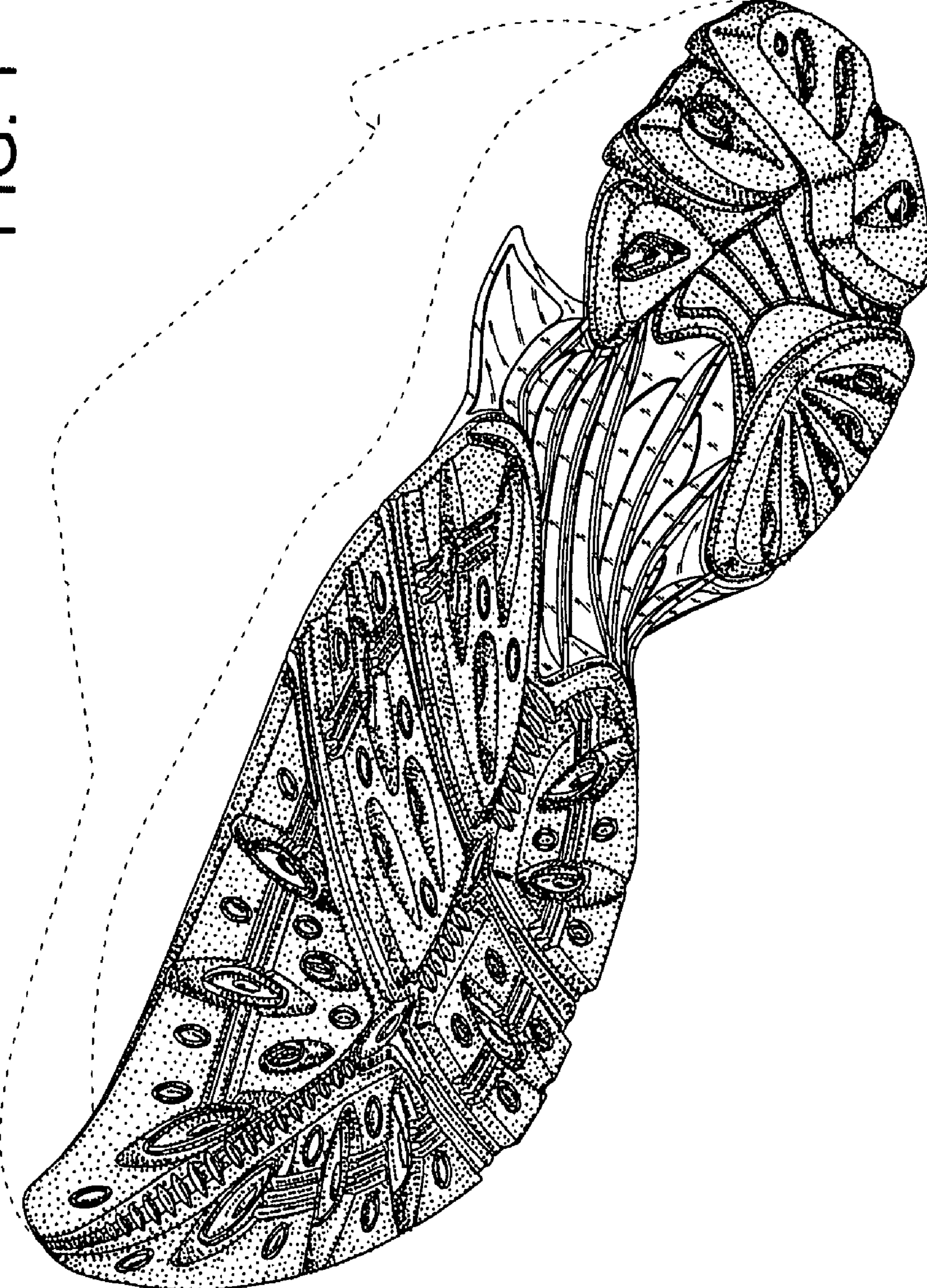

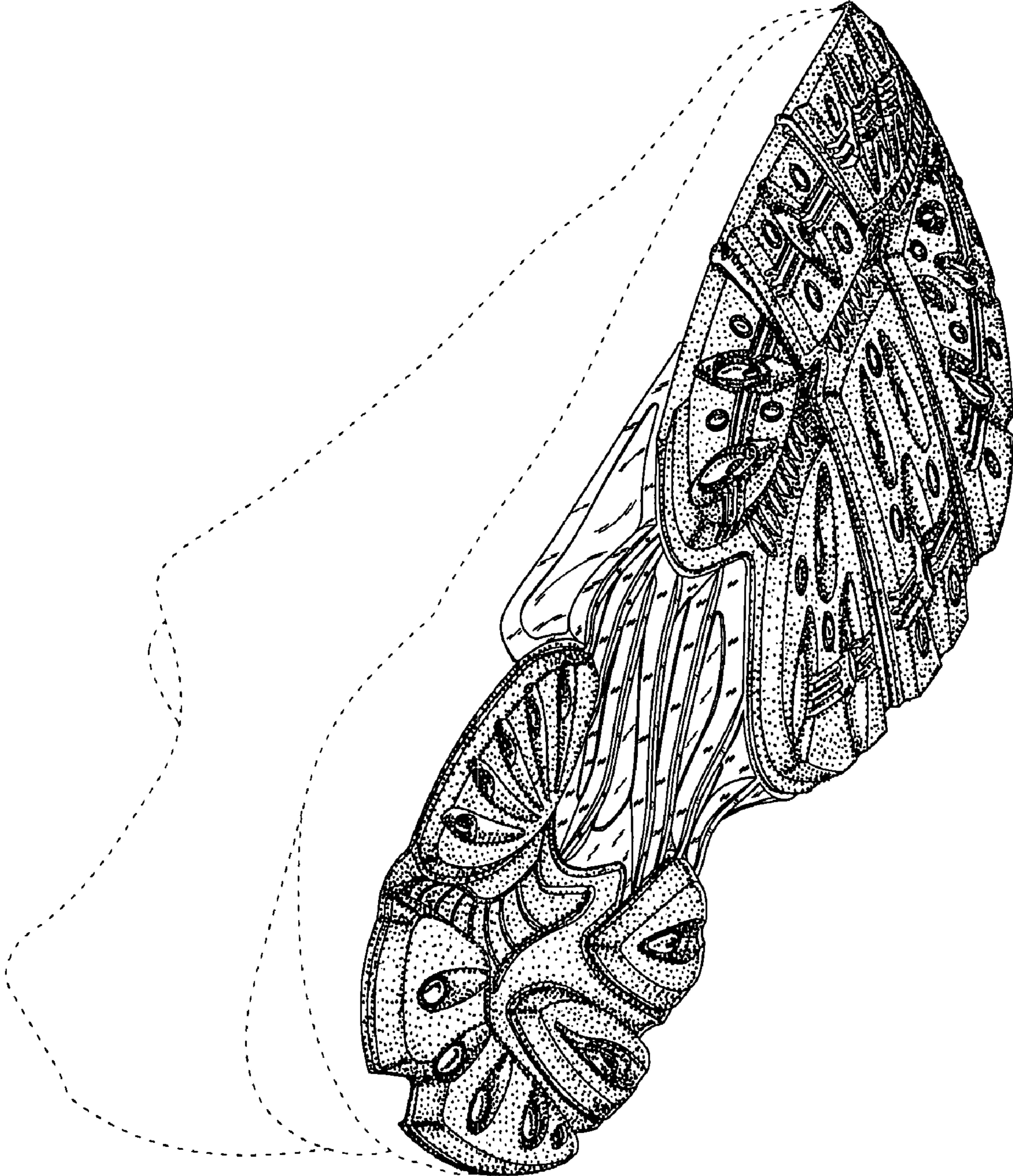

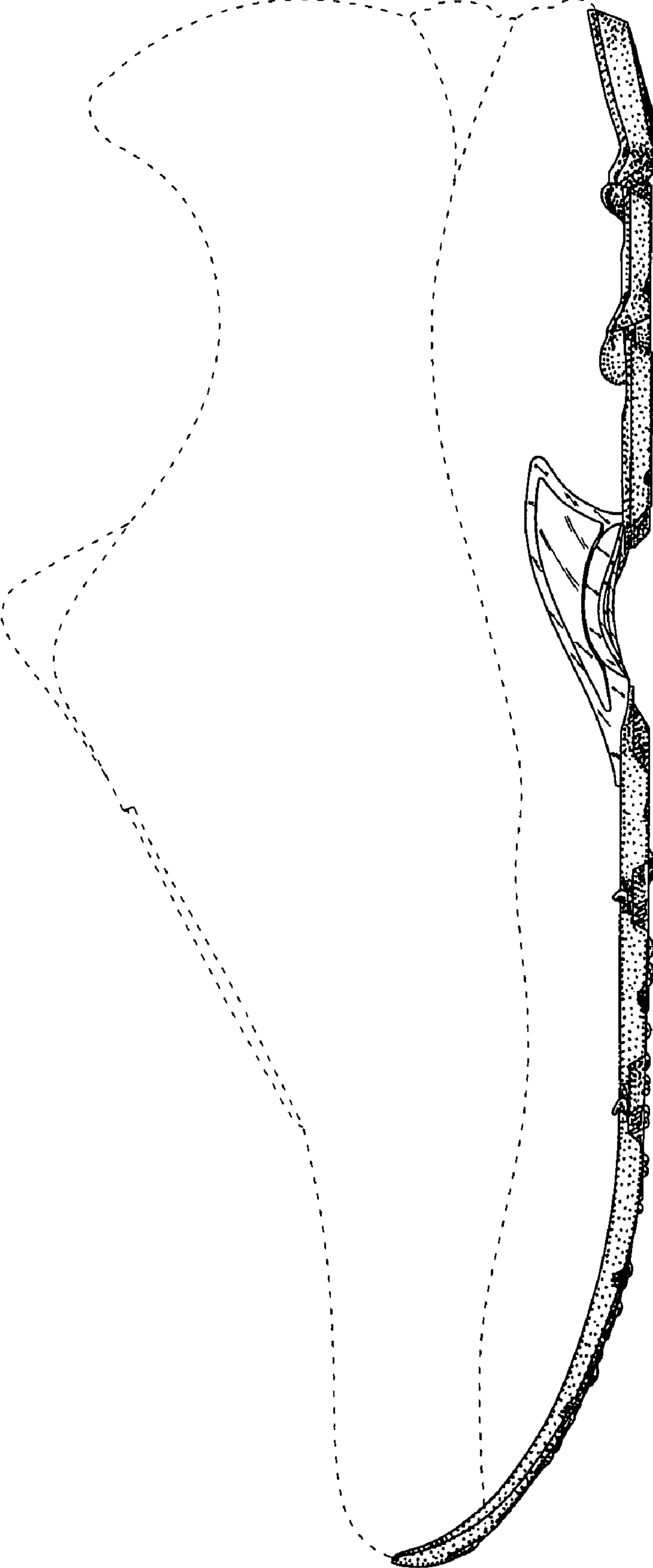

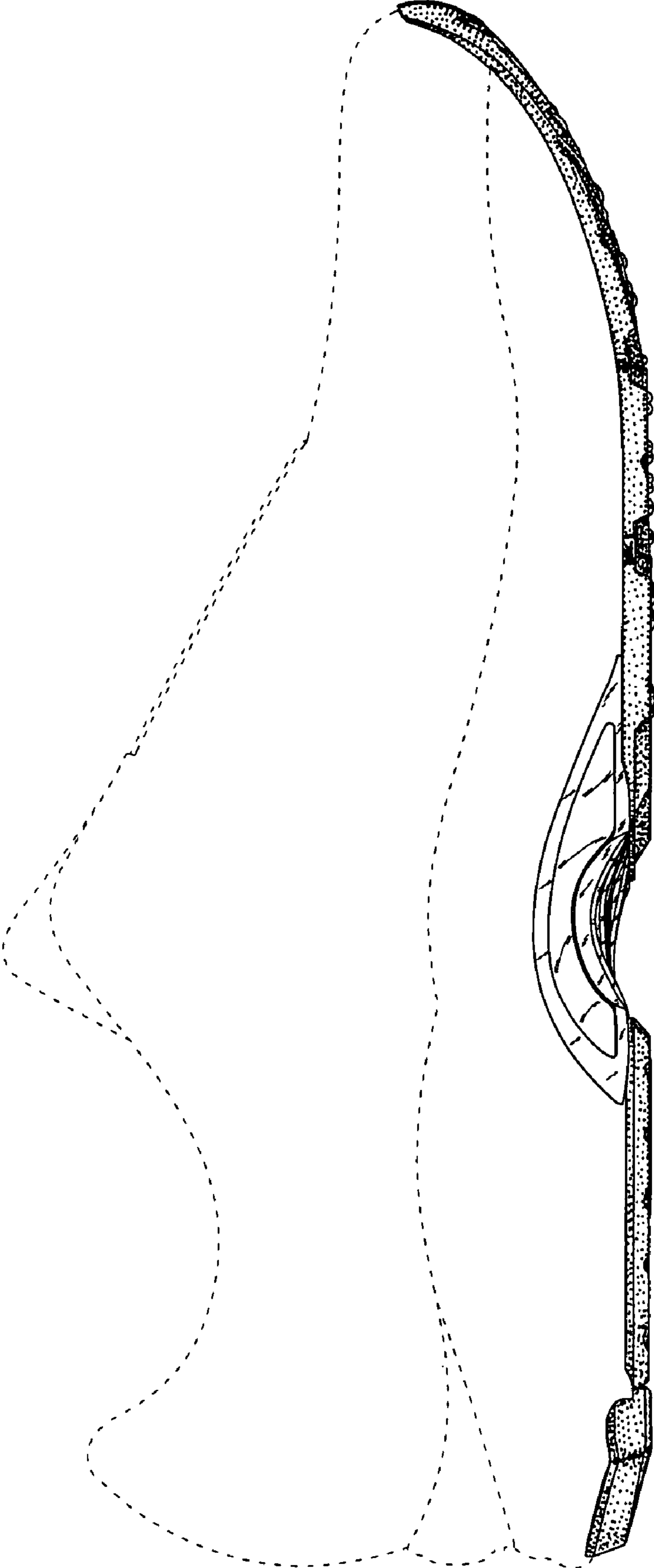

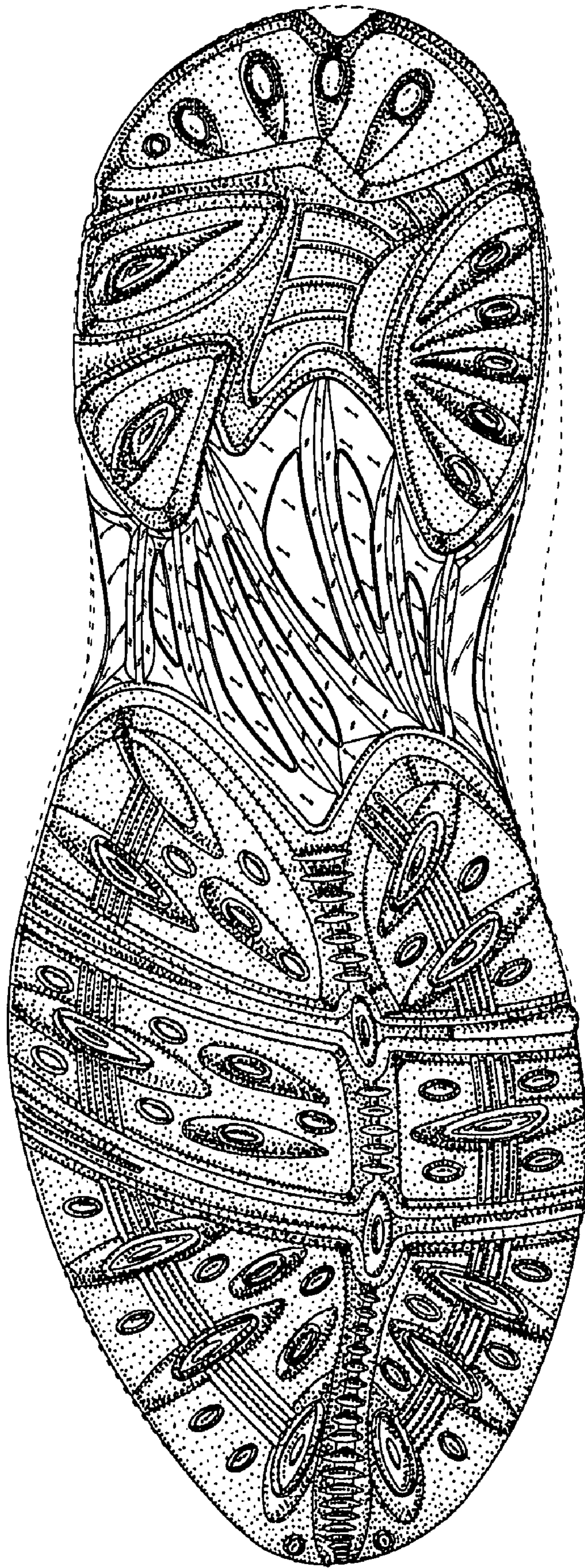

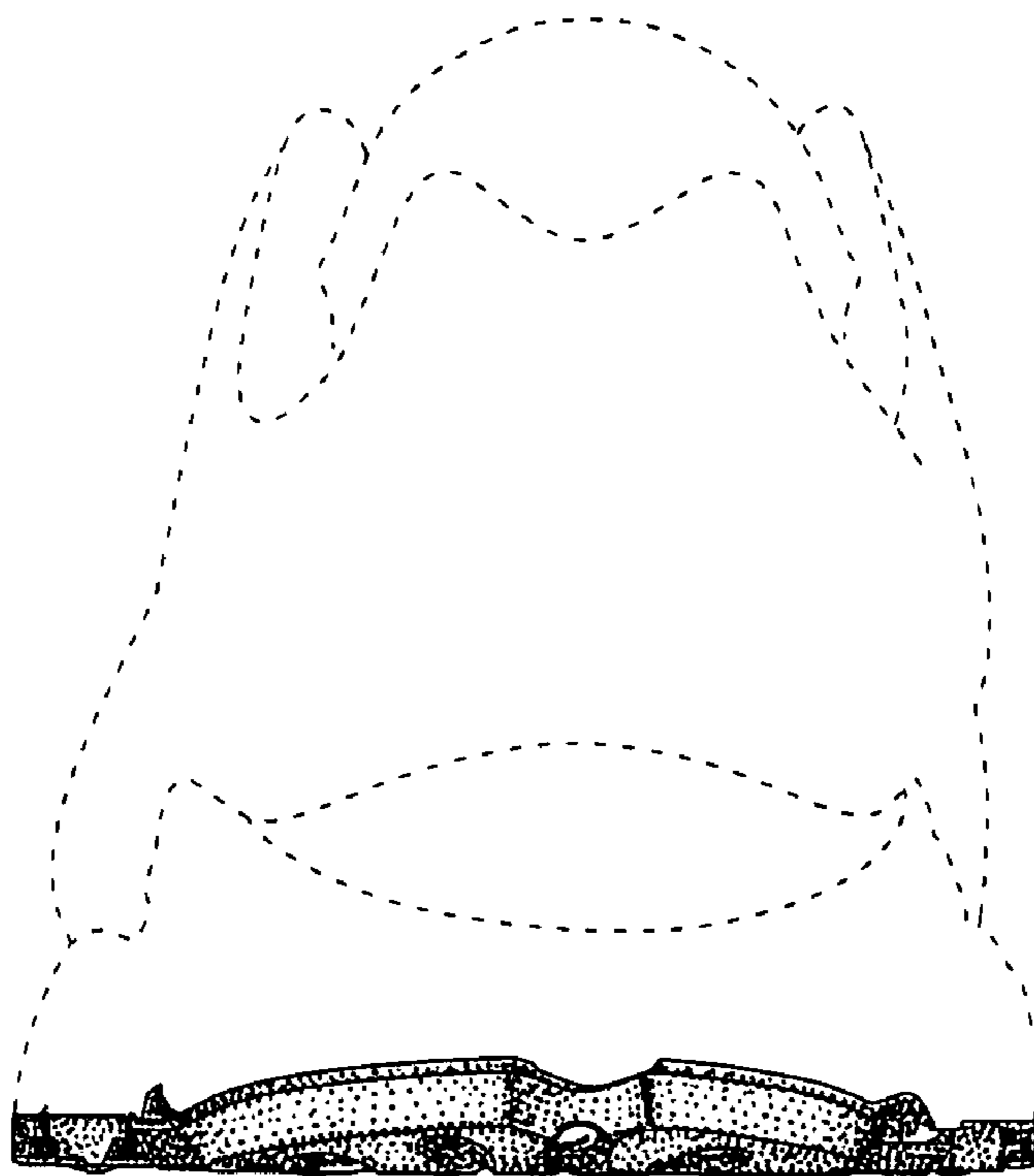
