DESCRIPTION

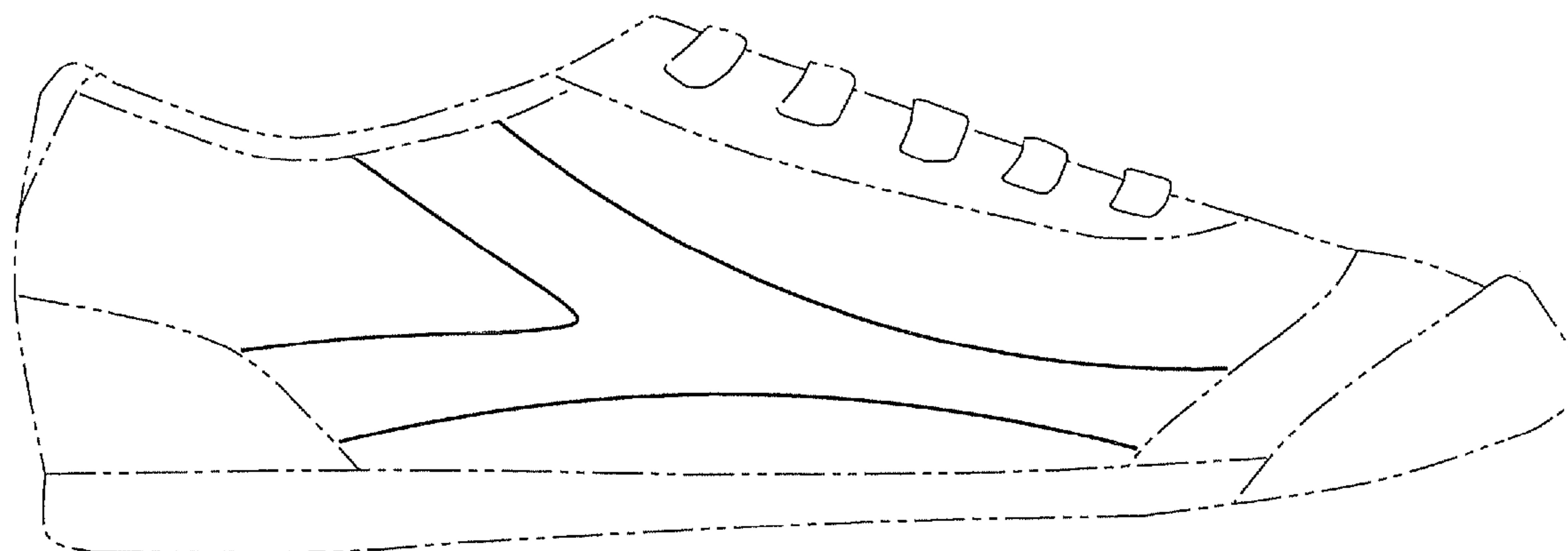
FIG. 1 is a perspective view of a shoe showing my new design.

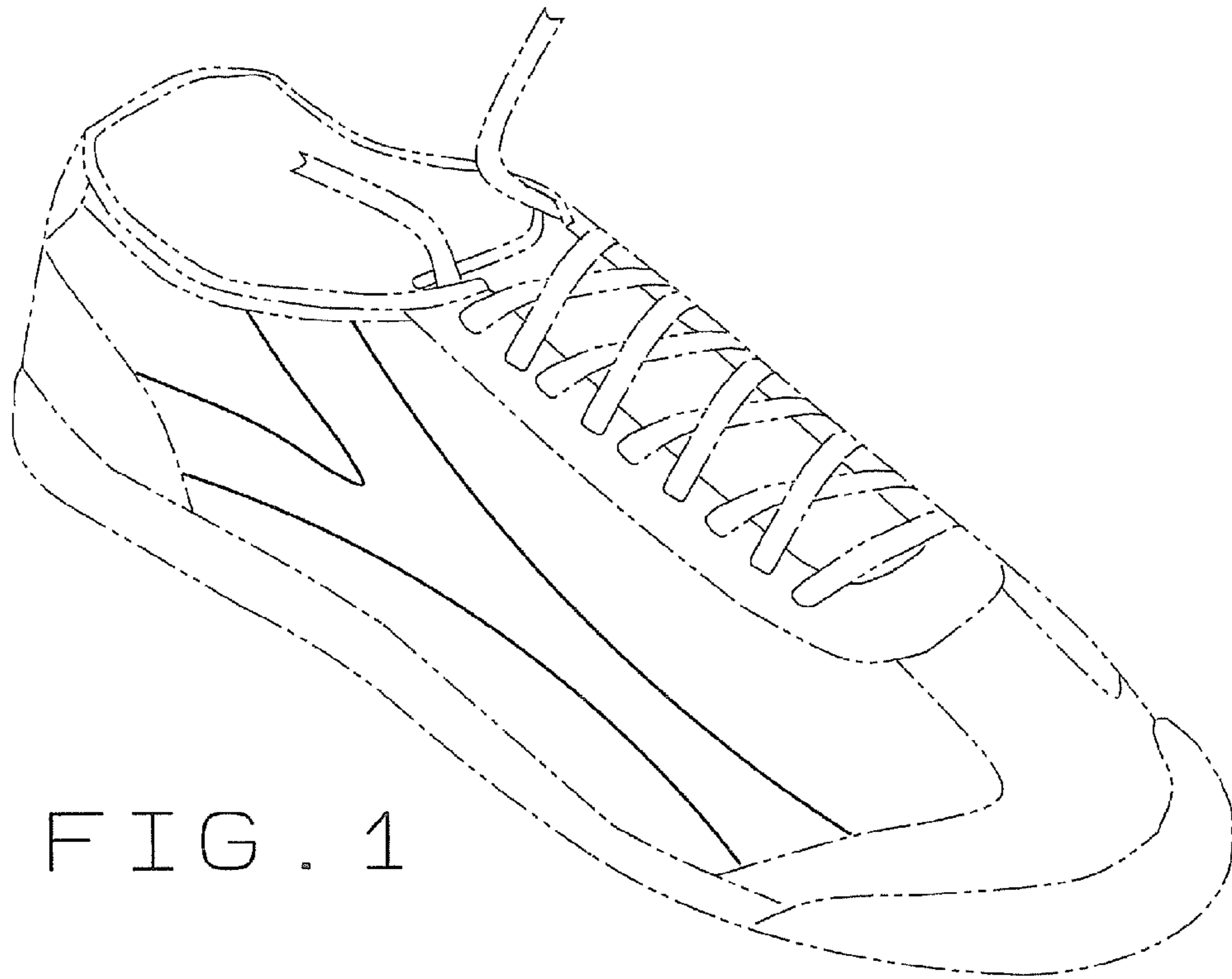

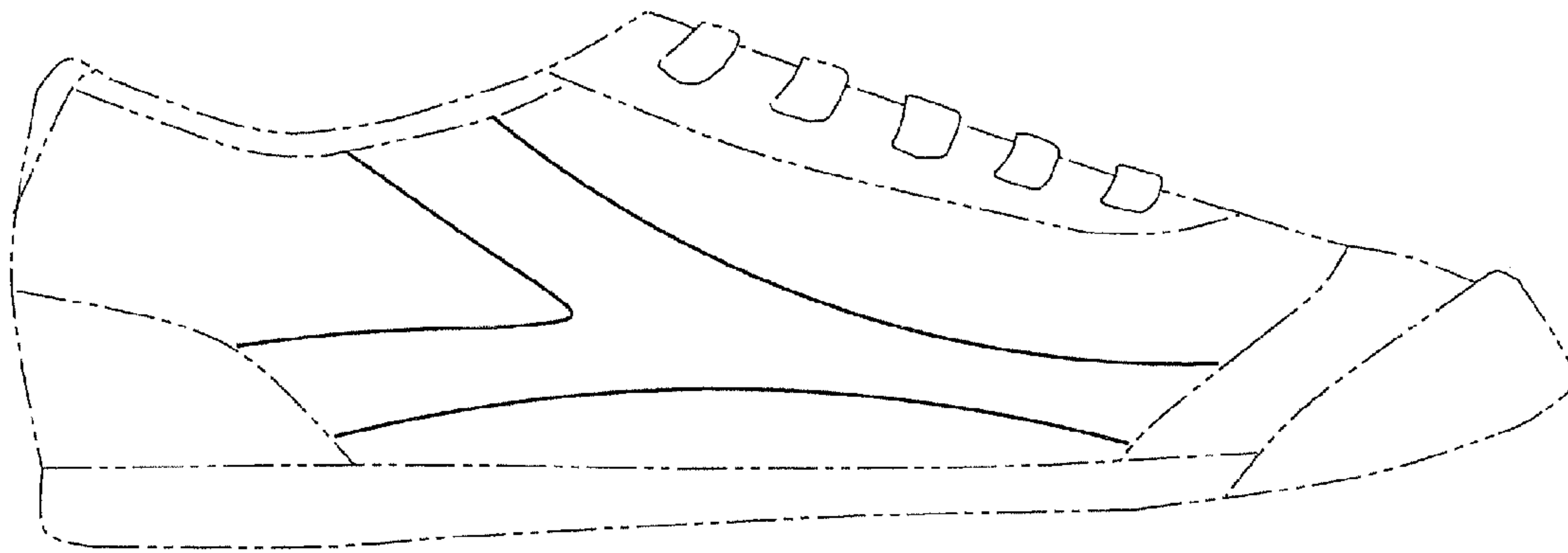

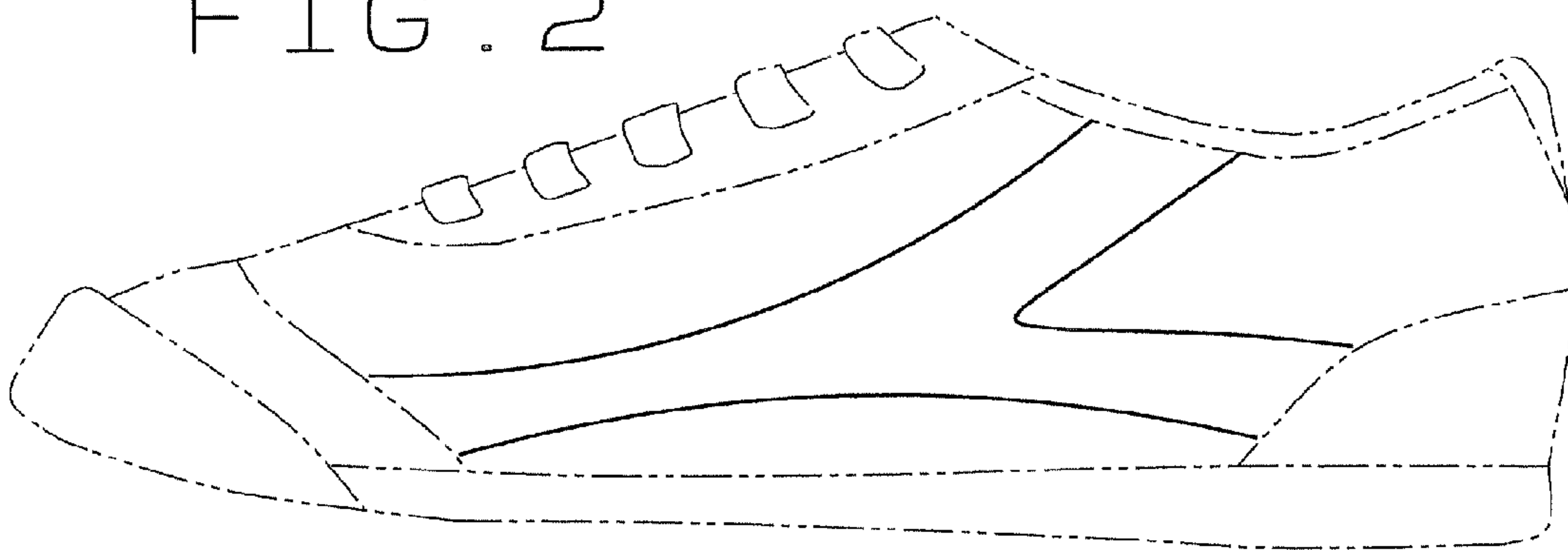
