DESCRIPTION

FIG. 1 is a perspective view of the massage chair according to the present invention;

FIG. 2 is a front view of the massage chair according to the present invention;

FIG. 3 is a side view of the massage chair according to the present invention;

FIG. 4 is a rear view of the massage chair according to the present invention;

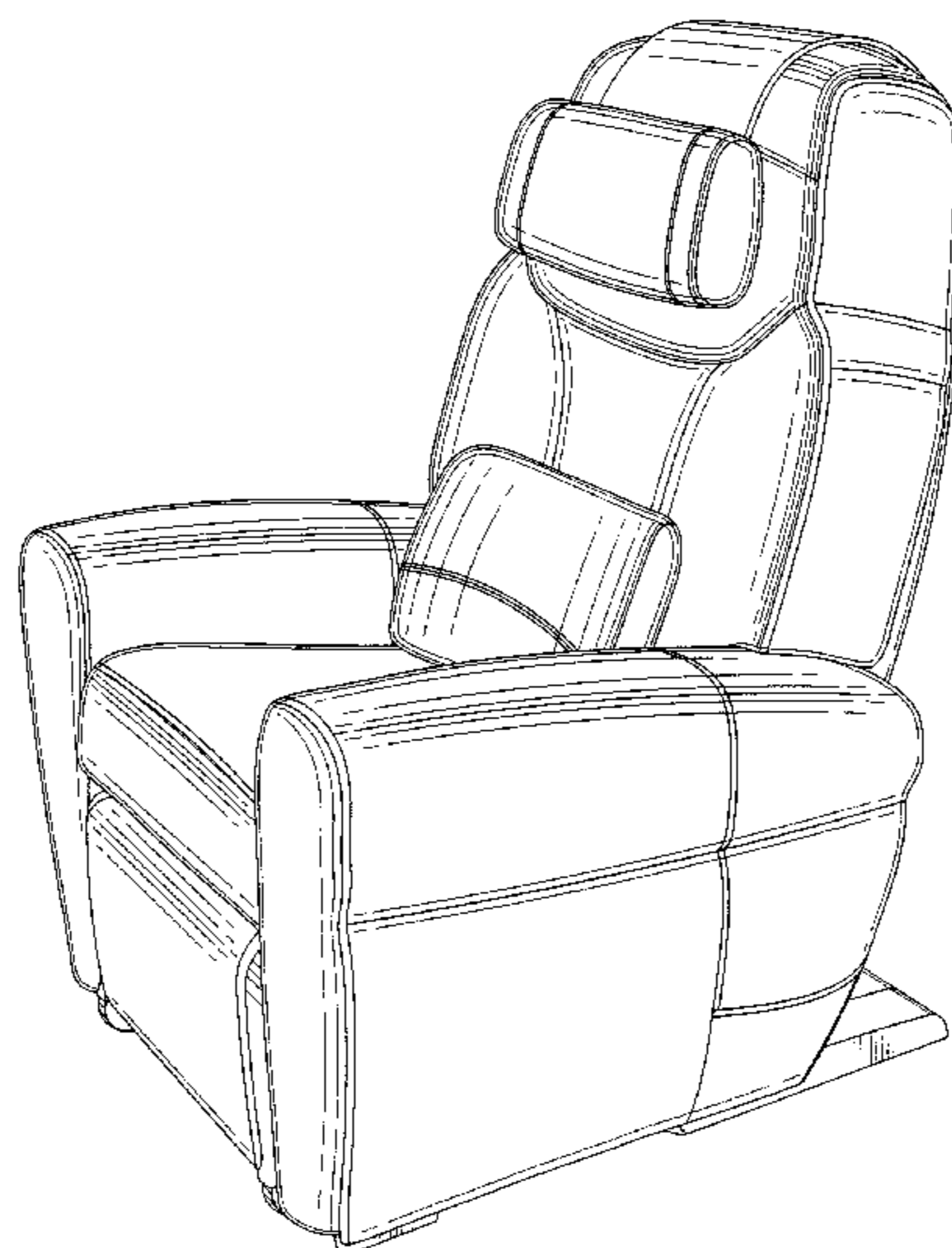

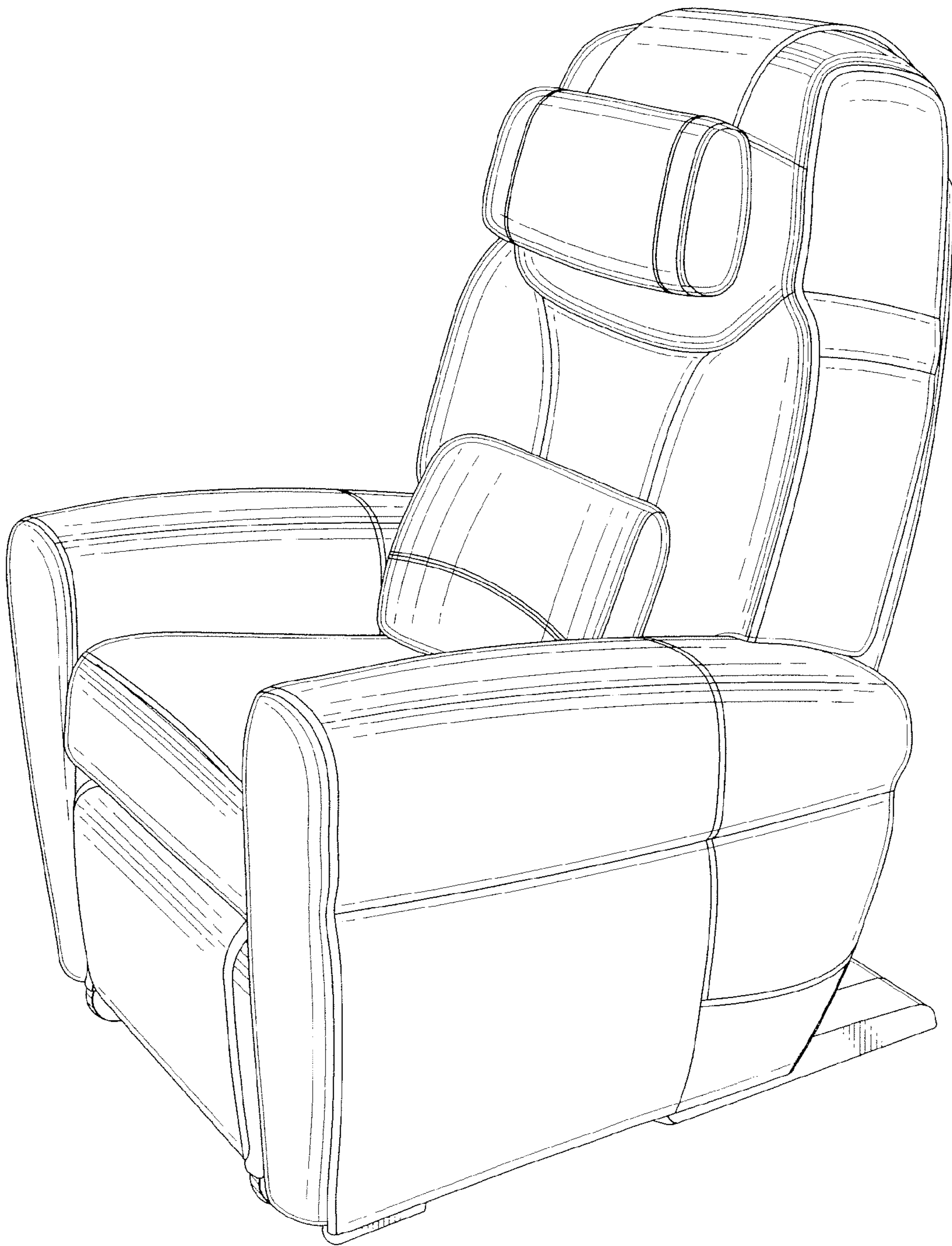

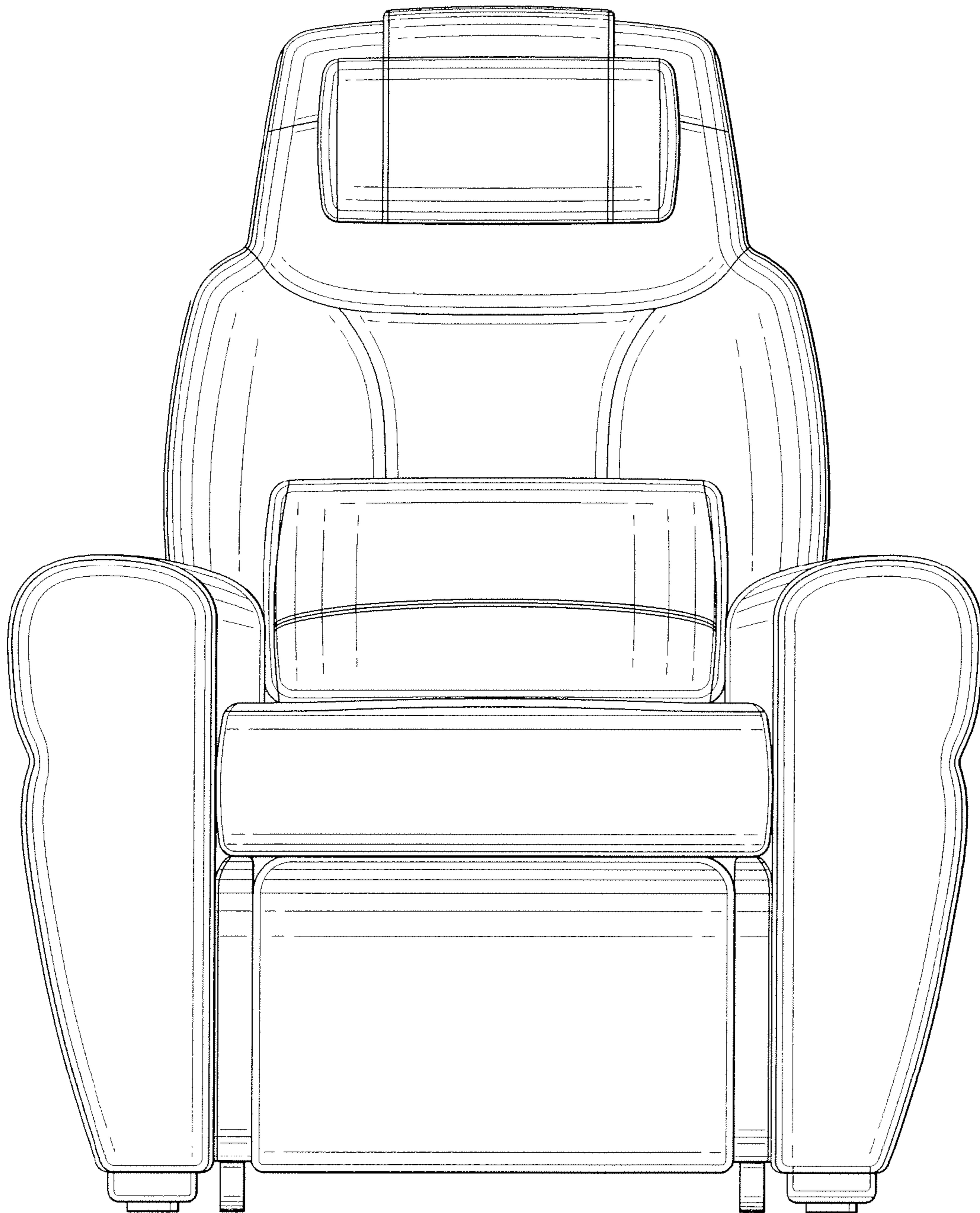

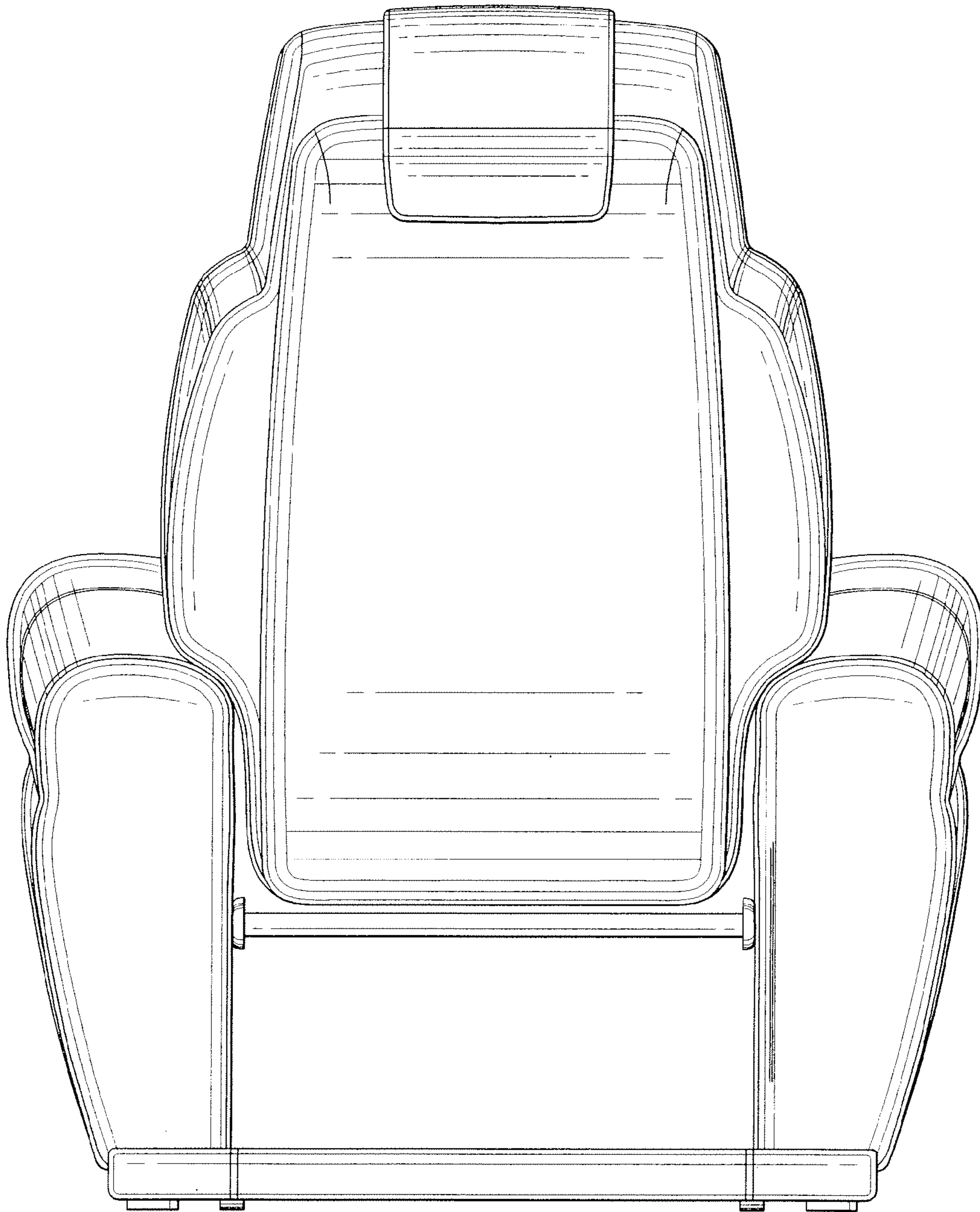

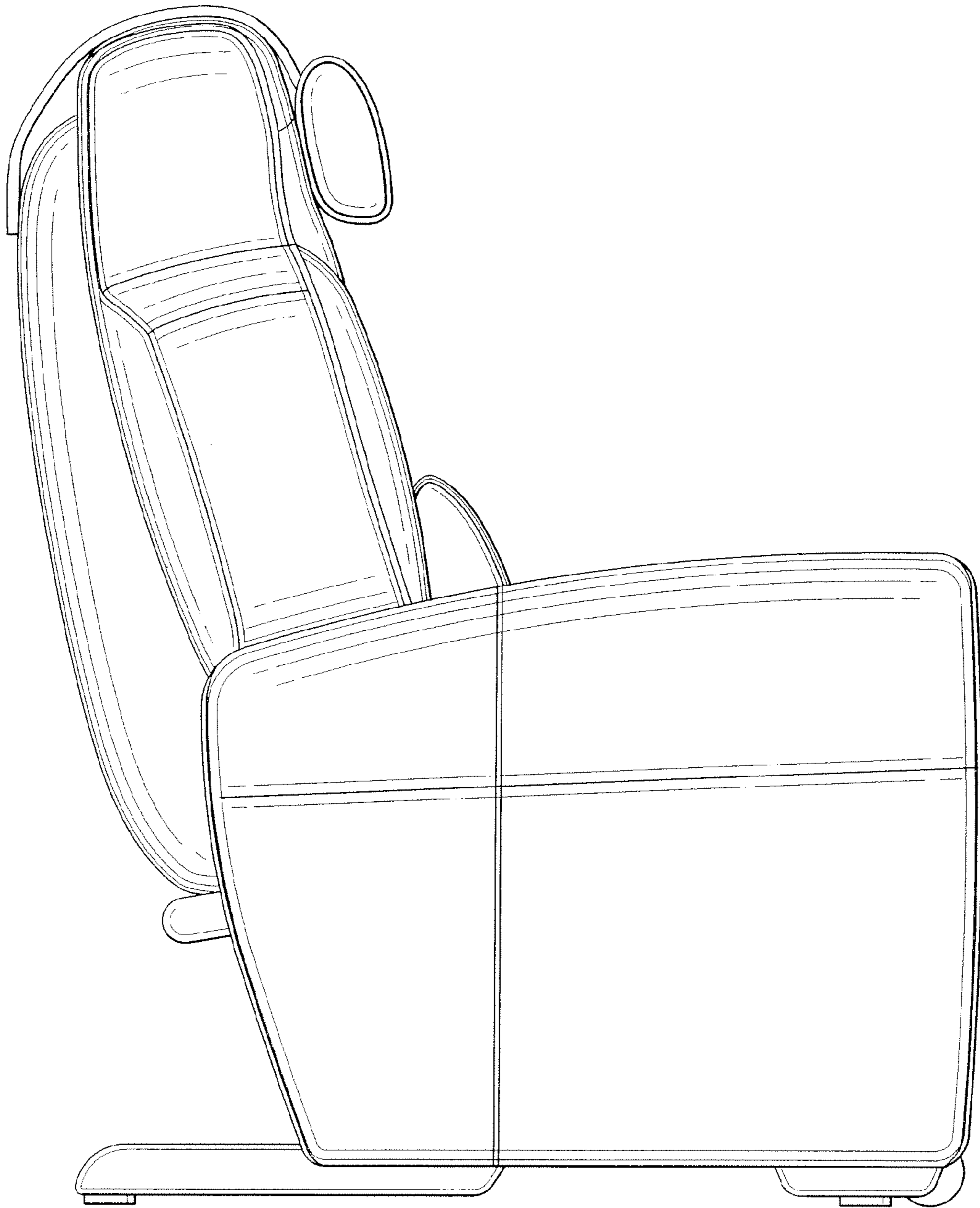

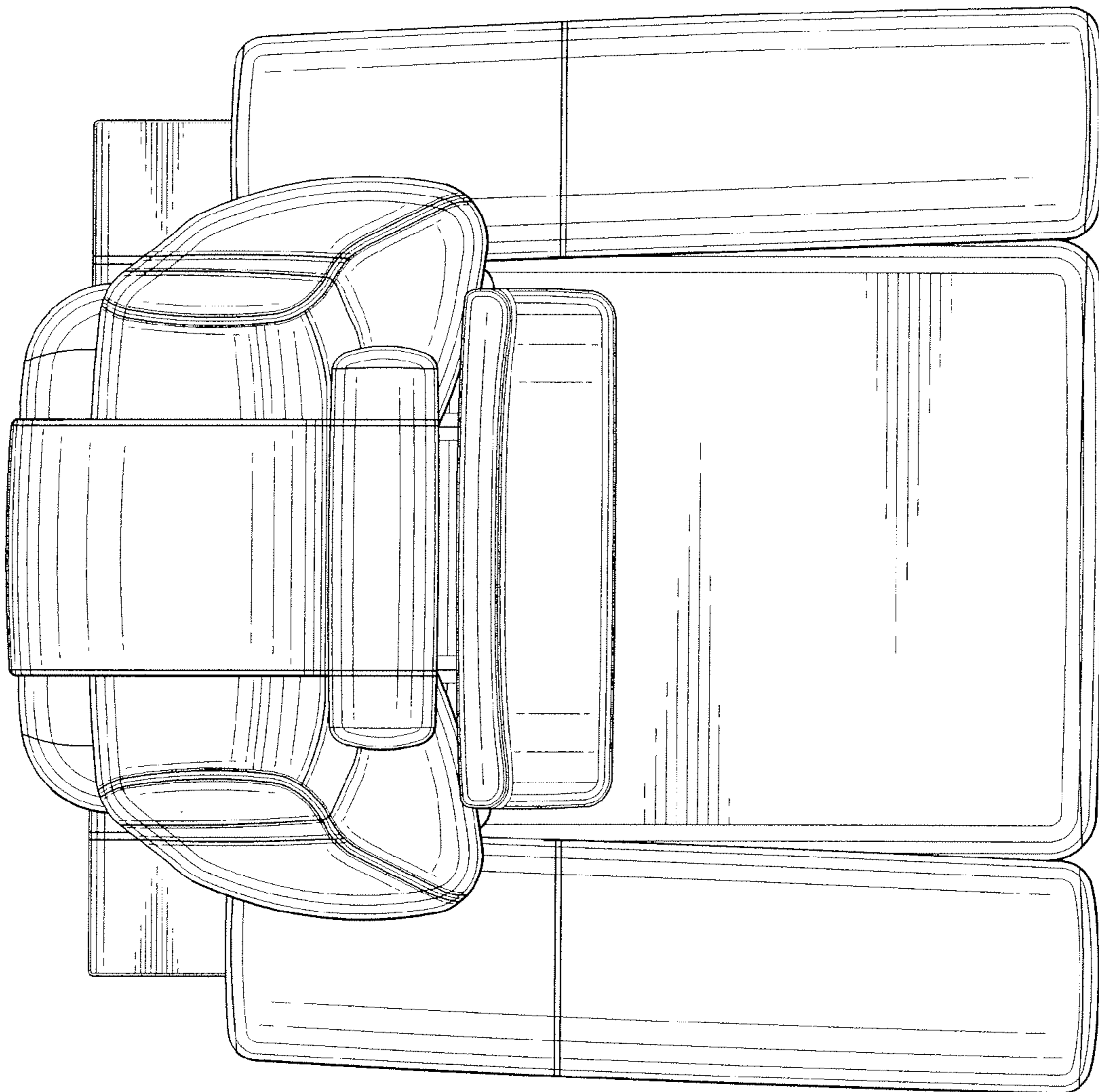

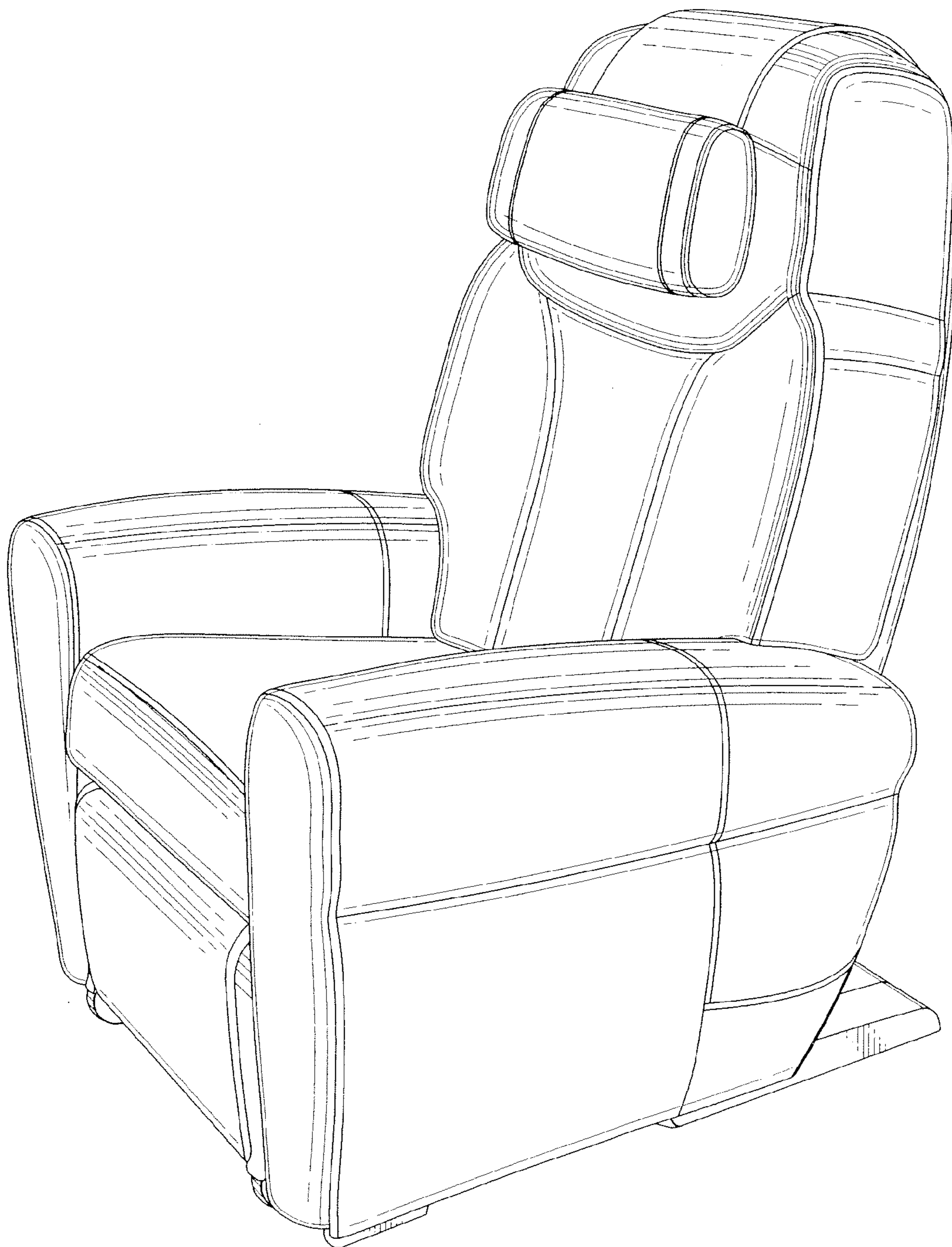

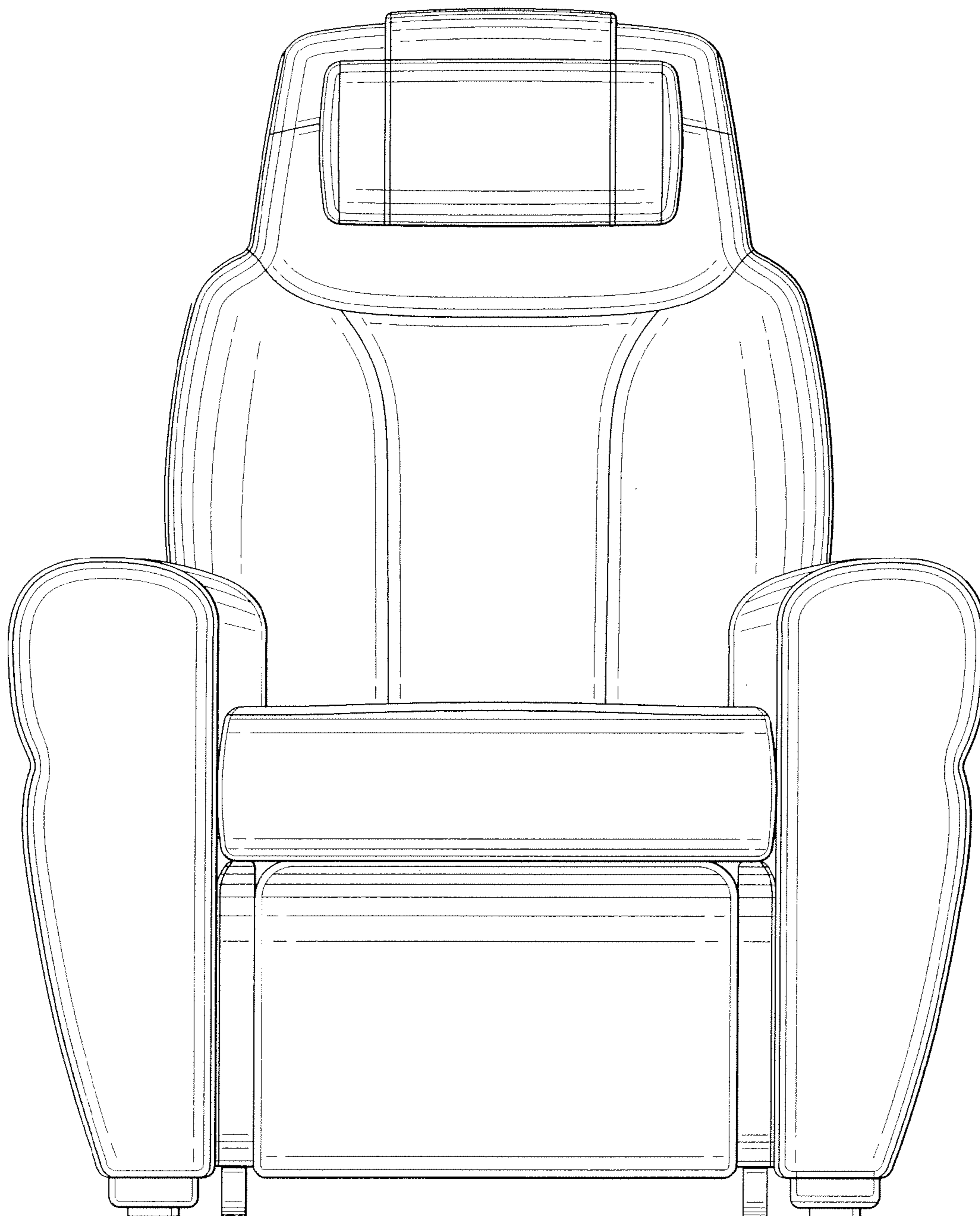

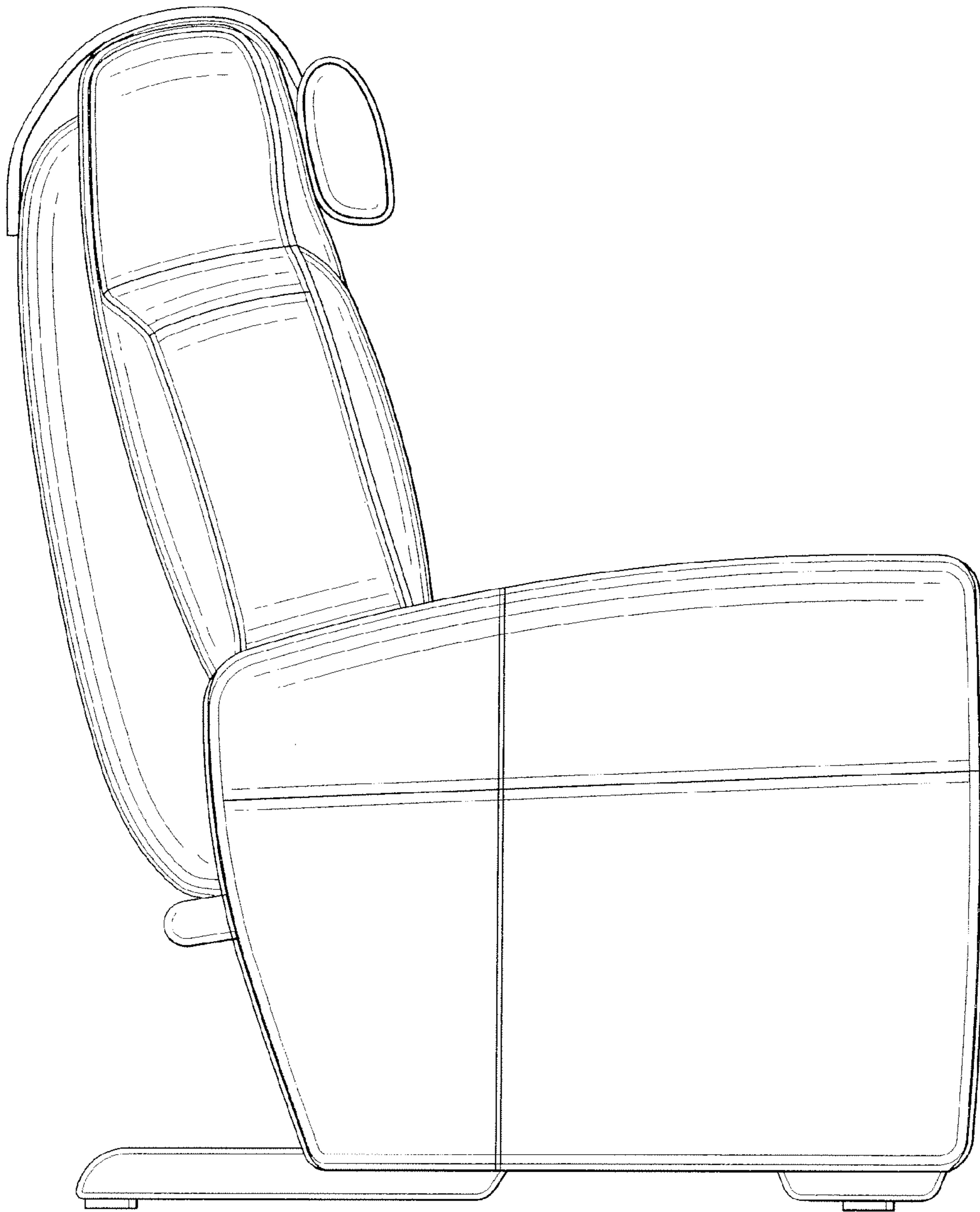
