FIG. 6 is a bottom view thereof;

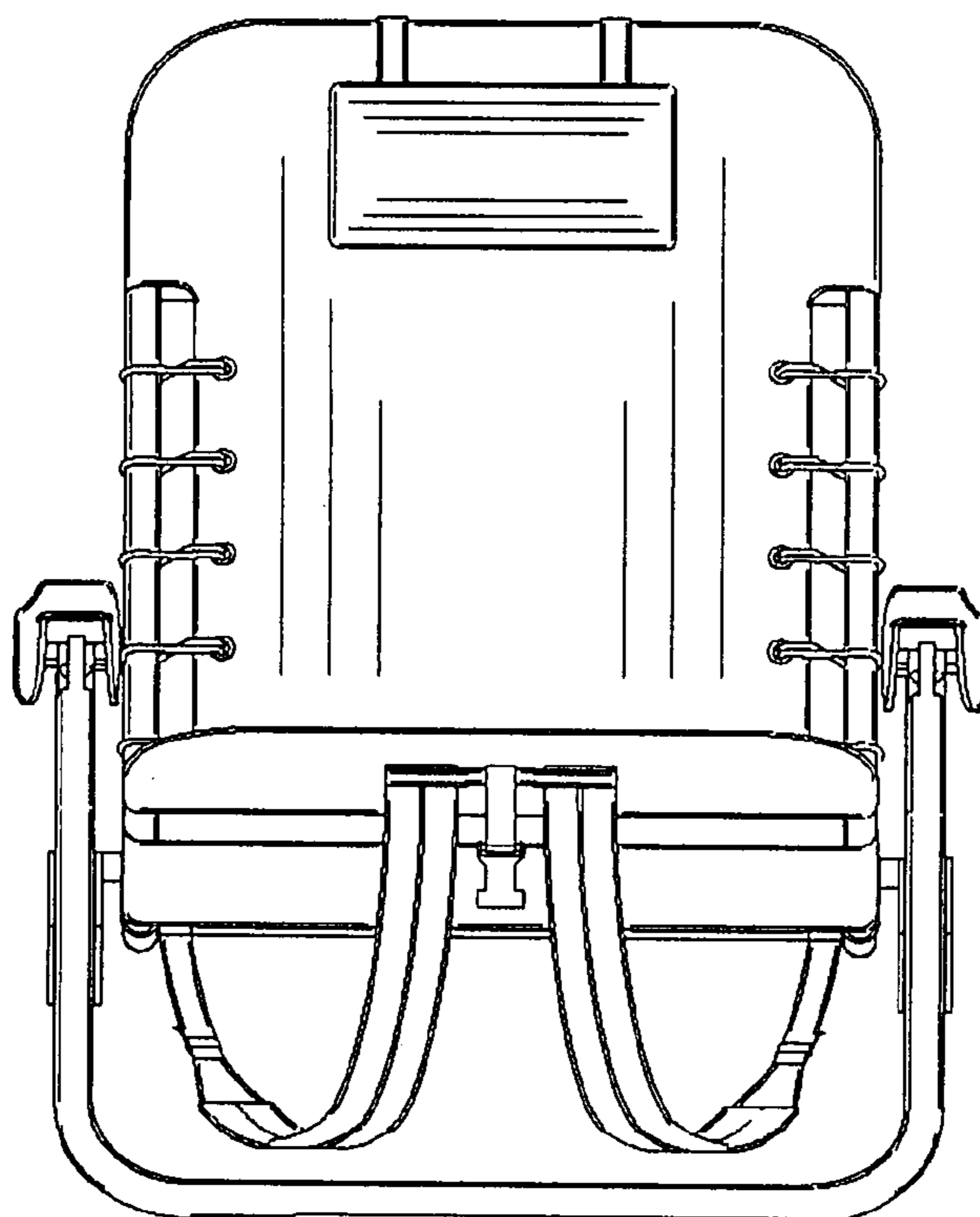
FIG. 7 is a back view thereof in a folded configuration;

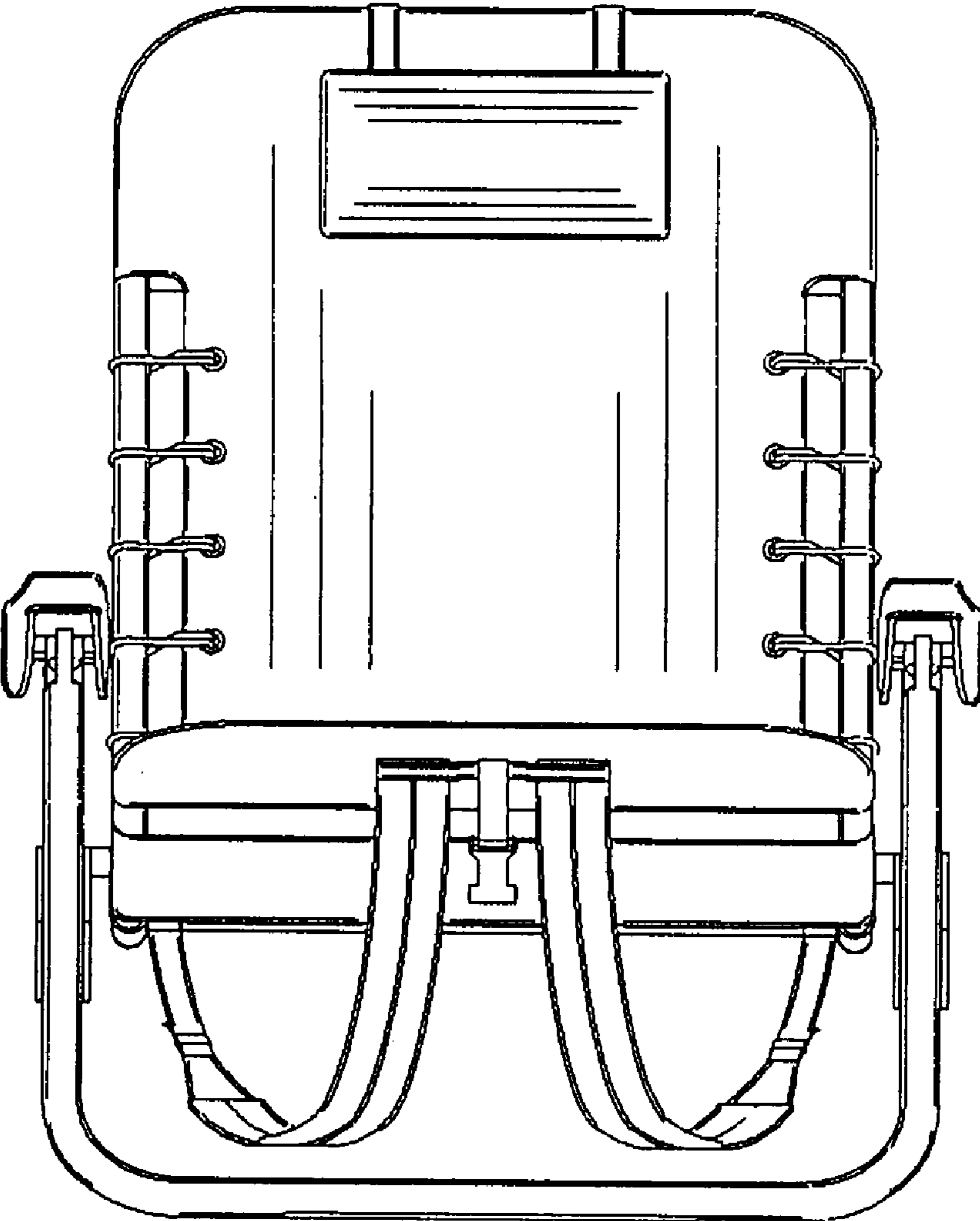

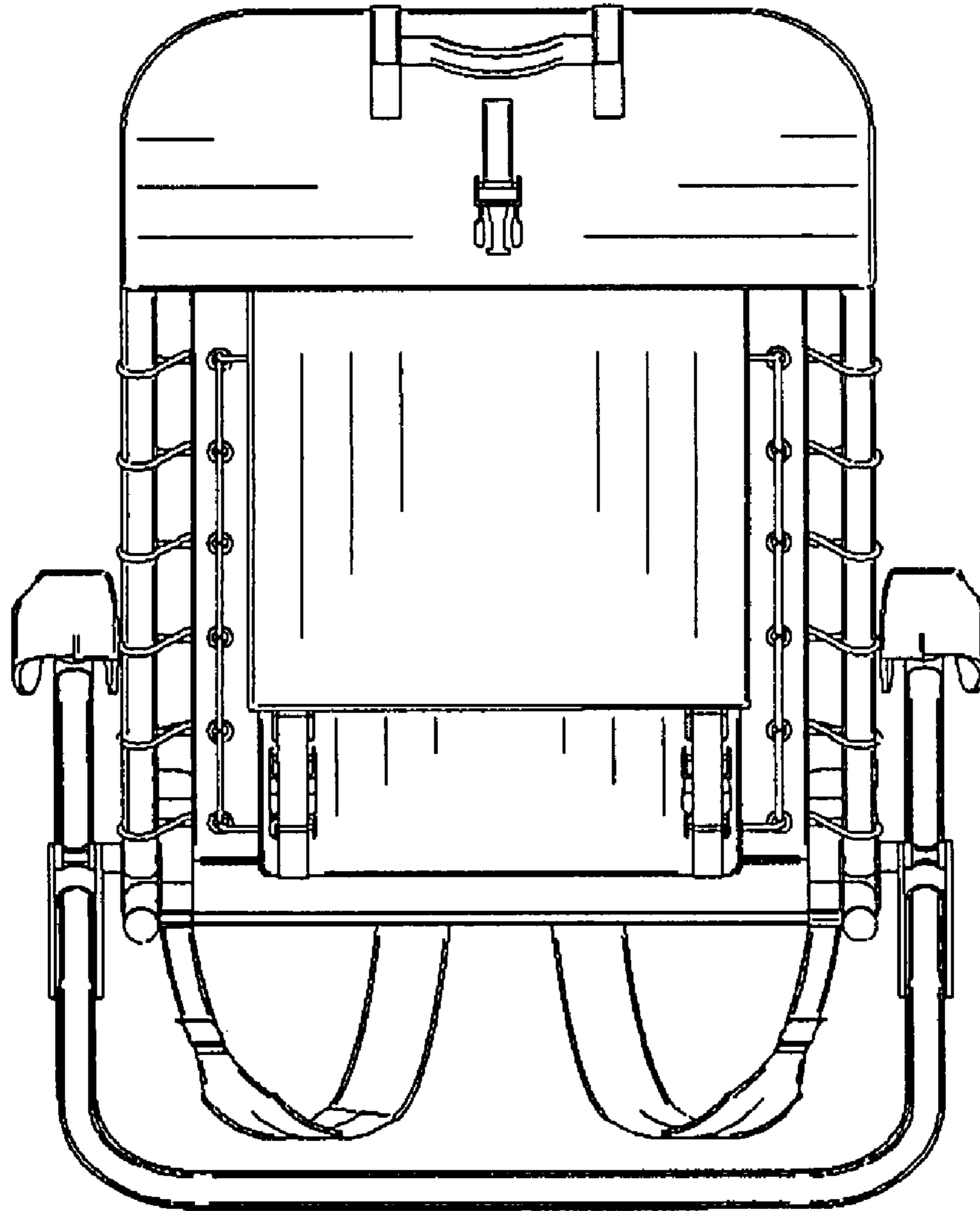

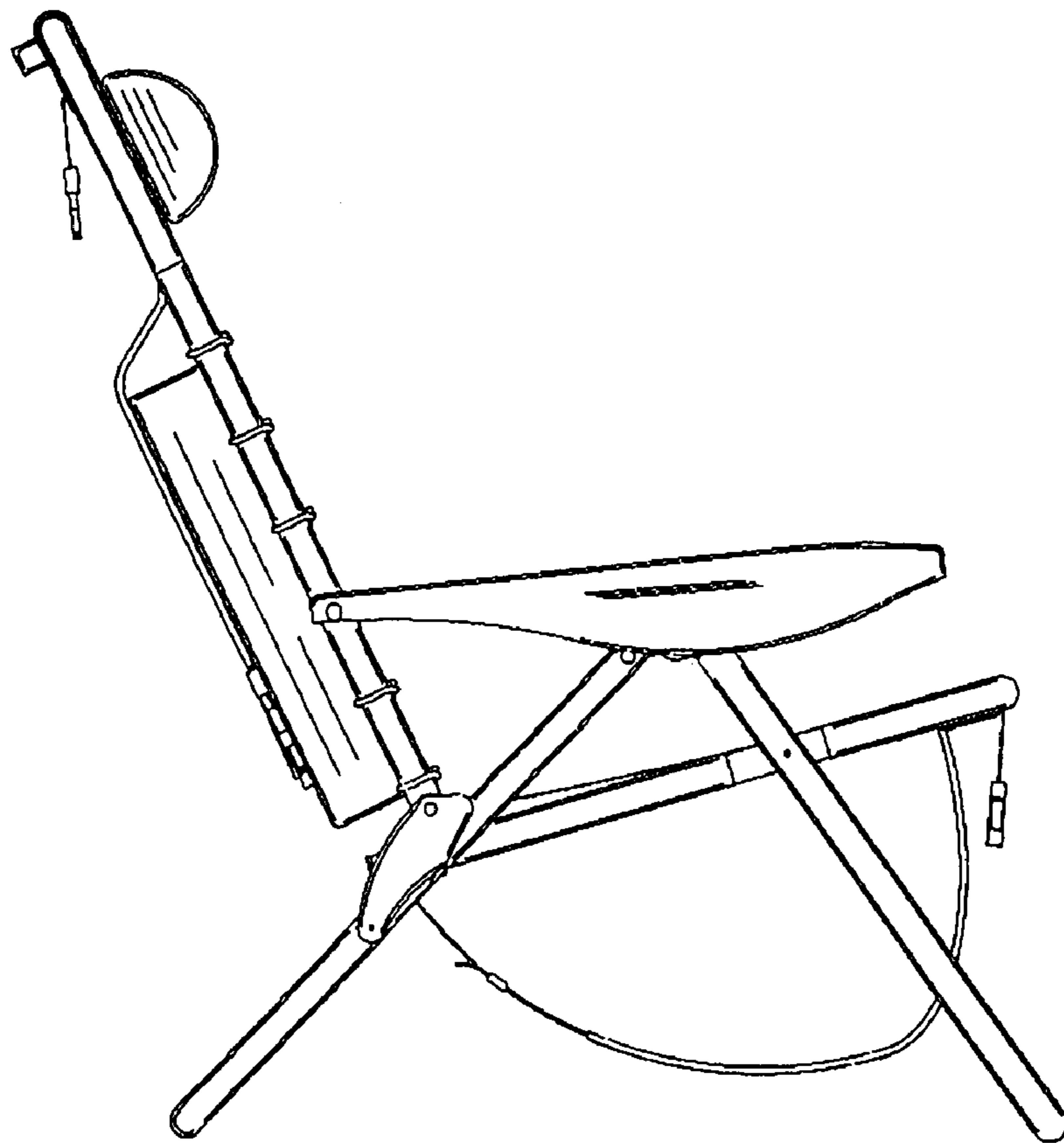

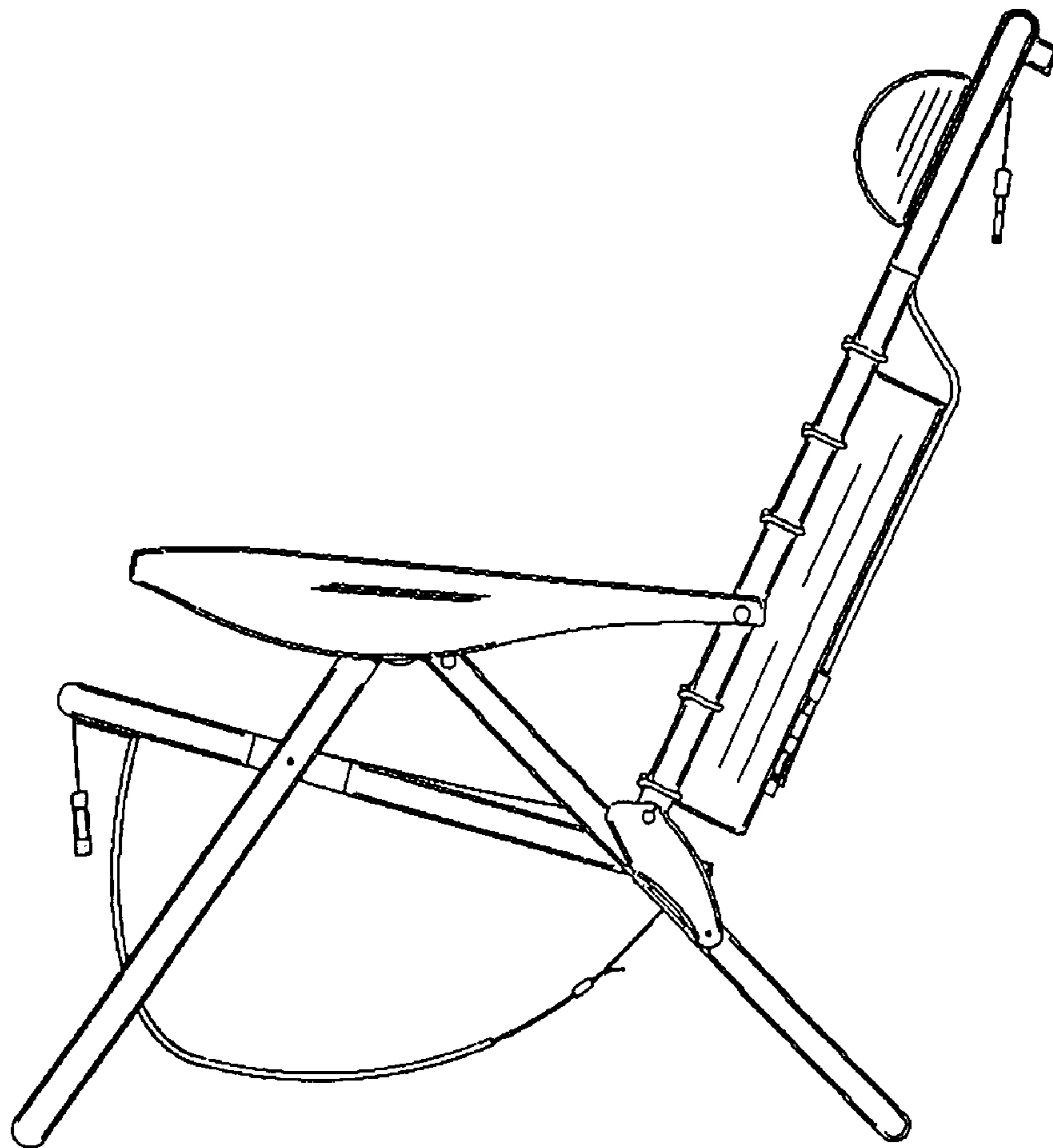

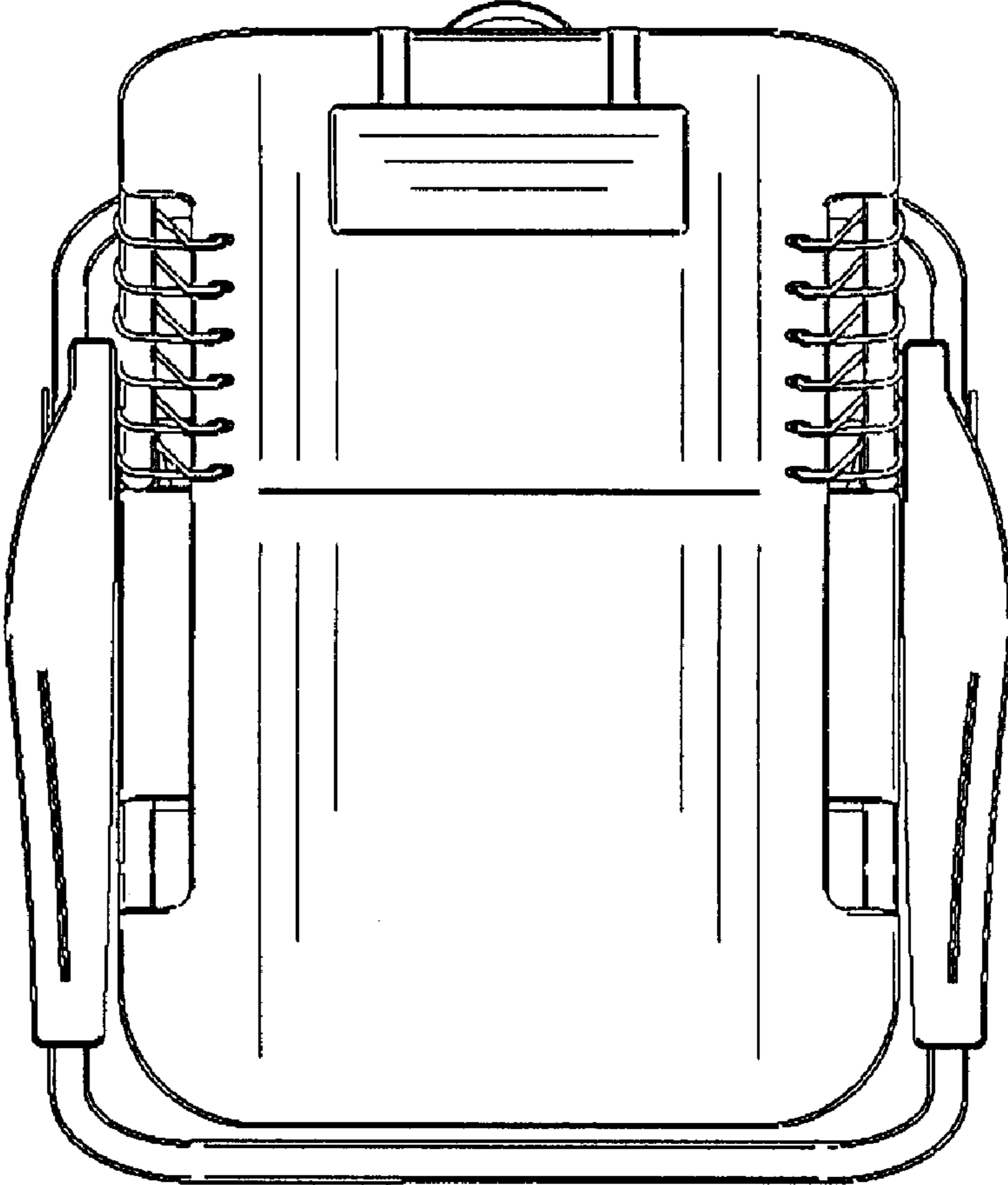

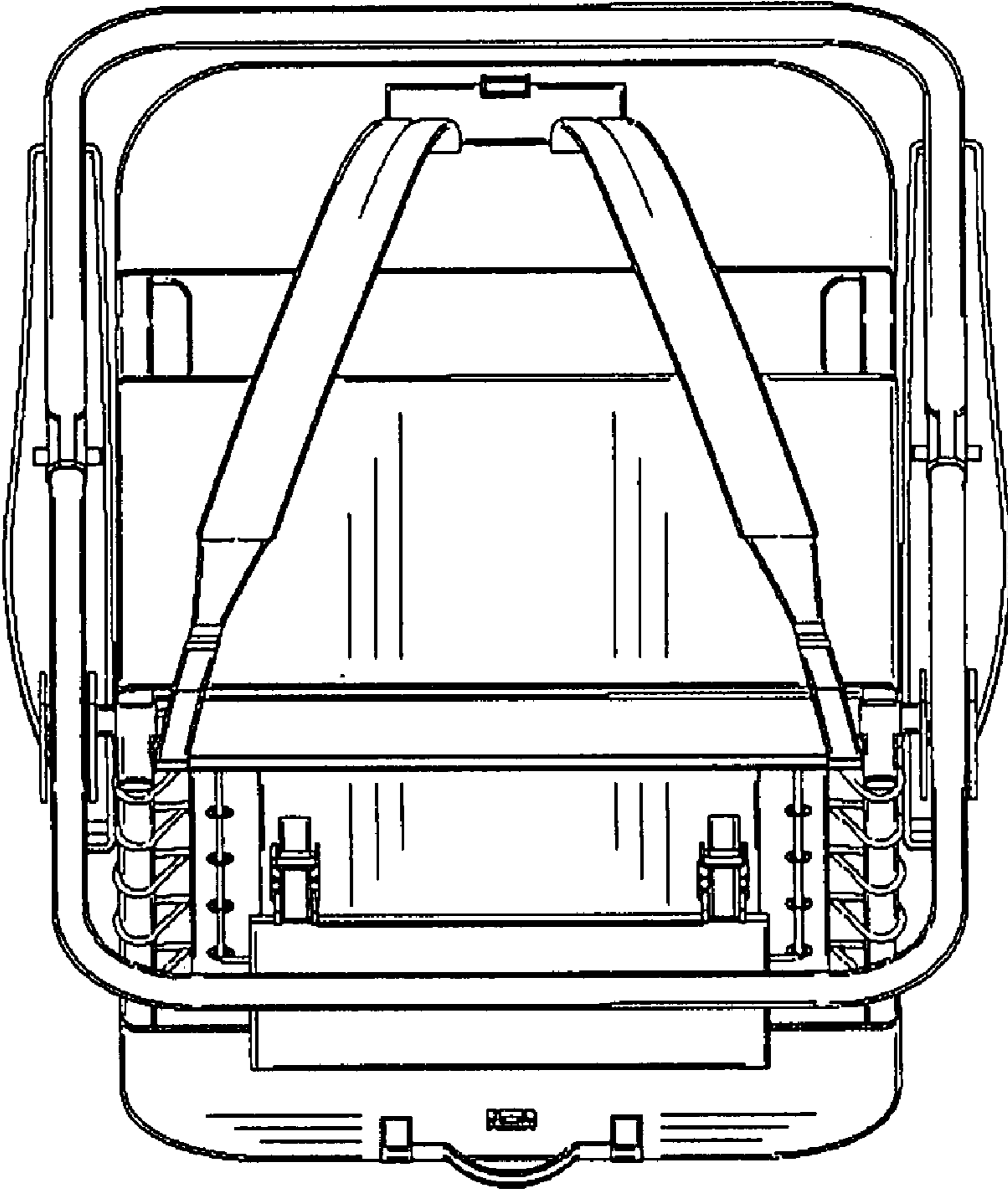

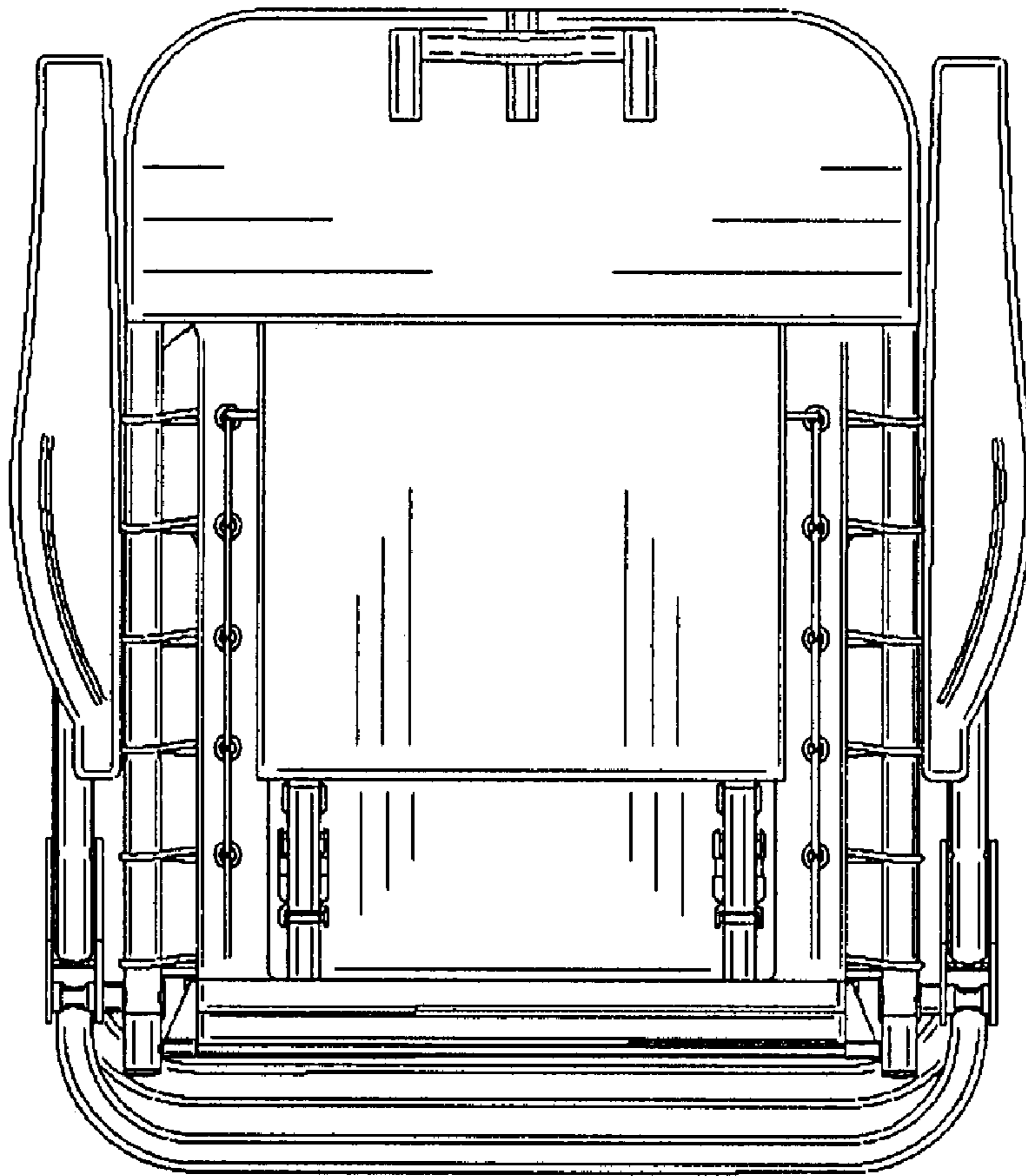

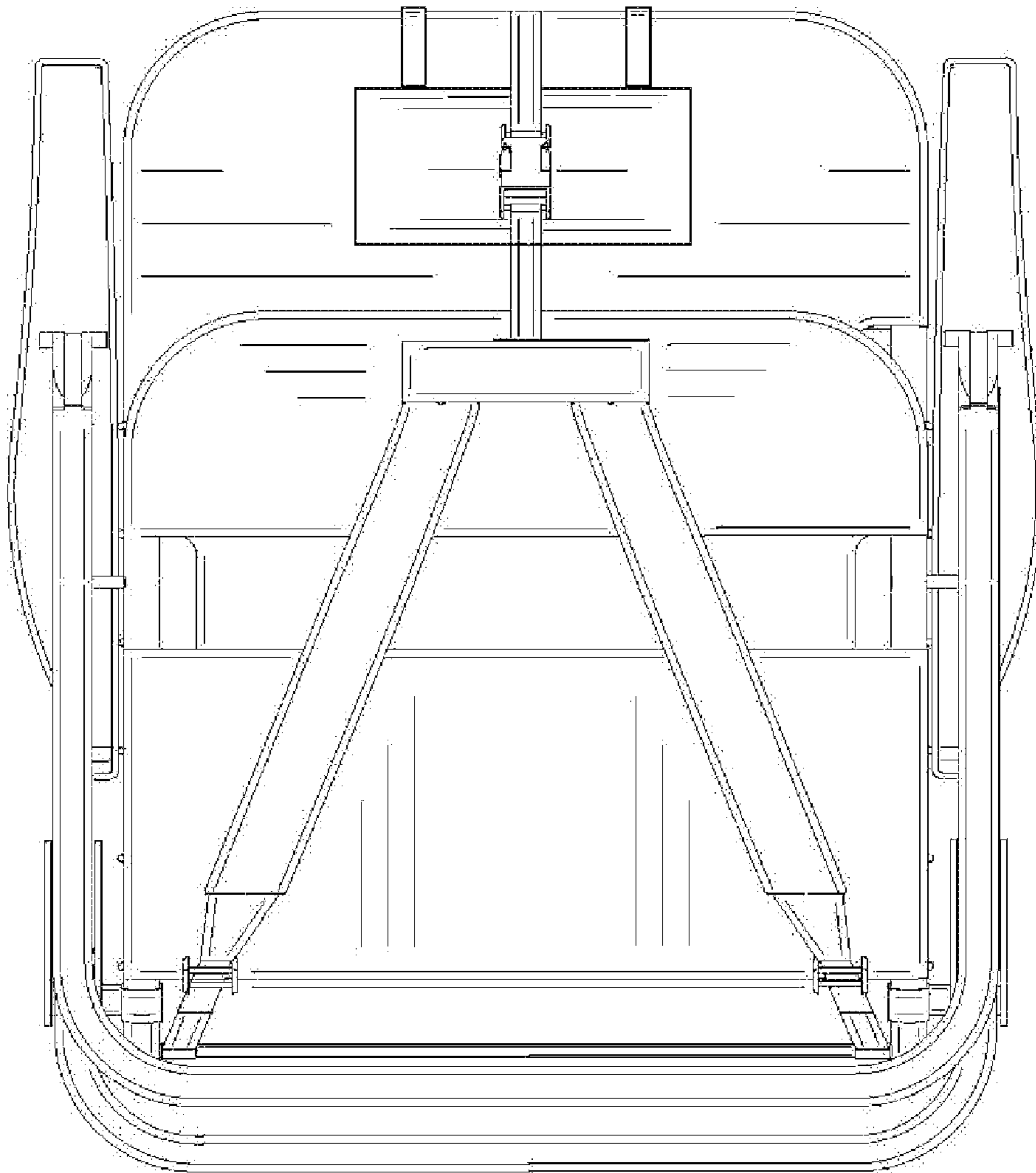

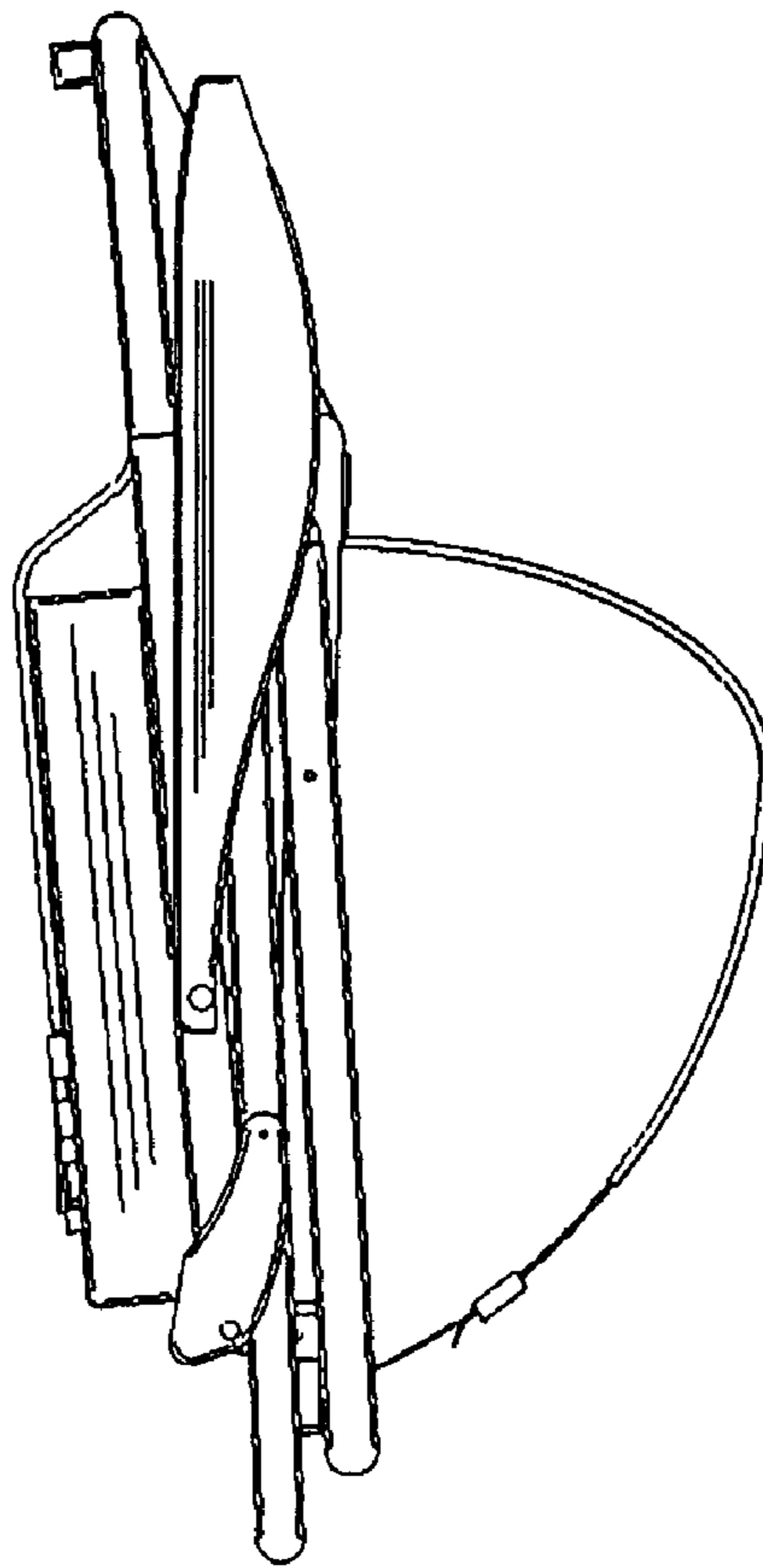

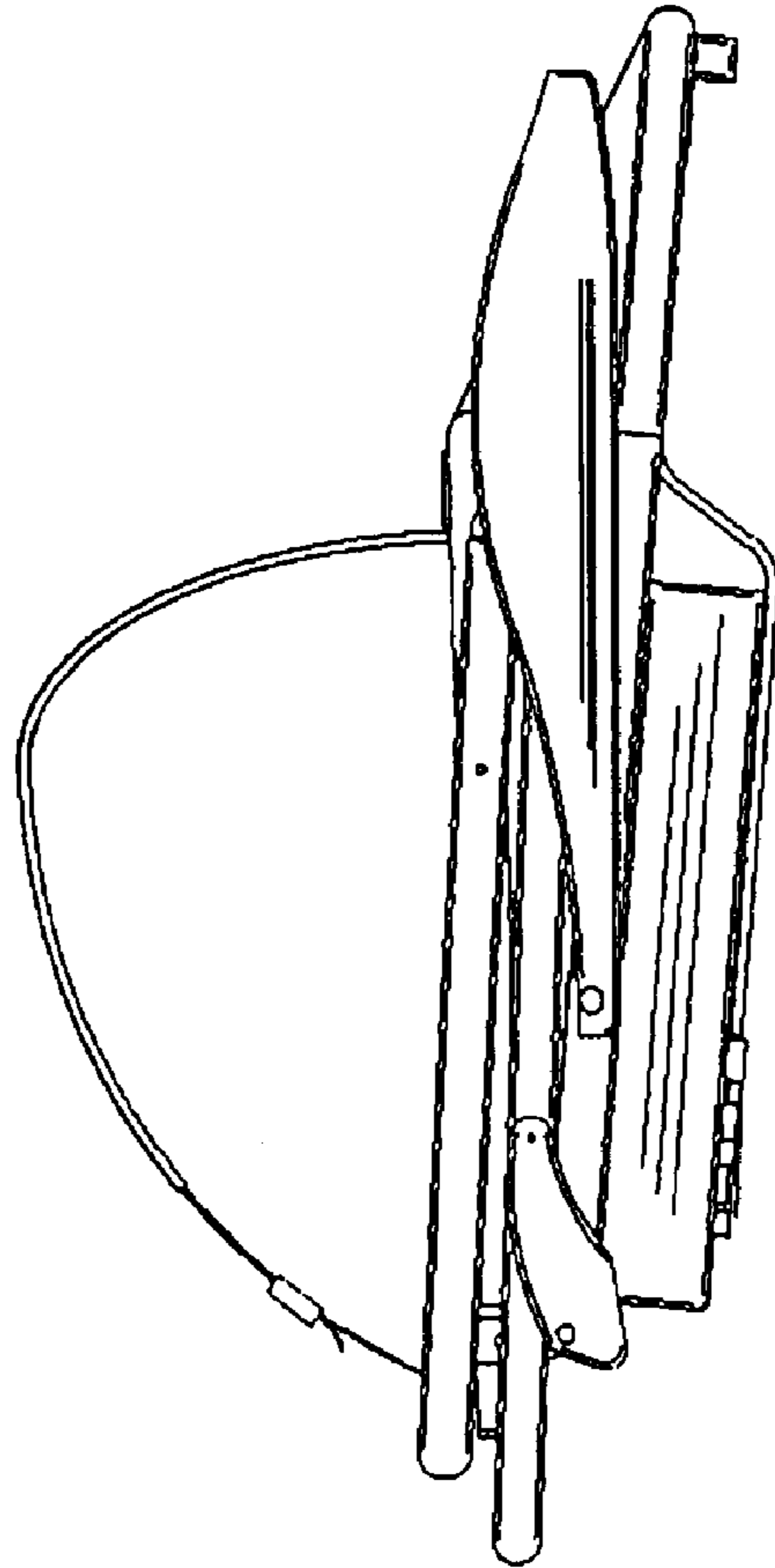
