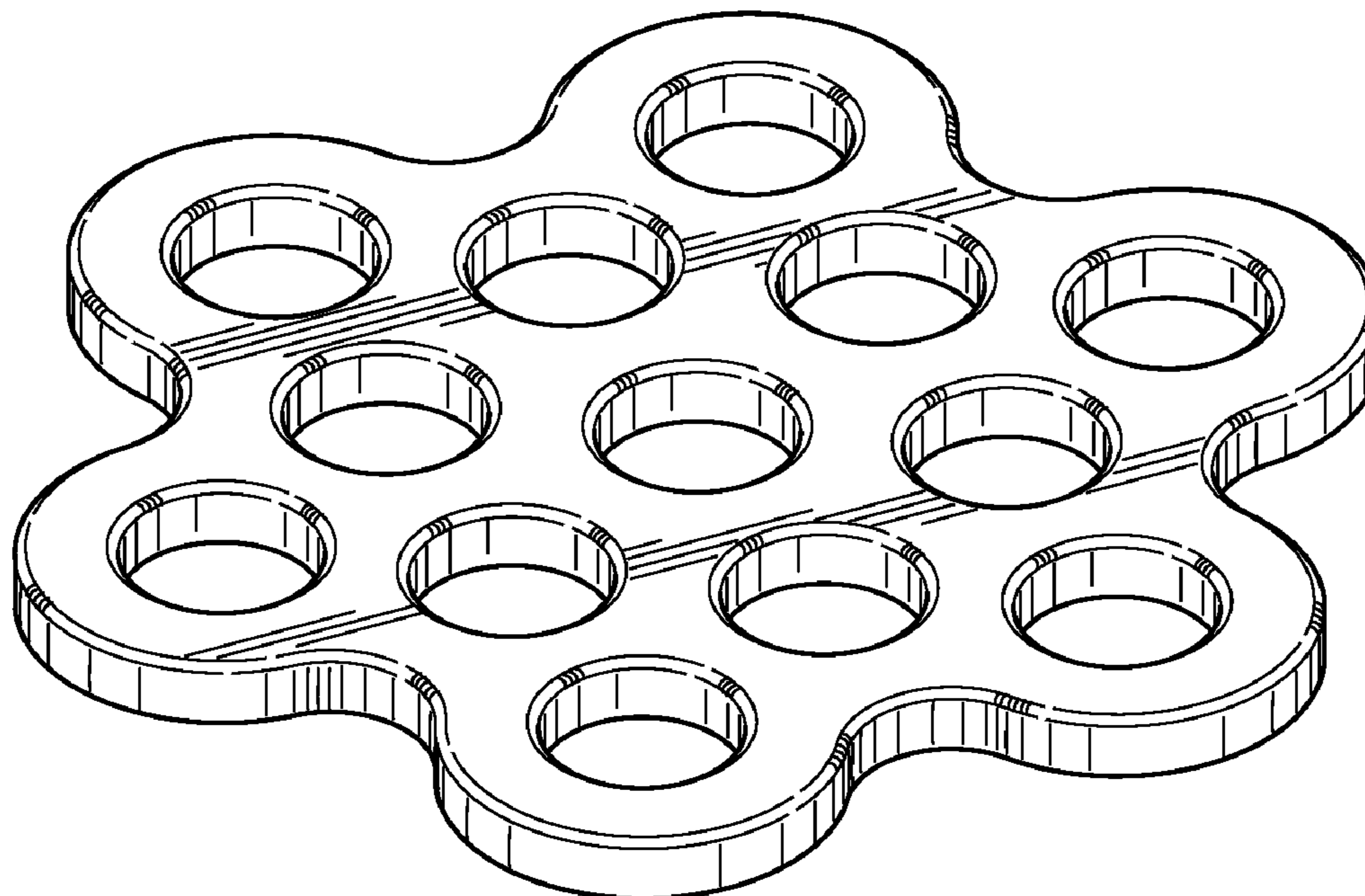
(57) **CLAIM**

The ornamental design for a rigging plate, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a top side of the rigging plate; FIG. 2 is an isometric view of a bottom side thereof; FIG. 3 is a plan view of the top side thereof; FIG. 4 is a side elevation view of a first side thereof; and, FIG. 5 is a side elevation view of a second side thereof.

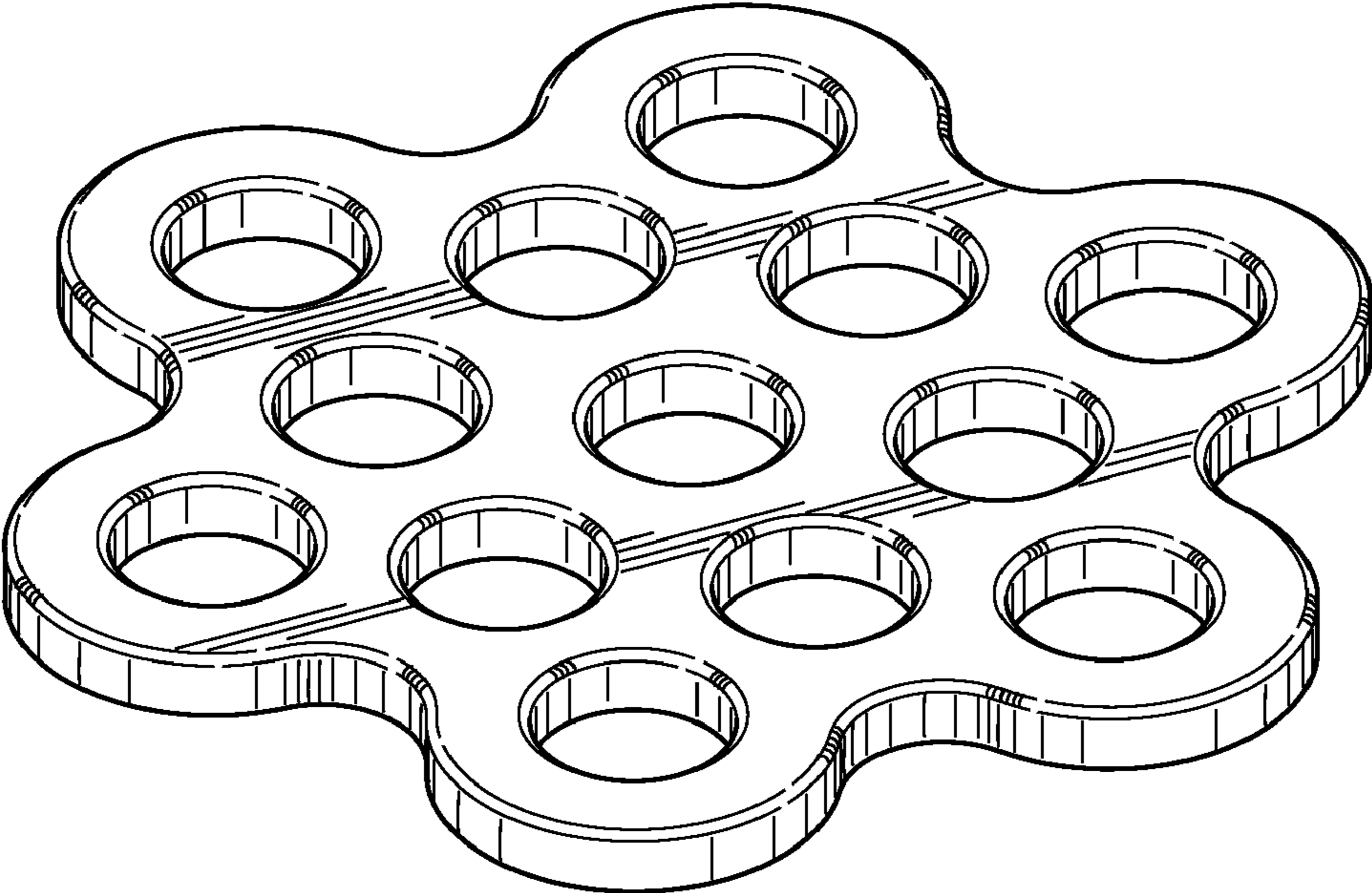

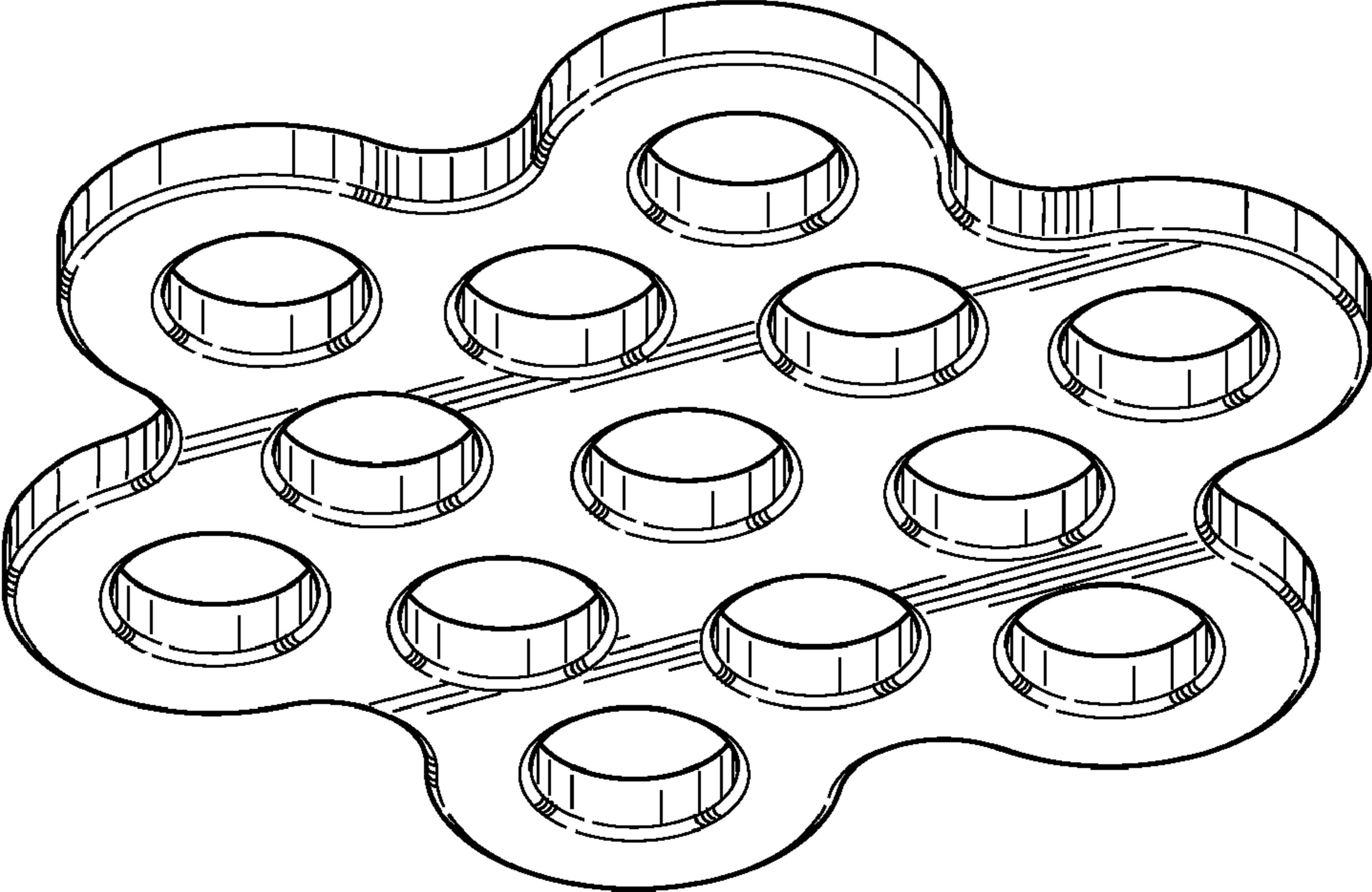

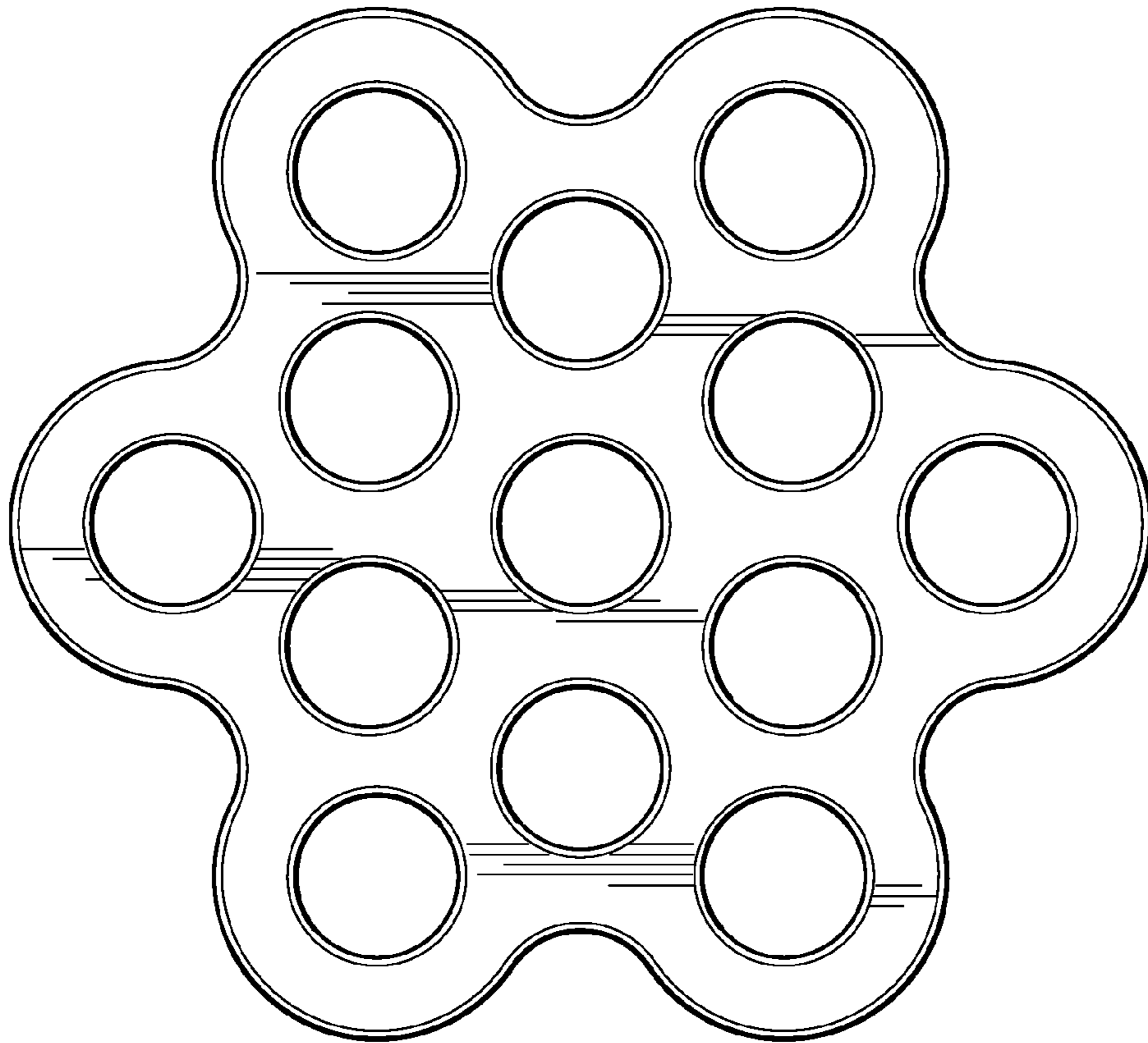

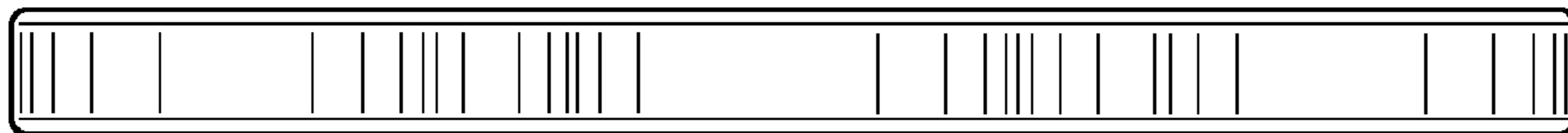

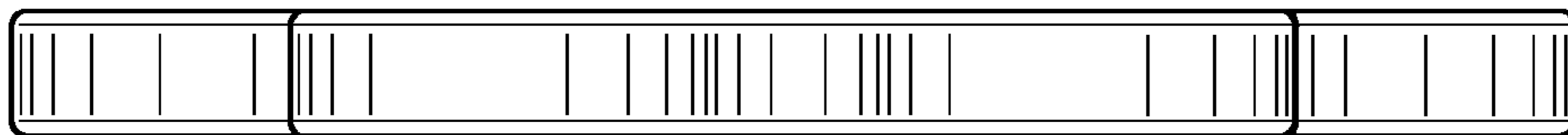
