(57) **CLAIM**

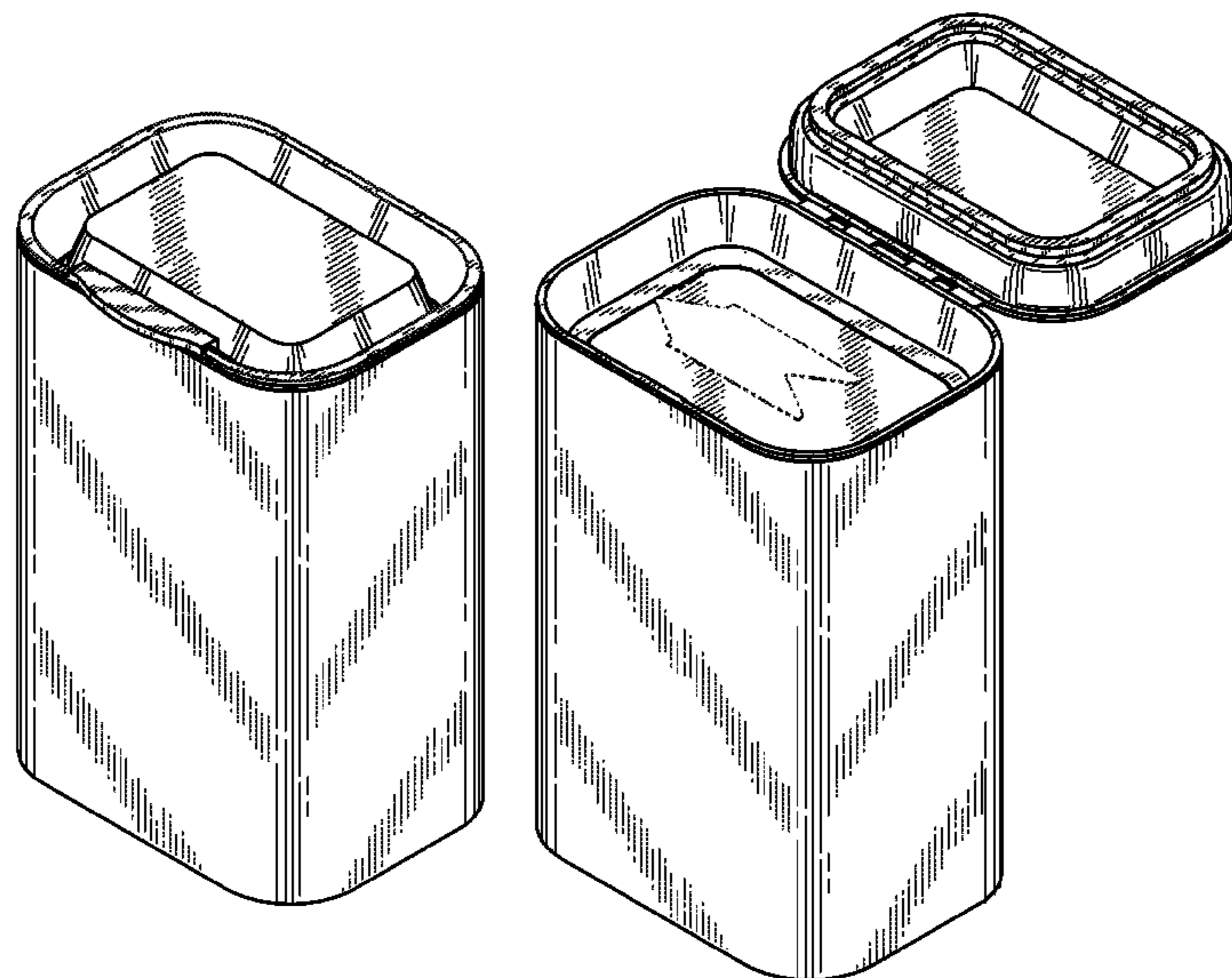
We claim the ornamental design for a flexible container and lid, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a flexible container and lid;  
 FIG. 2 is a front side view of the flexible container and lid;  
 FIG. 3 is a back side view of the flexible container and lid;  
 FIG. 4 is a right side view of the flexible container and lid;  
 FIG. 5 is a left side view of the flexible container and lid;  
 FIG. 6 is a top view of the flexible container and lid;  
 FIG. 7 is a bottom view of the flexible container and lid;  
 FIG. 8 is a perspective view of the flexible container and lid with the lid in an open position;  
 FIG. 9 is a front side view of the flexible container and lid with the lid in an open position;  
 FIG. 10 is a back side view of the flexible container and lid with the lid in an open position;  
 FIG. 11 is a right side view of the flexible container and lid with the lid in an open position;  
 FIG. 12 is a left side view of the flexible container and lid with the lid in an open position;  
 FIG. 13 is a top view of the flexible container and lid with the lid in an open position; and,  
 FIG. 14 is a bottom view of the flexible container and lid with the lid in an open position.

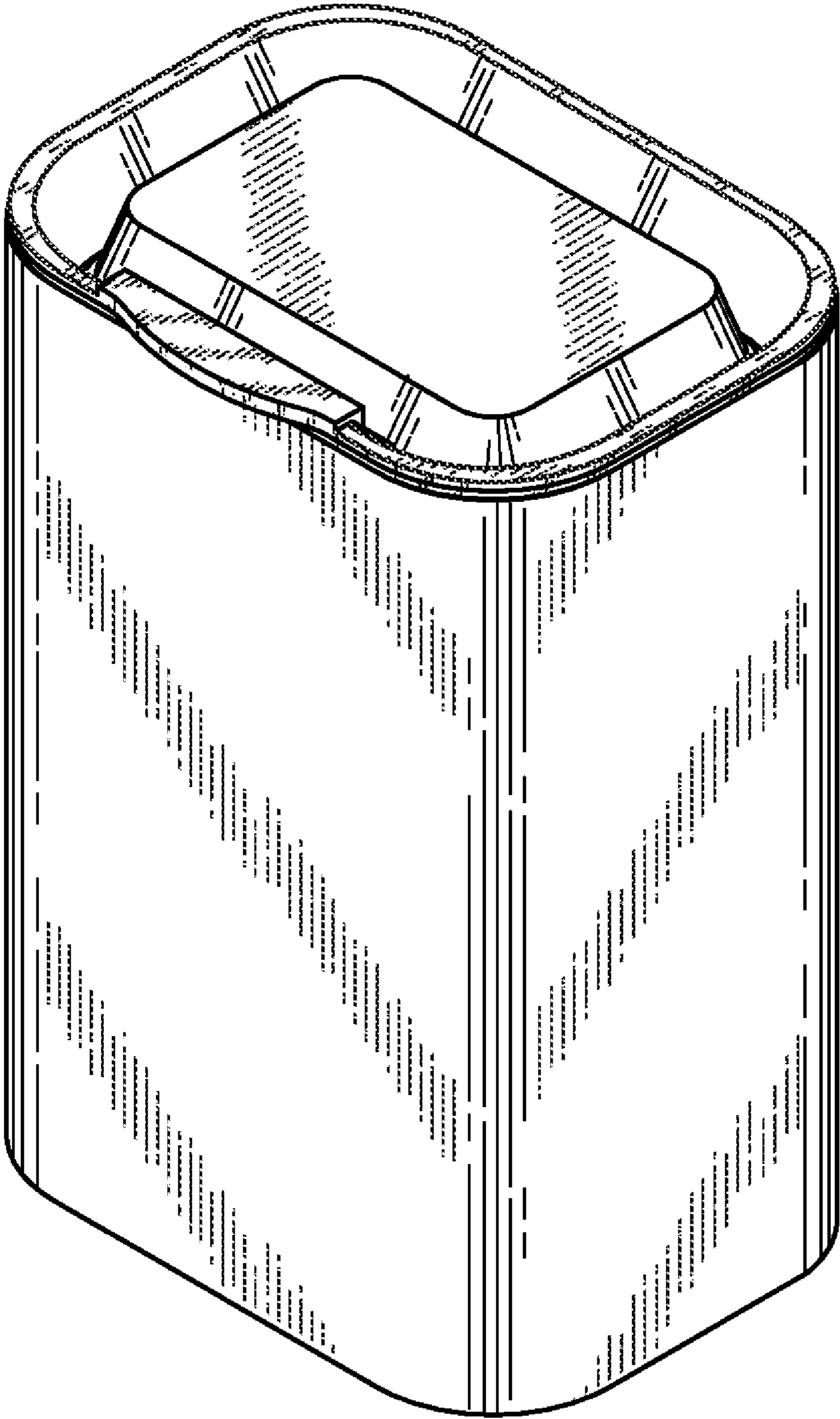

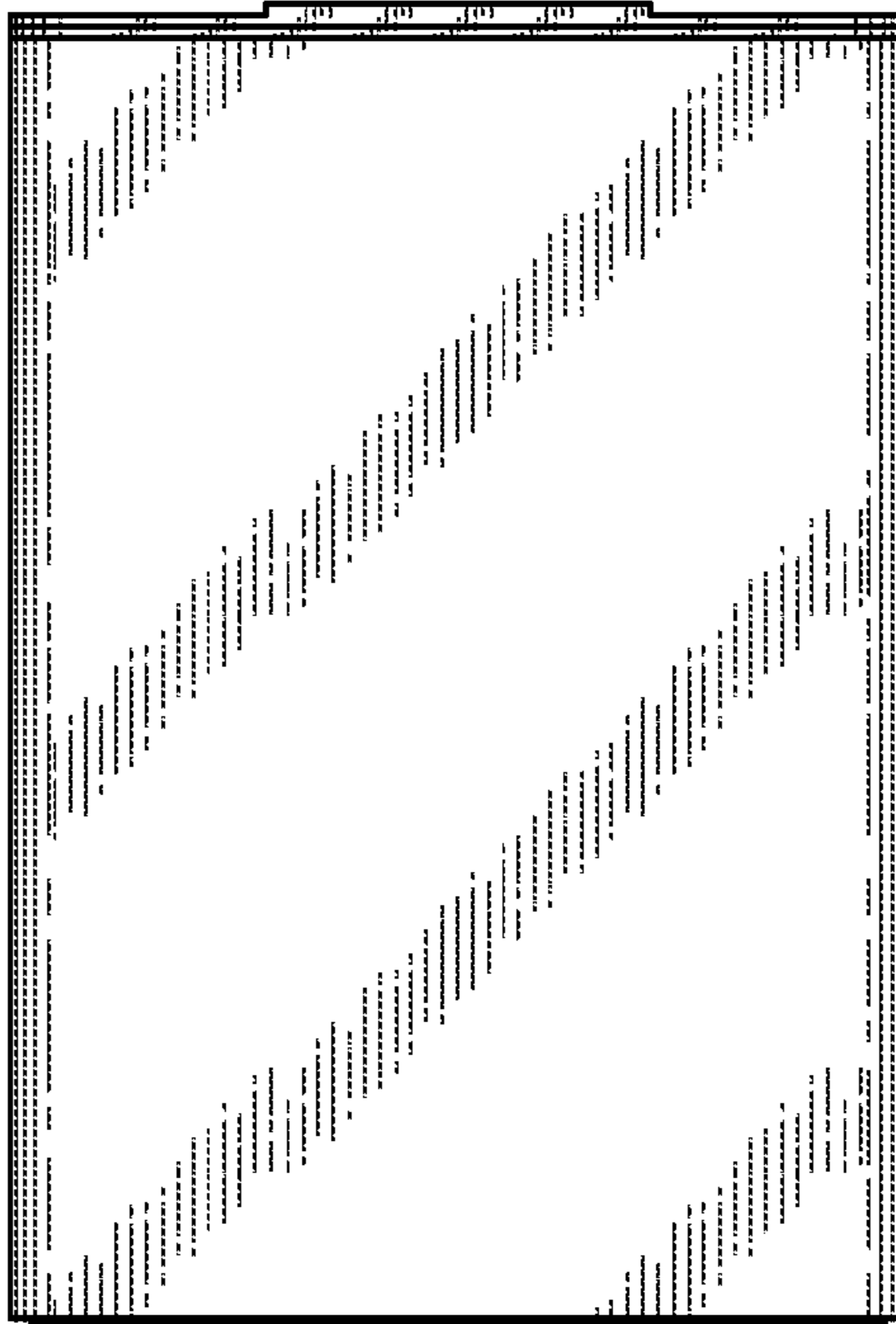

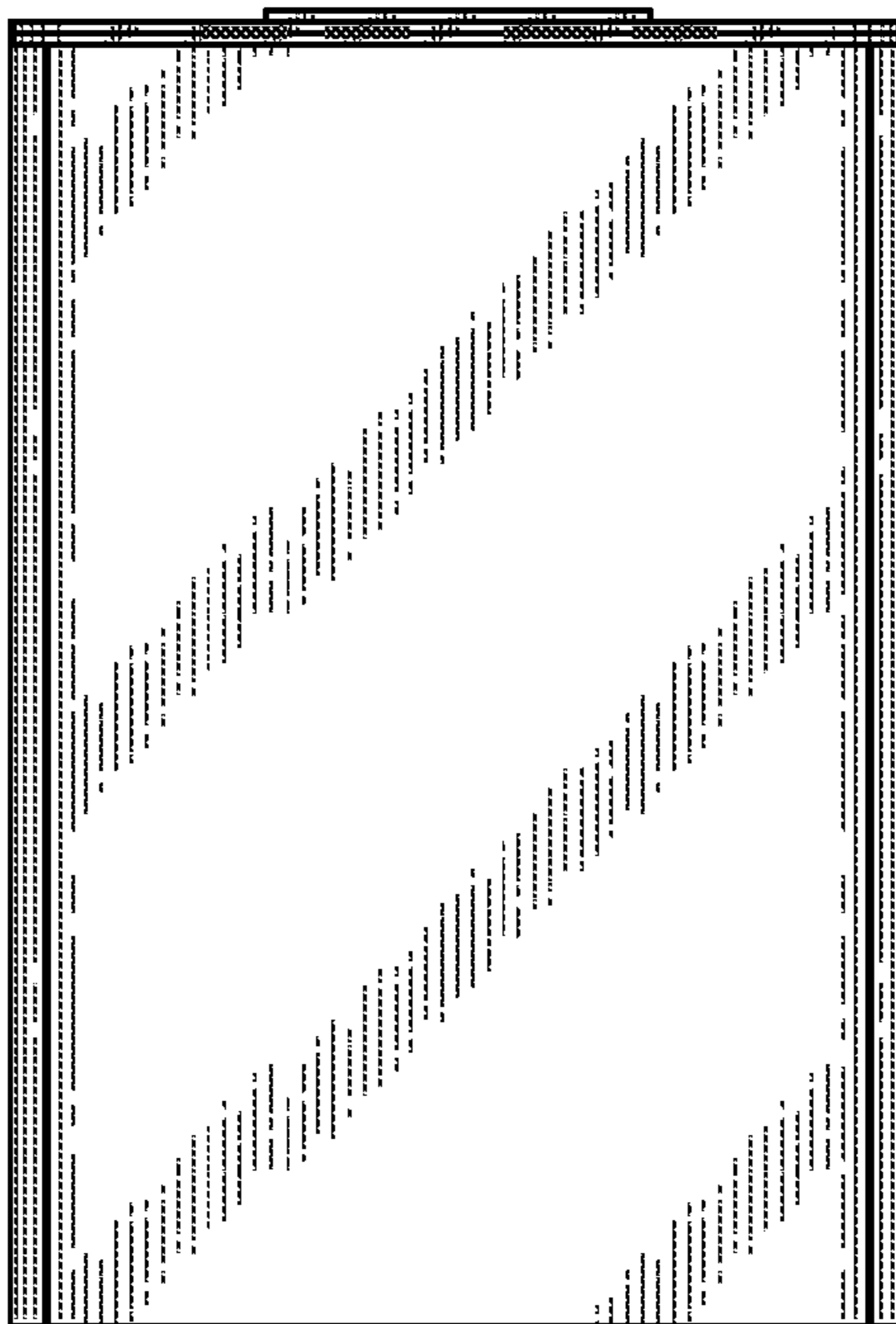

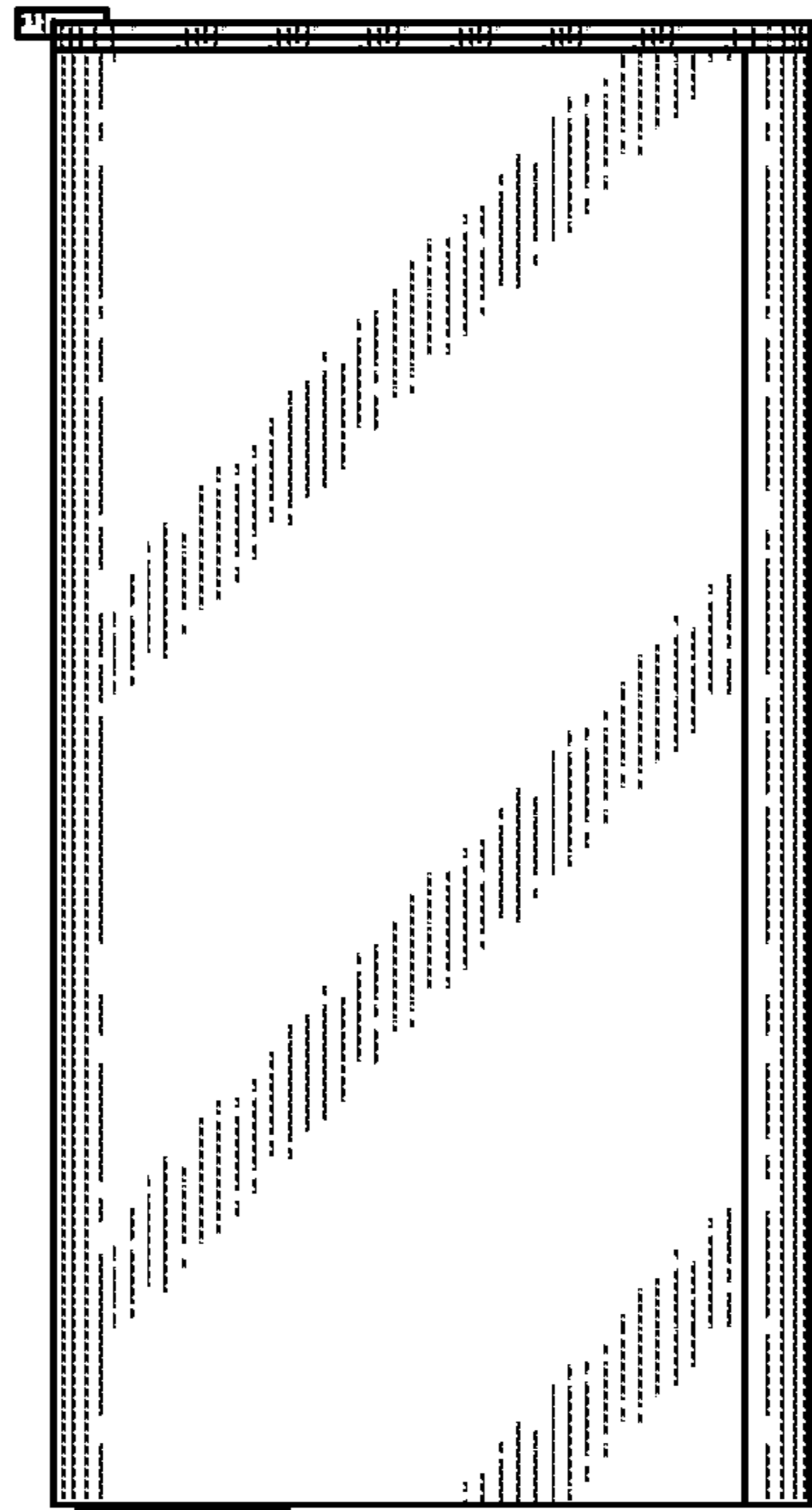

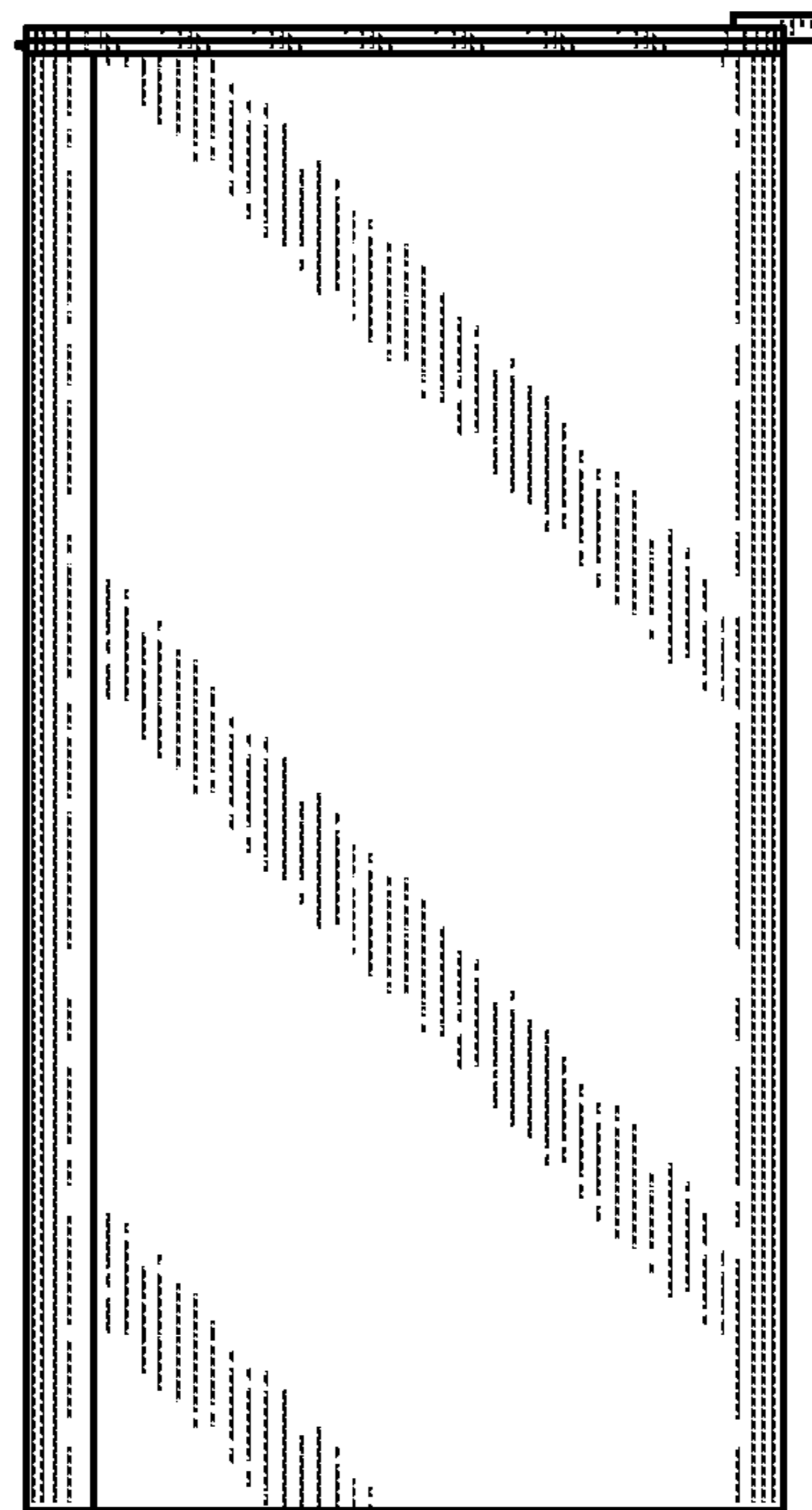

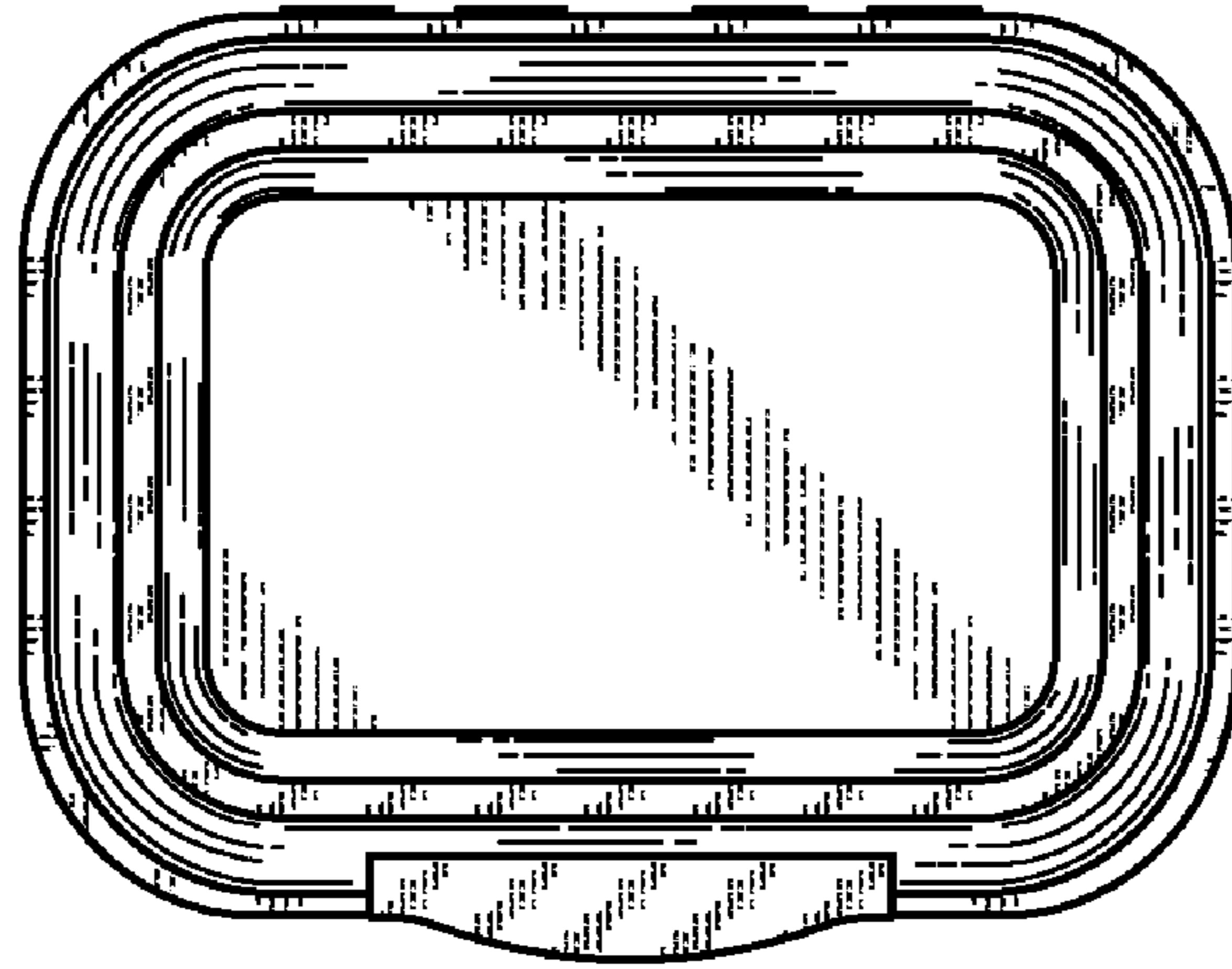

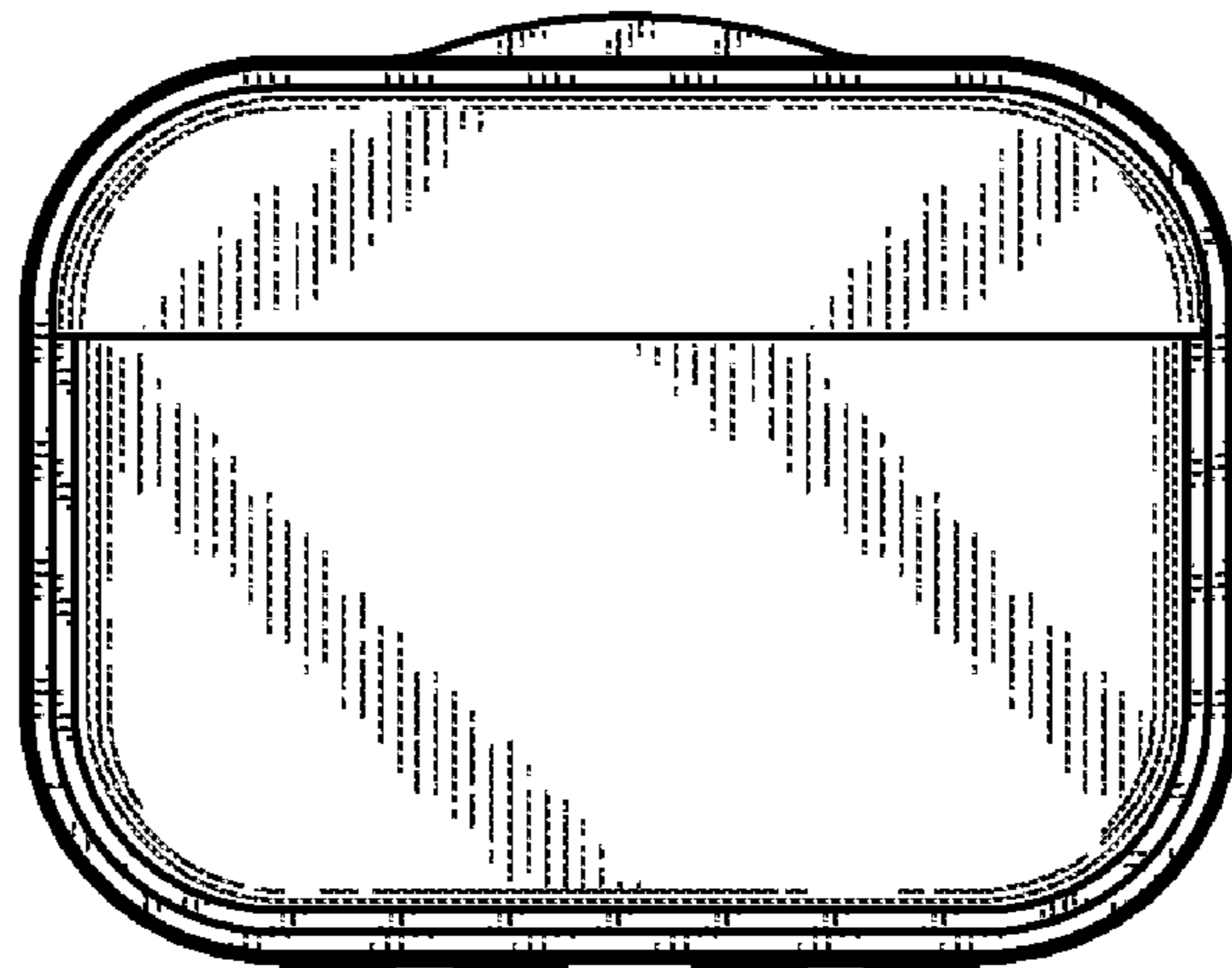

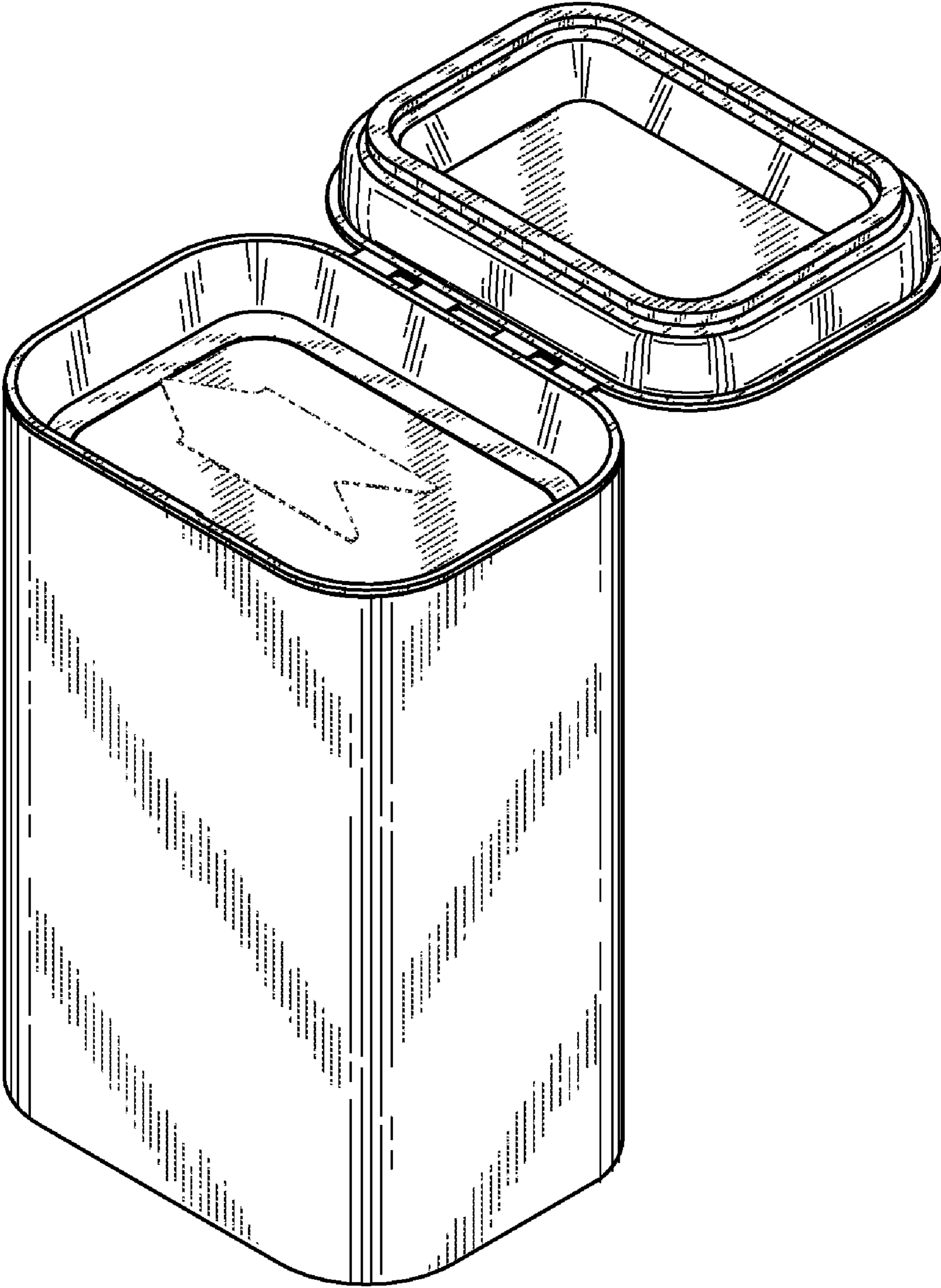

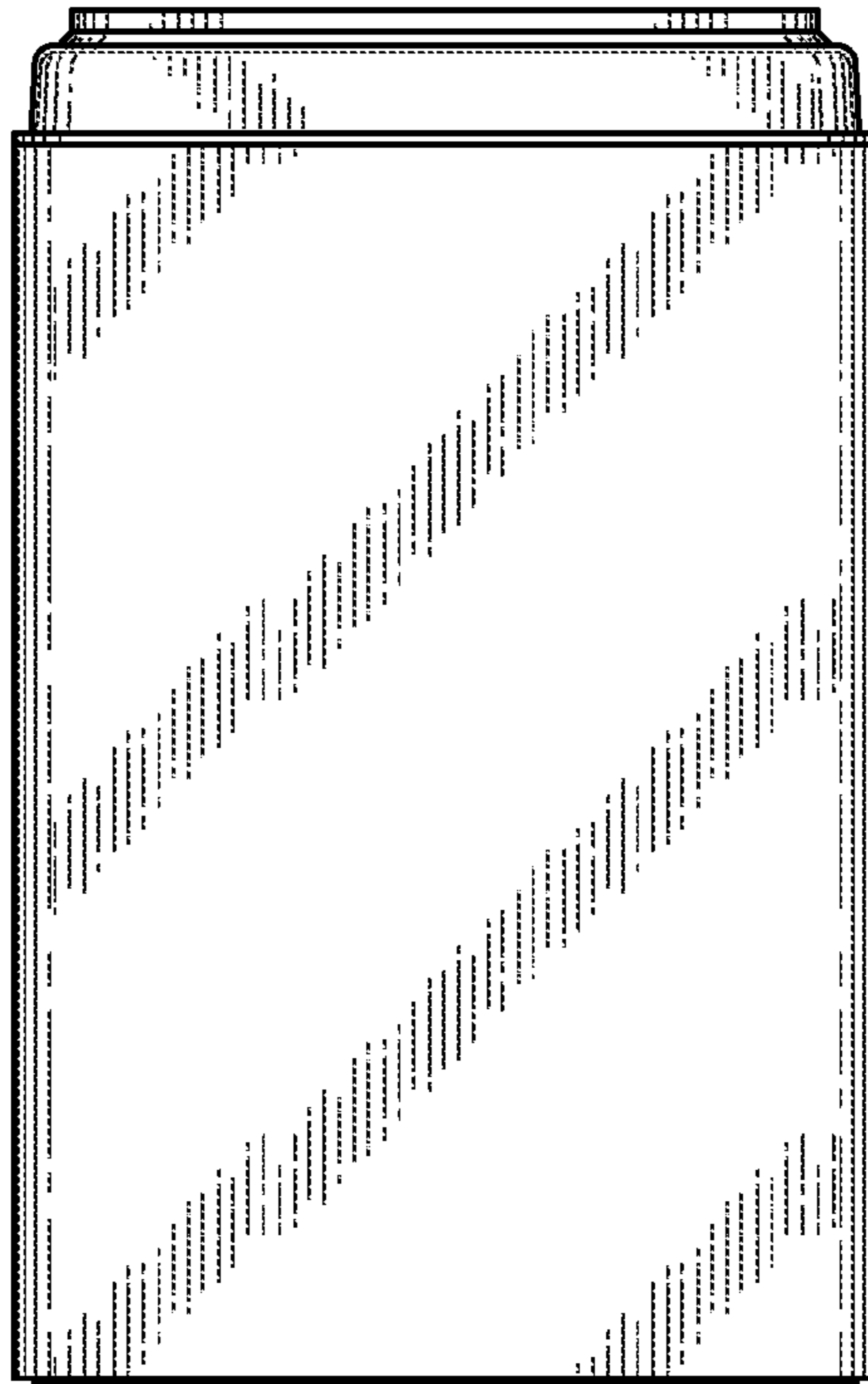

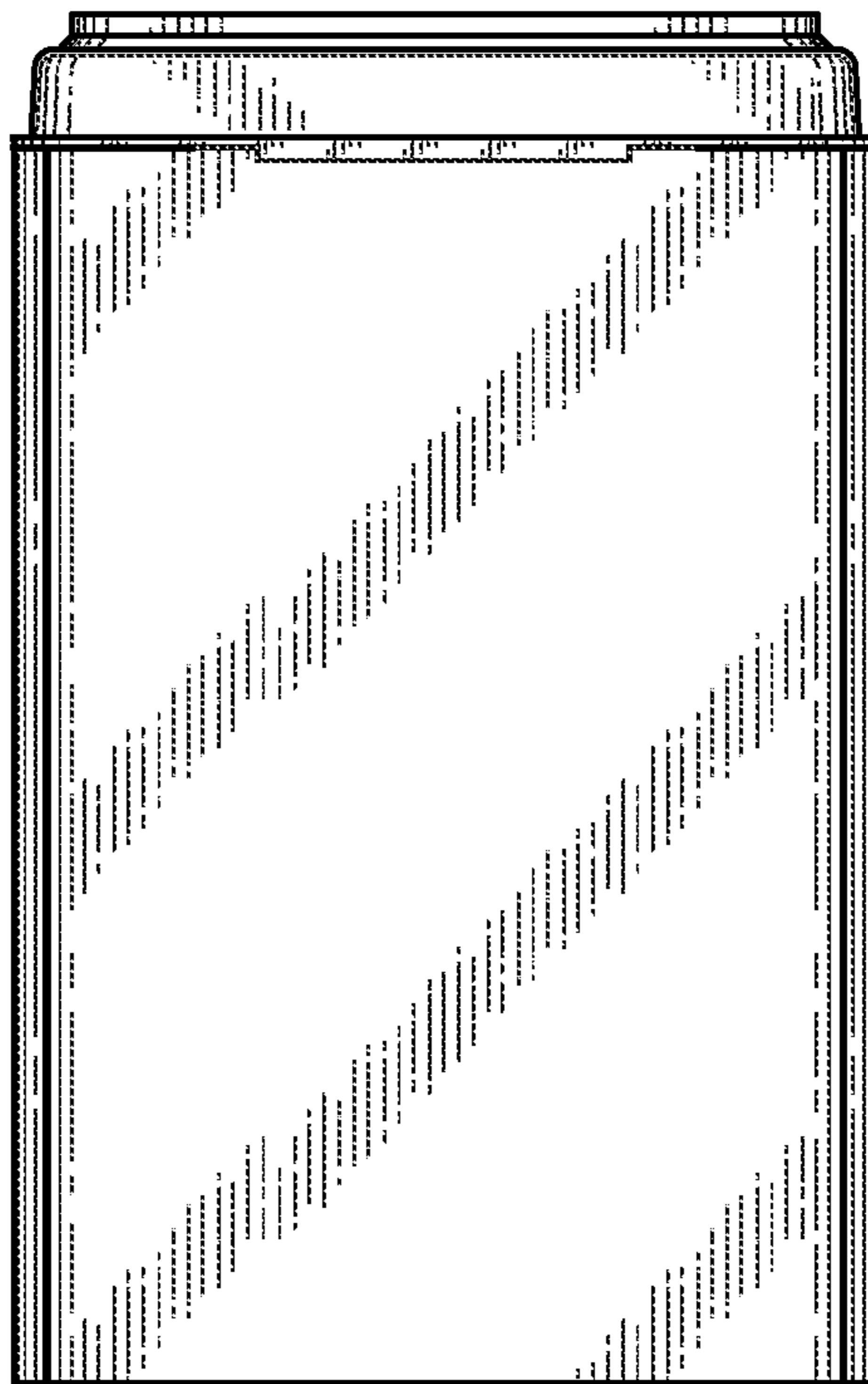

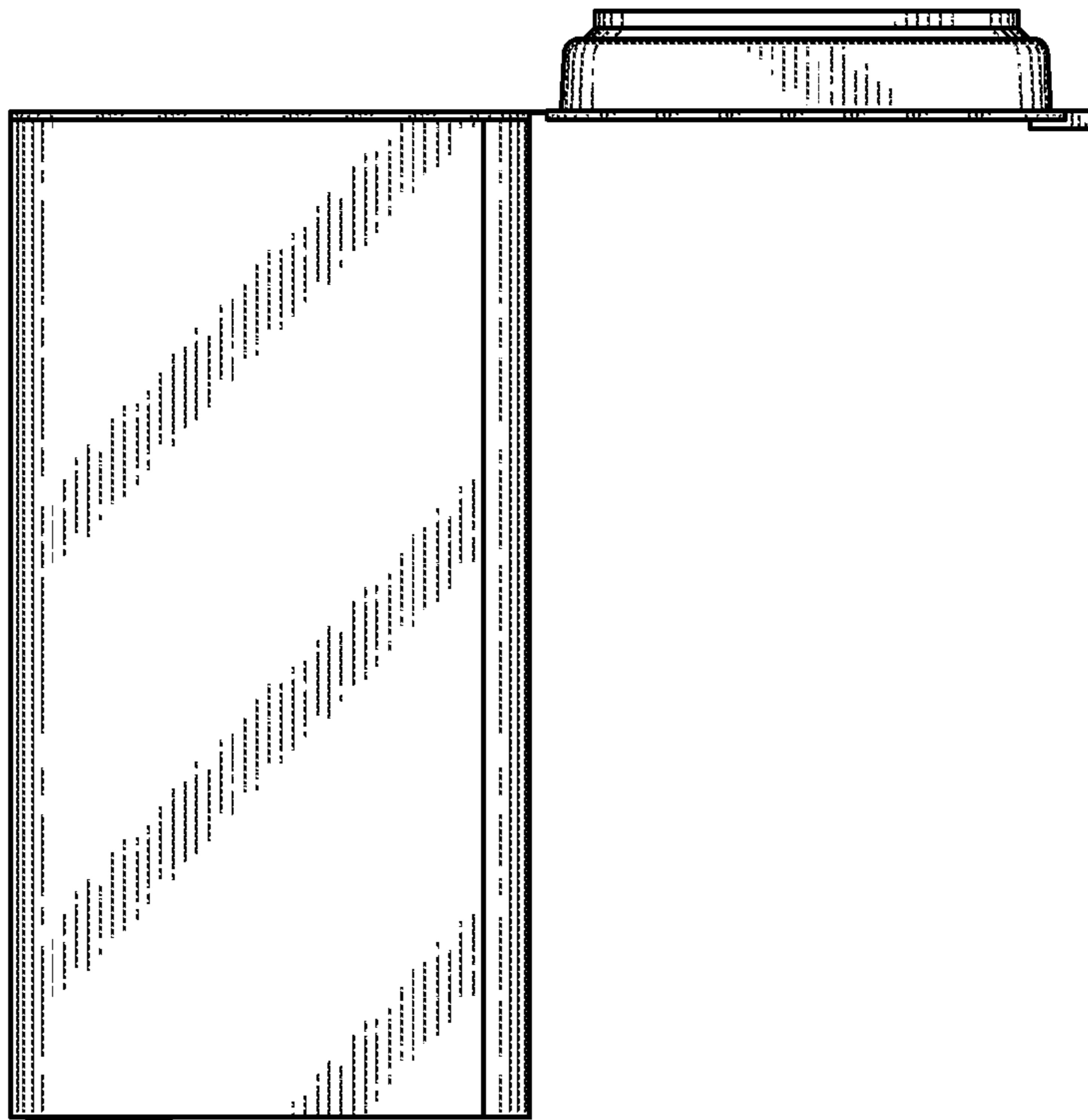

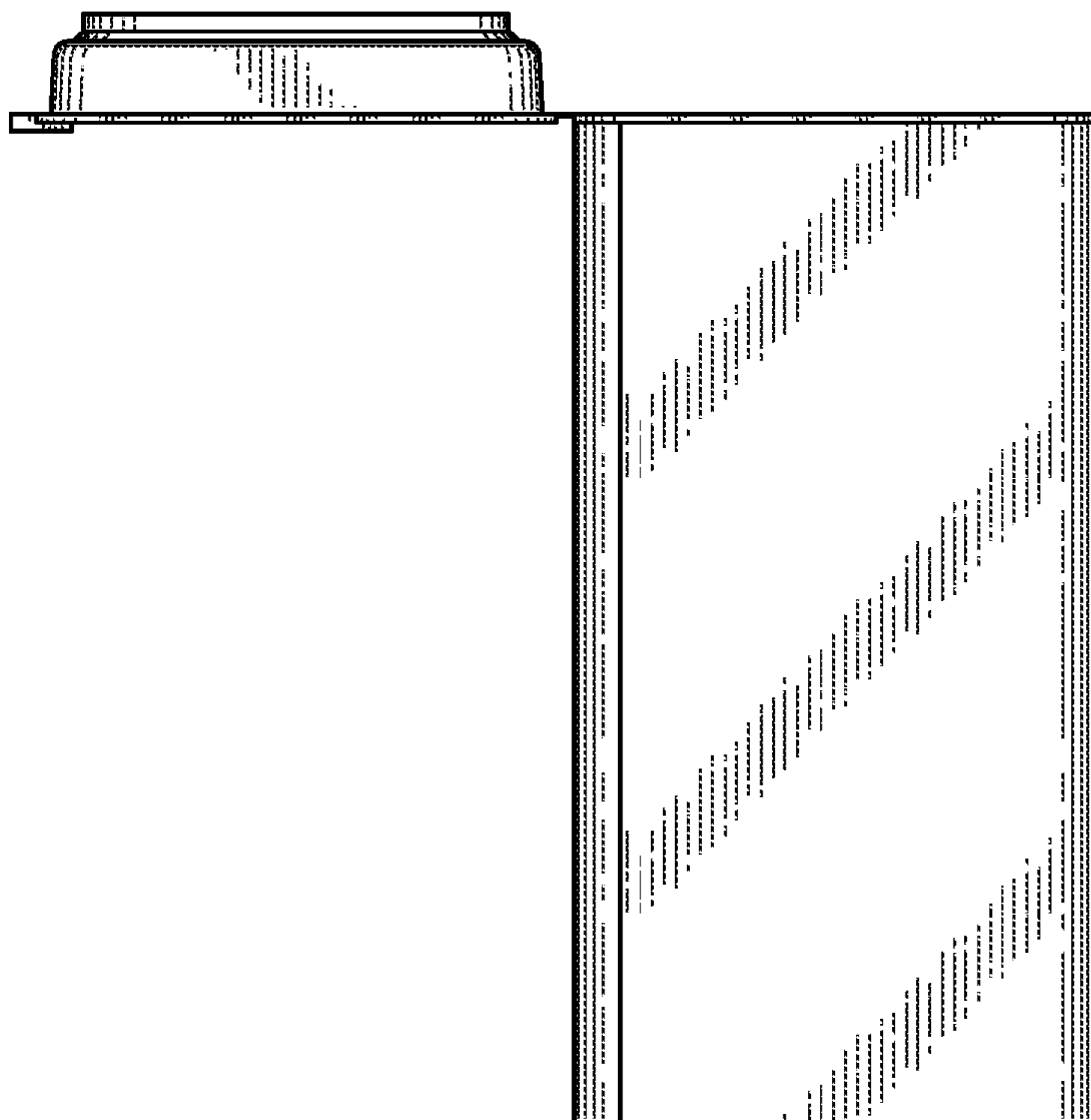

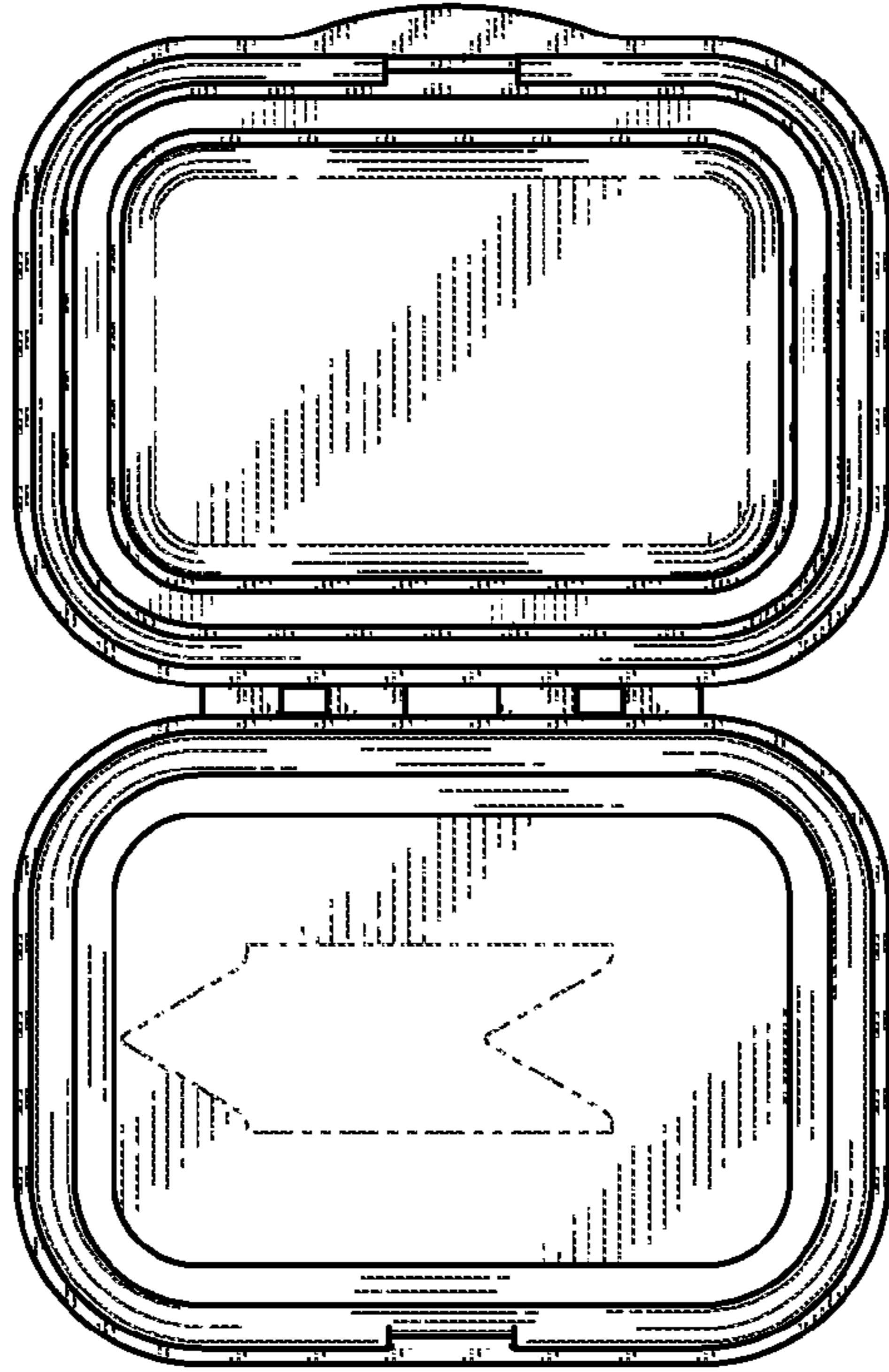

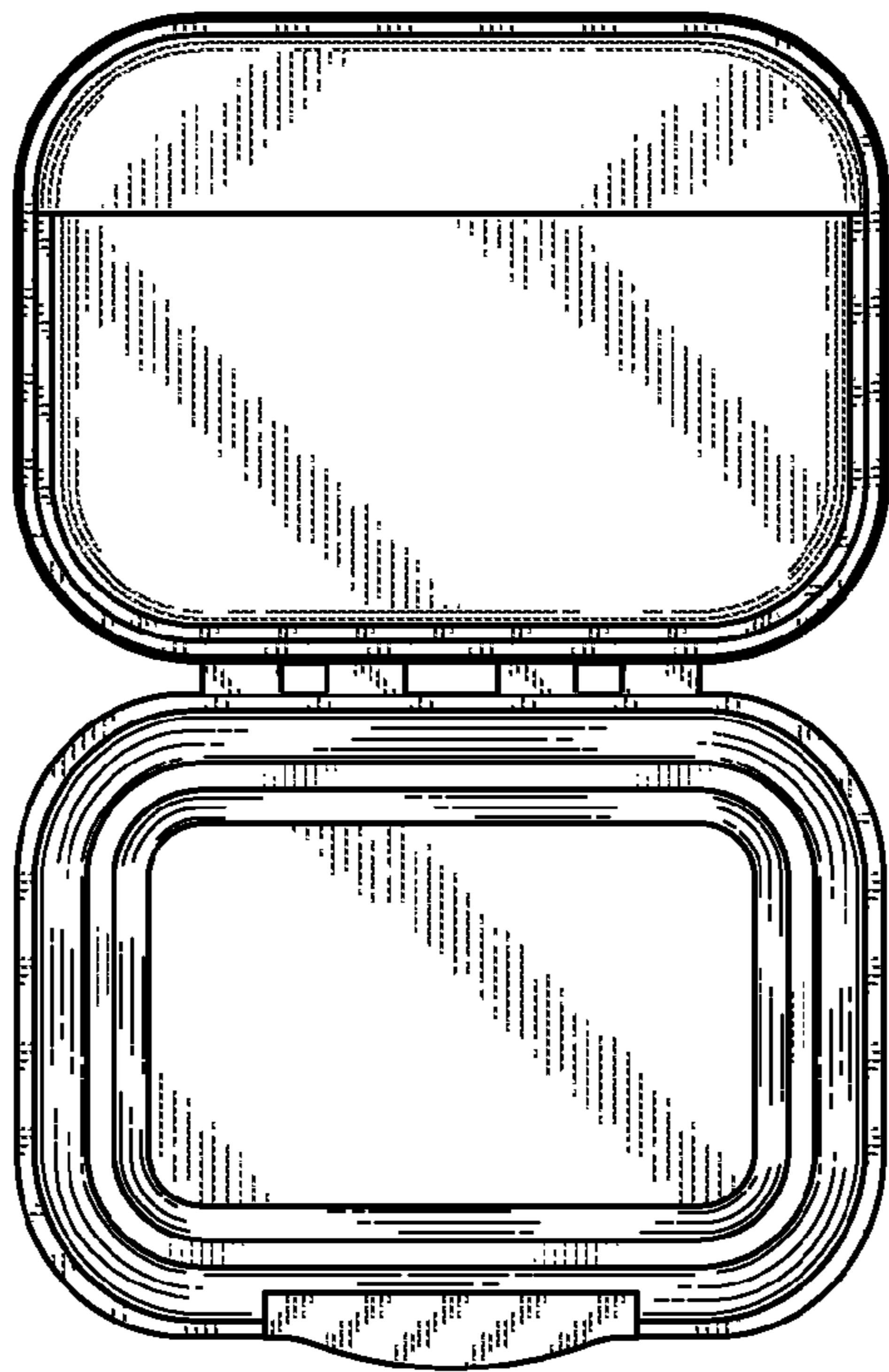
