FIG. 14 is a top plan view of the lid for container of FIG. 11; and,

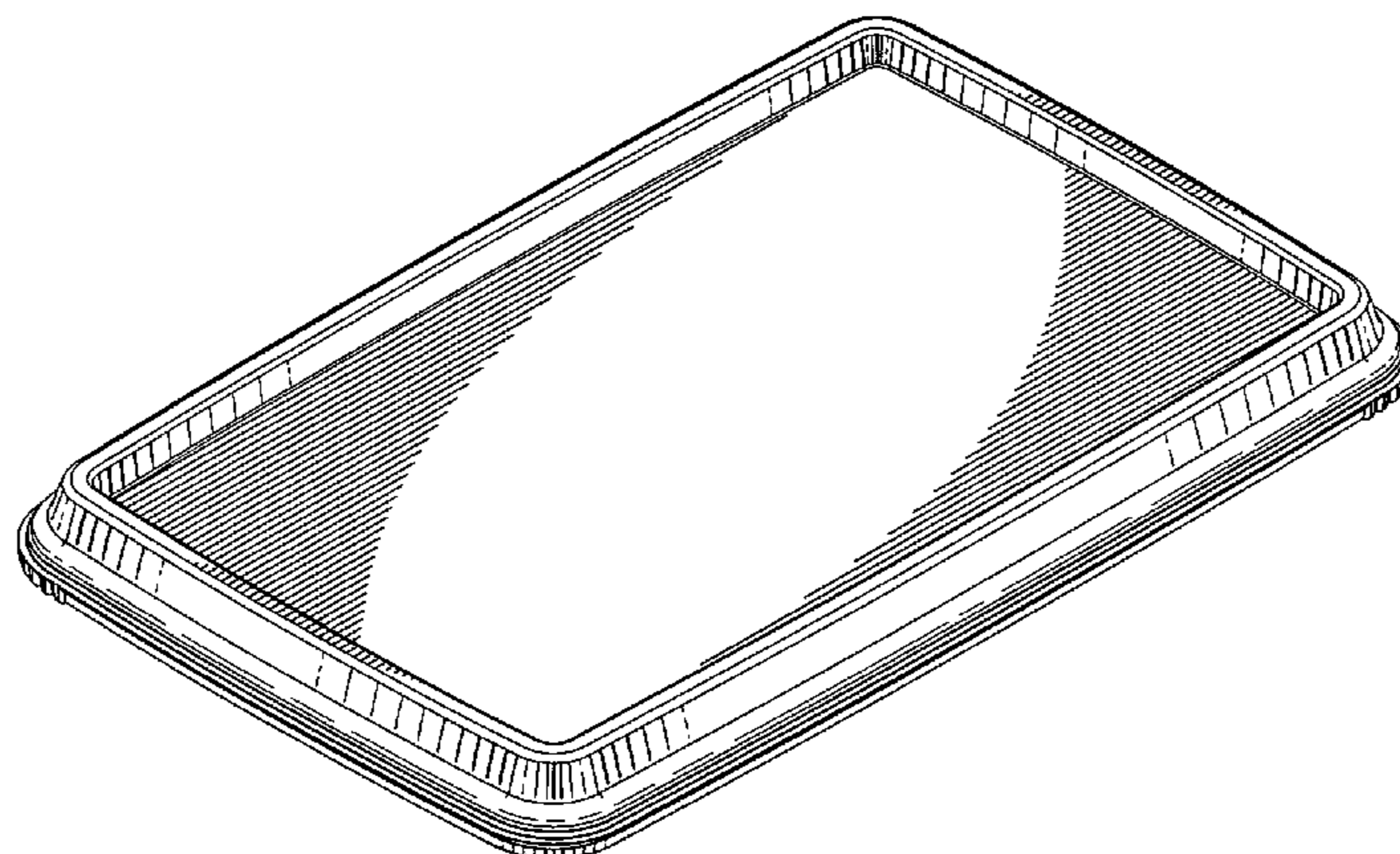
FIG. 15 is a bottom plan view of the lid for container of FIG. 11.

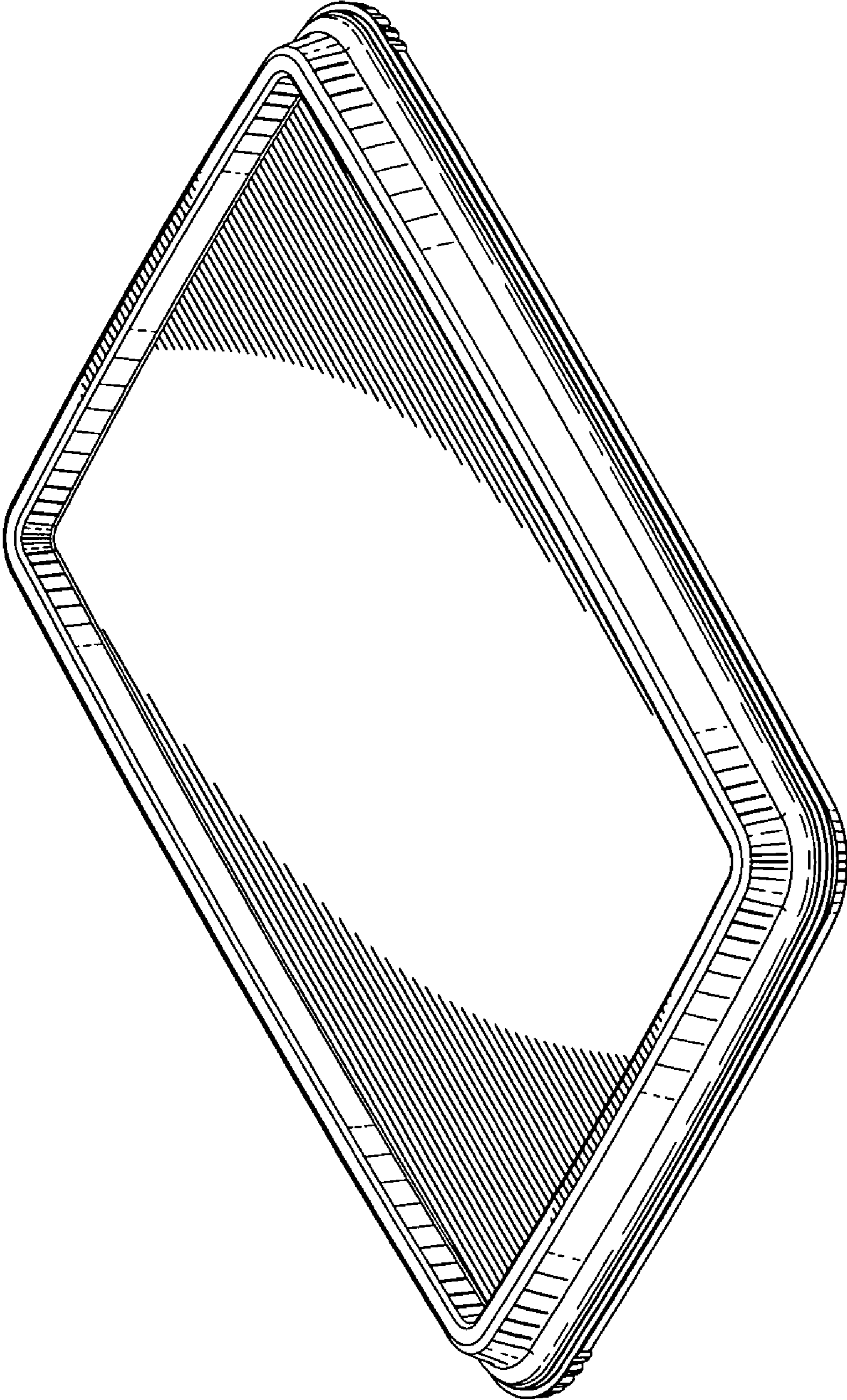

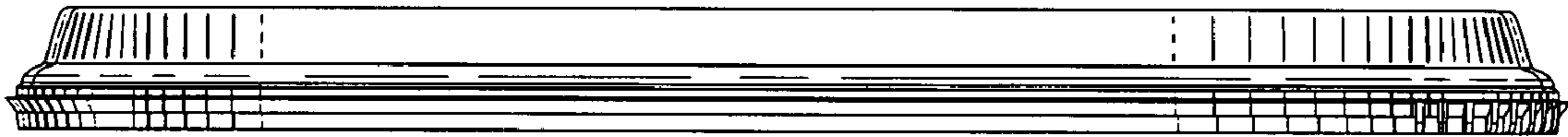

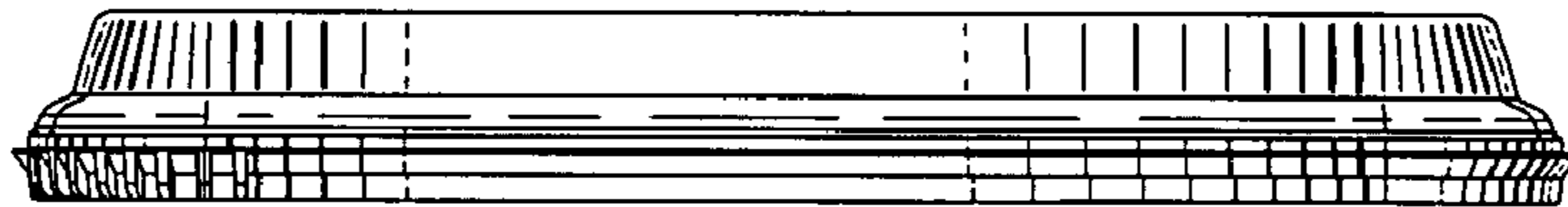

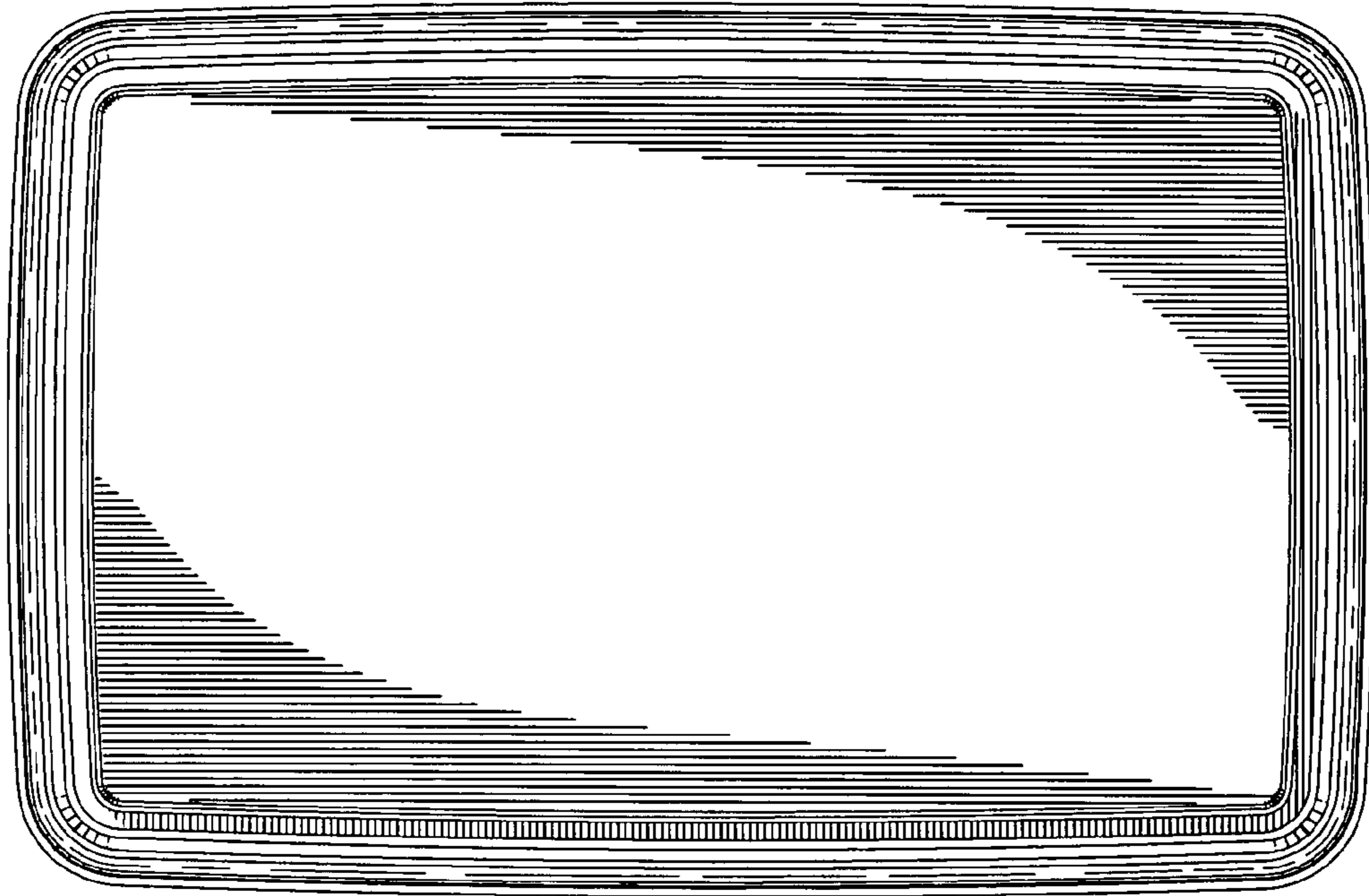

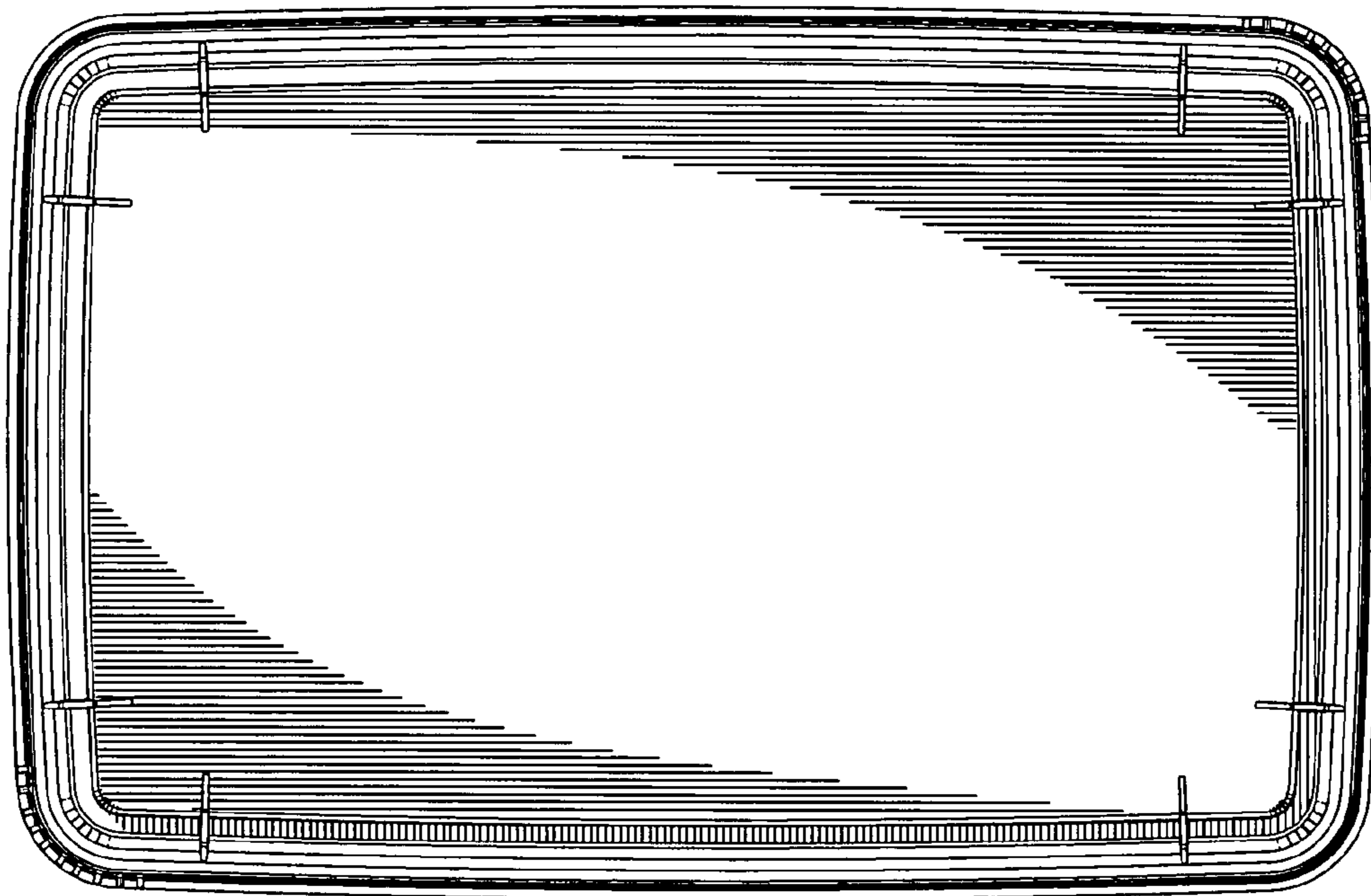

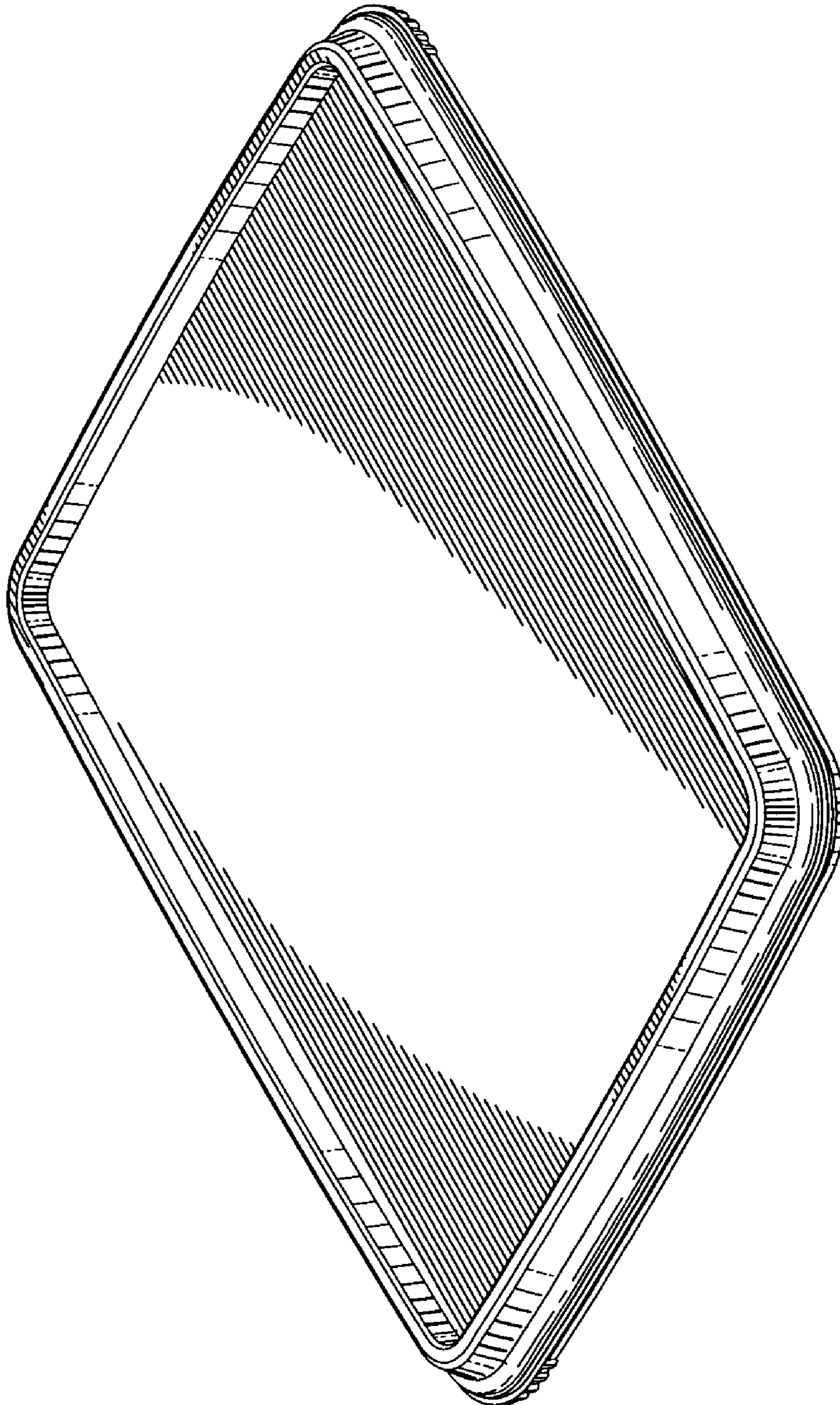

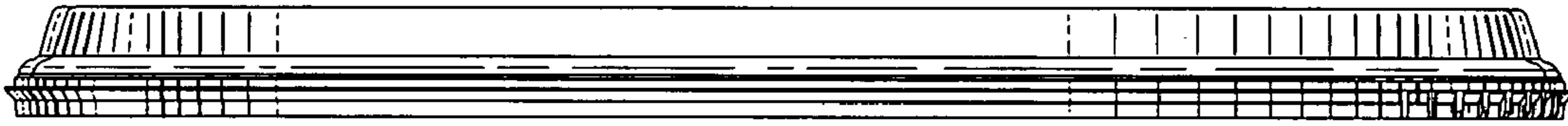

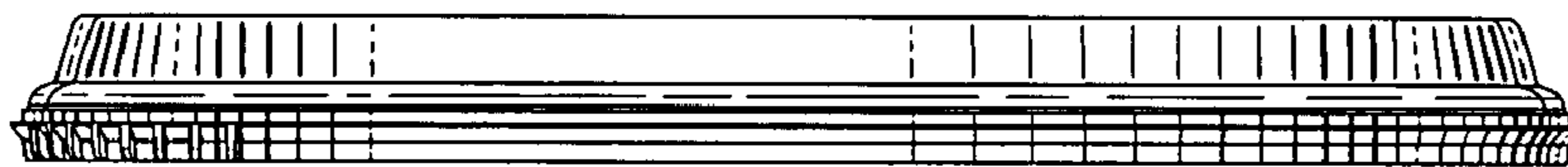

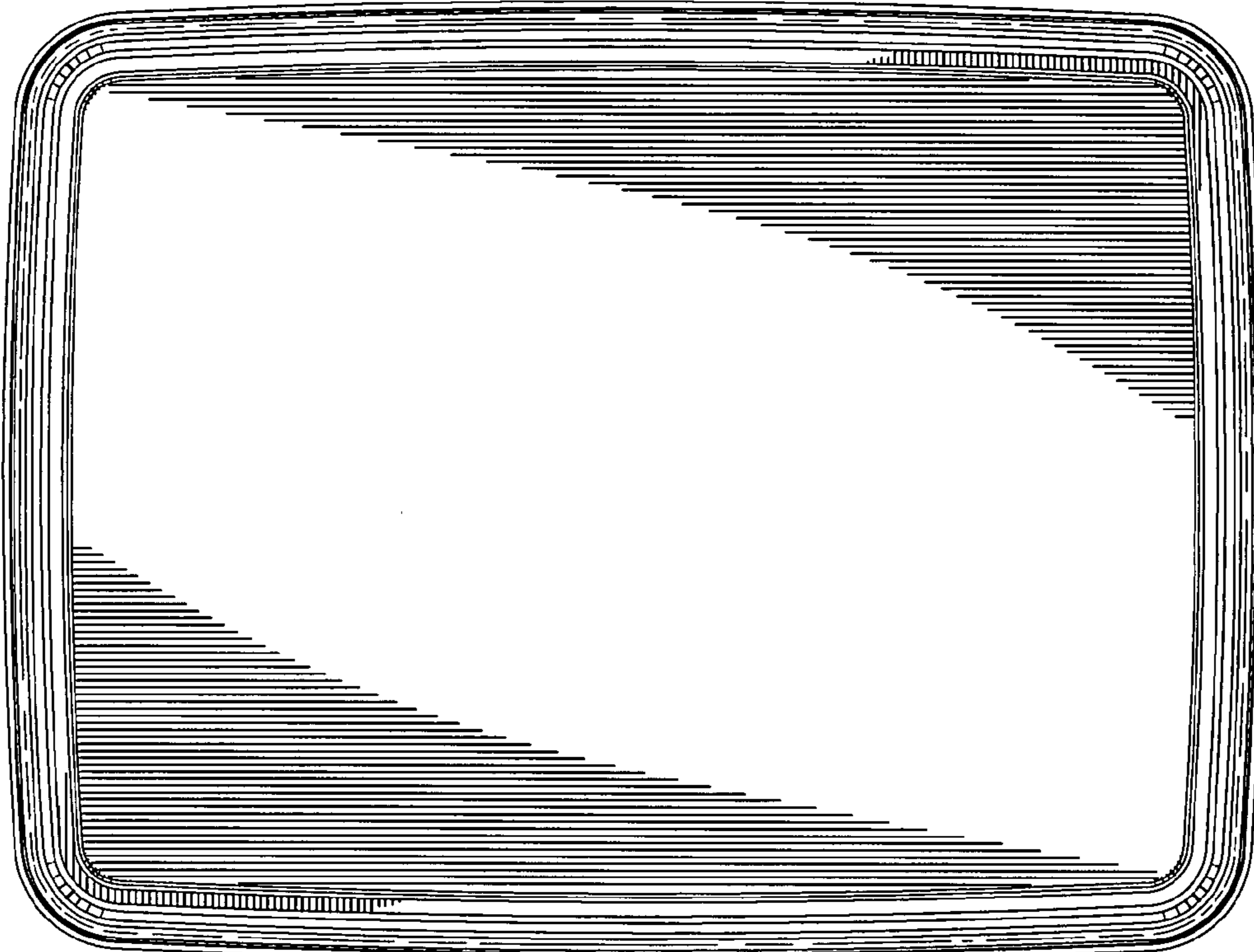

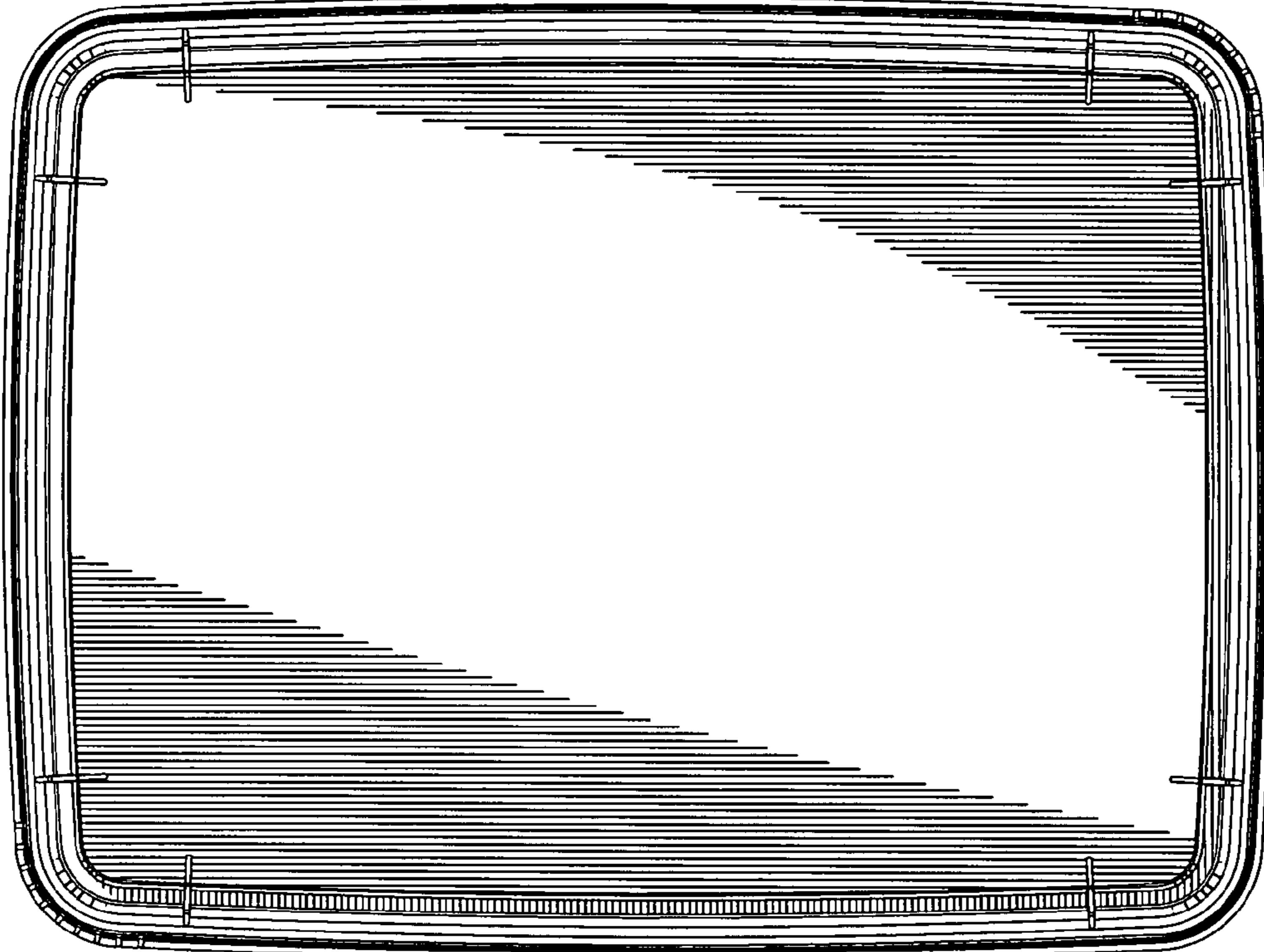

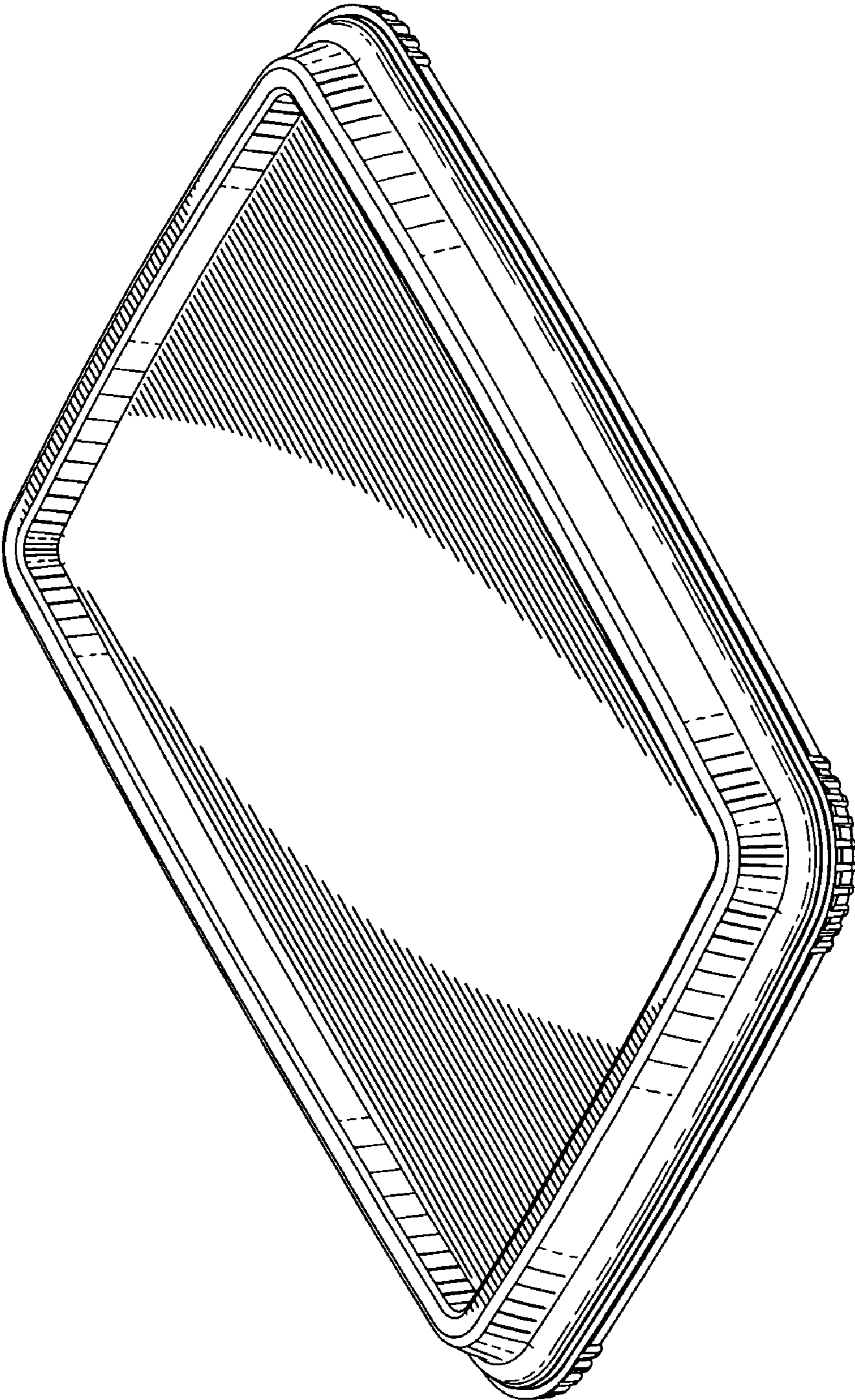

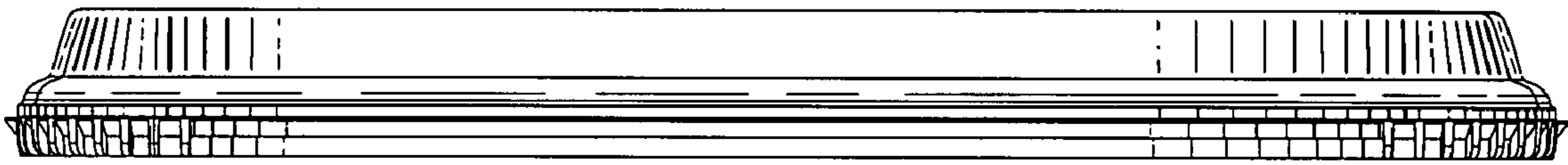

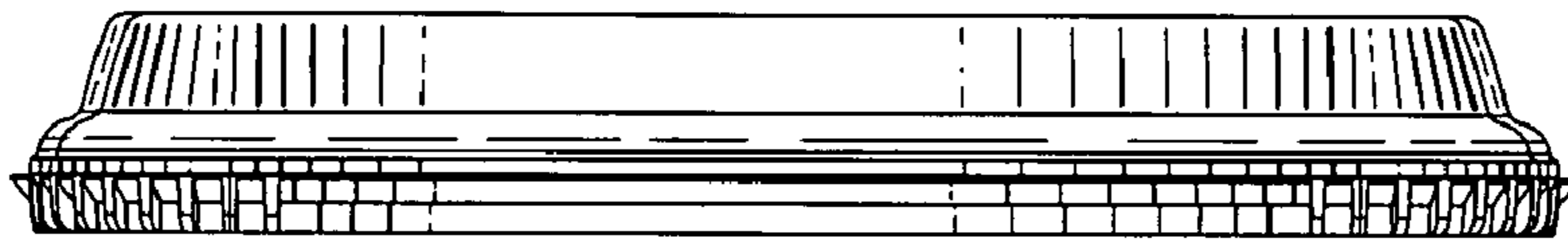

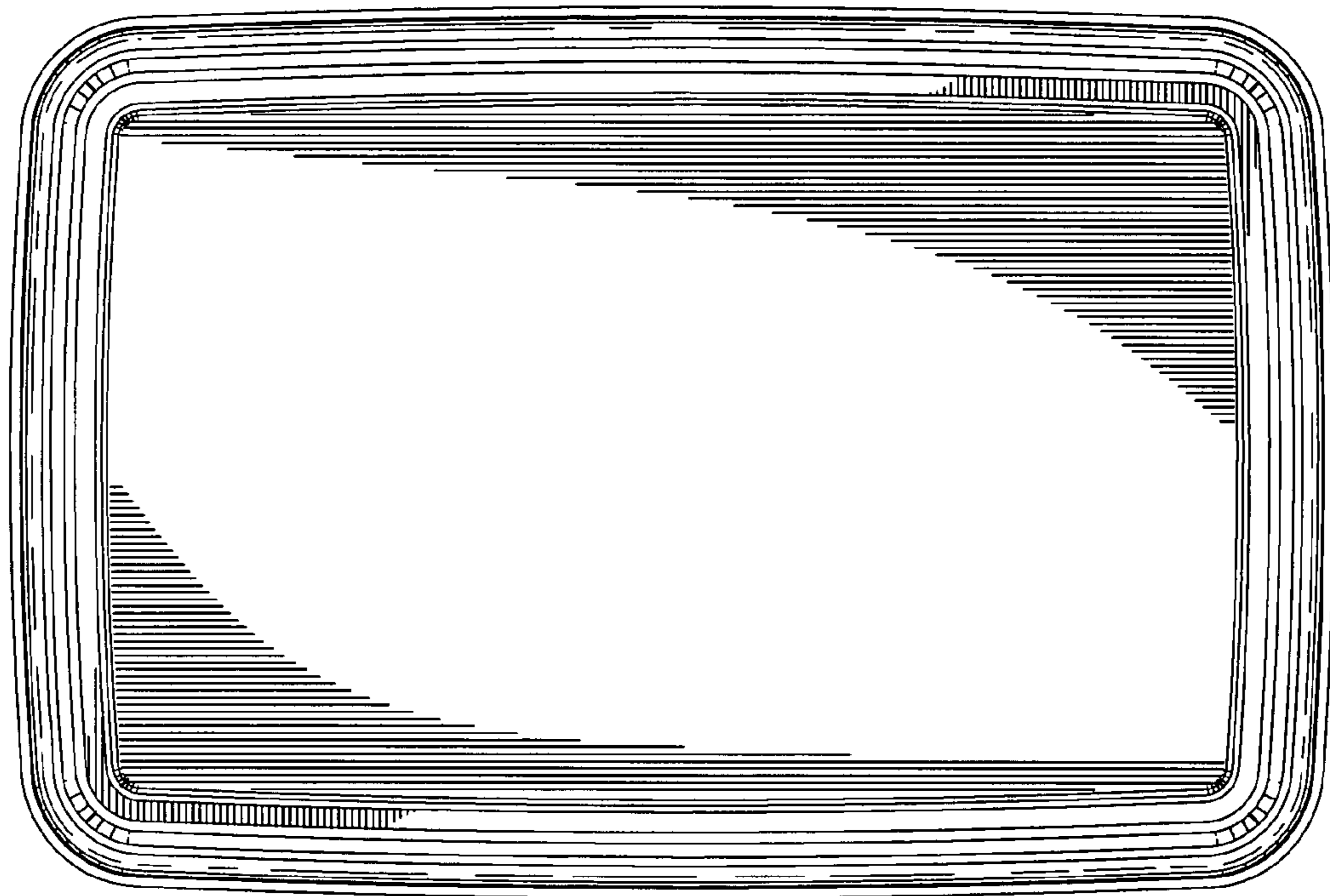

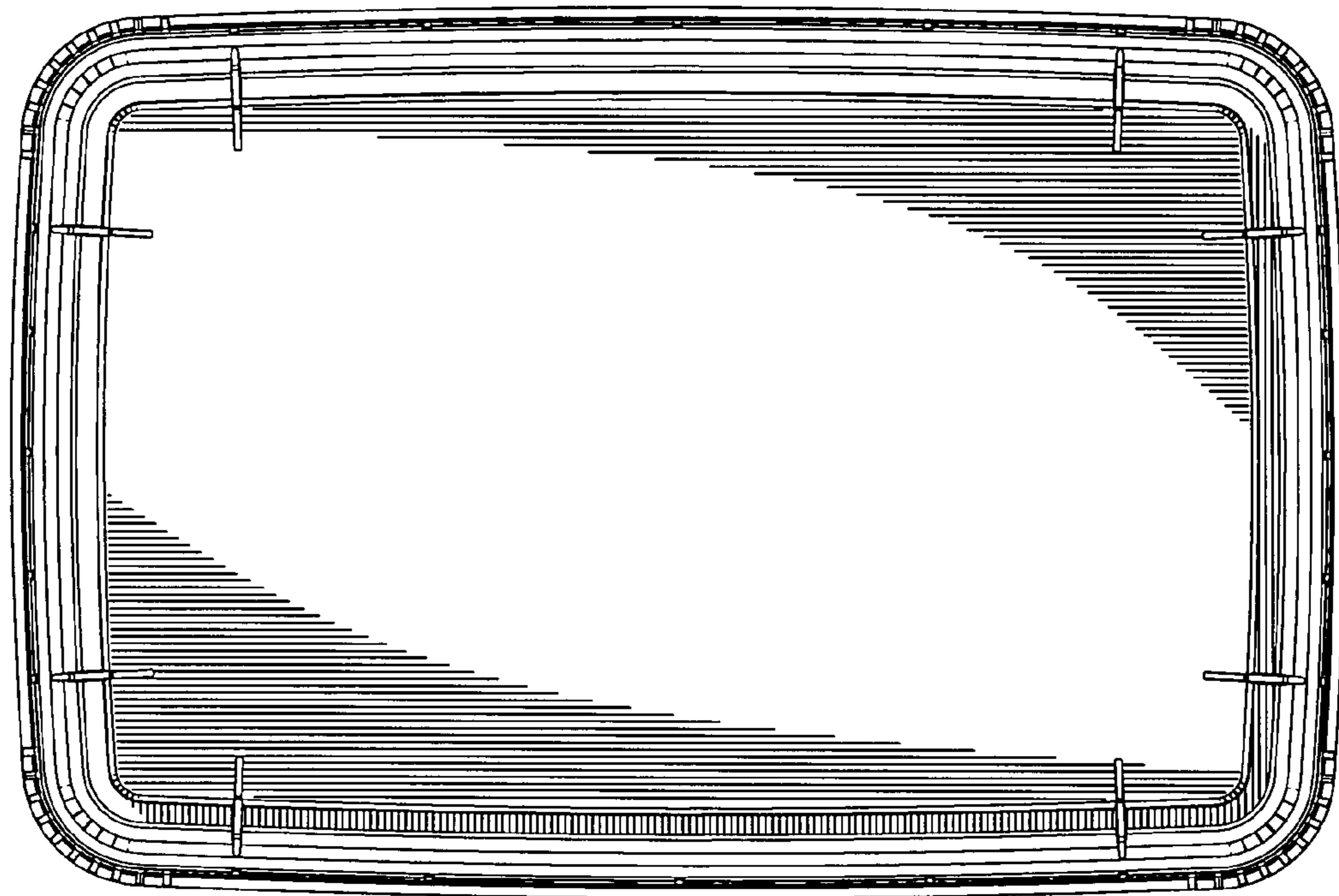
