FIG. 19 is a right view thereof;

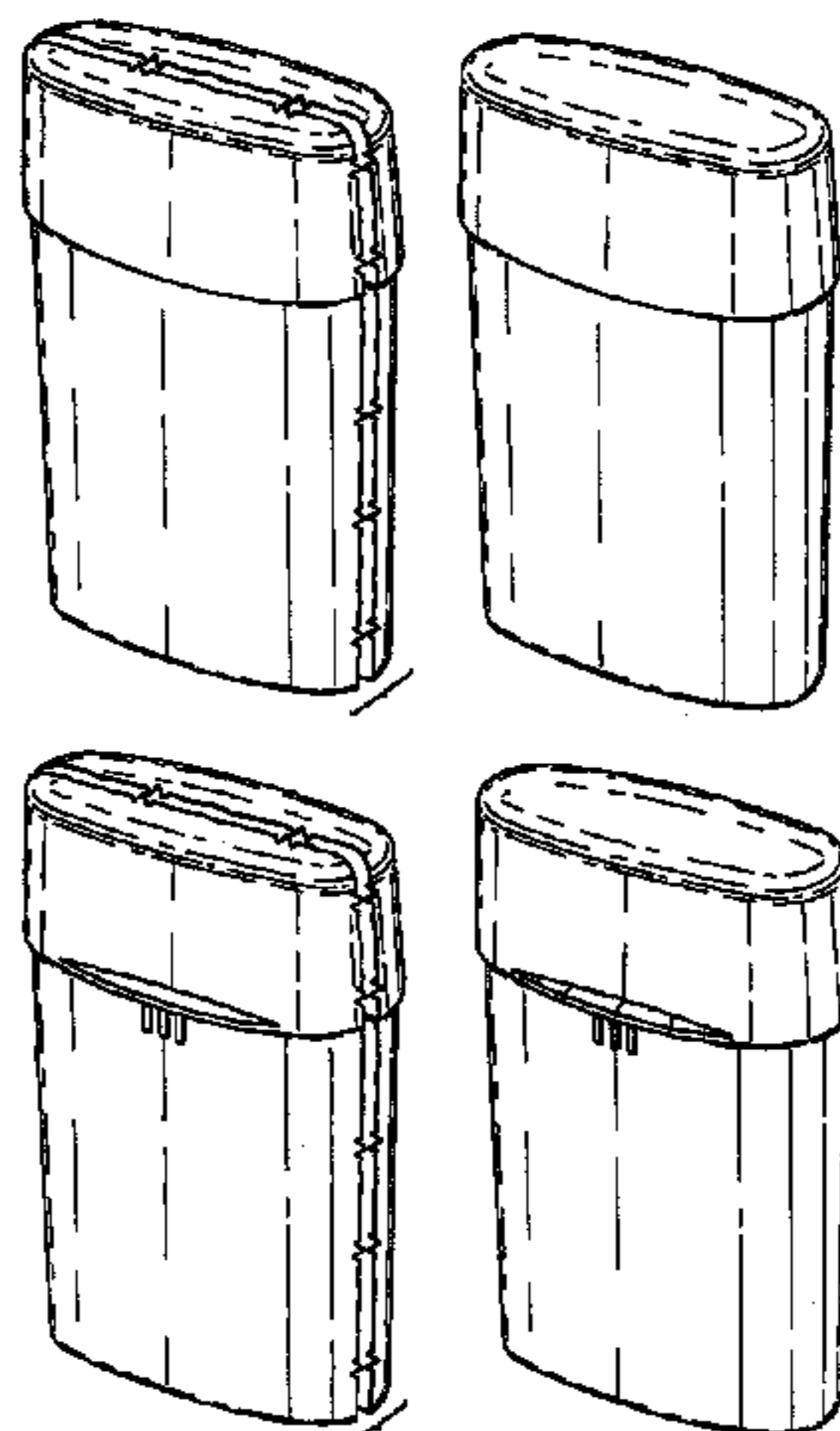


FIG. 20 is a top view thereof;

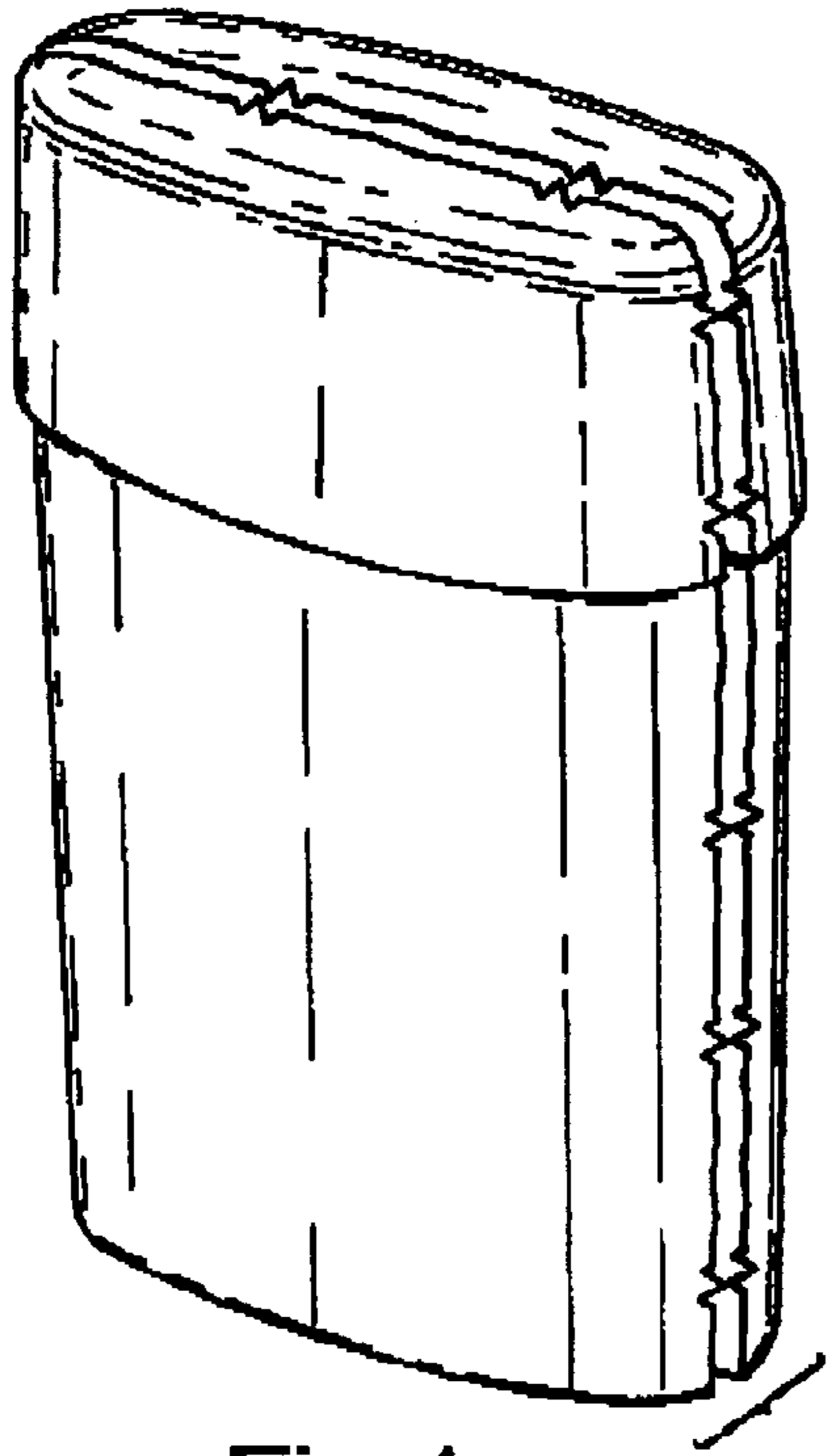

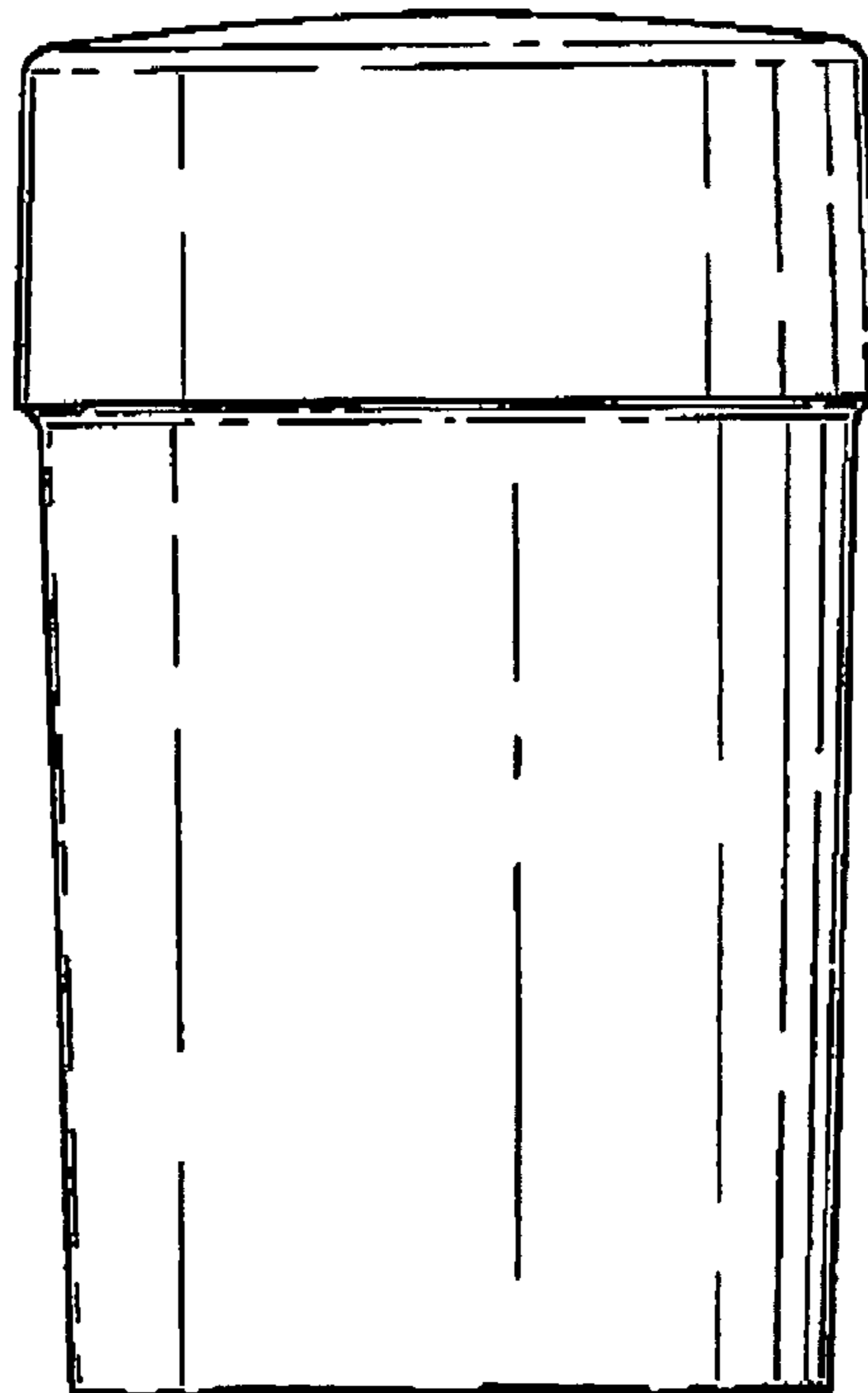

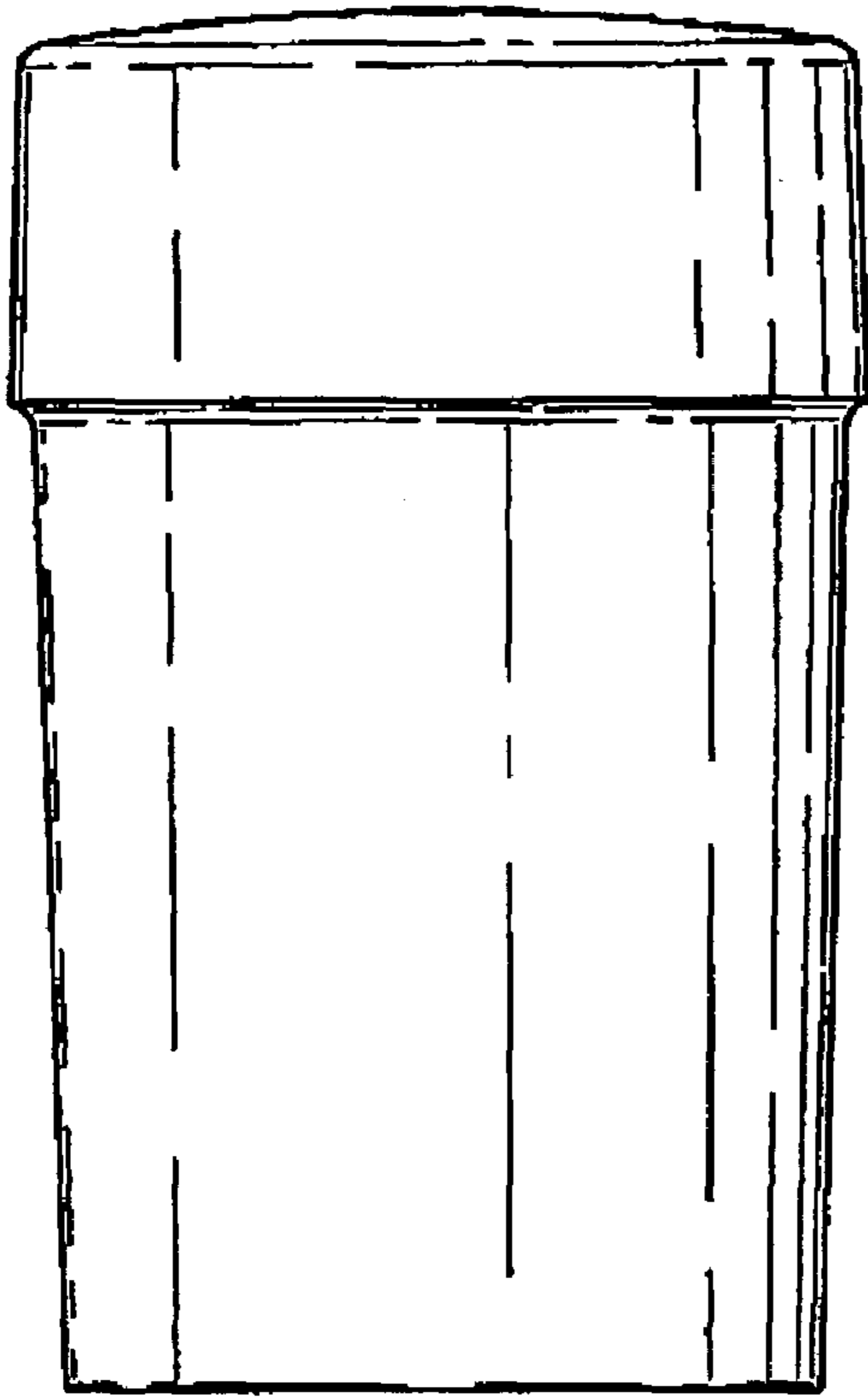

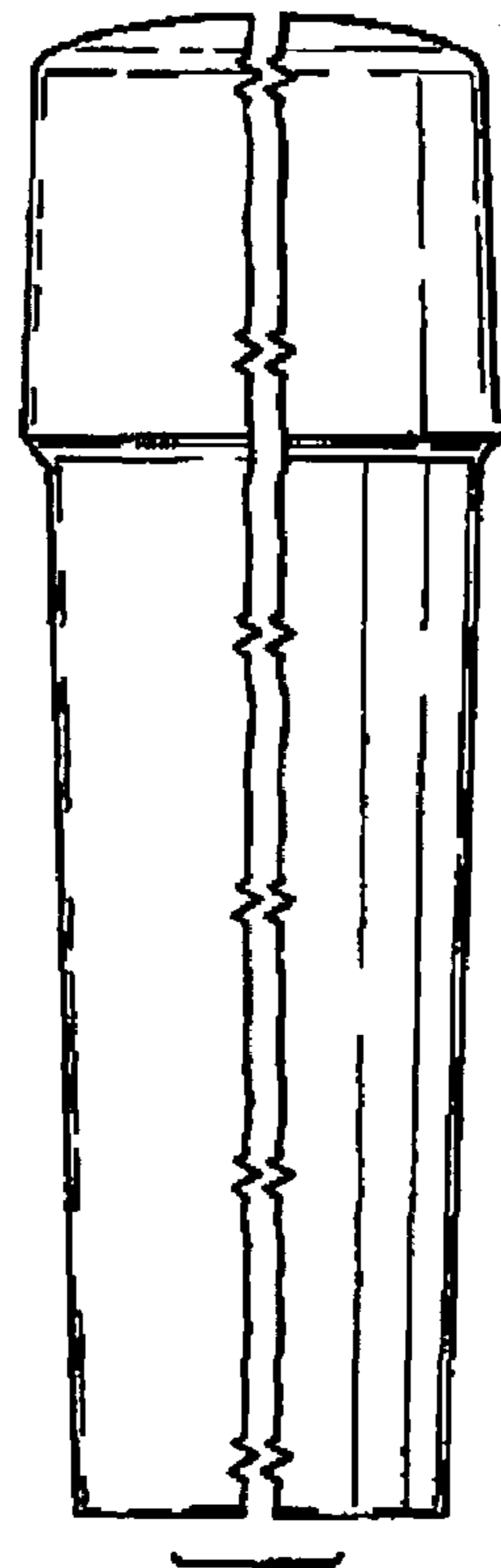

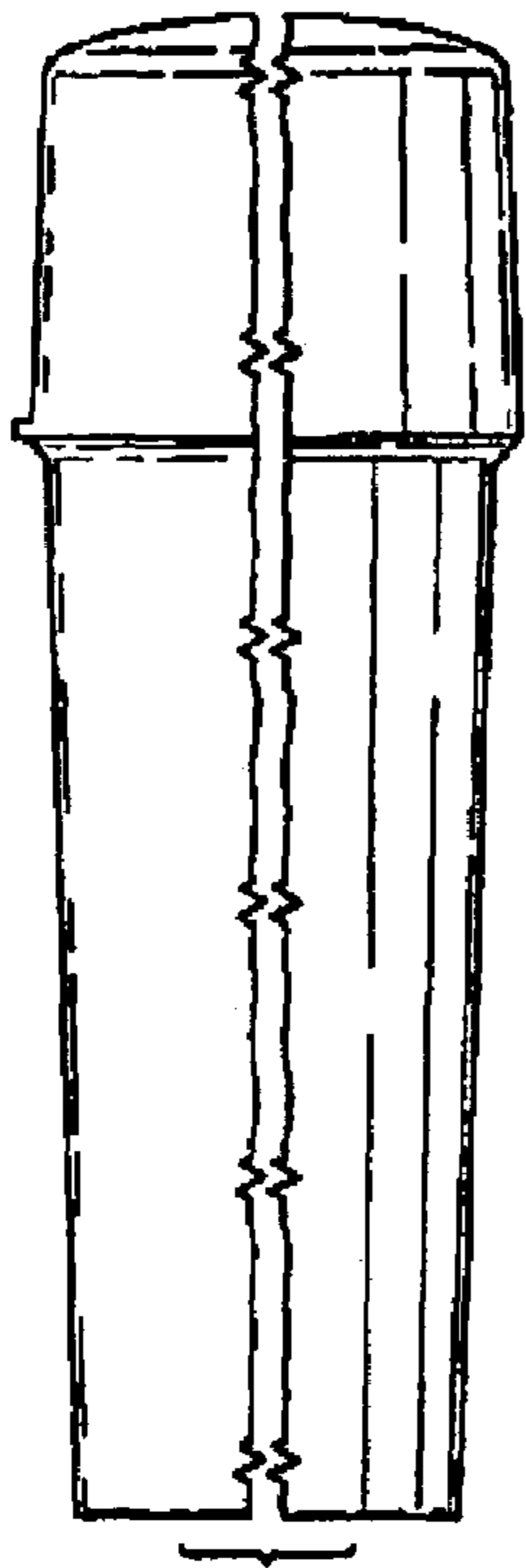

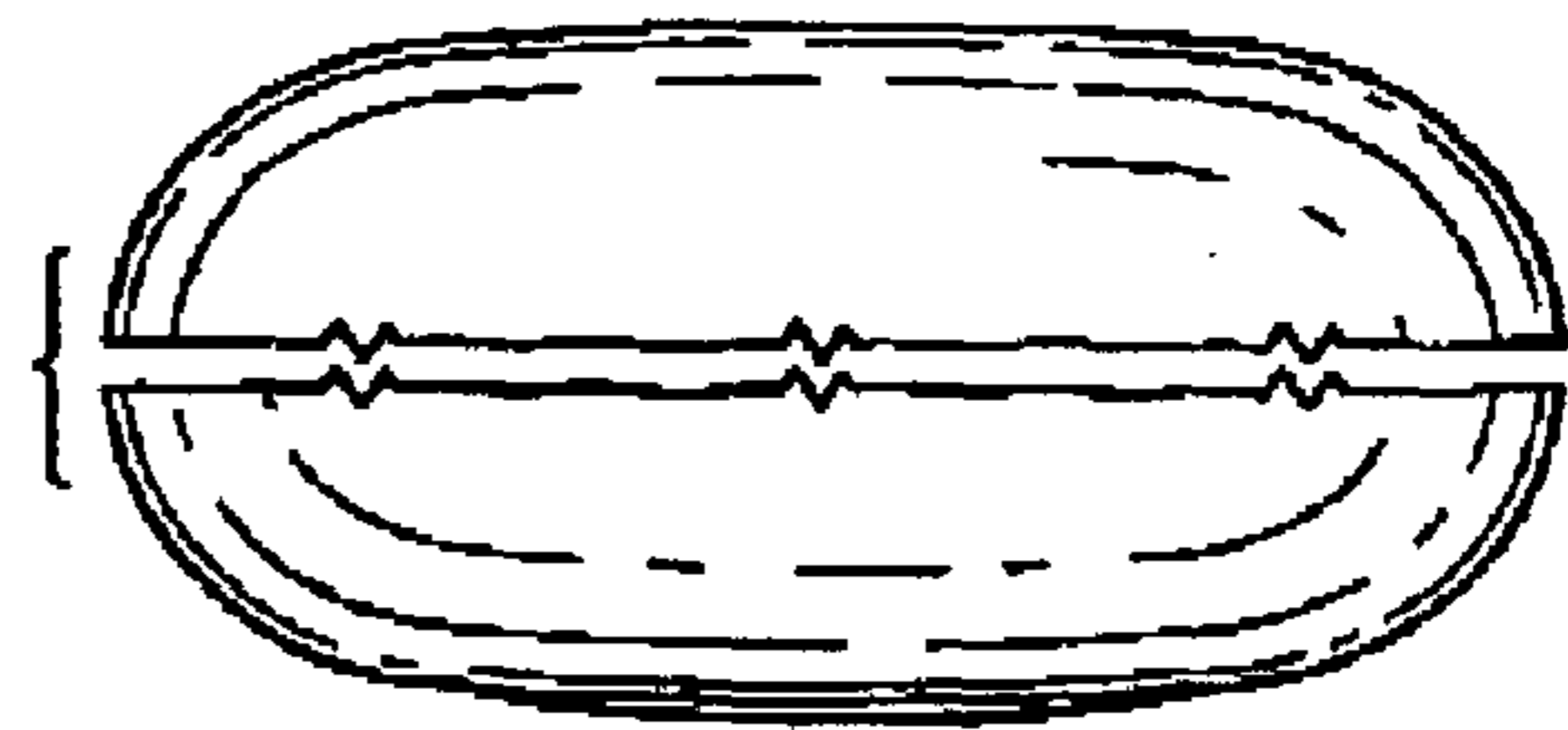

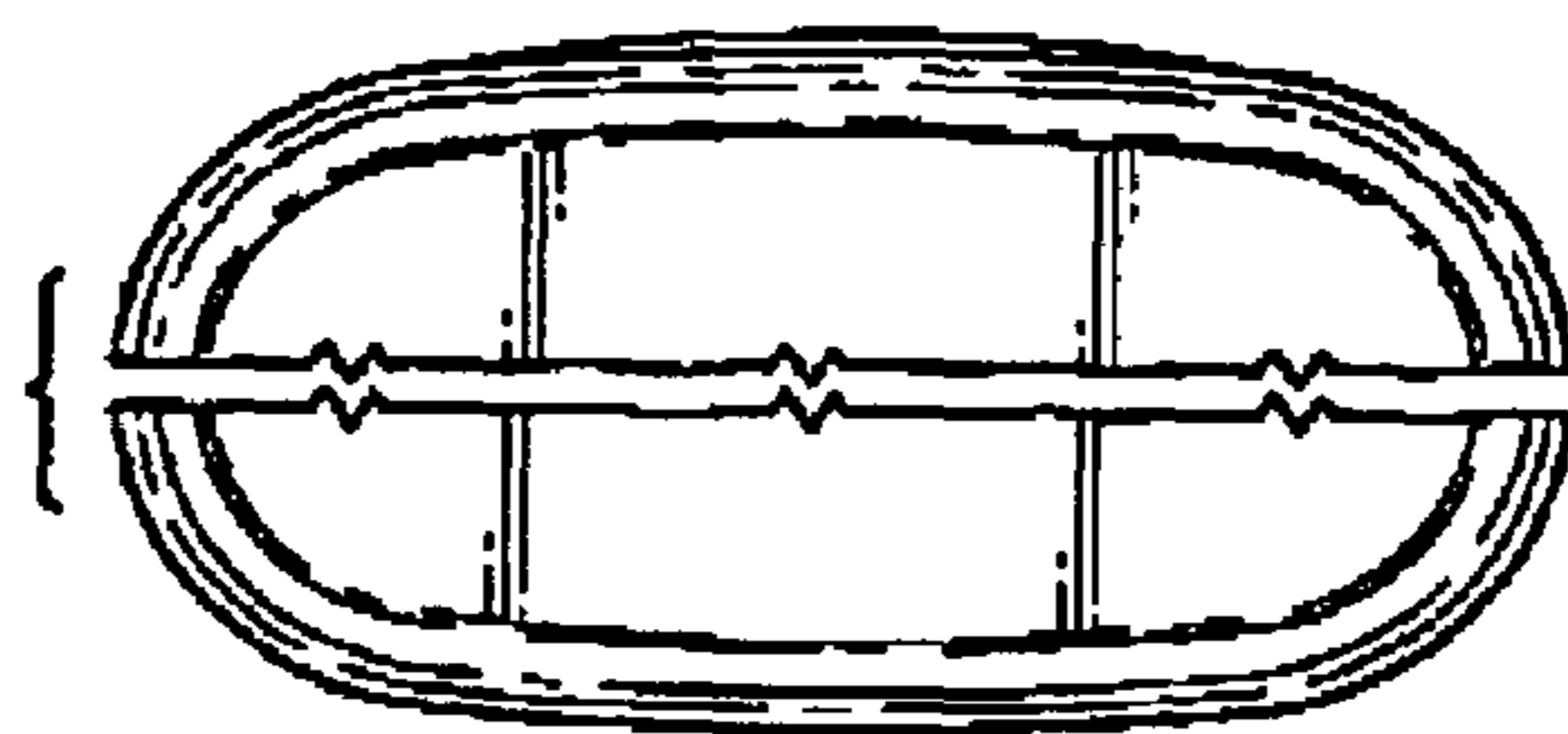

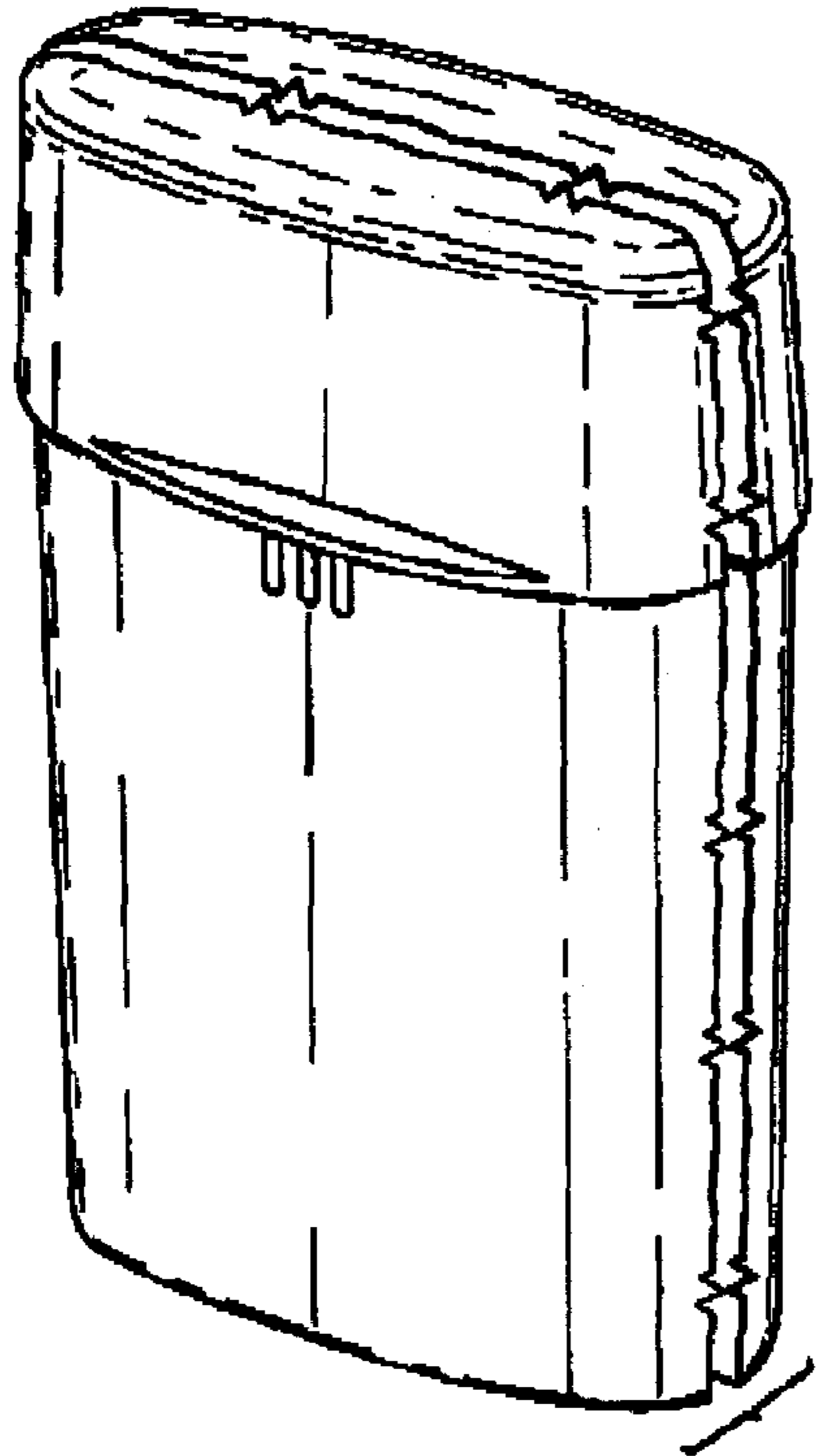

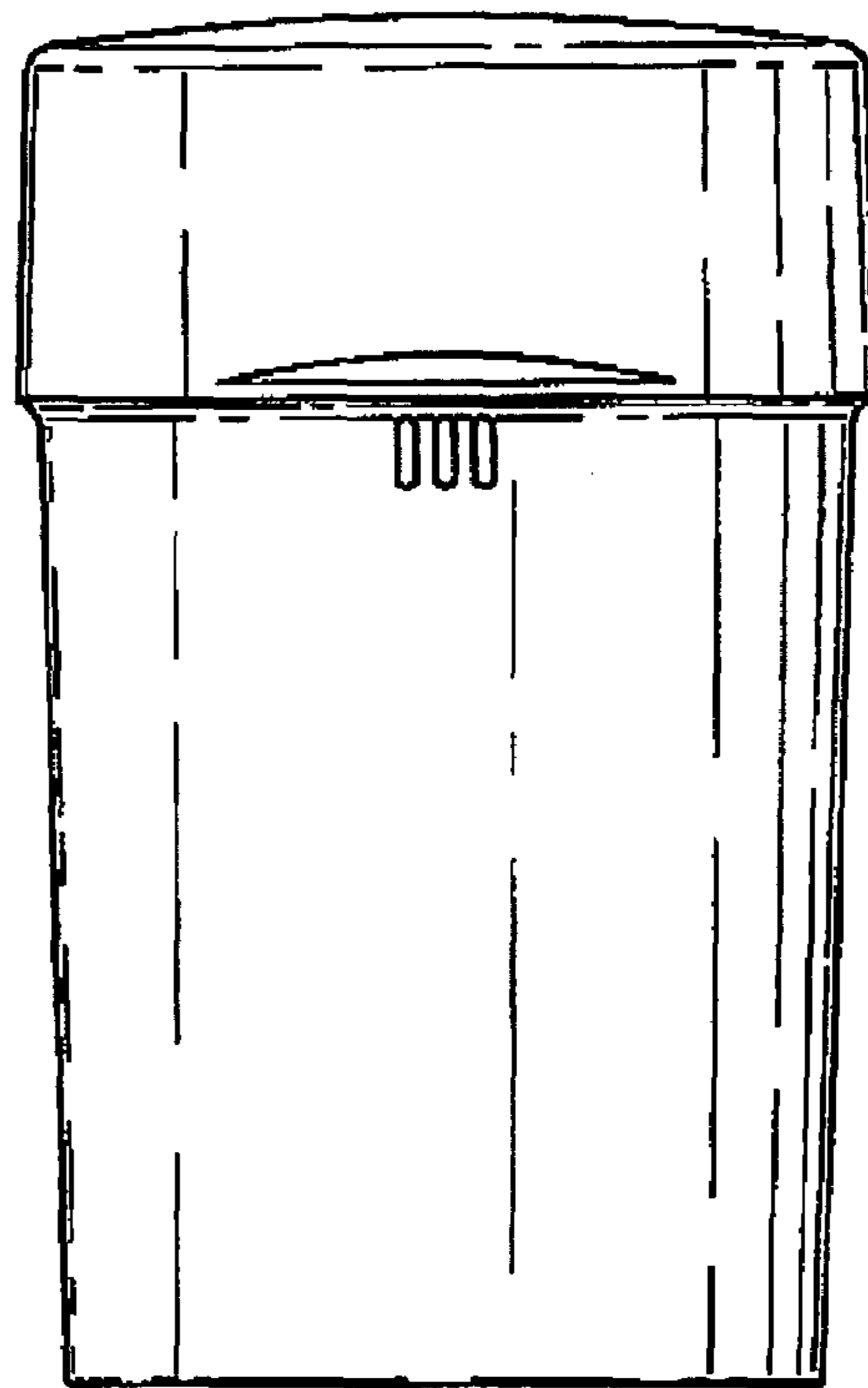

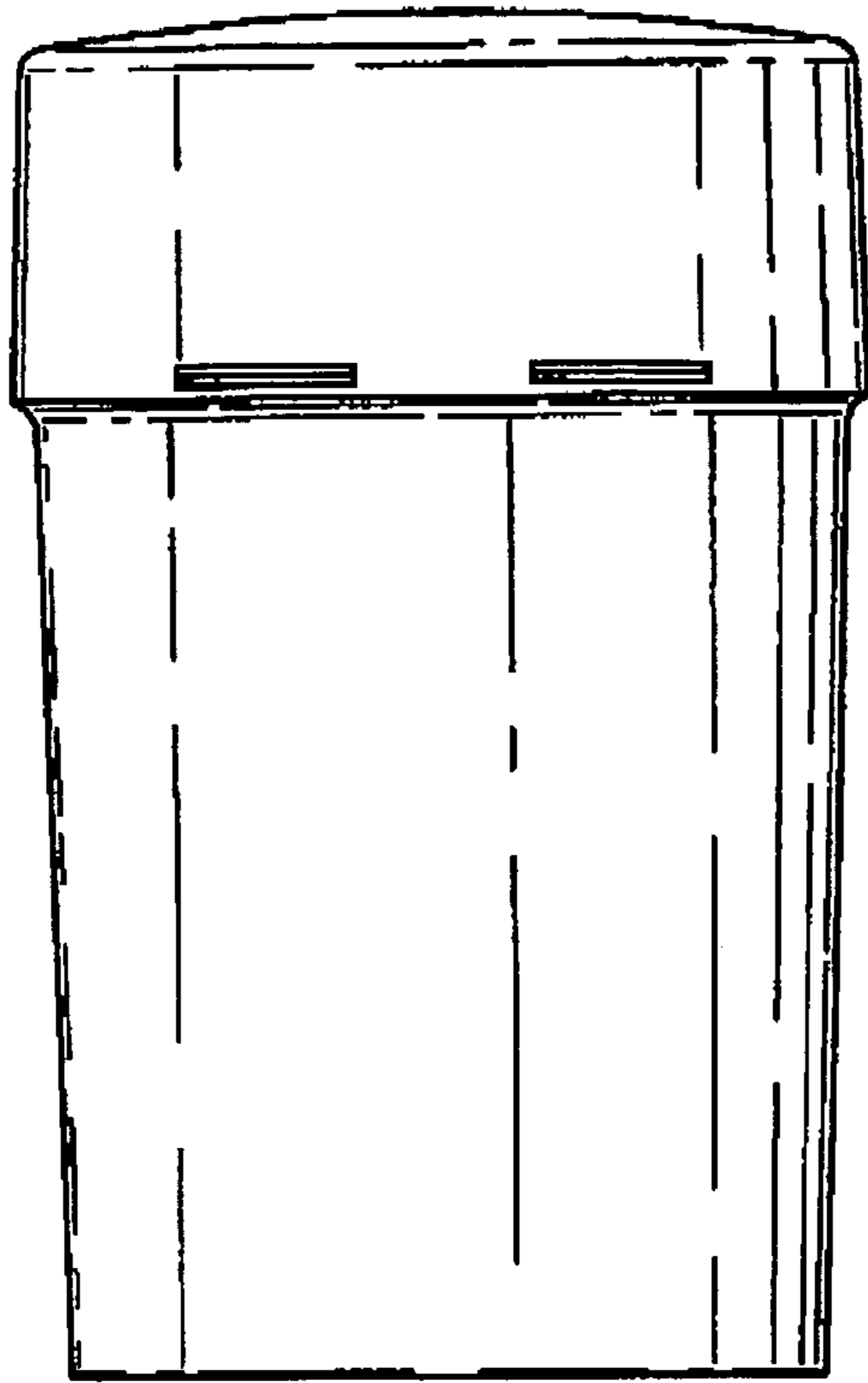

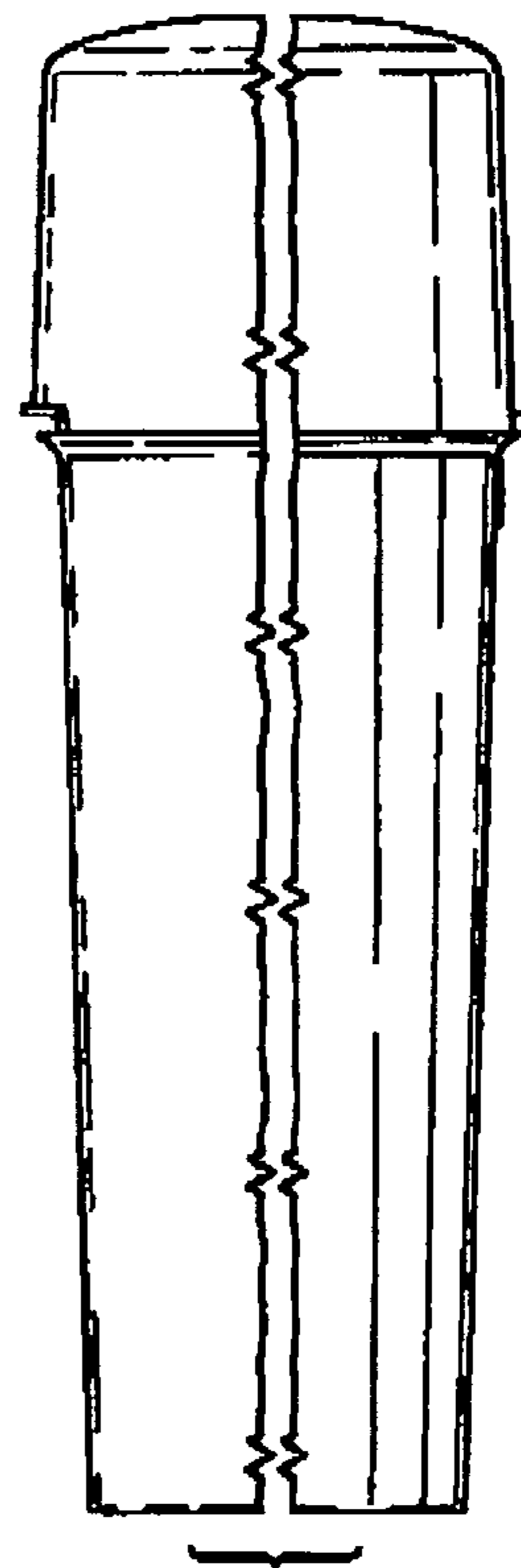

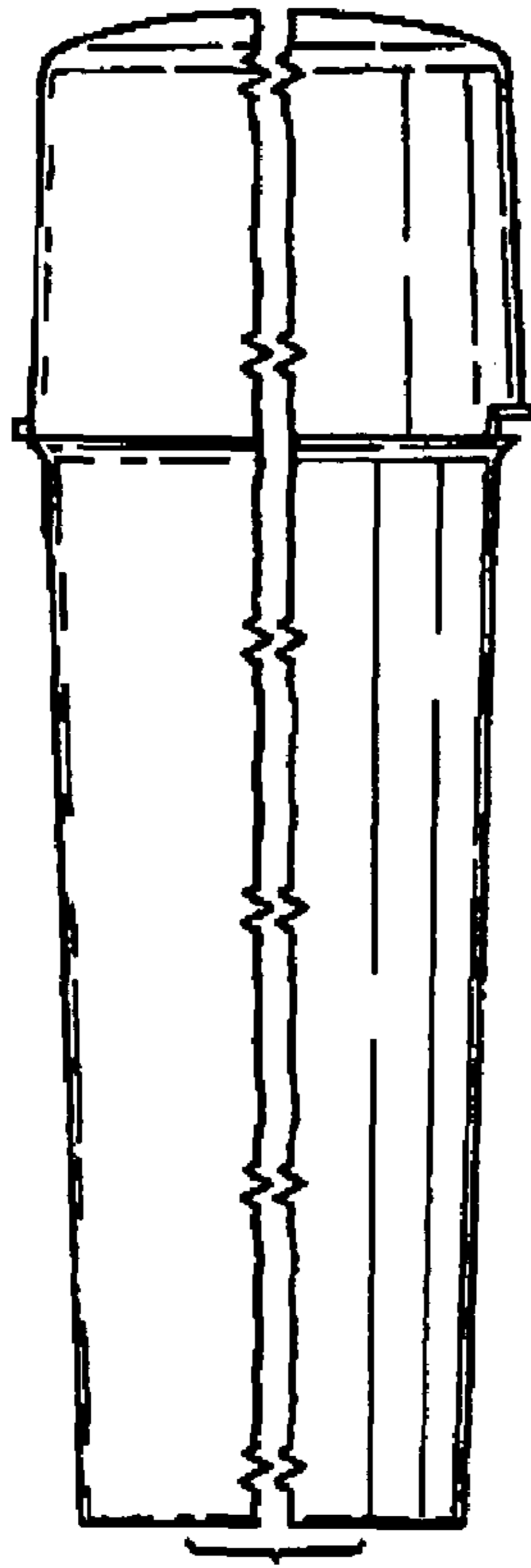

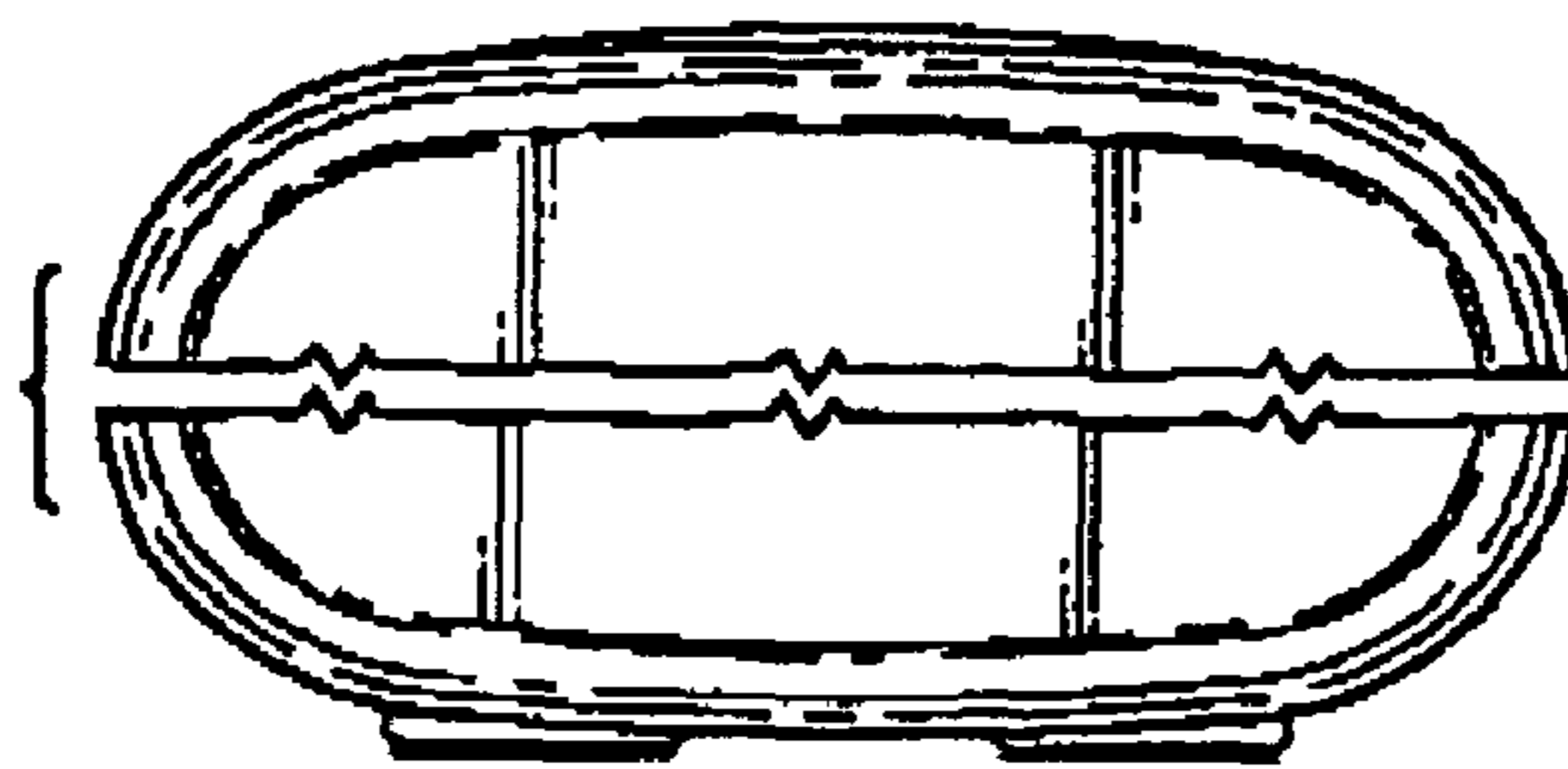

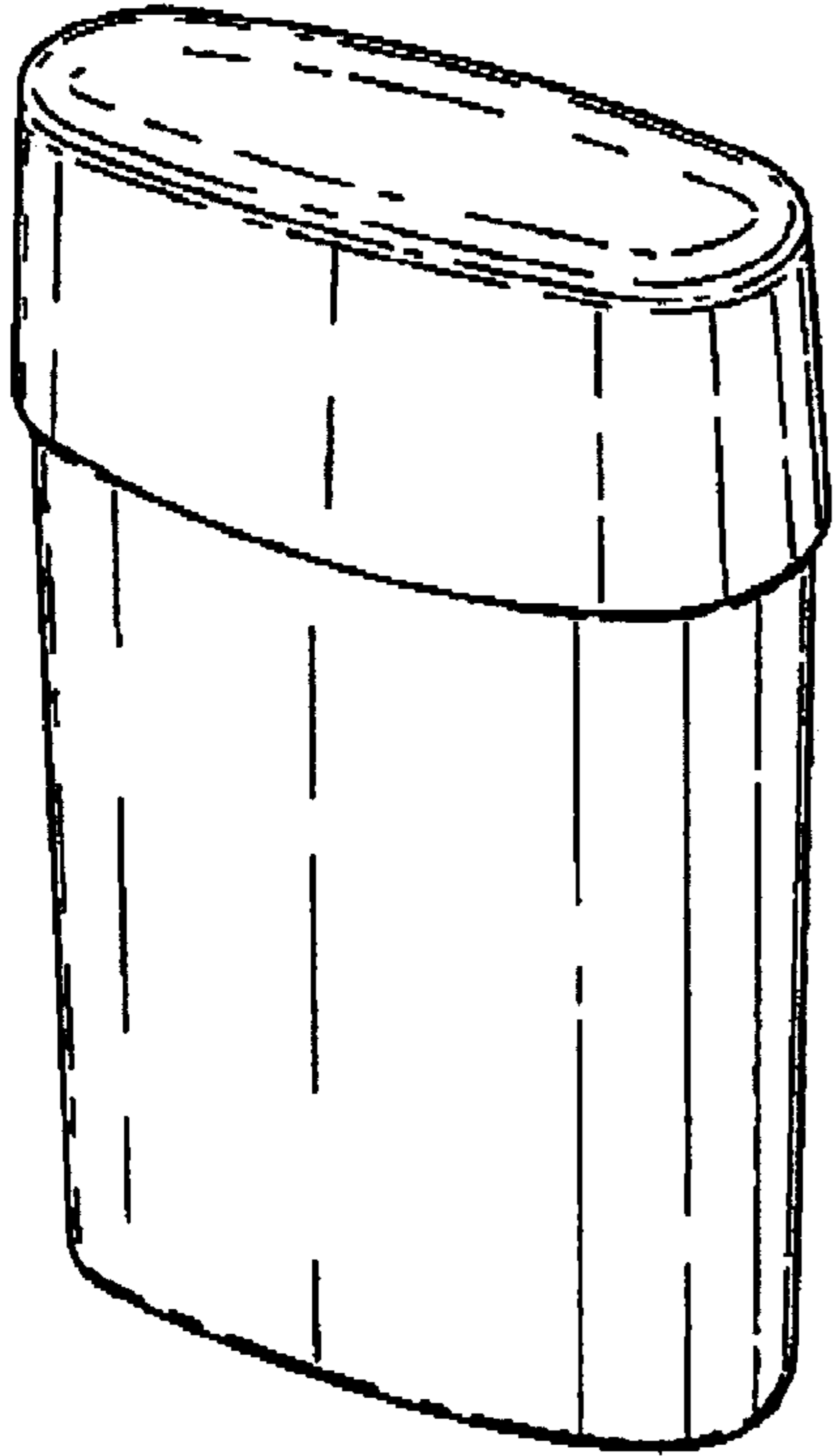

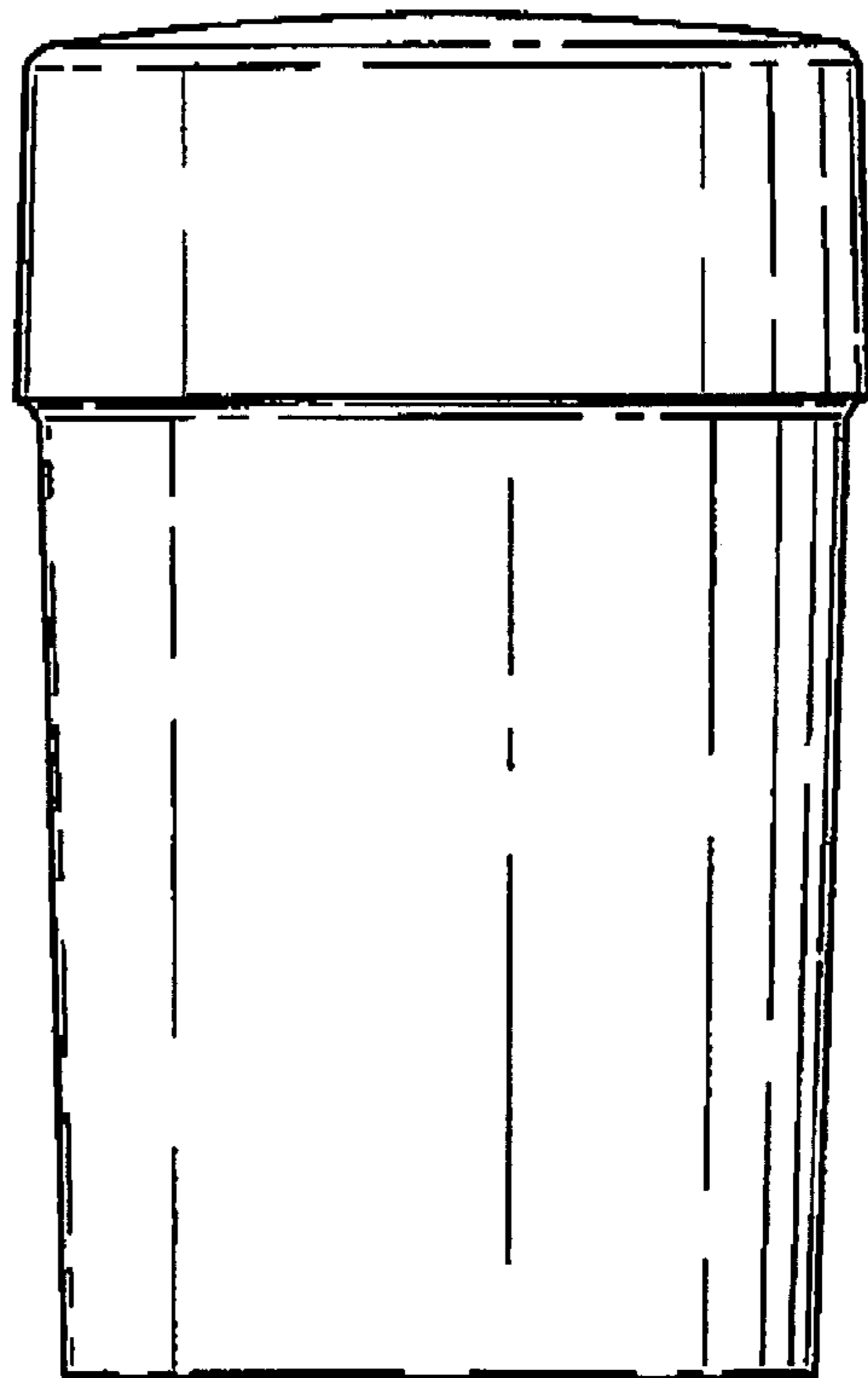

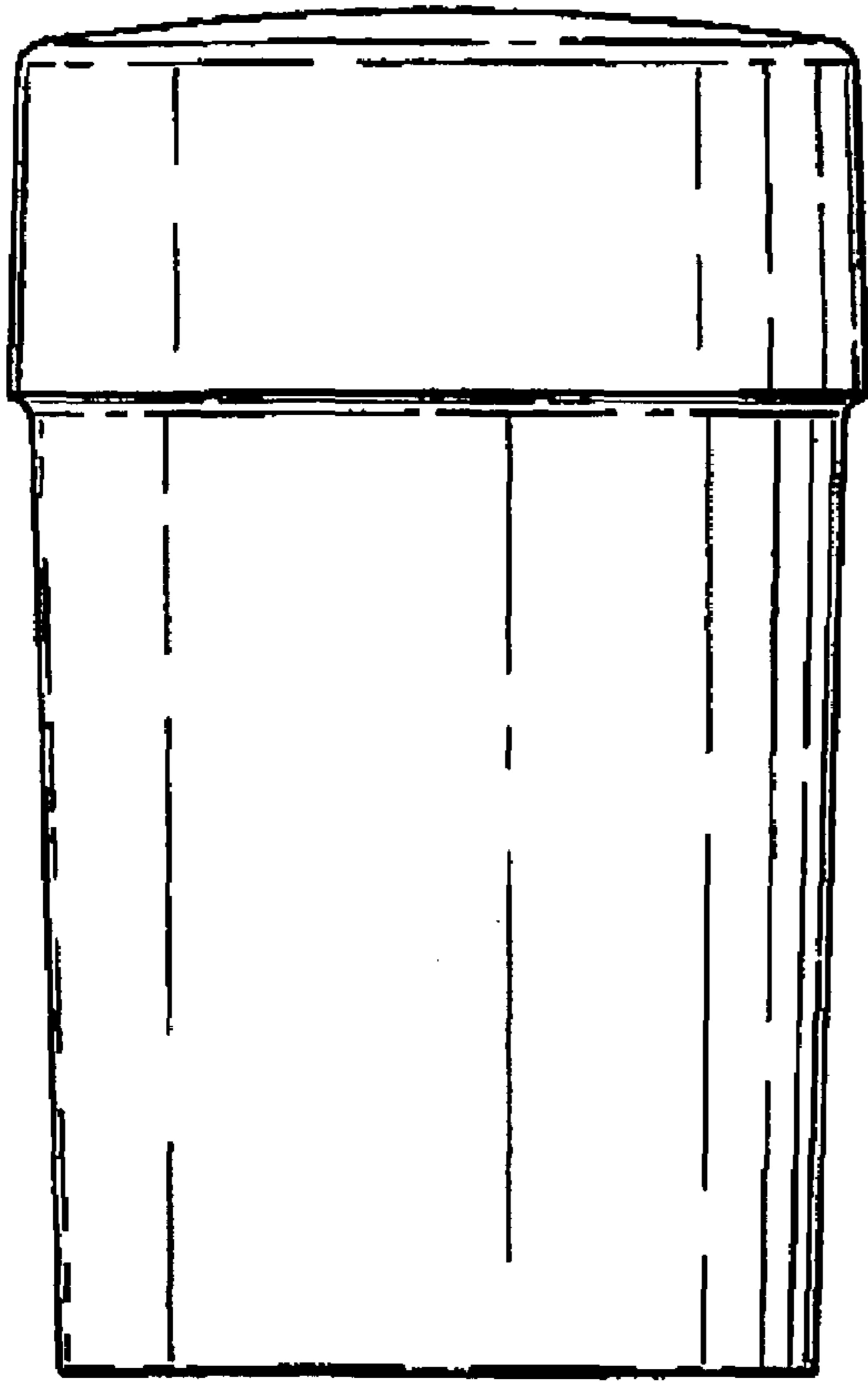

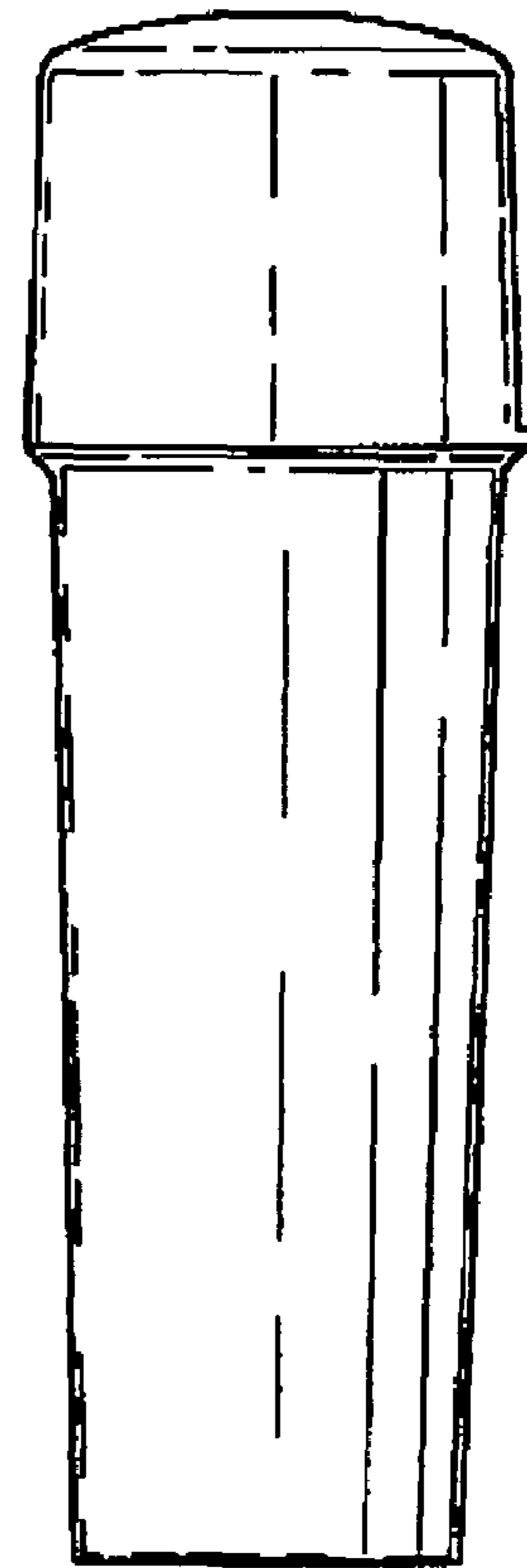

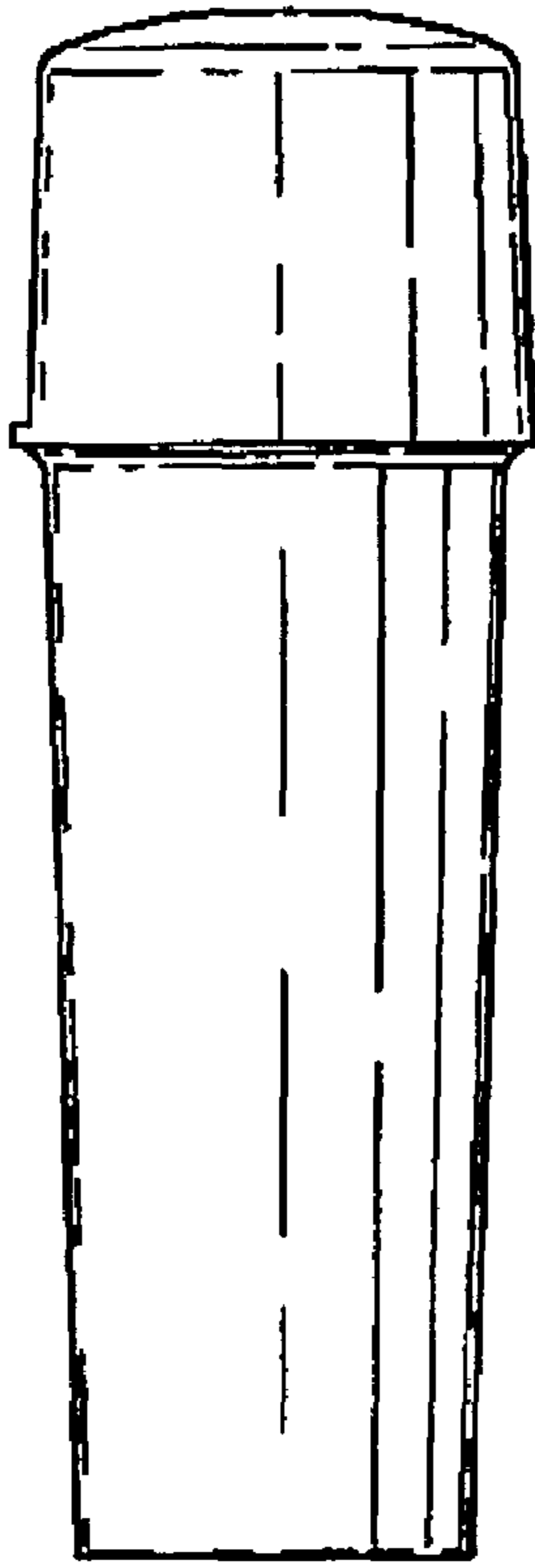

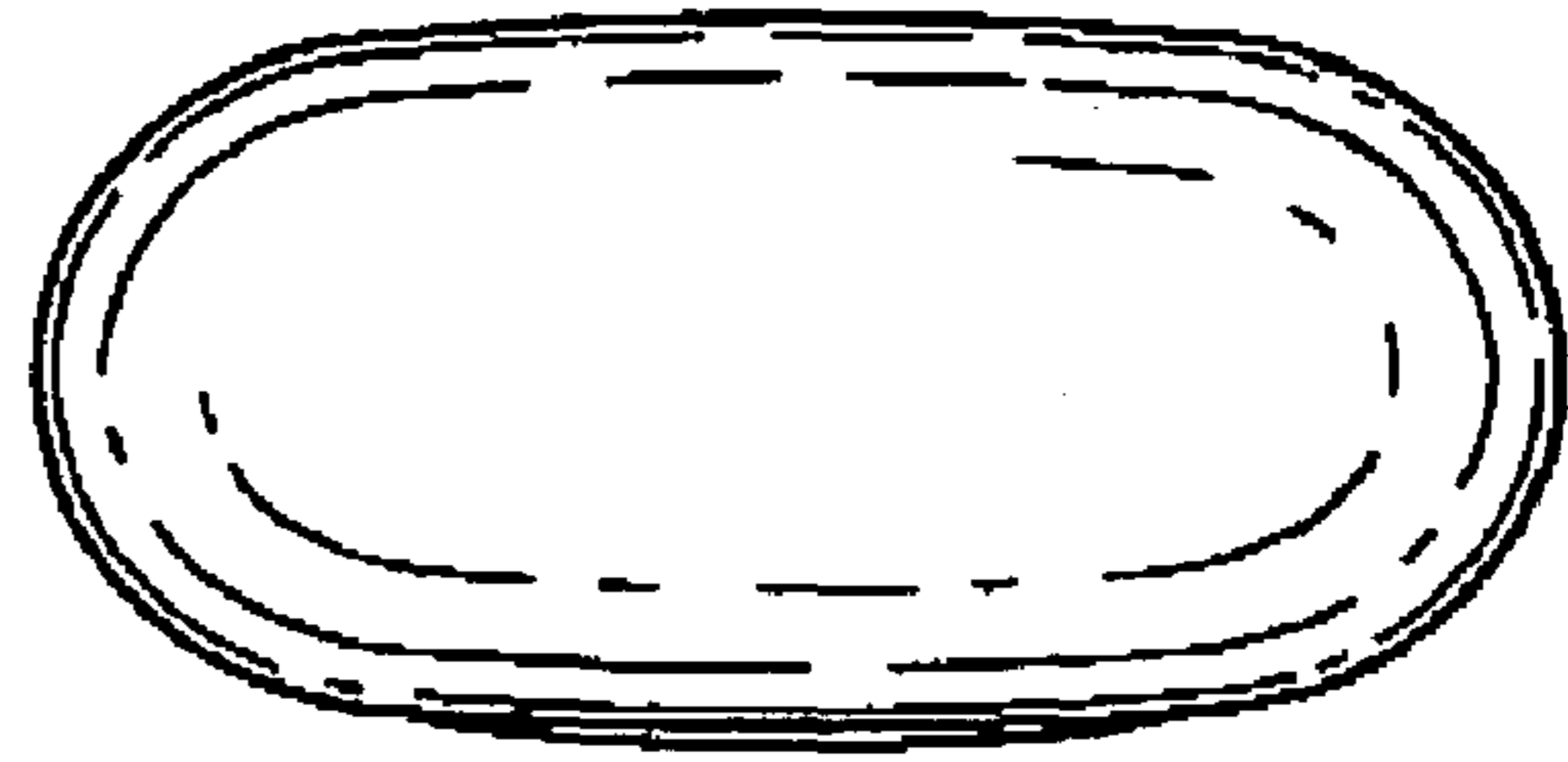

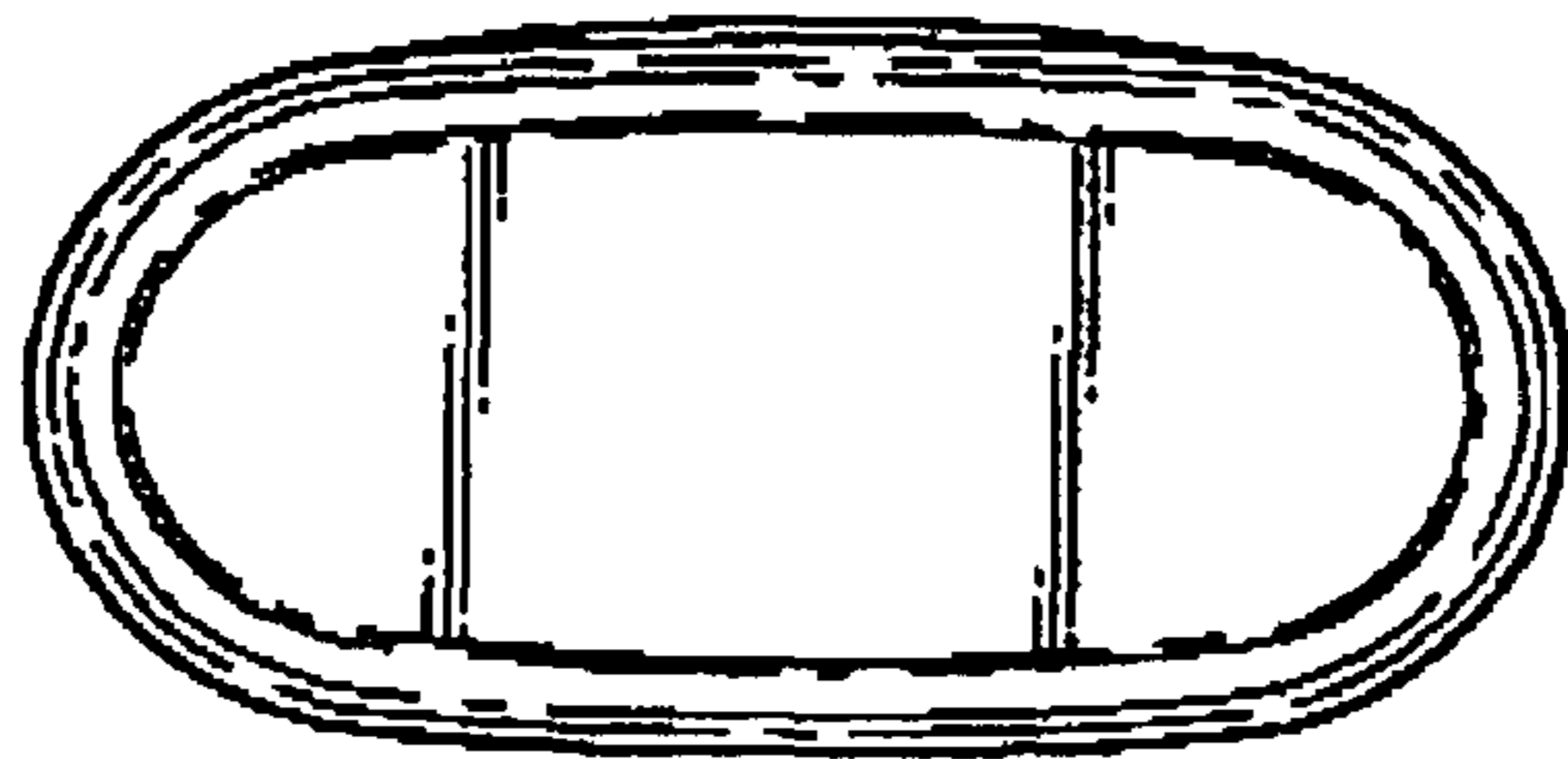

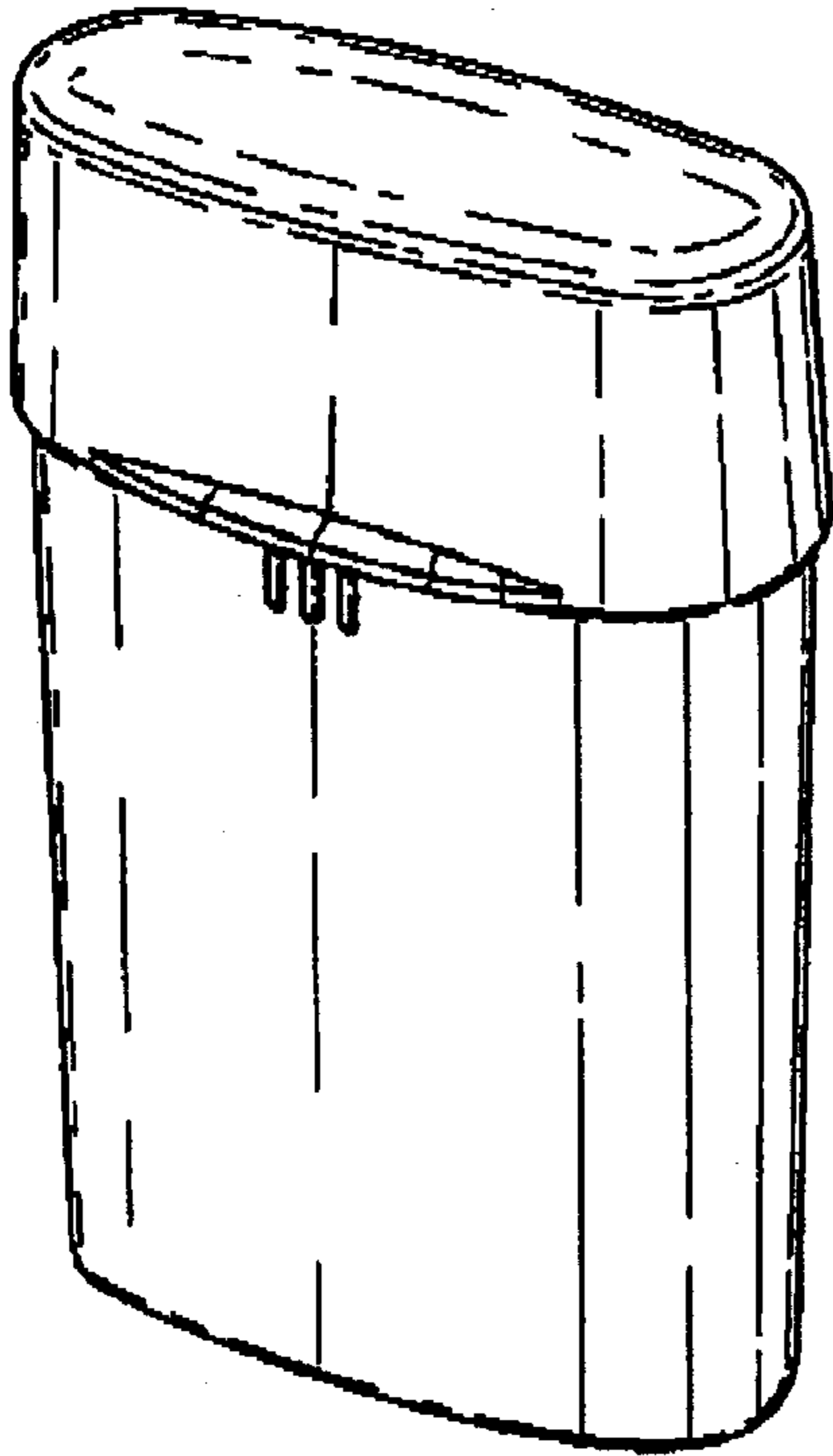

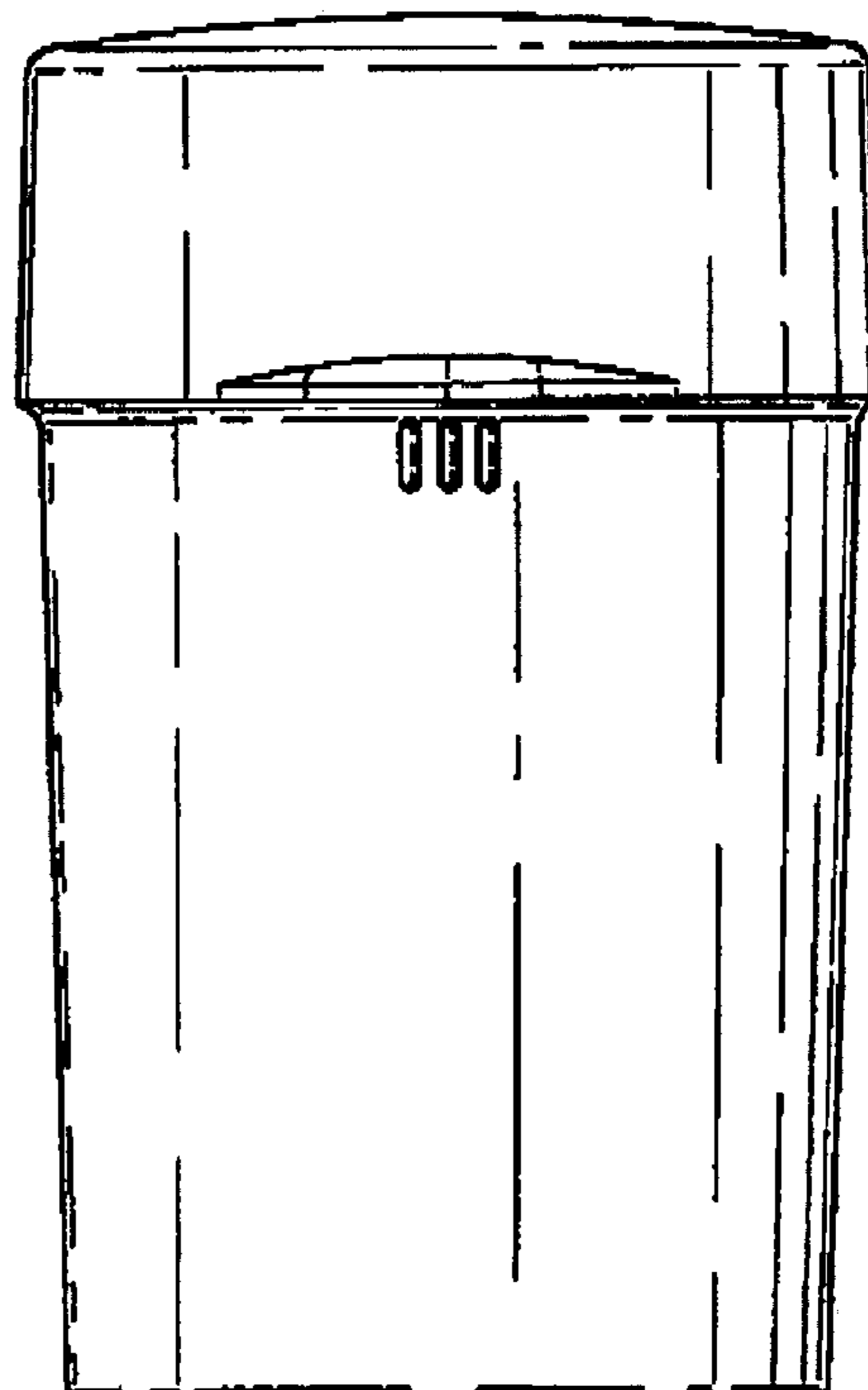

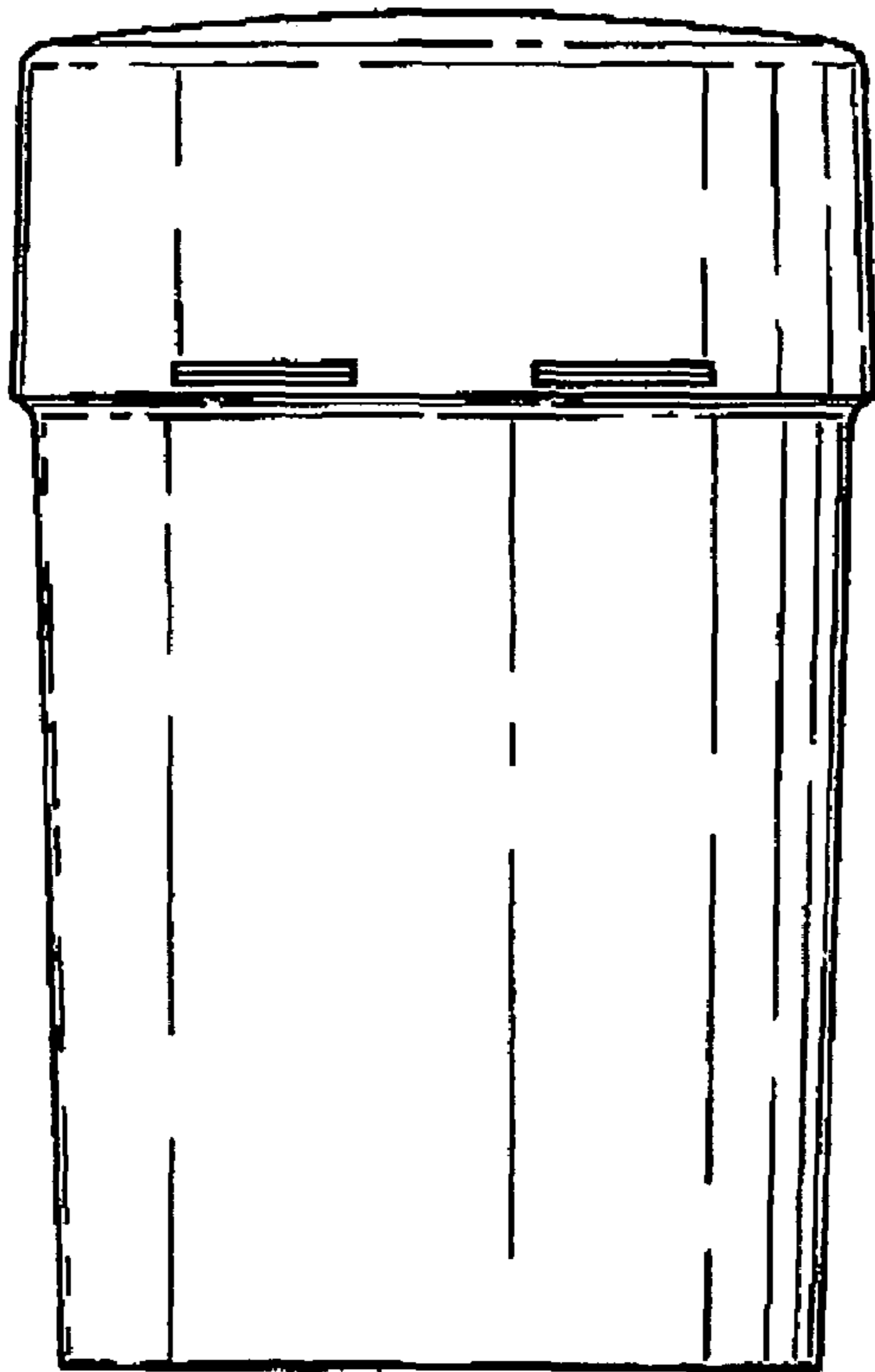

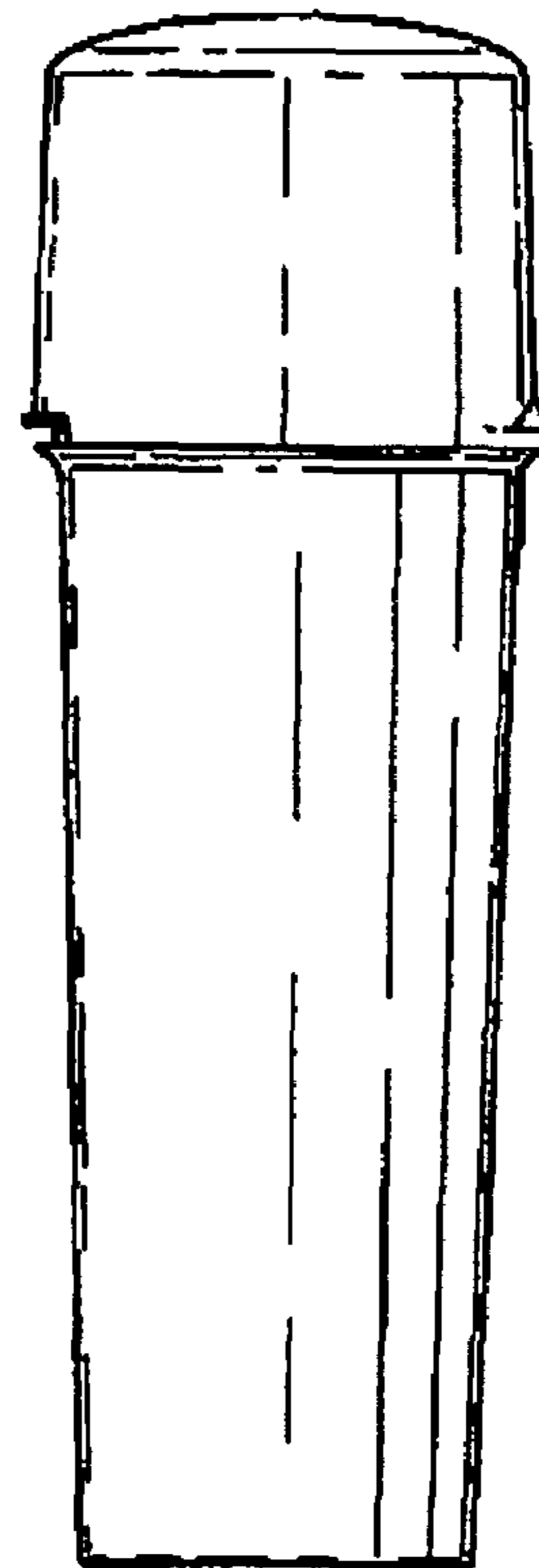

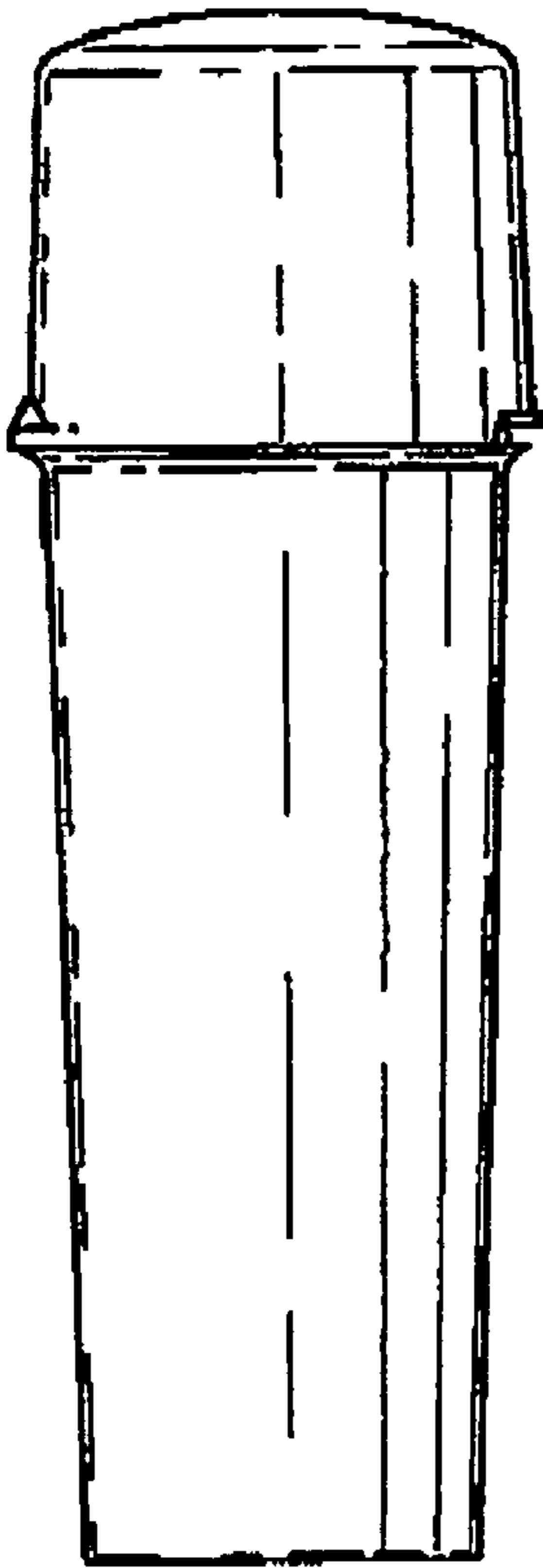

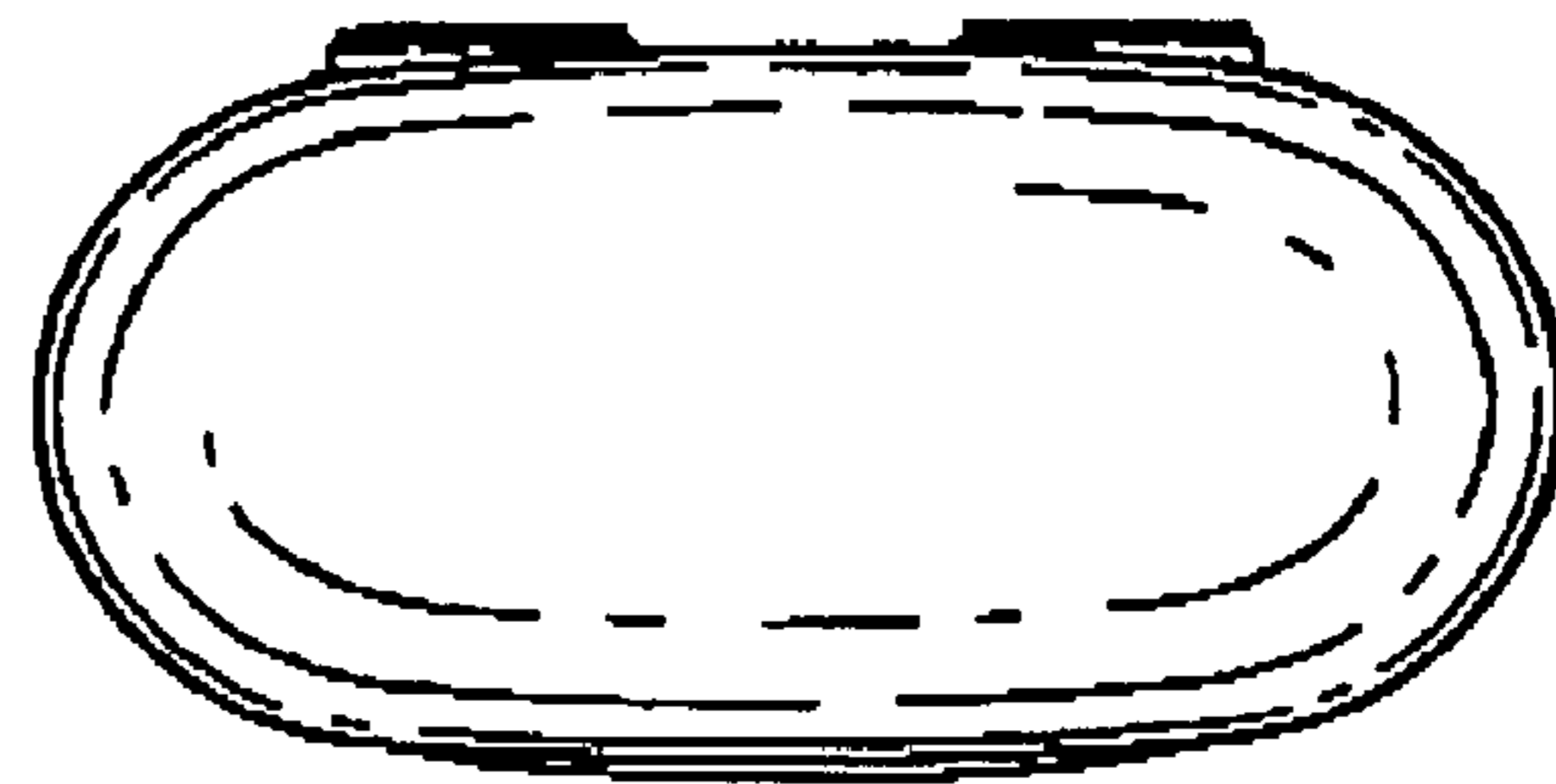

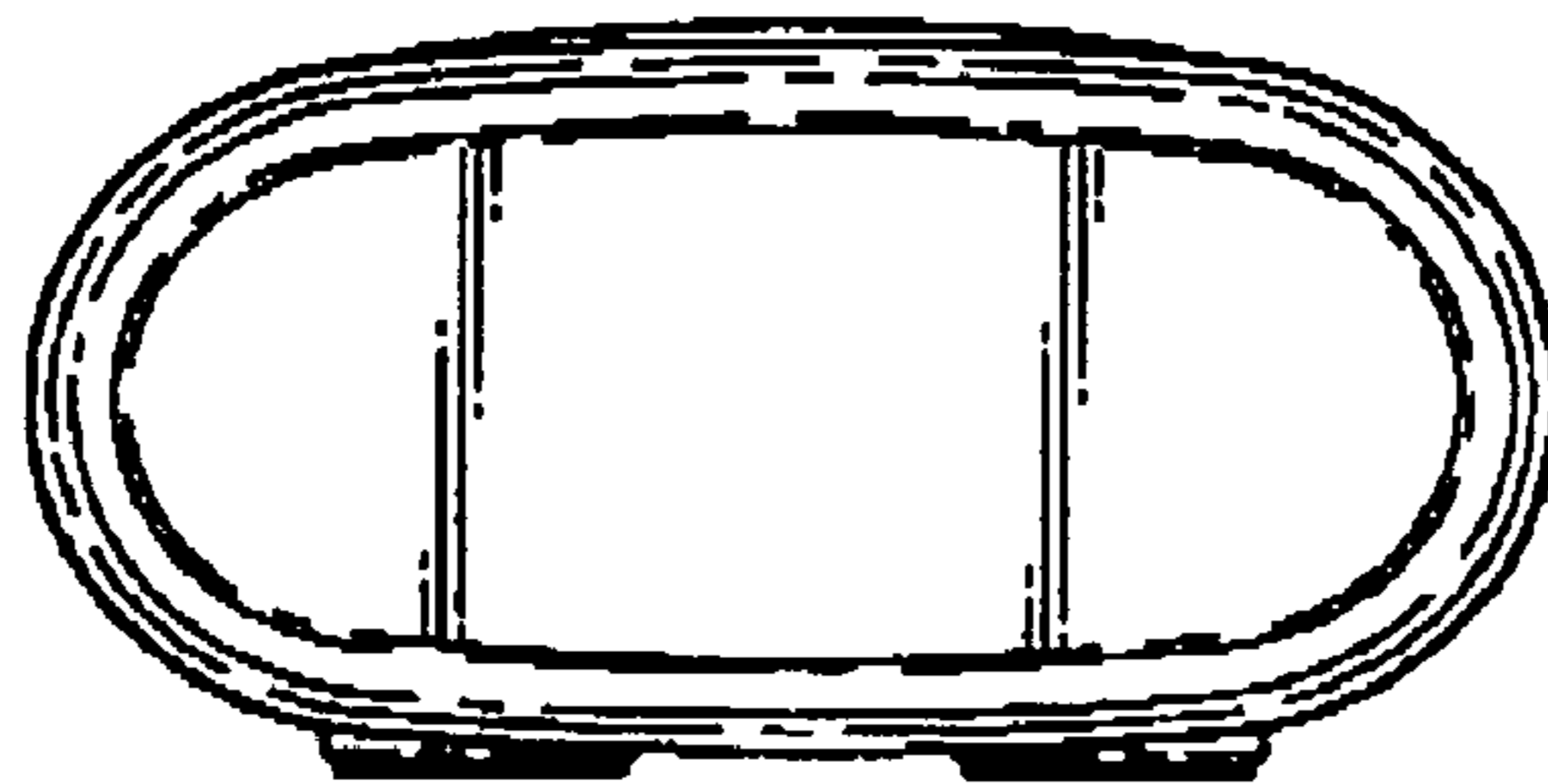

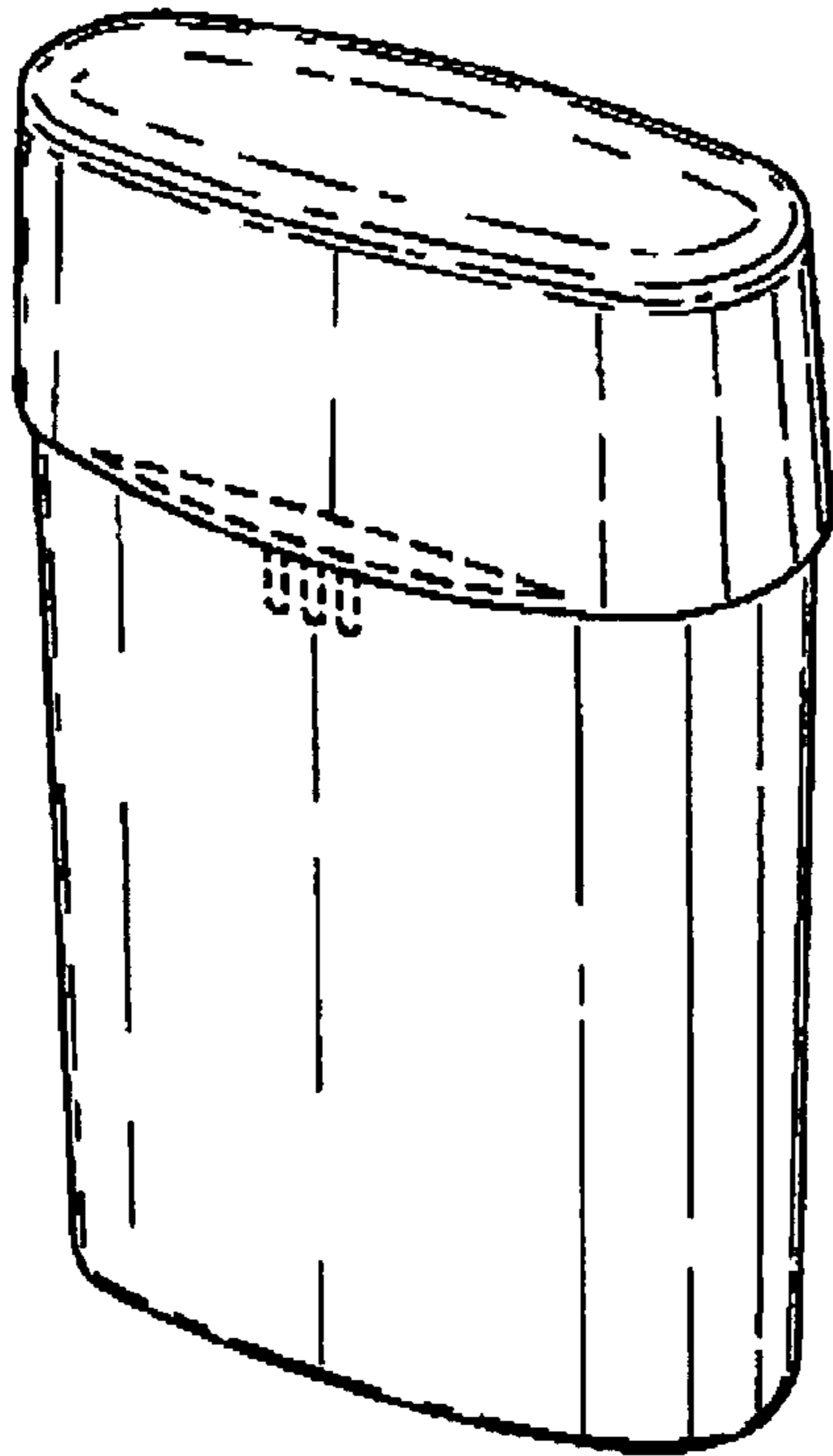

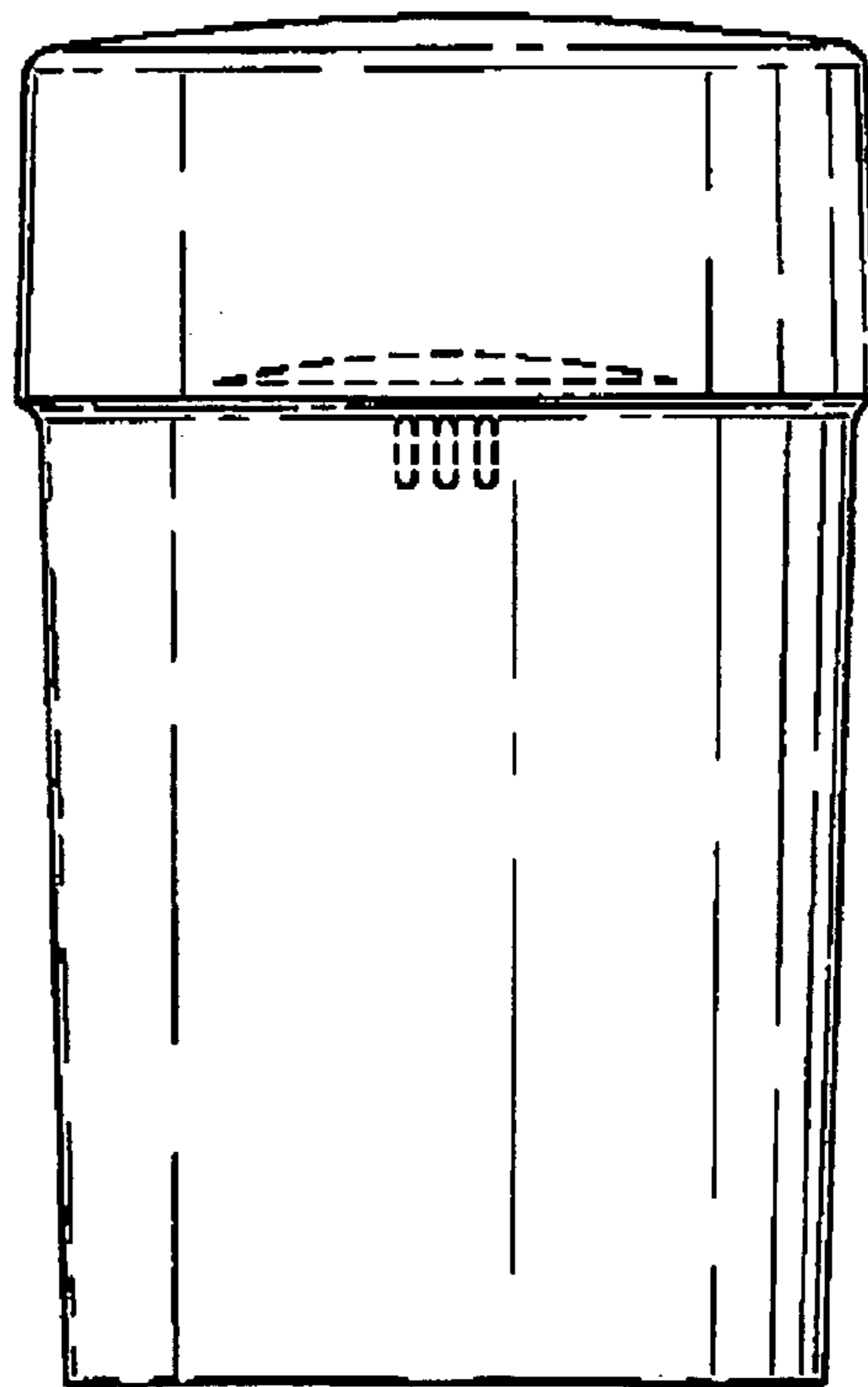

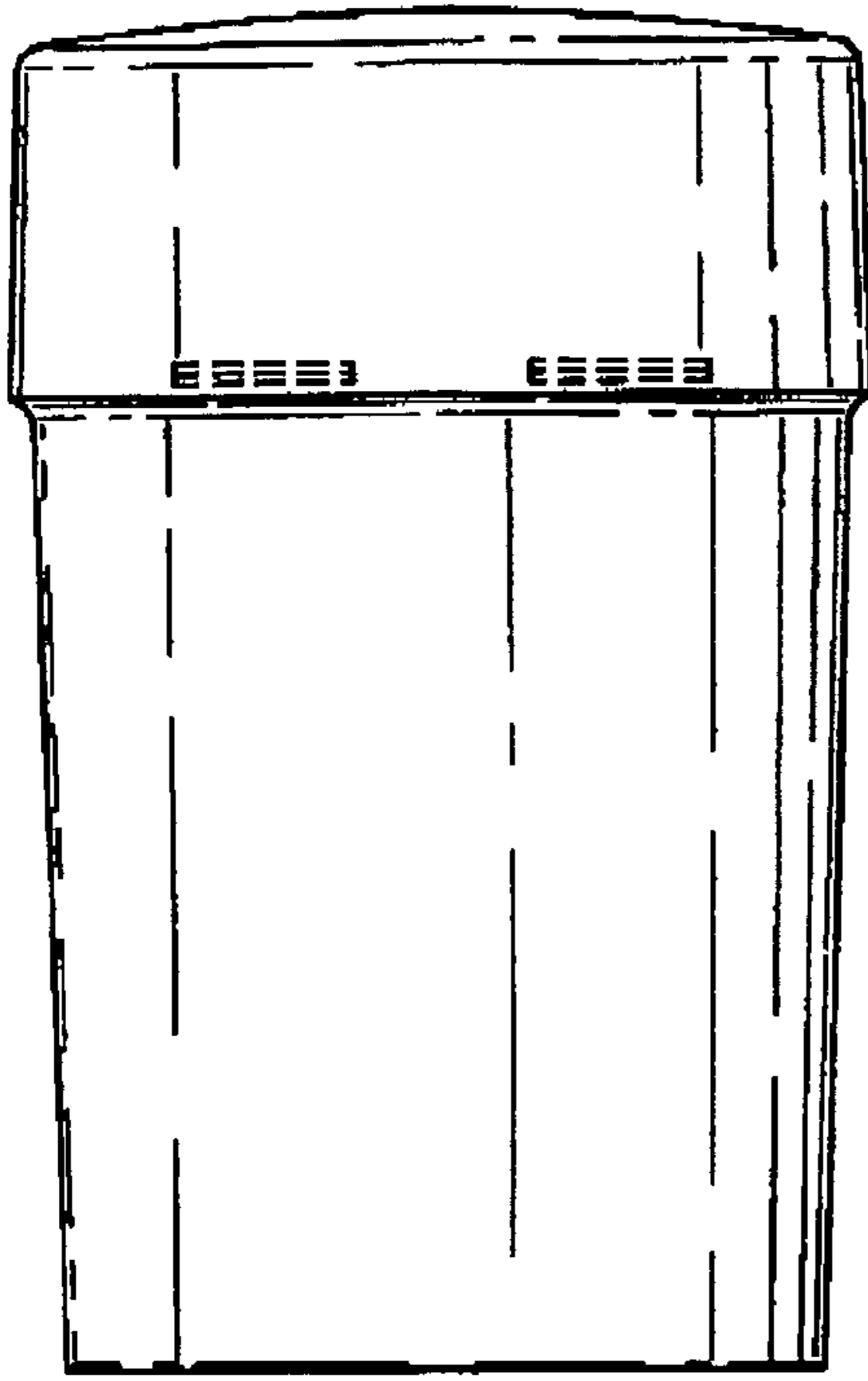

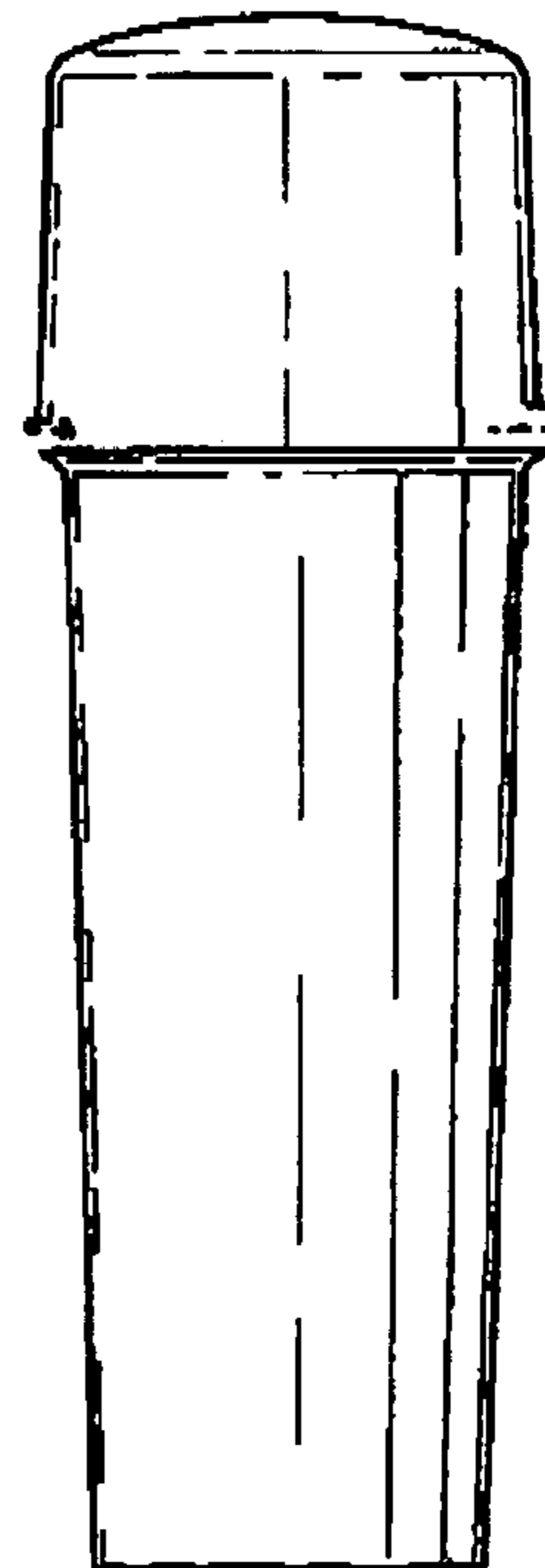

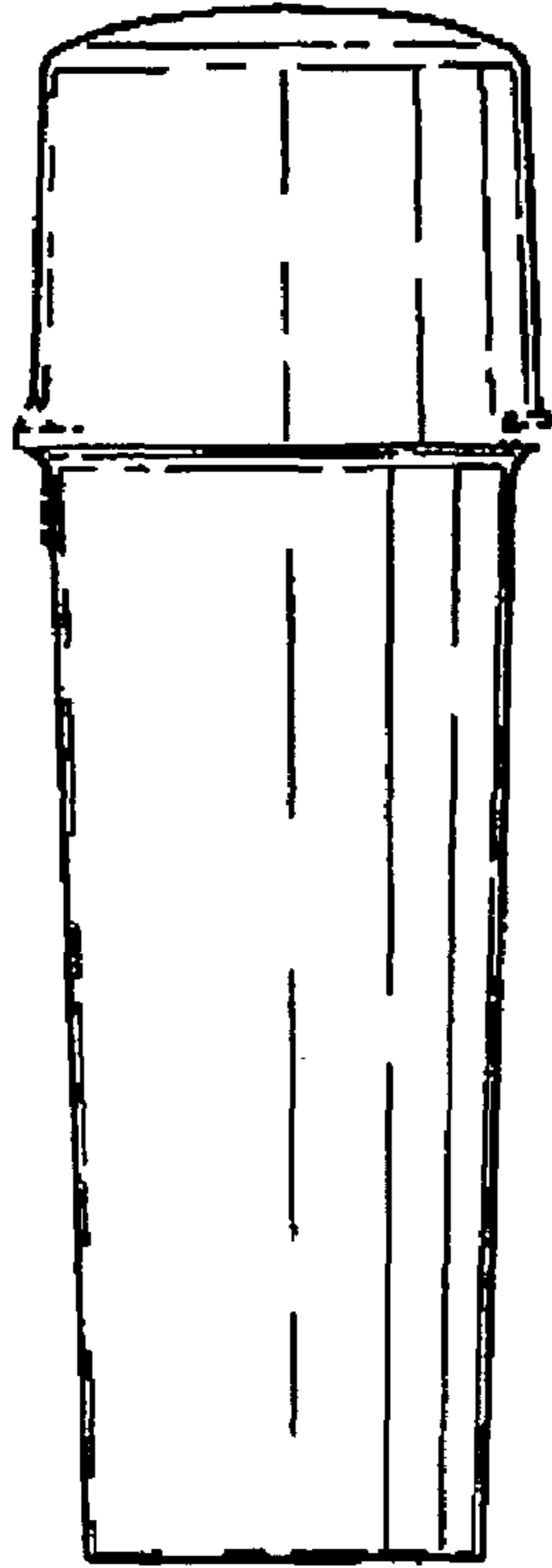

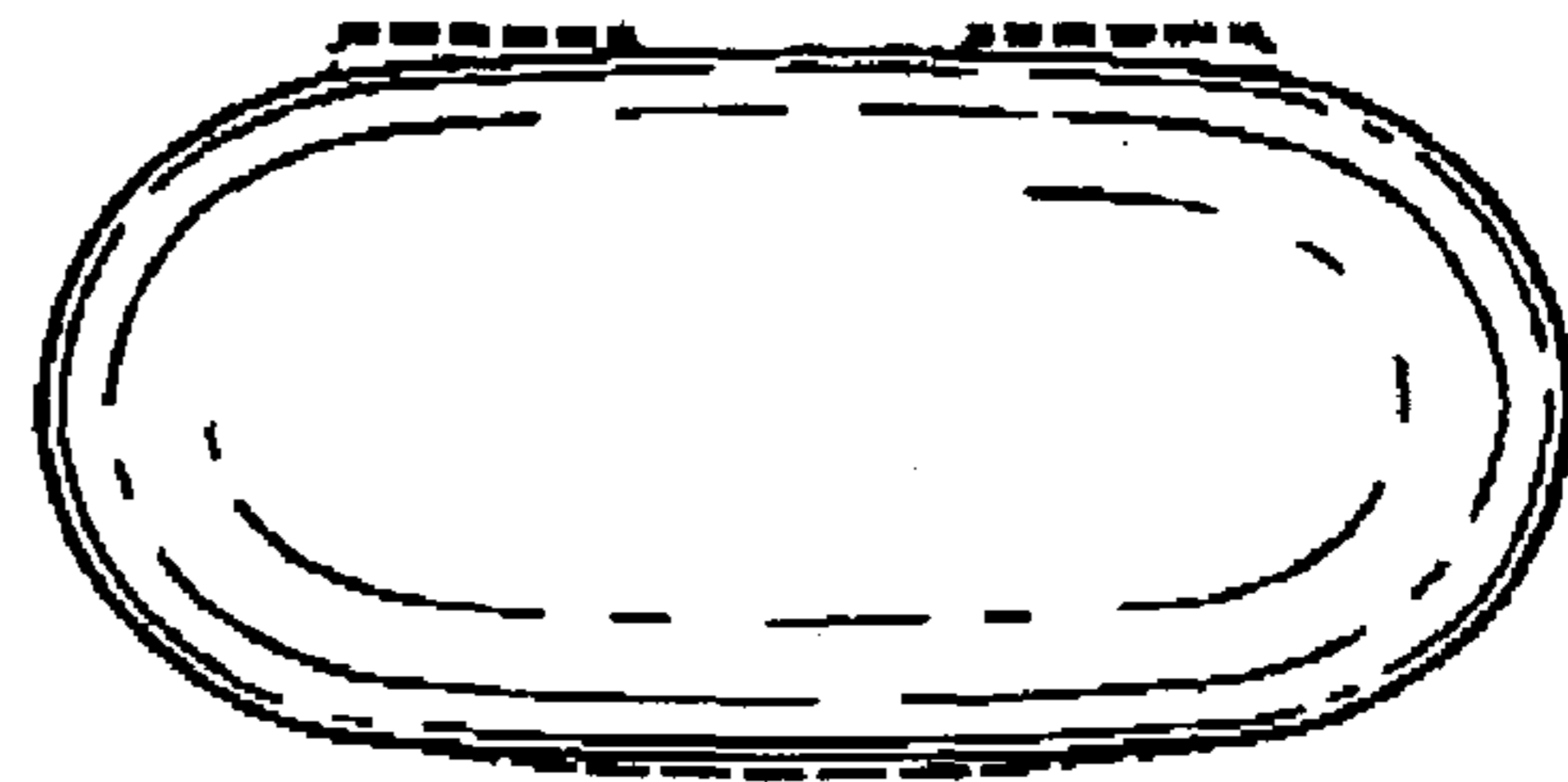

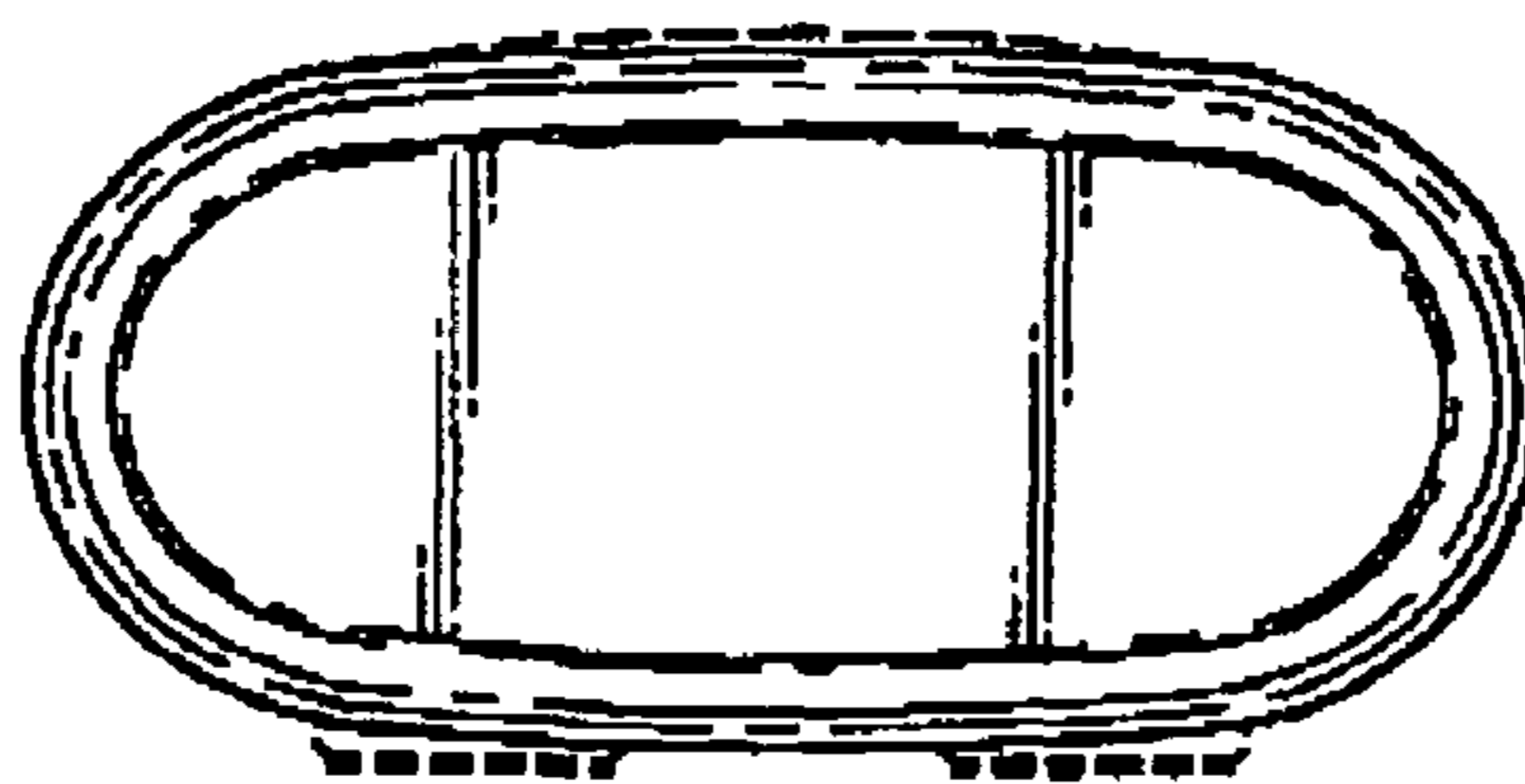
