FIG. 8 is a left side elevation view thereof;

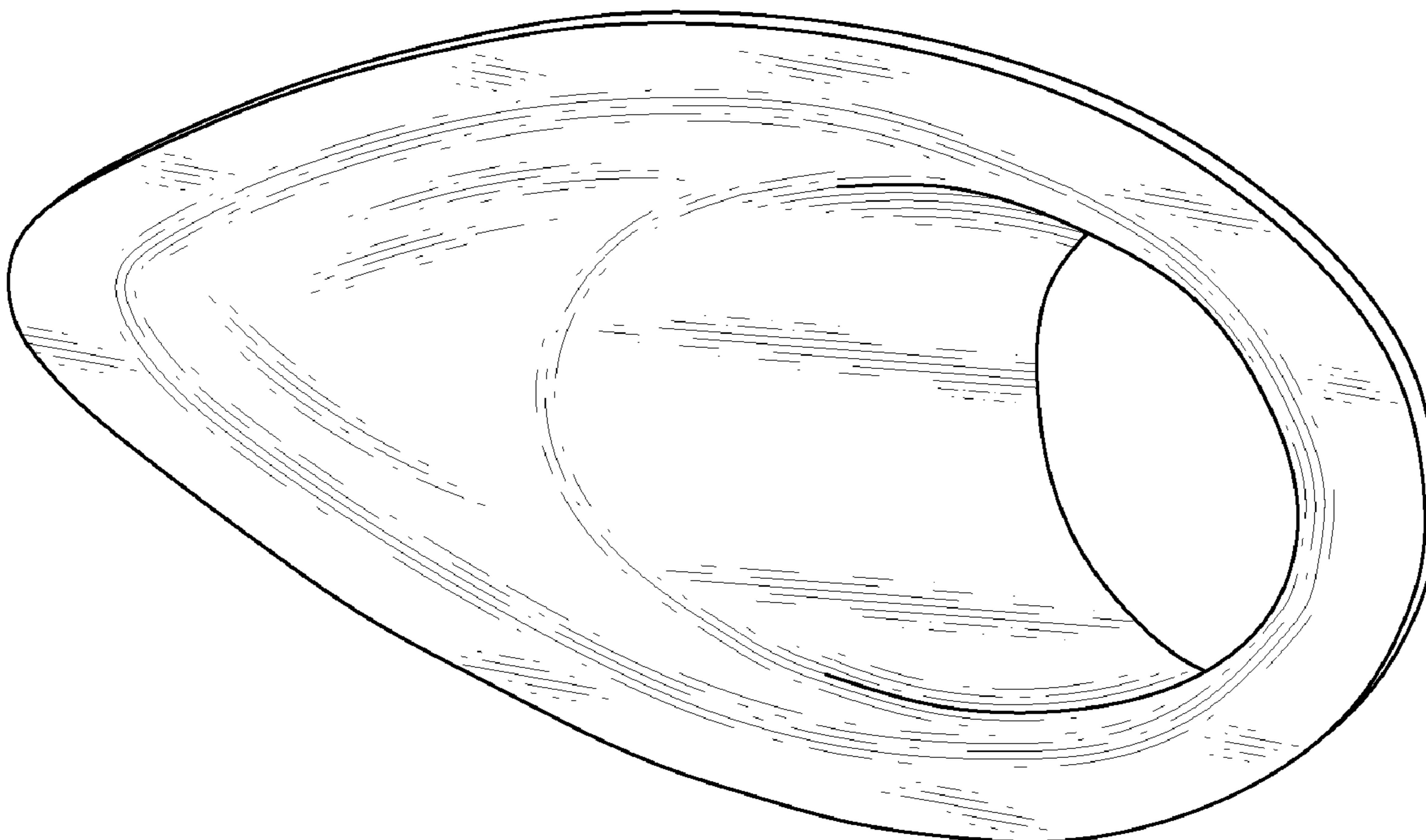
FIG. 9 is a top plan view thereof;

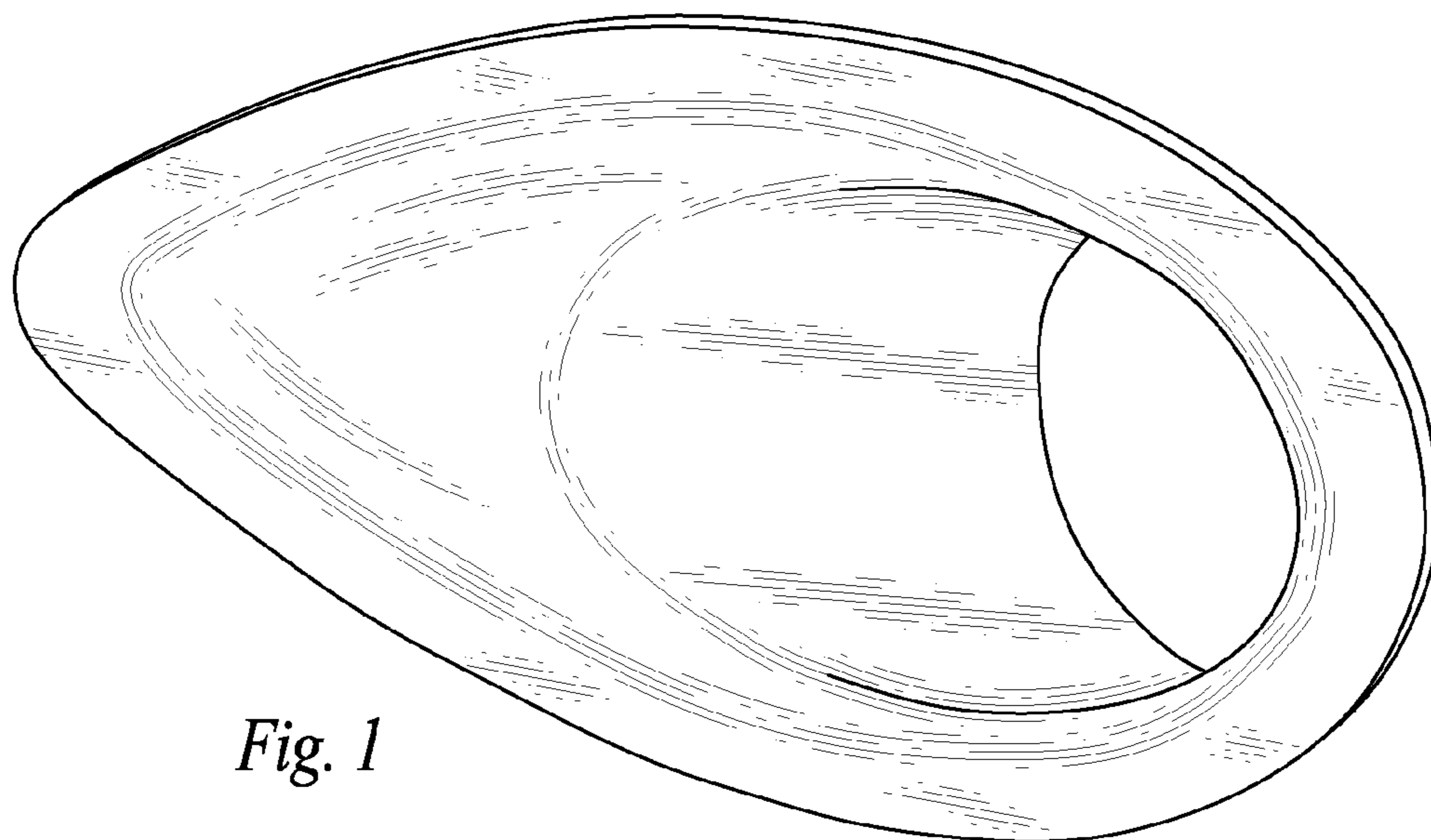
FIG. 10 is a right side elevation view thereof;

FIG. 11 is front elevation view thereof; and,

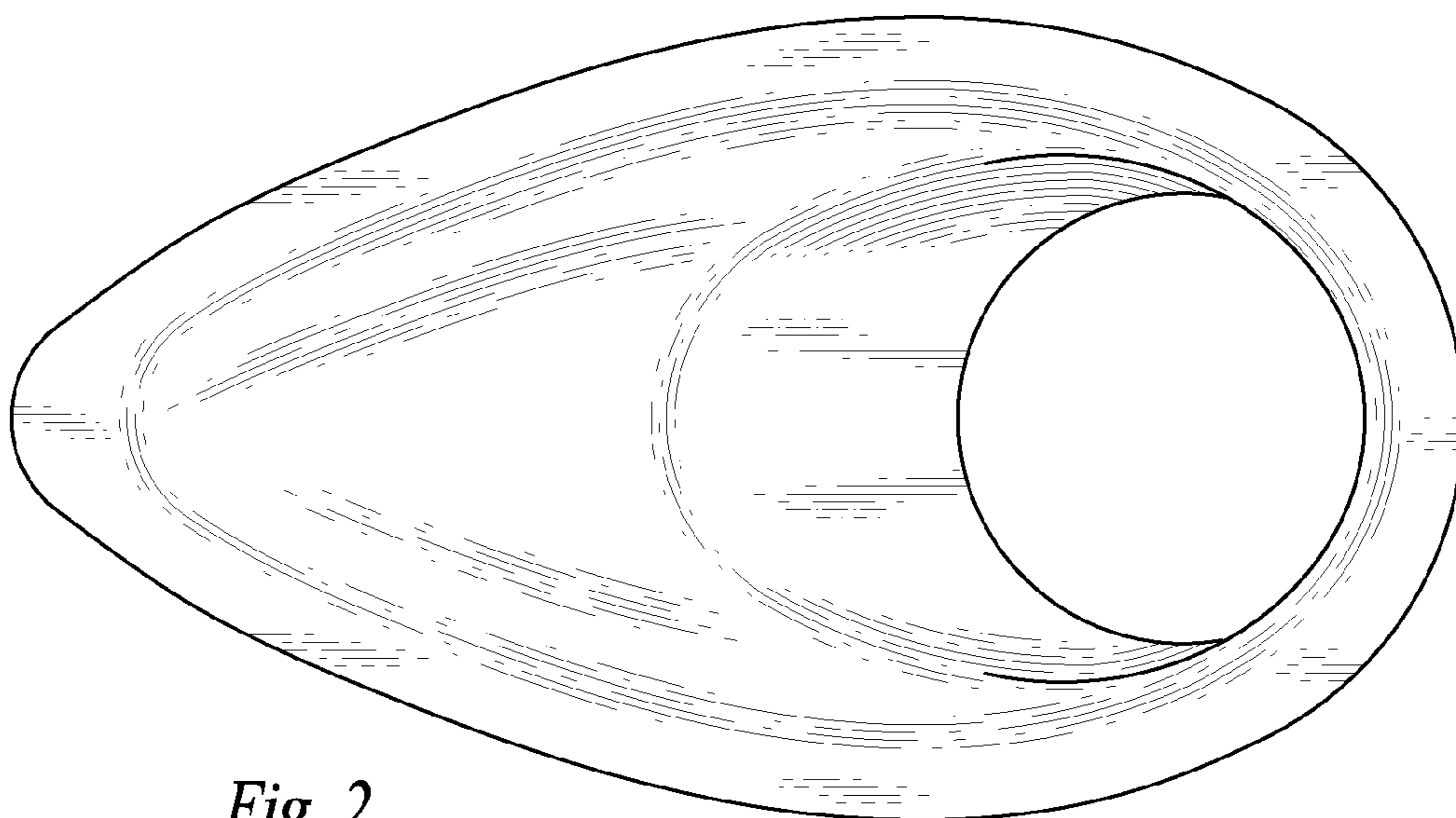
FIG. 12 is rear elevation view thereof.

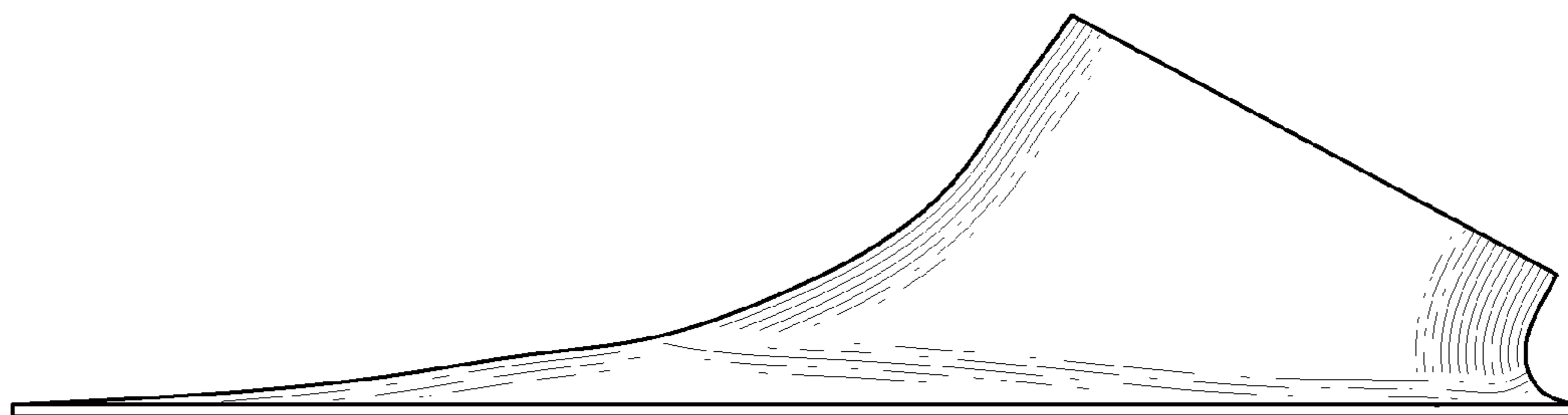




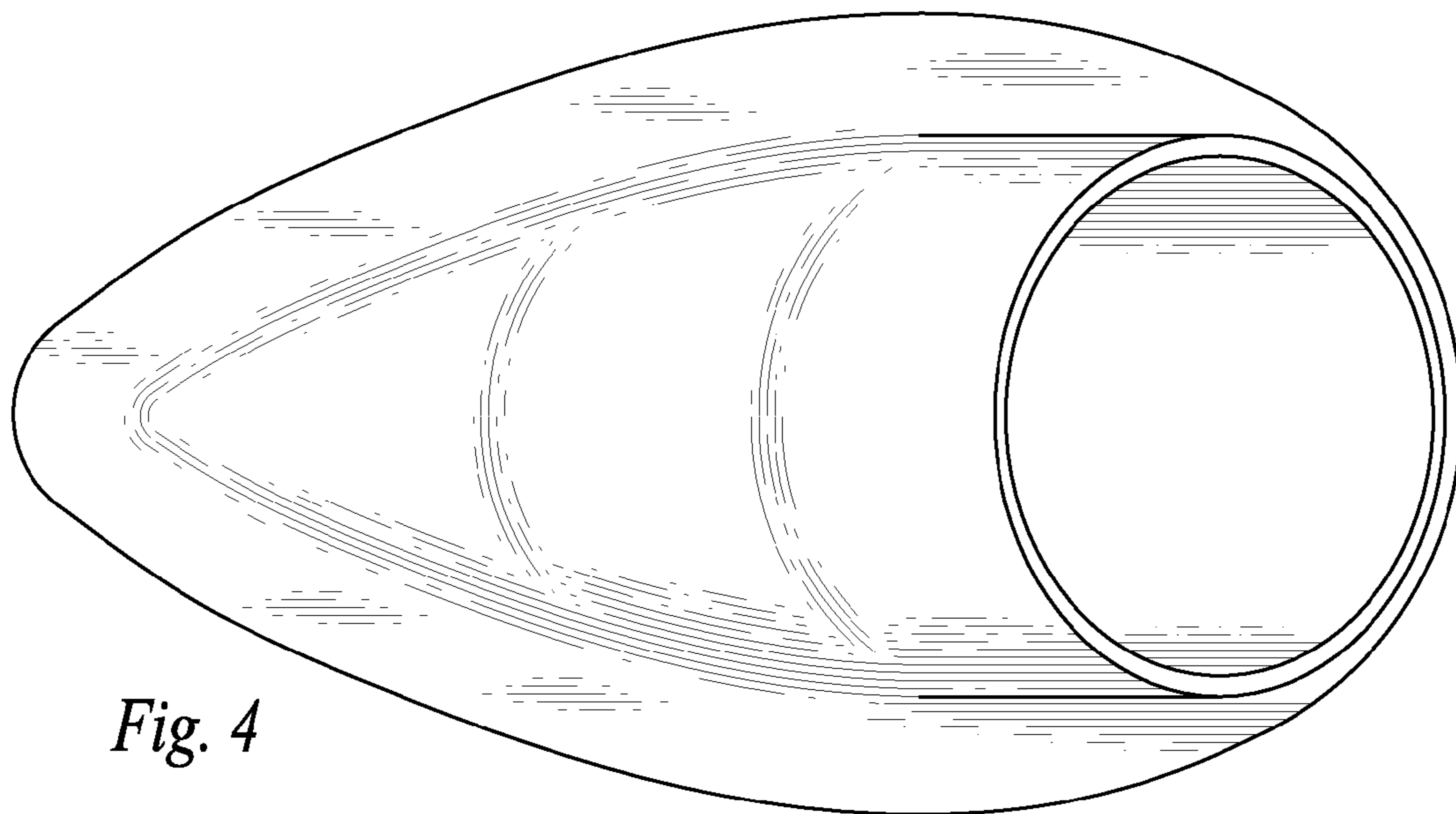

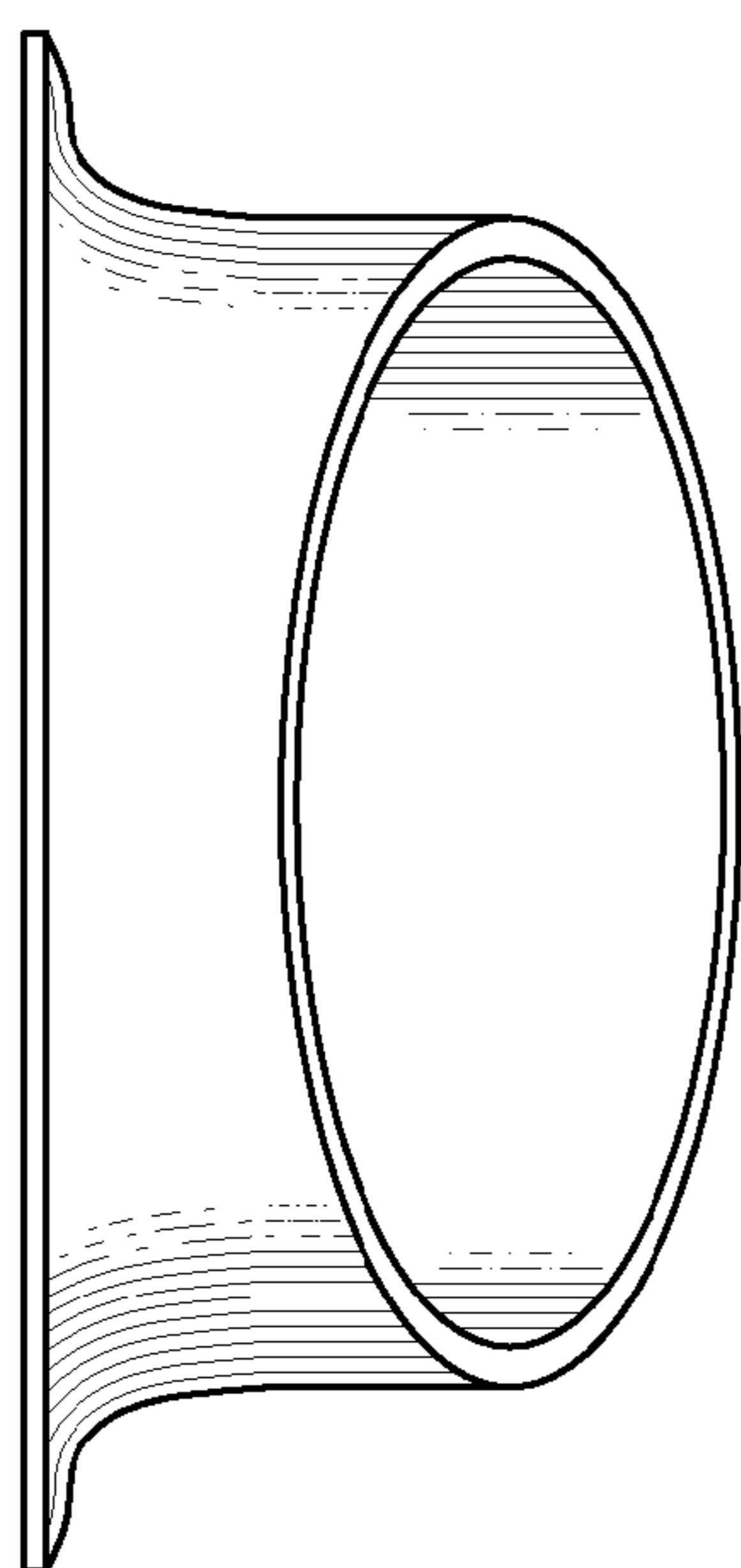

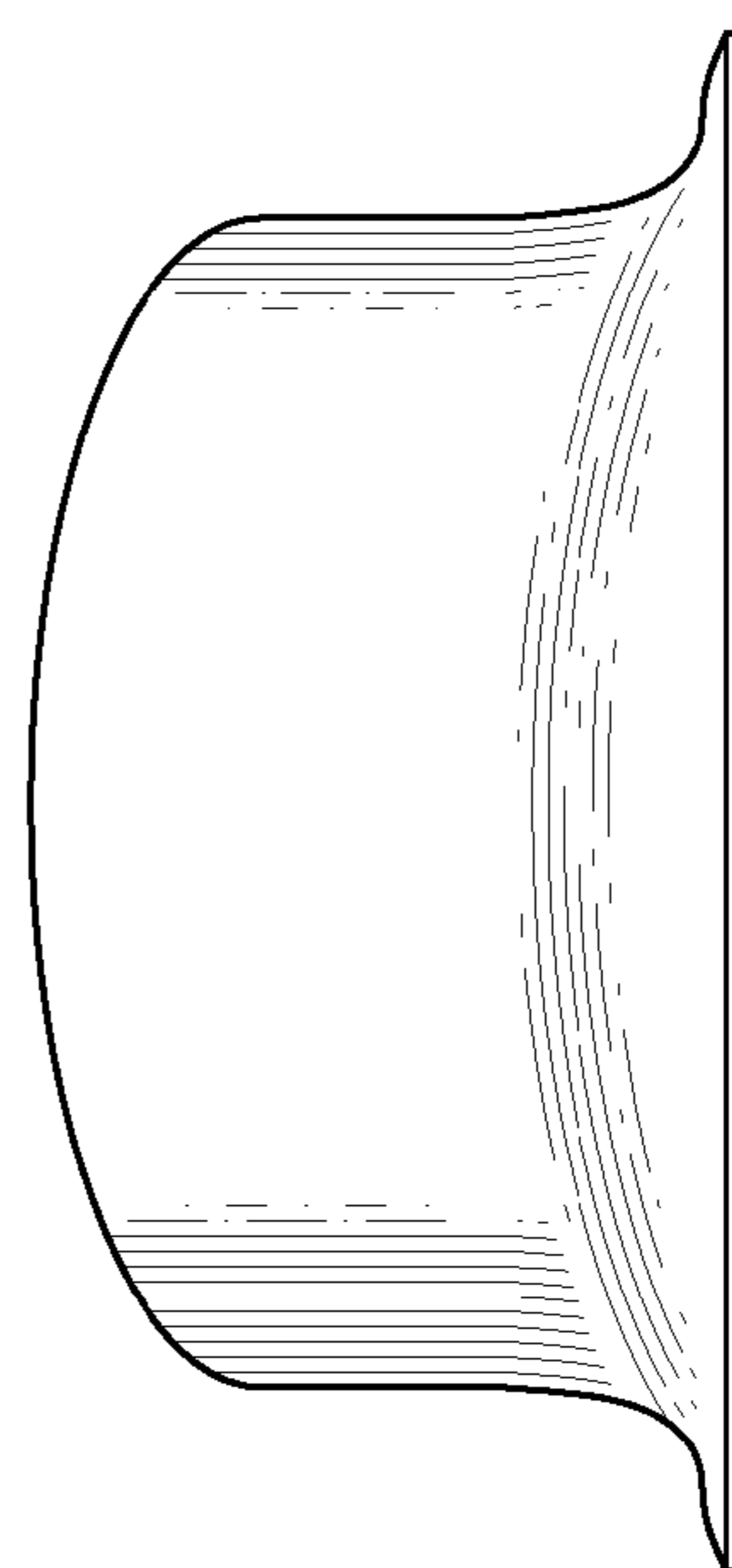

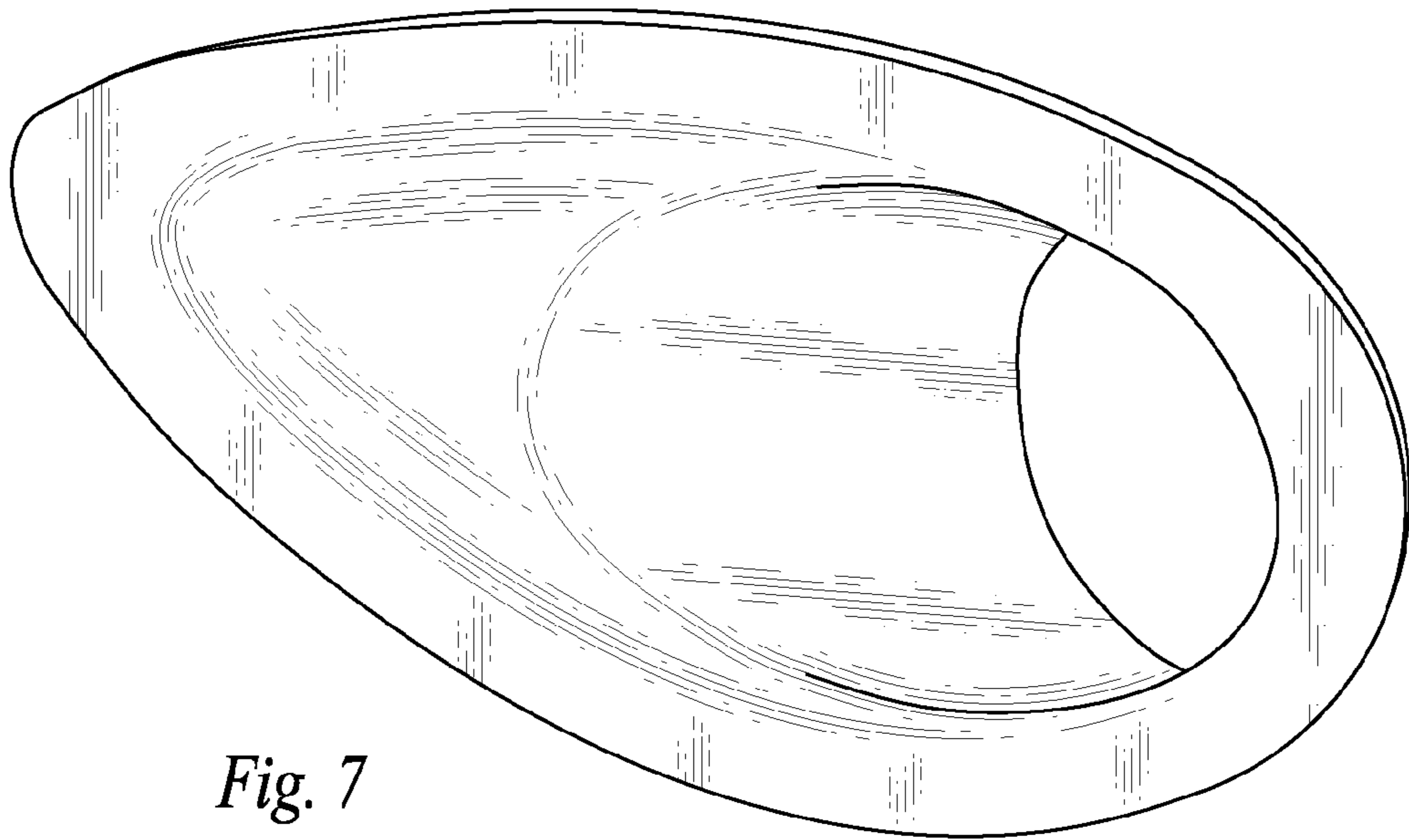

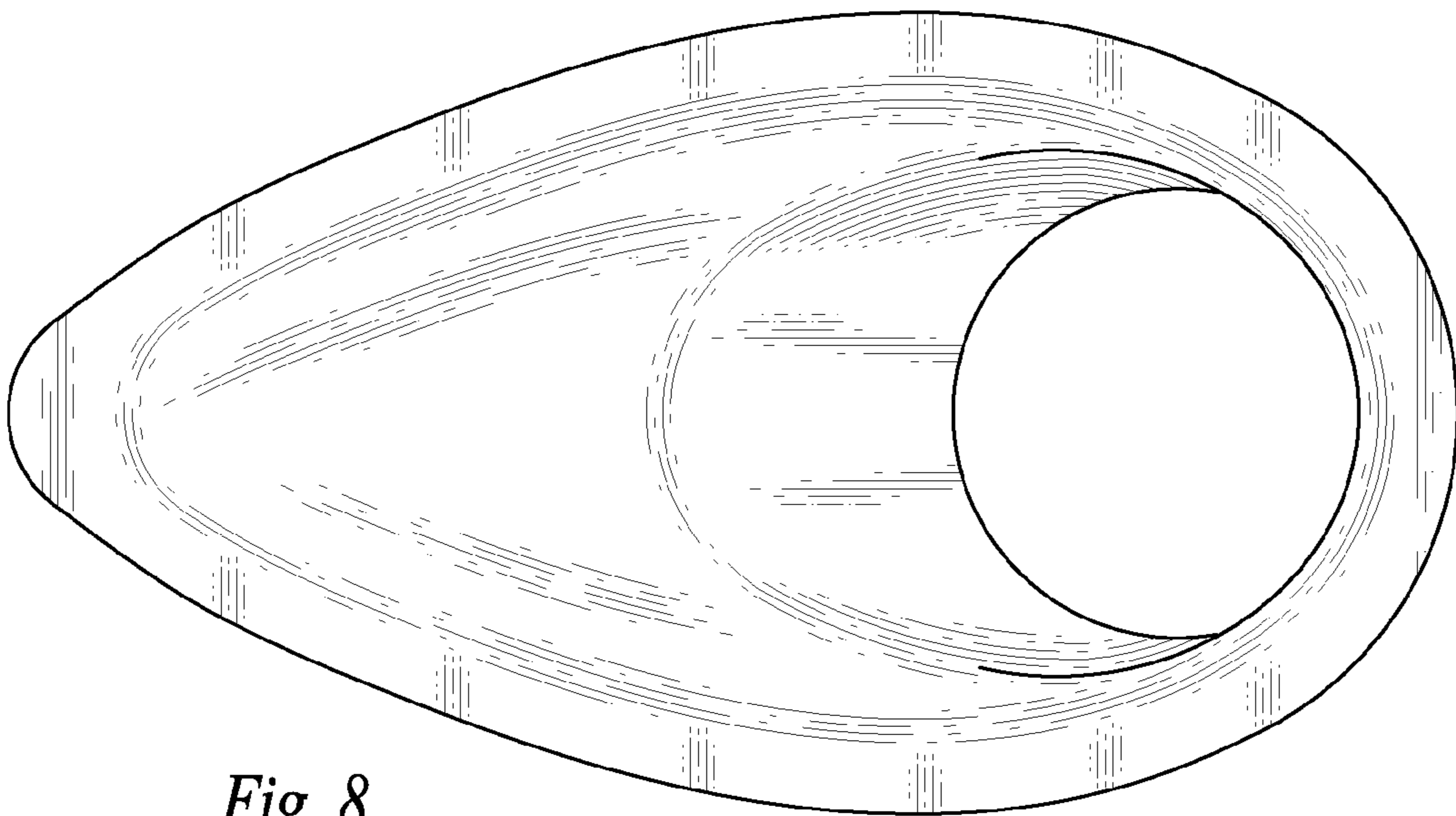

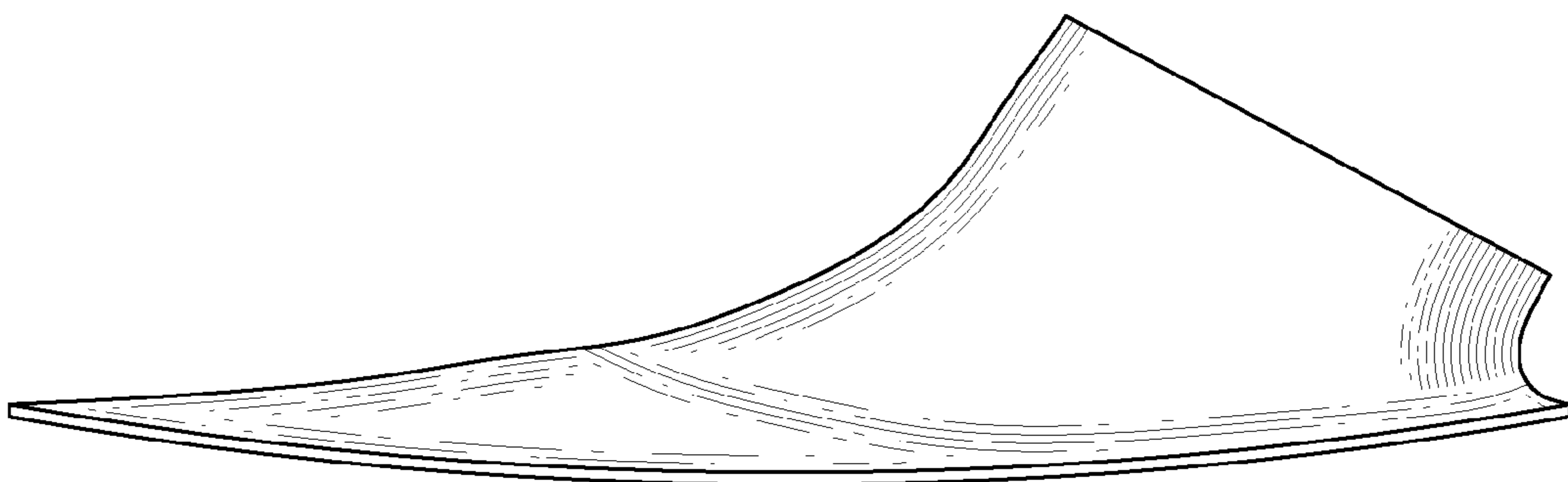

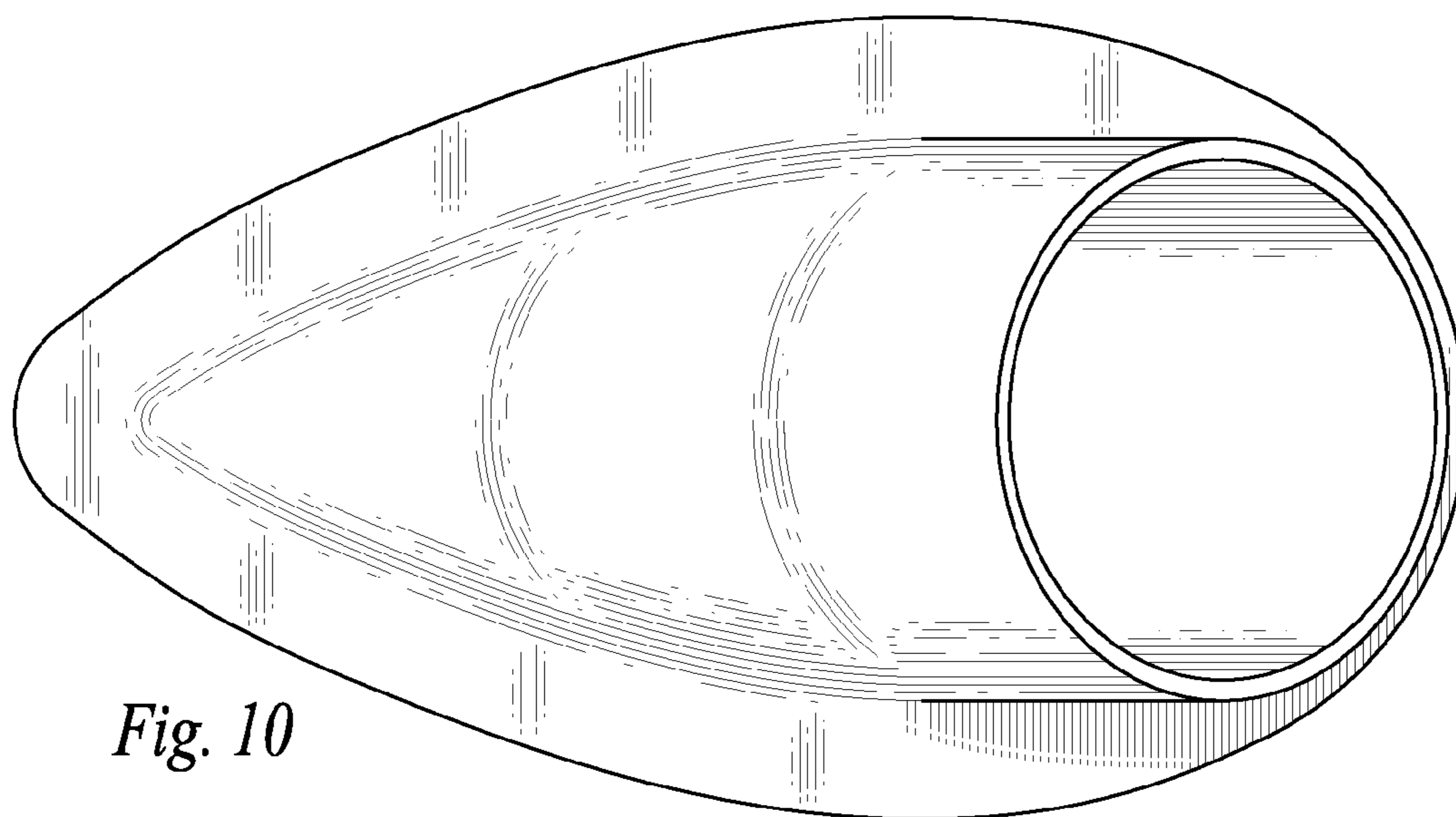

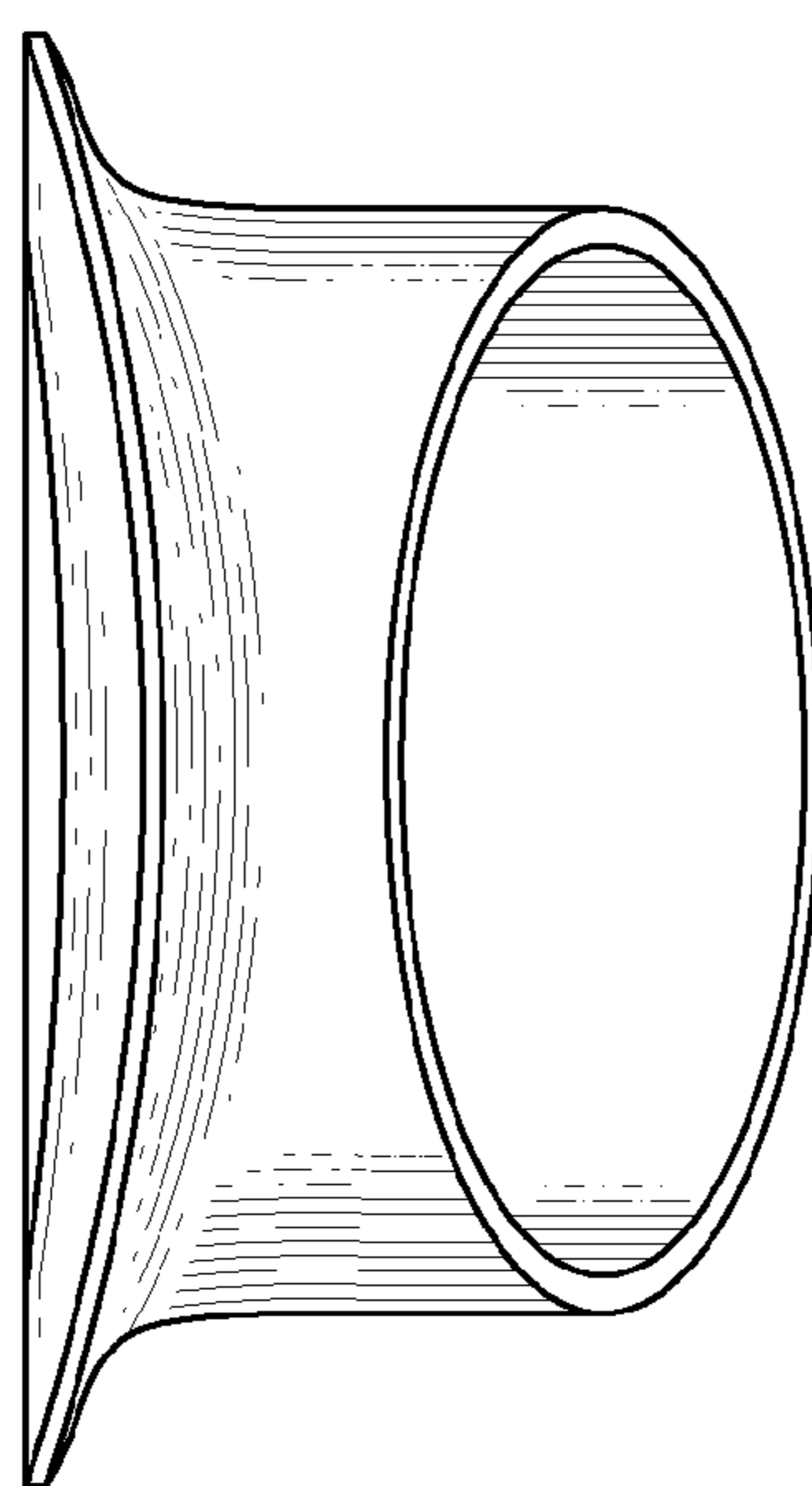

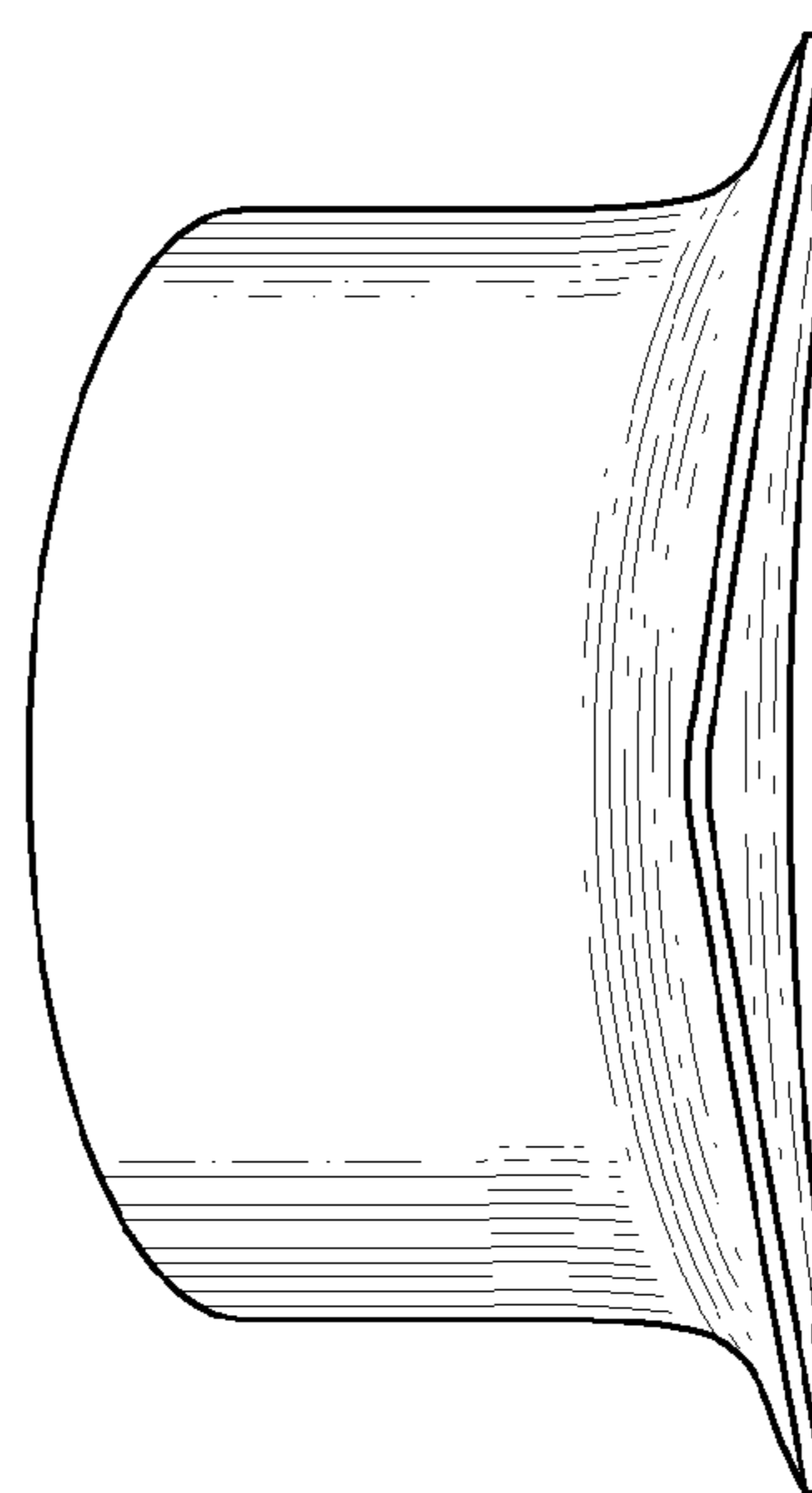
