We claim the ornamental design for mobile phone, as shown.

DESCRIPTION

- FIG. 1 is a front/left-side/top perspective view of a mobile phone showing our new design;
- FIG. 2 is a front elevational view thereof;
- FIG. 3 is a rear elevational view thereof;
- FIG. 4 is a left-side elevational view thereof;
- FIG. 5 is a right-side elevational view thereof;
- FIG. 6 is a top-side elevational view thereof;
- FIG. 7 is a bottom-side elevational view thereof; and,
- FIG. 8 is a a front/left-side/top perspective view thereof when mobile phone is open.

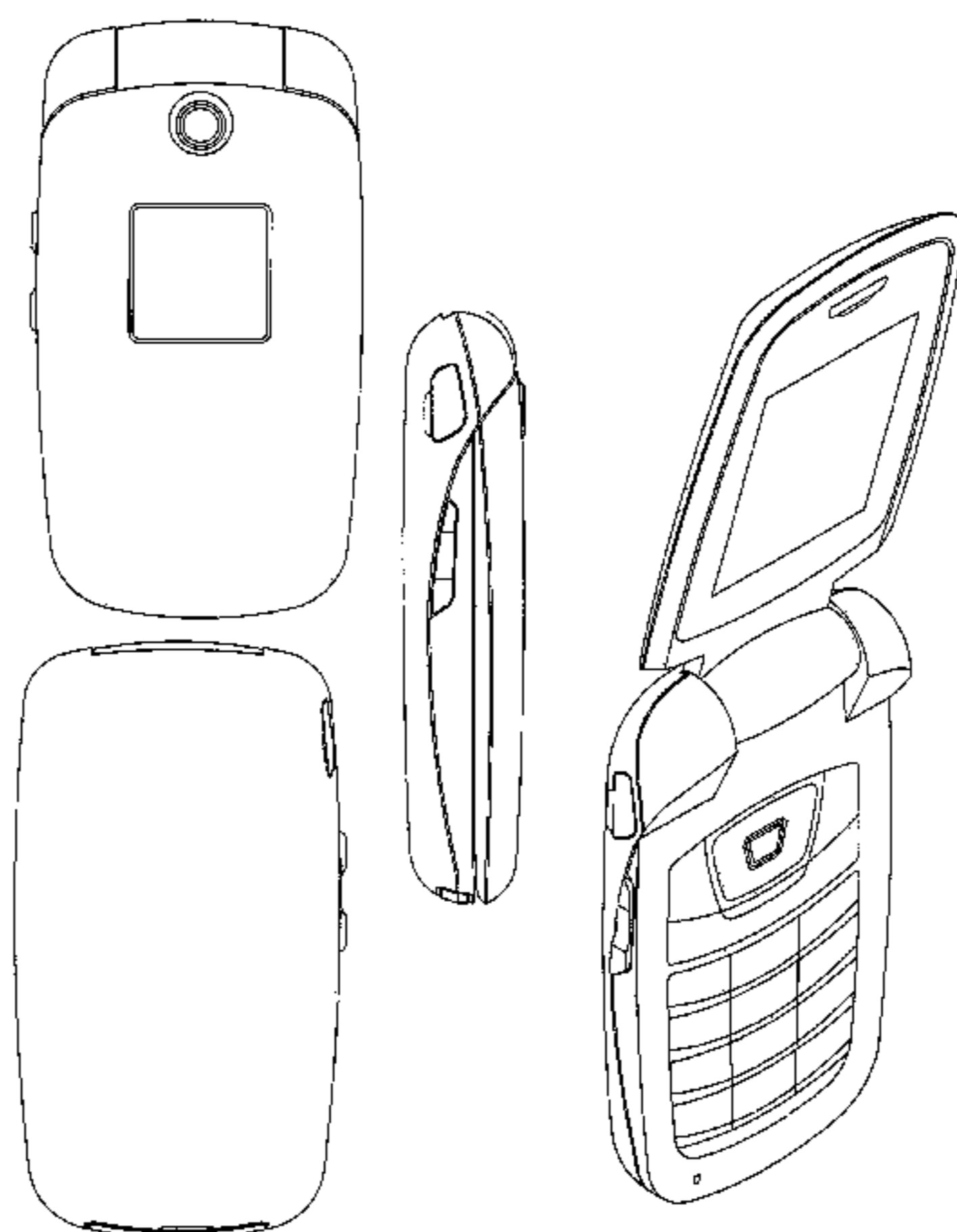

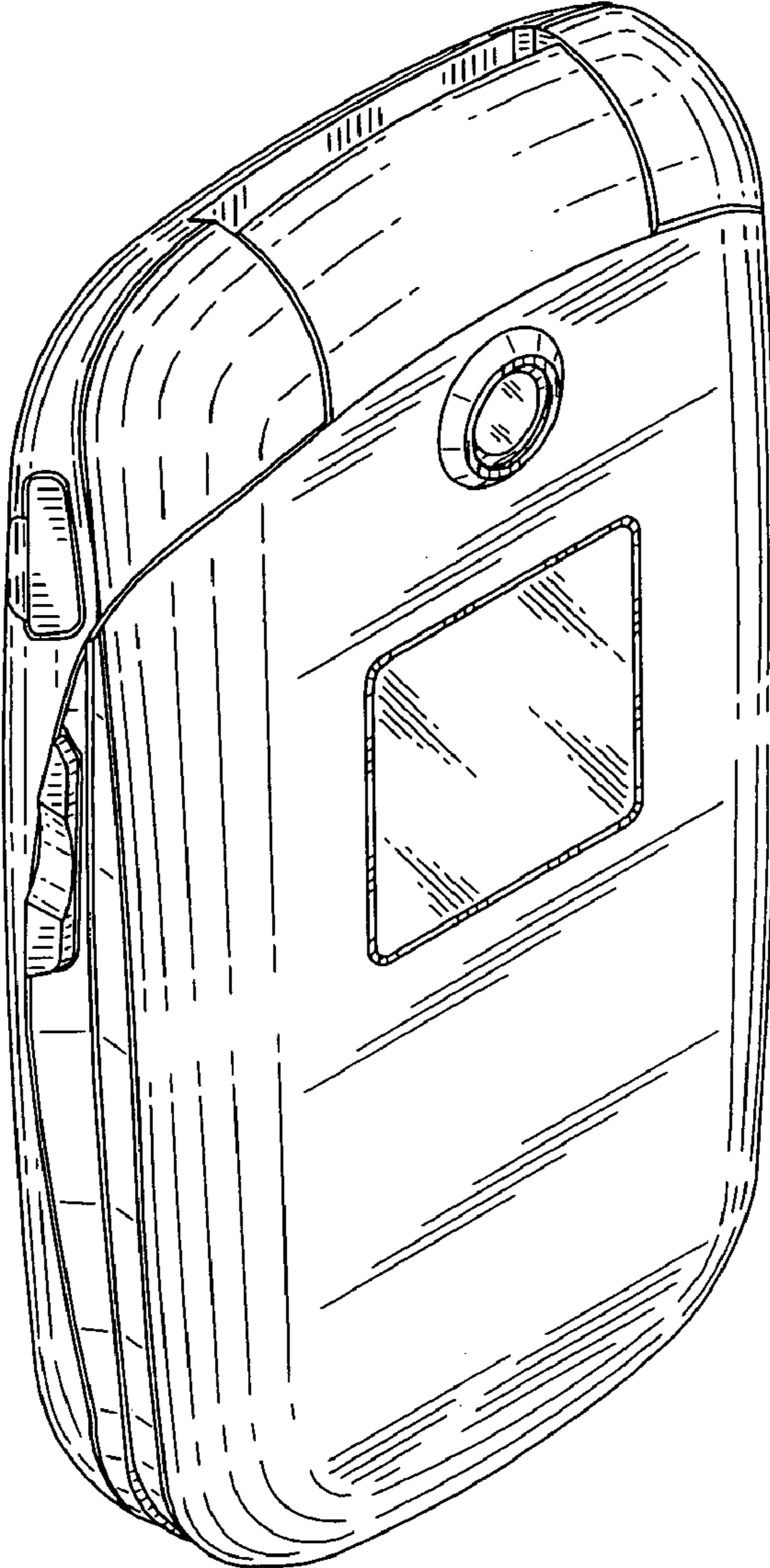

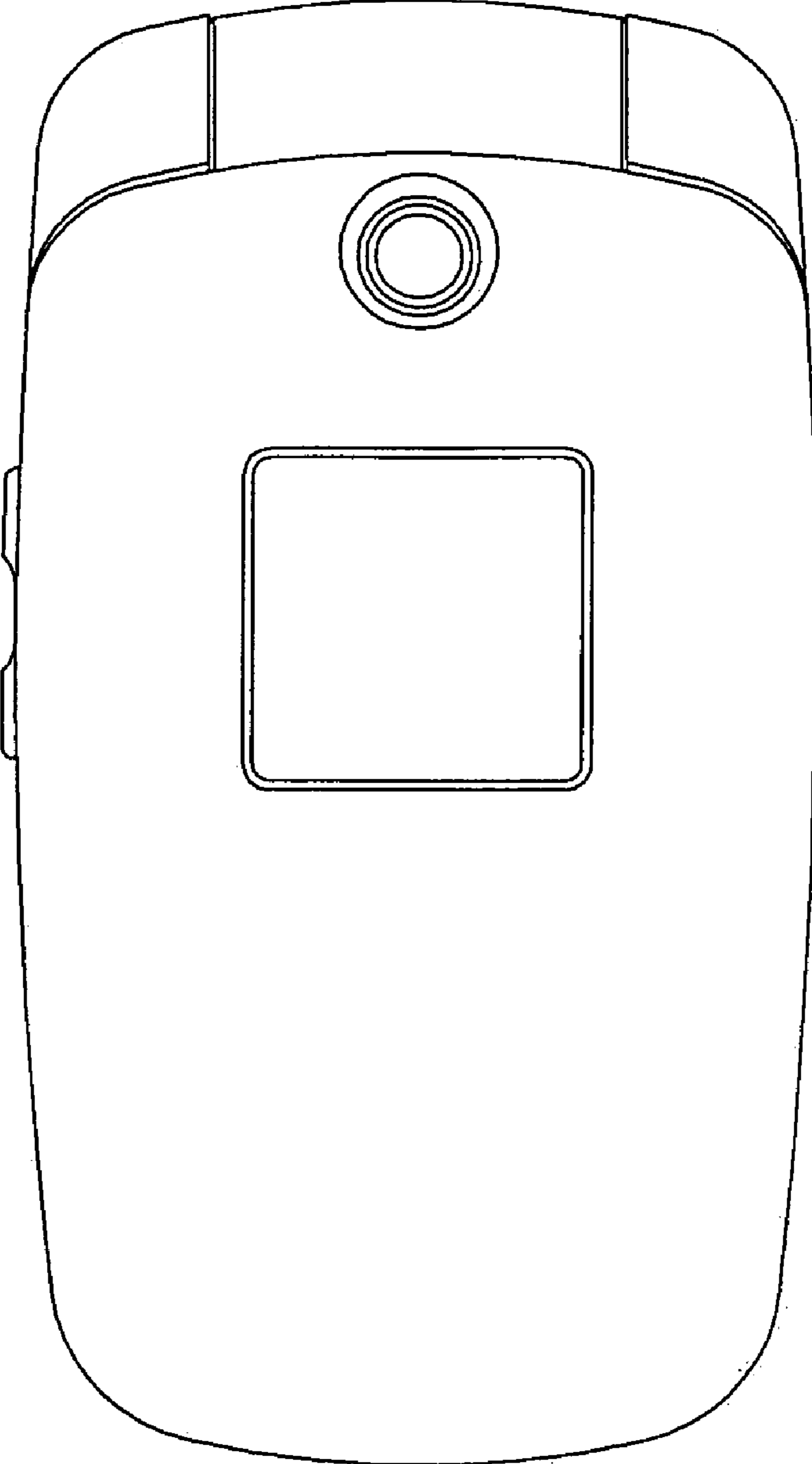

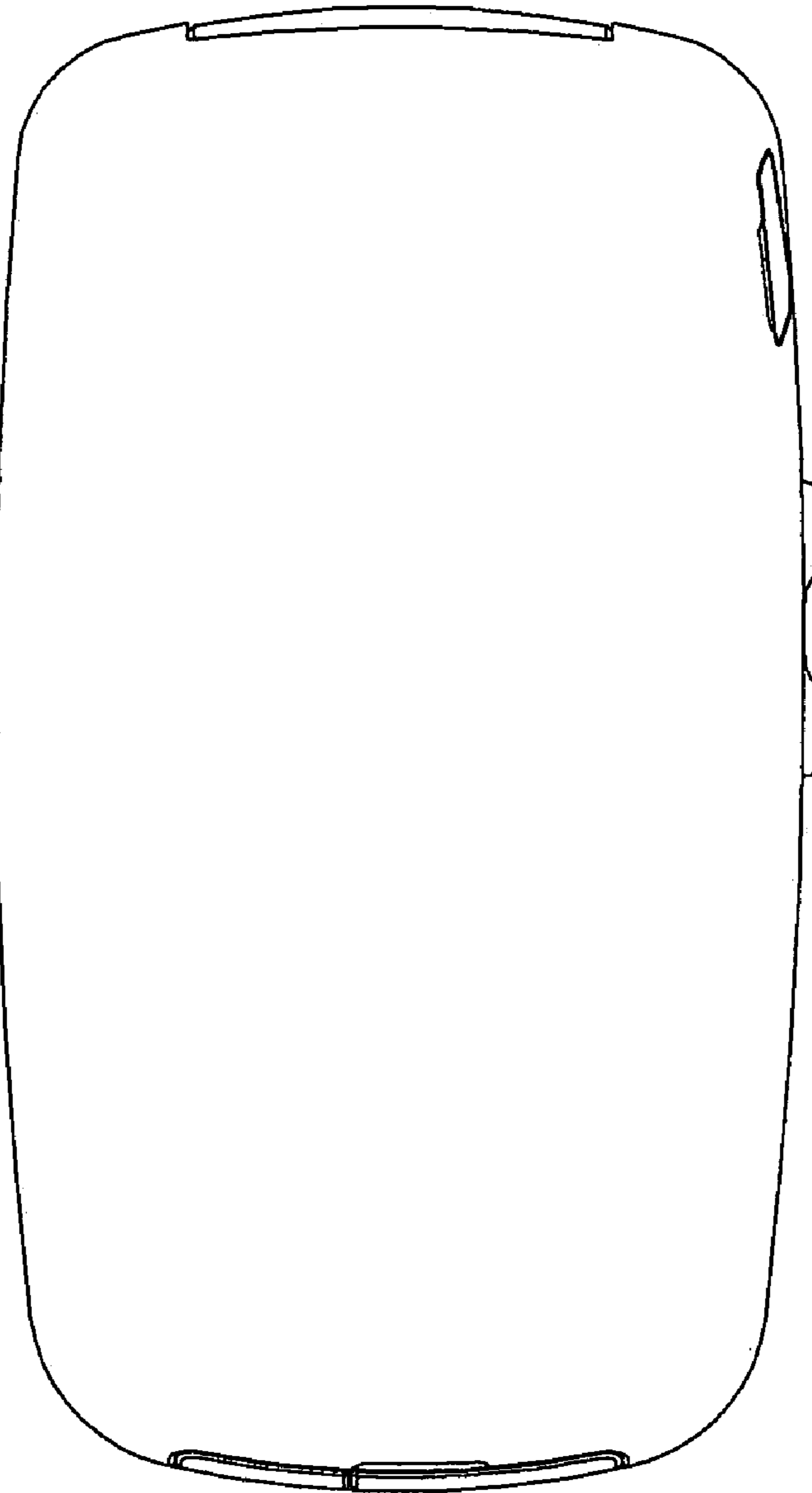

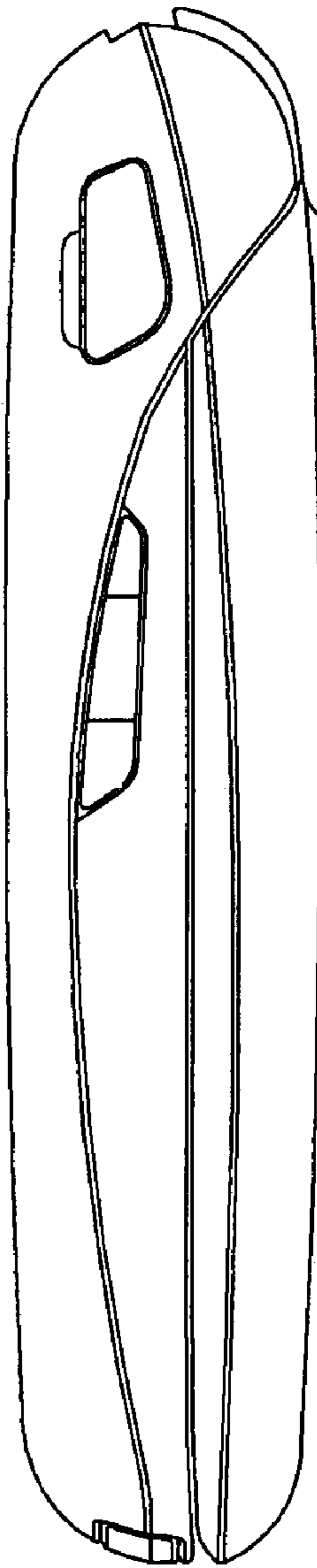

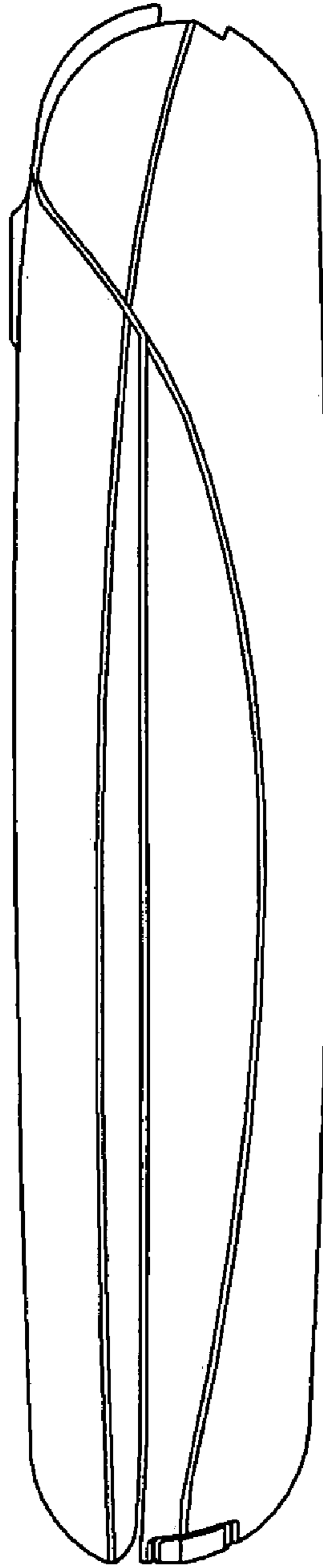

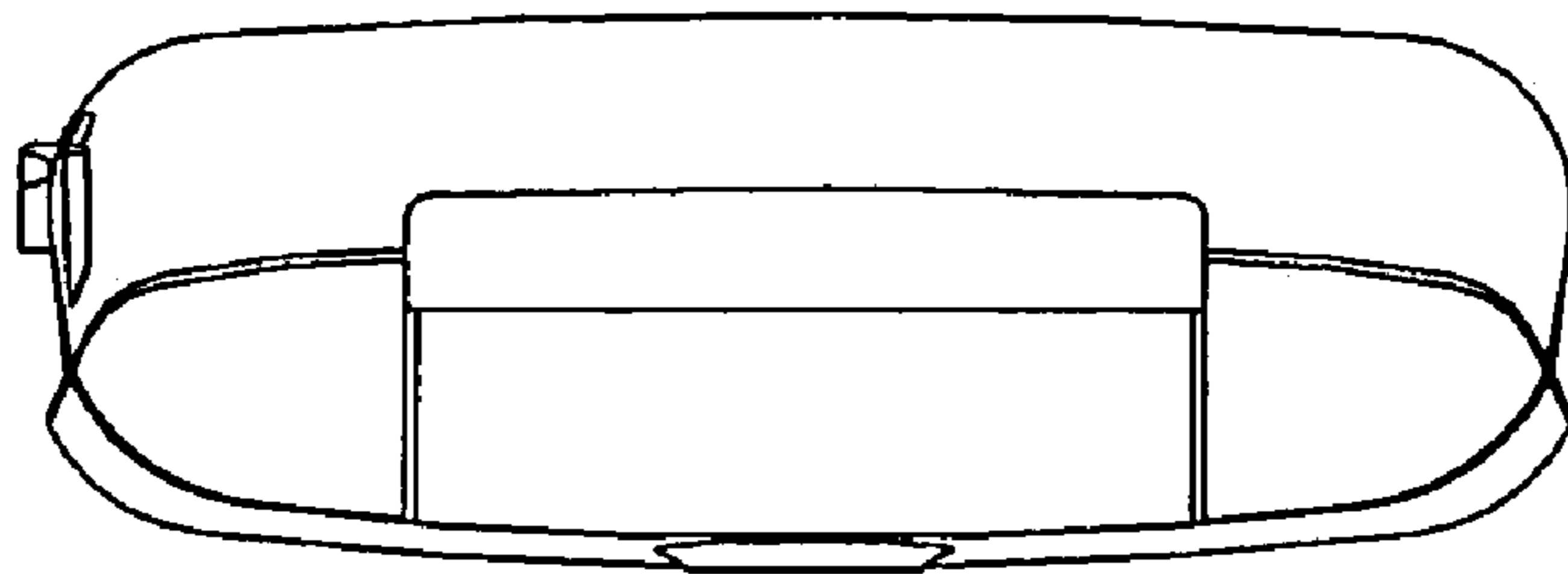

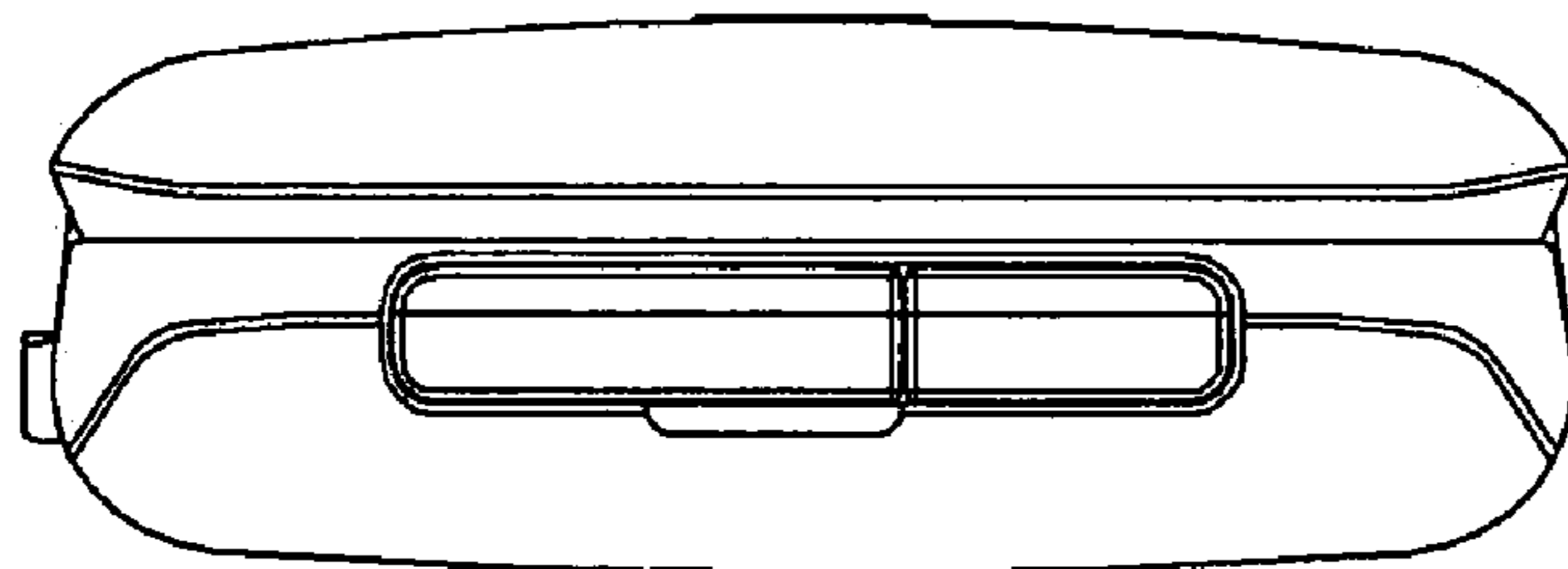
