FIG. 1 is a perspective view of a light component showing my new design.

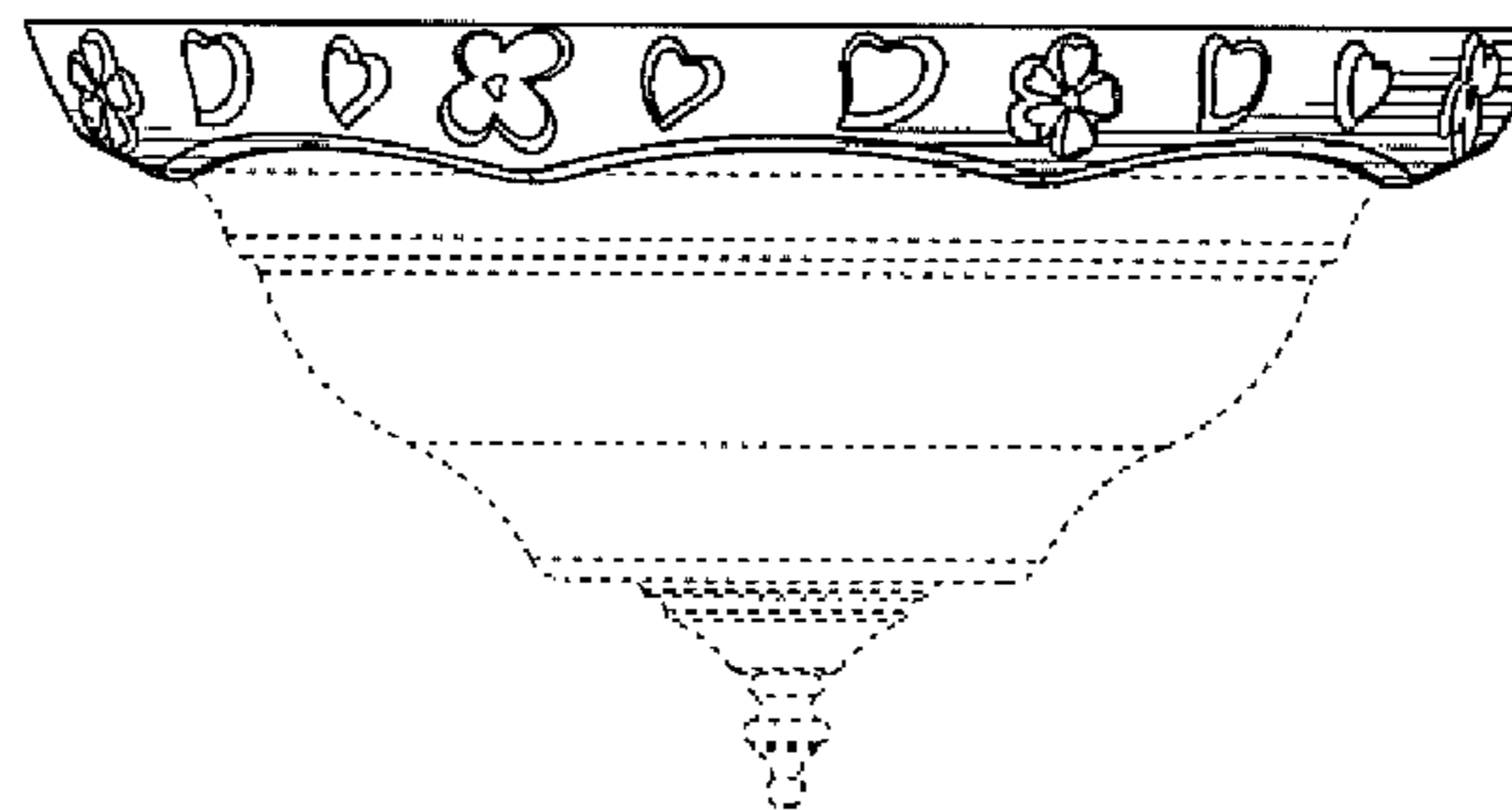
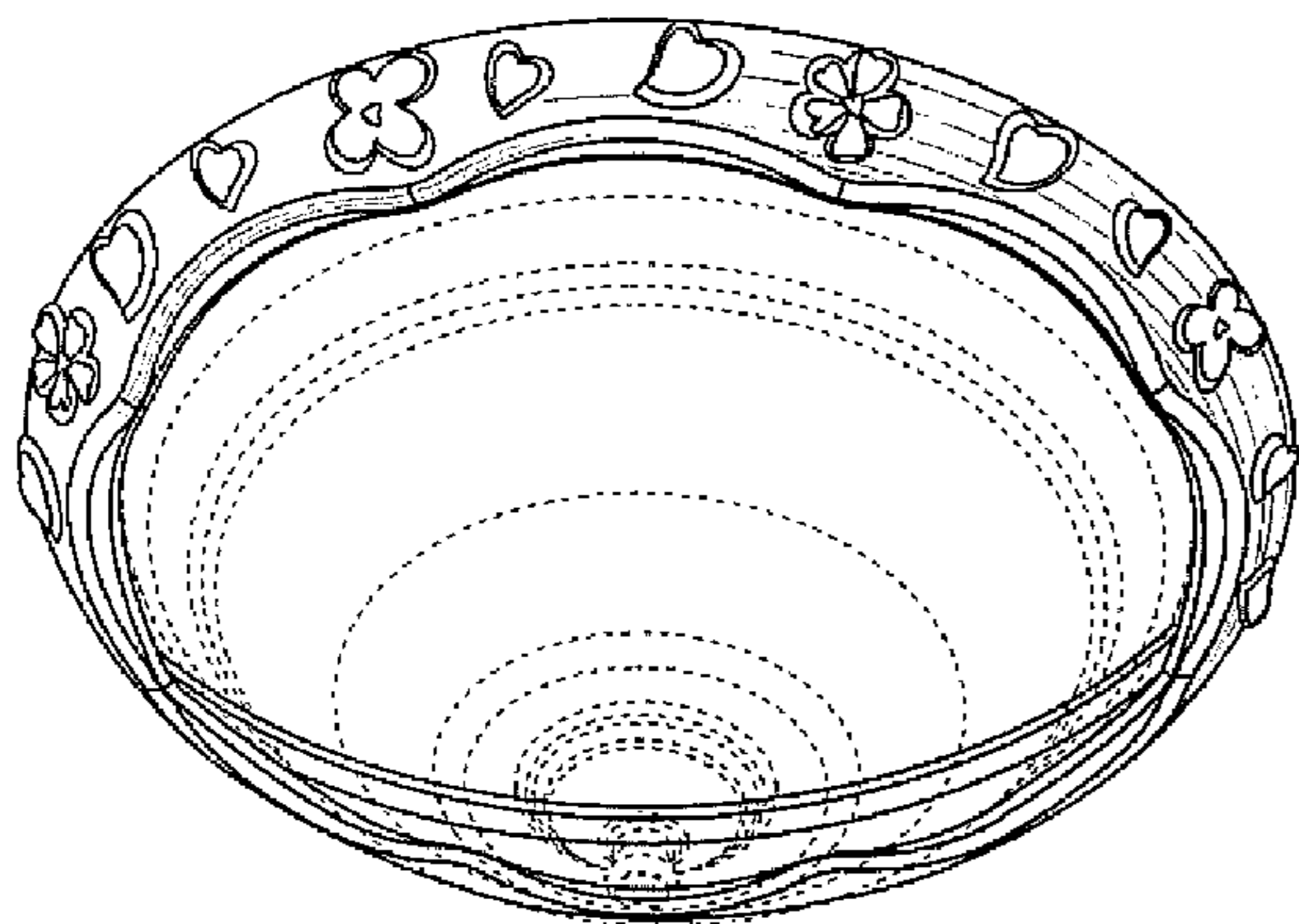
FIG. 2 is a front view thereof, the rear view, right side view and left side views being the same thereof.

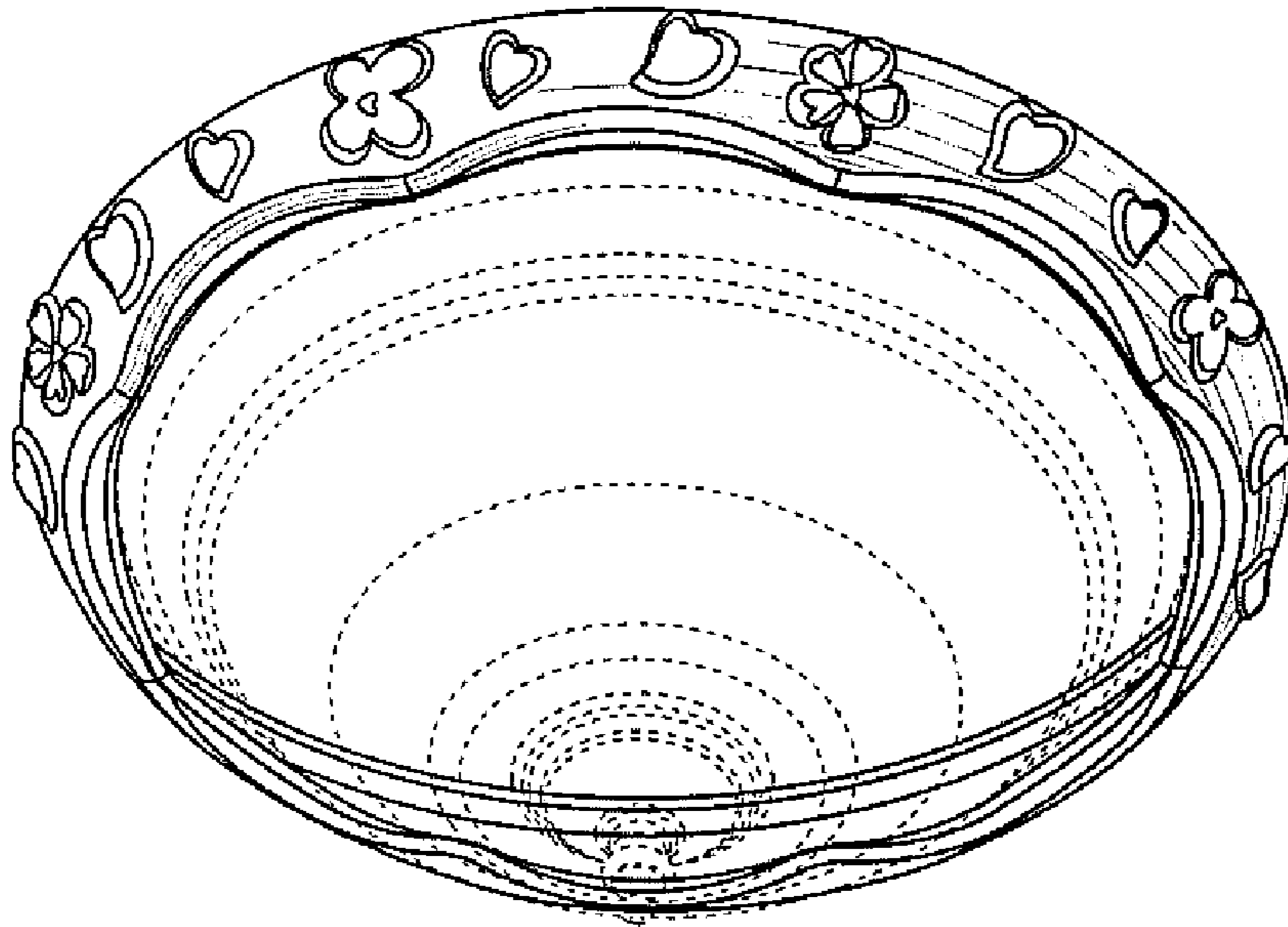

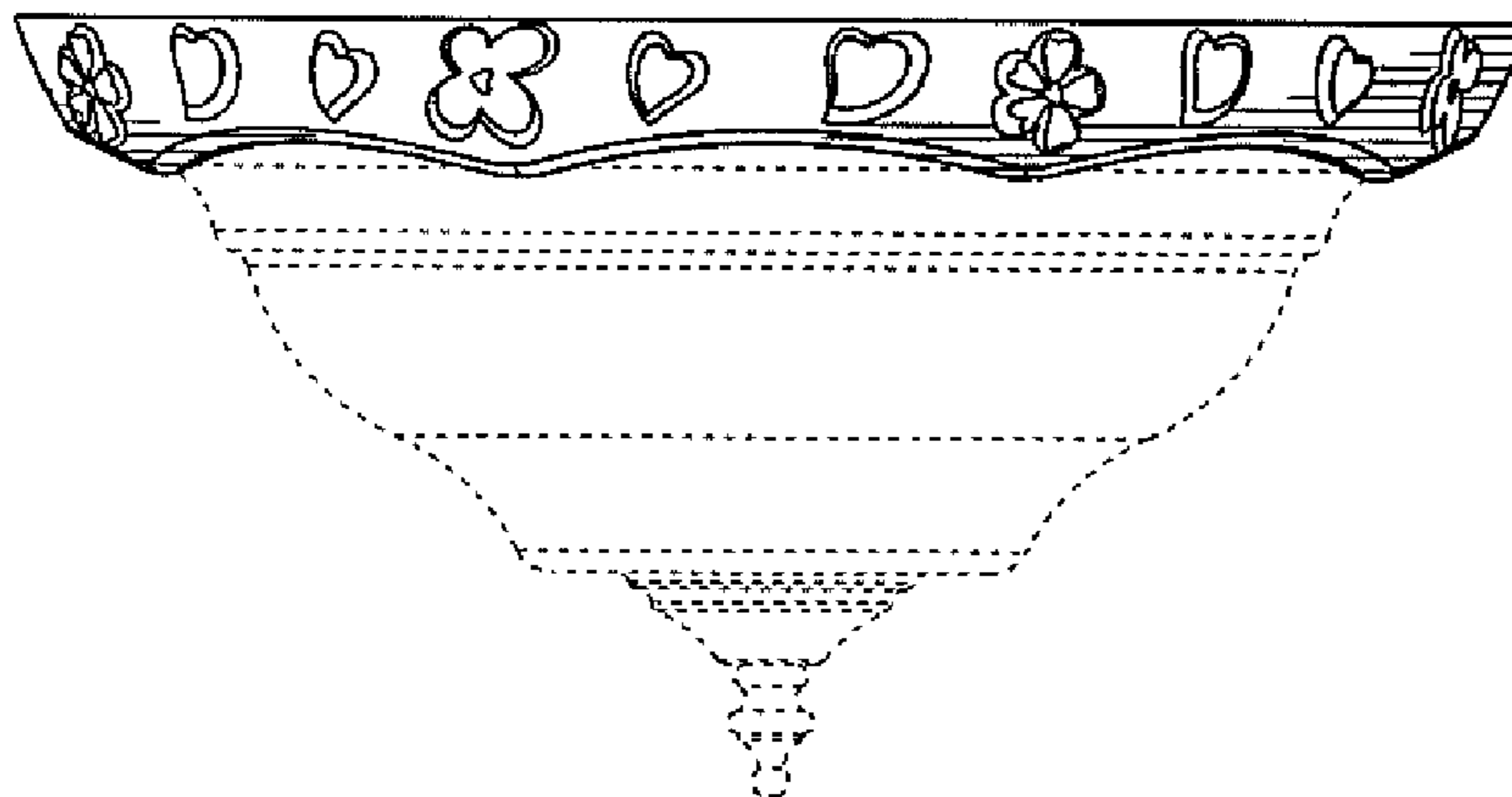

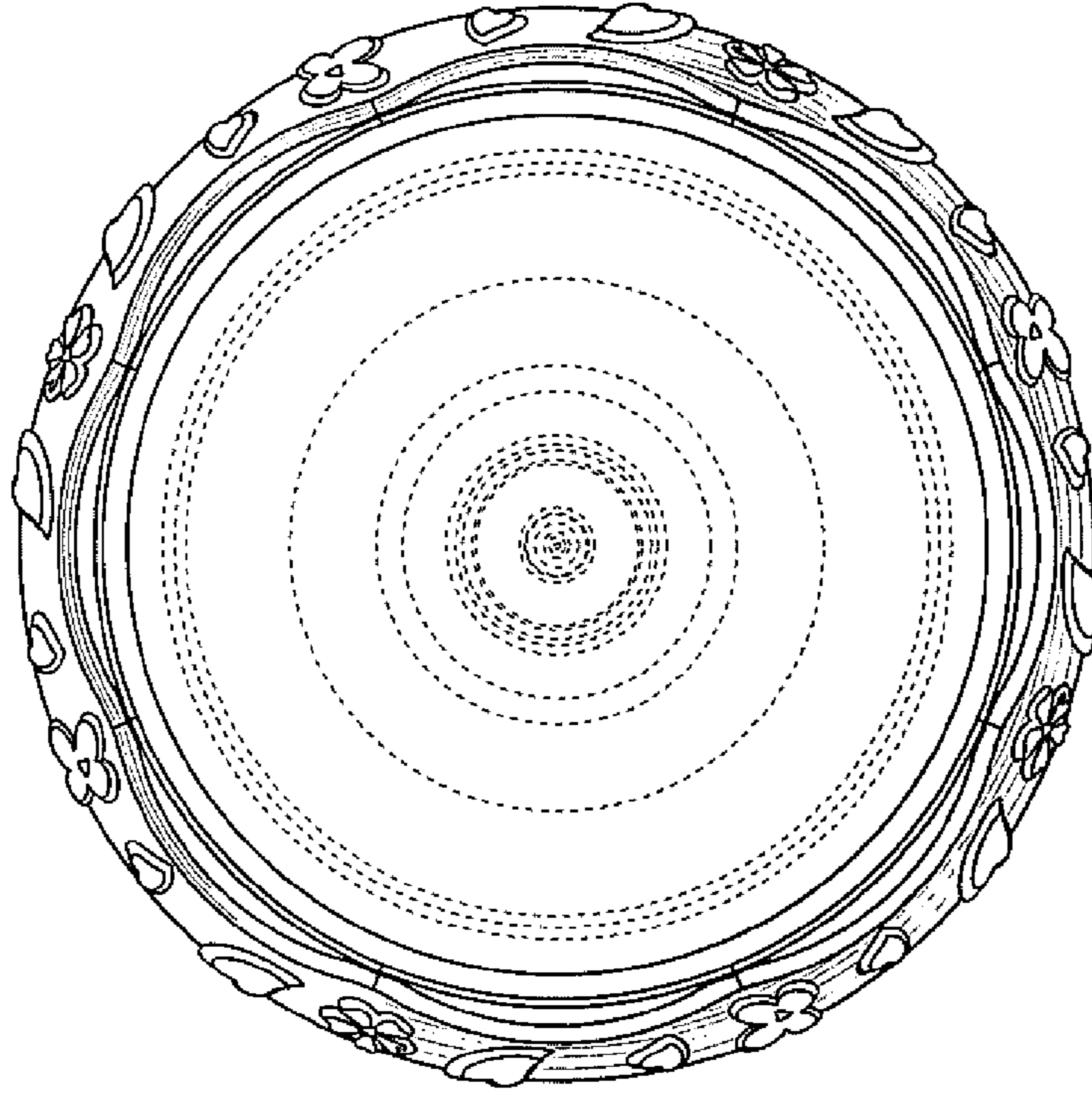
