(57) **CLAIM**

The ornamental design for a vacuum cleaner, as shown and
described.

DESCRIPTION

FIG. 1 is a perspective view of a vacuum cleaner showing
the new design;

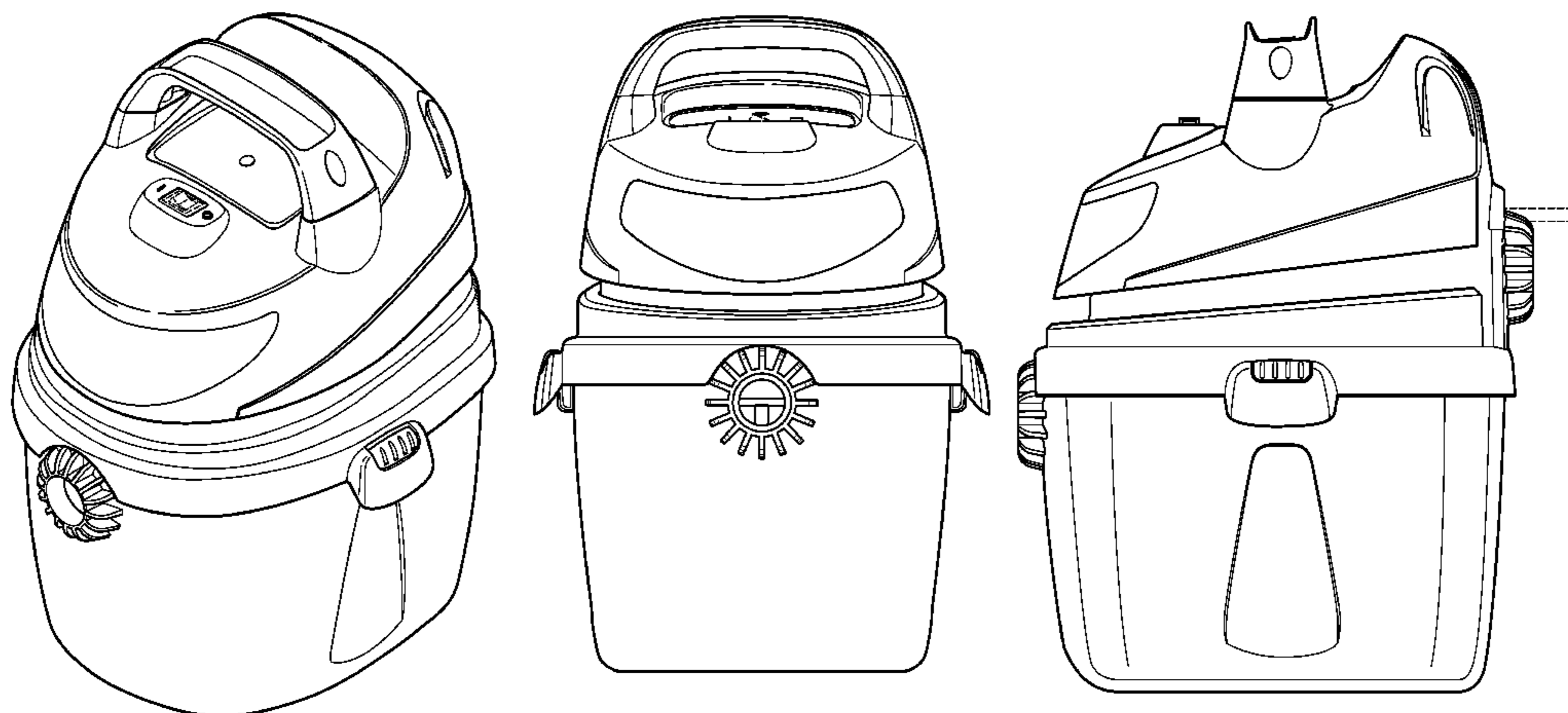

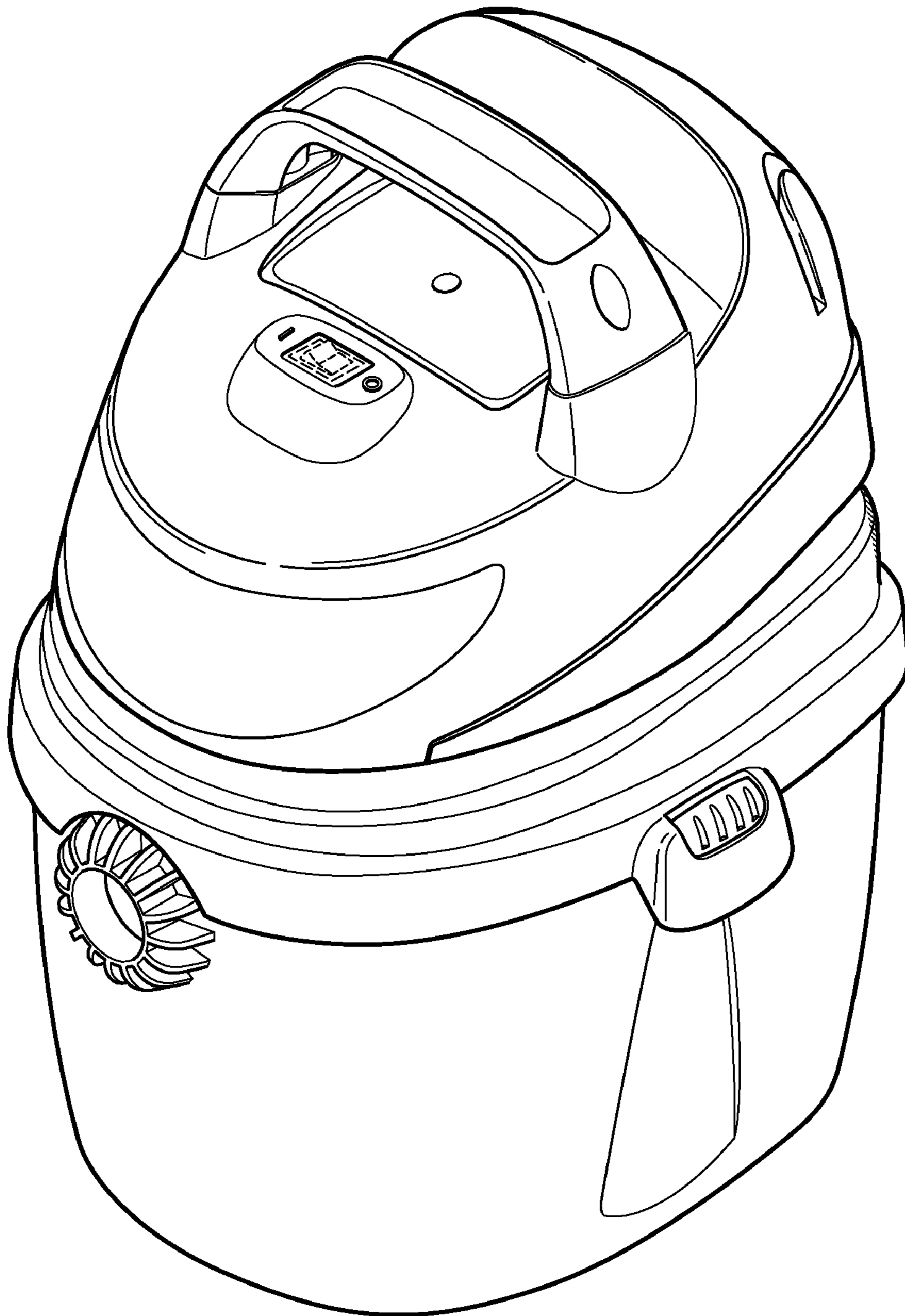

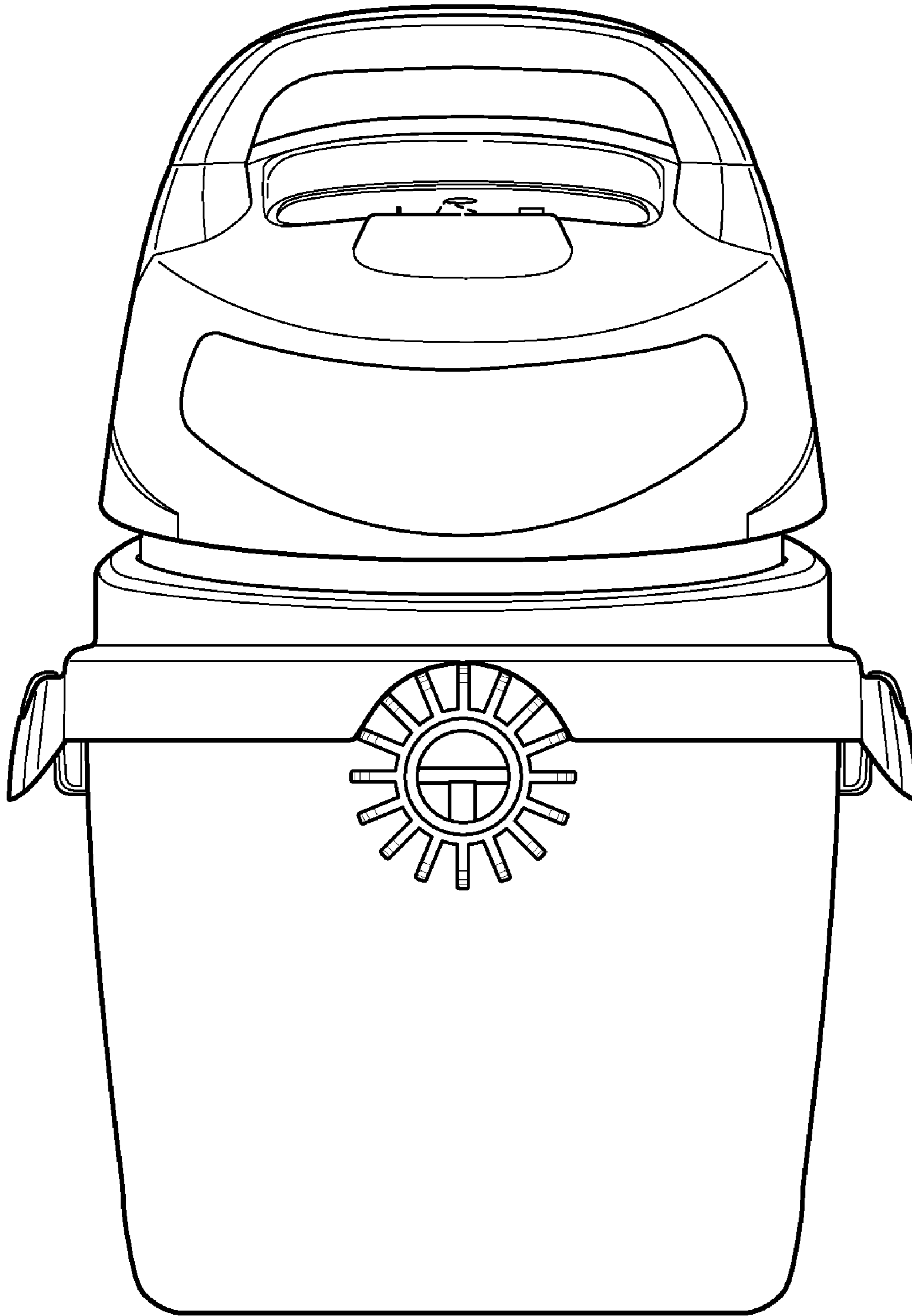

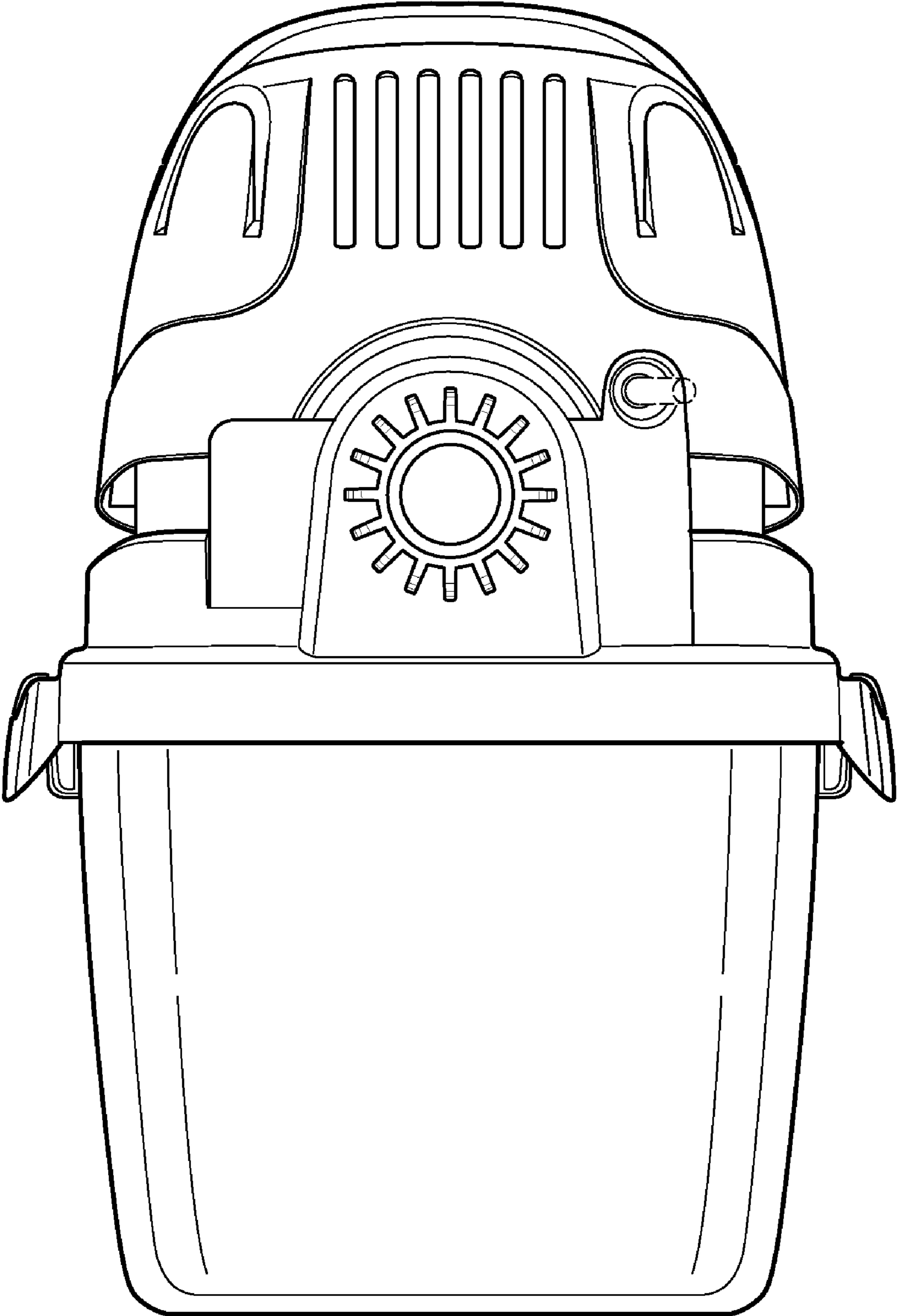

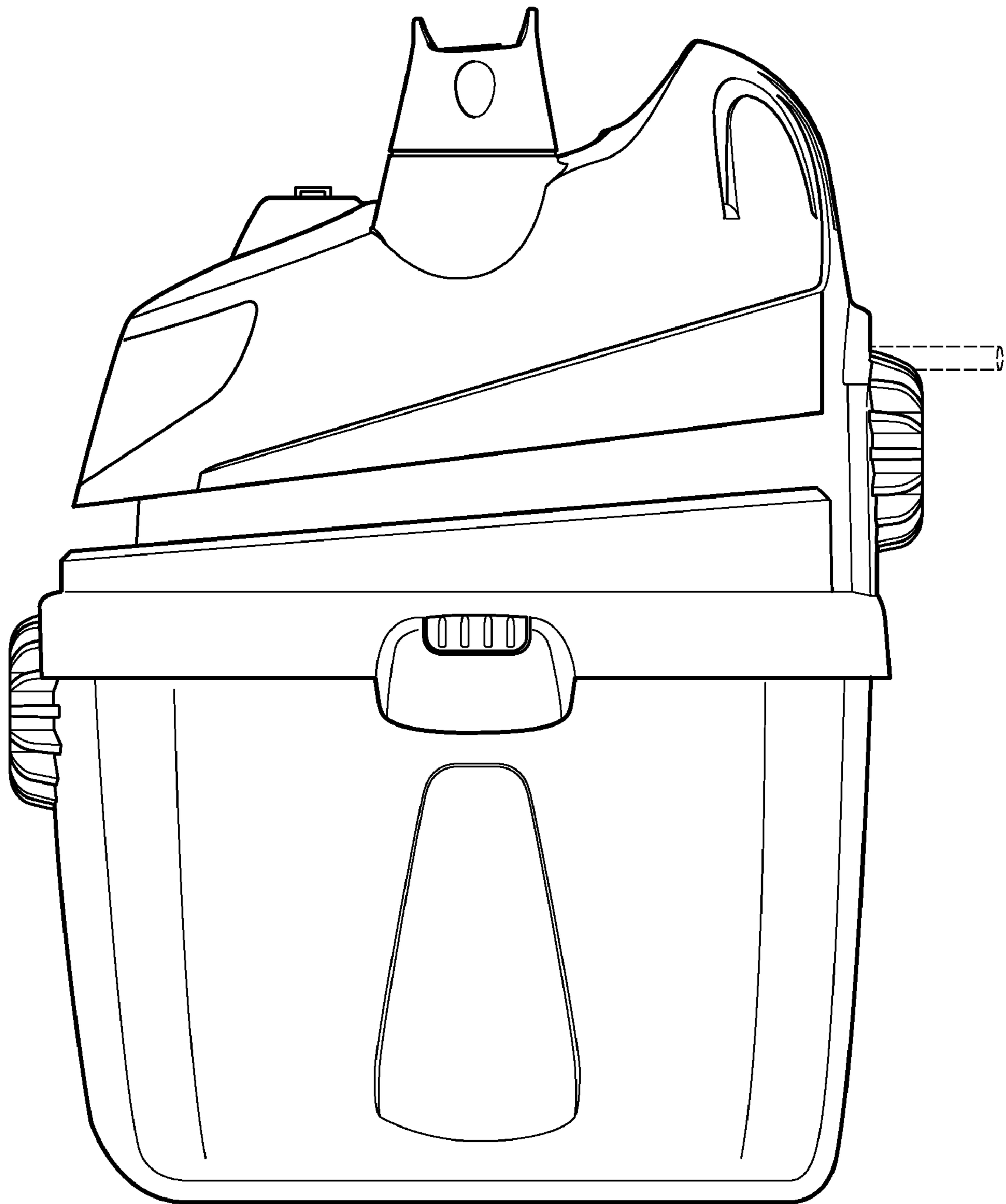

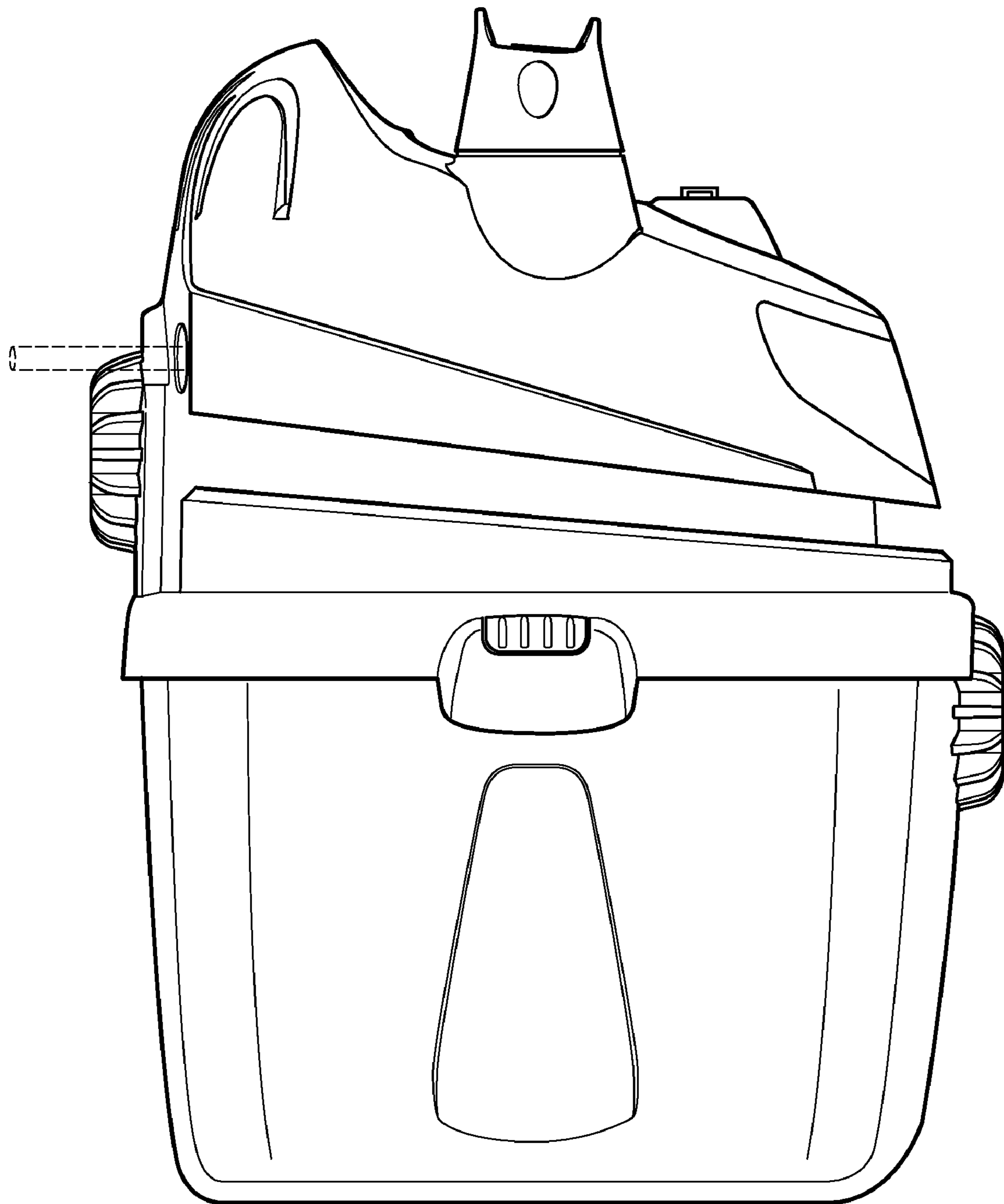
