FIG. 3 is a second side view of the bag holder;

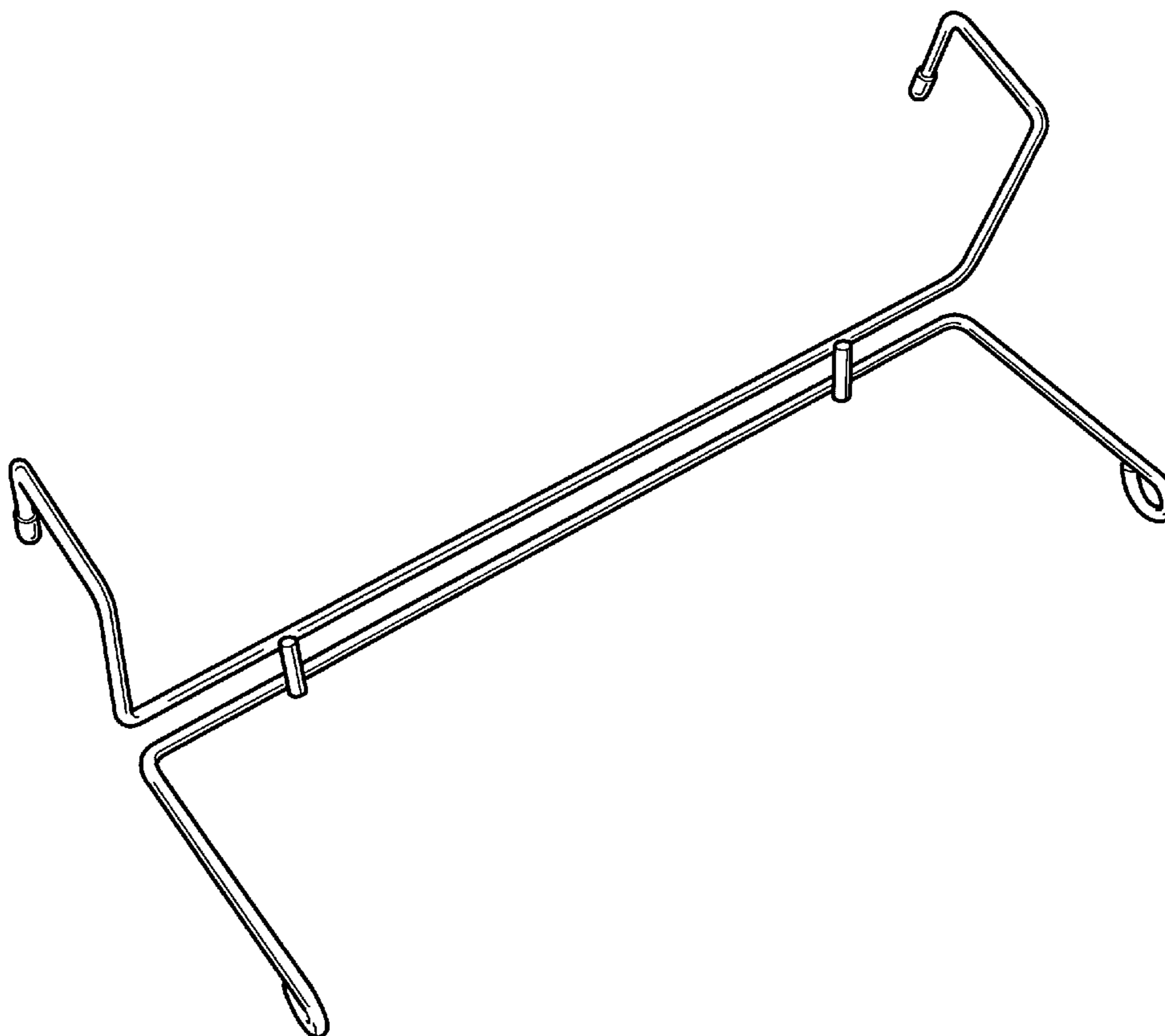
FIG. 4 is a front view of the bag holder;

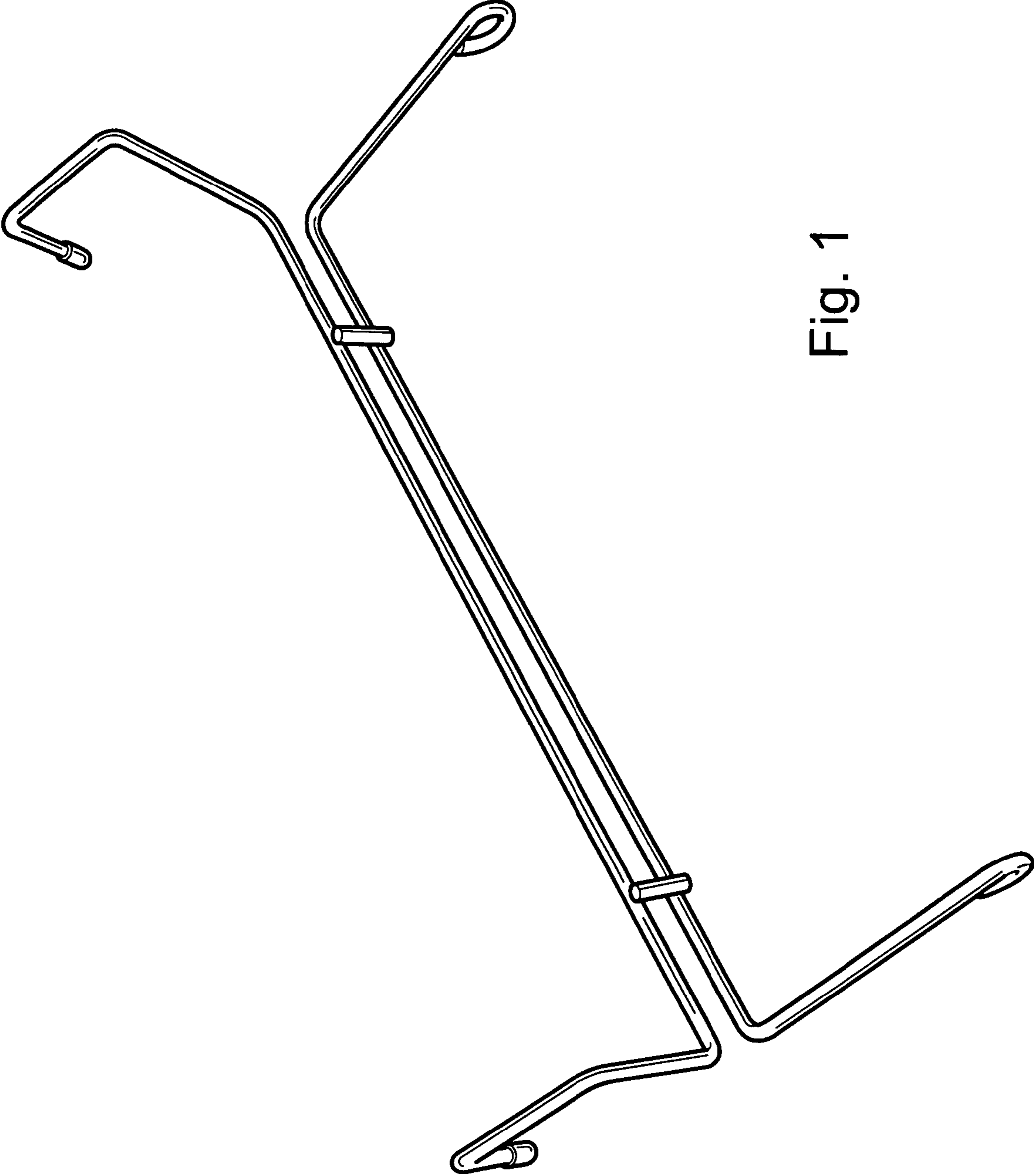

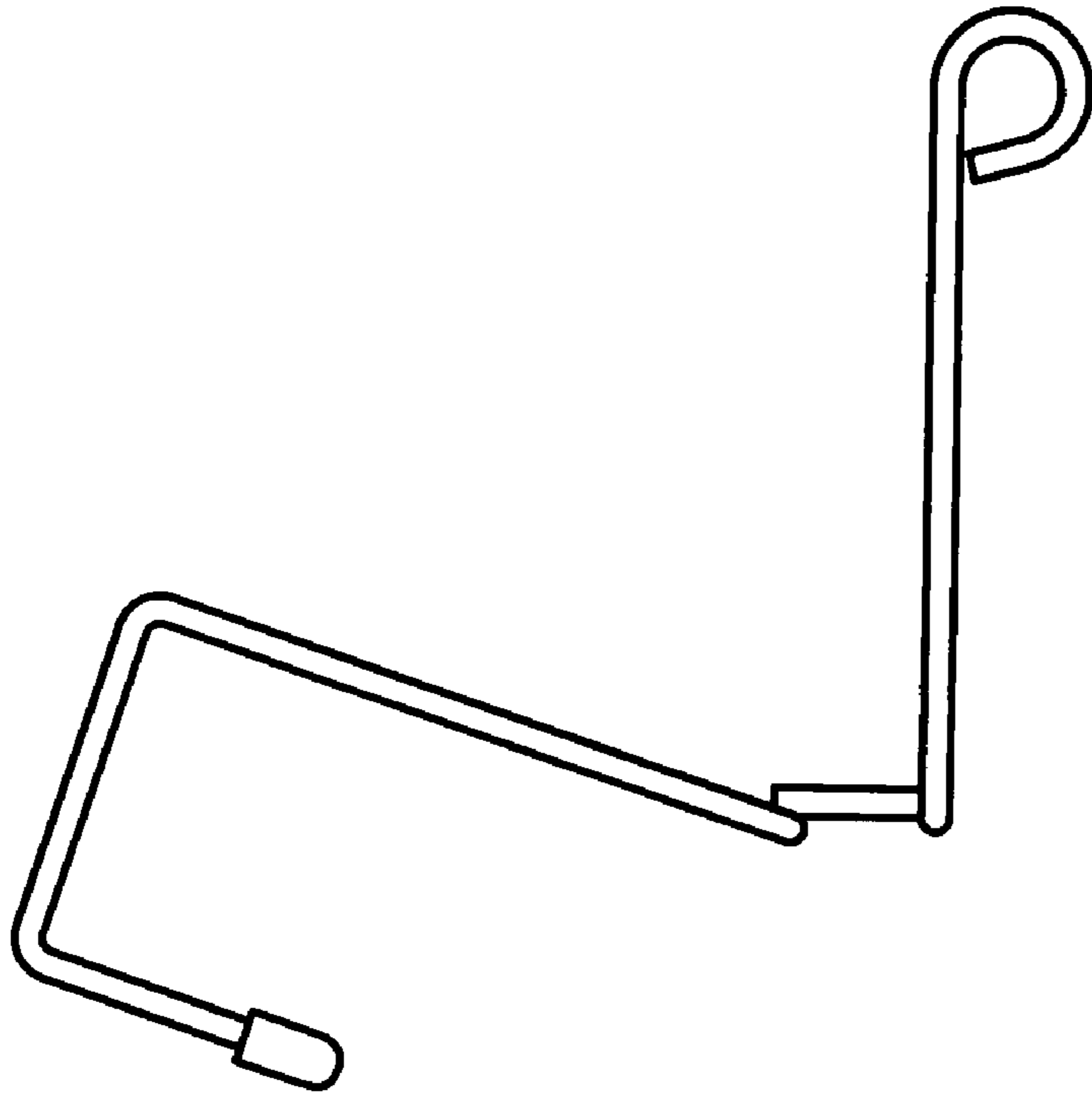

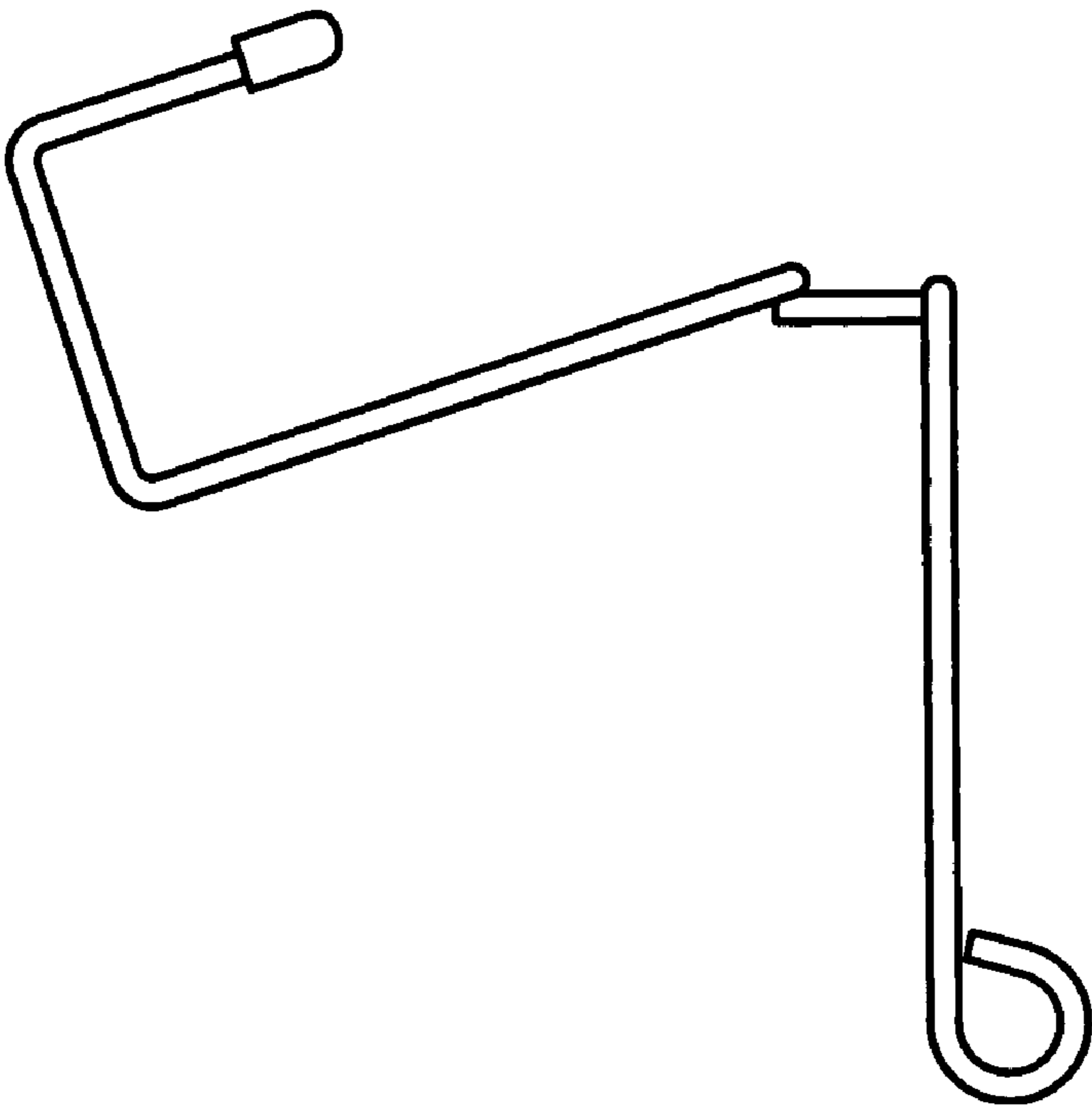

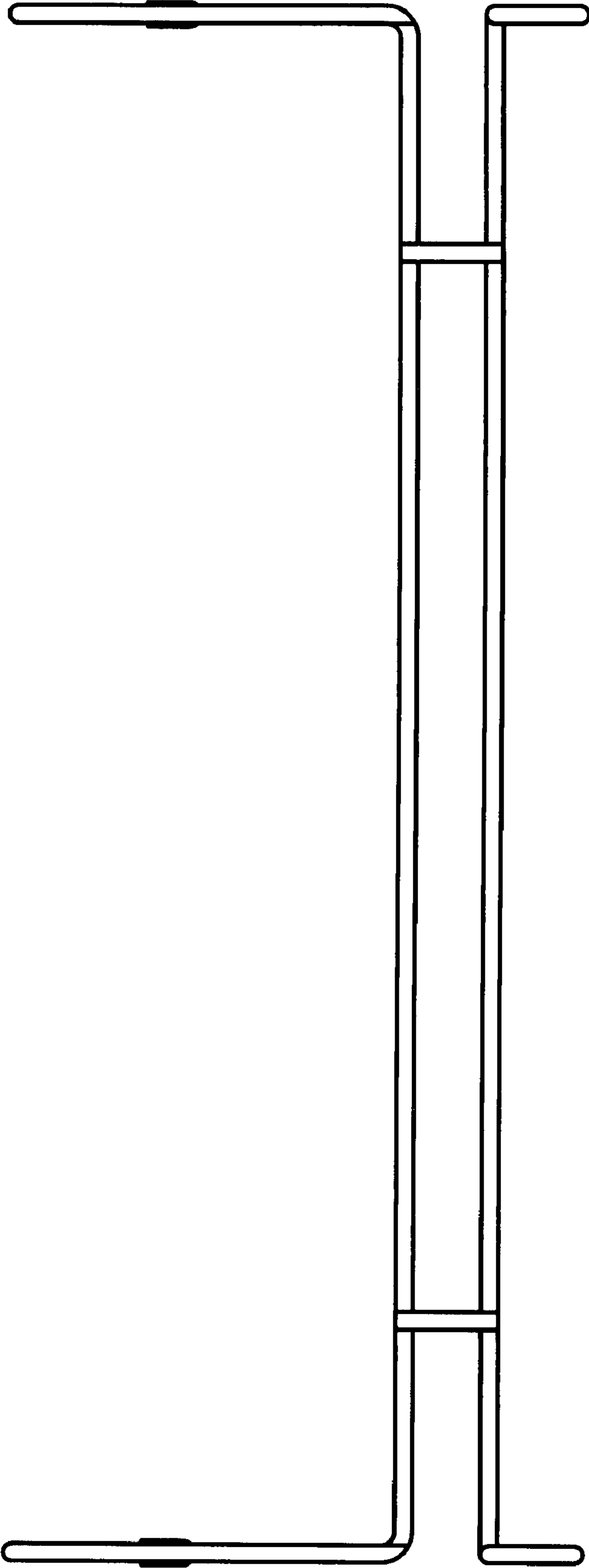

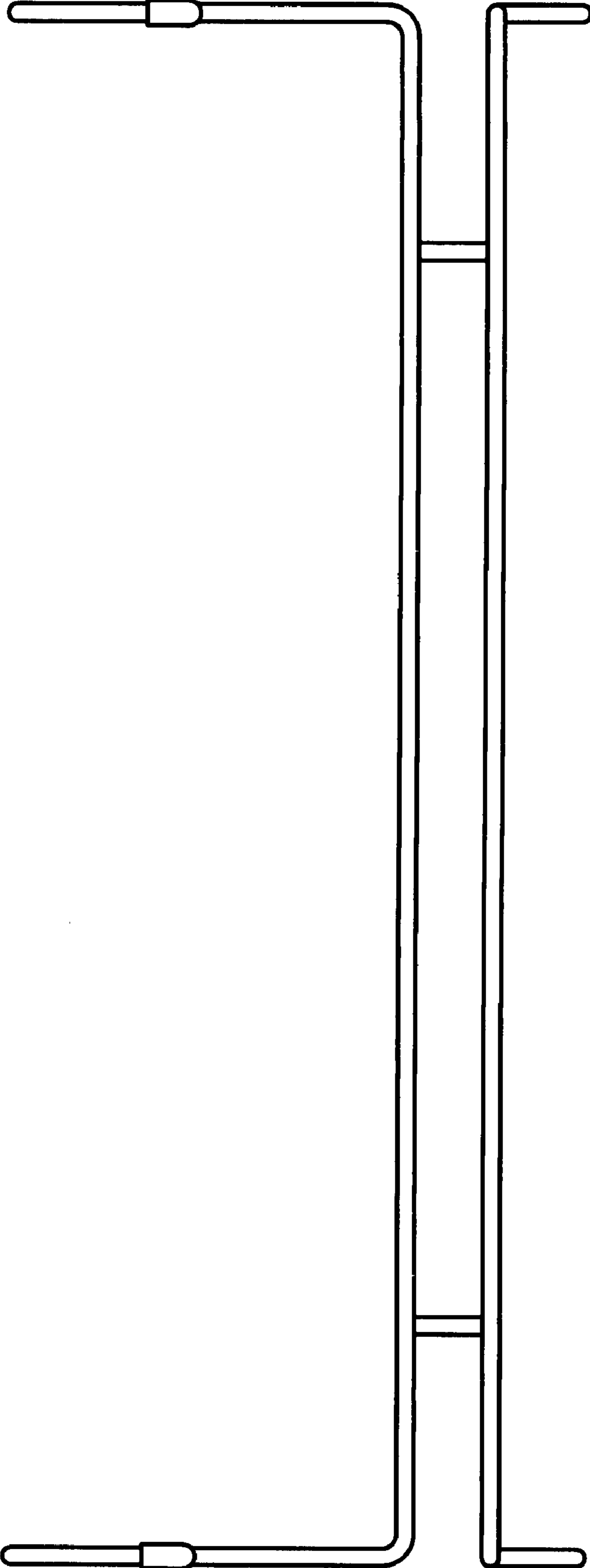

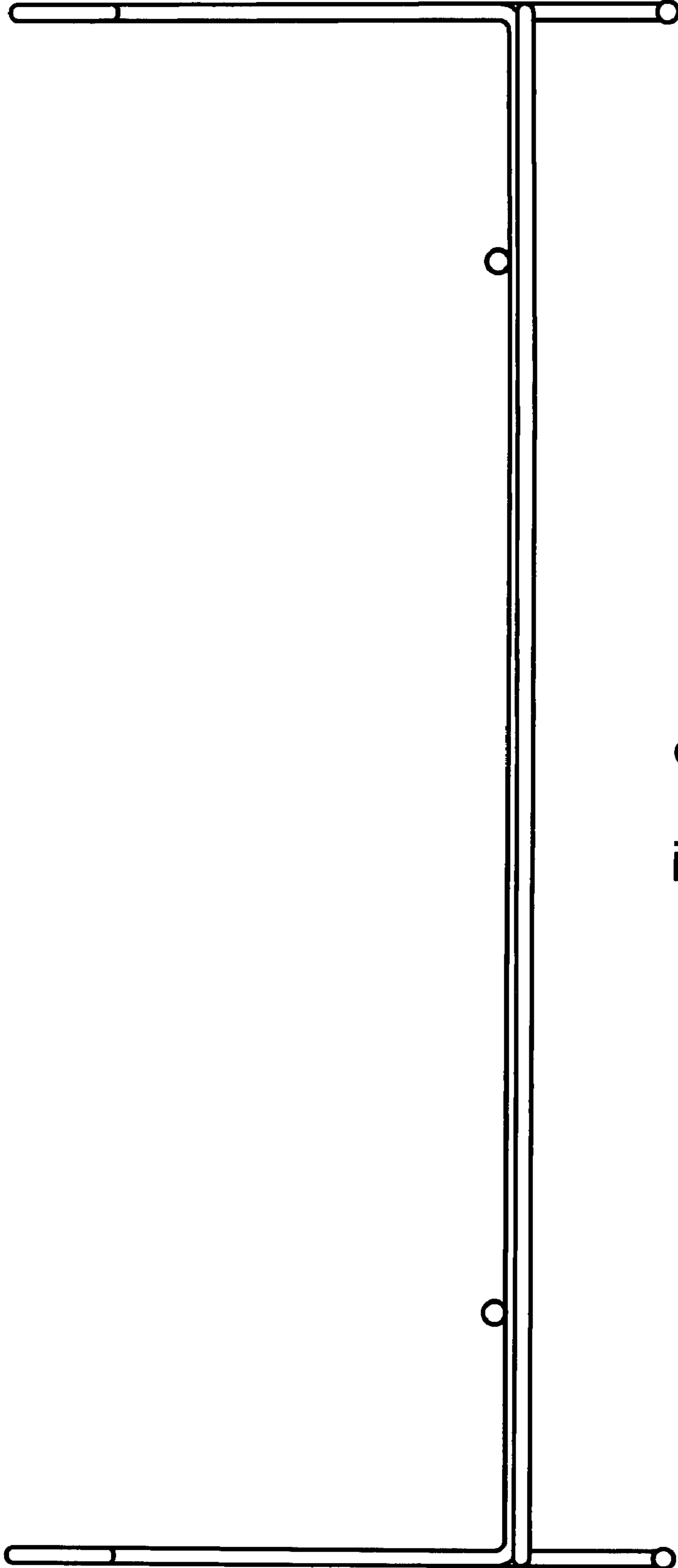

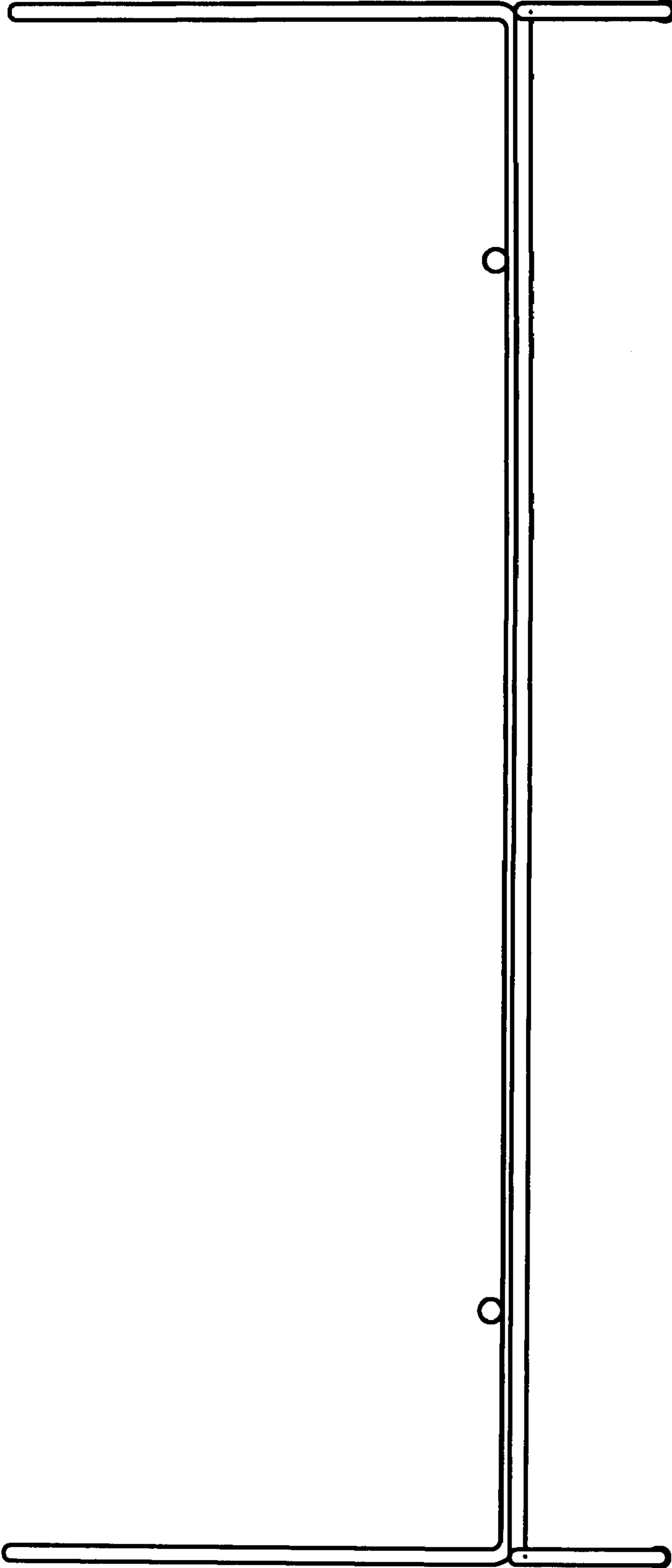
