FIG. 1 is a front elevational view of a jacket showing my new design;

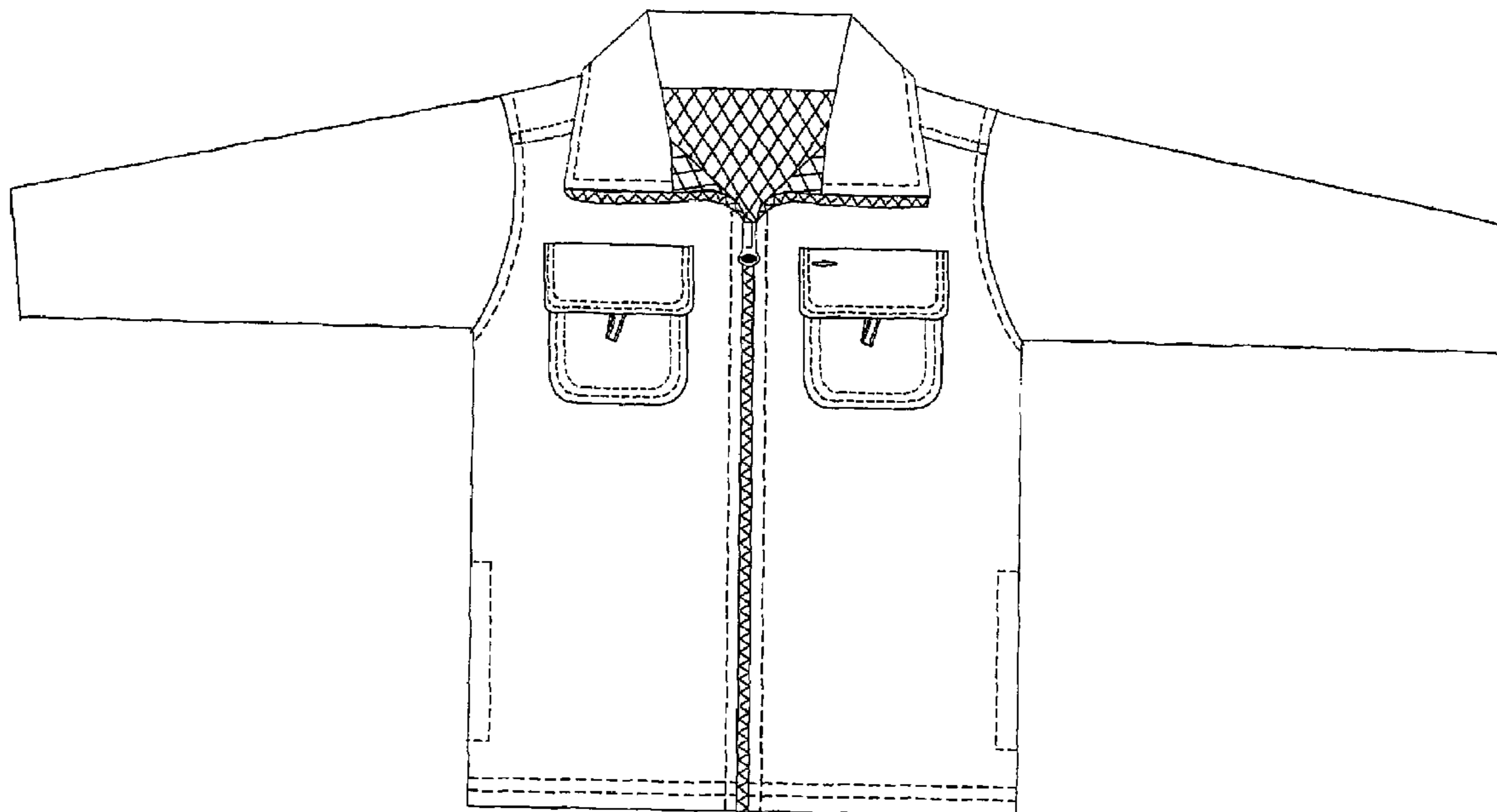
FIG. 2 is a left side elevational view thereof;

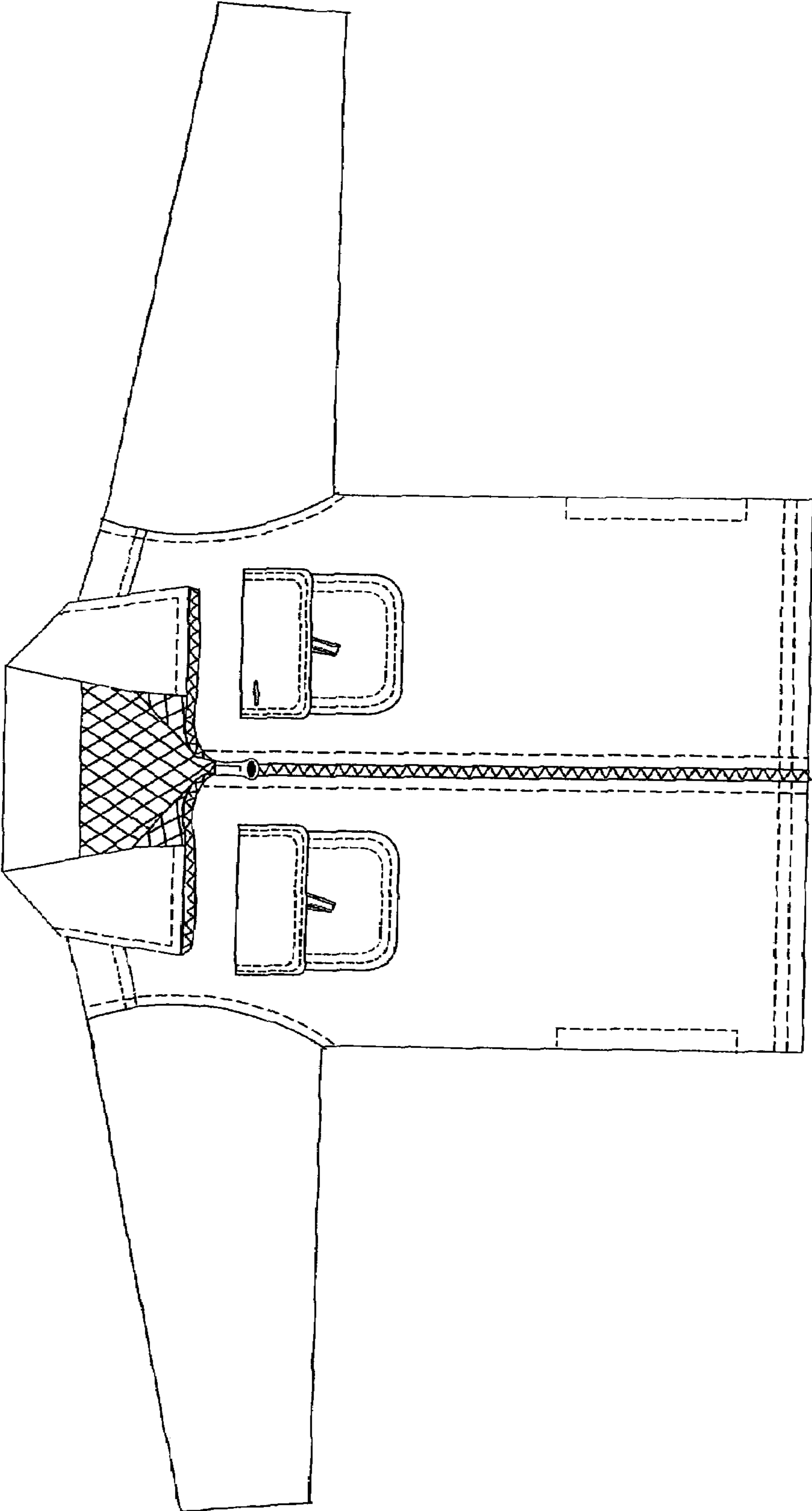

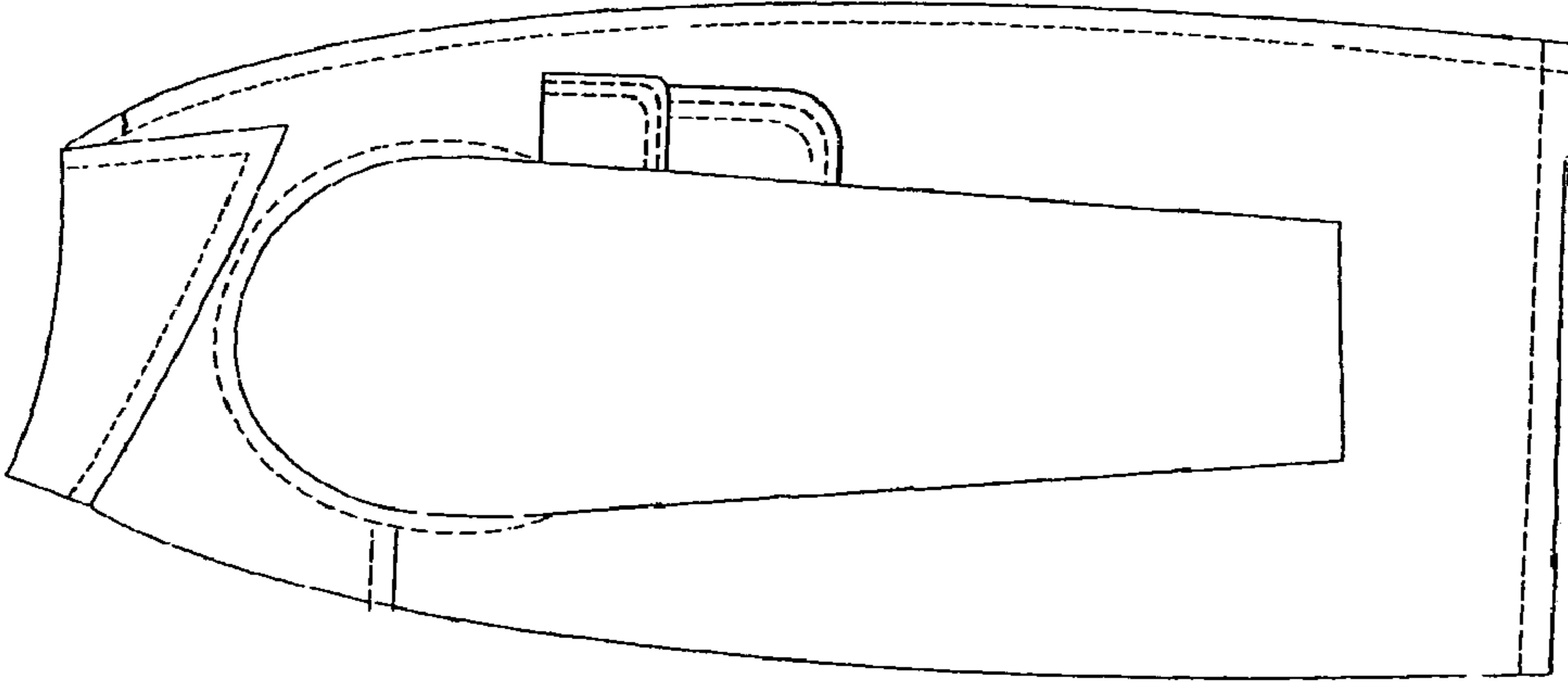

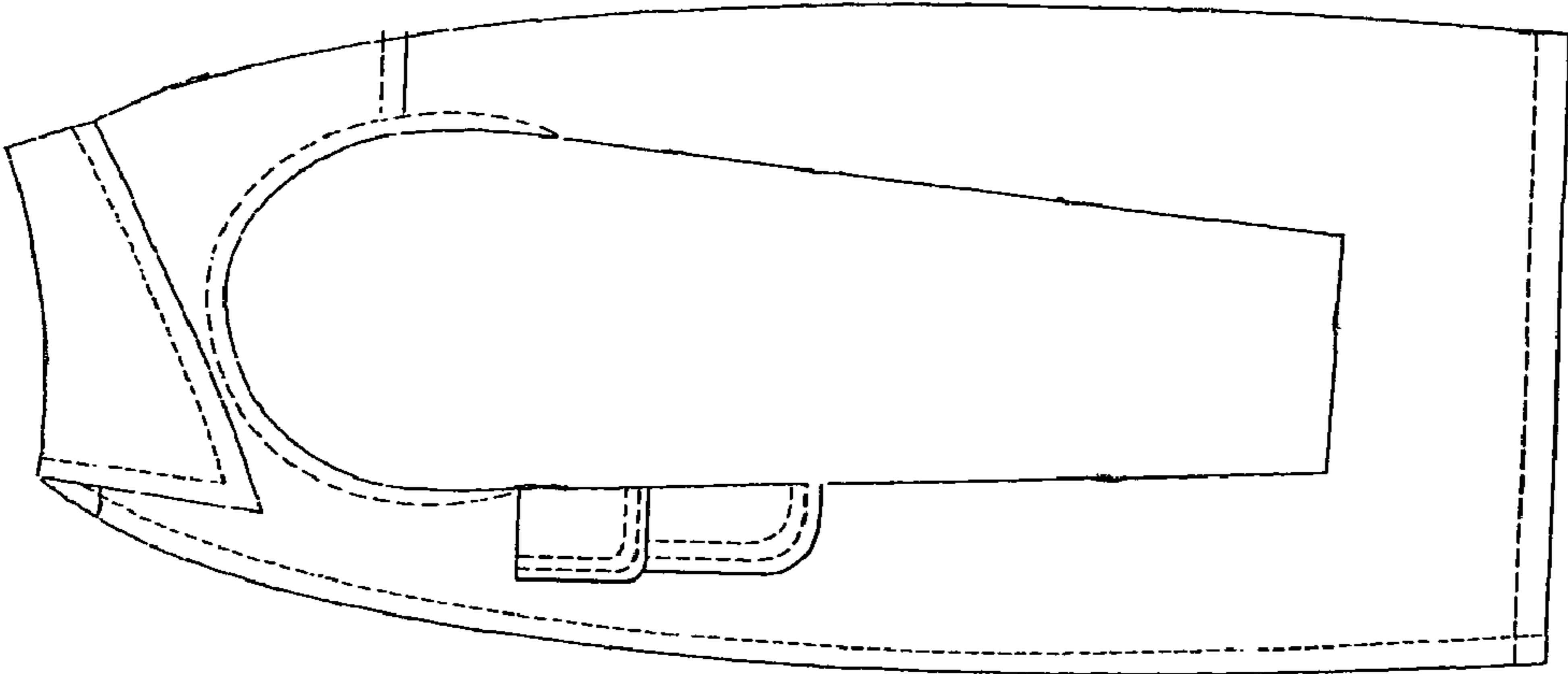

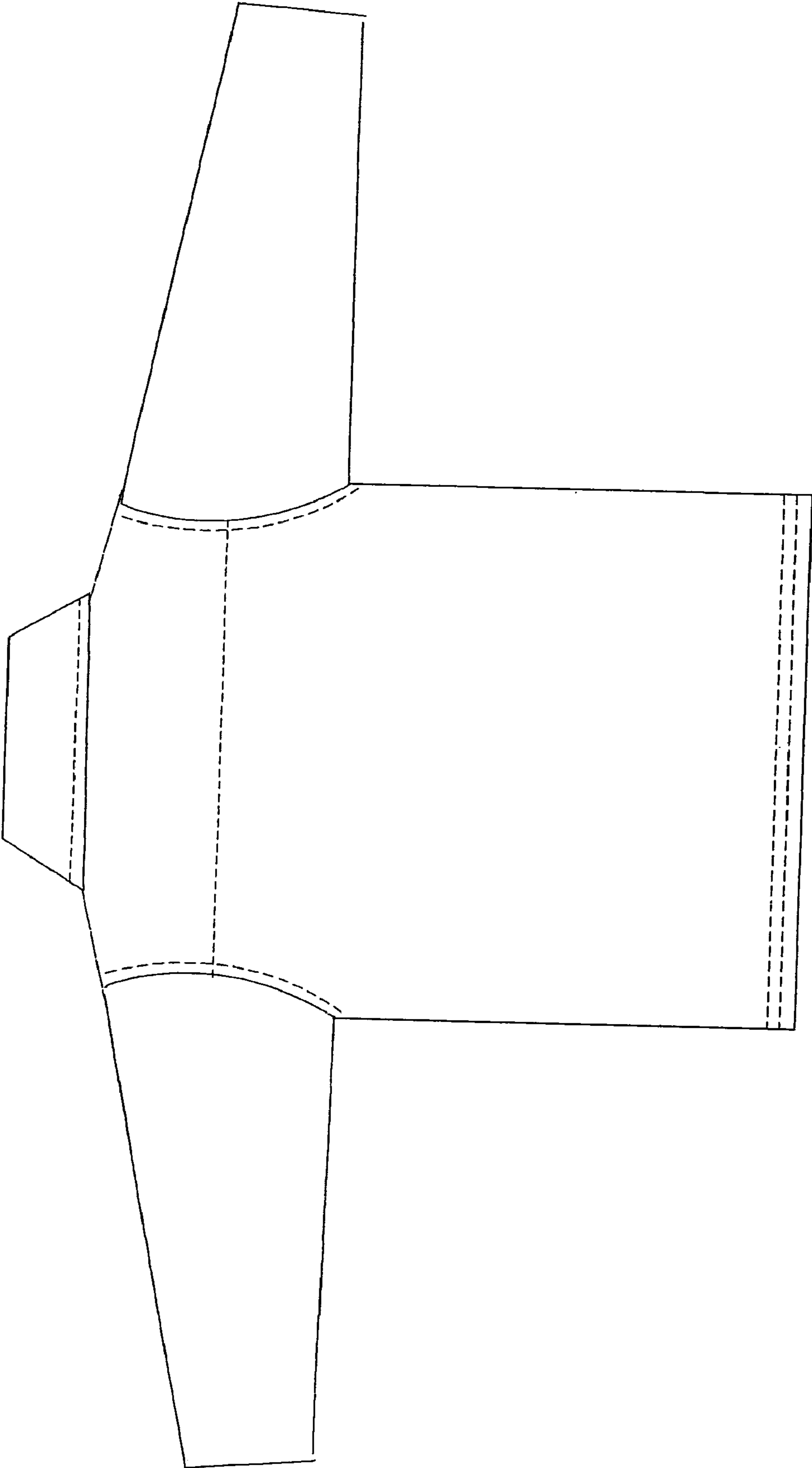
