FIG. 7 is a top view of the vegetable serving spoon of the present invention showing my new design; and,

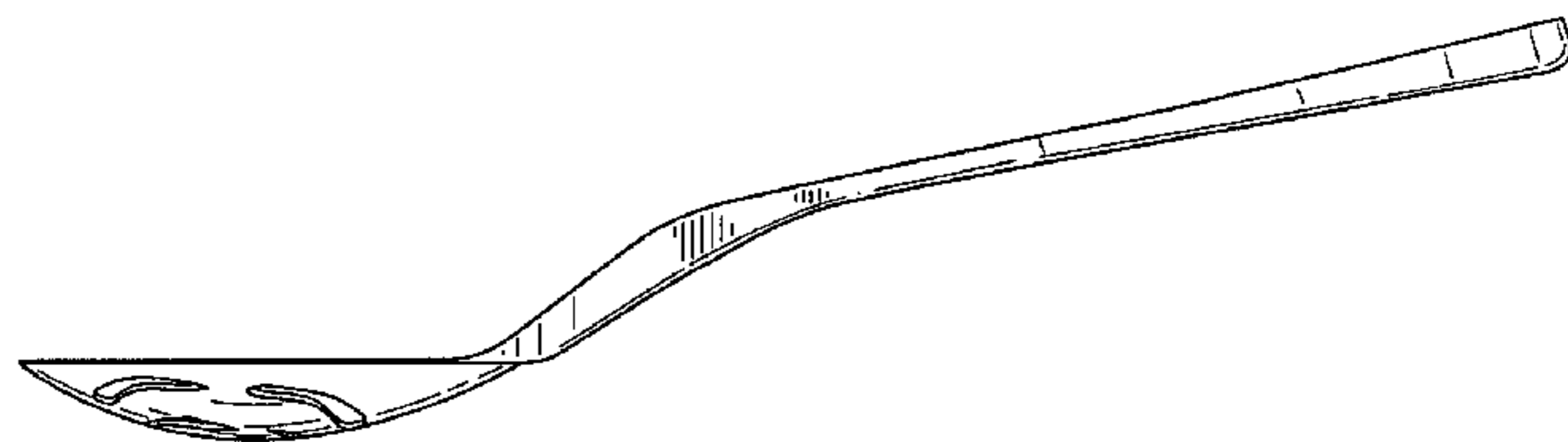
FIG. 8 is a bottom view of the vegetable serving spoon of the present invention showing my new design.

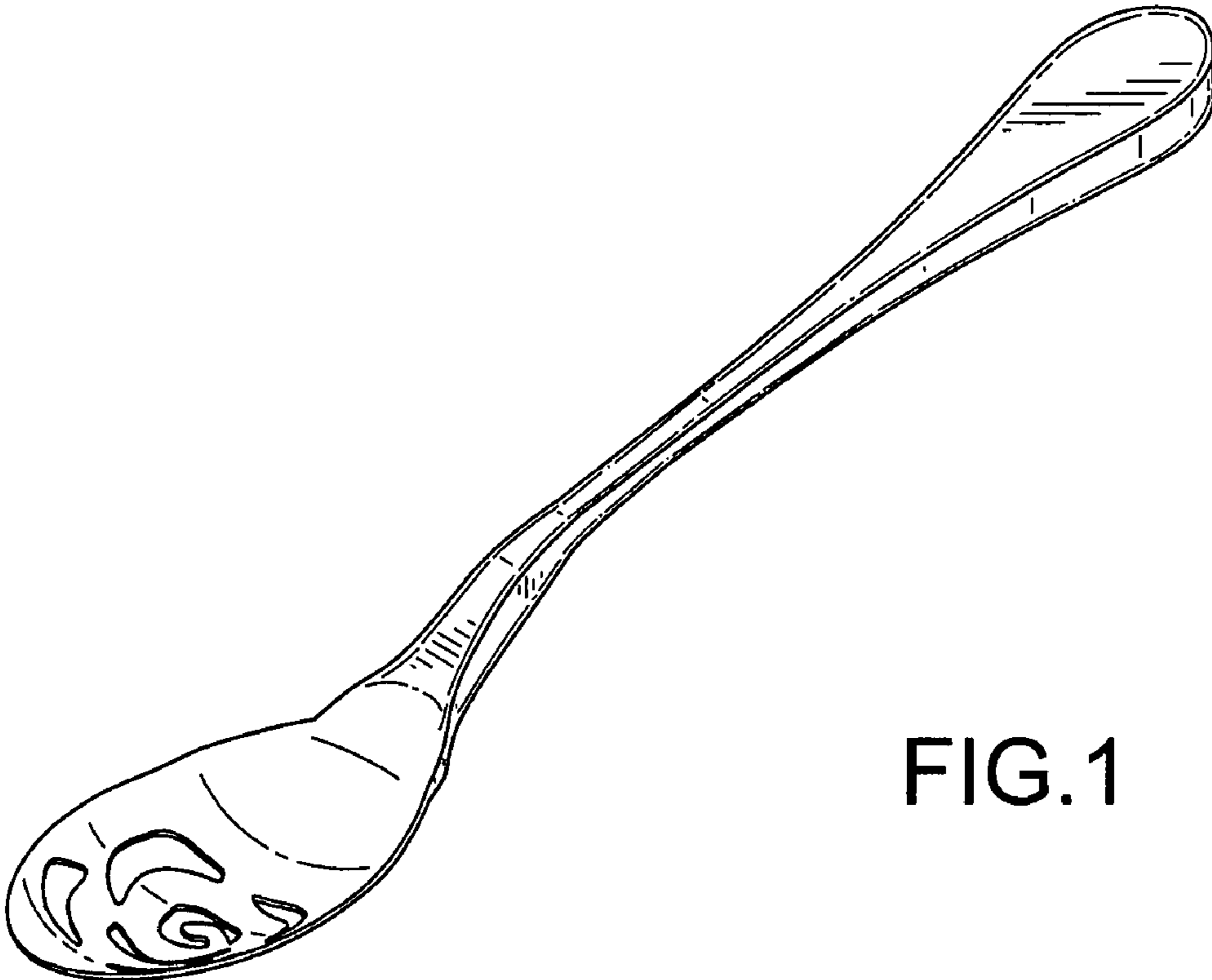

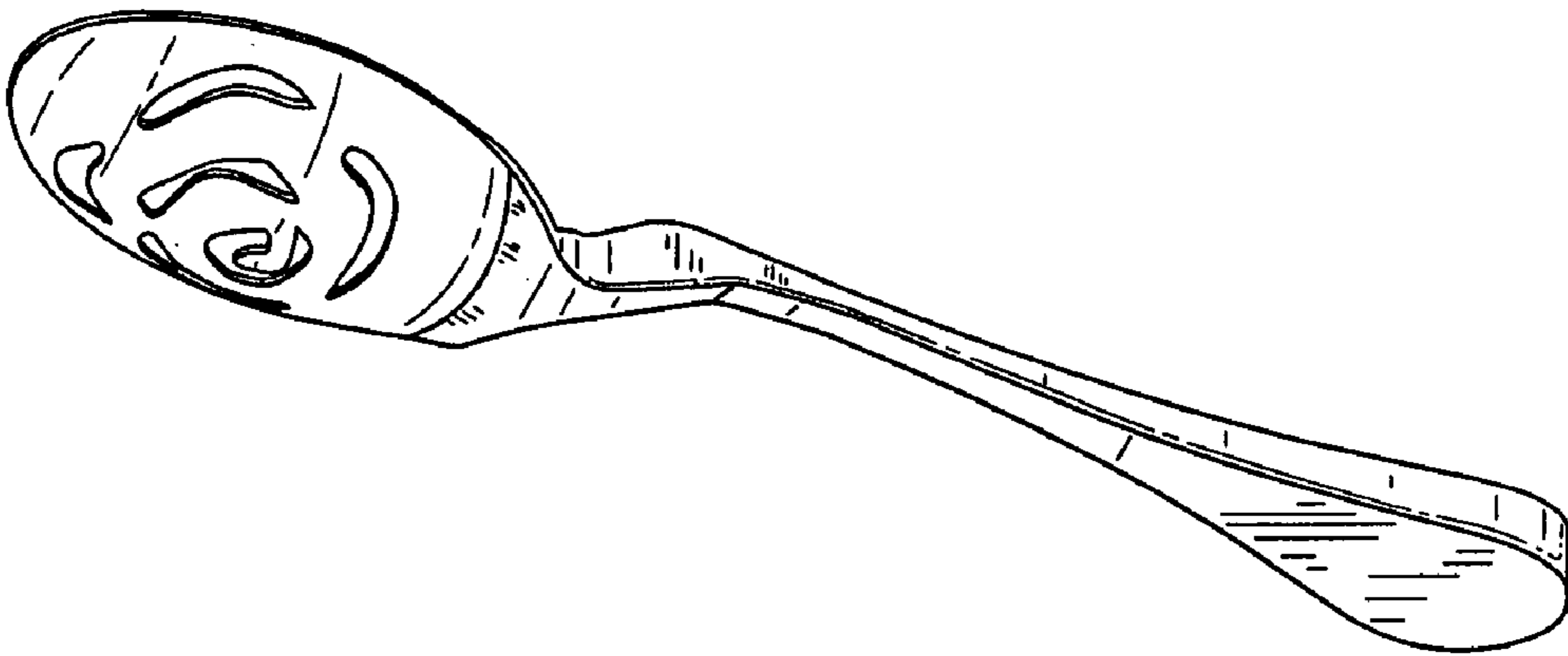

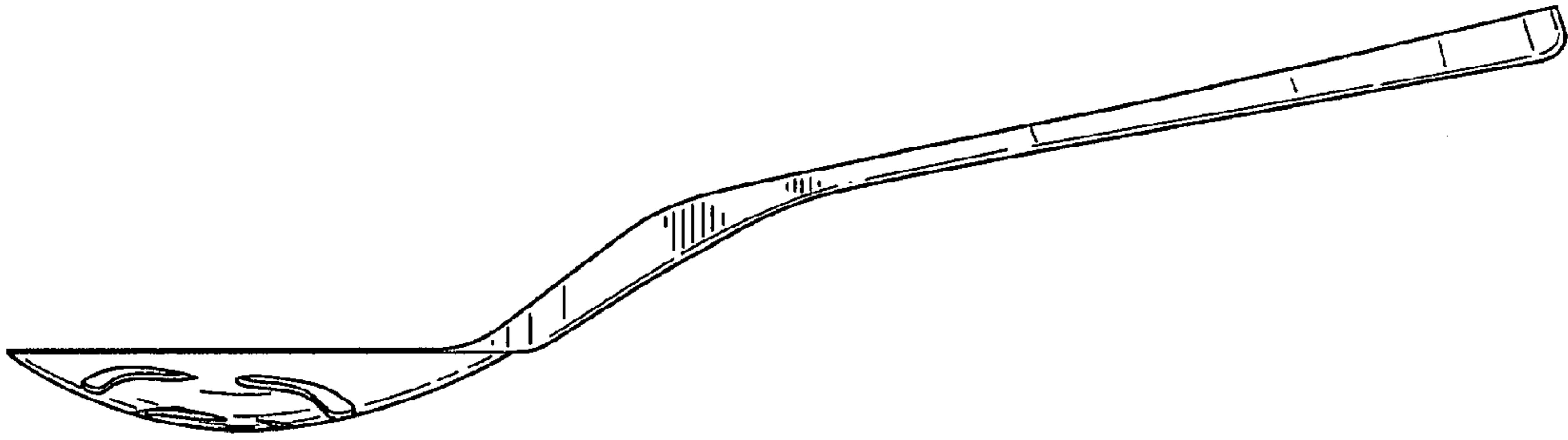

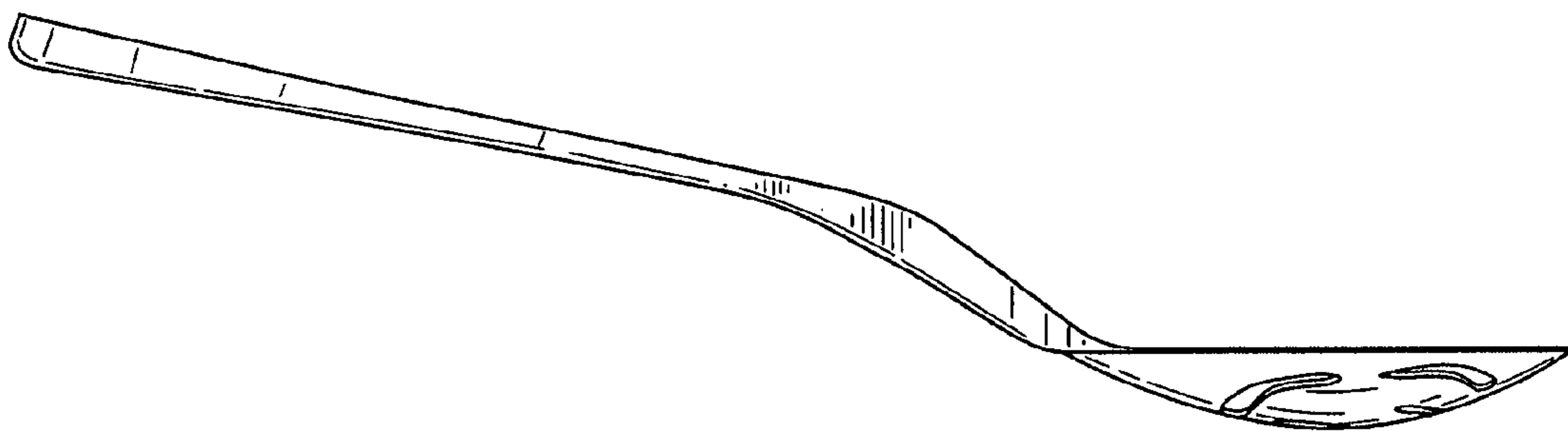

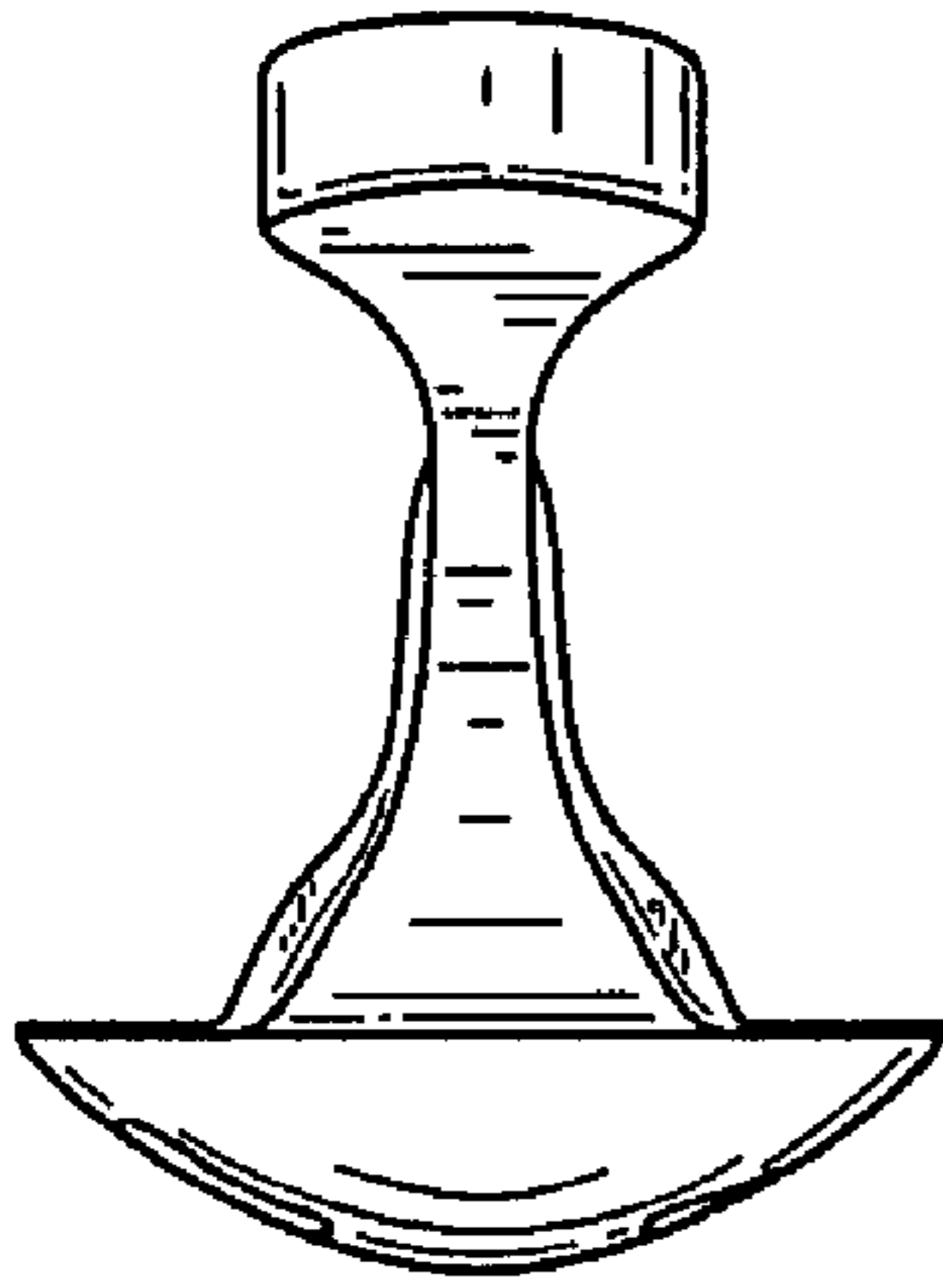

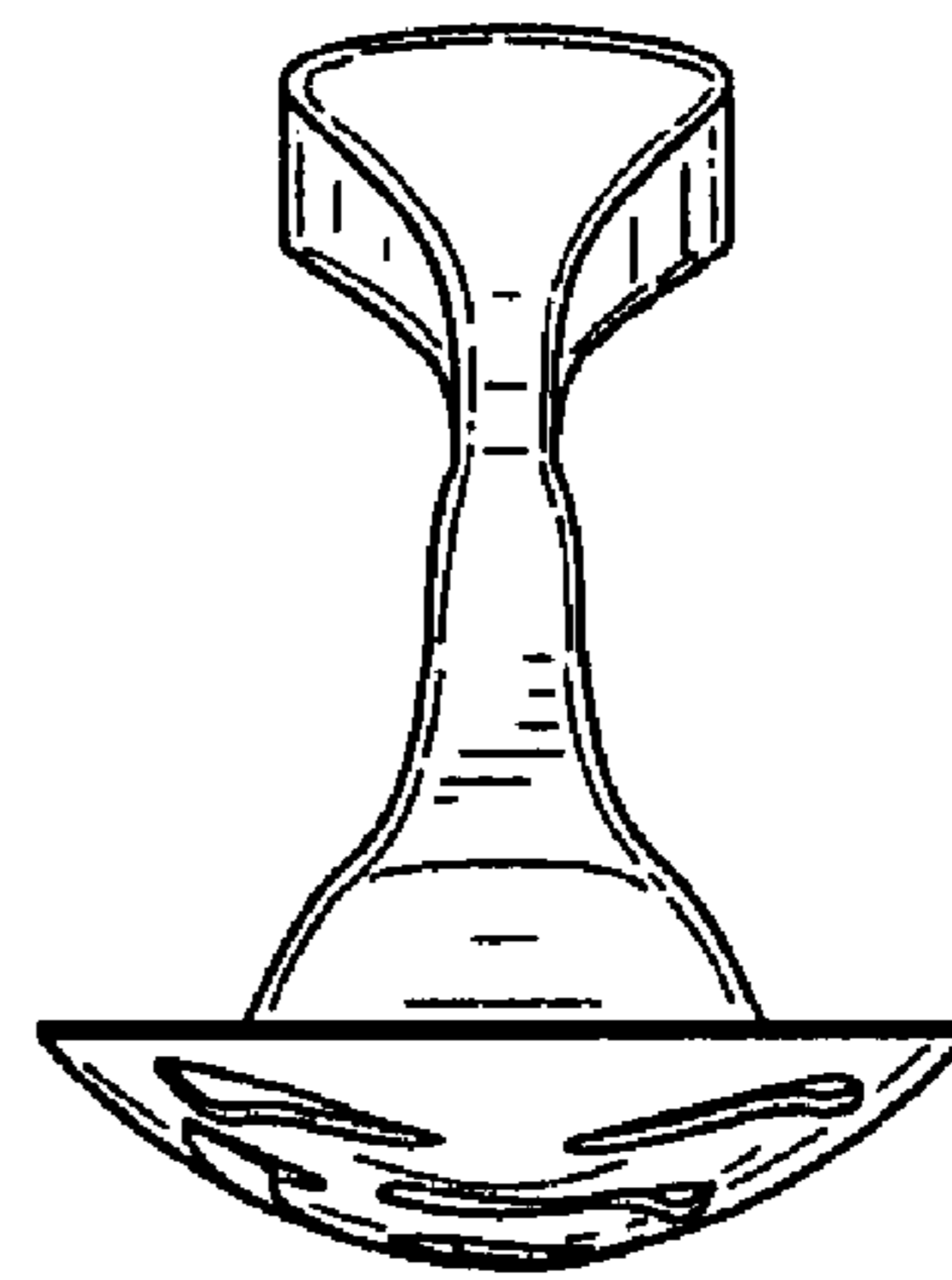

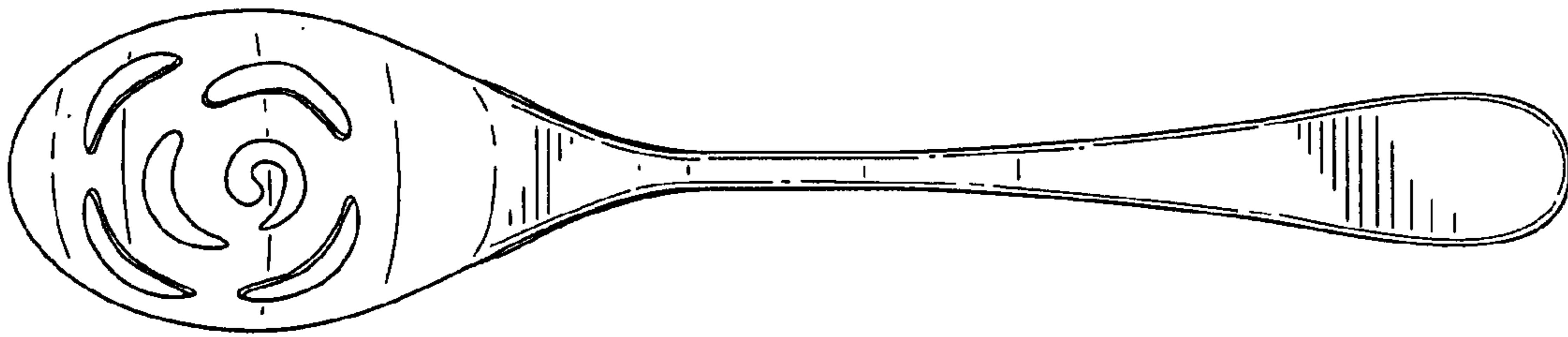

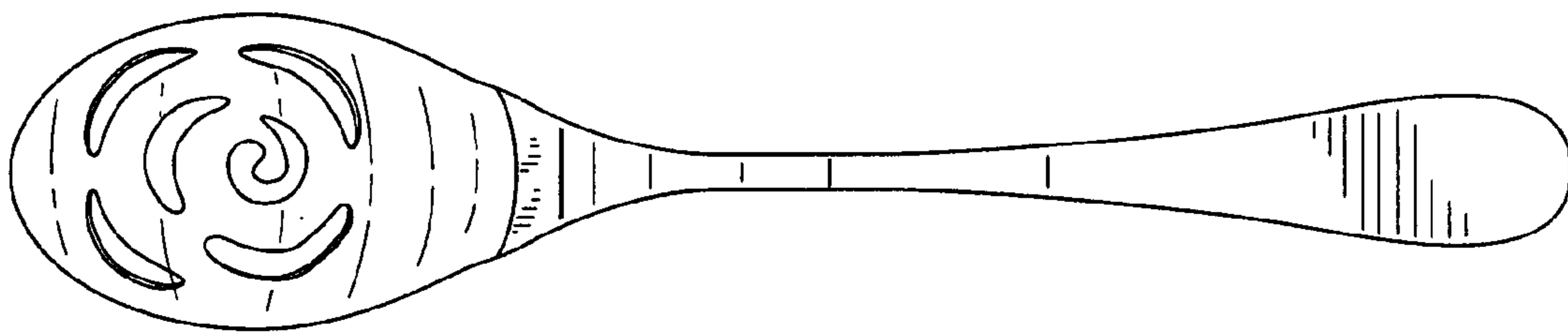
