**DESCRIPTION**

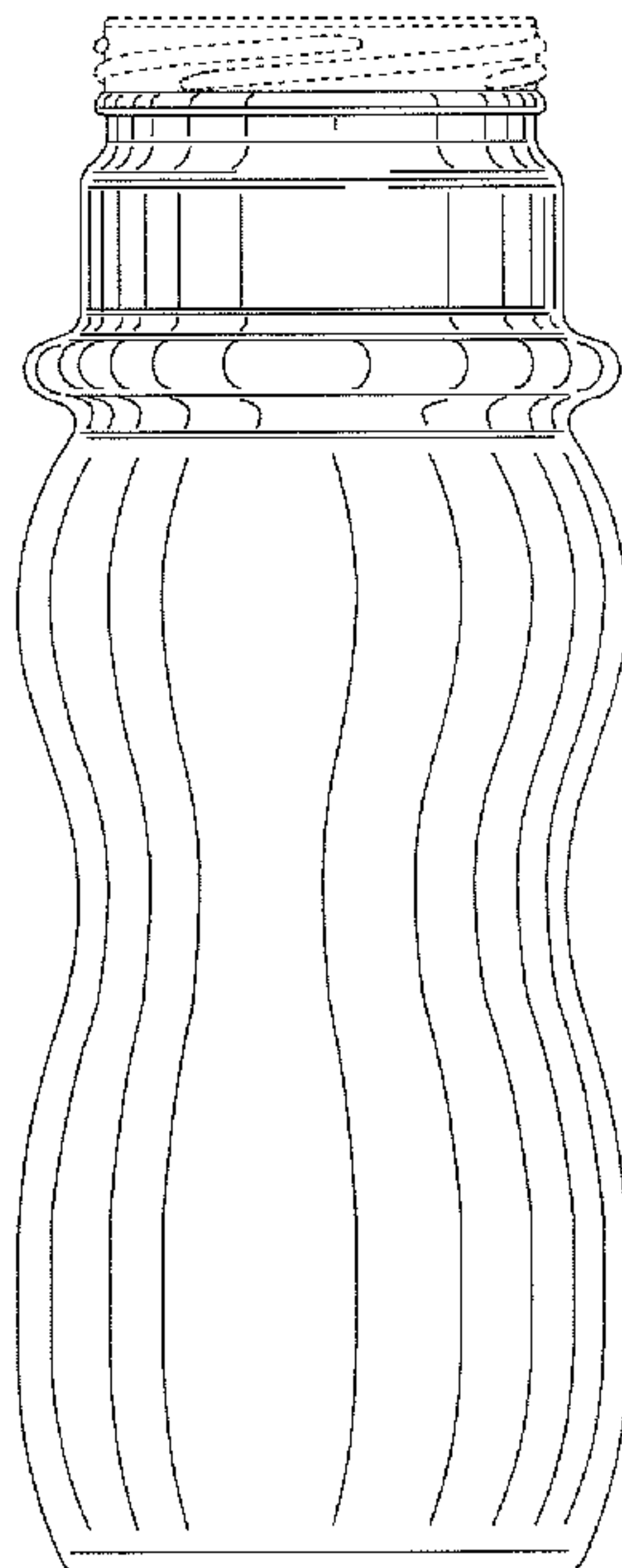
FIG. 1 is a front elevation view of a container showing our new design; the rear, left and right elevational views being identical; and,

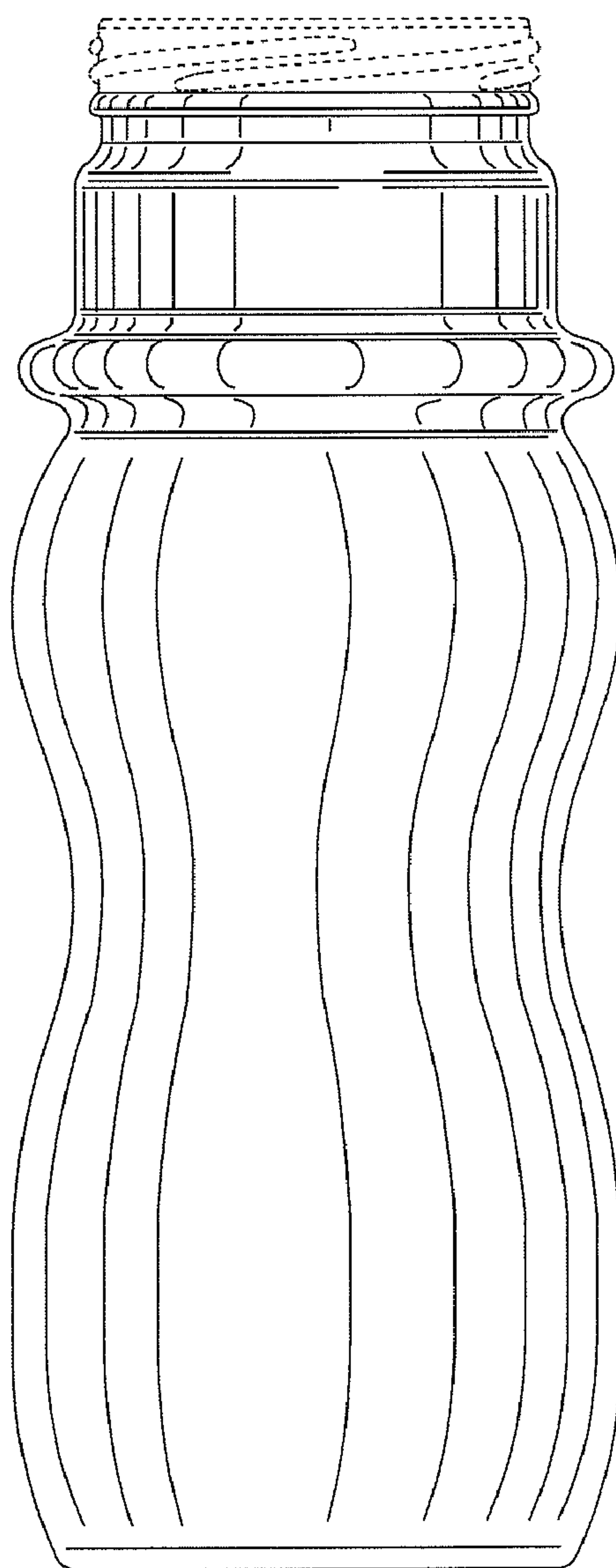

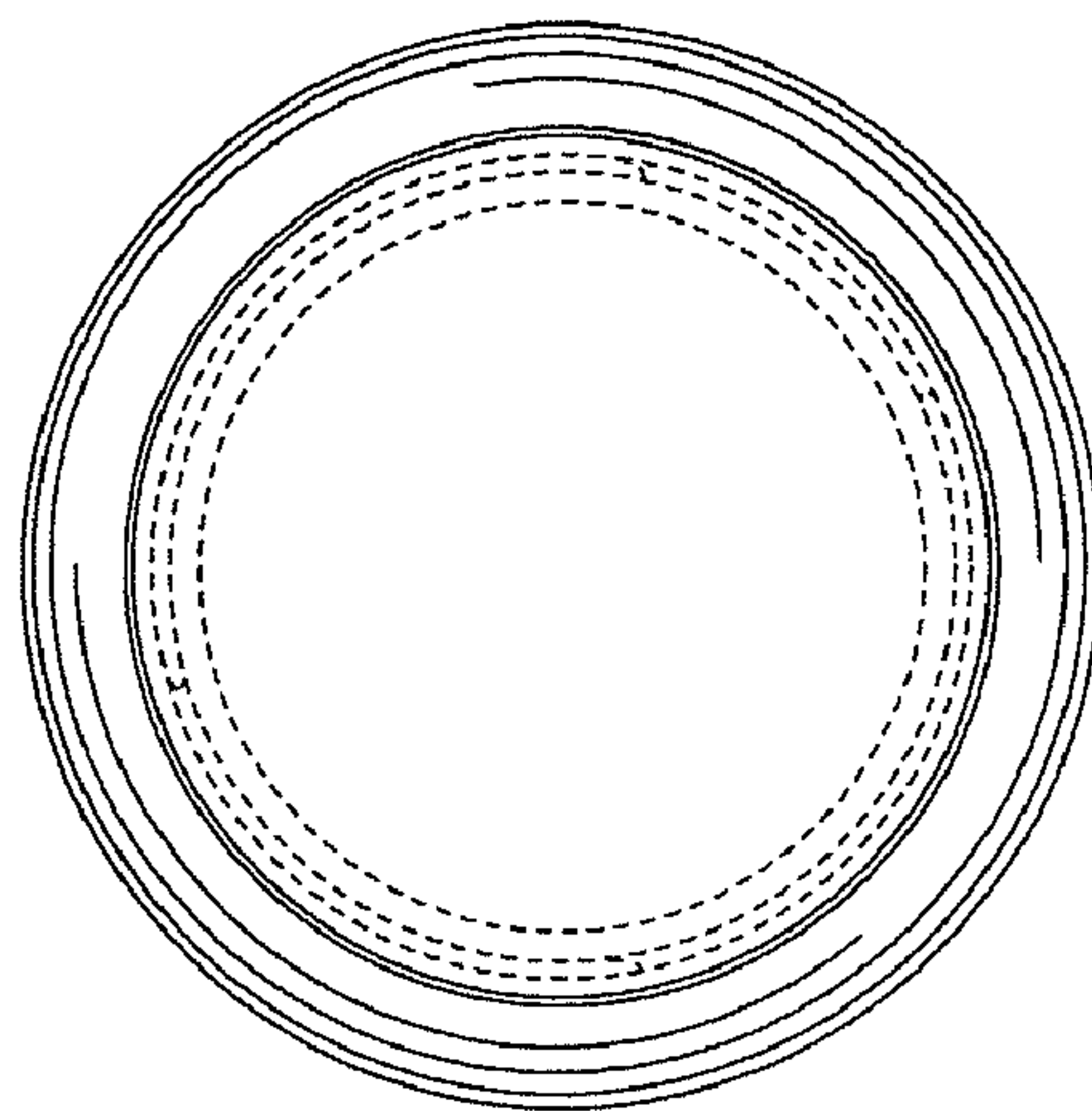
