**DESCRIPTION**

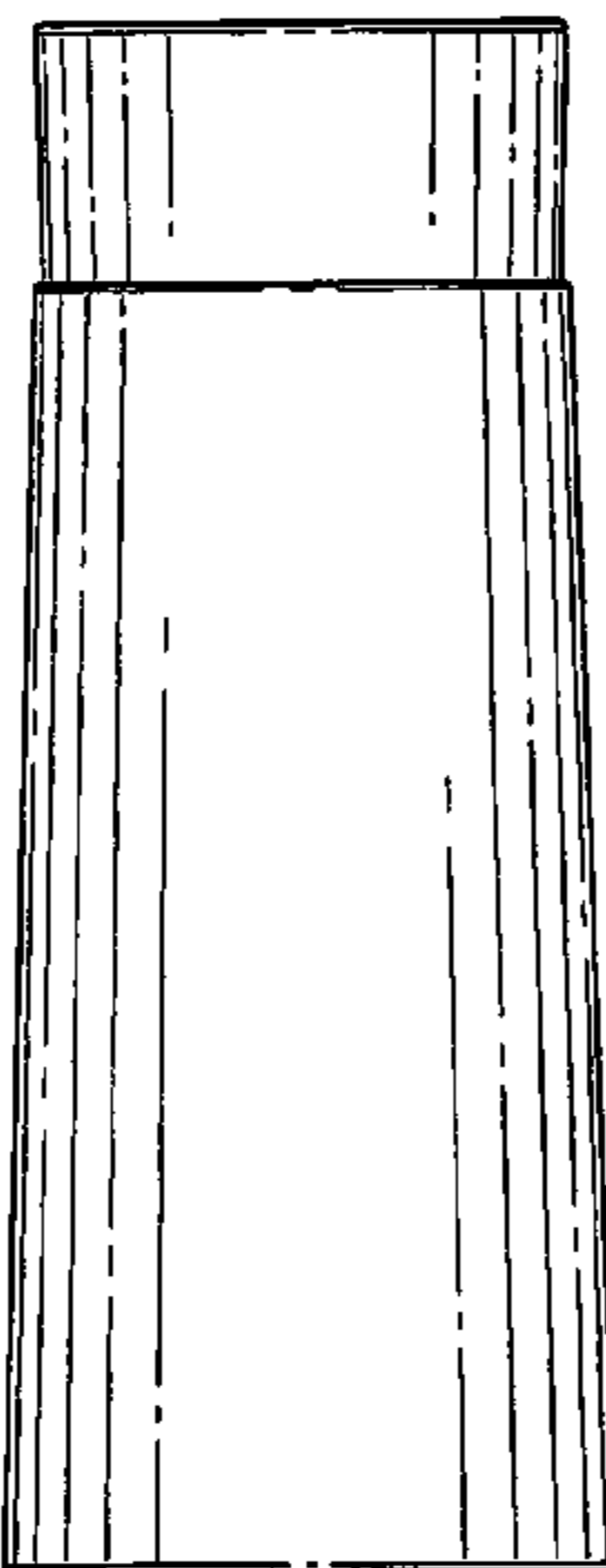
FIG. 1 is a top, front perspective view of a cosmetic container of the present invention;

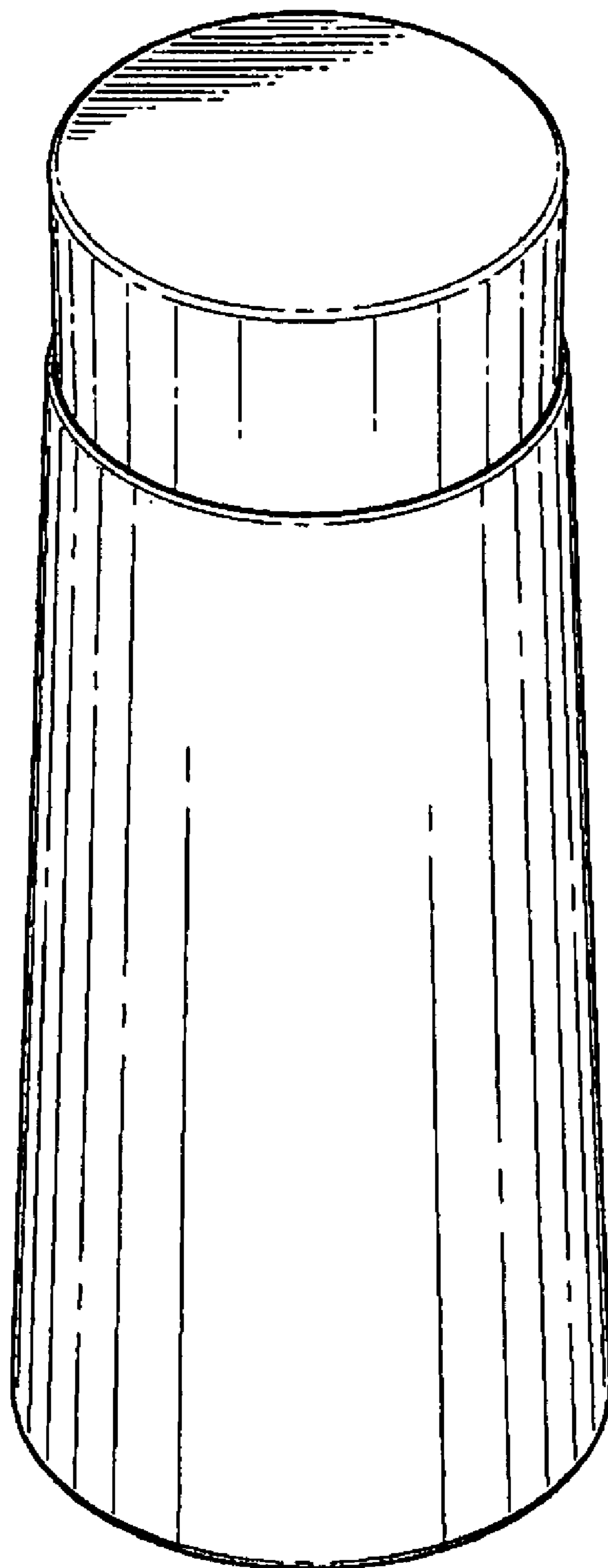

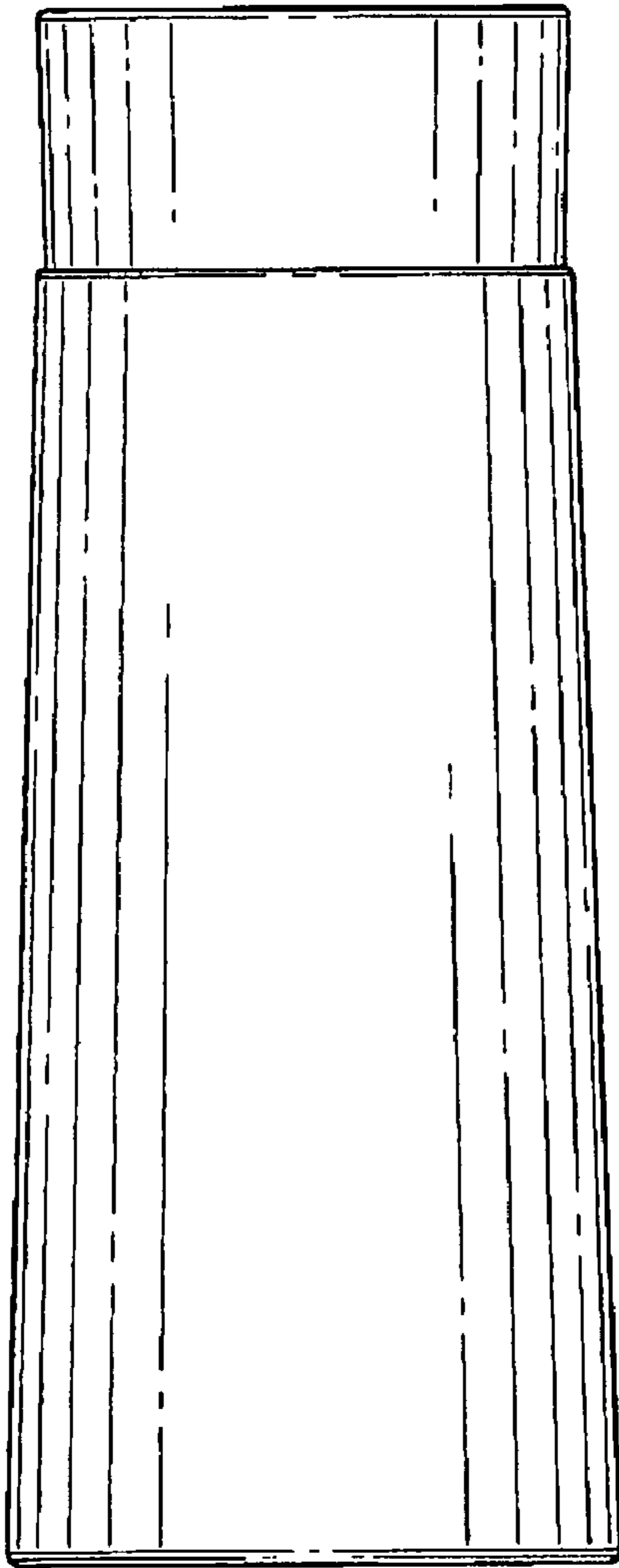

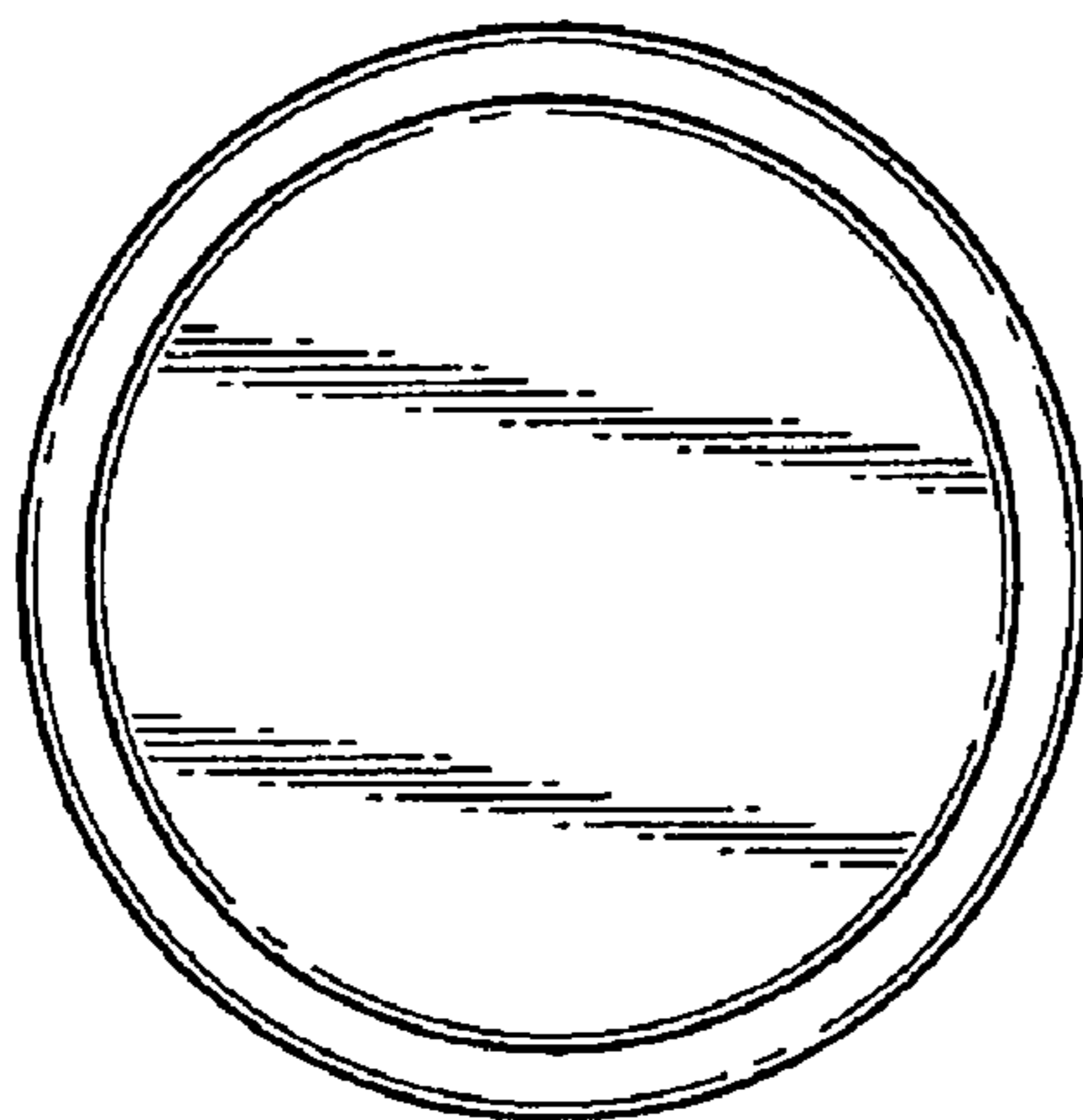

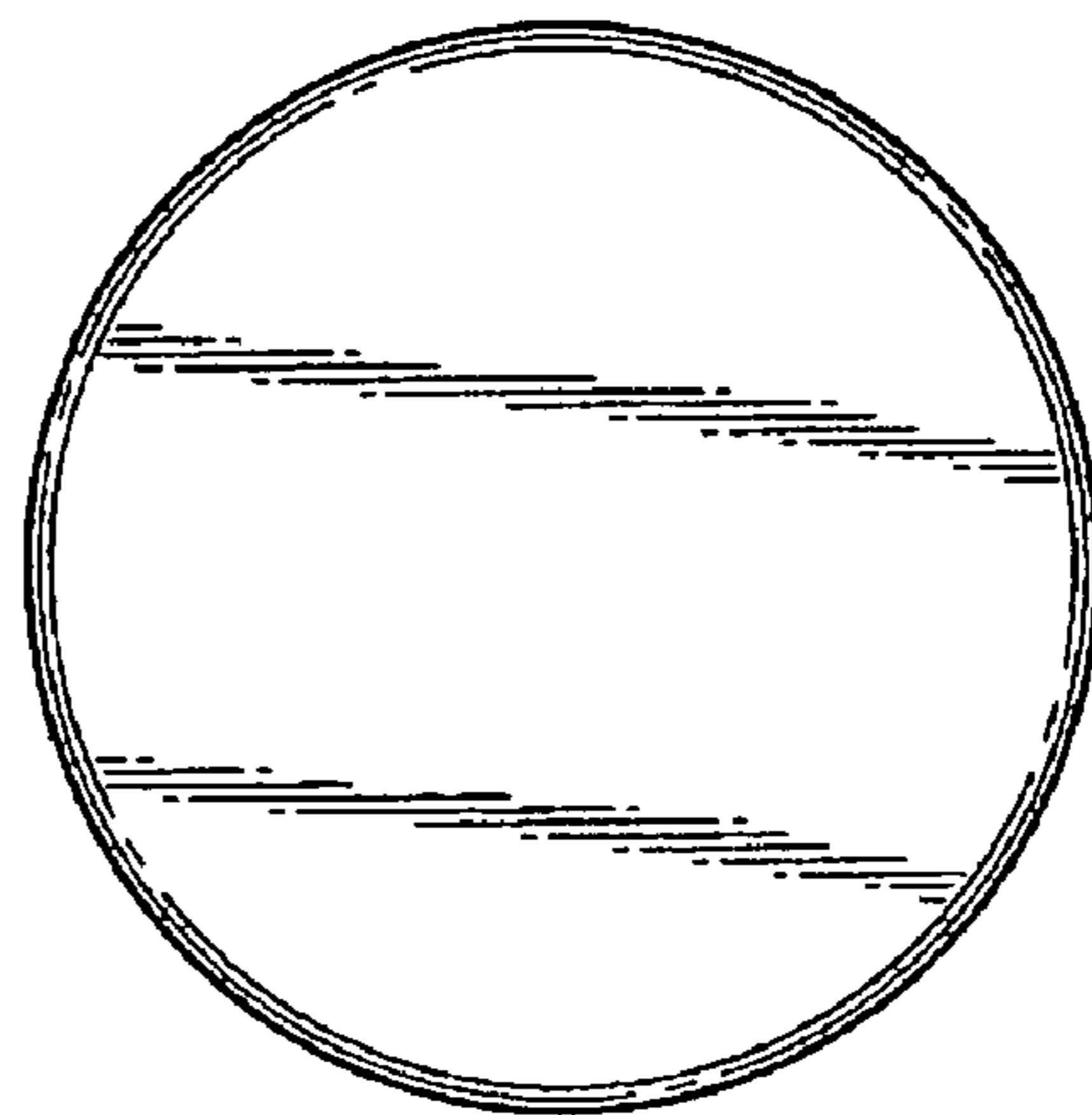
