(57) **CLAIM**

The ornamental design for a perfume bottle, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bottle showing my new design;

FIG. 2 is a front view of the bottle shown in FIG. 1;

FIG. 3 is a side view of the bottle illustrated in FIG. 1, the other side being a mirror image thereof;

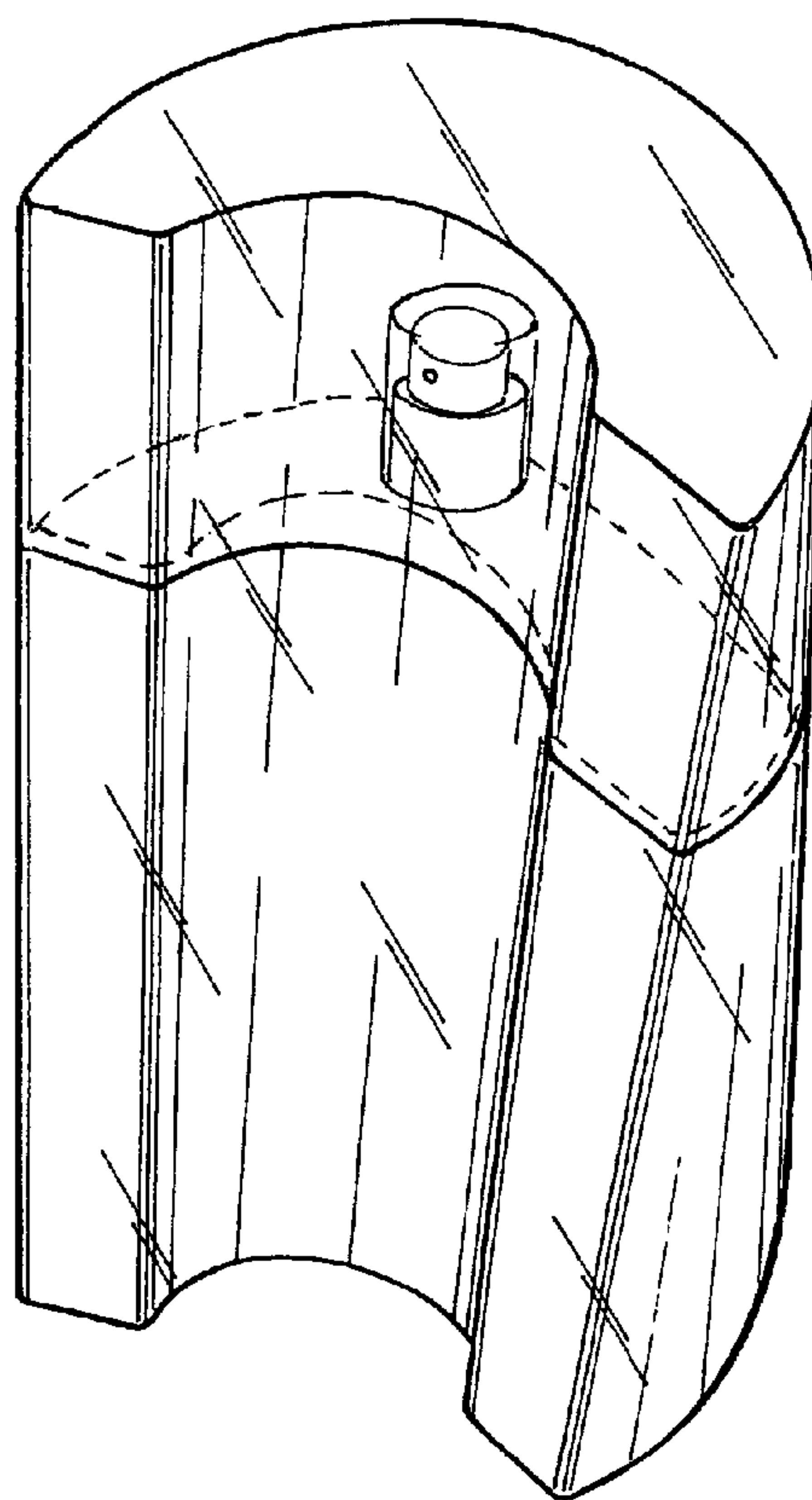
FIG. 4 is a rear view of the bottle set forth in FIG. 1;

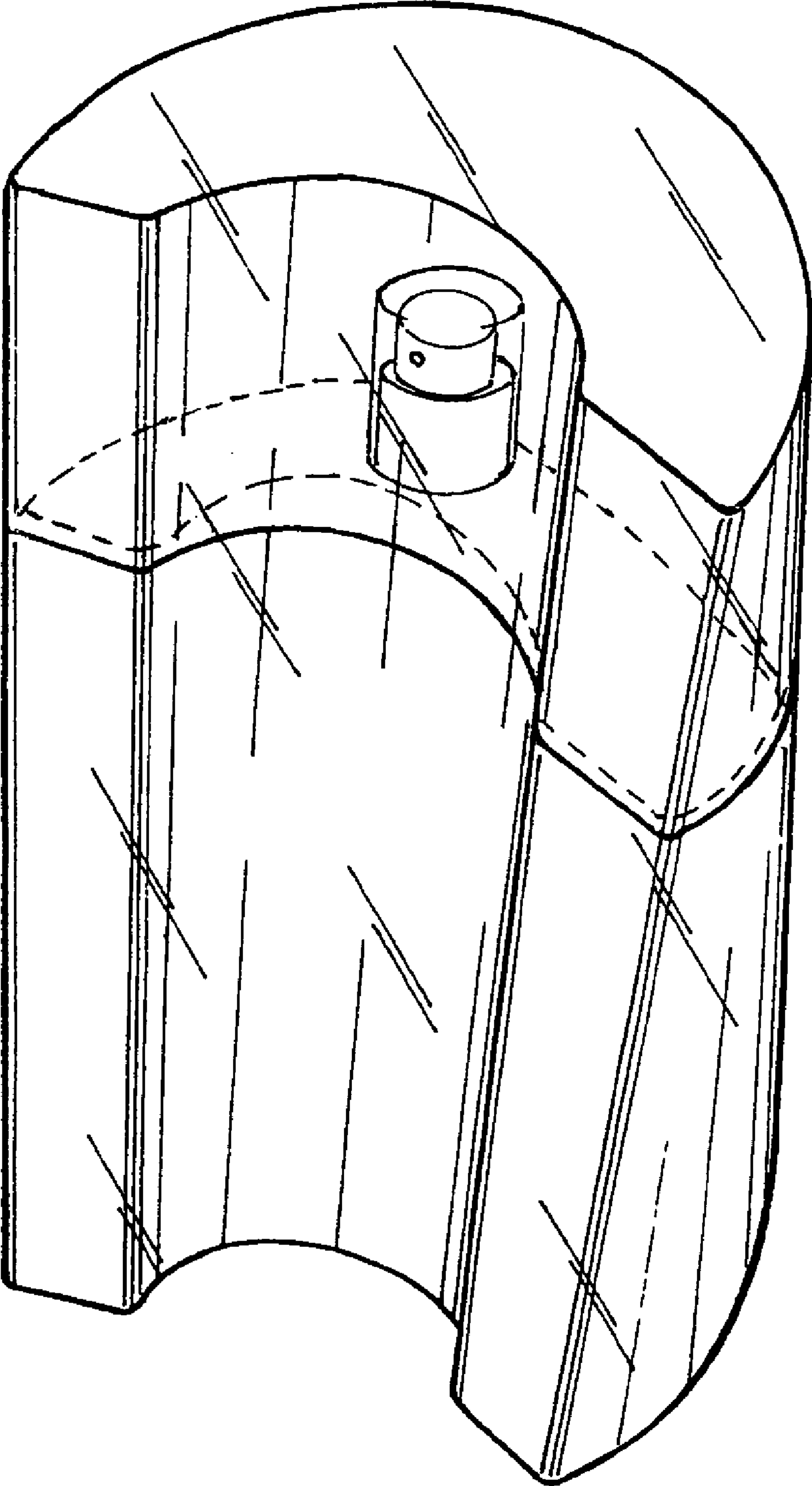
FIG. 5 is a bottom plan view of the bottle shown in FIG. 1; and,

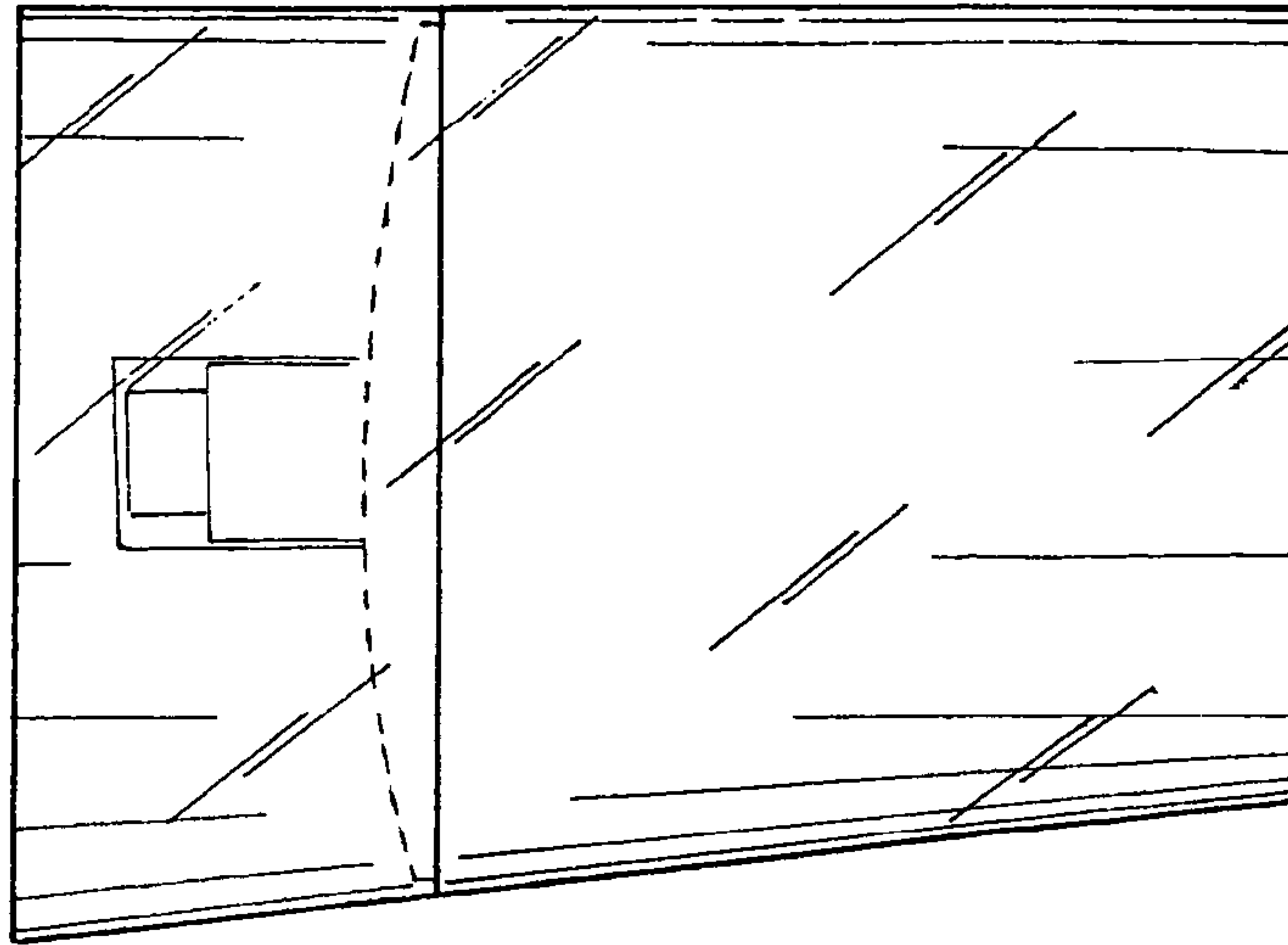

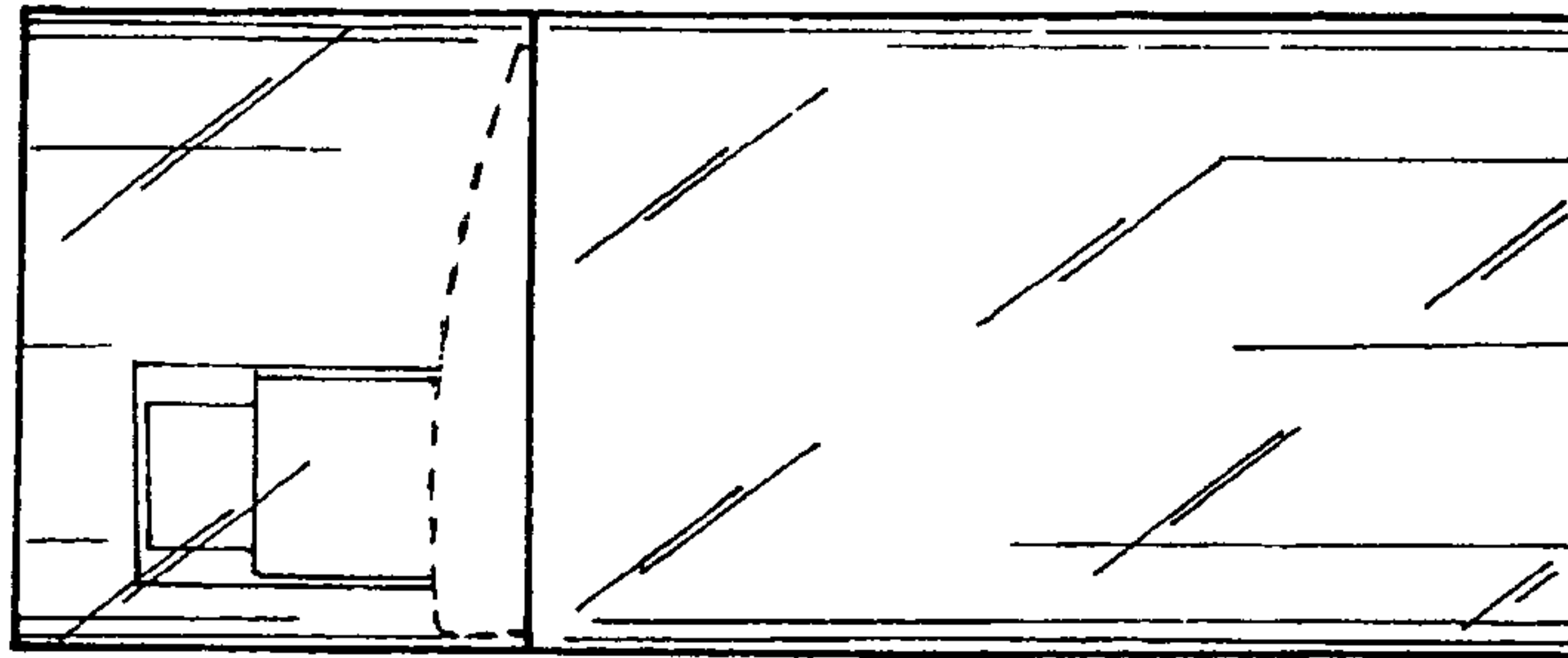

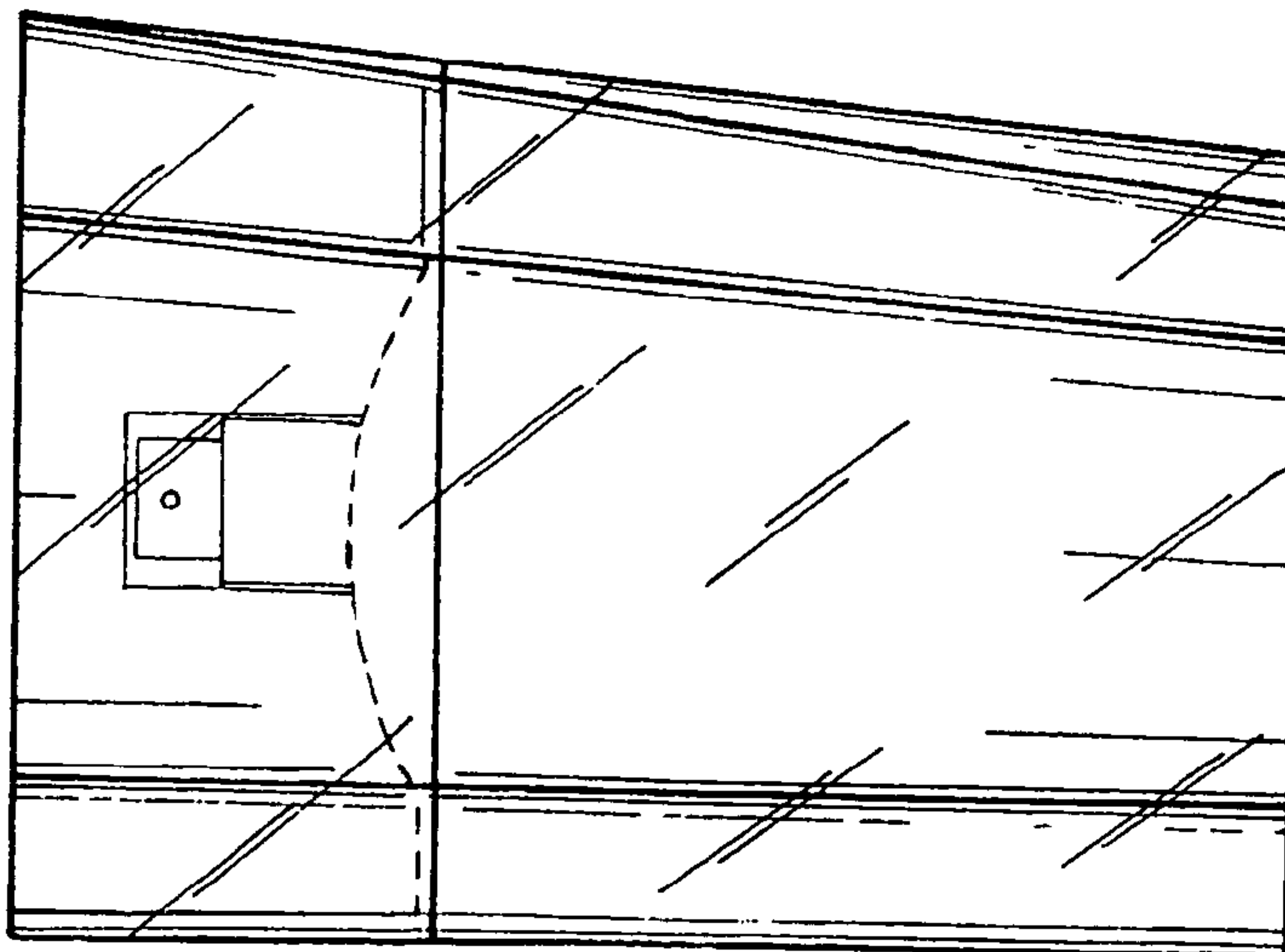
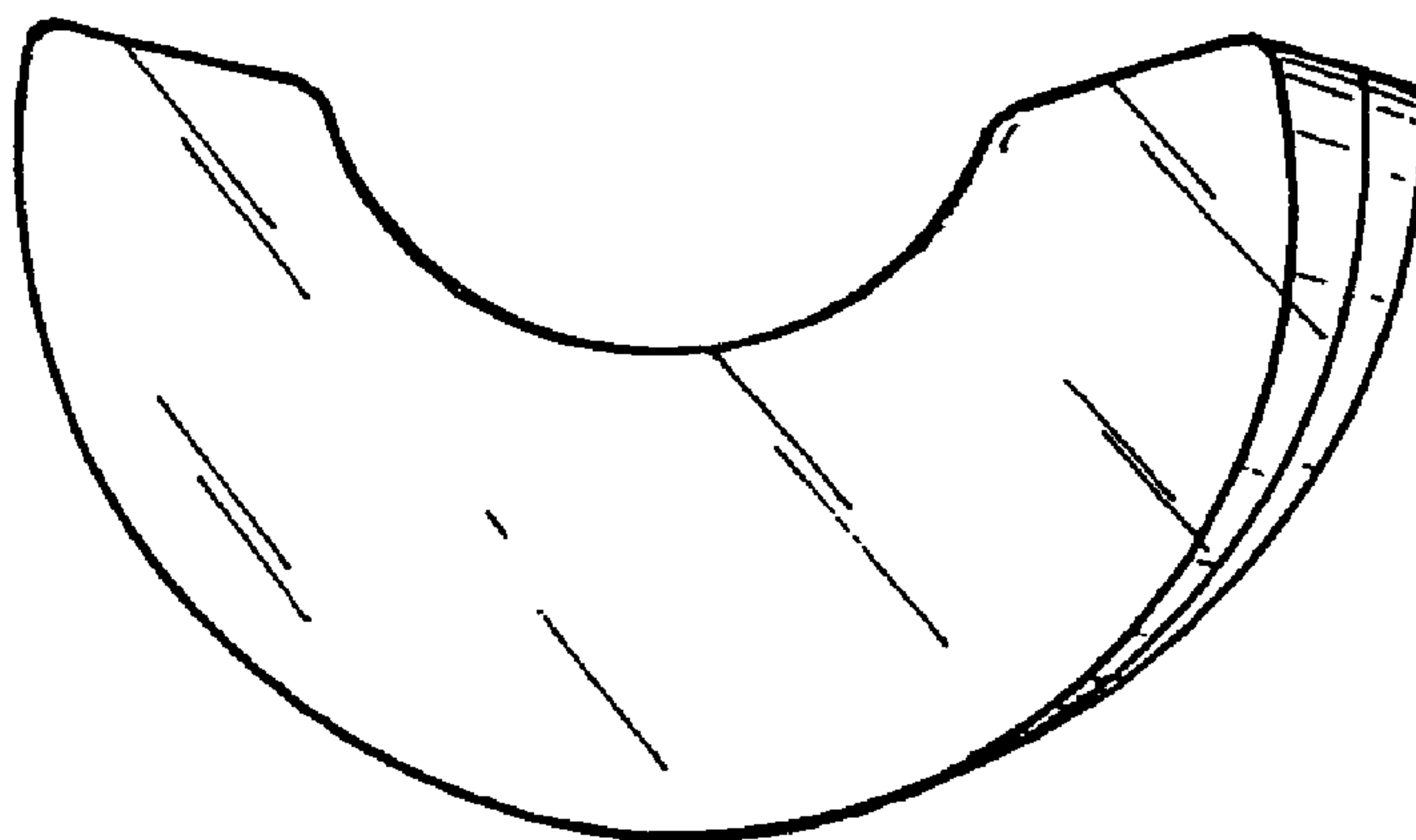
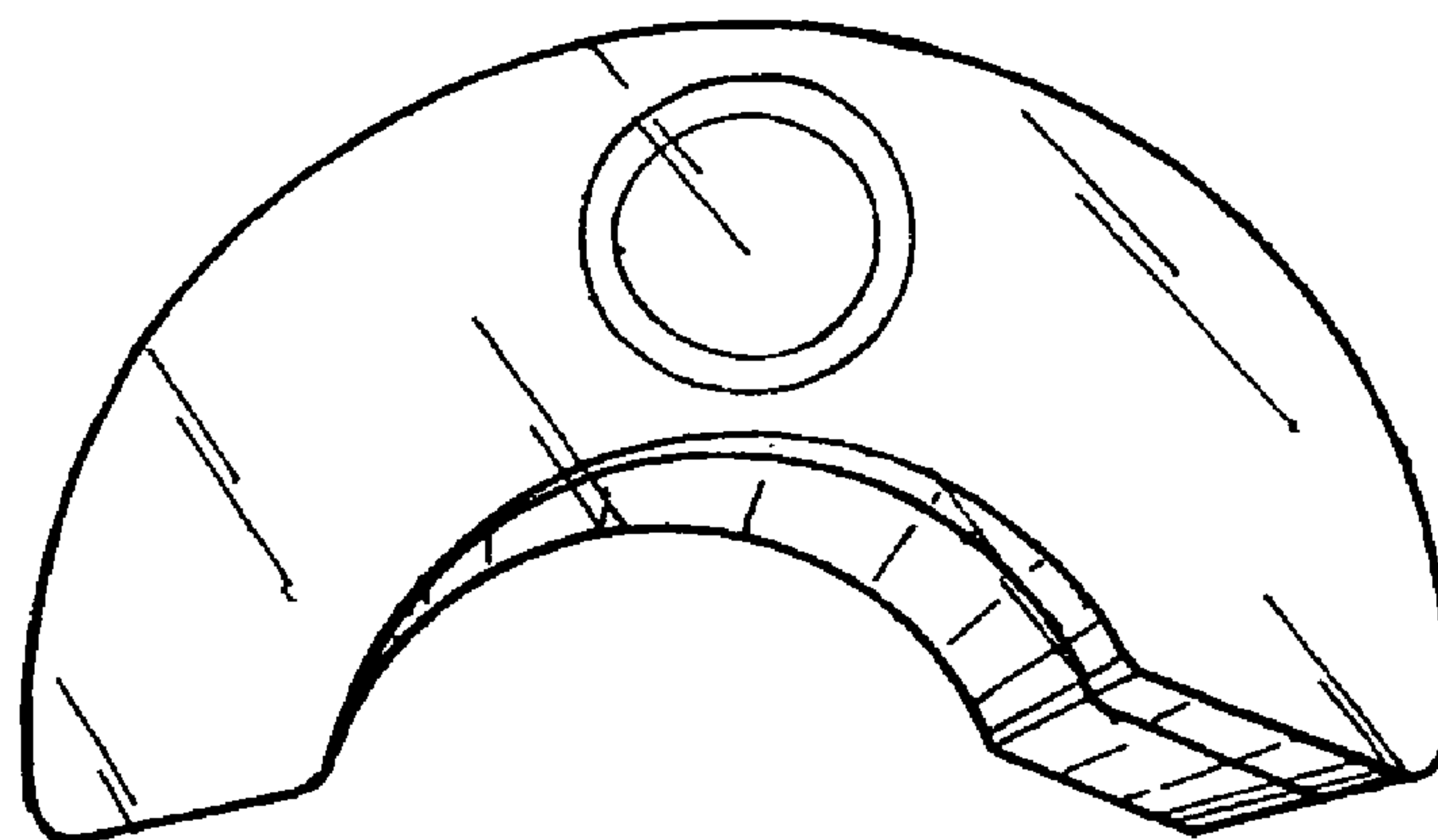
