(57) **CLAIM**

The ornamental design for a wide-strap decorative outlet, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side elevation view of a wide-strap decorative outlet in accordance with the design;

FIG. 2 is a front elevation view of a wide-strap decorative outlet in accordance with the design;

FIG. 3 is a right side elevation view of a wide-strap decorative outlet in accordance with the design;

FIG. 4 is a top plan view of a wide-strap decorative outlet in accordance with the design;

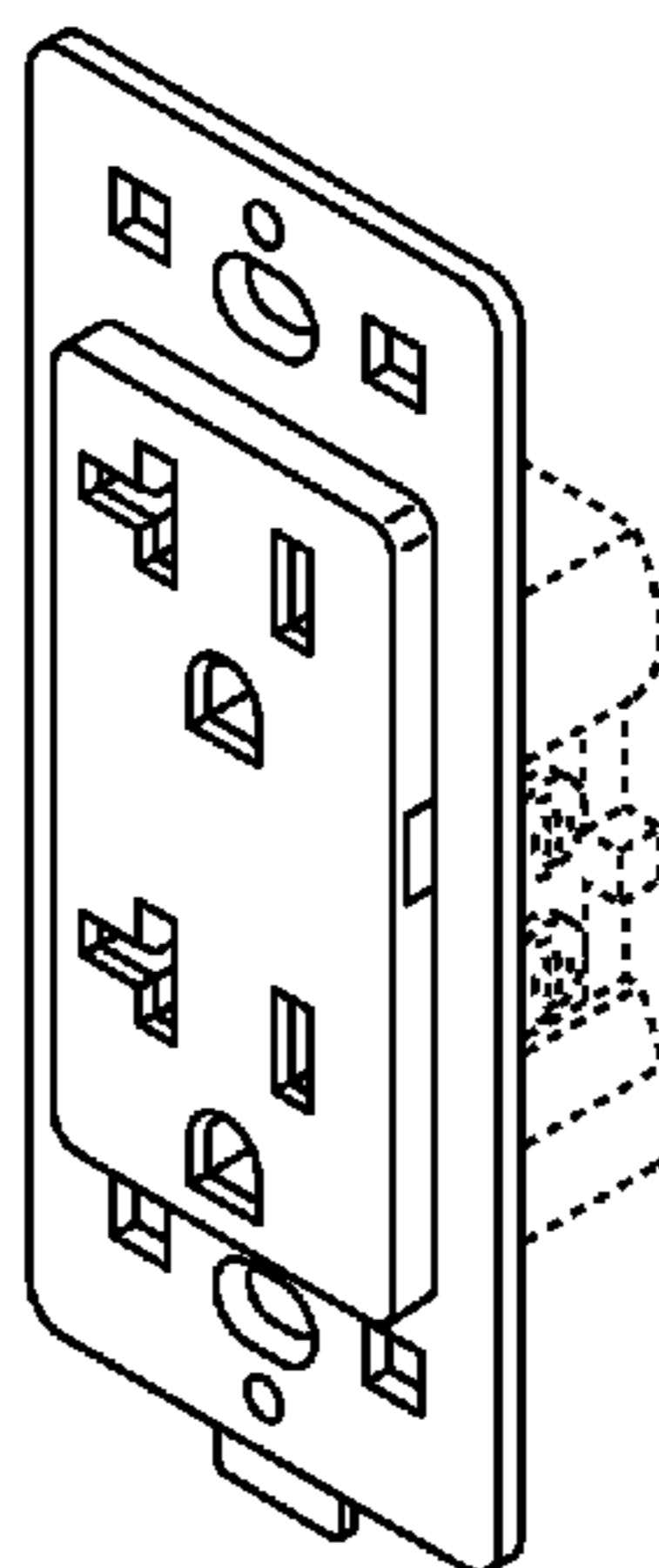
FIG. 5 is a rear elevation view of a wide-strap decorative outlet in accordance with the design;

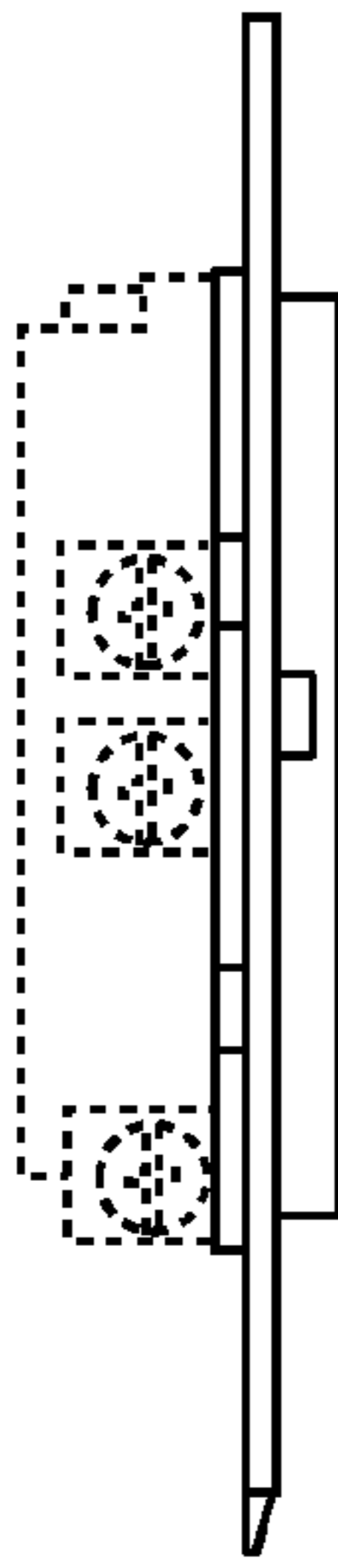

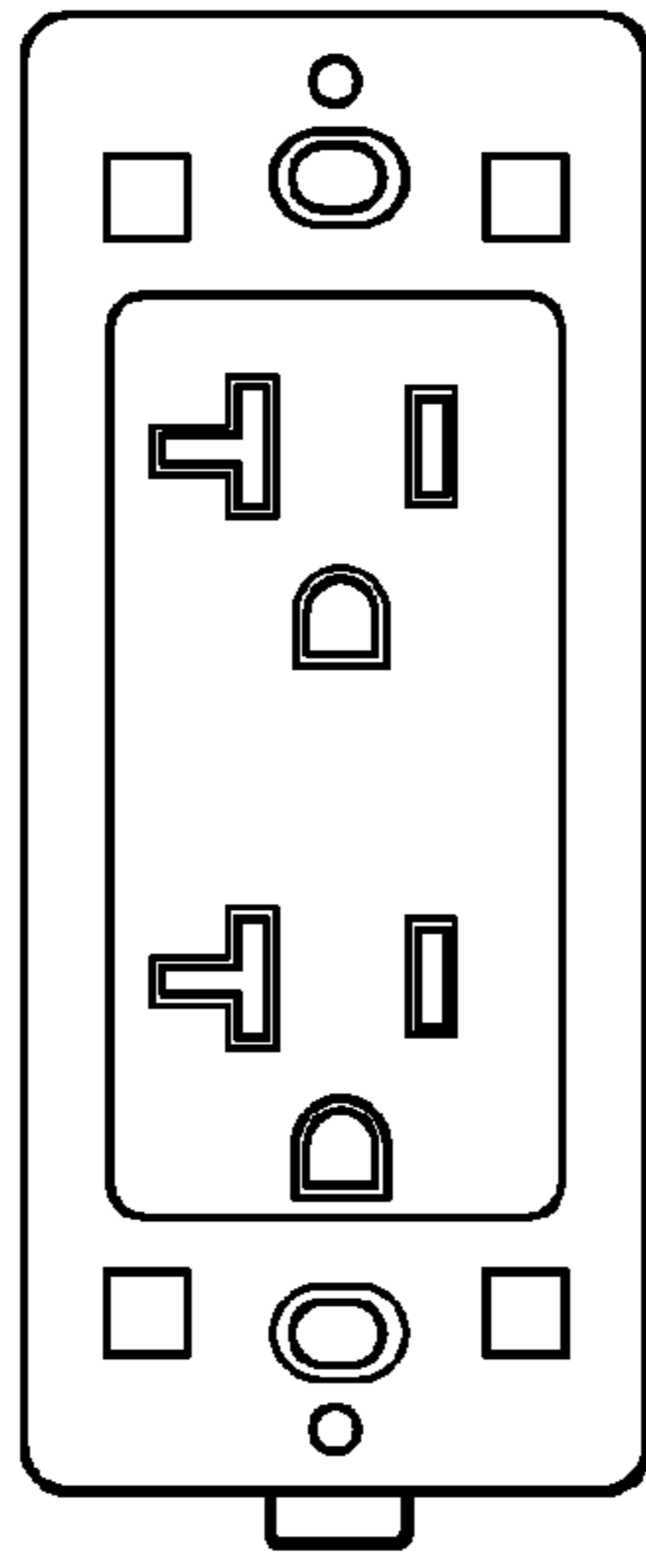

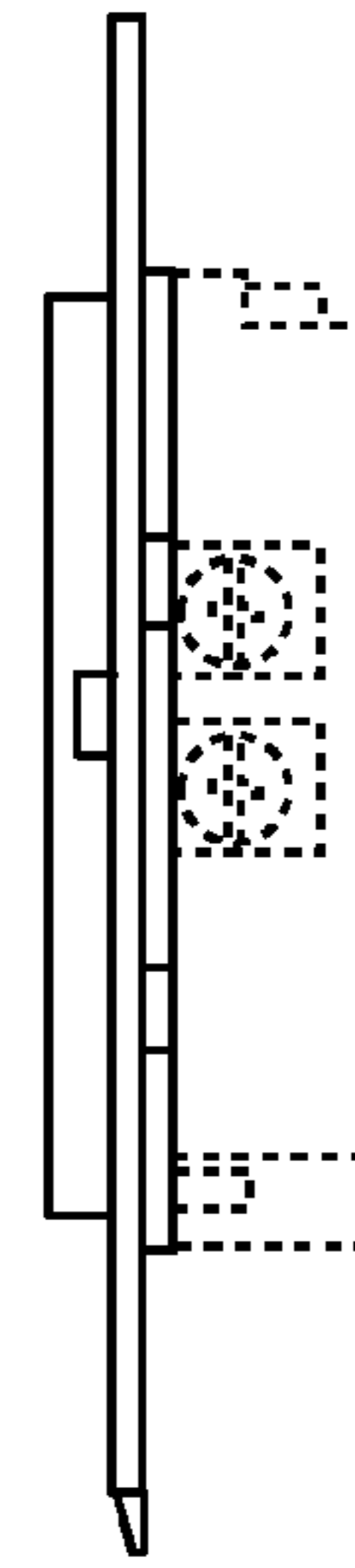

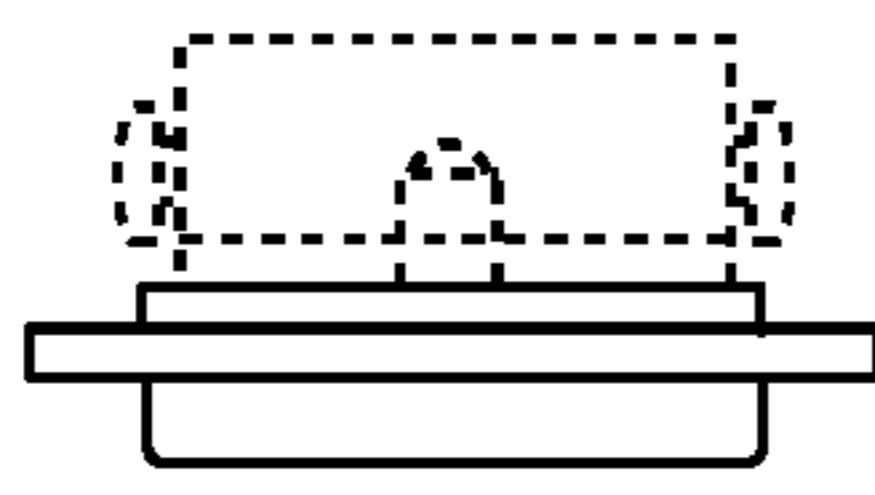

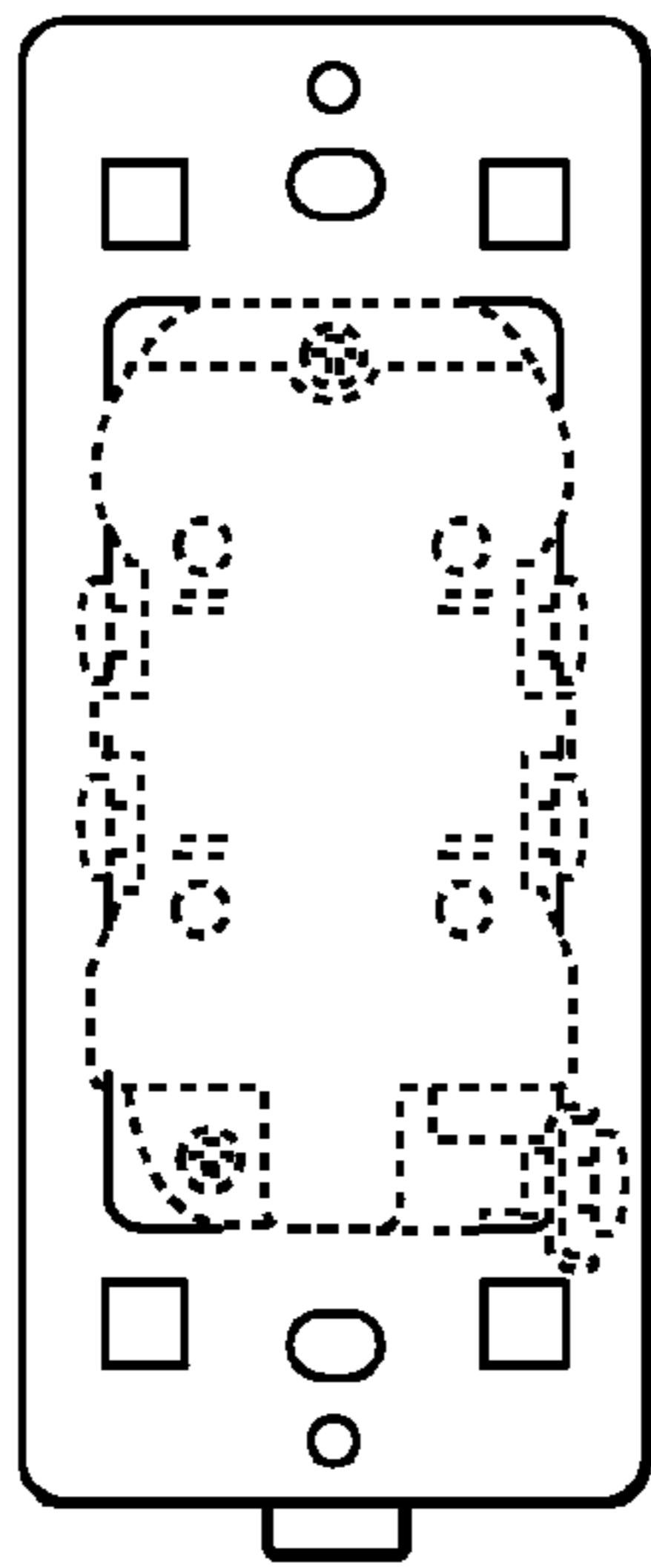

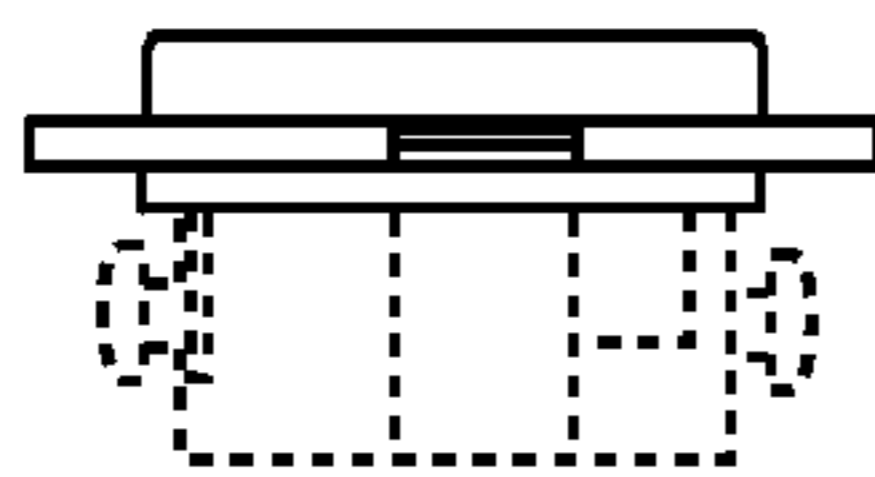

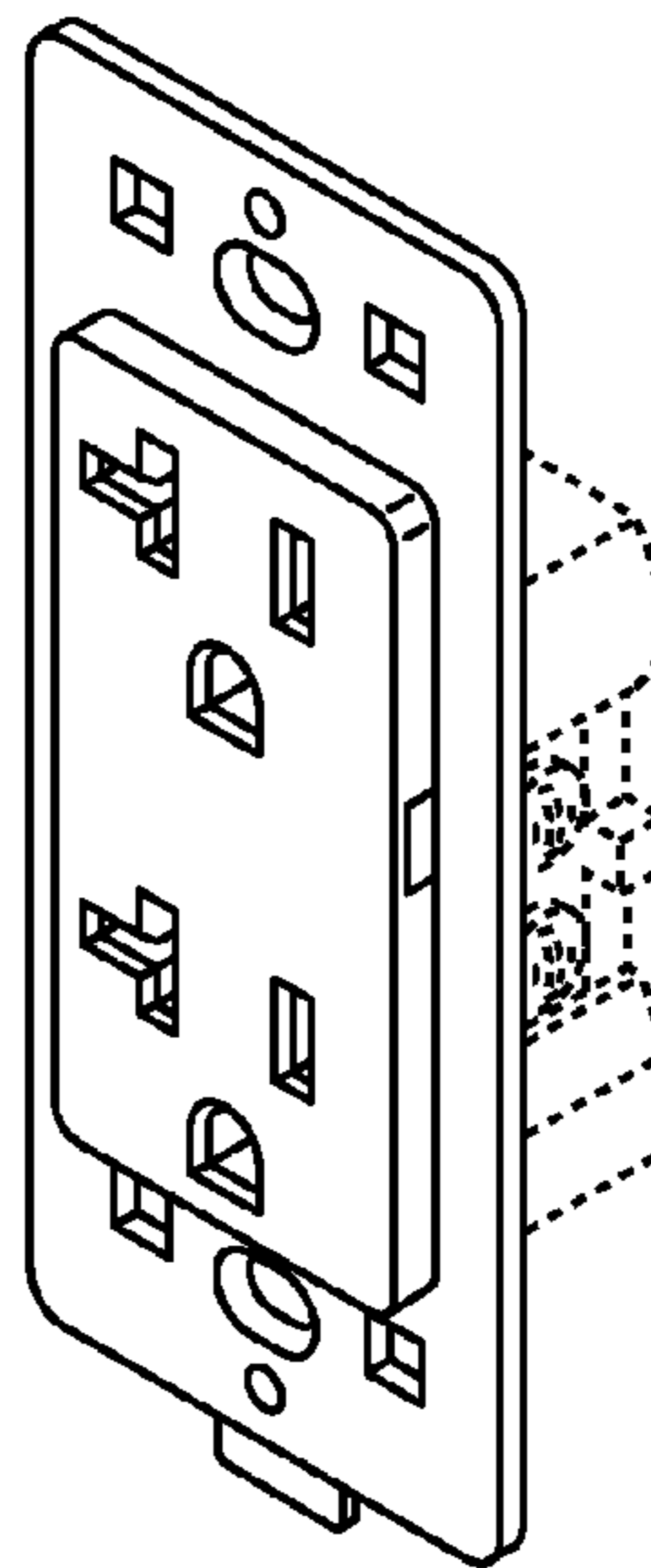
