FIG. 2 is a rear elevational view of the portable electronic map thereof;

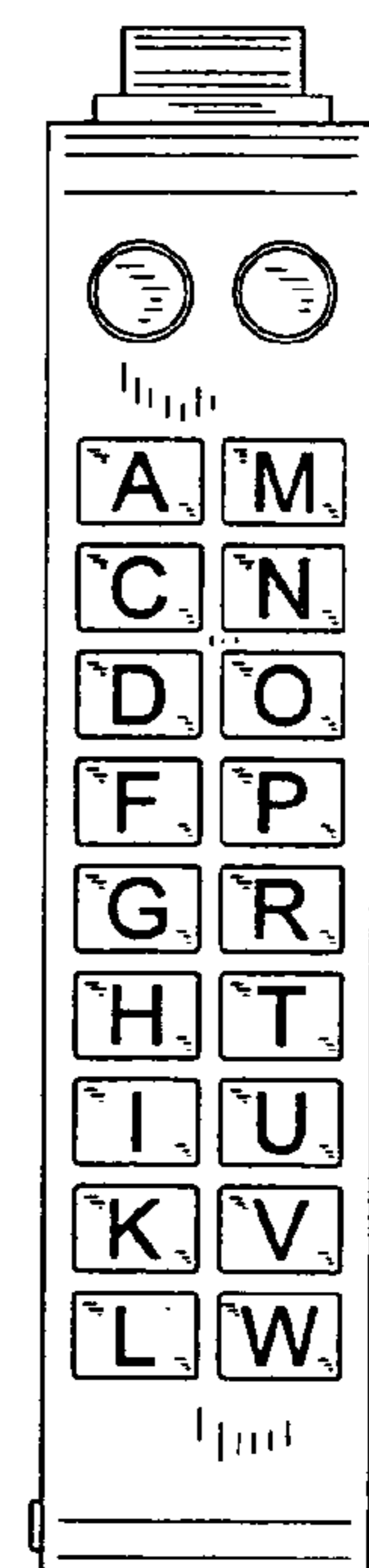
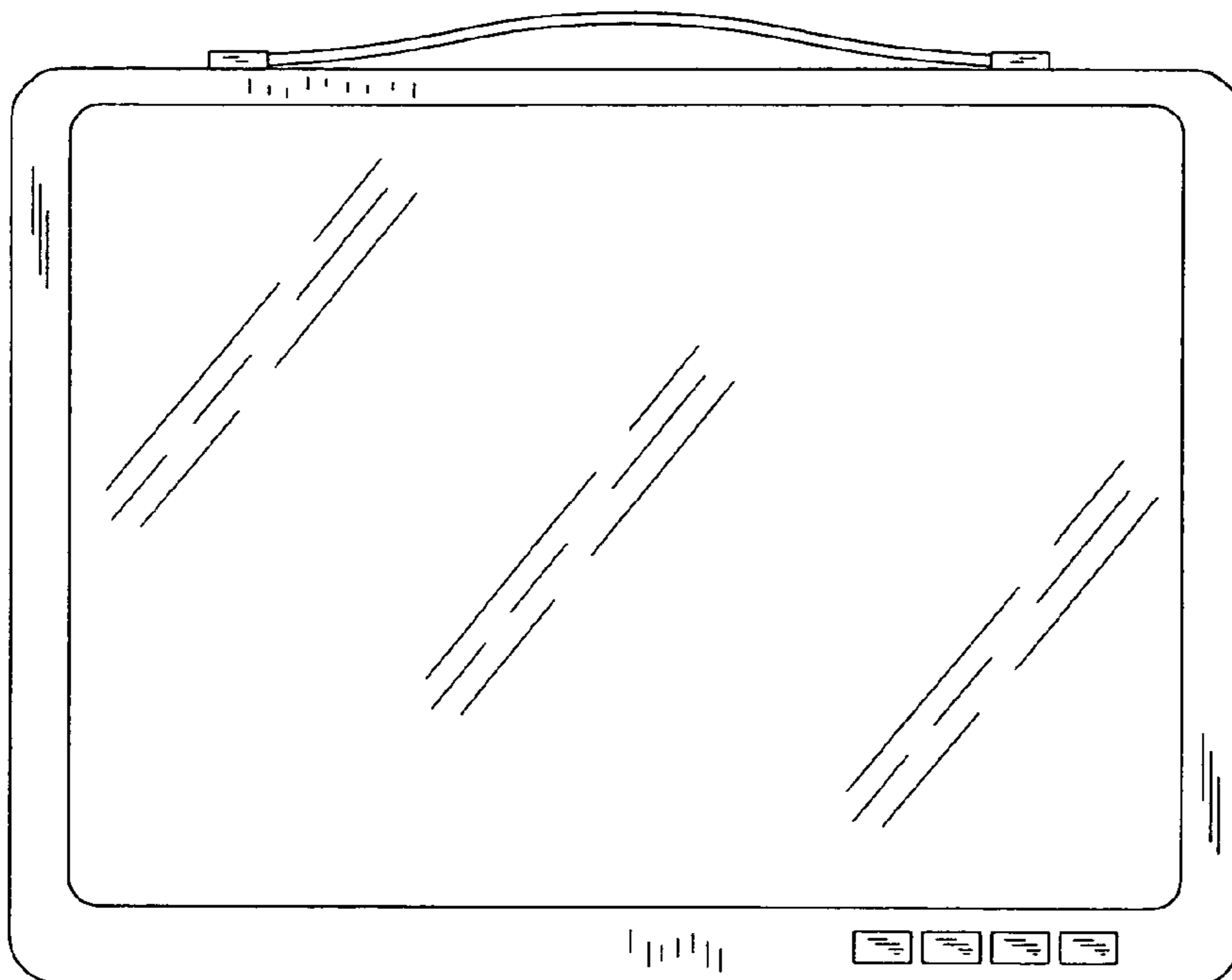
FIG. 3 is a left-side elevational view of the portable electronic map thereof;

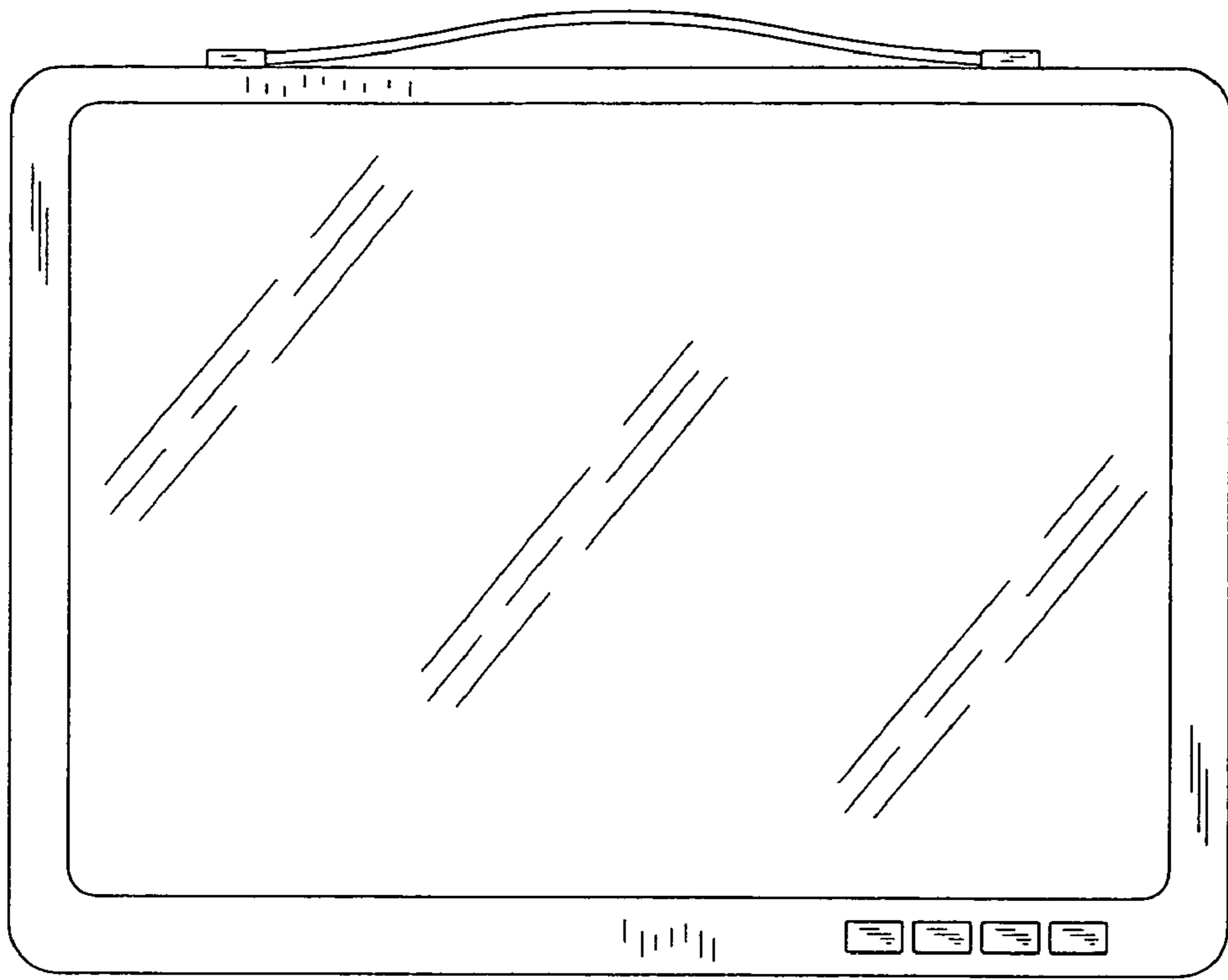

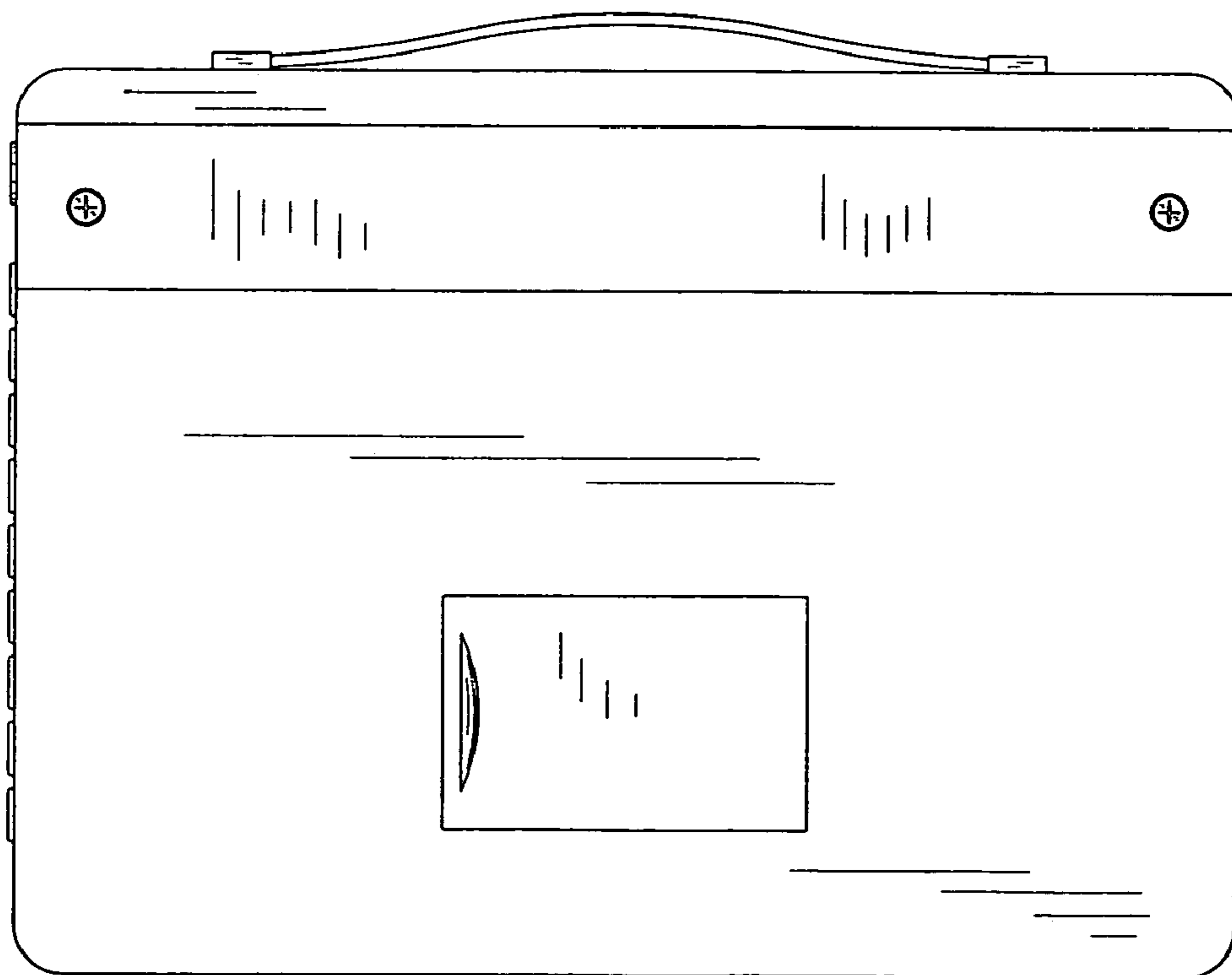

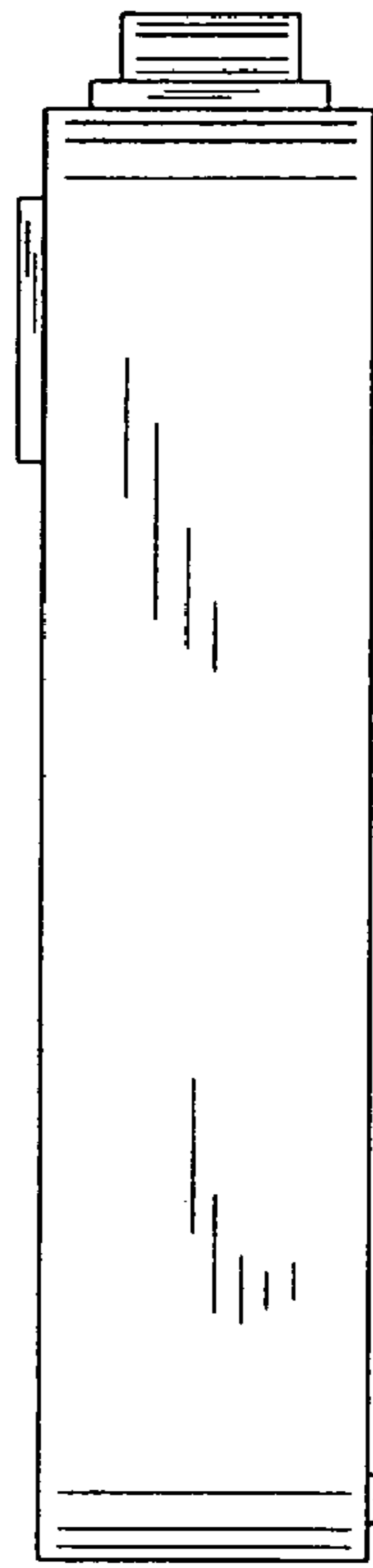

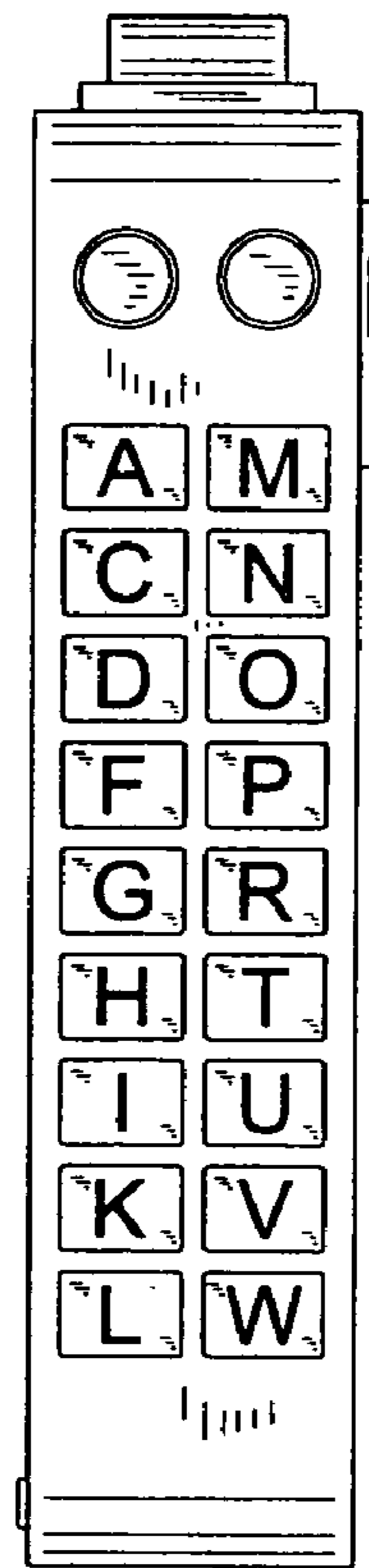

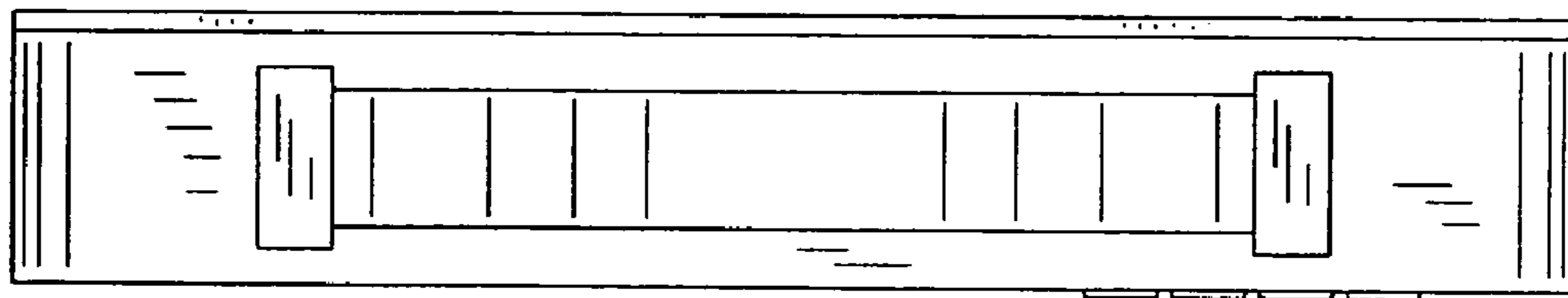

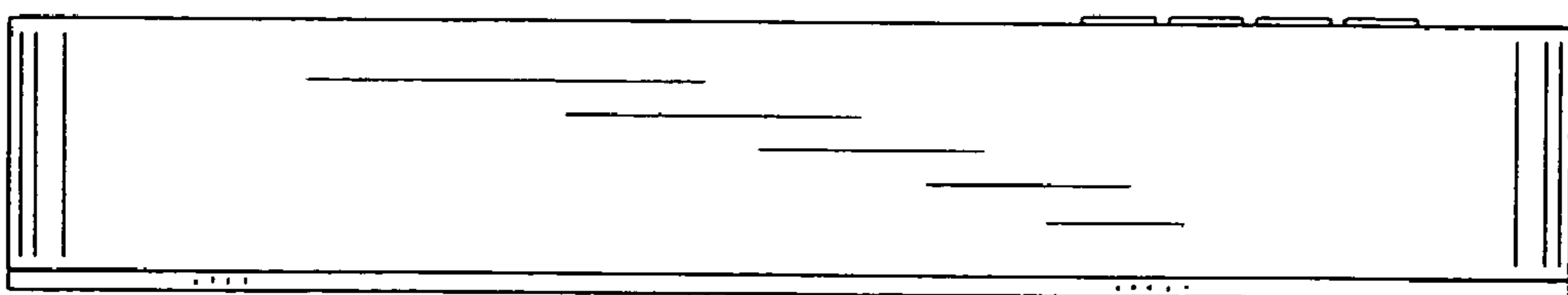
