The ornamental design for digital camera, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right-side perspective view of our new design for digital camera;

FIG. 2 is a front, right-side, bottom perspective view thereof with the display pivoted upwardly and rotated toward the front;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a left-side elevation view thereof; and,

FIG. 8 is a right-side elevation view thereof.

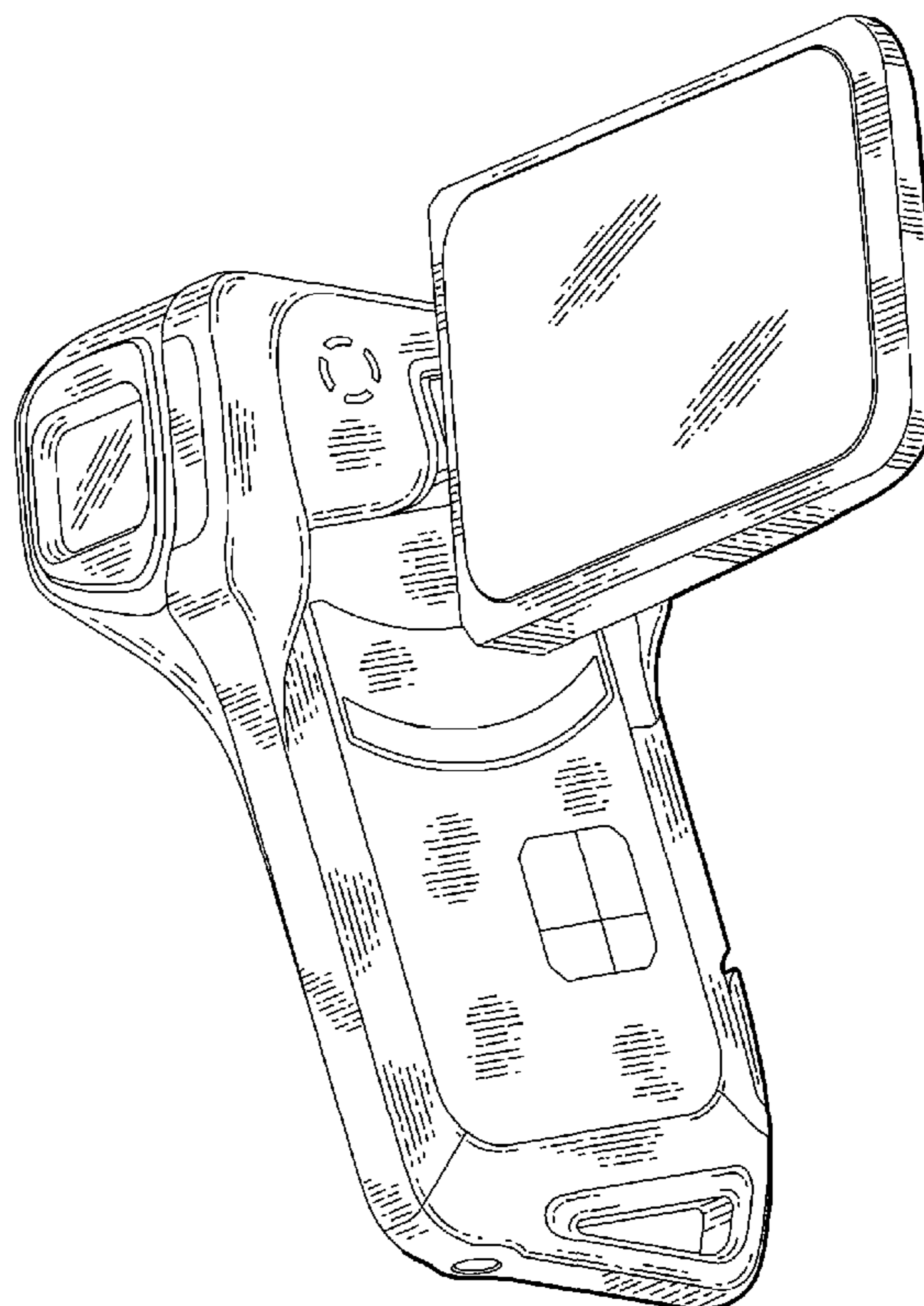
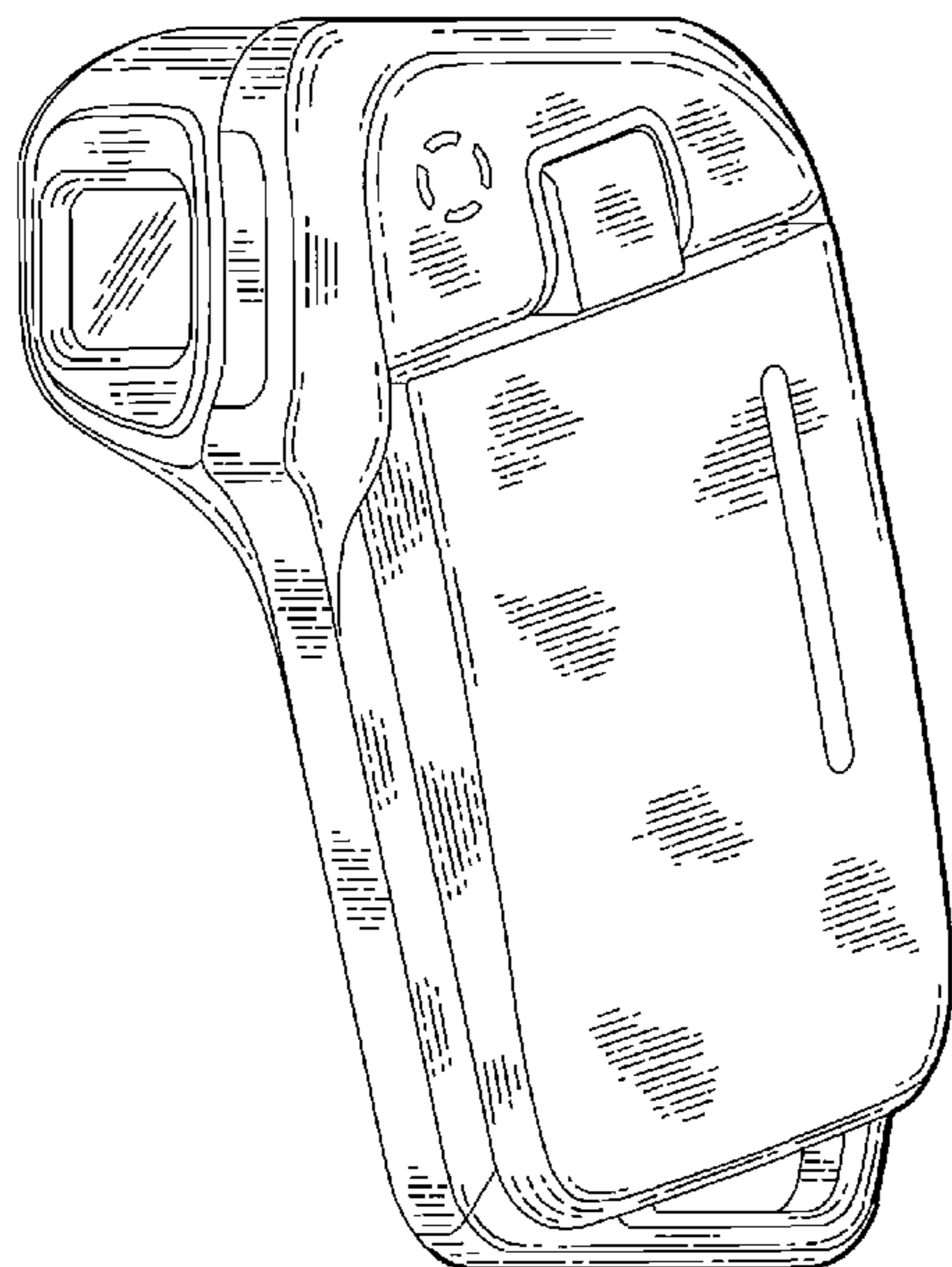

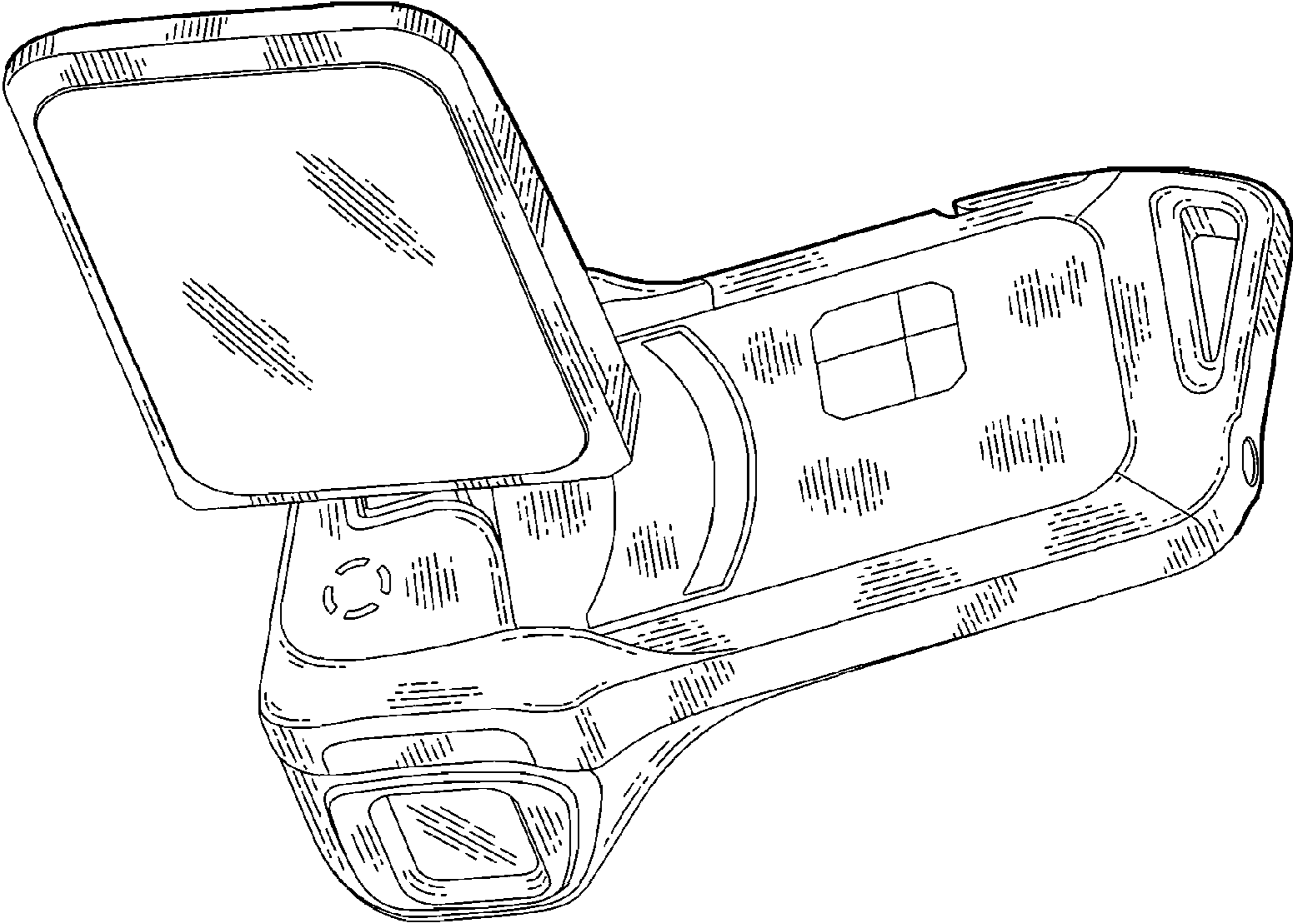

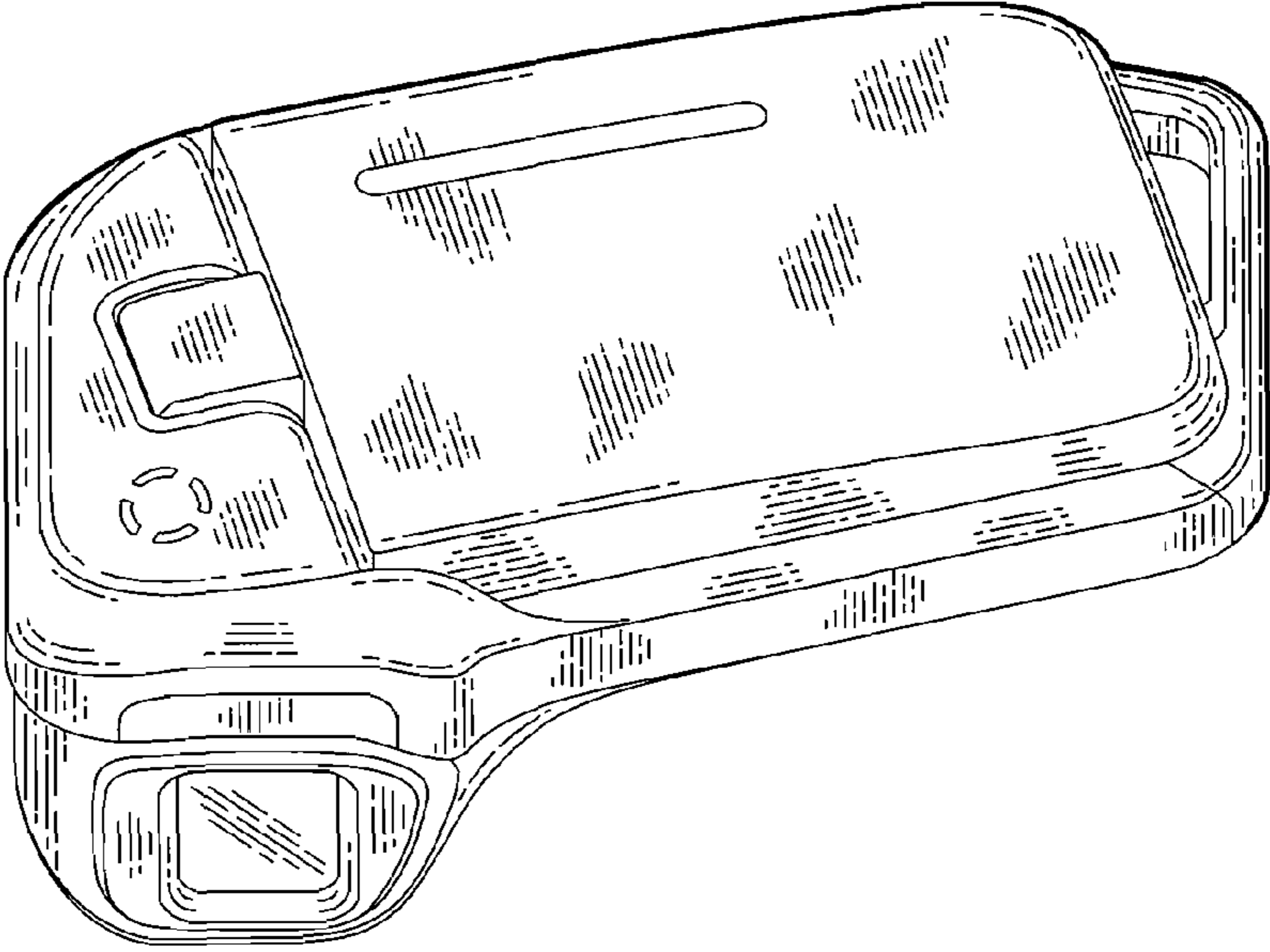

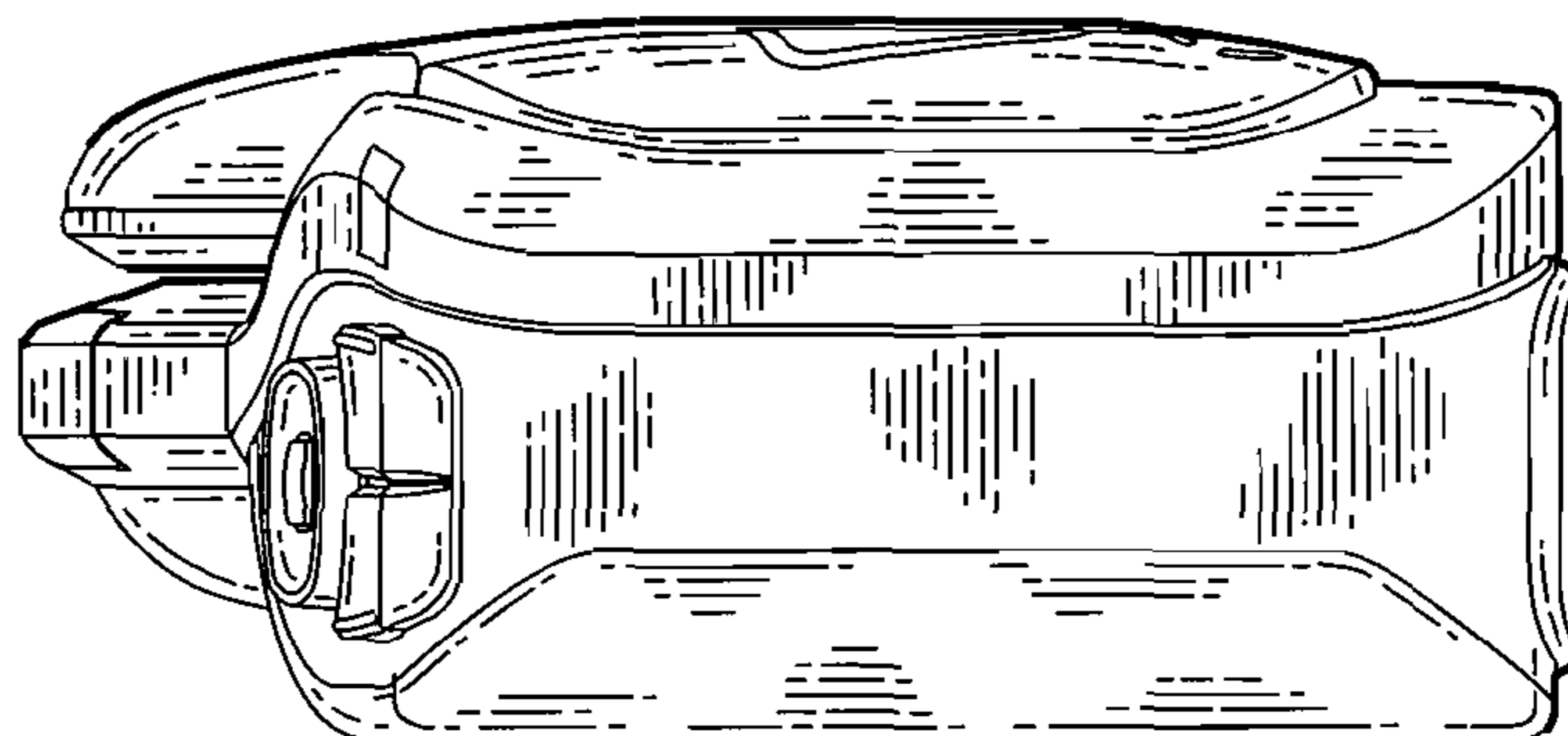

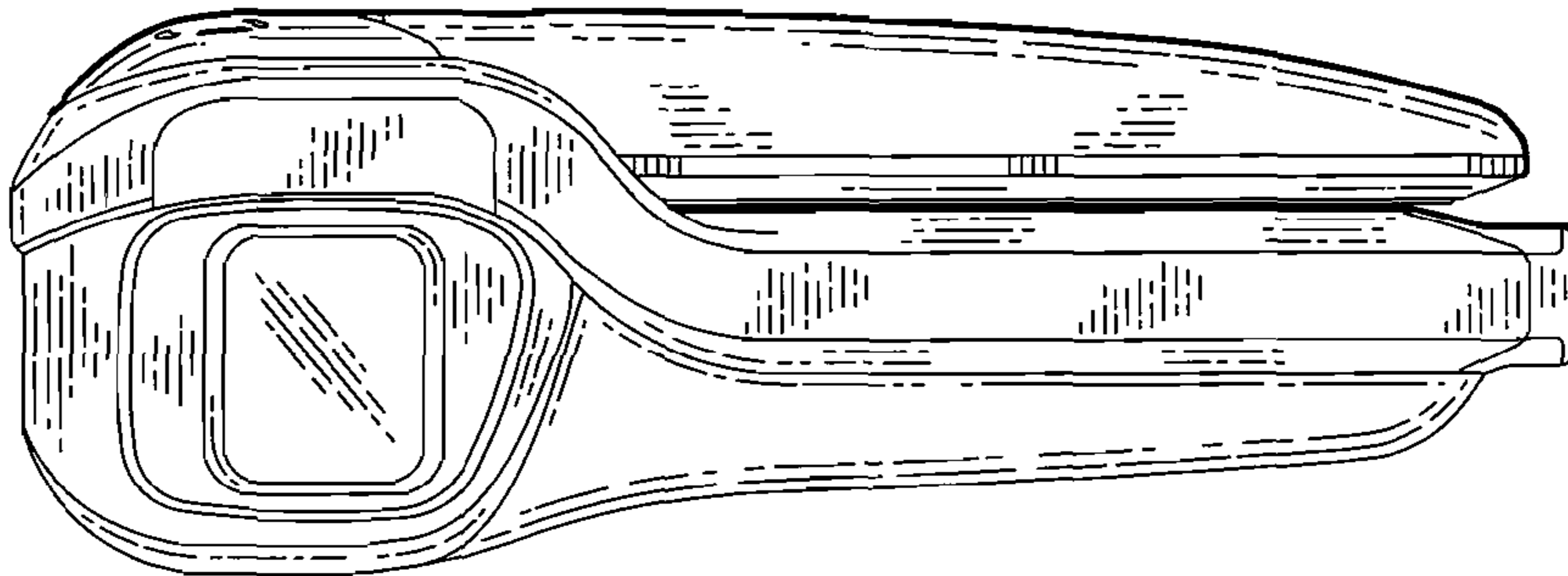

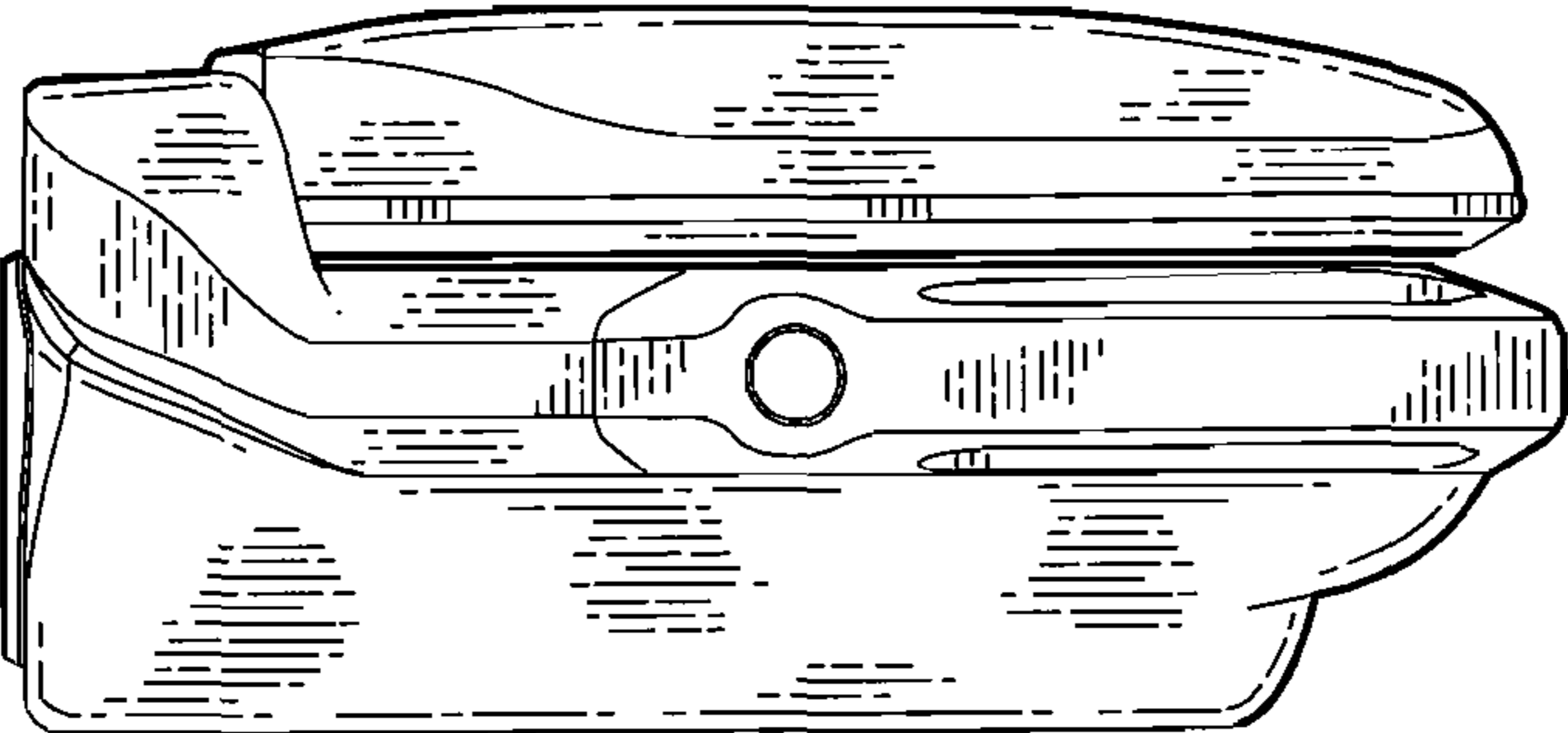

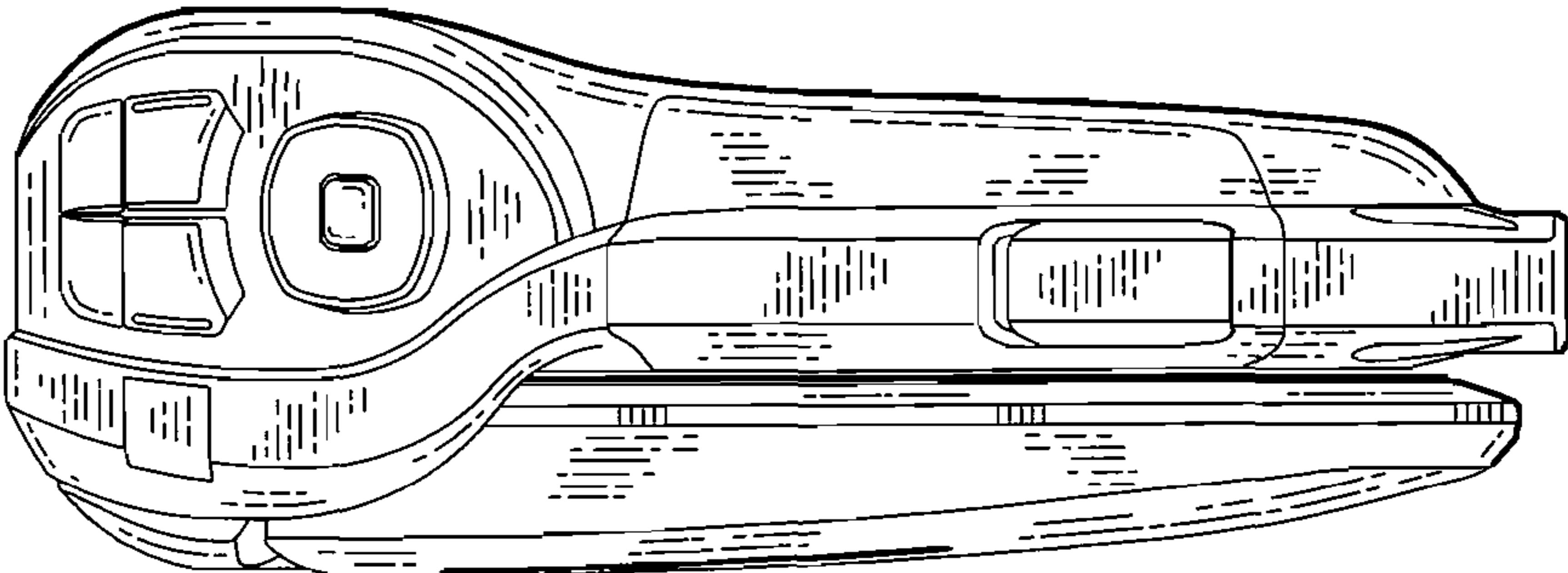

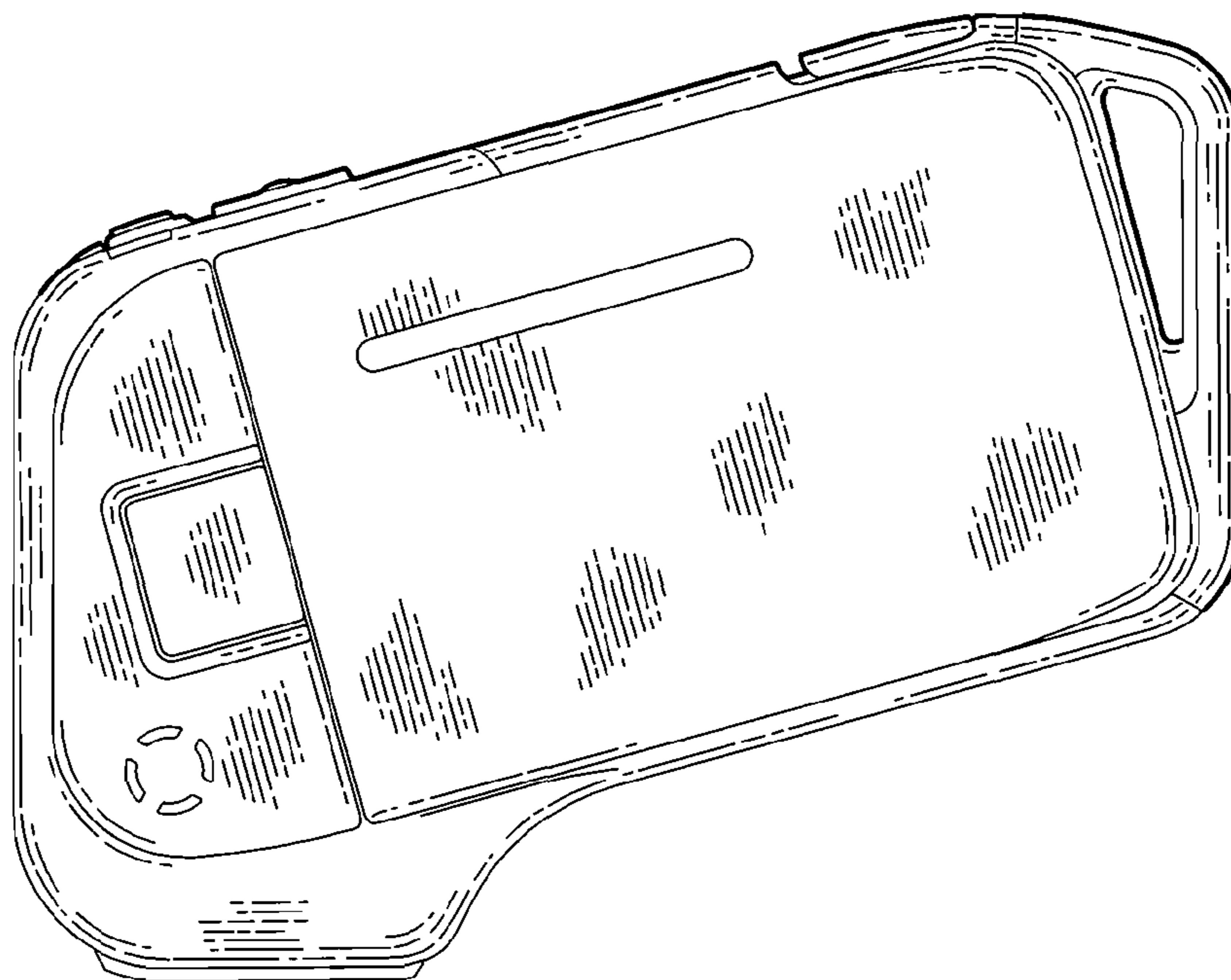
